[57] **CLAIM**

The ornamental design for a nursery container upper portion, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a first embodiment of a nursery container upper portion showing our new design, the rear elevational view is identical;

FIG. 2 is a right side elevational view of the nursery container upper portion shown in FIG. 1, the left side elevational view is identical;

FIG. 3 is a top plan view of the nursery container upper portion shown in FIG. 1;

FIG. 4 is a bottom plan view of the nursery container upper portion shown in FIG. 1;

FIG. 5 is a front elevational view of a second embodiment of a nursery container upper portion showing our new design;

FIG. 6 is a rear elevational view of the nursery container upper portion shown in FIG. 5;

FIG. 7 is a right side elevational view of the nursery container upper portion shown in FIG. 5;

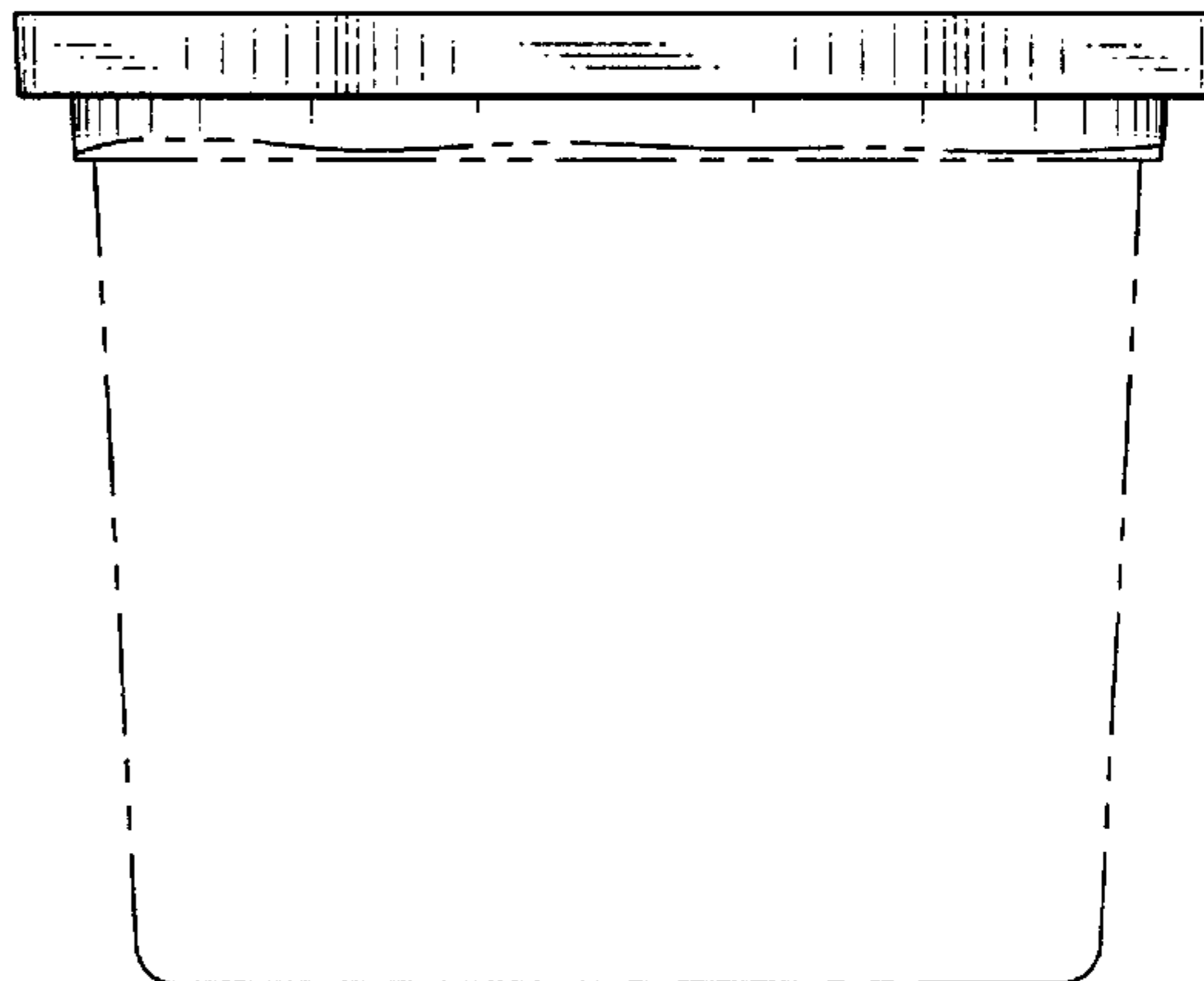
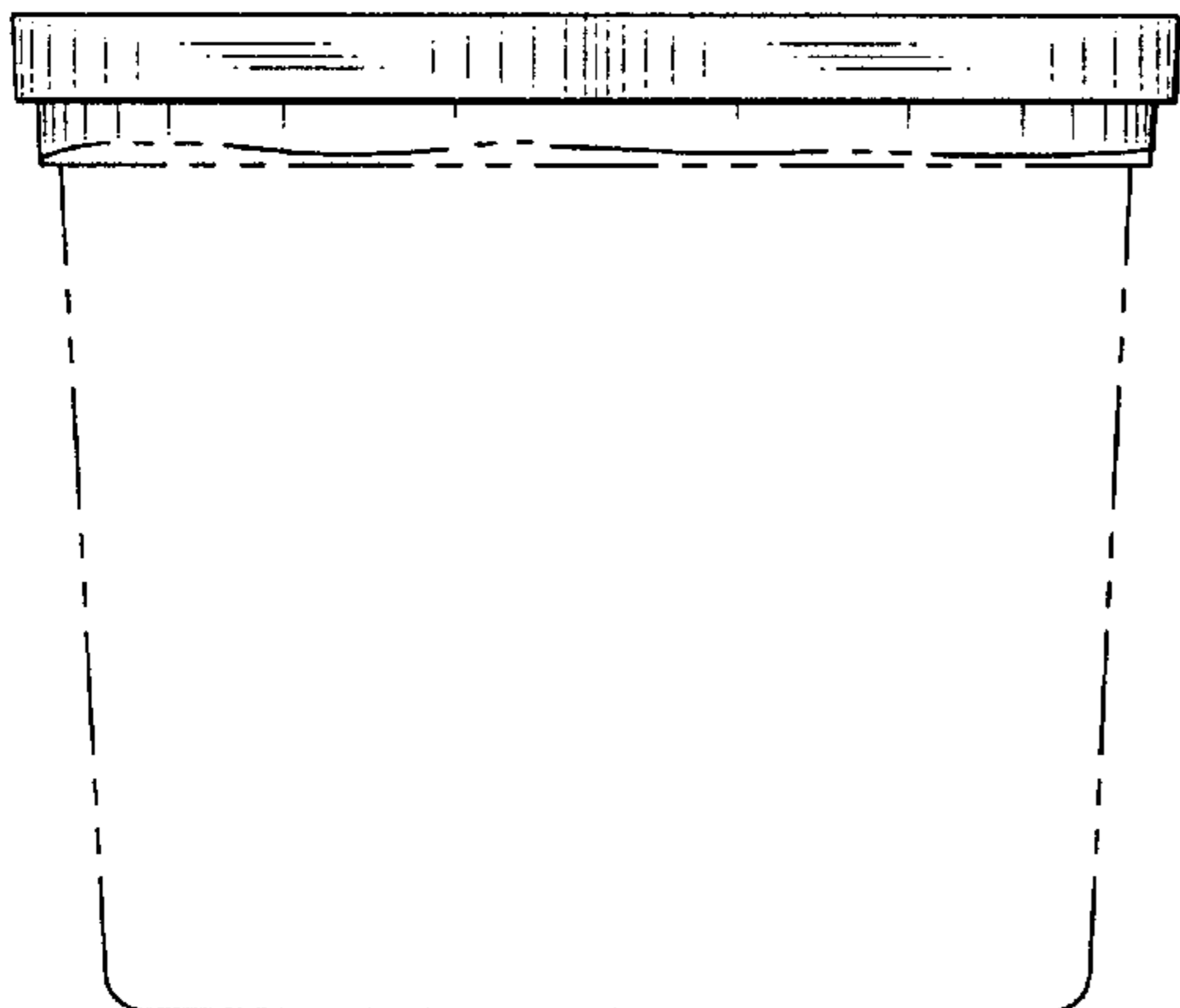


FIG. 8 is a left side elevational view of the nursery container upper portion shown in FIG. 5;

FIG. 14 is a front elevational view of yet another embodiment of a nursery container upper portion showing our new design, the right, left and rear elevational views are identical;

FIG. 15 is a top plan view of the nursery container upper portion shown in FIG. 14; and,

FIG. 16 is a bottom elevational view of the nursery container upper portion shown in FIG. 14.

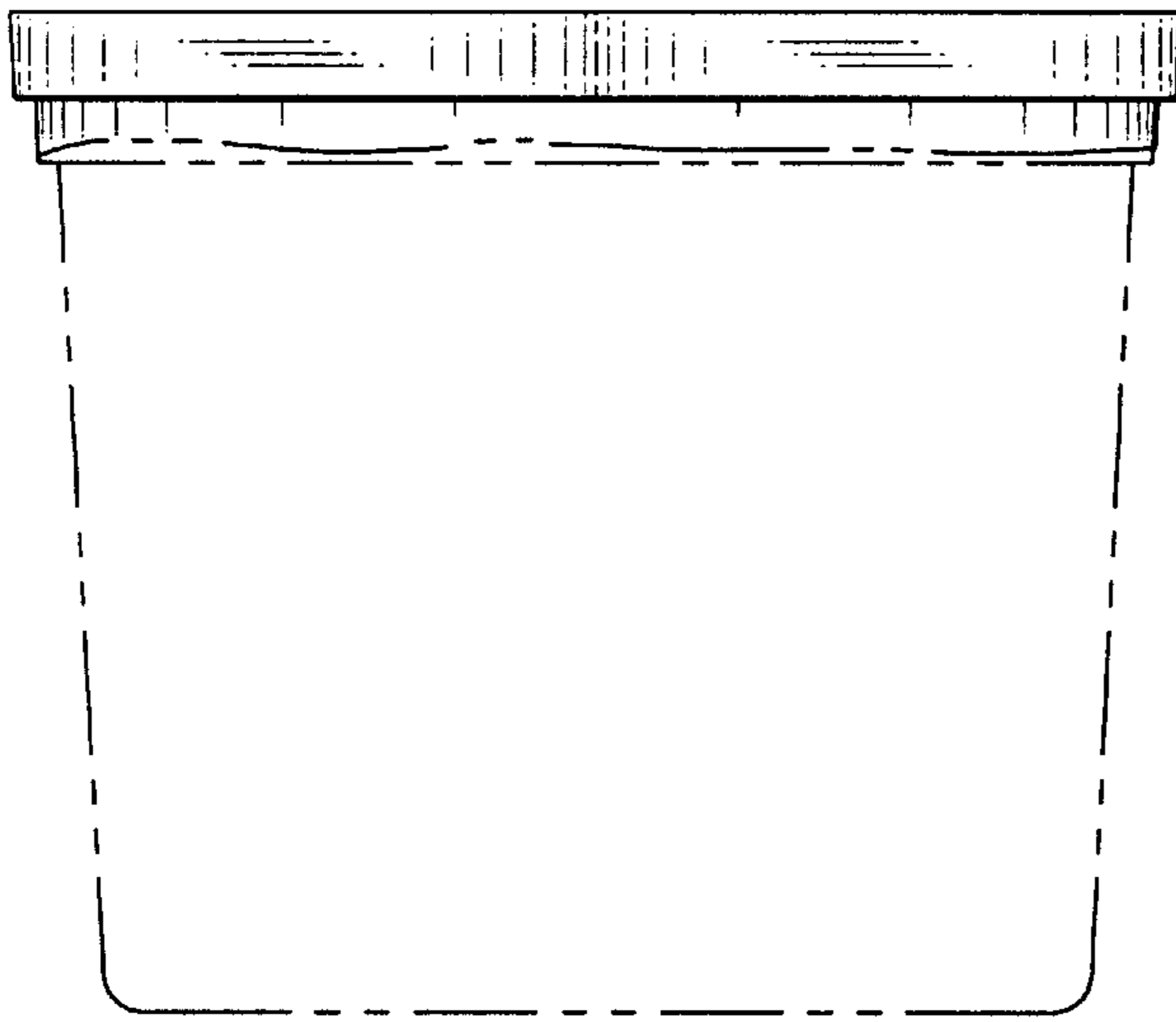

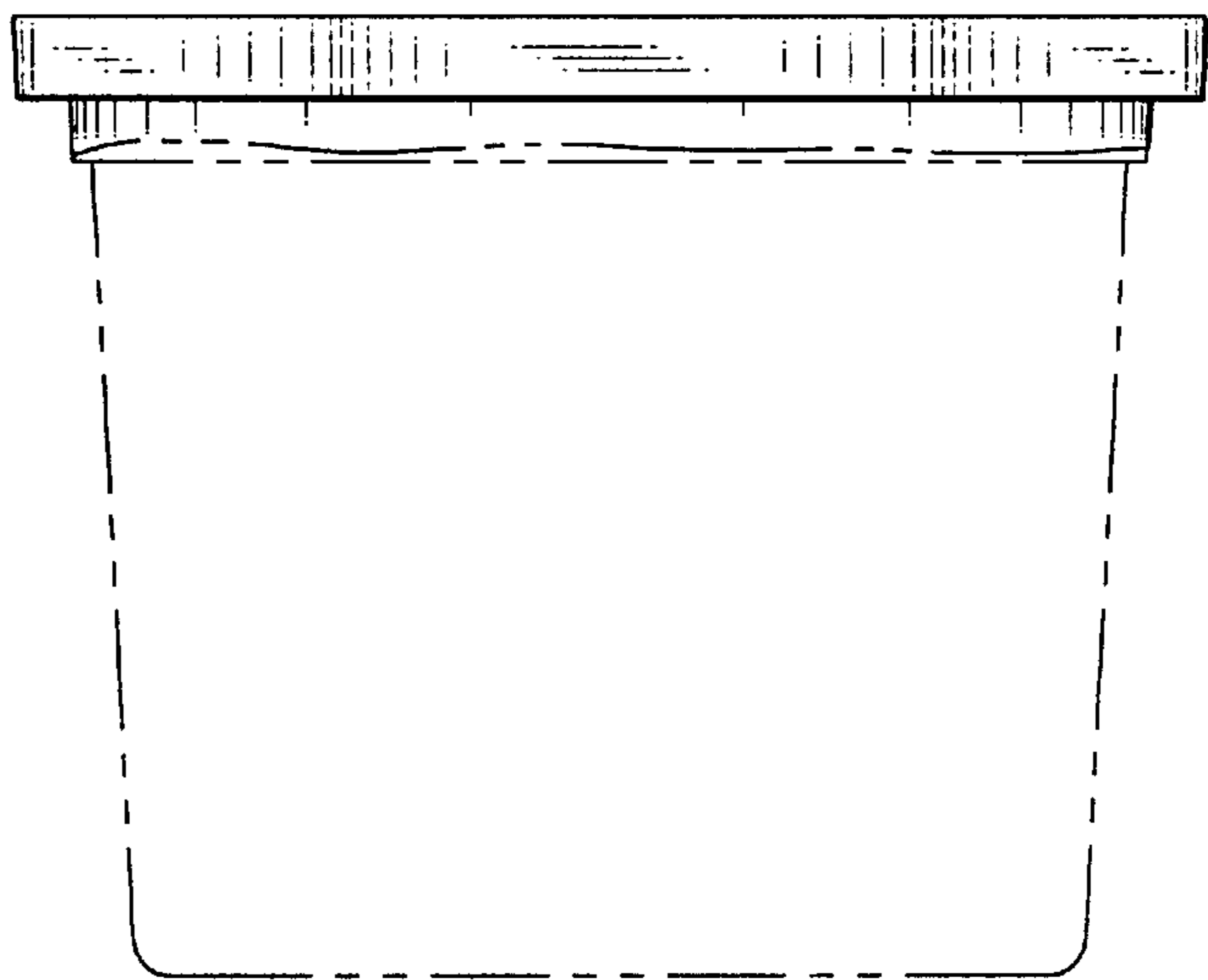

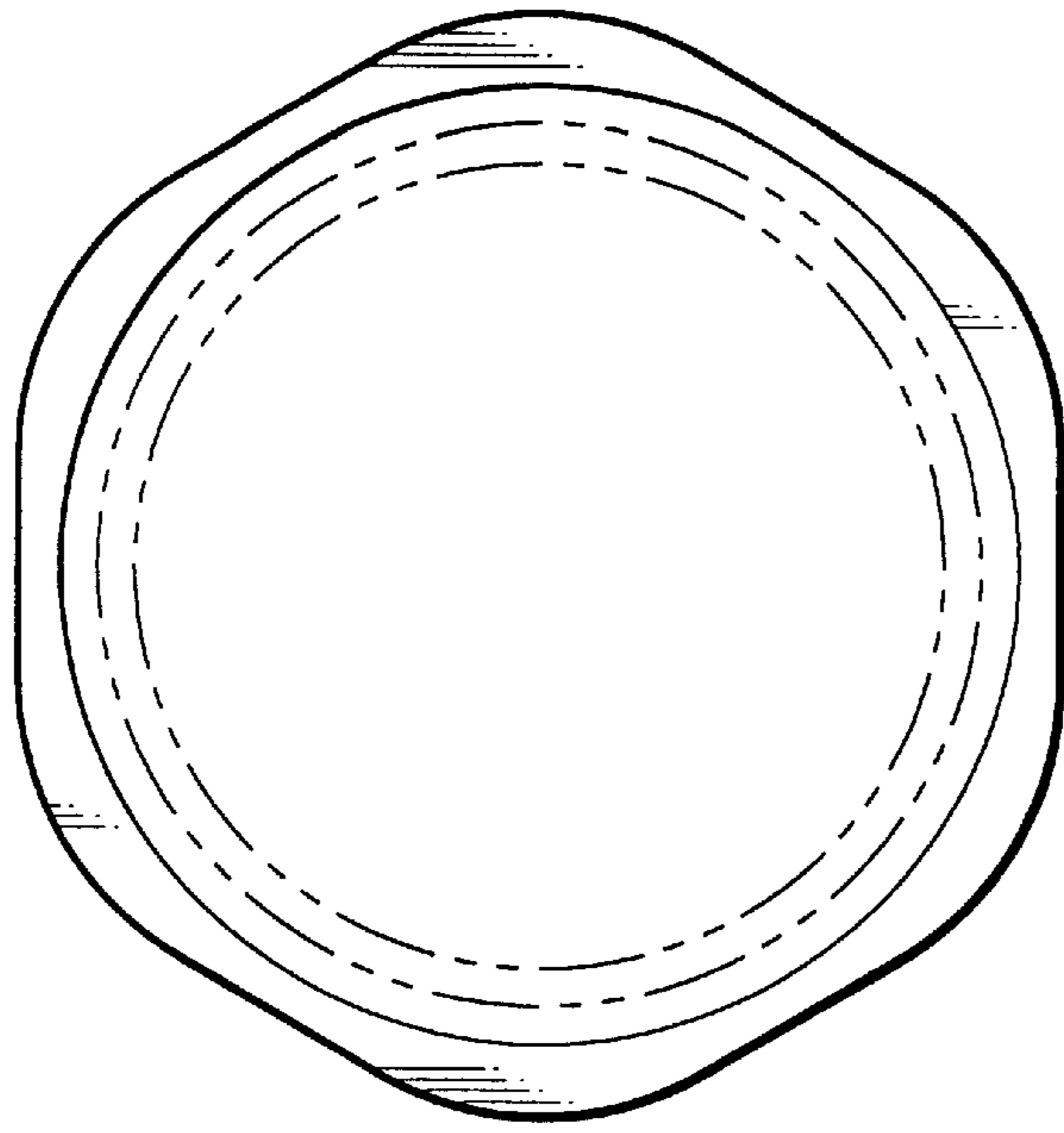

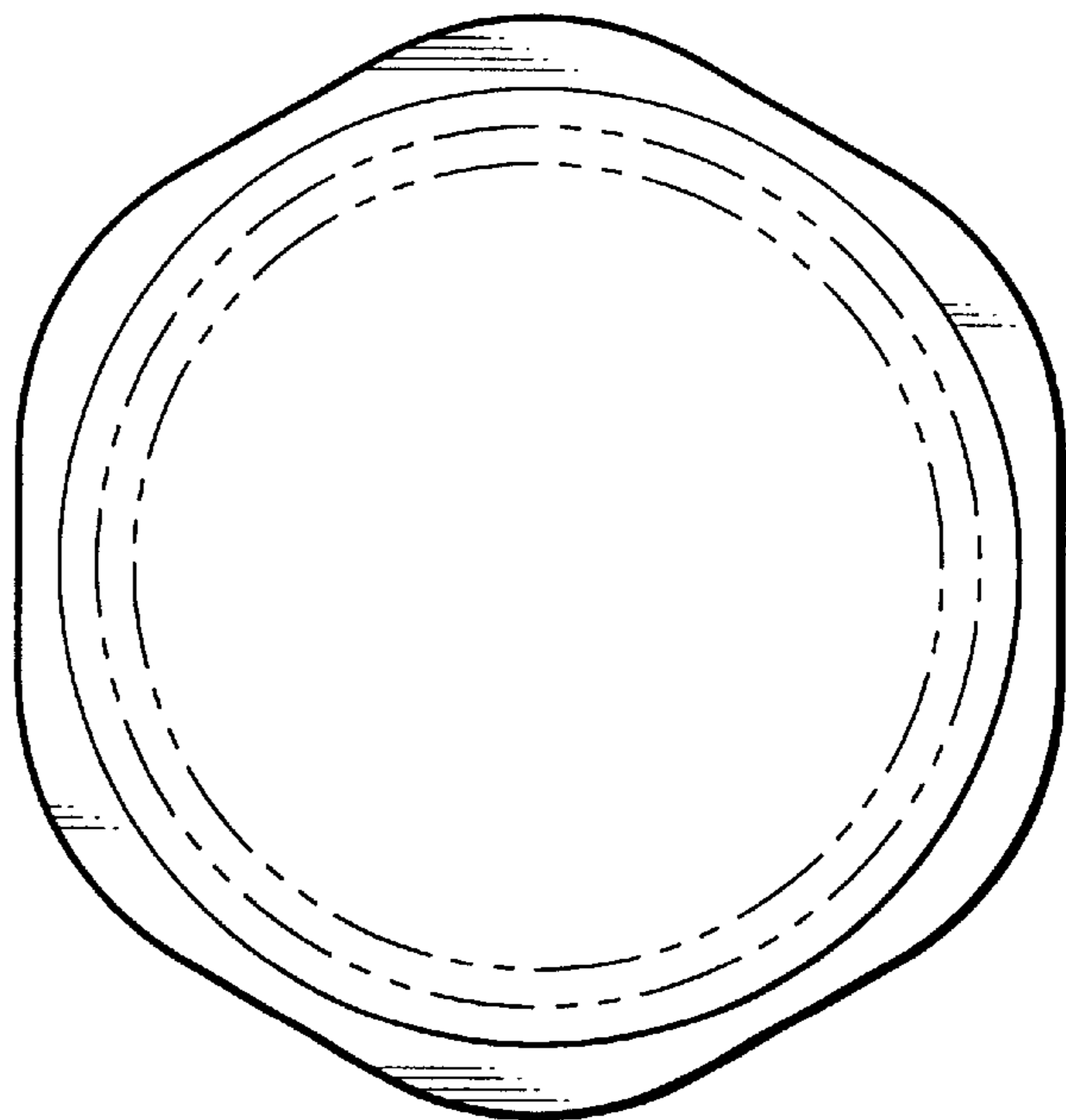

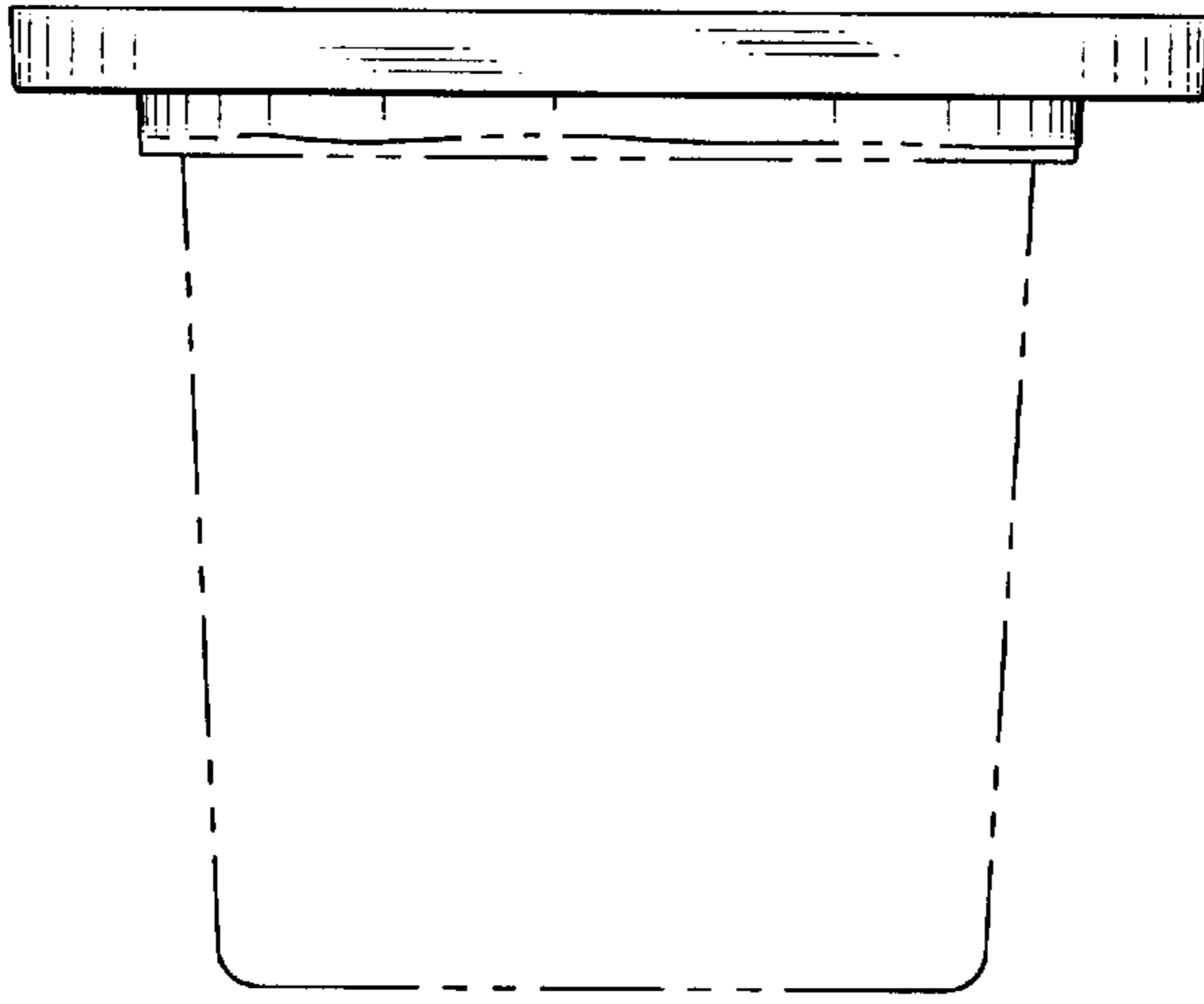

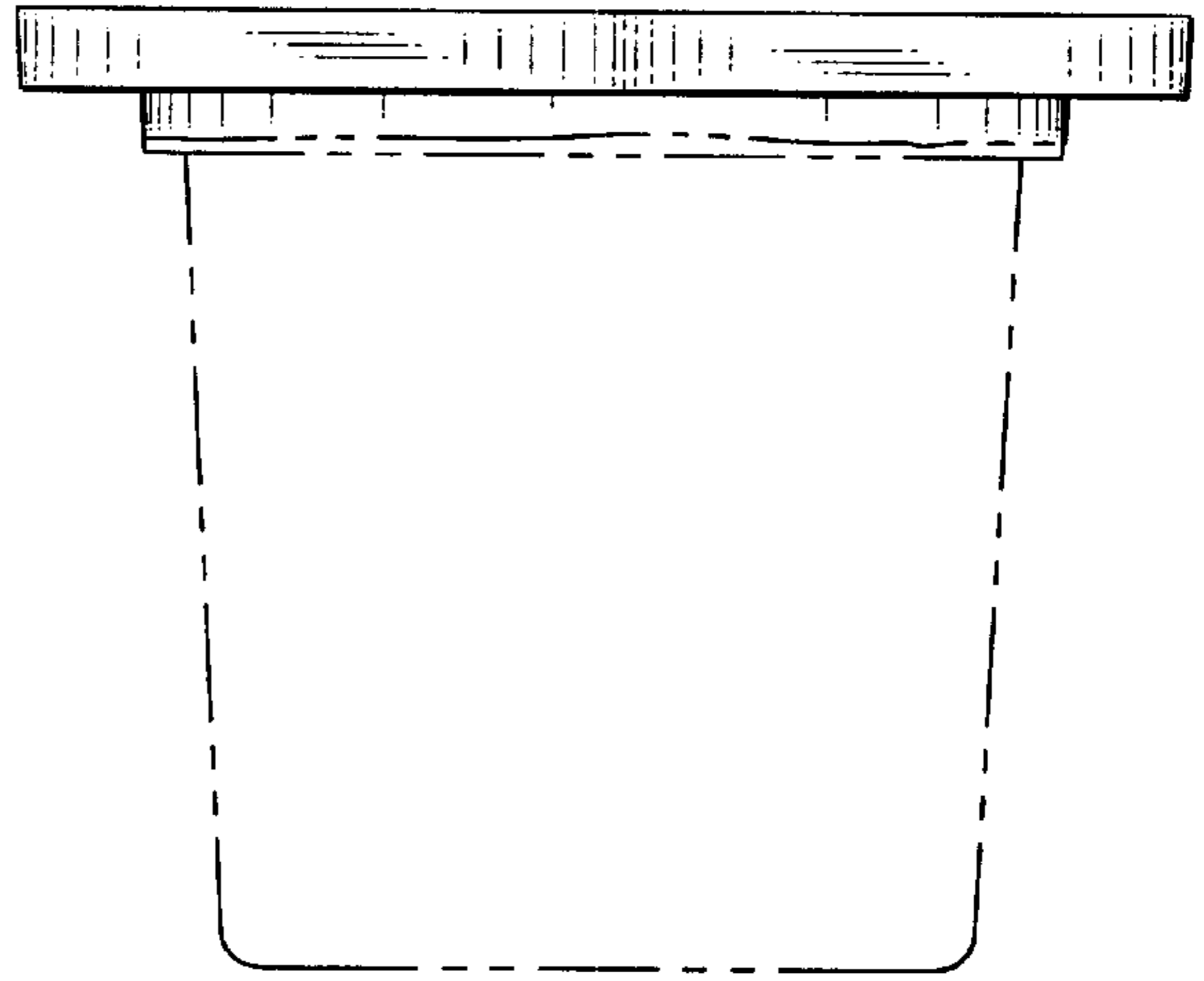

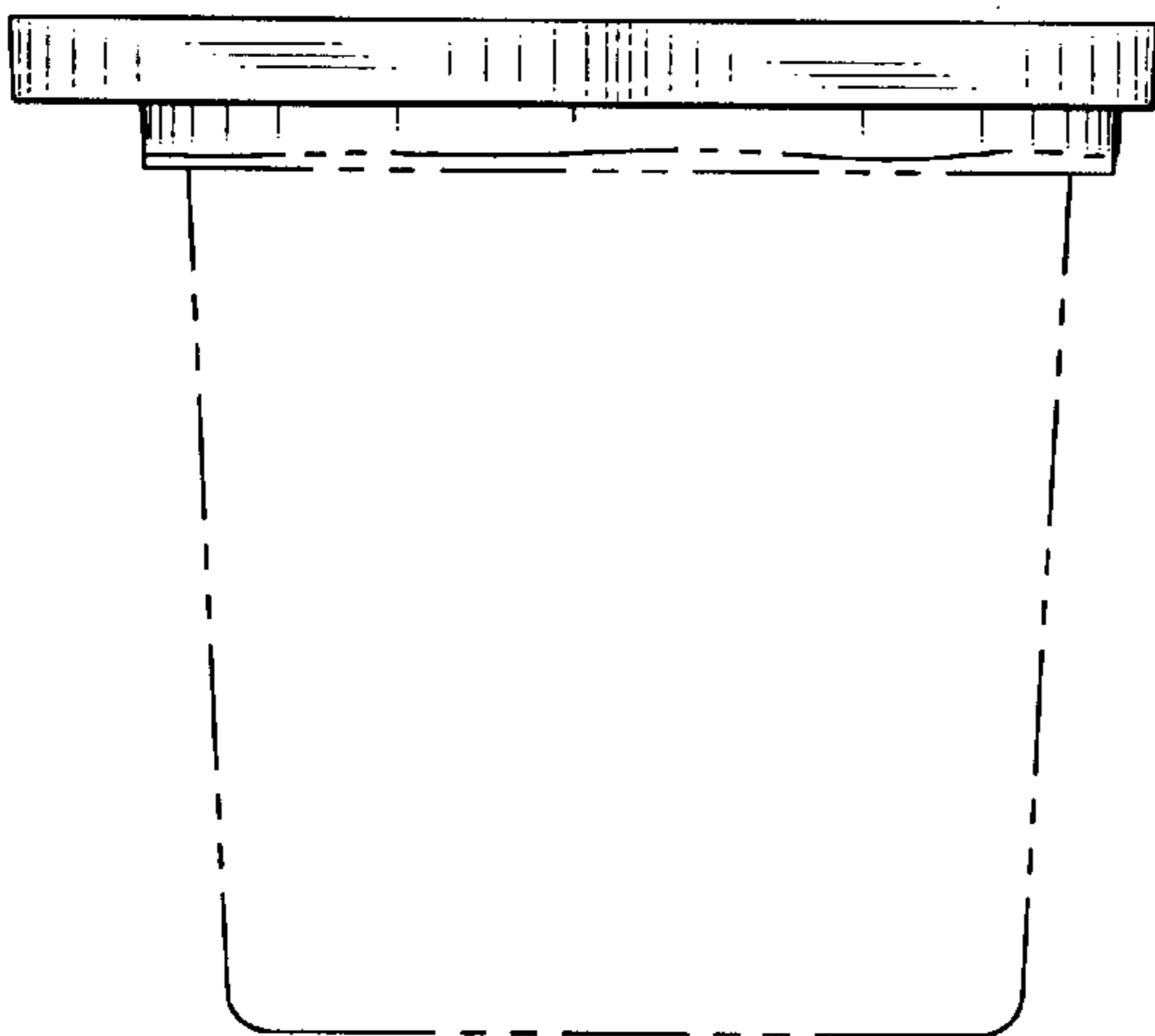

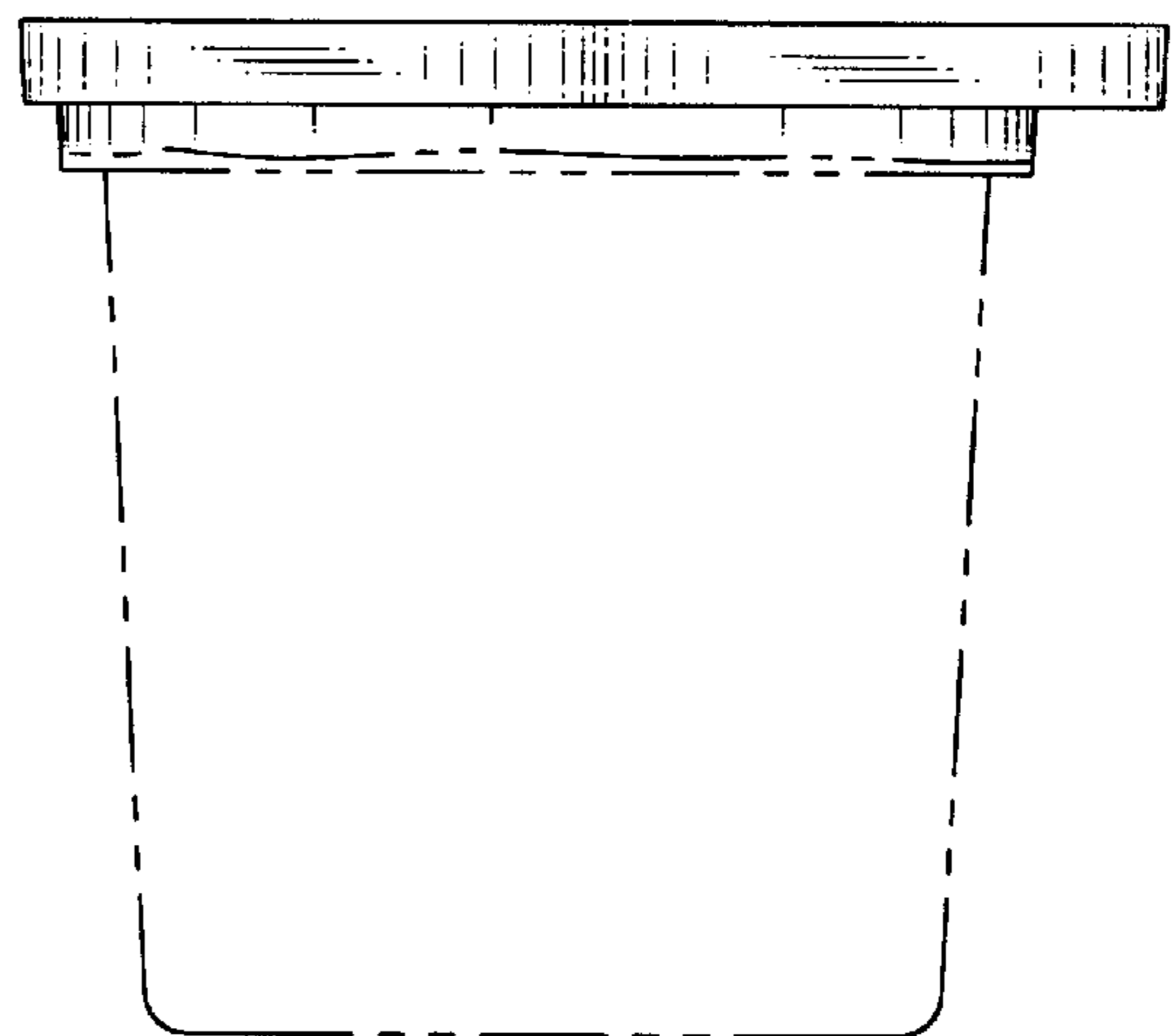

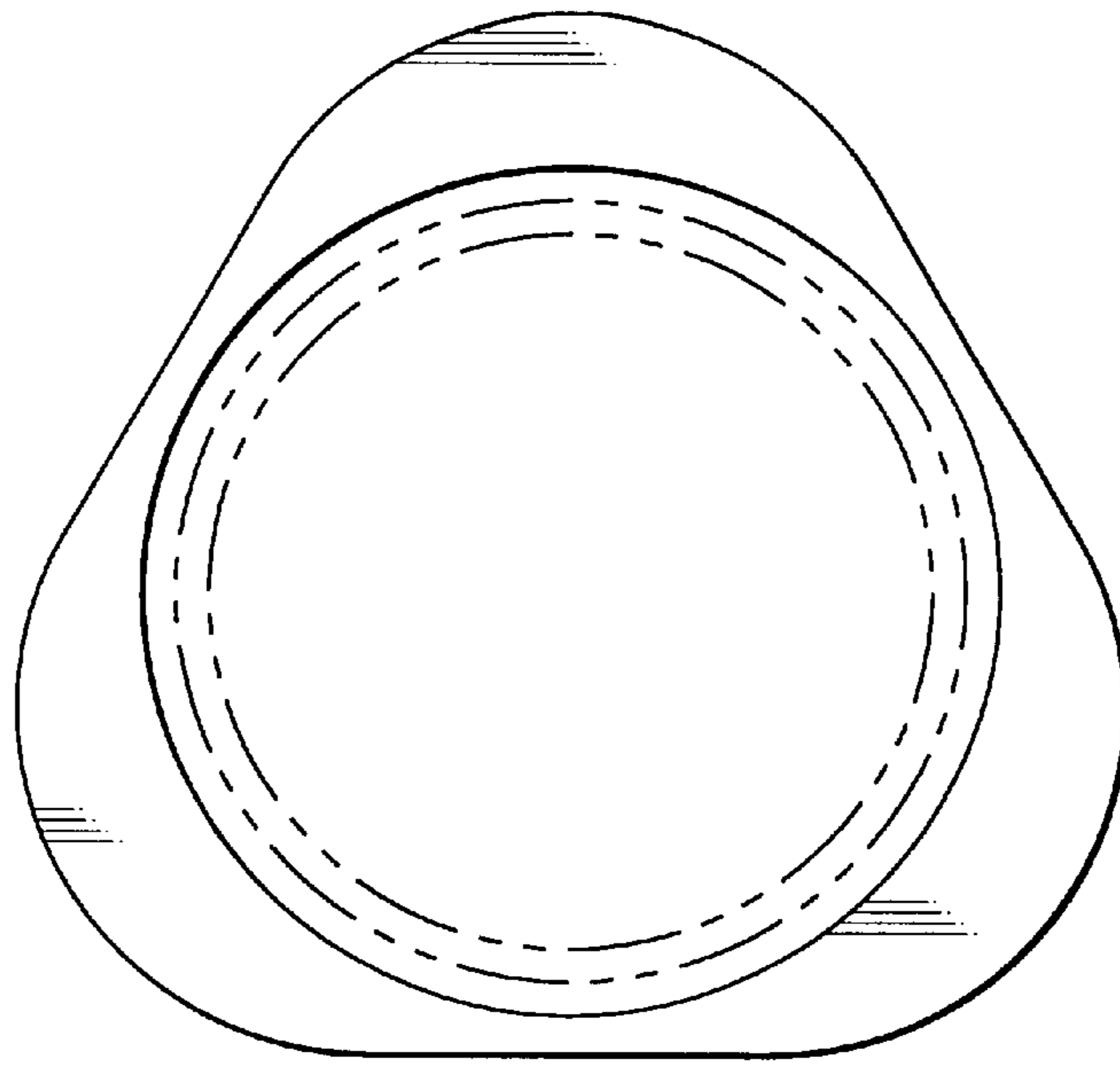

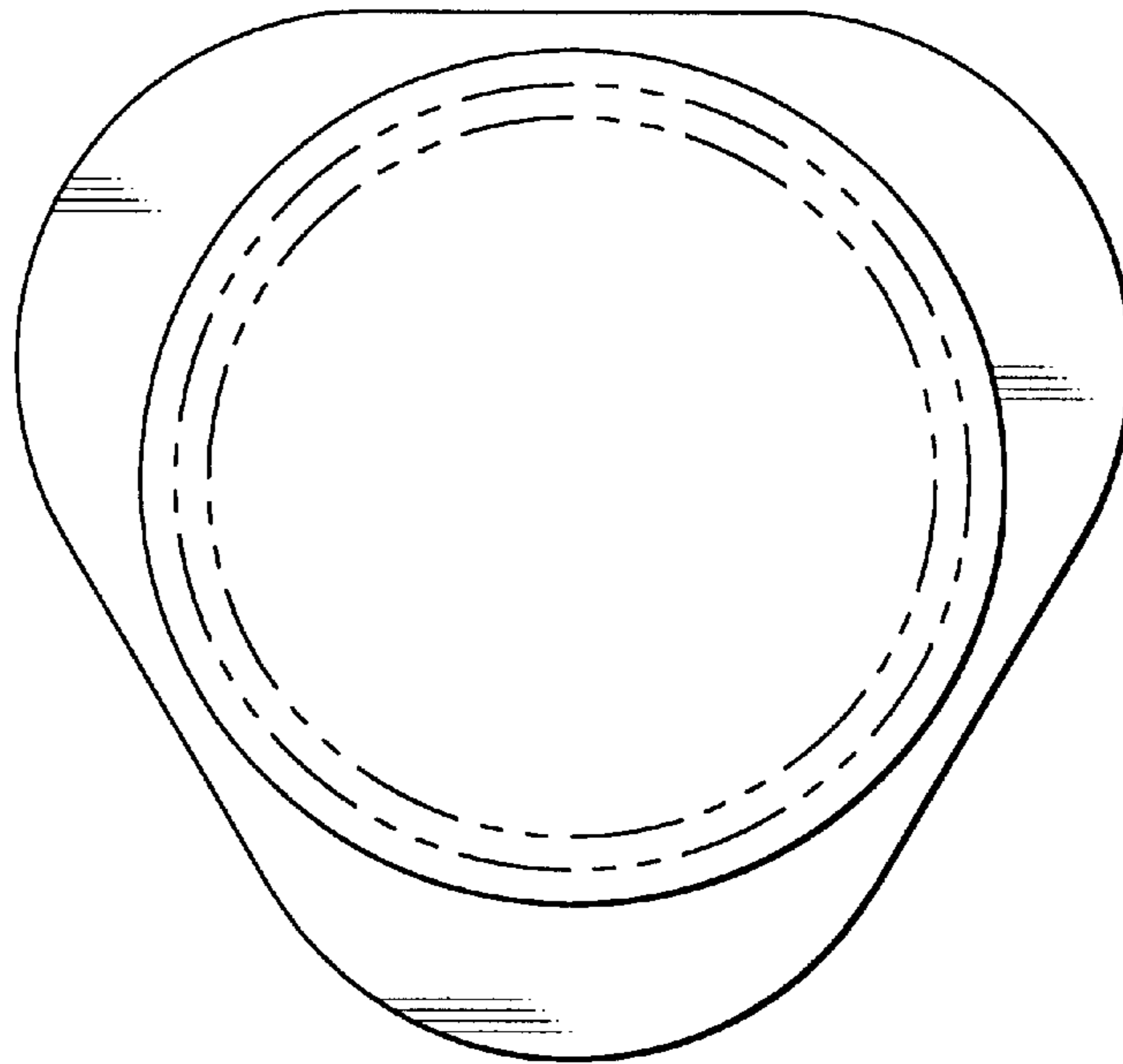

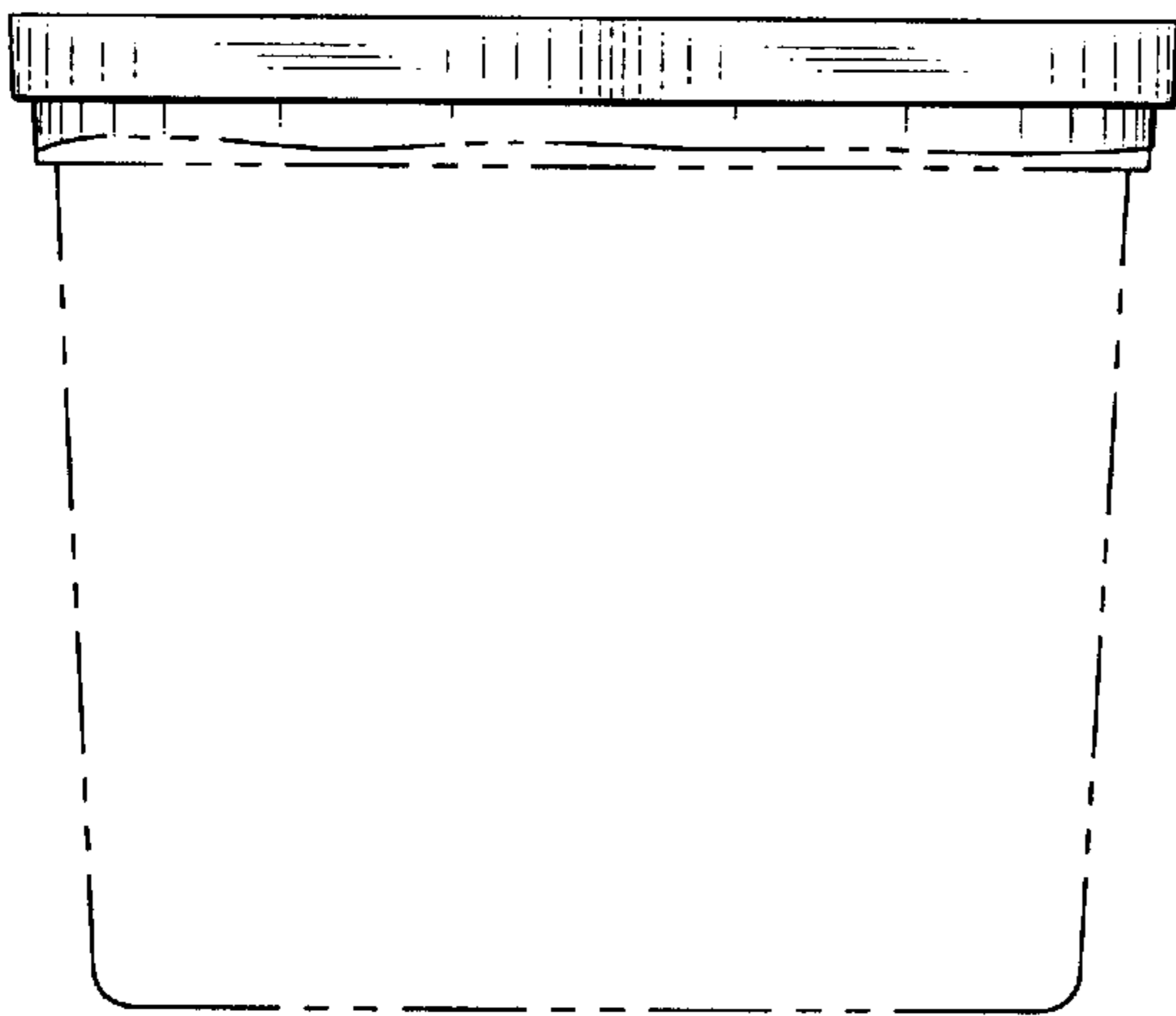

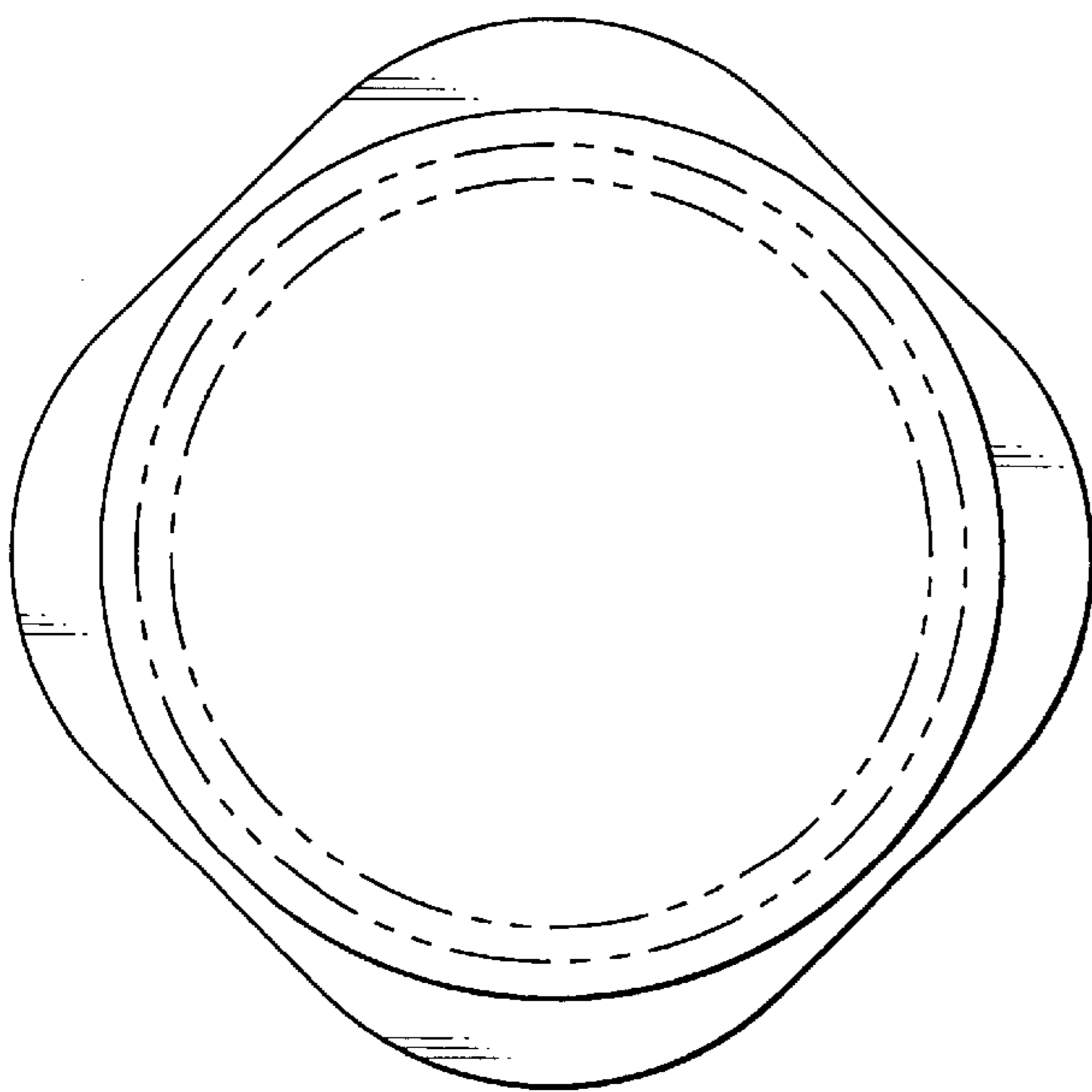
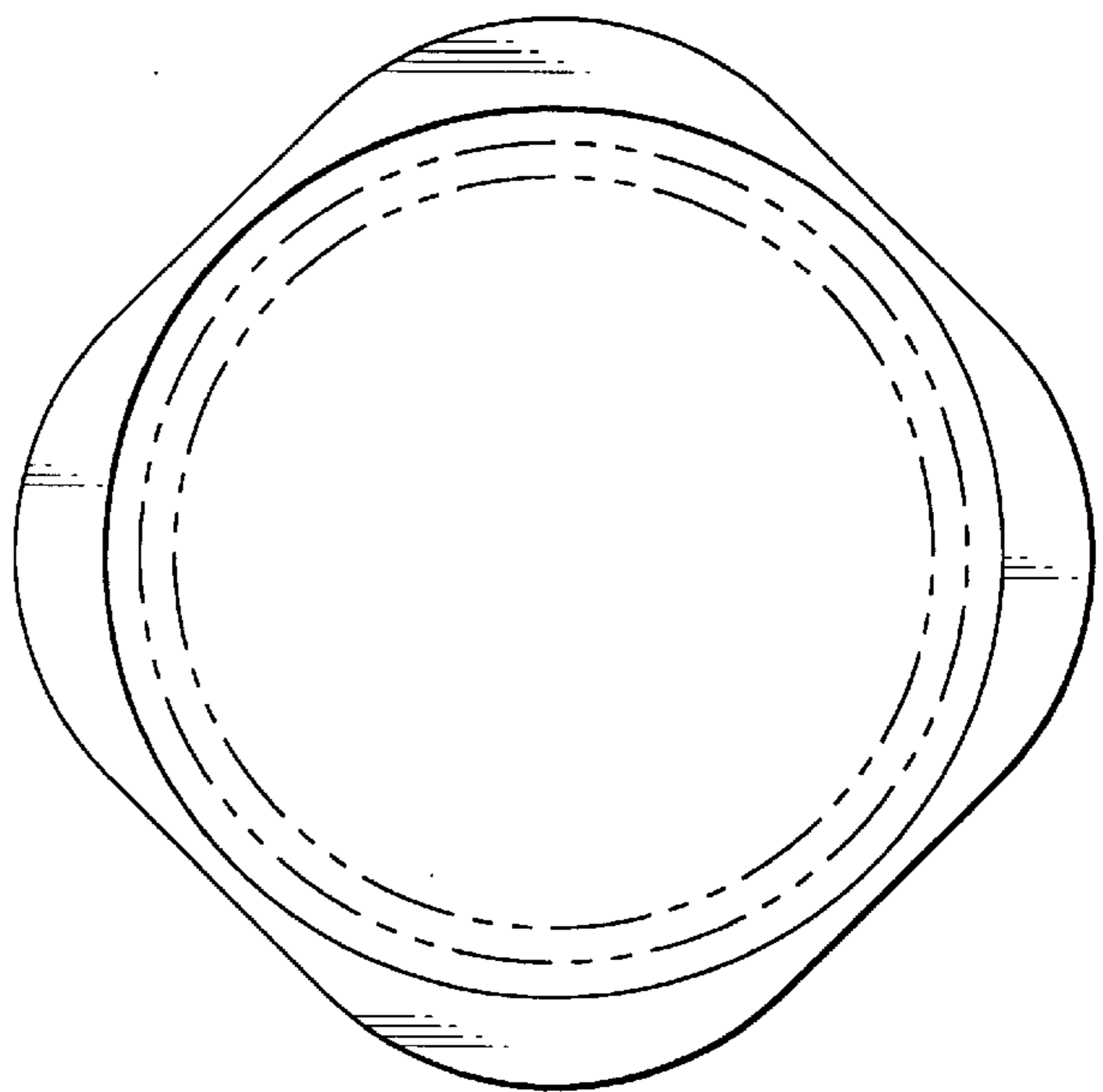

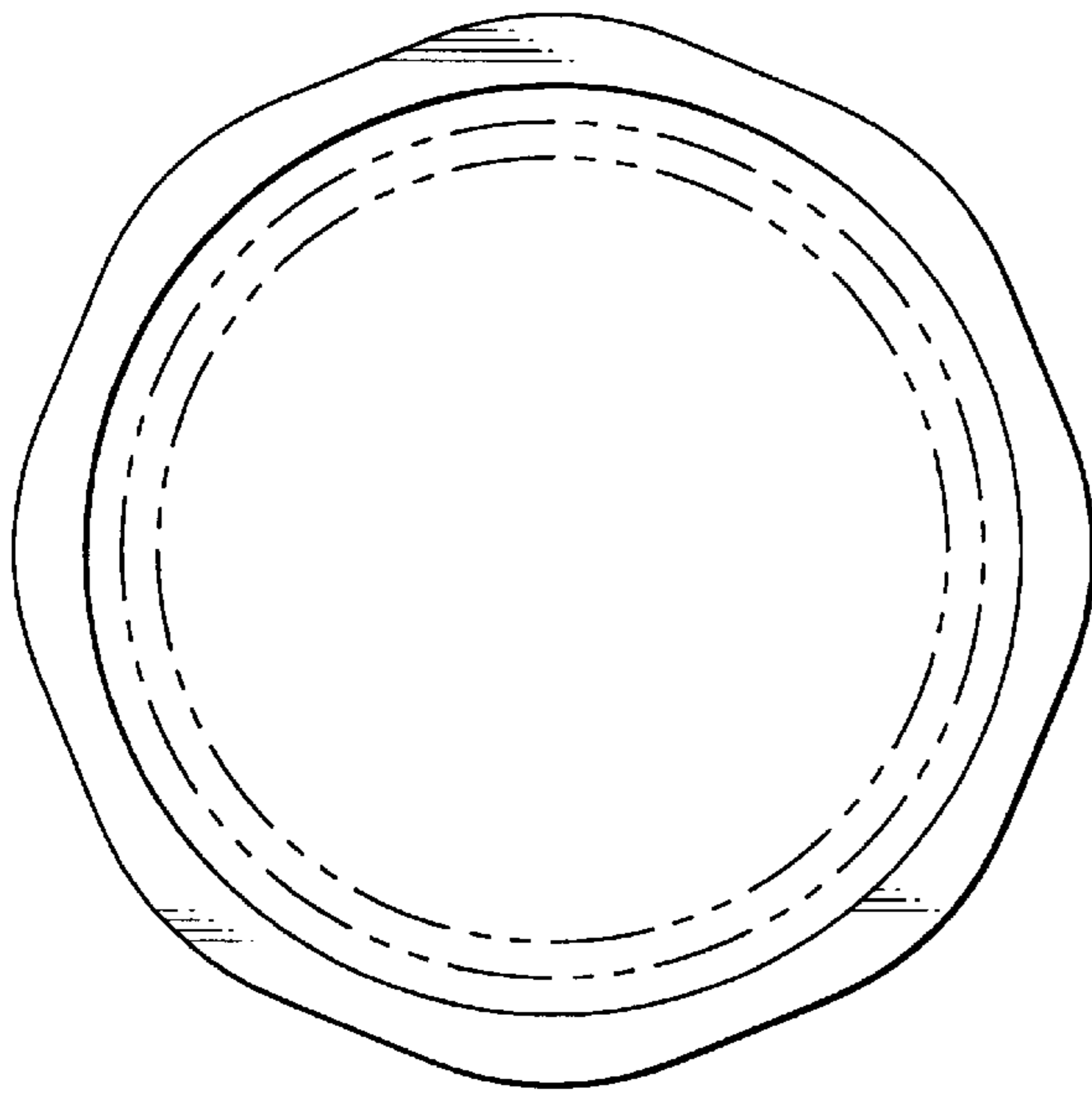
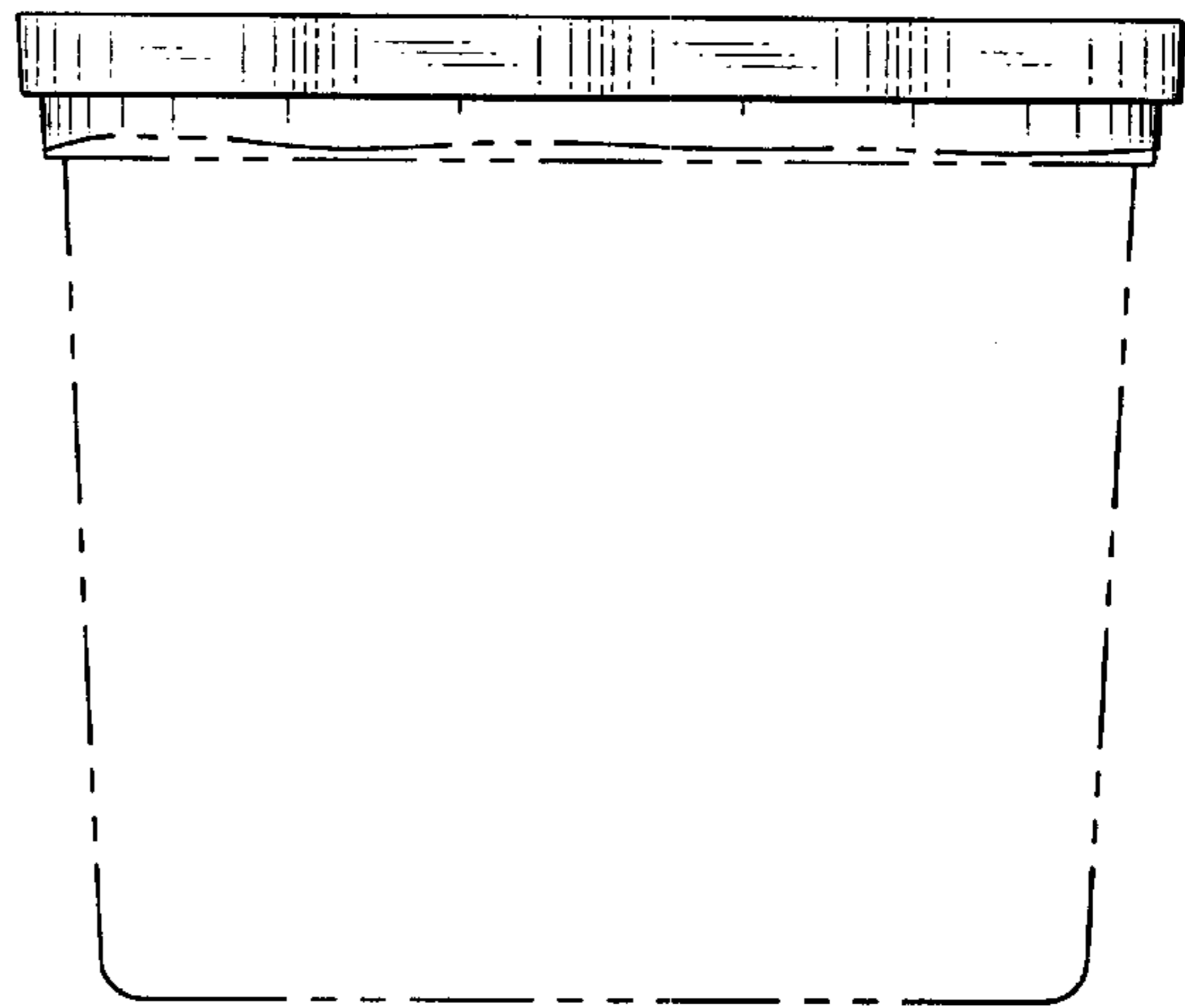
