The ornamental design for a telephone, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of our new telephone design; FIG. 2 is a rear elevational view thereof; FIG. 3 is a left side elevational view thereof; FIG. 4 is a right side elevational view thereof; FIG. 5 is a top plan view thereof; FIG. 6 is a bottom plan view thereof; FIG. 7 is a front view with the cover of the telephone in an open position; and, FIG. 8 is a right side view with the cover of the telephone in an open position.

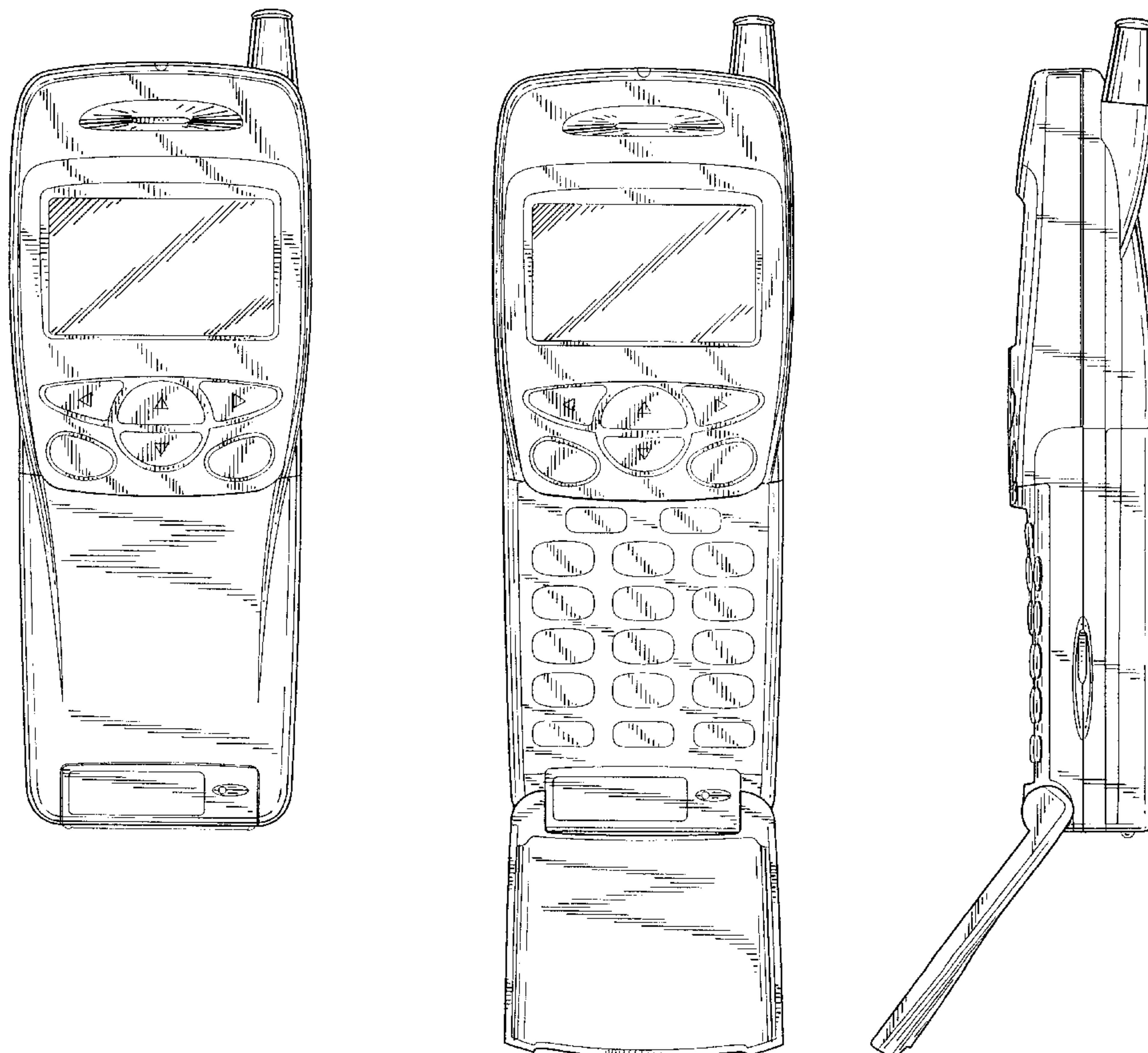

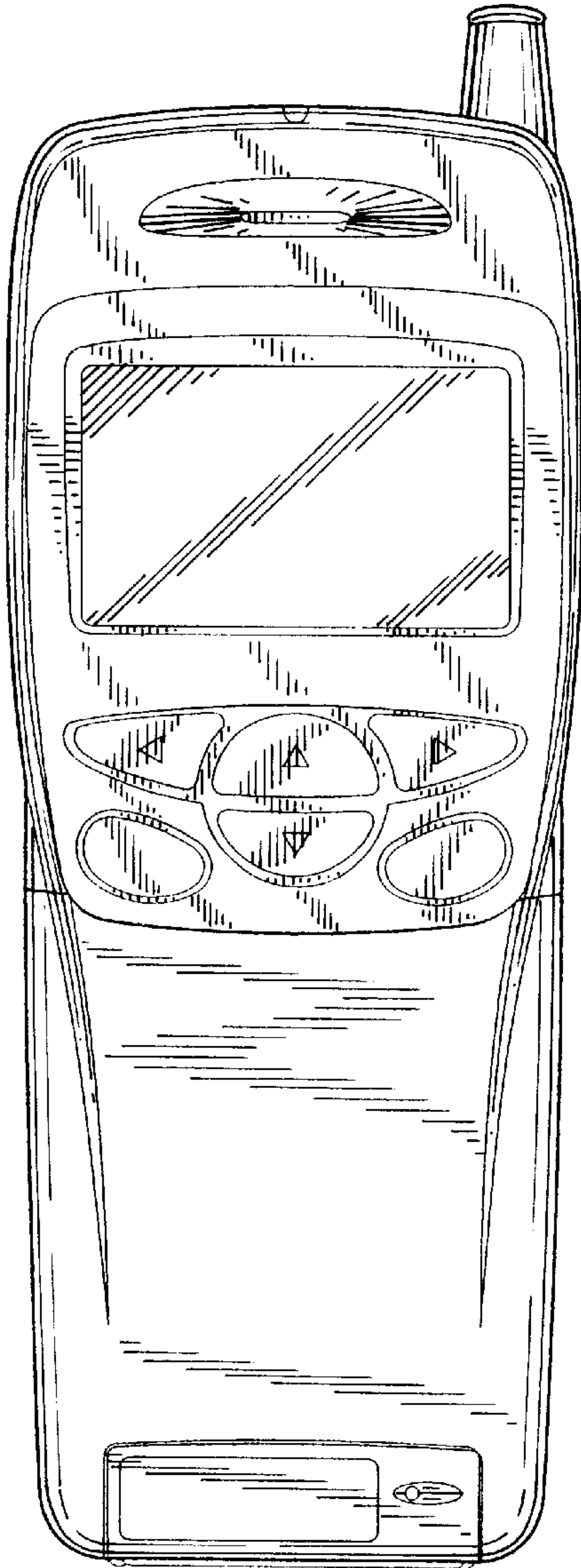

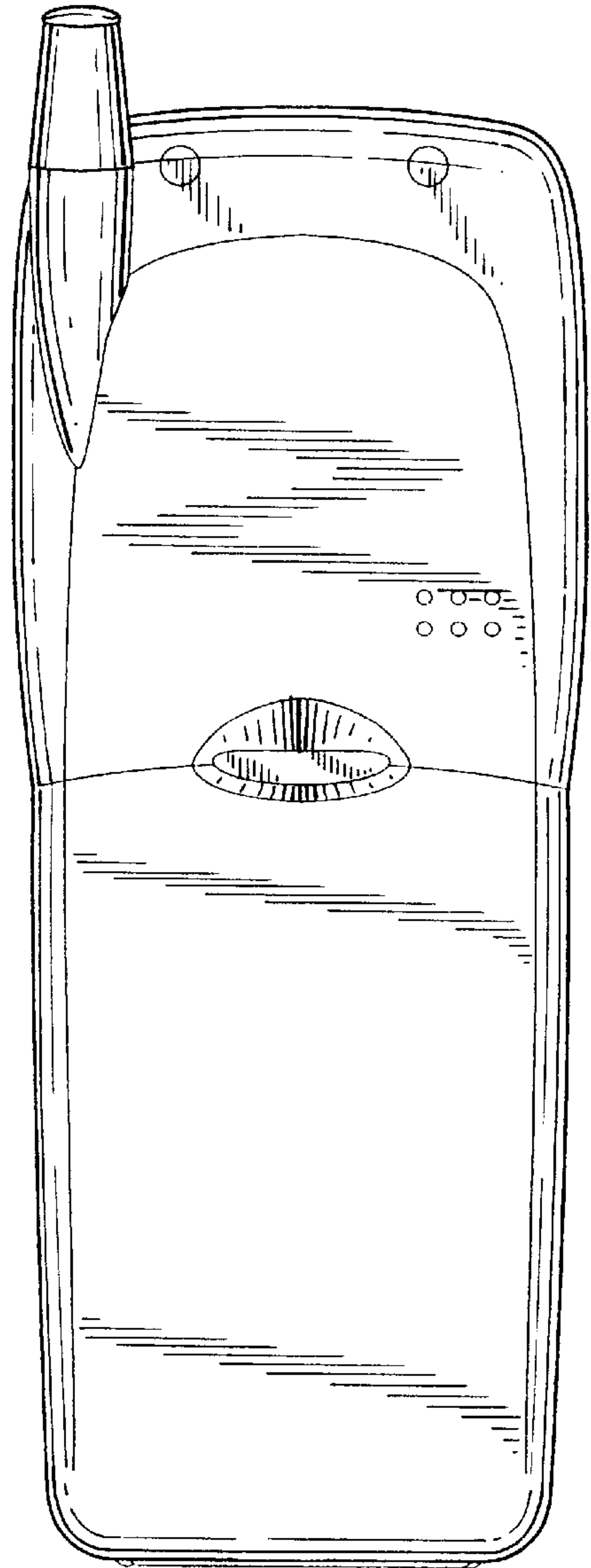

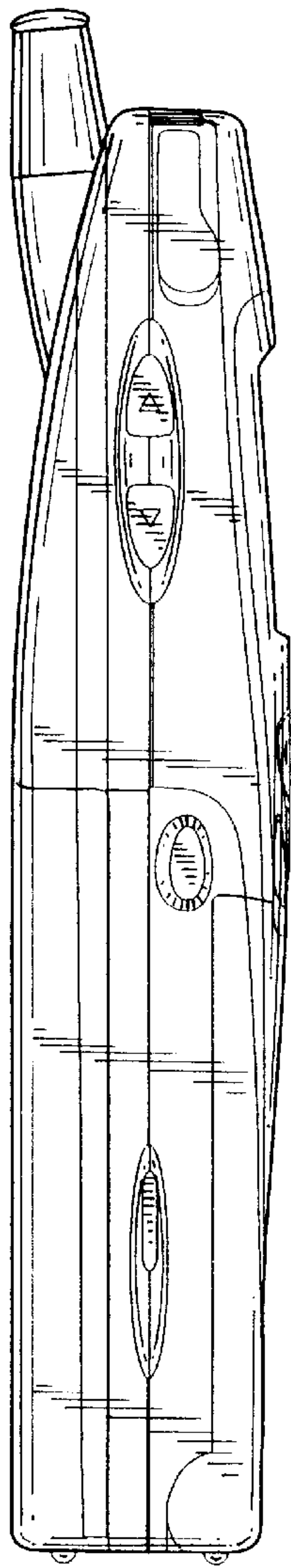

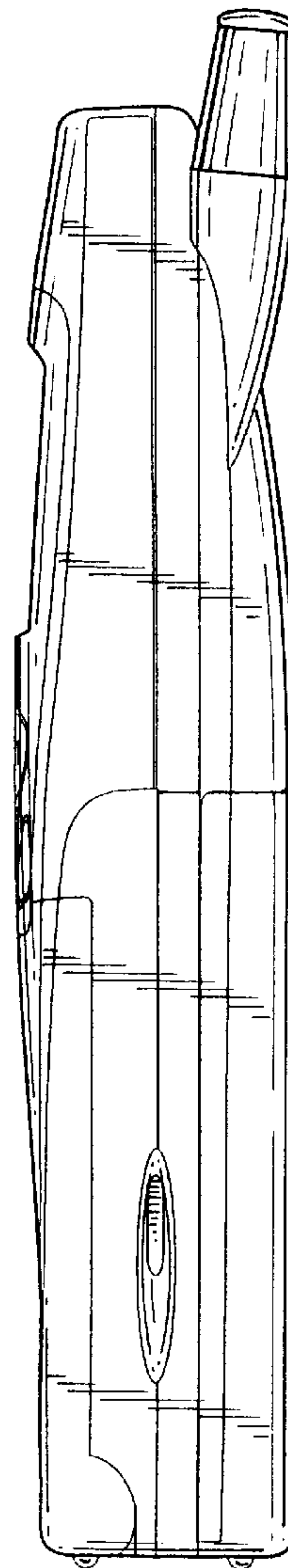

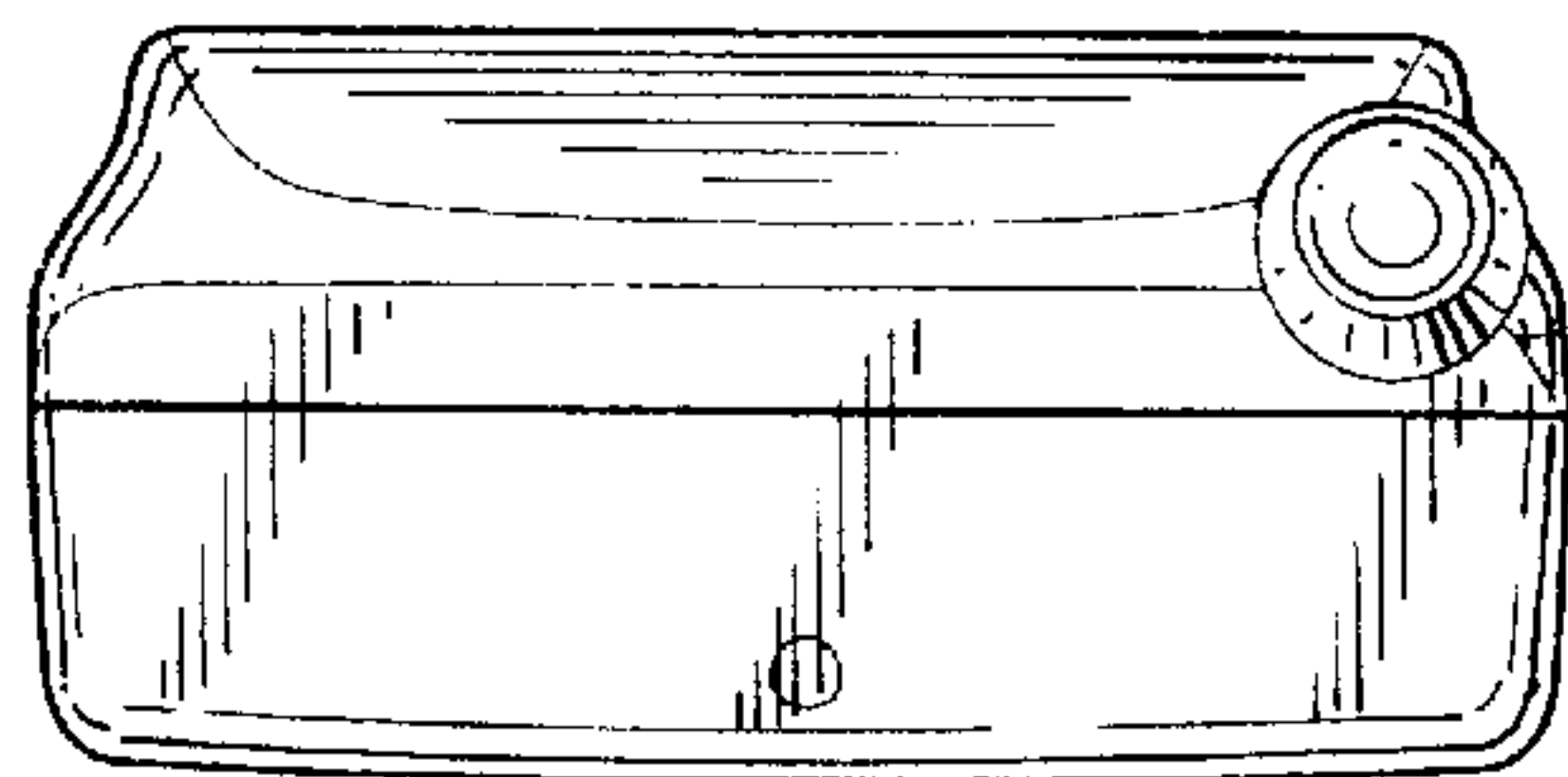

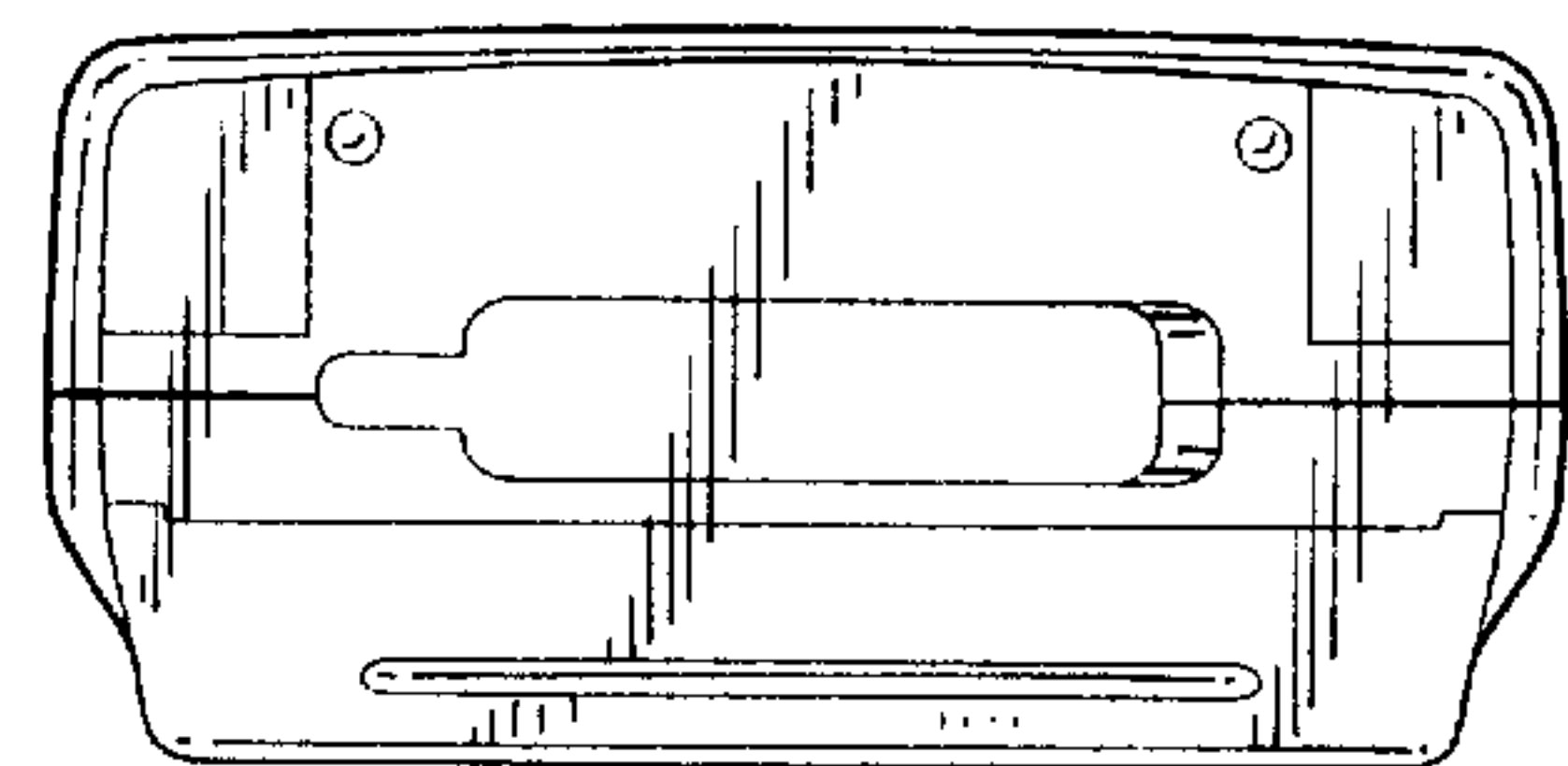

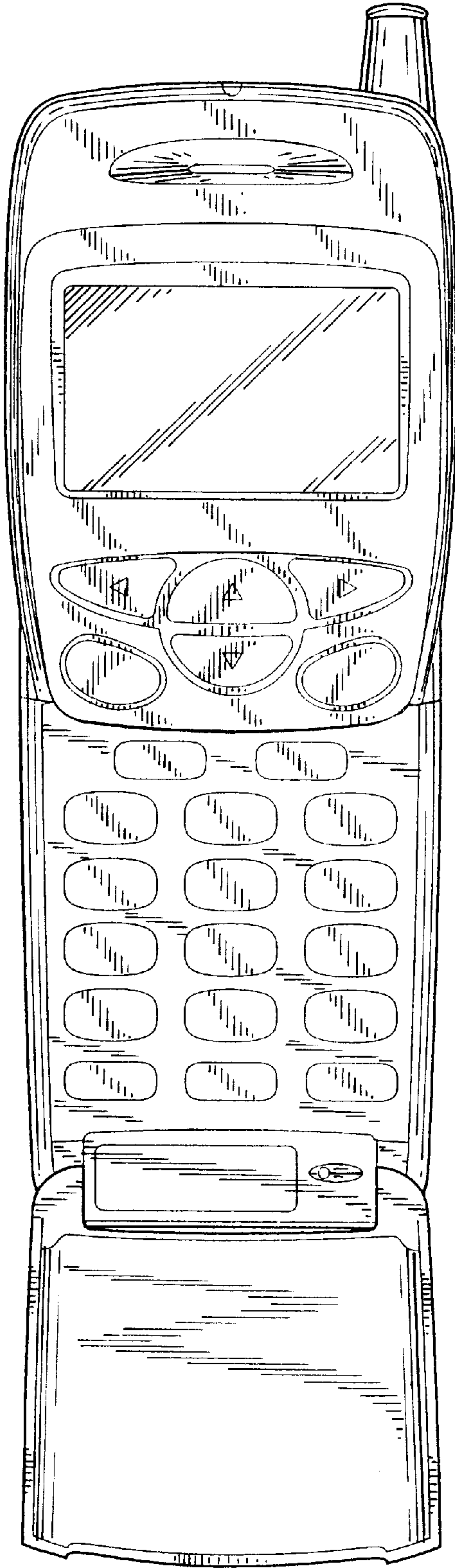
