[57] **CLAIM**

The ornamental design for a mechanical pencil, as shown.

DESCRIPTION

FIG. 1 is a front isometric view of a writing instrument showing my new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a right side elevational view thereof;
FIG. 5 is a left side elevational view thereof;
FIG. 6 is a bottom plan view thereof;
FIG. 7 is a top plan view thereof; and,
FIG. 8 is a cross-sectional view thereof along segment 8—8 of FIG. 2.

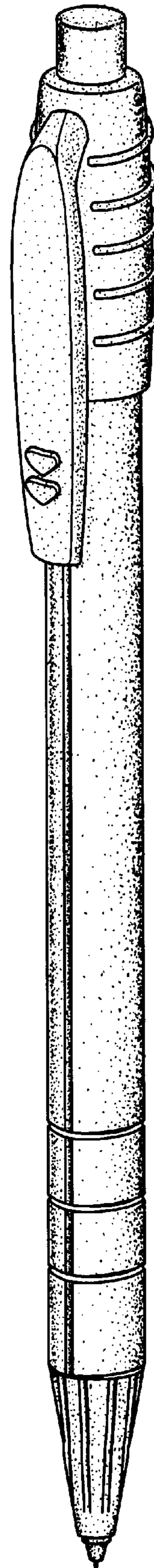

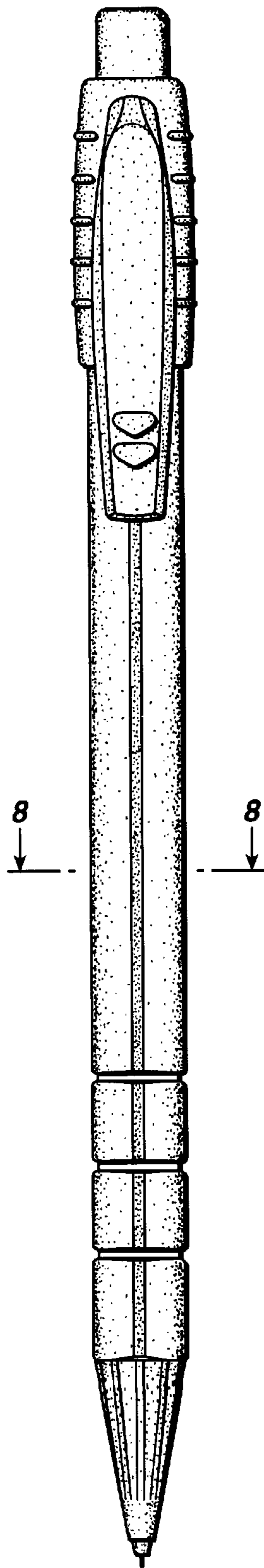

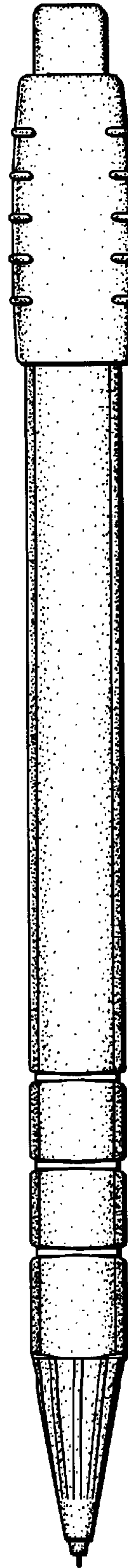

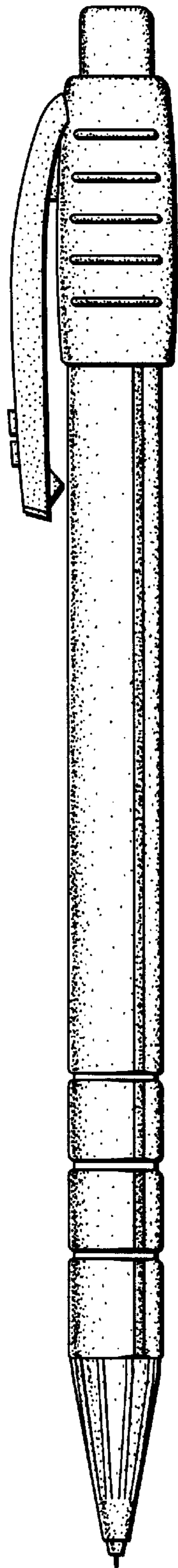

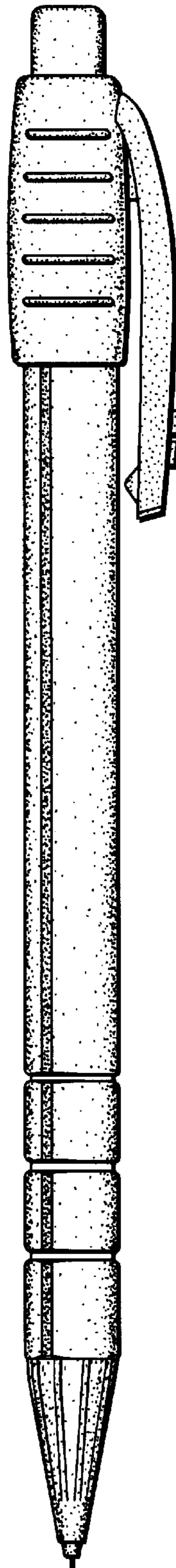

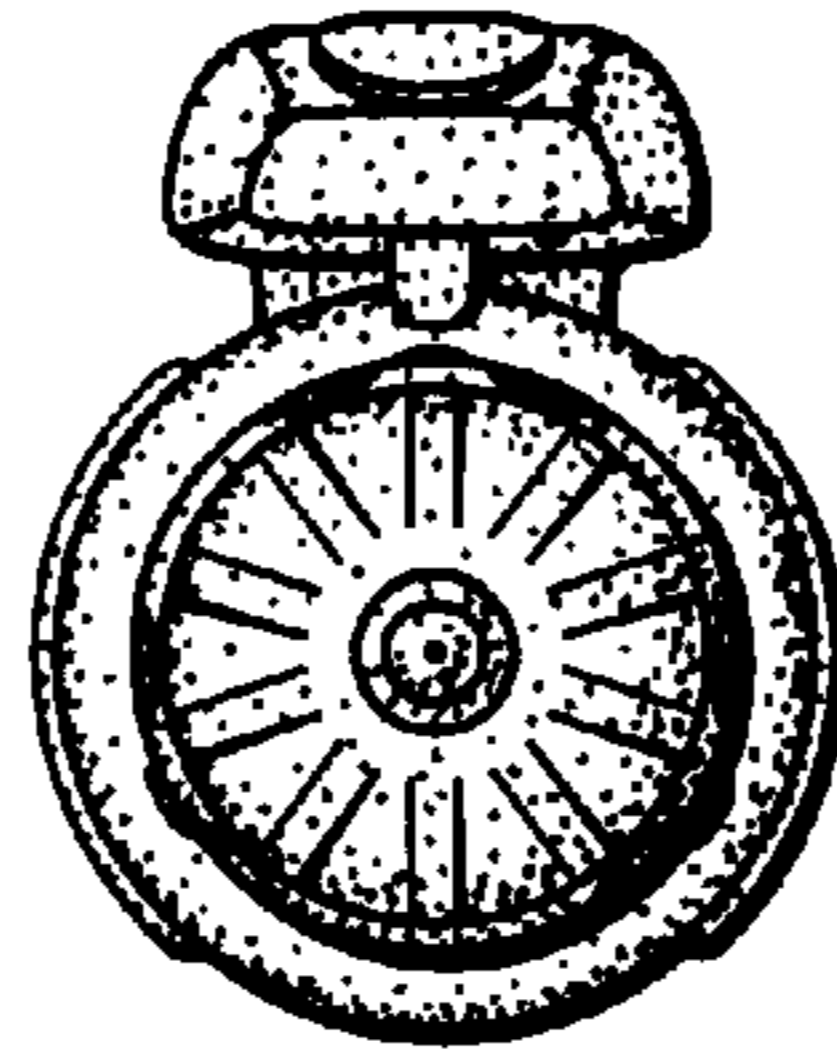

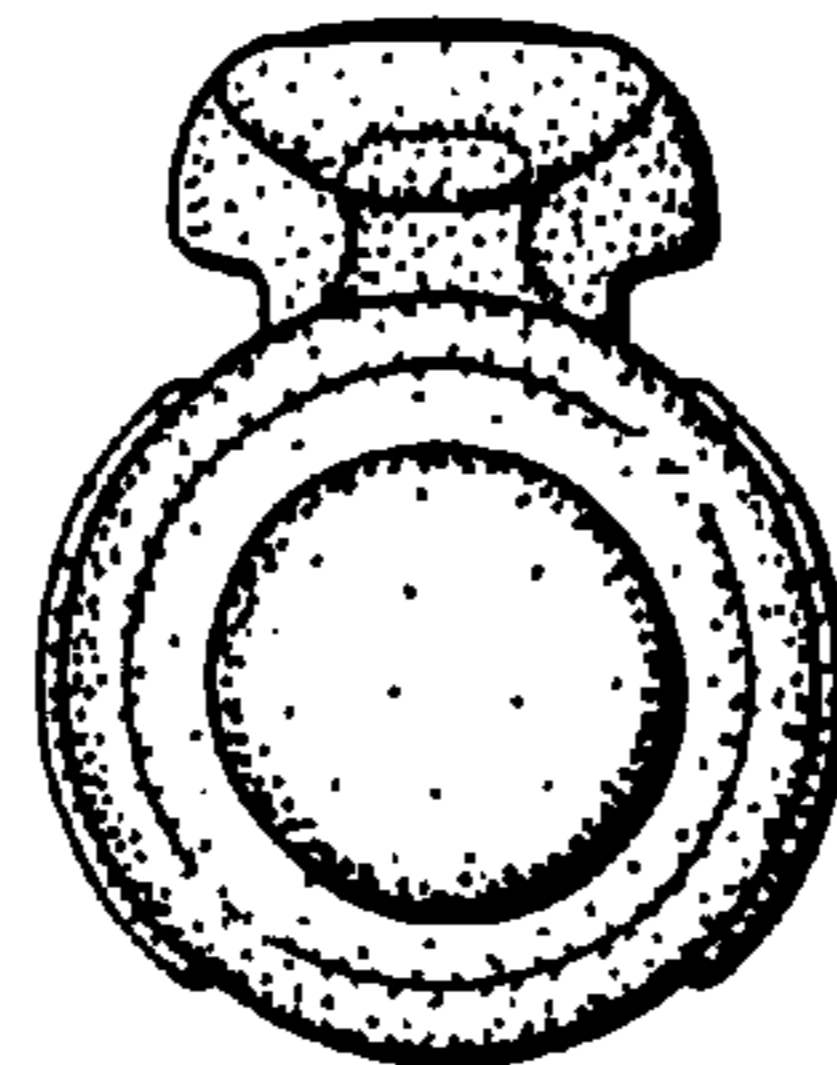
