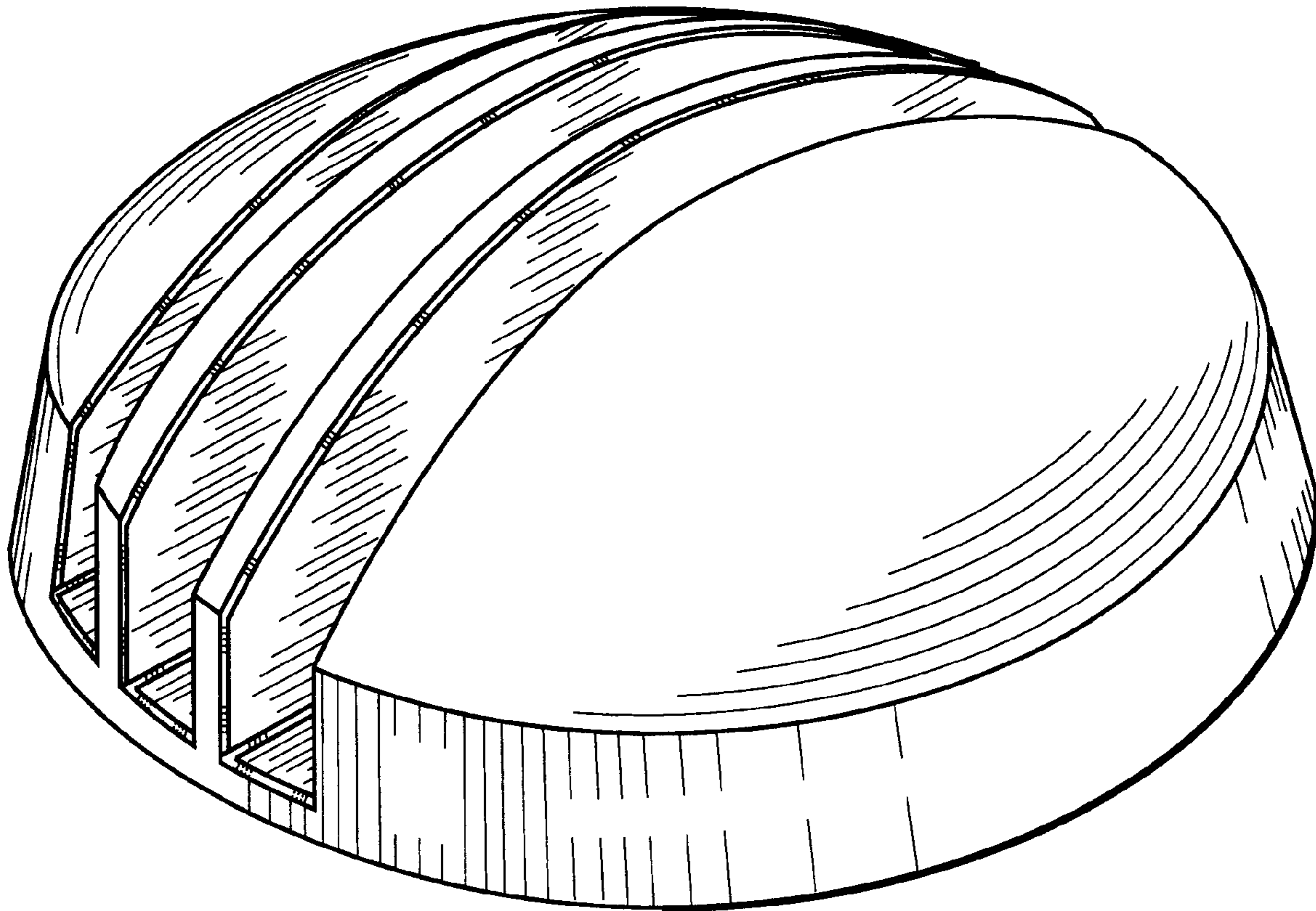
[57] **CLAIM**

### DESCRIPTION

FIG. 1 is a perspective view of a CD/Envelope Organizer showing our new design;

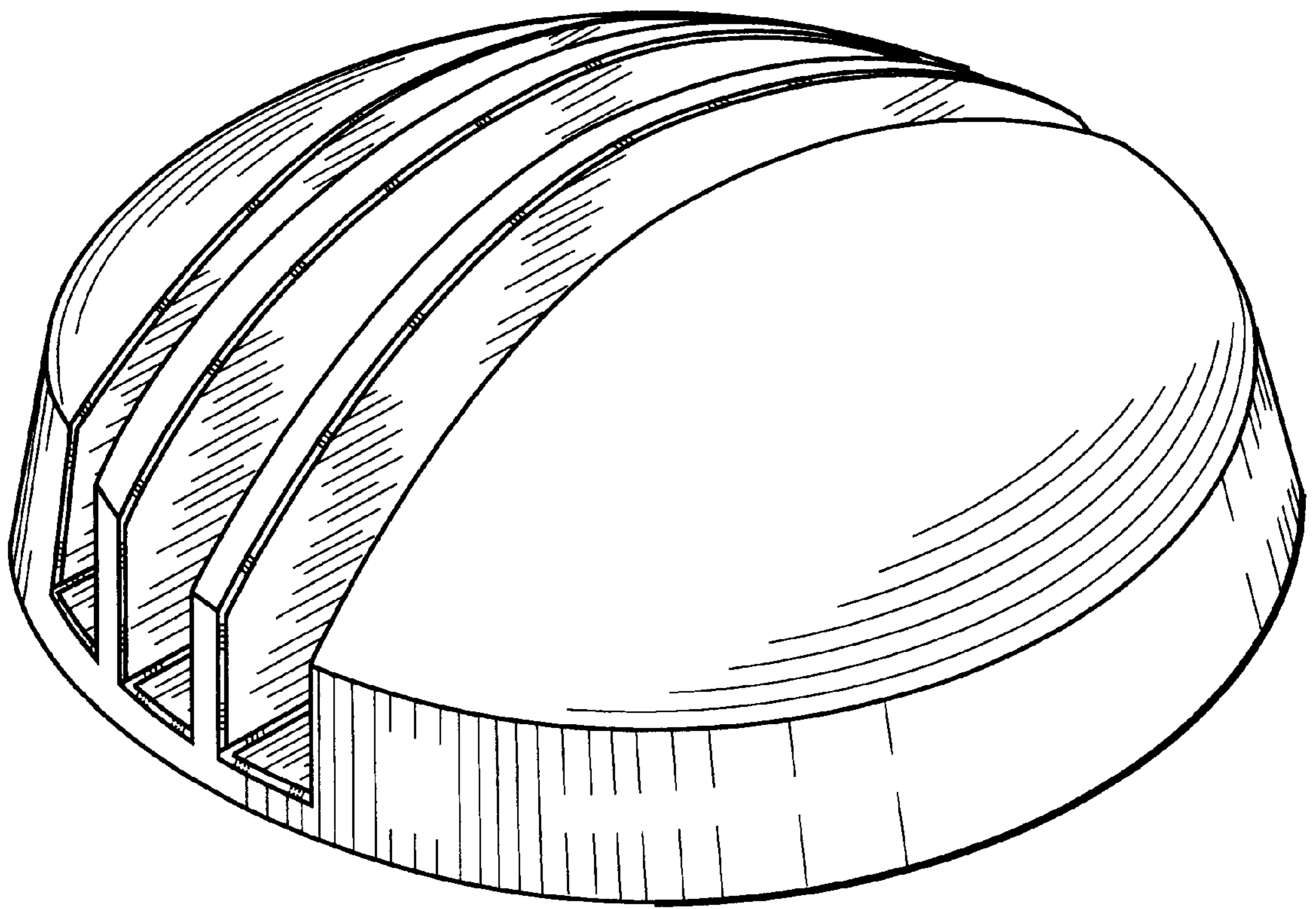

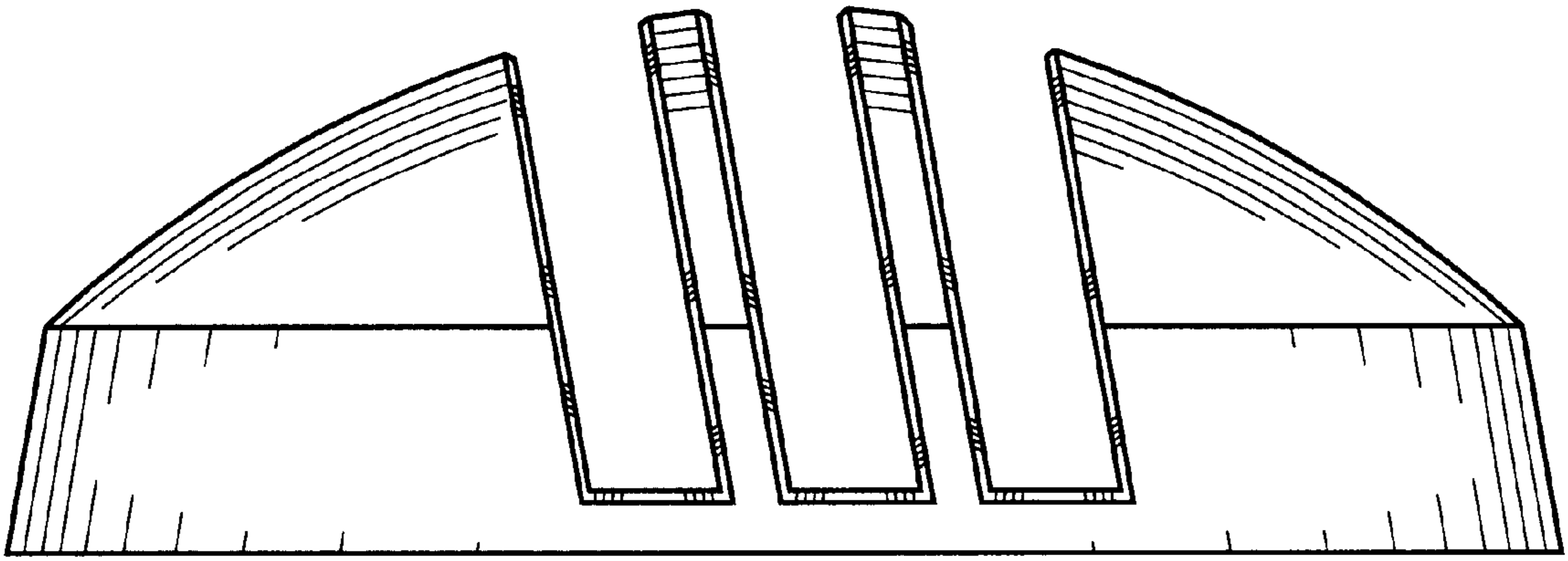

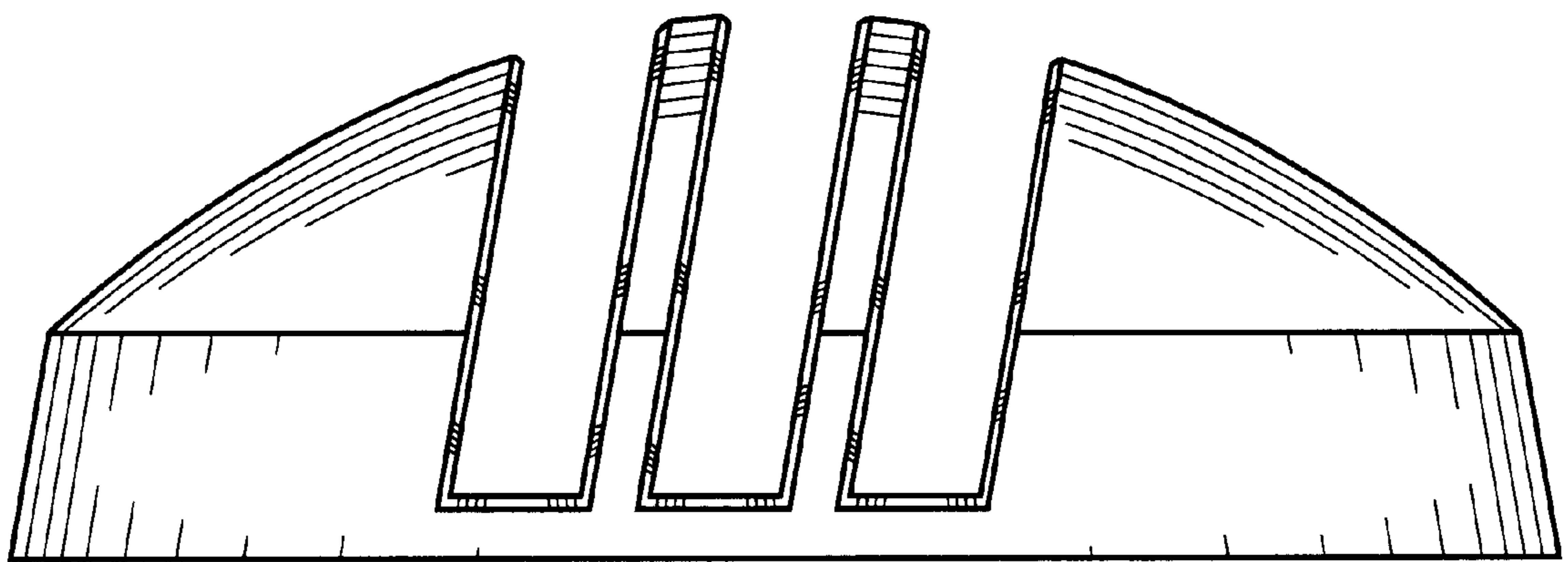

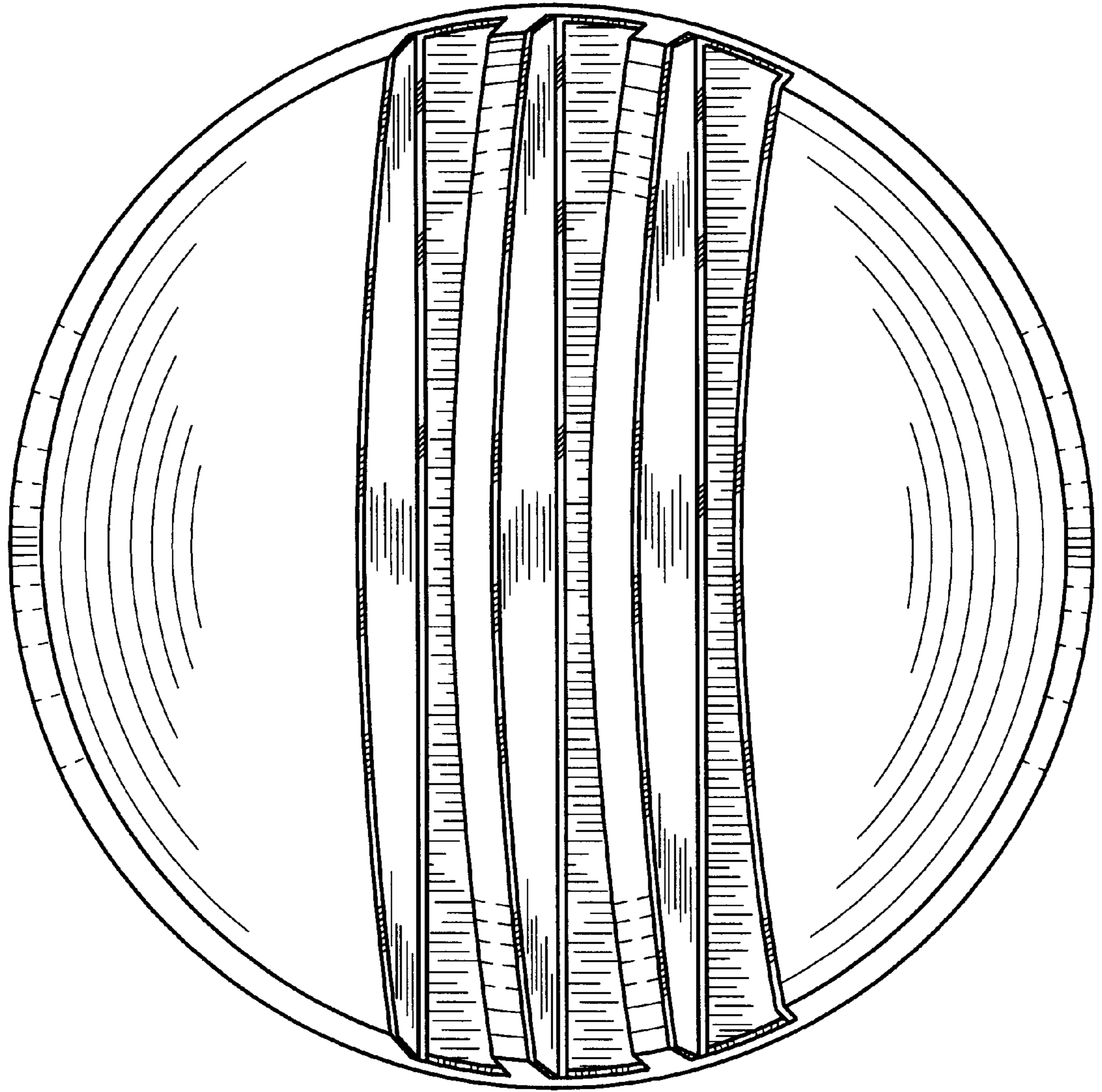

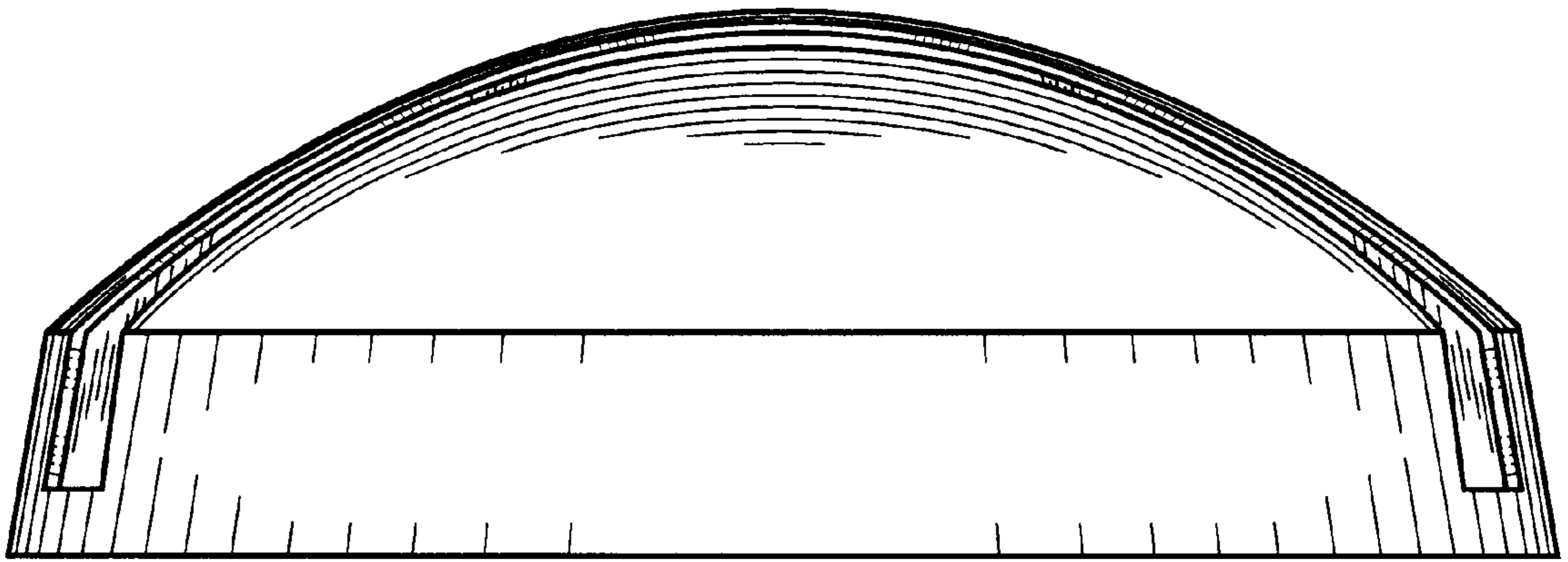

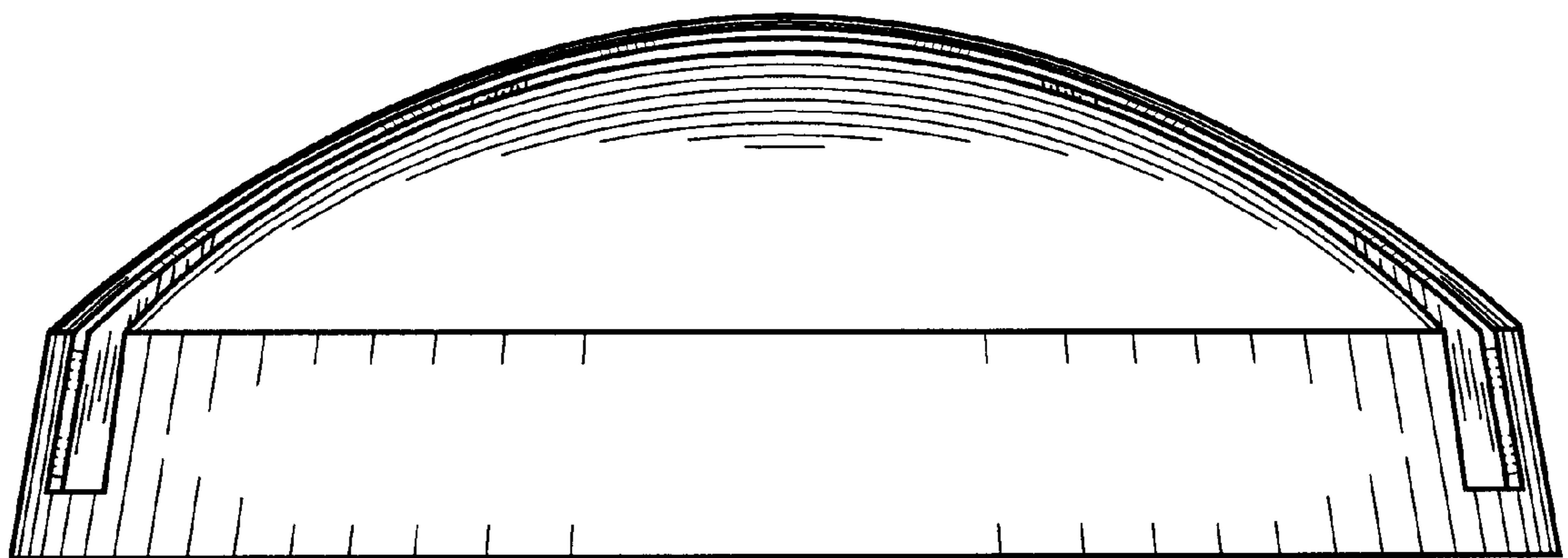

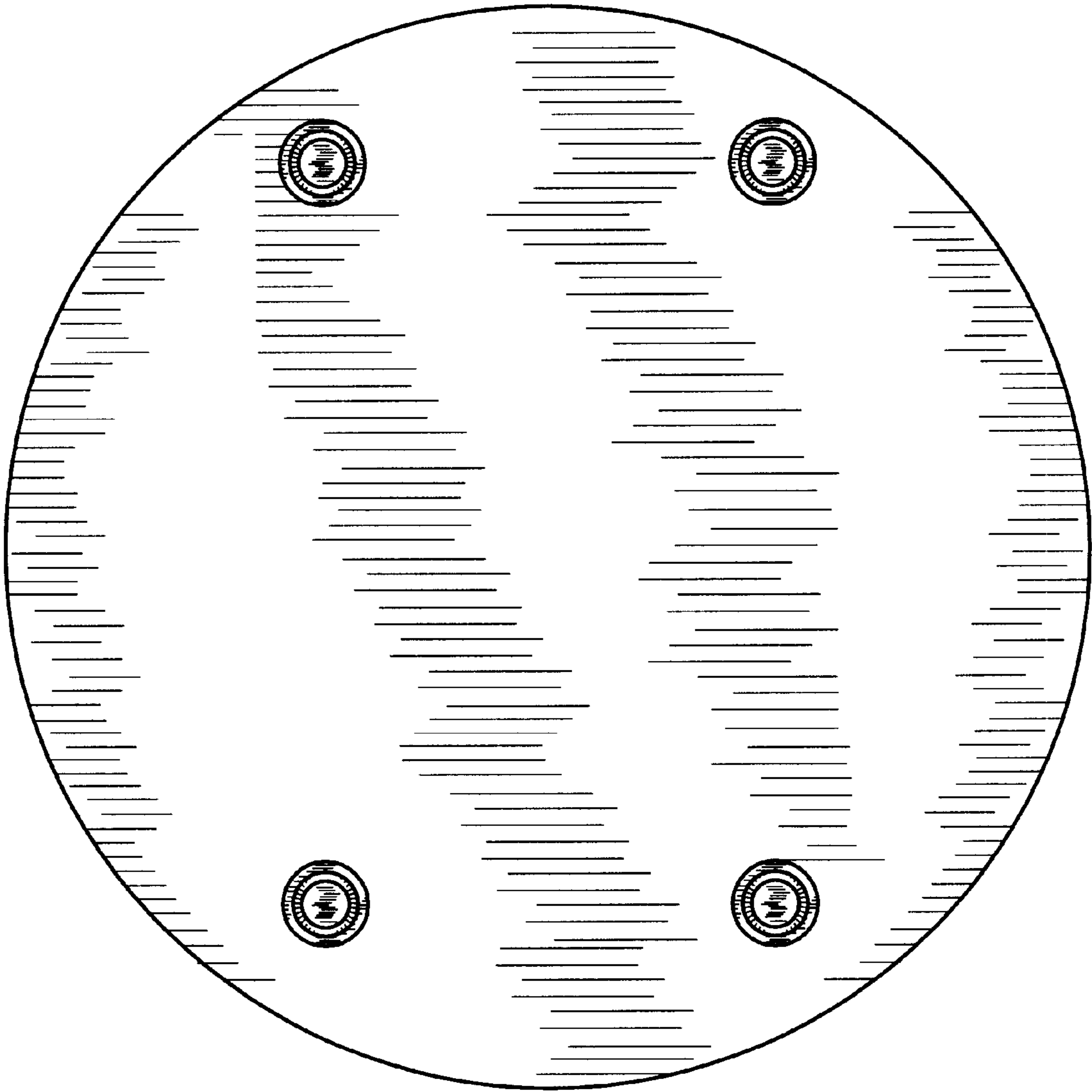
