[57] **CLAIM**

The ornamental design for a rectangular plate with link design border, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a rectangular plate with

link design border, showing our new design.

FIG. 2 is a right side elevational view of the embodiment shown in FIG. 1, the left side elevational view being a mirror image thereof;

FIG. 3 is a bottom plan view of the embodiment shown in FIG. 1, the top plan view being a mirror image thereof;

FIG. 4 is a front elevational view of a rectangular plate with link design border showing a second embodiment of our new design;

FIG. 5 is a right side elevational view of the embodiment shown in FIG. 4, the left side elevational view being a mirror image thereof;

FIG. 6 is a bottom plan view of the embodiment shown in FIG. 4, the top plan view being a mirror image thereof;

FIG. 7 is a front elevational view of a rectangular plate with link design border showing a third embodiment of our new design;

FIG. 8 is a right side elevational view of the embodiment shown in FIG. 7, the left side elevational view being a mirror image thereof;

FIG. 9 is a bottom plan view of the embodiment shown in FIG. 7, the top plan view being a mirror image thereof;

FIG. 10 is a rear elevational view of the embodiment shown in FIG. 7;

FIG. 11 is a cross-sectional view taken along the lines 11—11 of FIG. 7;

FIG. 12 is a cross-sectional view taken along the lines 12—12 of FIG. 7;

FIG. 13 is a front elevational view of a rectangular plate with link design border showing a fourth embodiment of our new design;

FIG. 14 is a right side elevational view of the embodiment shown in FIG. 13, the left side elevational view being a mirror image thereof;

FIG. 15 is a bottom plan view of the embodiment shown in FIG. 13, the top plan view being a mirror image thereof;

FIG. 16 is a front elevational view of a rectangular plate with link design border showing a fifth embodiment of our new design;

FIG. 17 is a right side elevational view of the embodiment shown in FIG. 16, the left side elevational view being a mirror image thereof;

FIG. 18 is a bottom plan view of the embodiment shown in FIG. 16, the top plan view being a mirror image thereof;

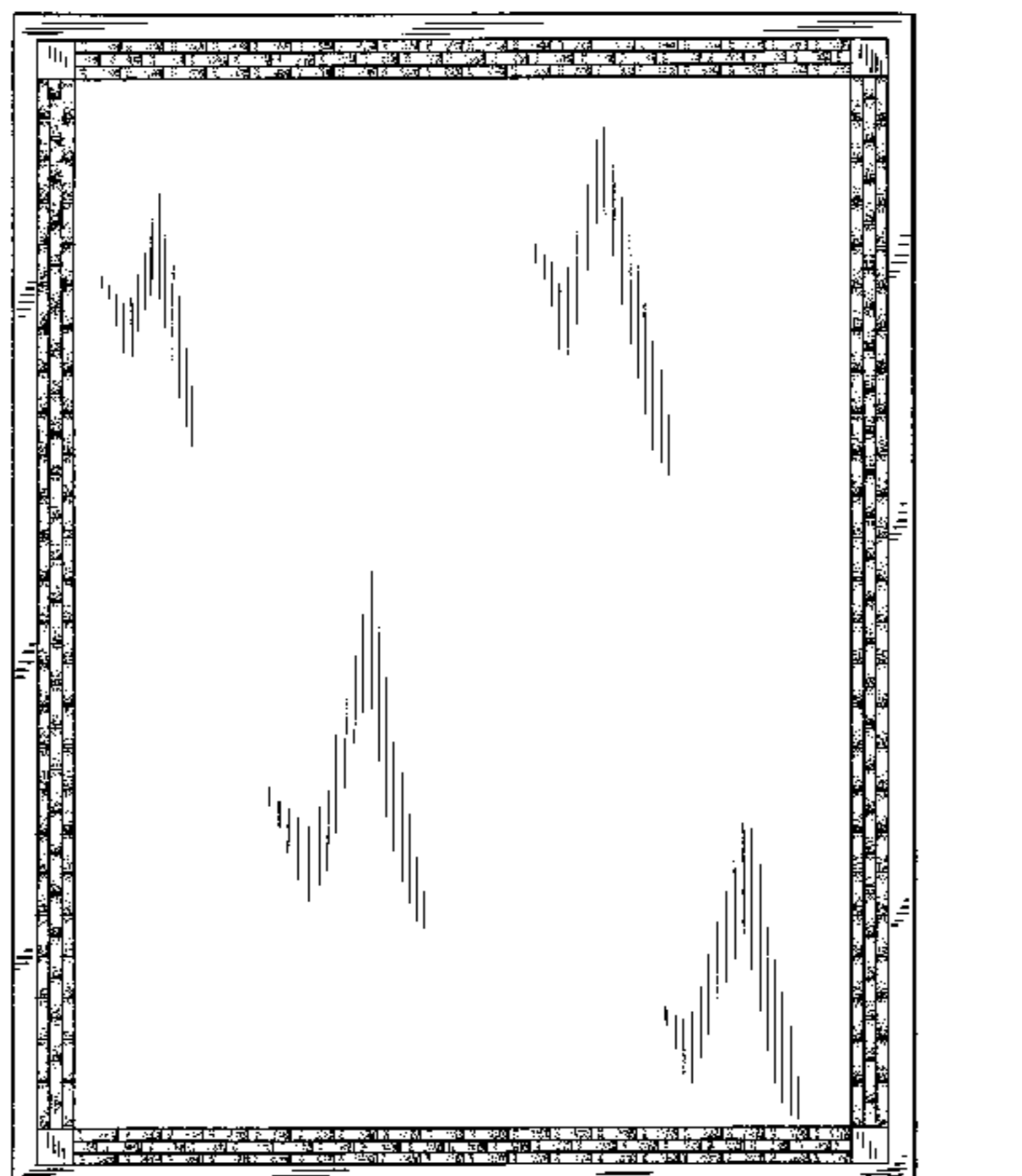


FIG. 19 is a front elevational view of a rectangular plate with link design border showing a sixth embodiment of our new design;

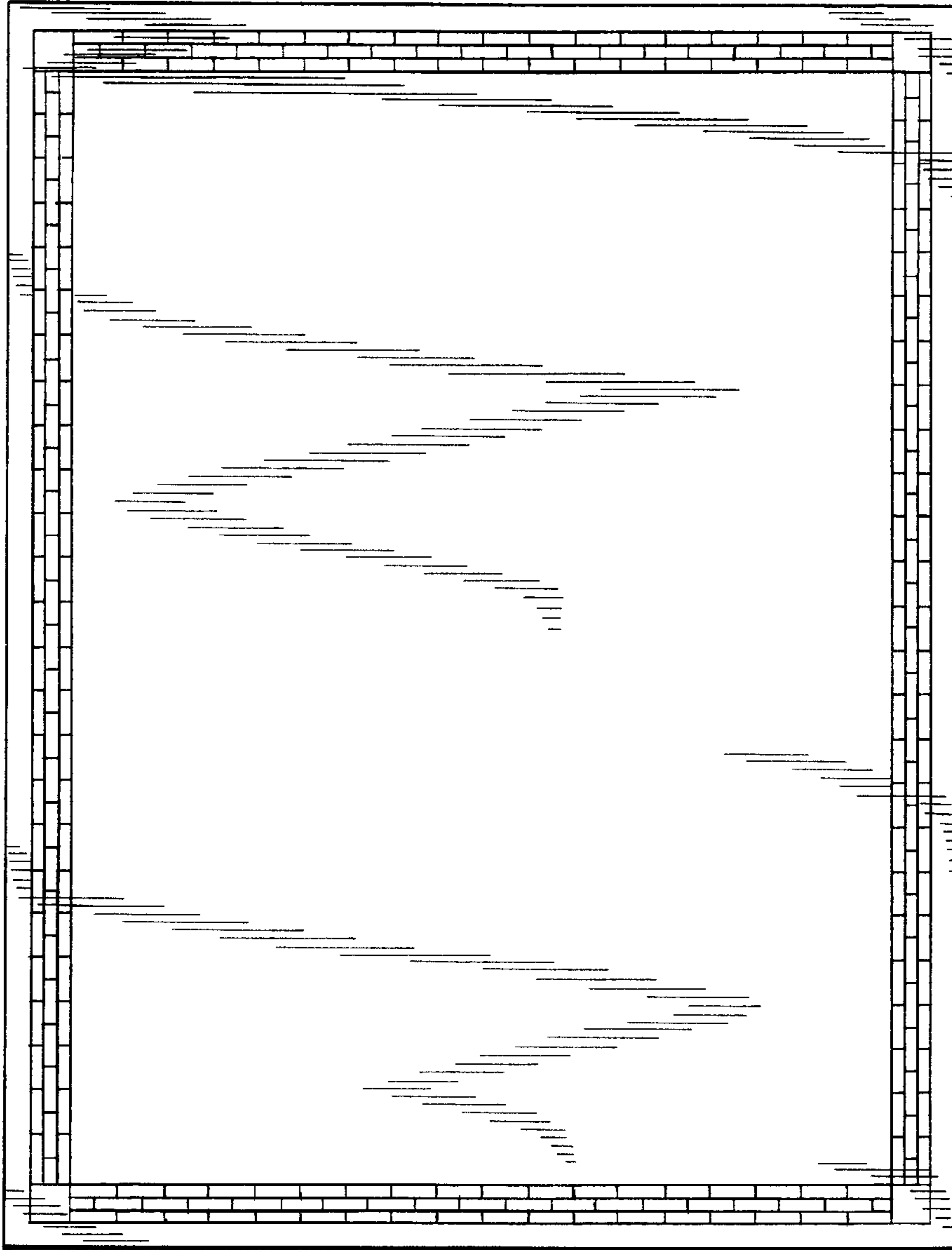

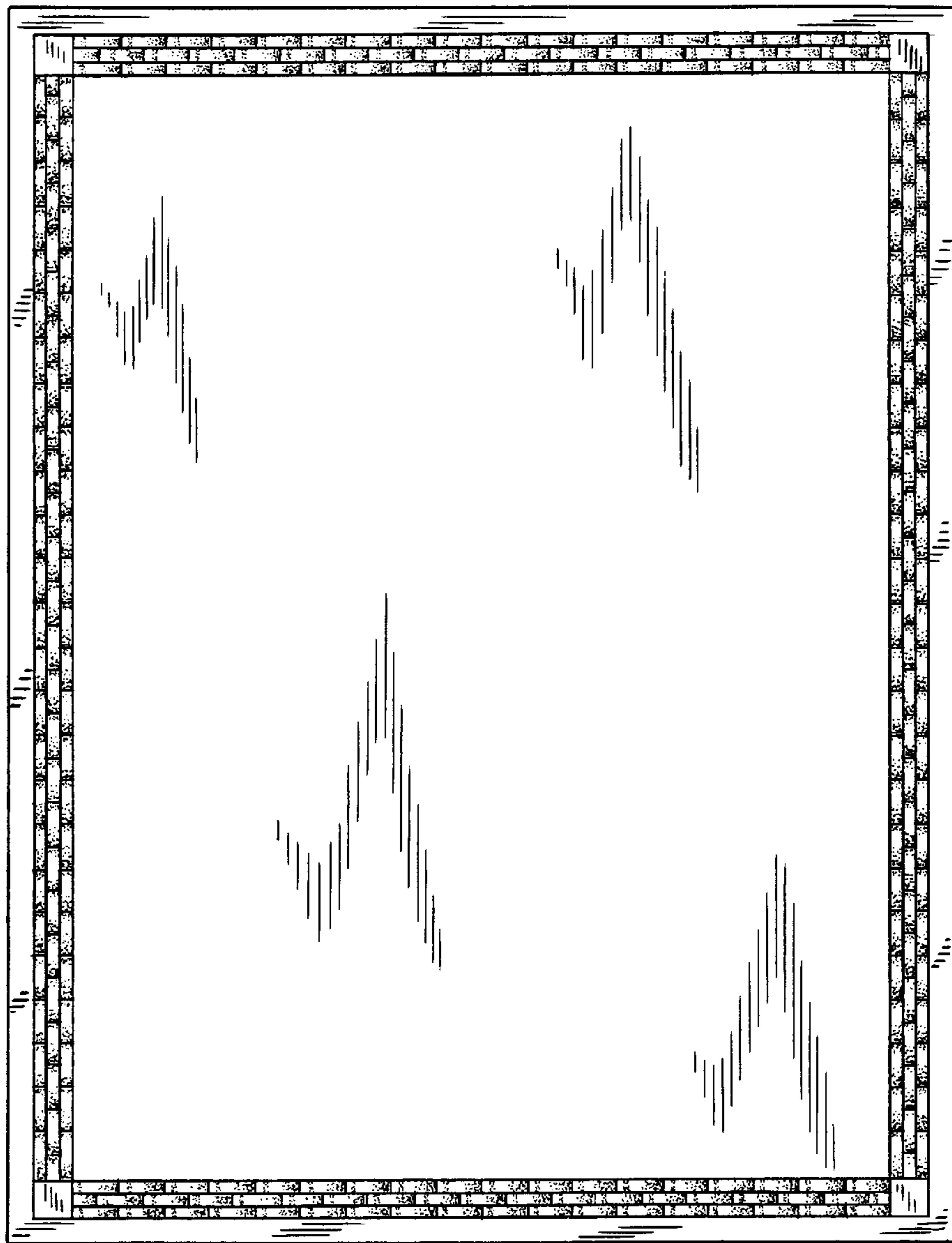

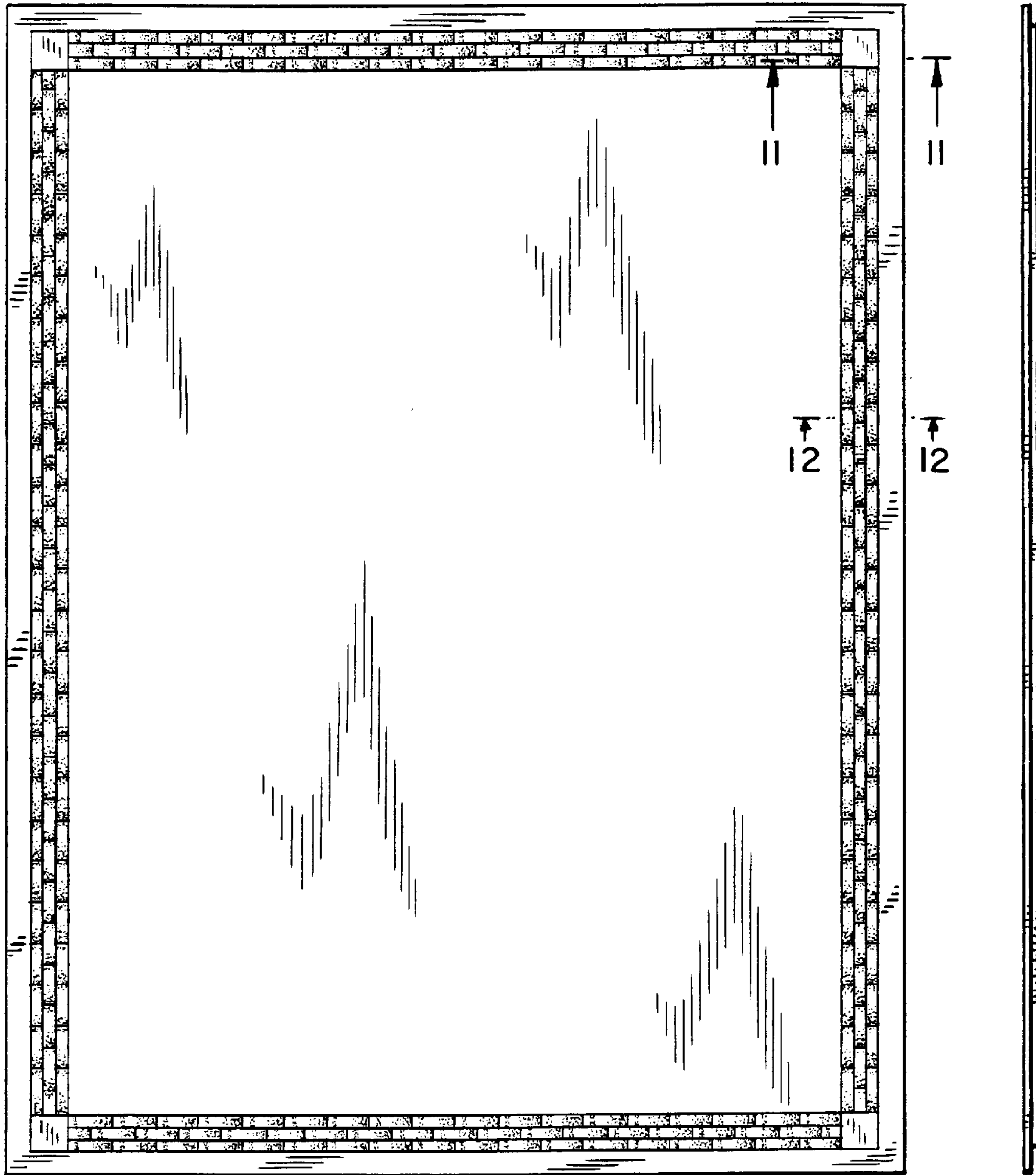

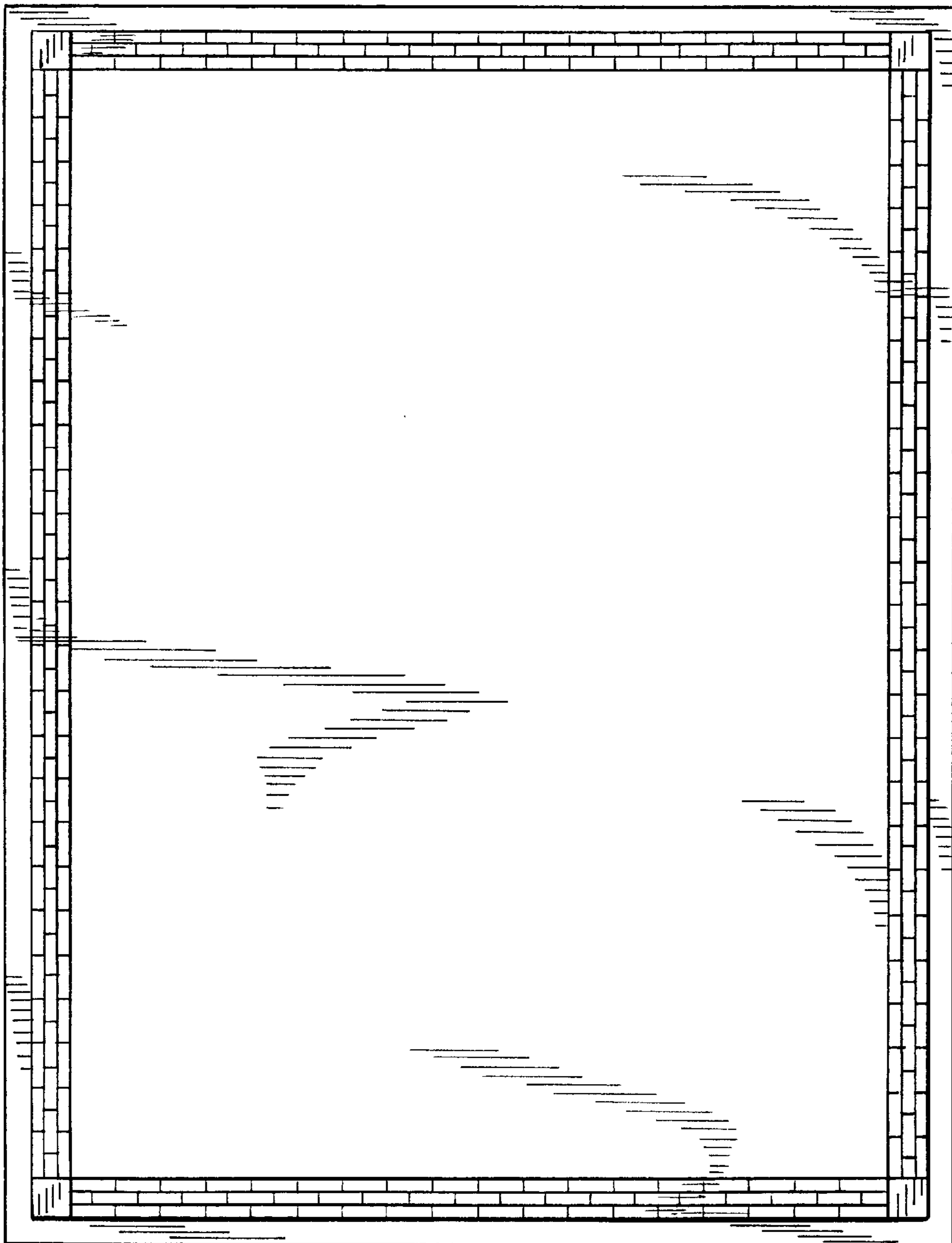

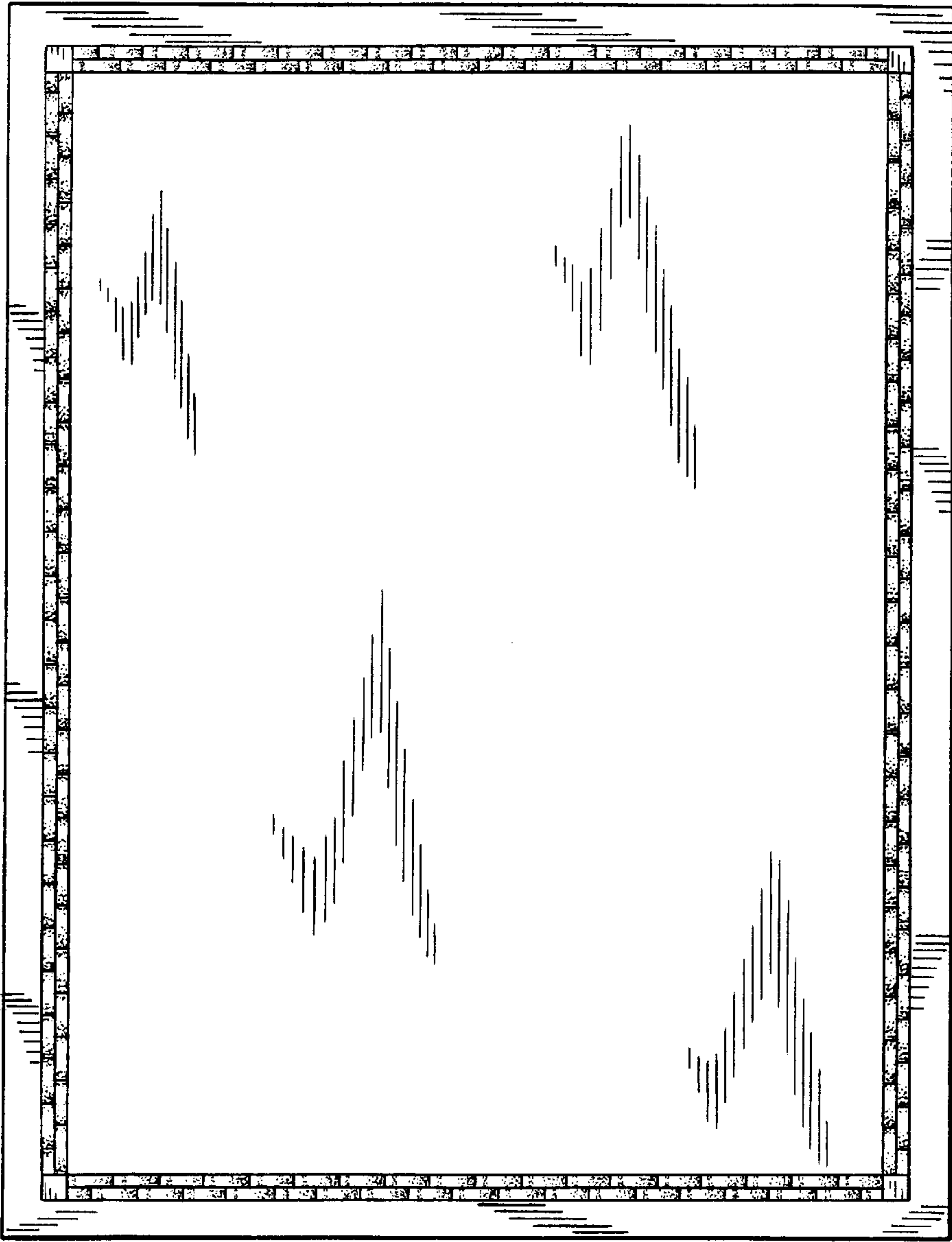

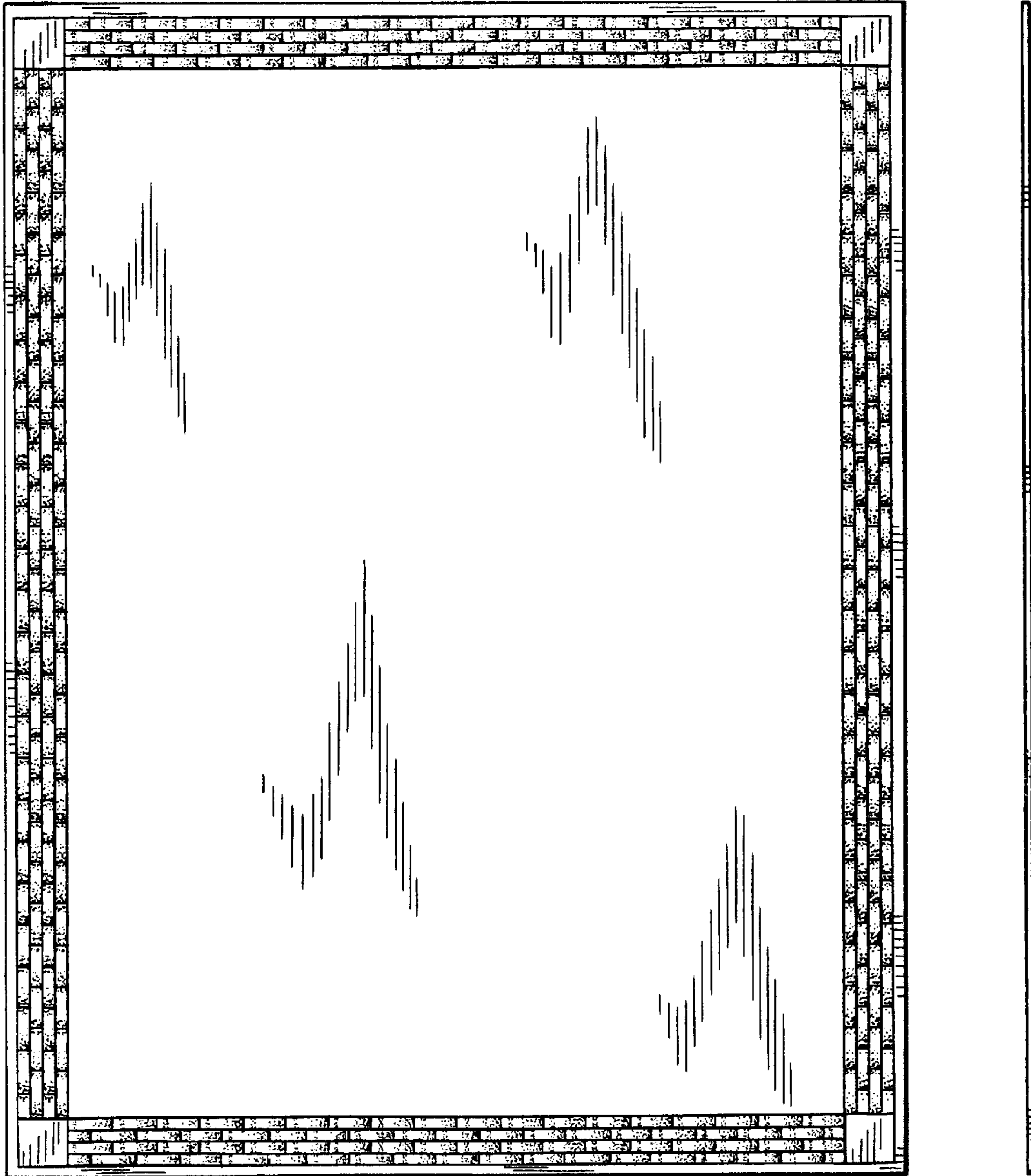

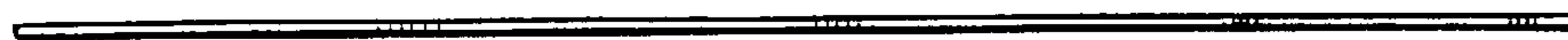
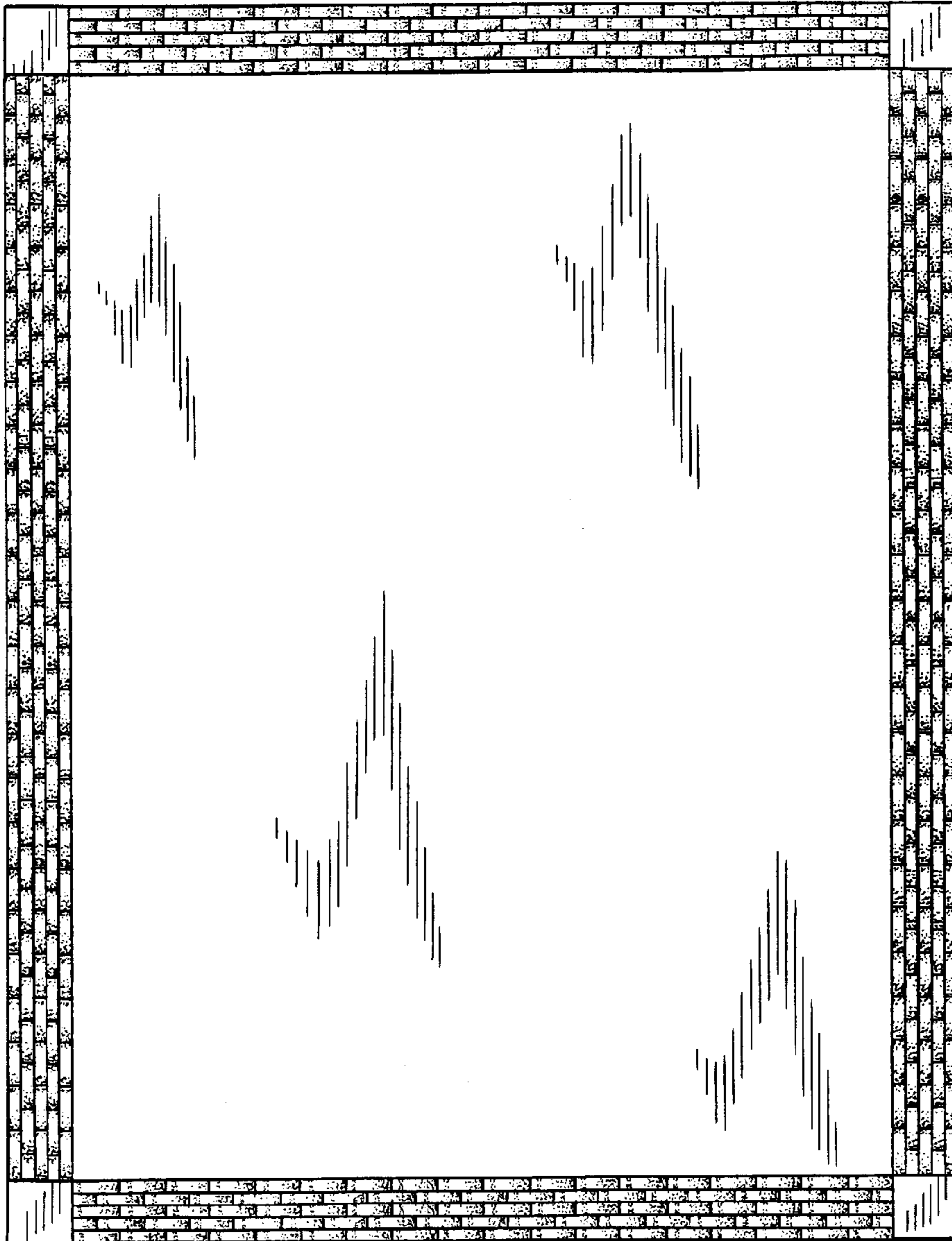
