[57] **CLAIM**

The ornamental design for a combined gemstone and setting, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a combined gemstone and setting showing my new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a side elevational view thereof, the opposite side view being a mirror image;

FIG. 4 is a rear elevational view thereof;

FIG. 5 is a top, front, right side perspective view thereof;

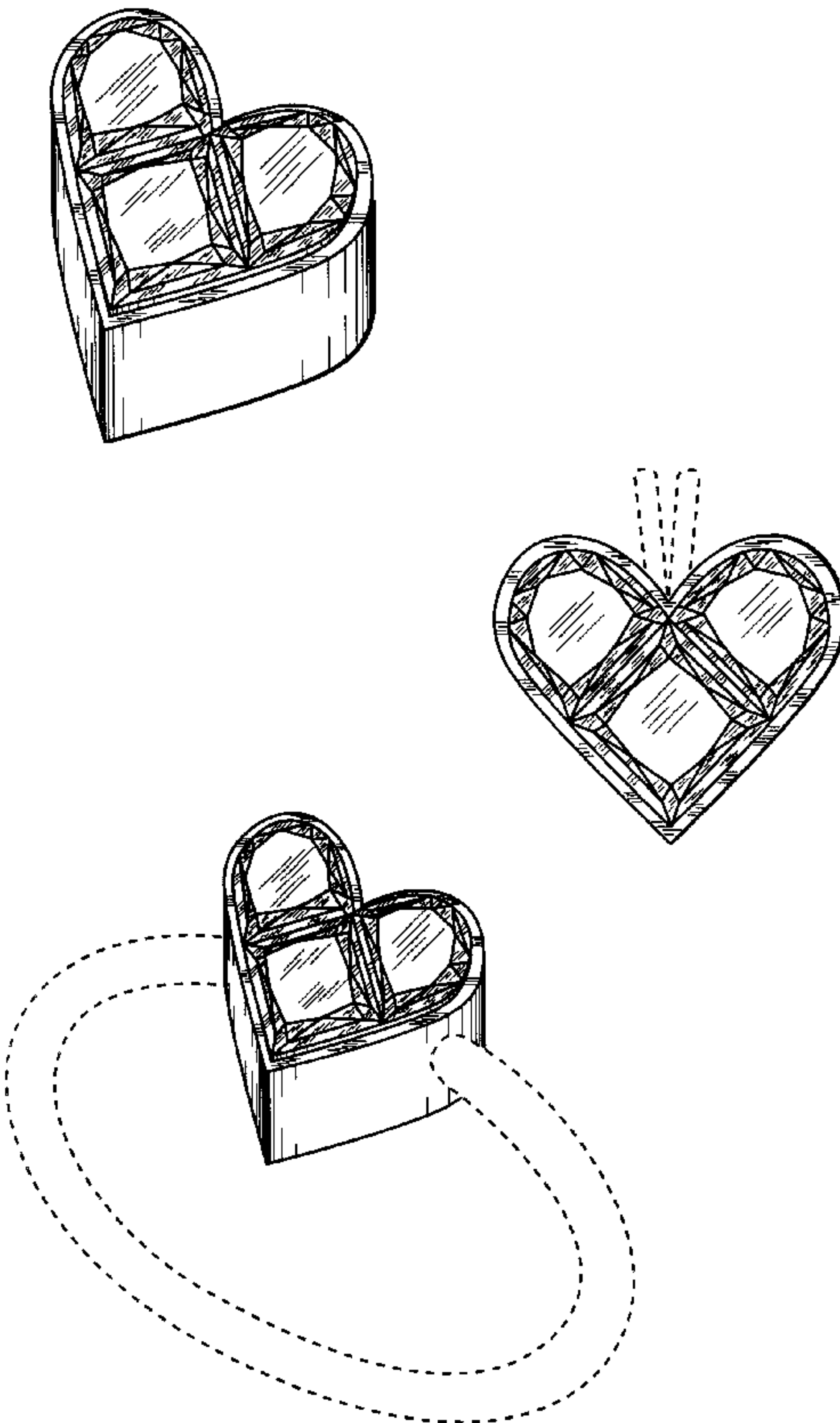
FIG. 6 is another top plan view thereof;

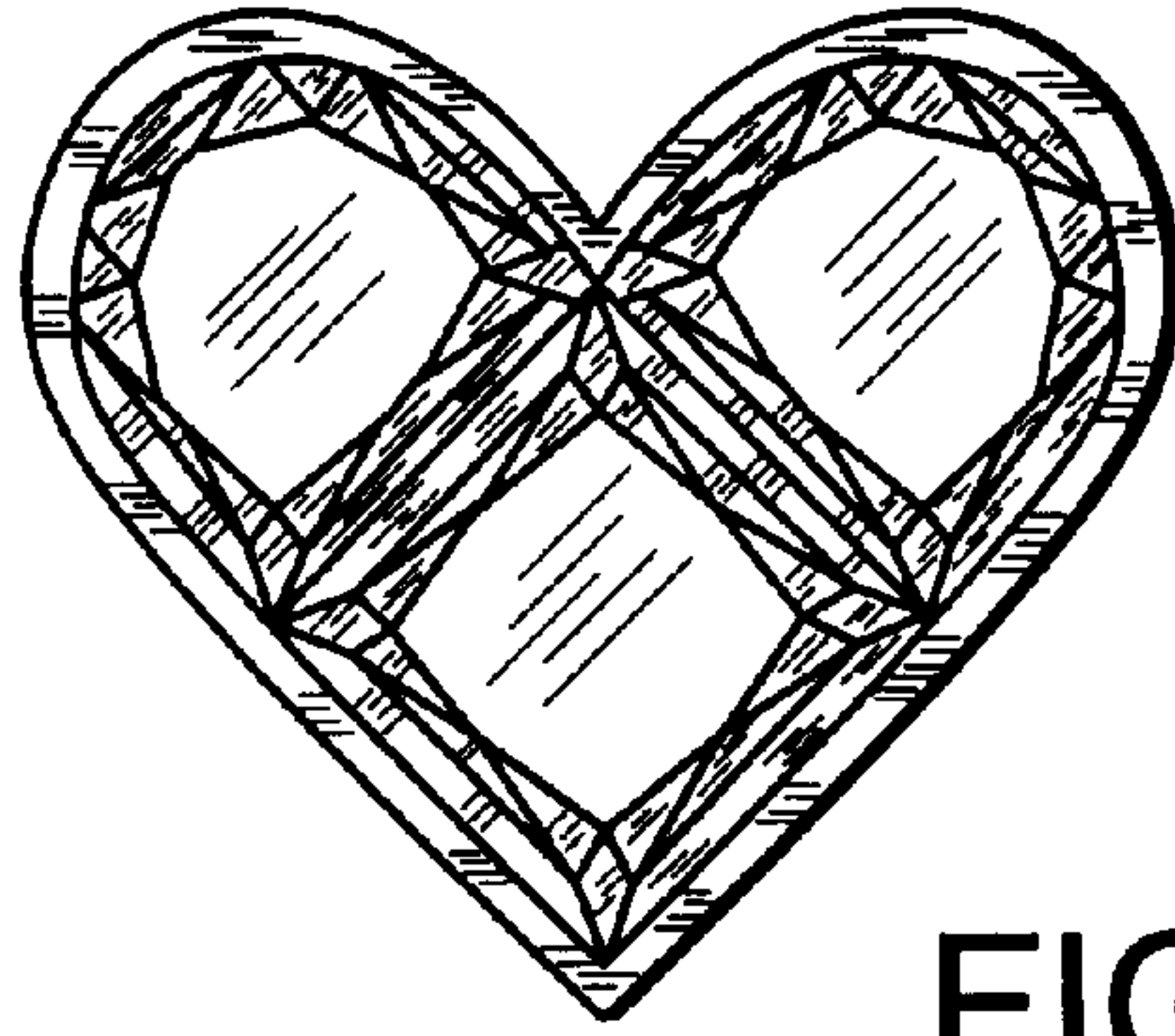

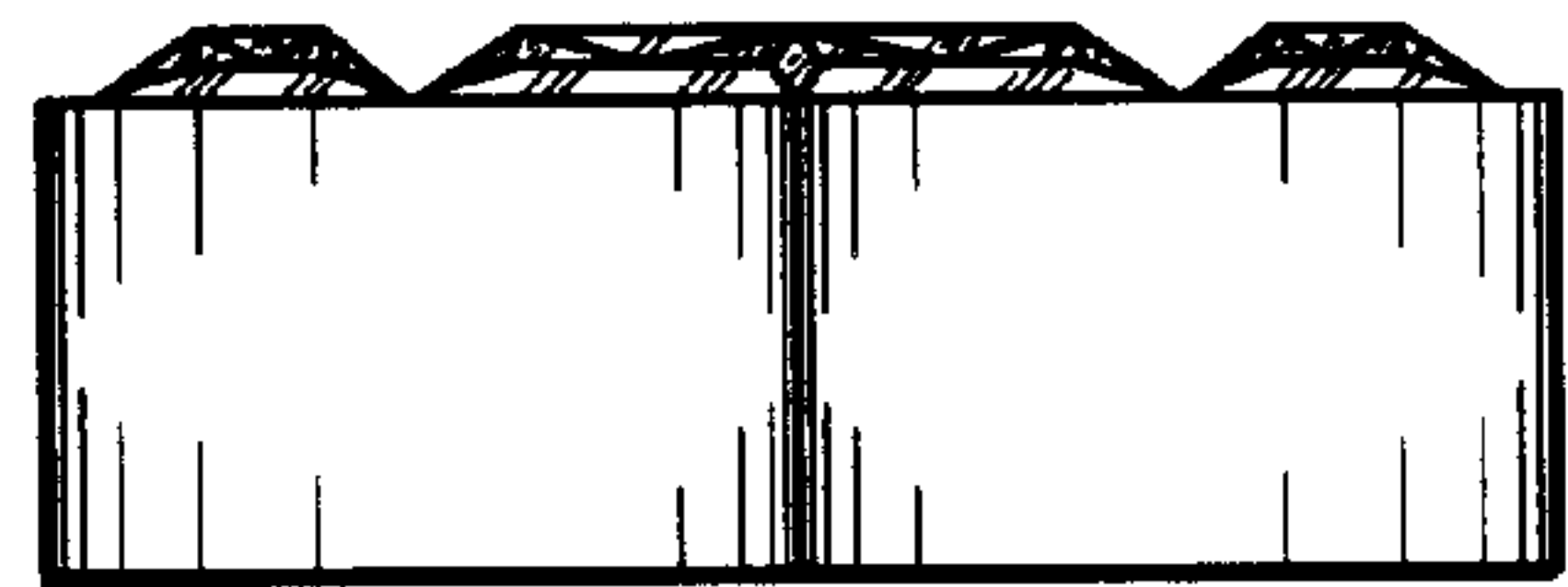

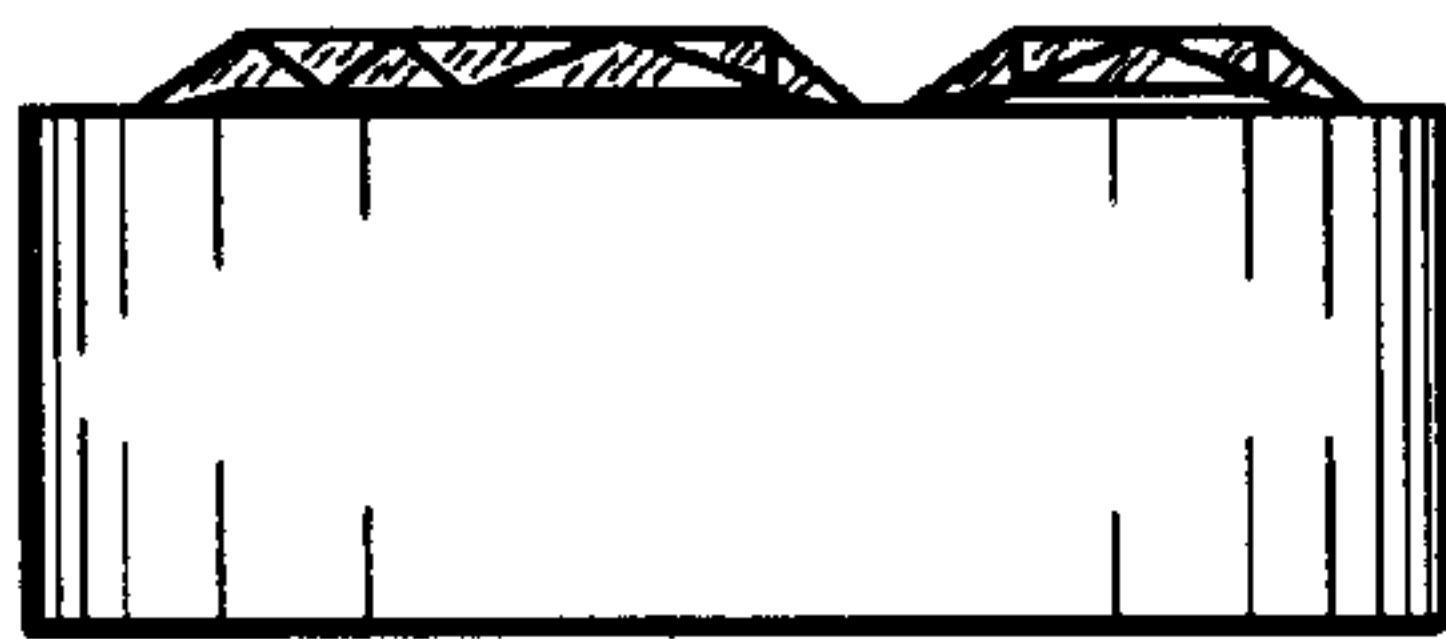

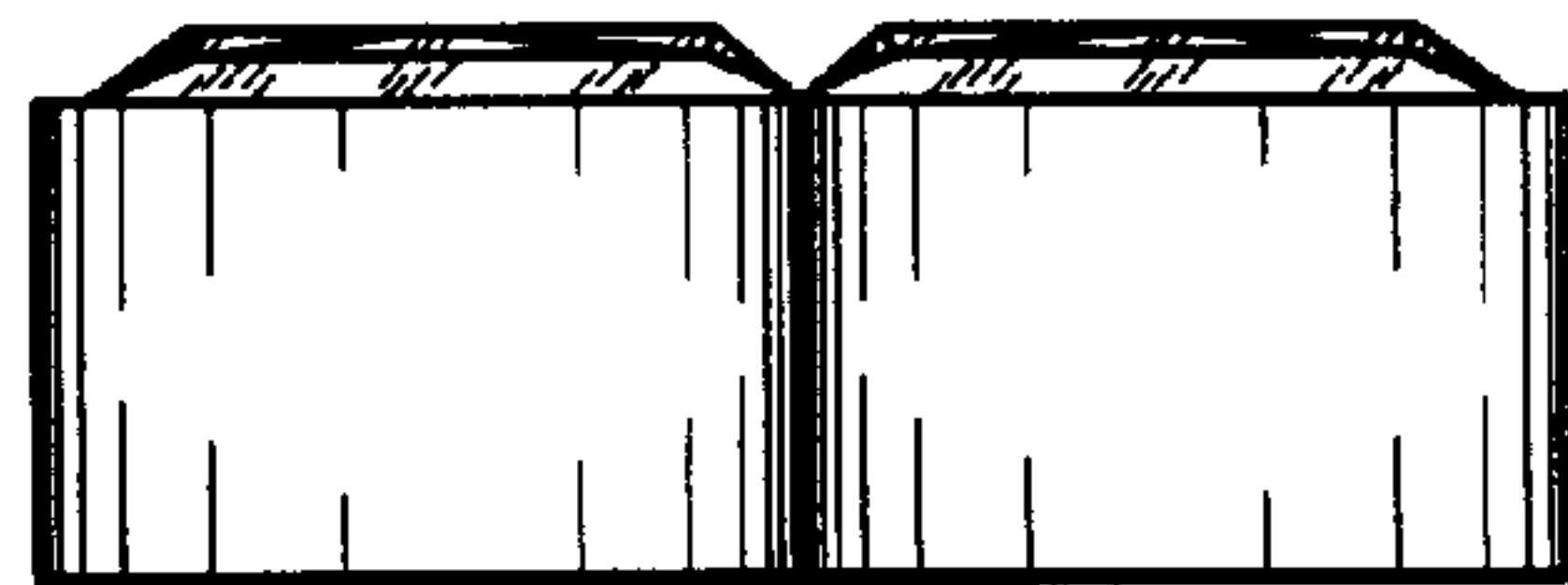

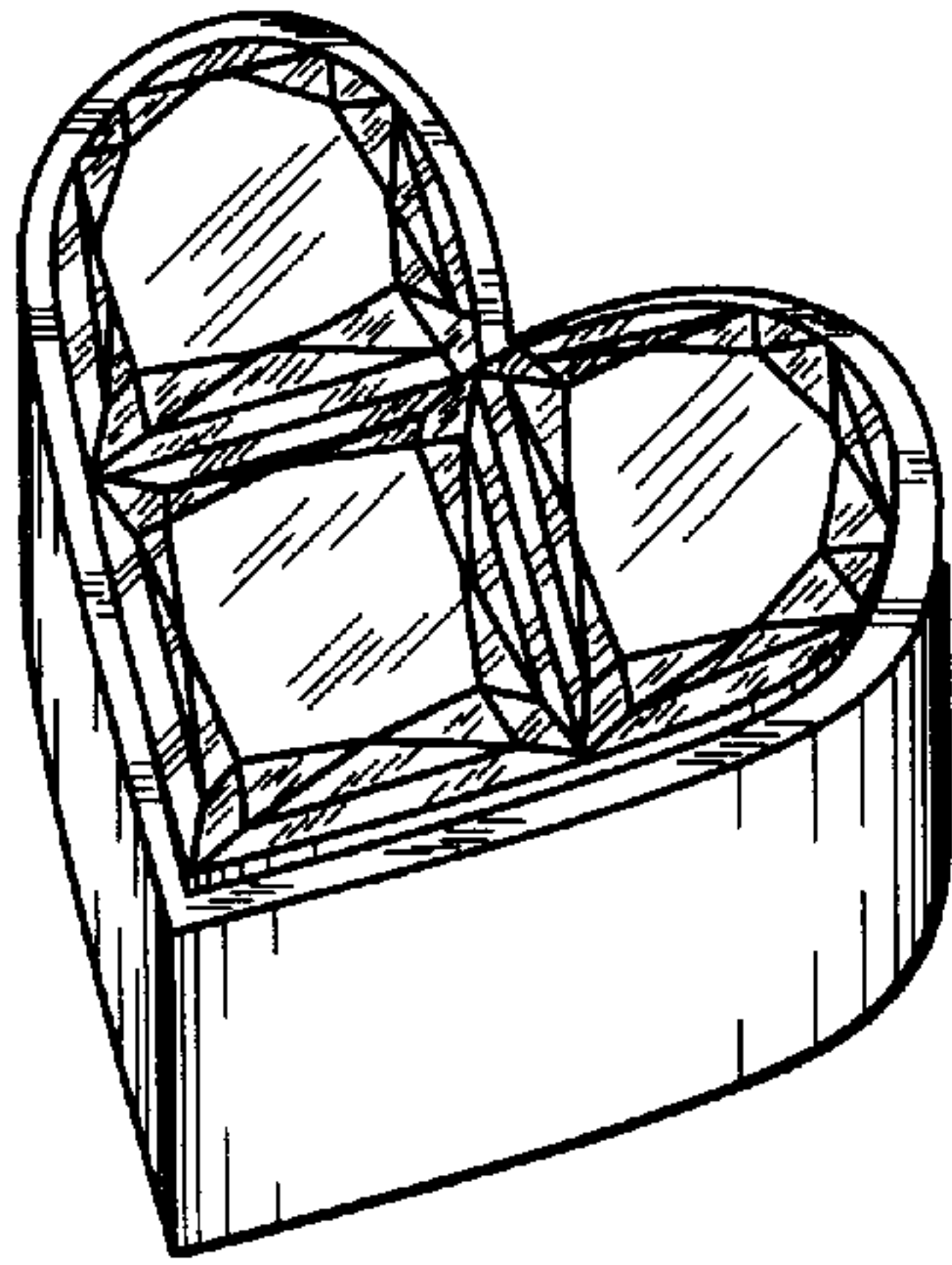

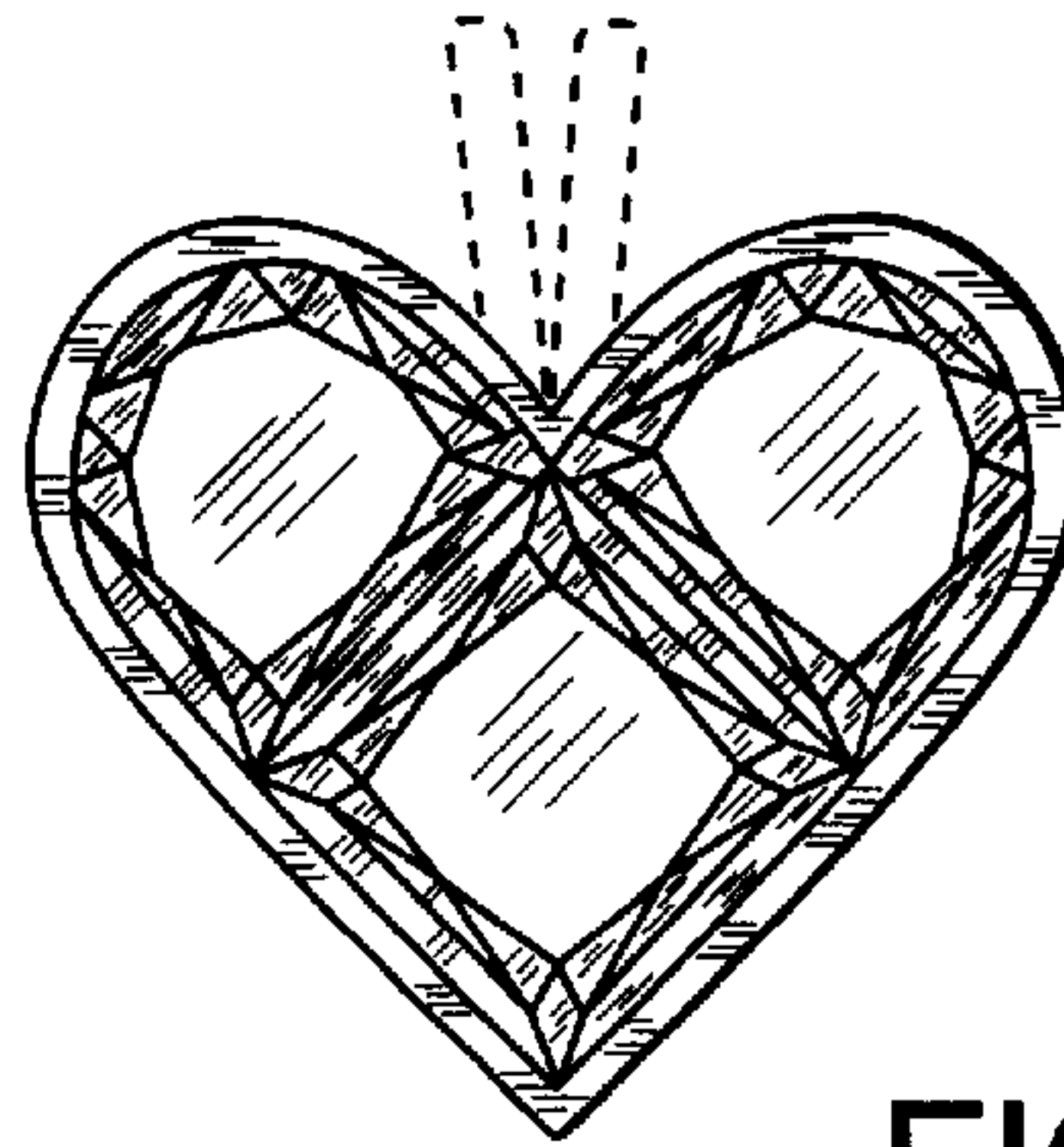

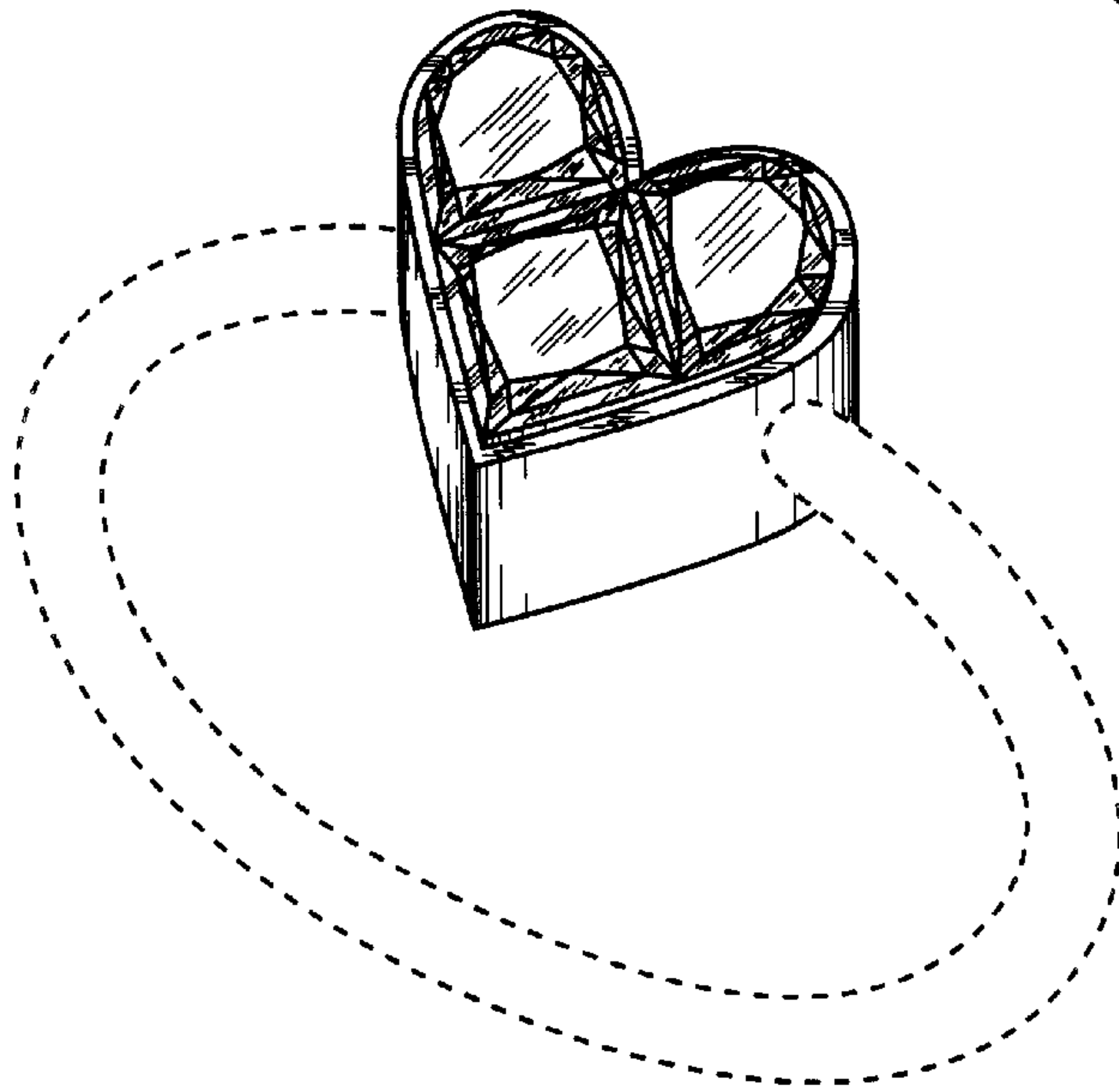

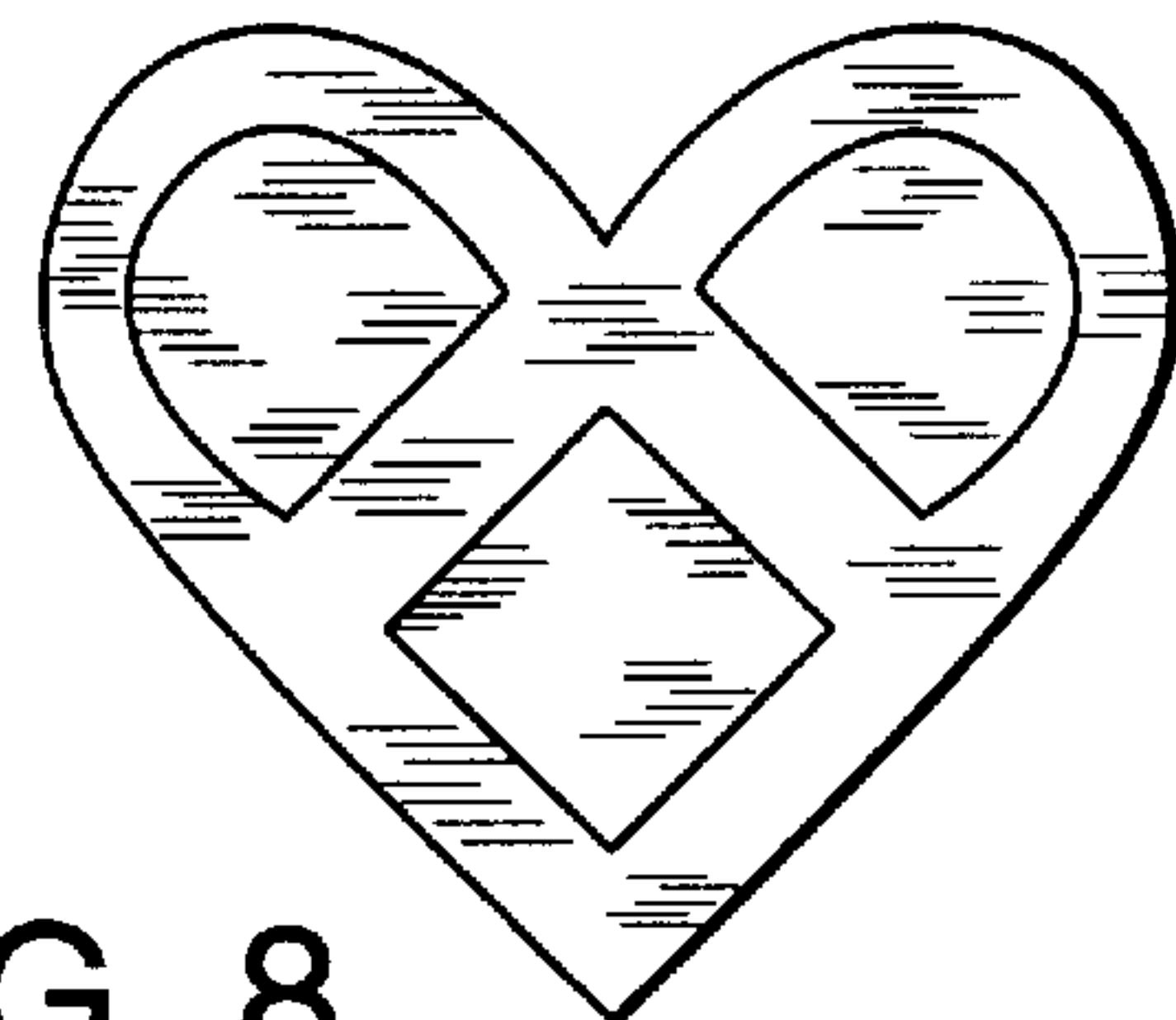
