FIG. 2 is a top view of the detachable storage container for a vehicle of FIG. 1, shown on a reduced scale.

FIG. 3 is a rear view of the detachable storage container of FIG. 2.

FIG. 4 is a bottom view of the detachable storage container of FIG. 2;

FIG. 5 is a left side view of the detachable storage container of FIG. 2, shown on a slightly enlarged scale.

FIG. 6 is a right side view of the detachable storage container of FIG. 5.

FIG. 7 is a front view of the detachable storage container of FIG. 2; and,

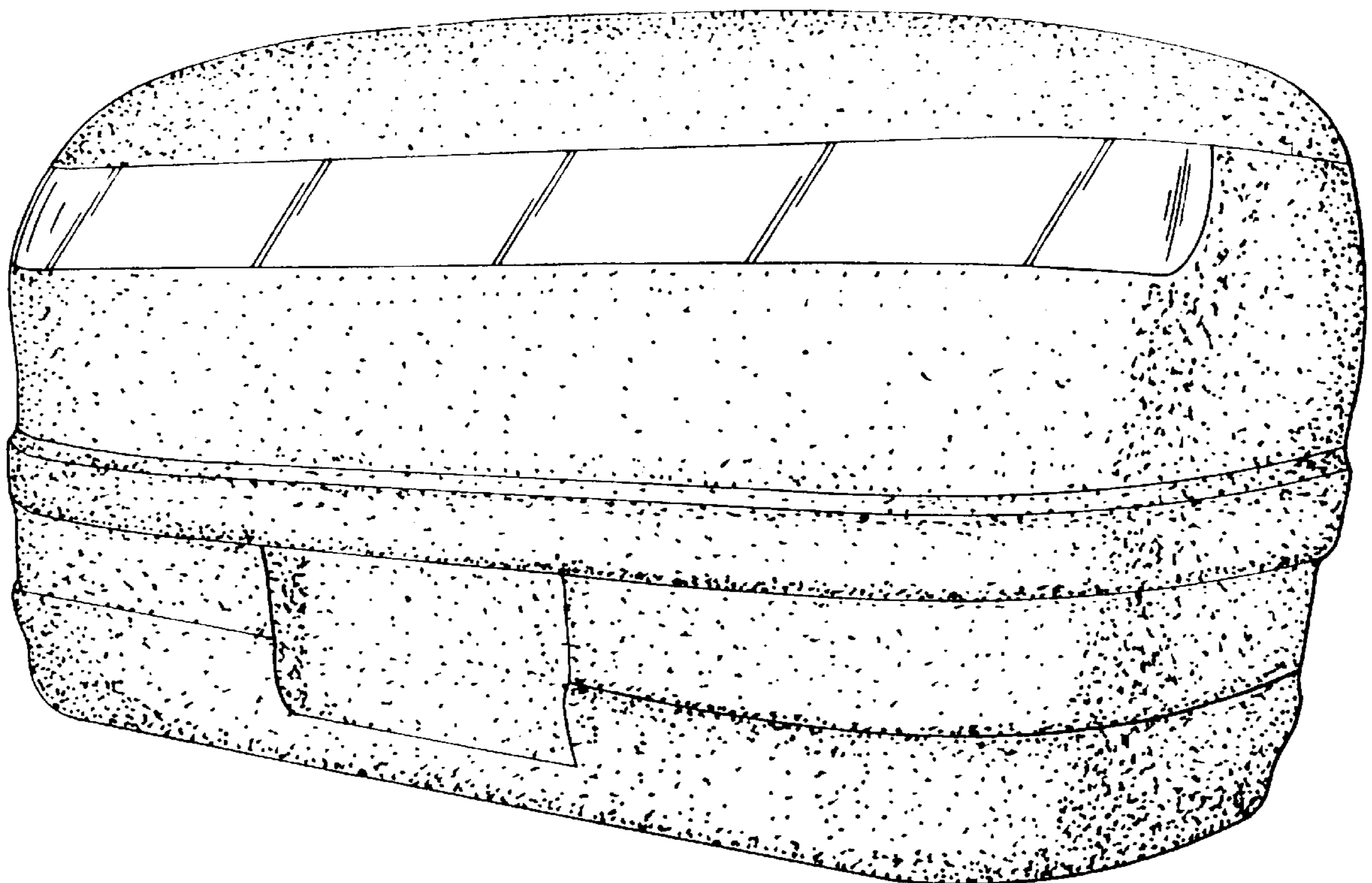

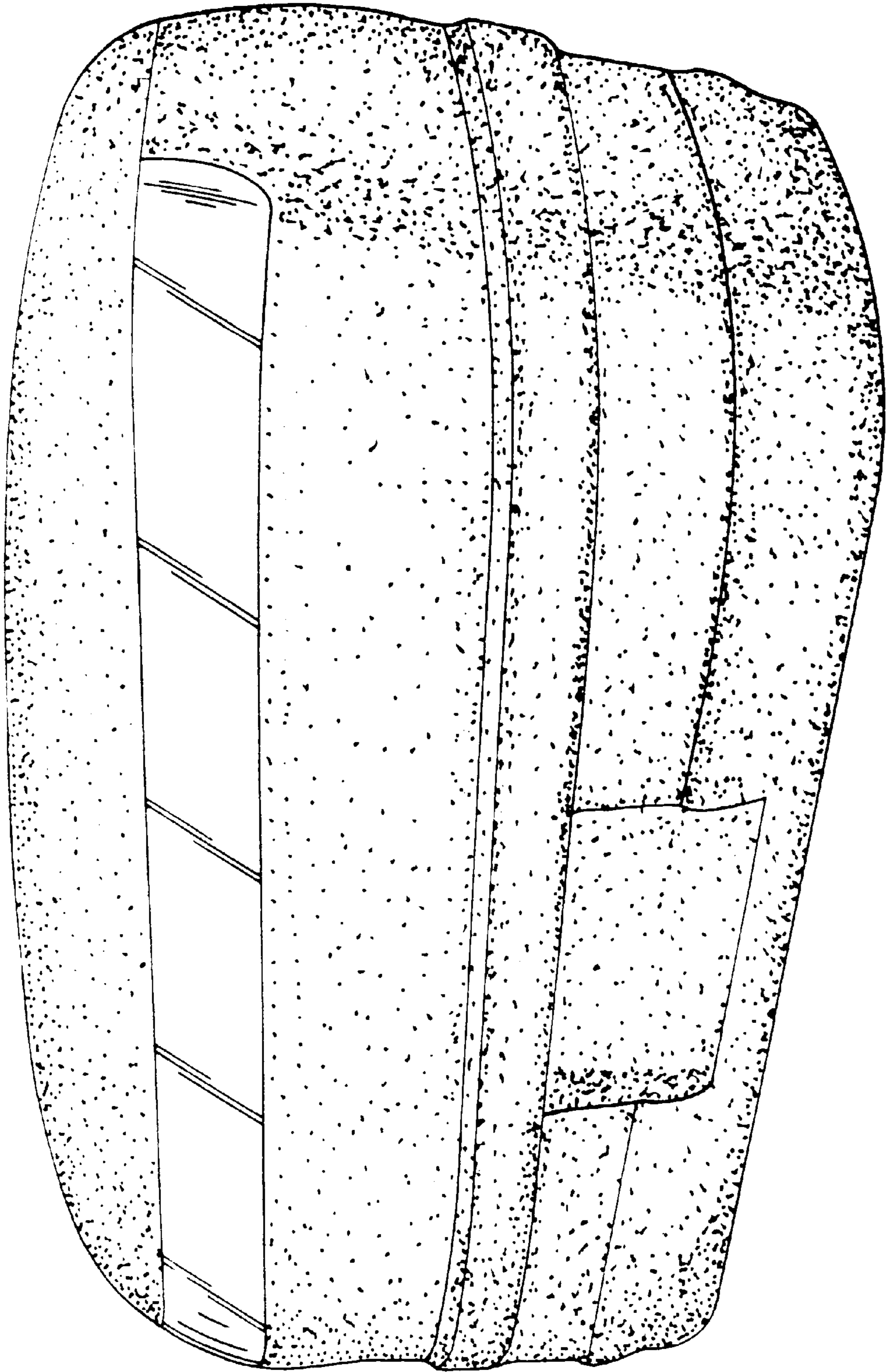

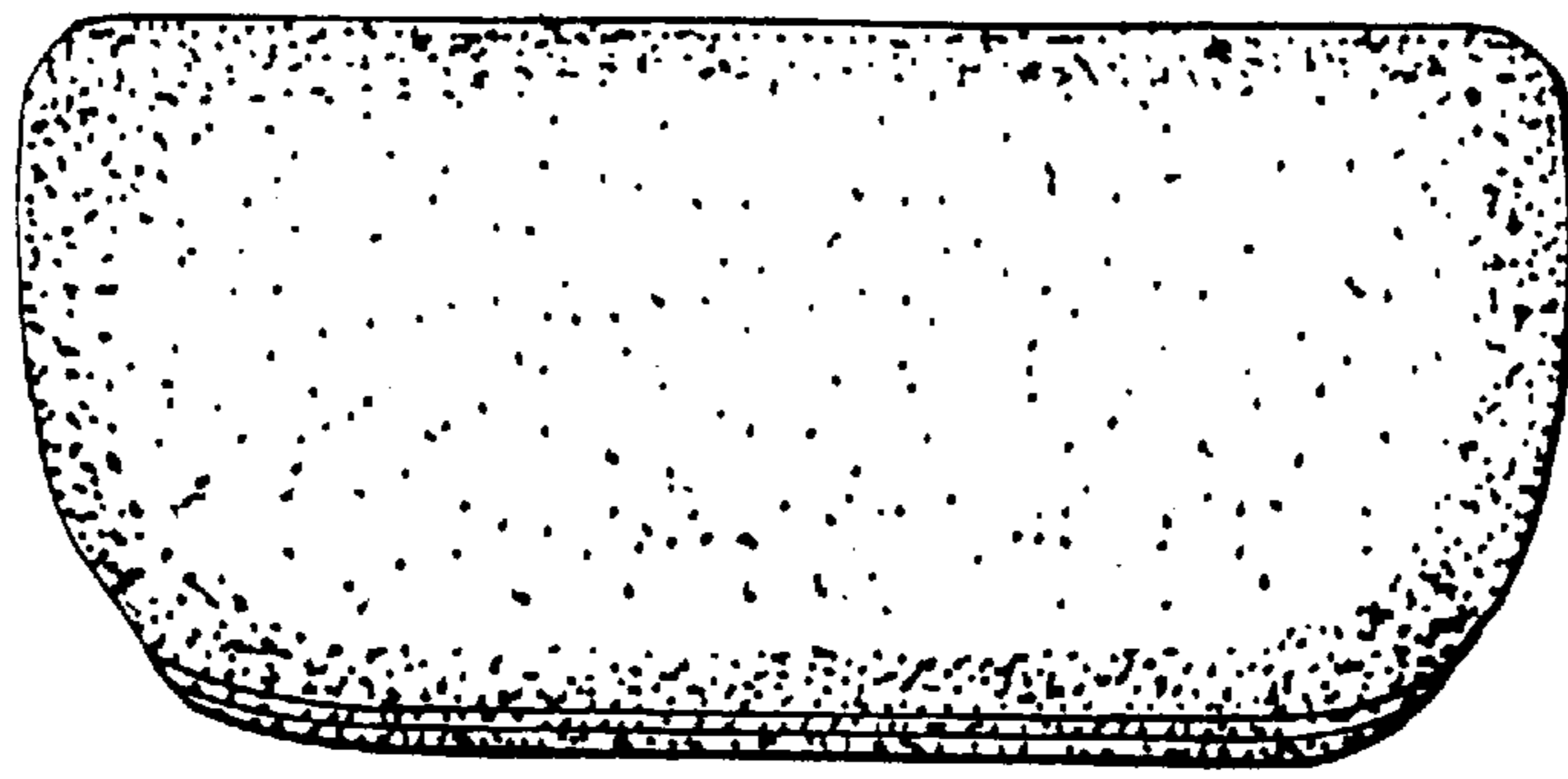

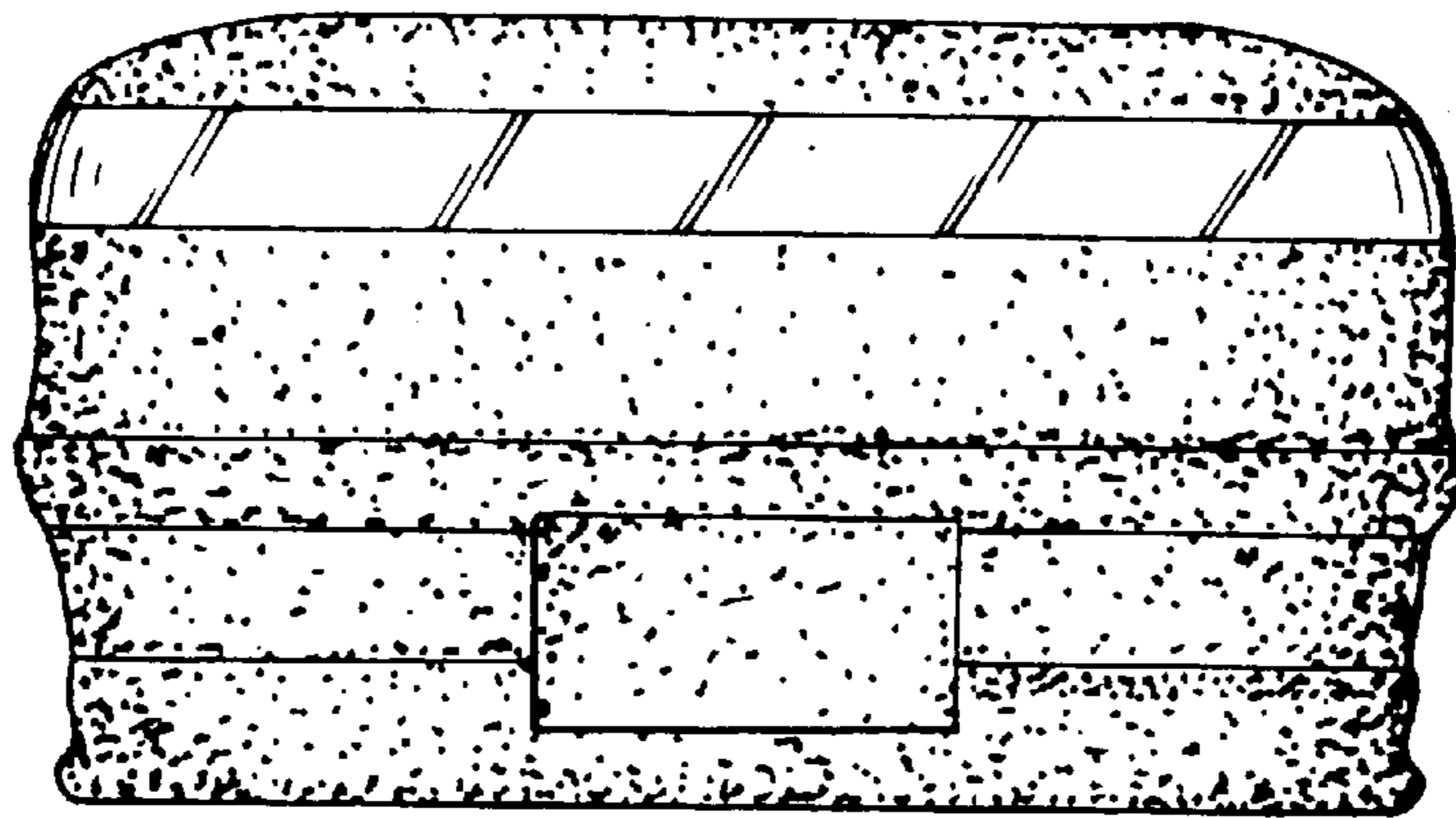

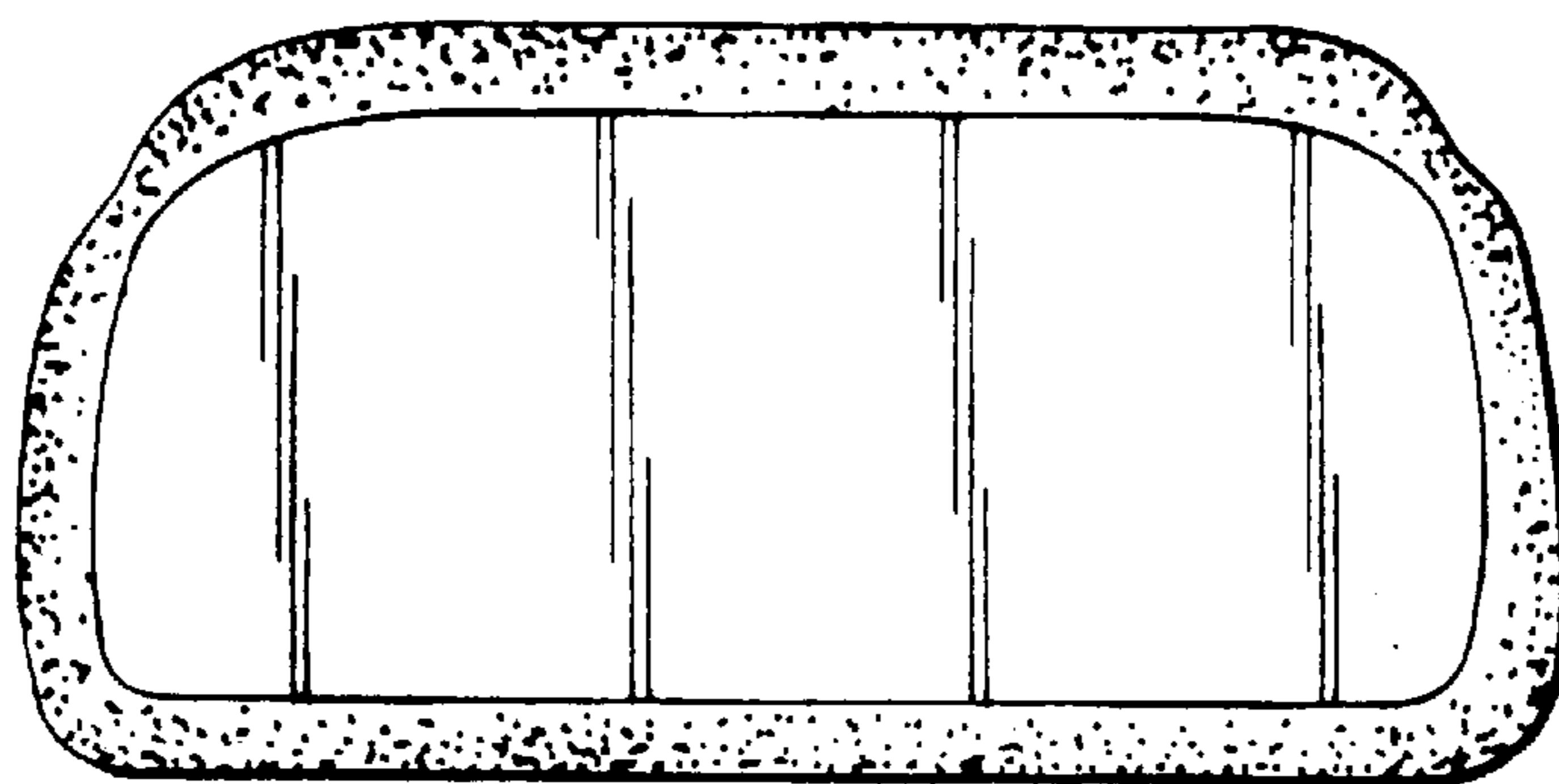

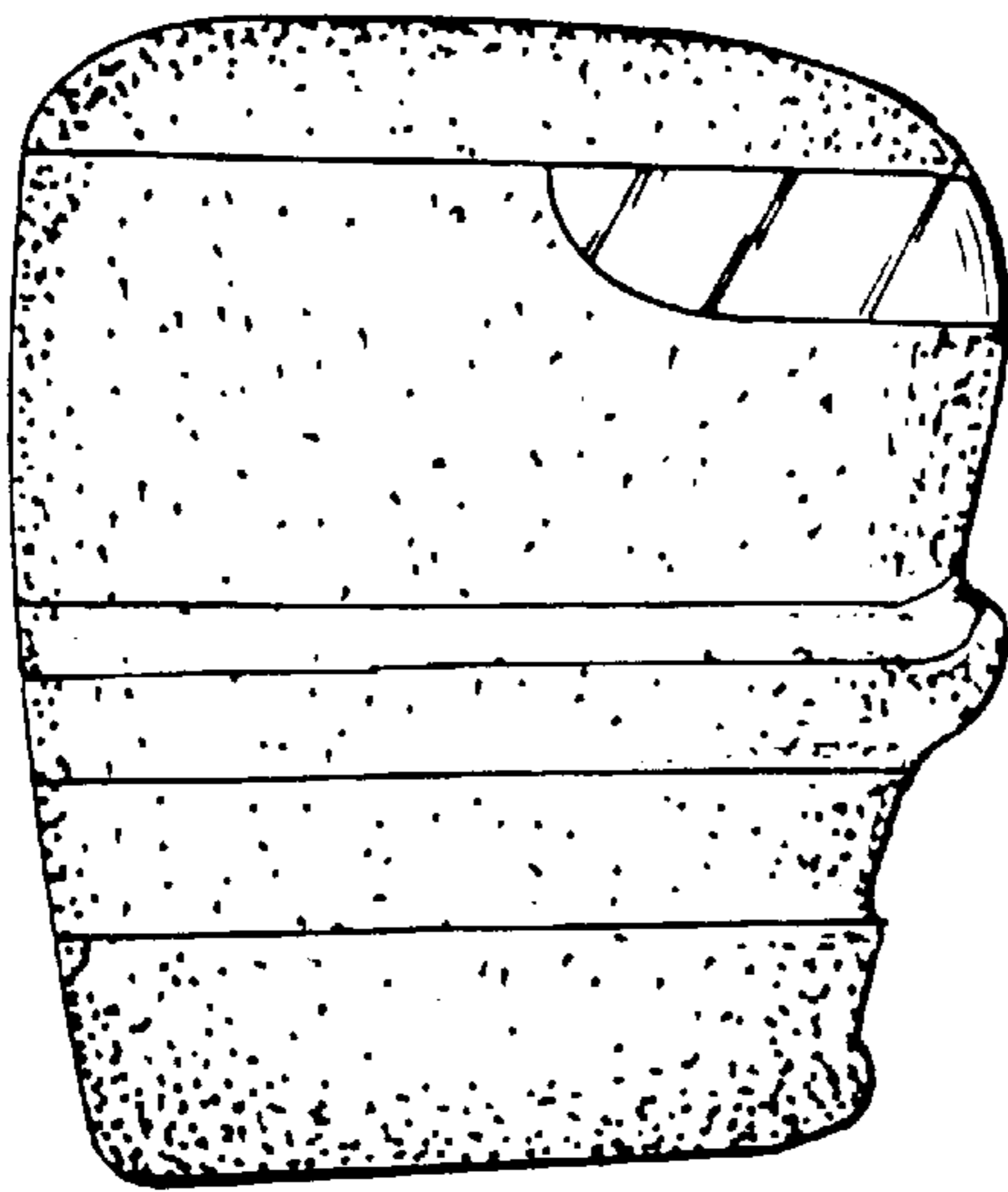

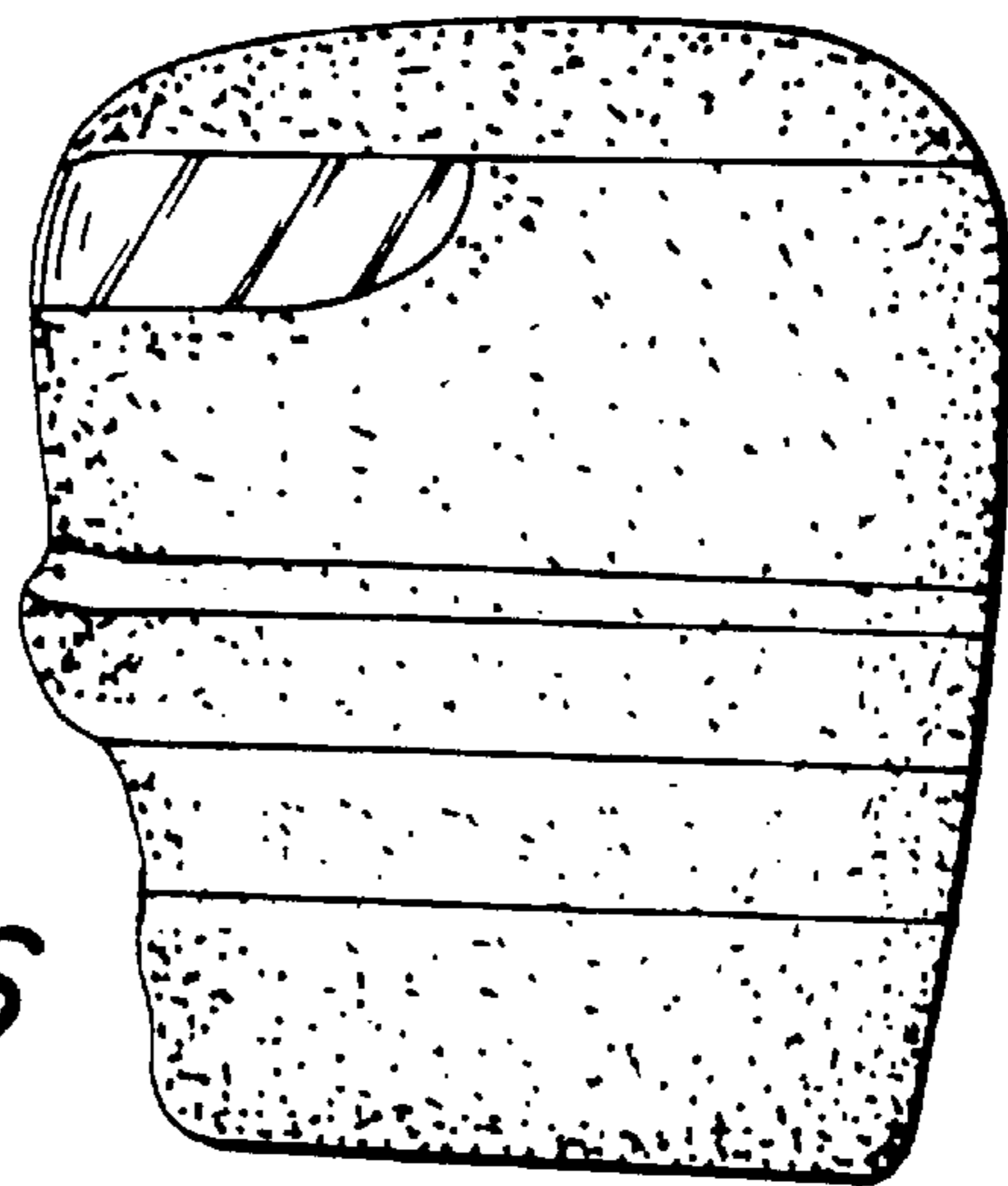
