[57] **CLAIM**

I claim the ornamental design for a fountain pen, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a first embodiment of a fountain pen showing my new design in an exploded condition;

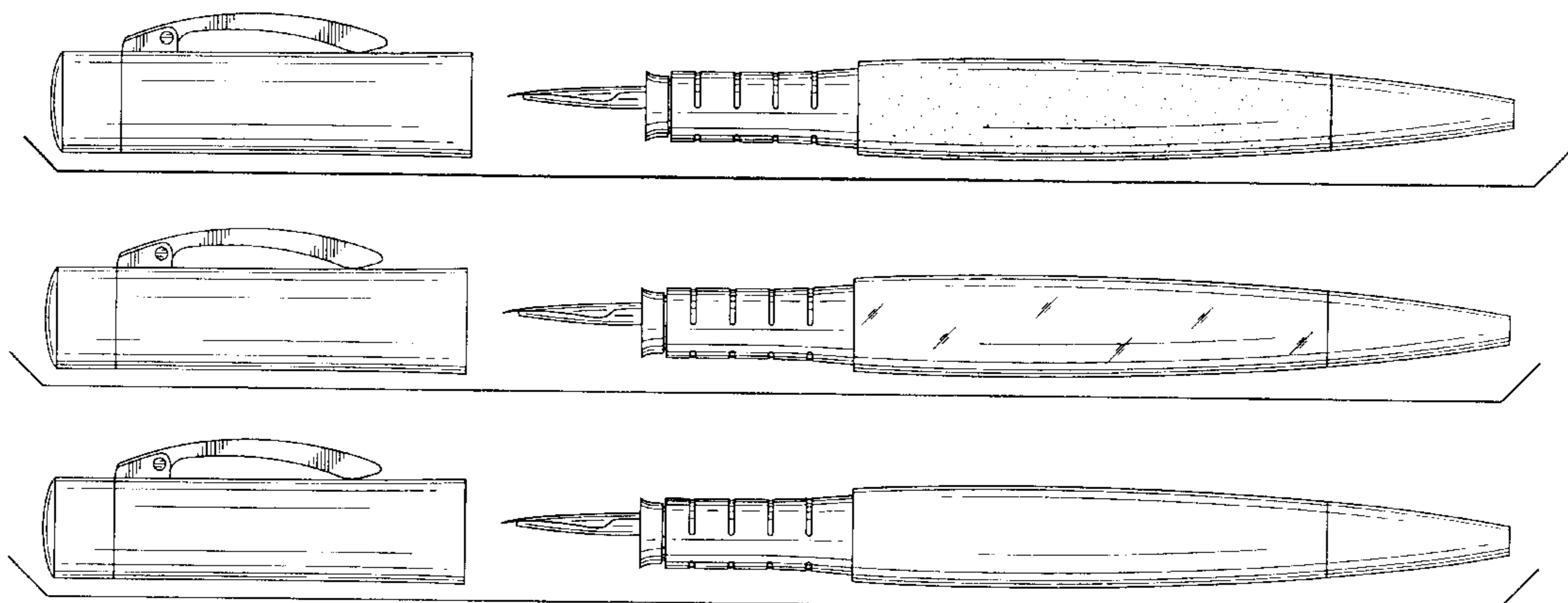


FIG. 34 is a right side elevation view of FIG. 25;

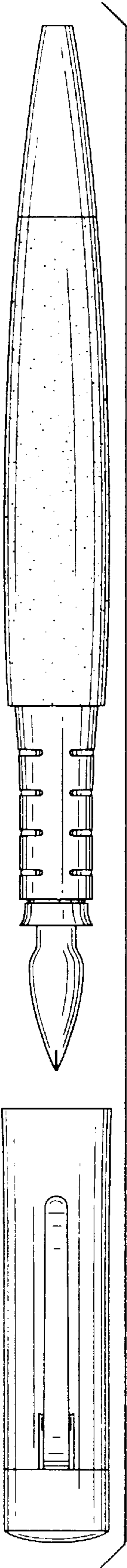

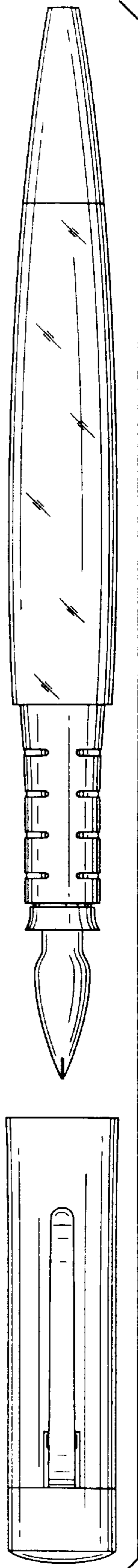

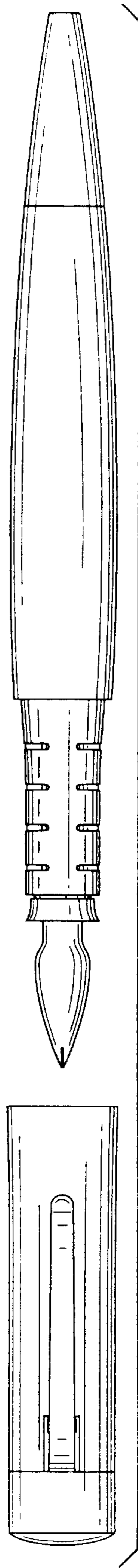

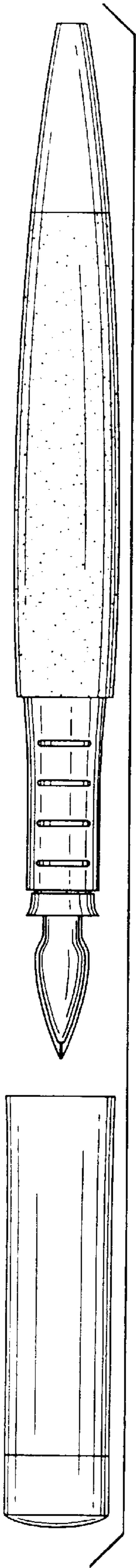

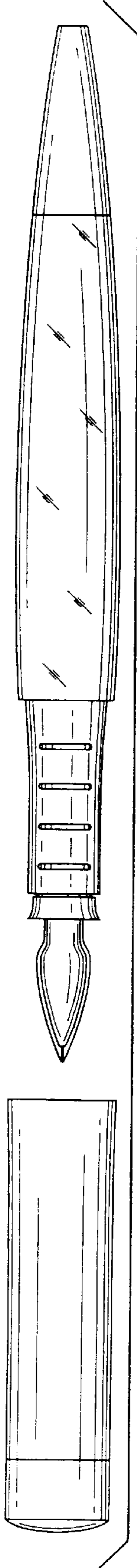

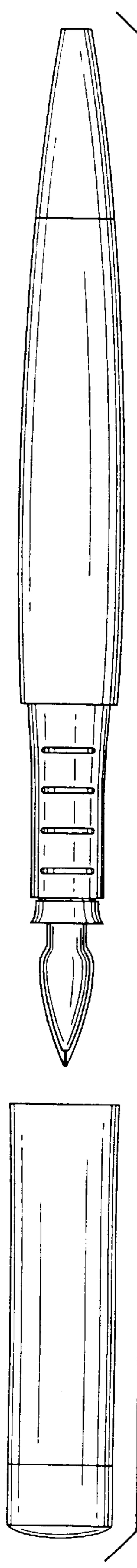

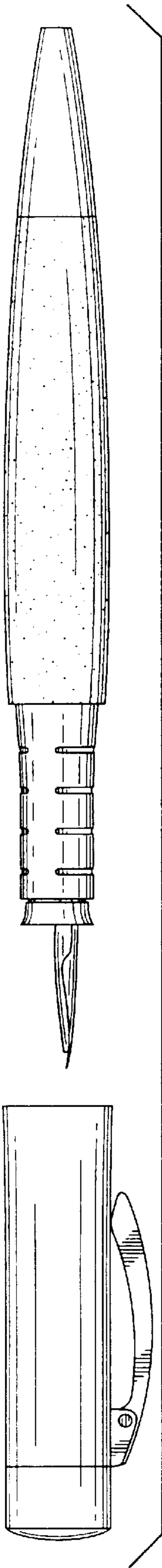

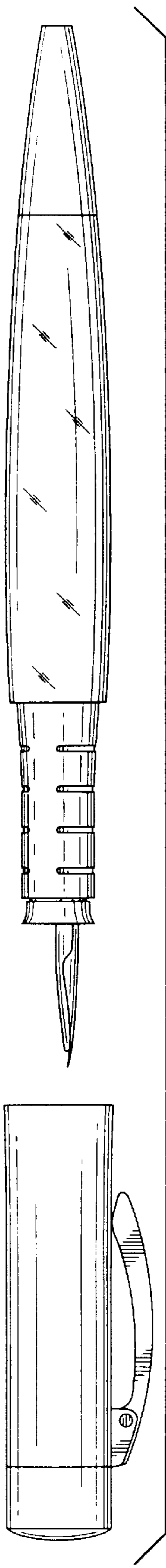

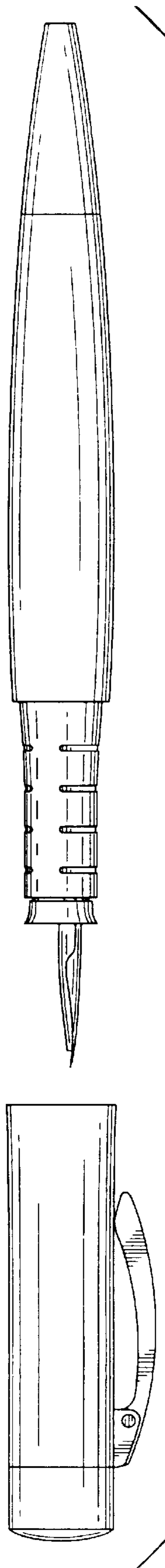

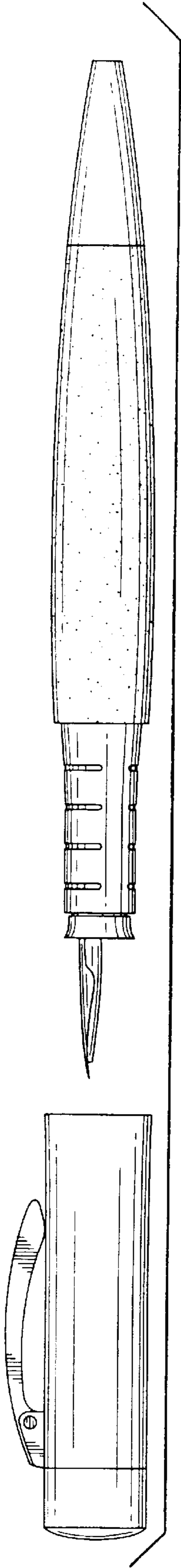

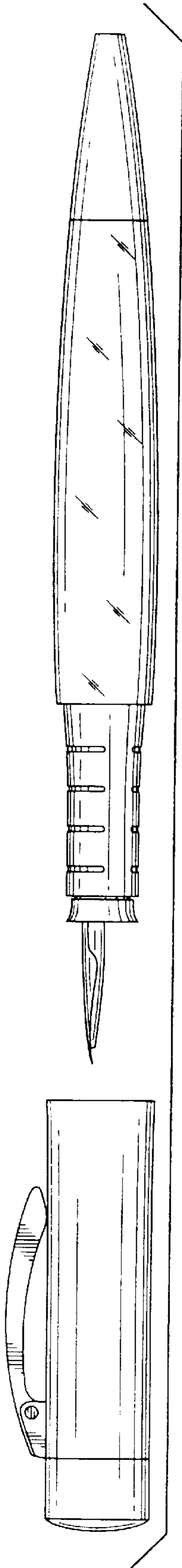

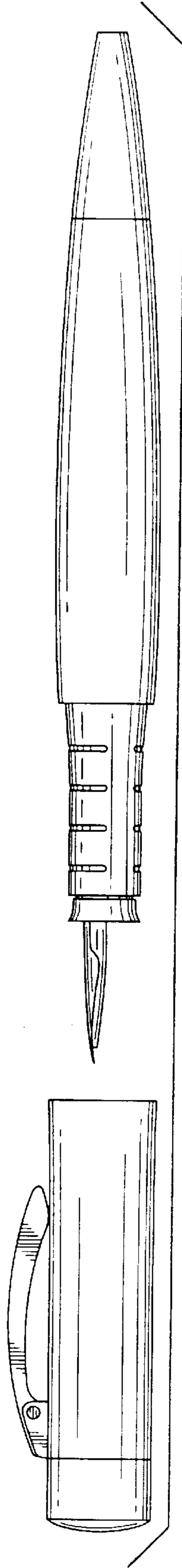

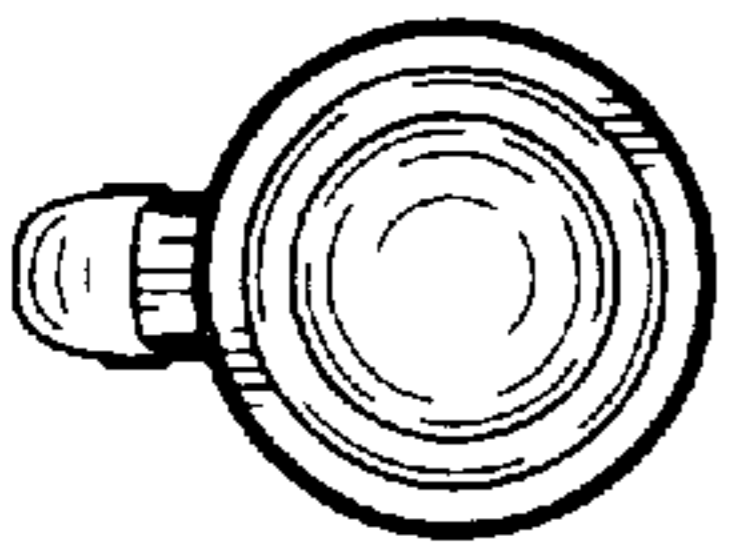

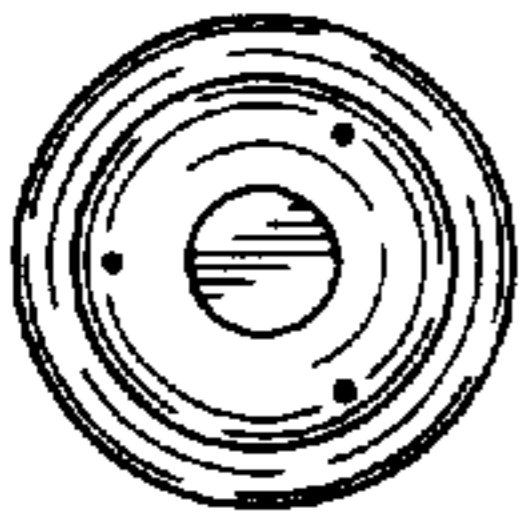

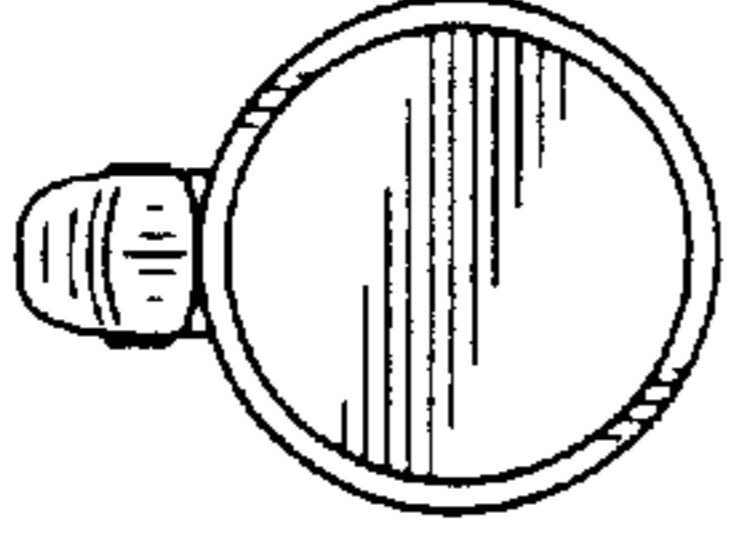

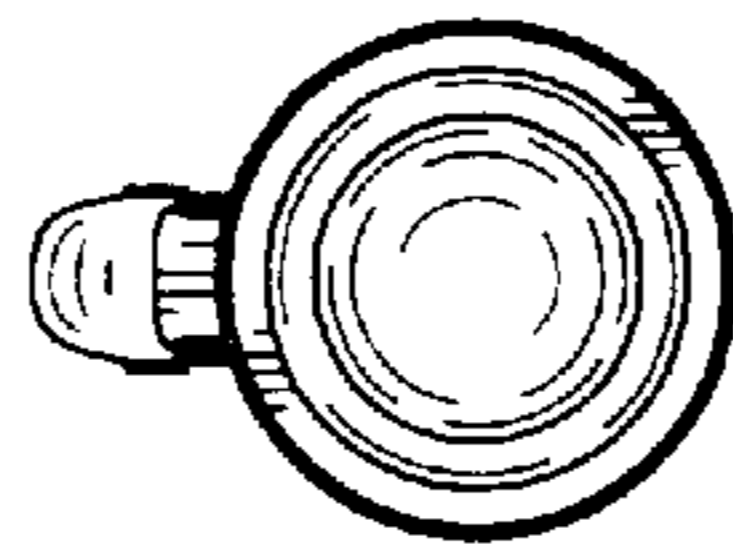

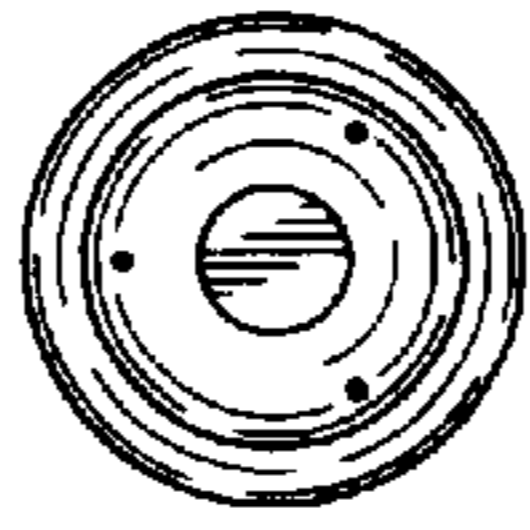

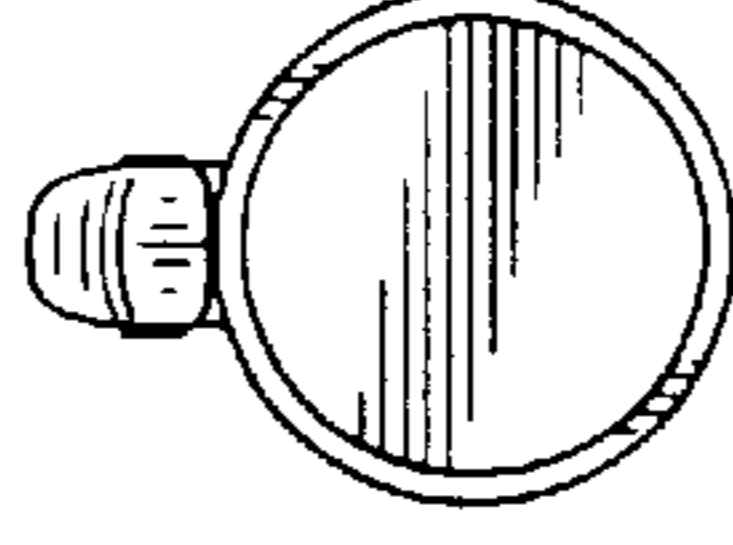

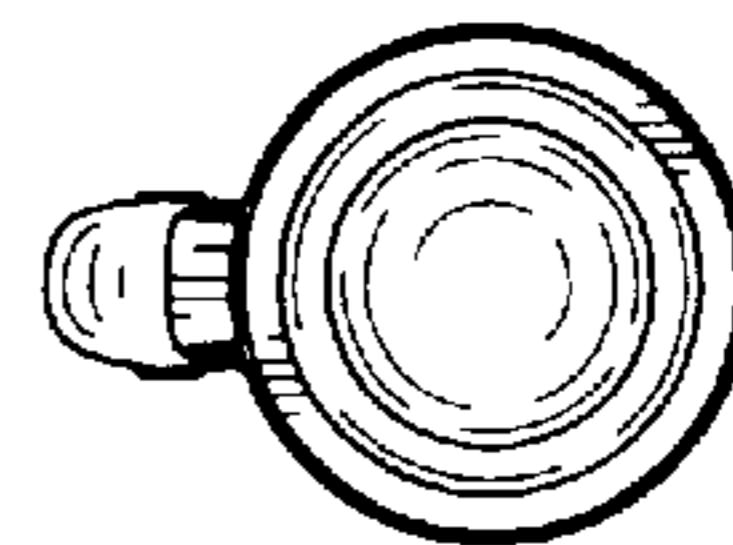

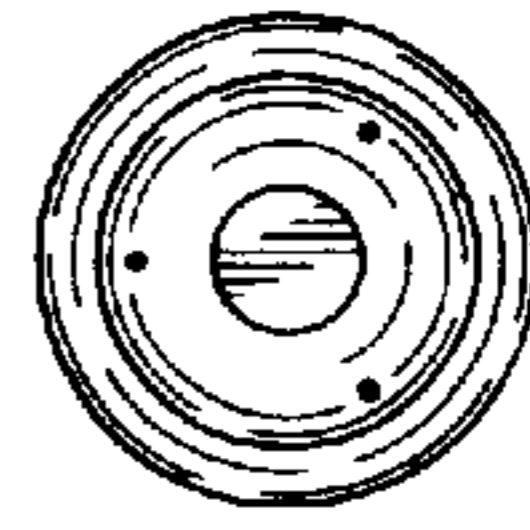

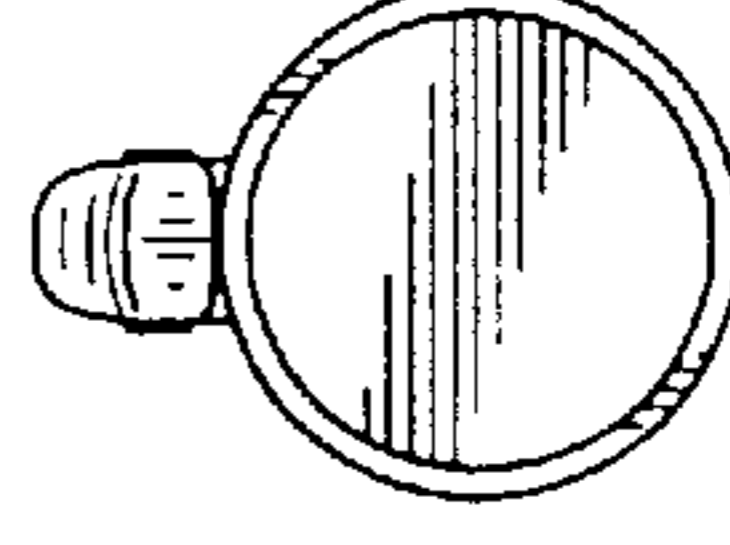

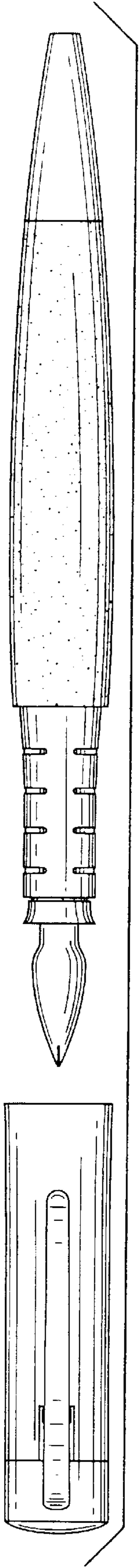

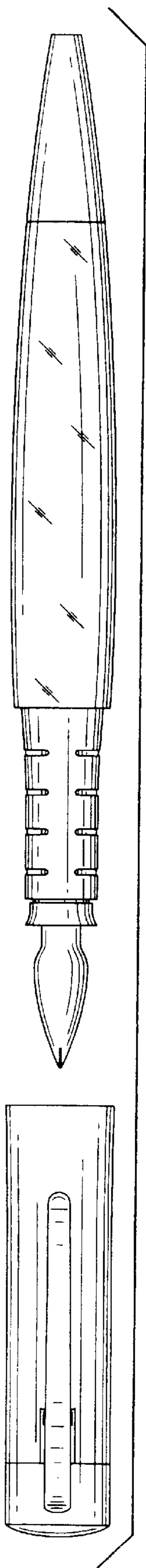

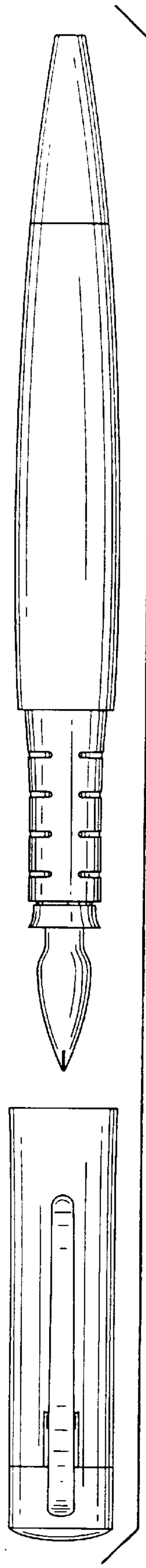

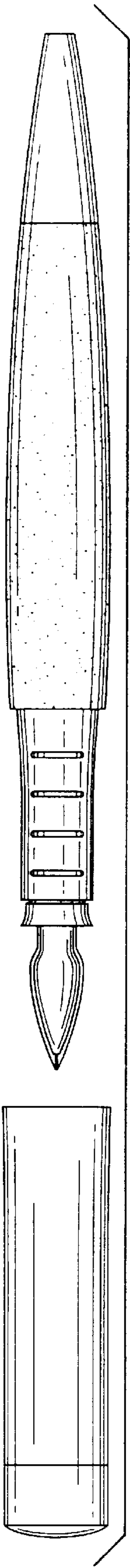

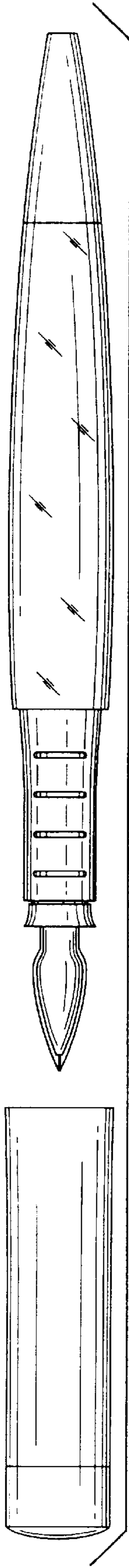

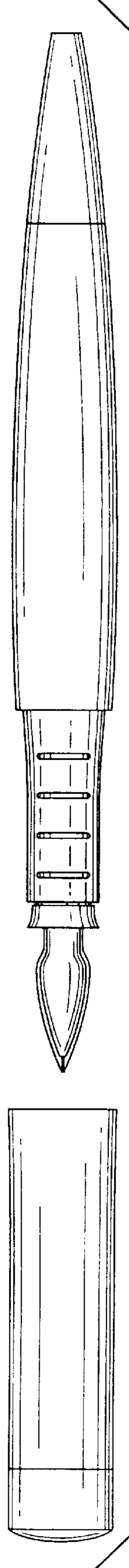

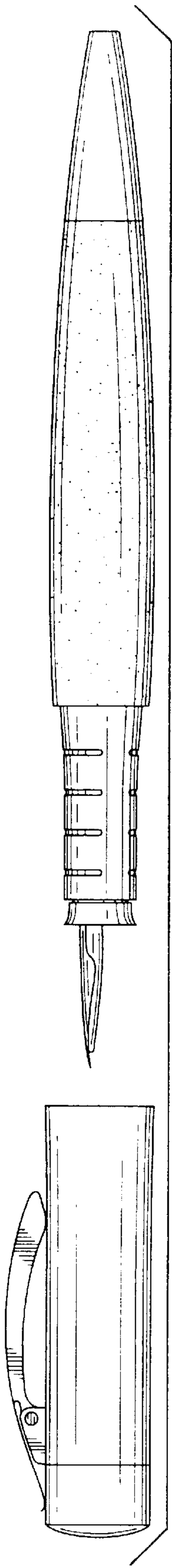

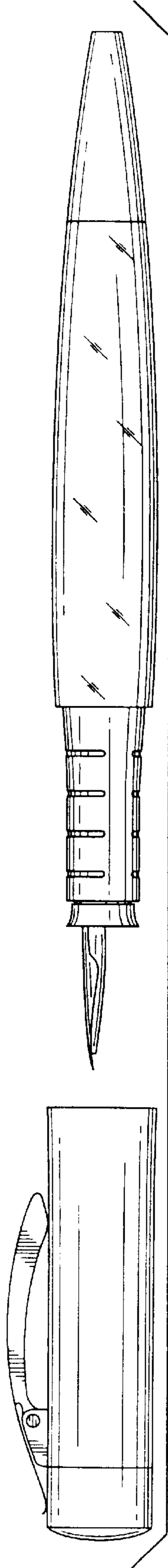

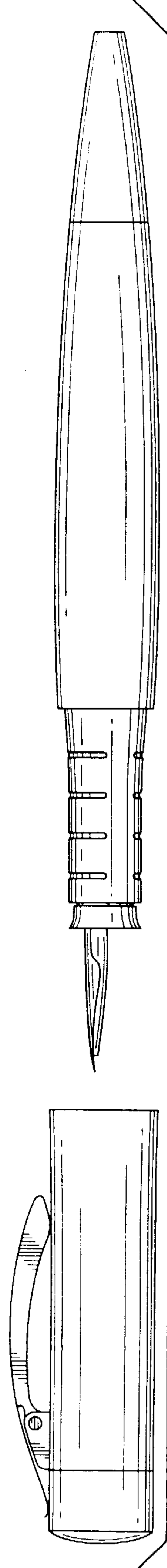

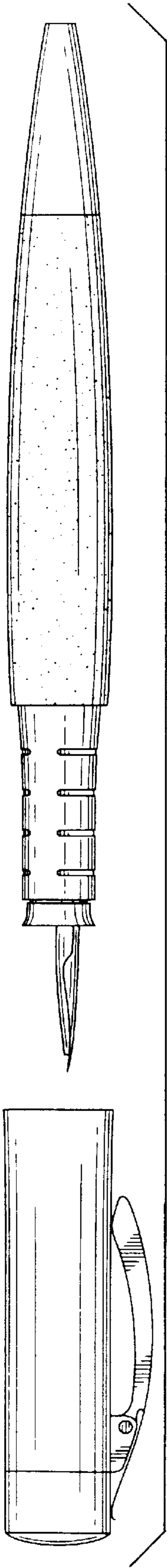

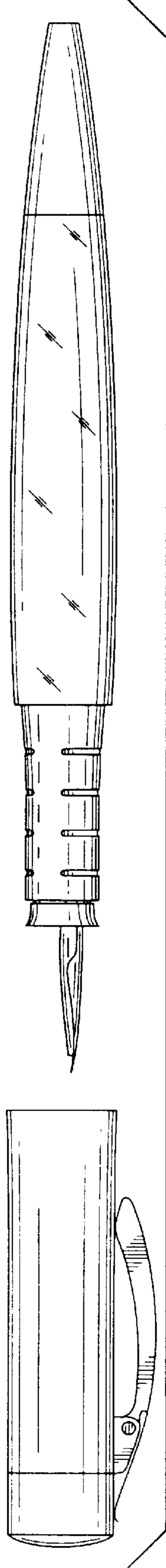

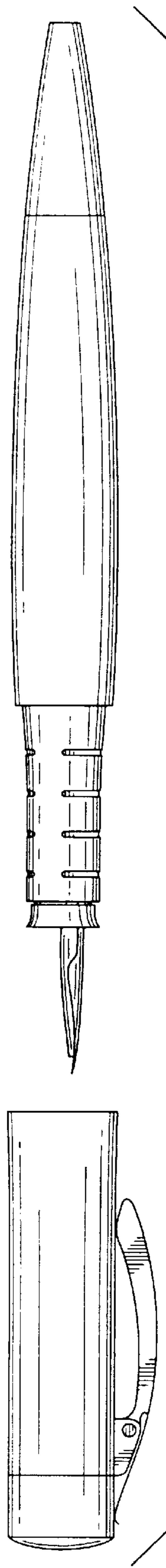

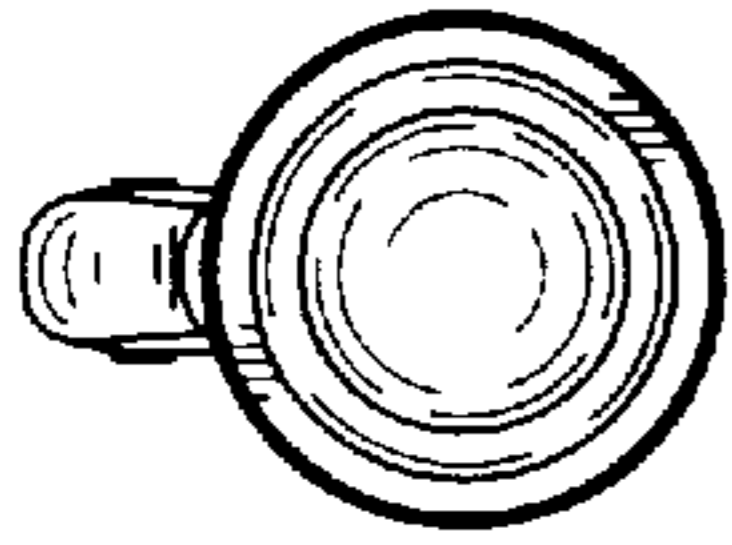

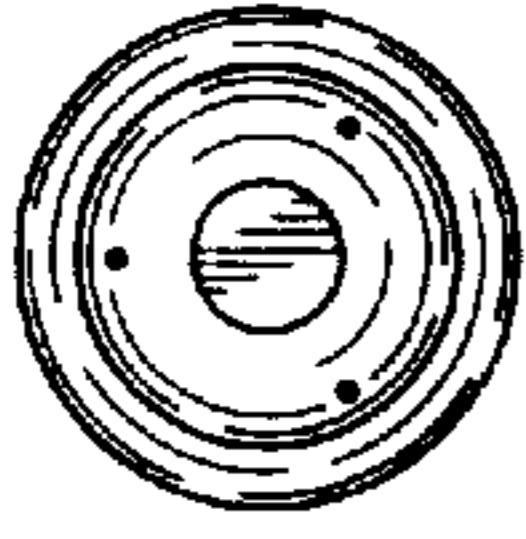

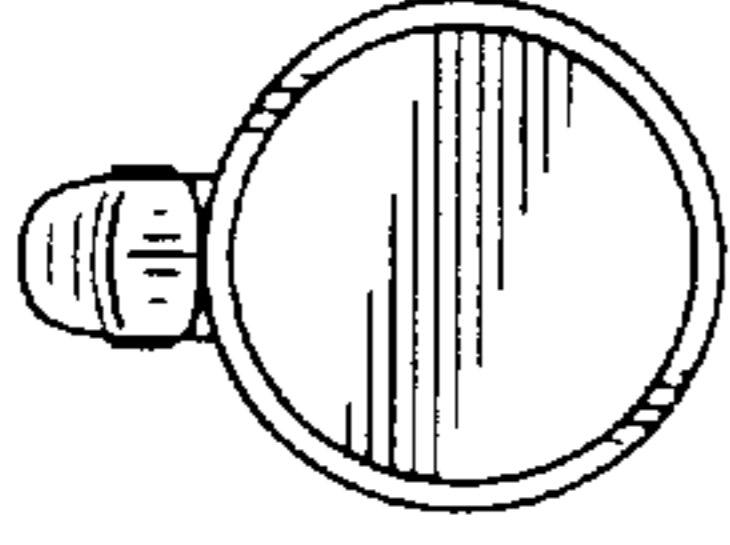

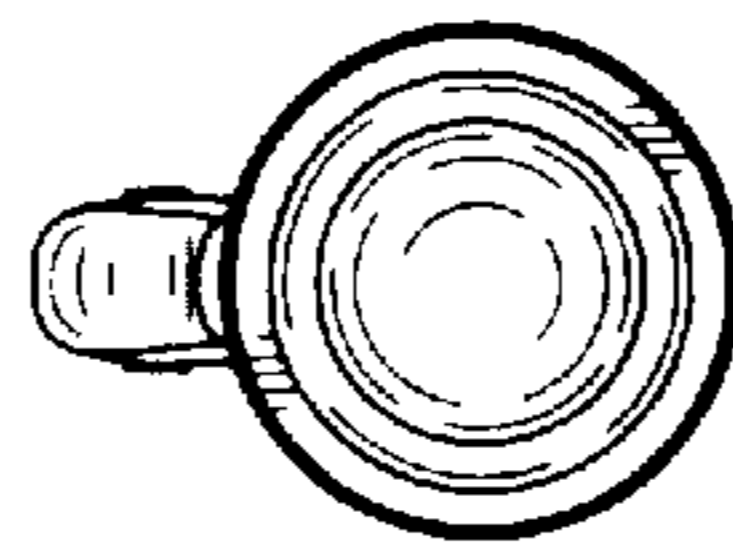

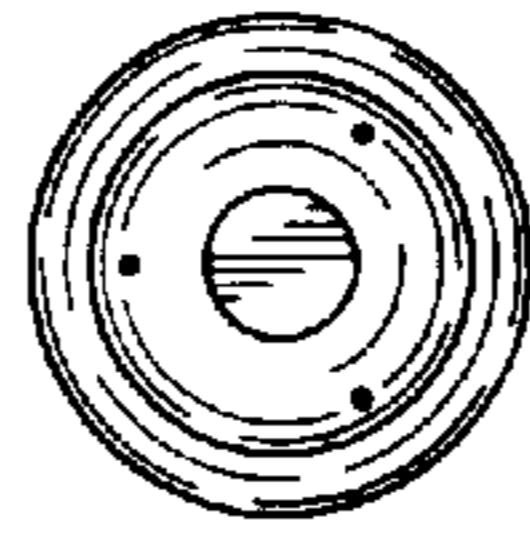

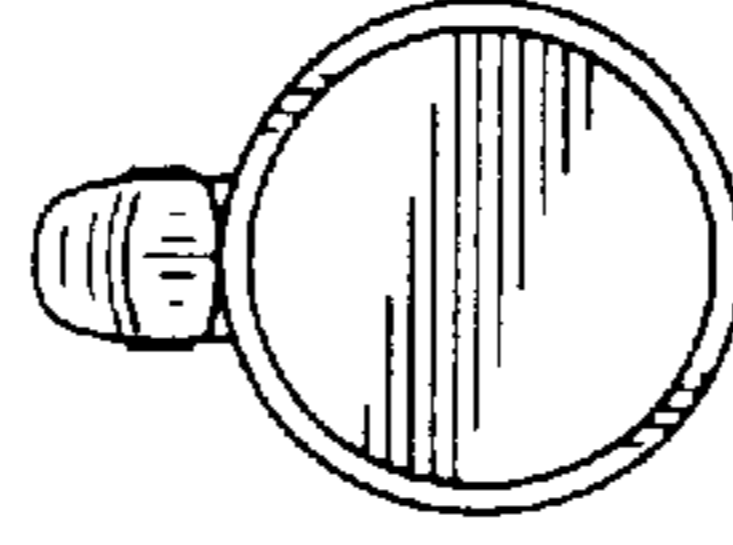

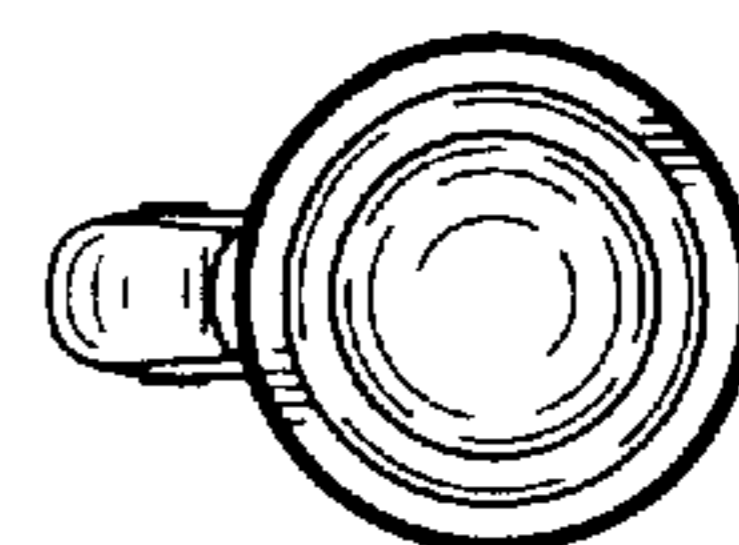

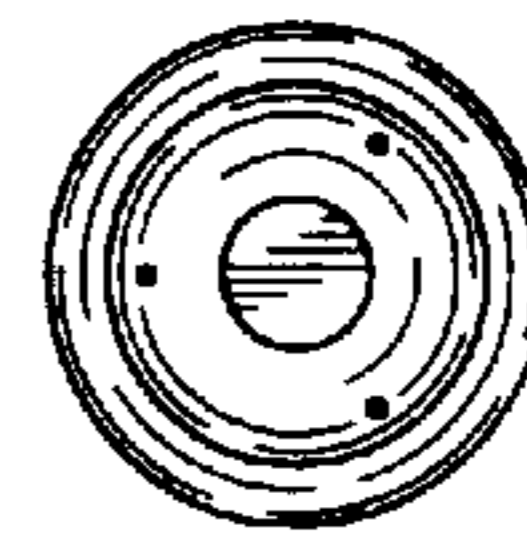

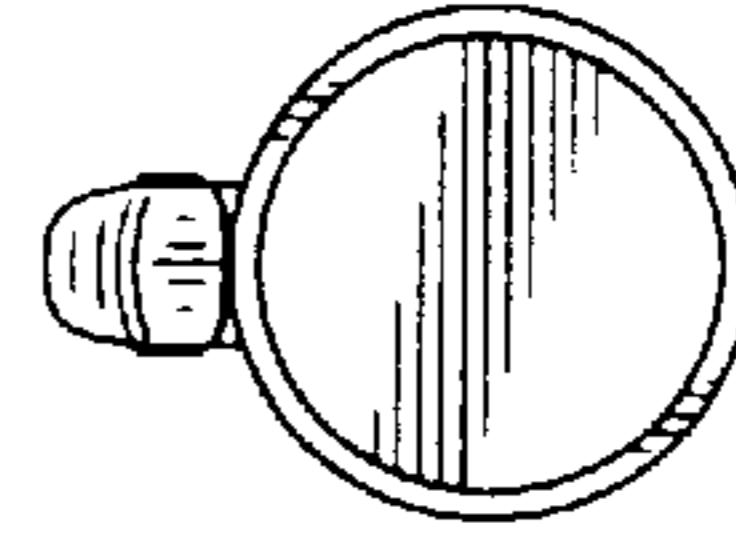
