The ornamental design for a children's ride-on vehicle, as shown and described.

DESCRIPTION

FIG. 1 is a front view thereof;
 FIG. 2 is a top view thereof, the bottom side being unornamented;
 FIG. 3 is a left-side view thereof, the right side being a mirror image of the left side;
 FIG. 4 is a rear view thereof;
 FIG. 5 is a front view of an alternative embodiment thereof;
 FIG. 6 is a top view of the alternative embodiment, the bottom side being unornamented;
 FIG. 7 is a left-side view of the alternative embodiment, the right side being a mirror image of the left side; and,
 FIG. 8 is a rear view of the alternative embodiment.
 The broken lines shown in FIGS. 1-8 is for illustrative purposes only and form no part of the claimed design.

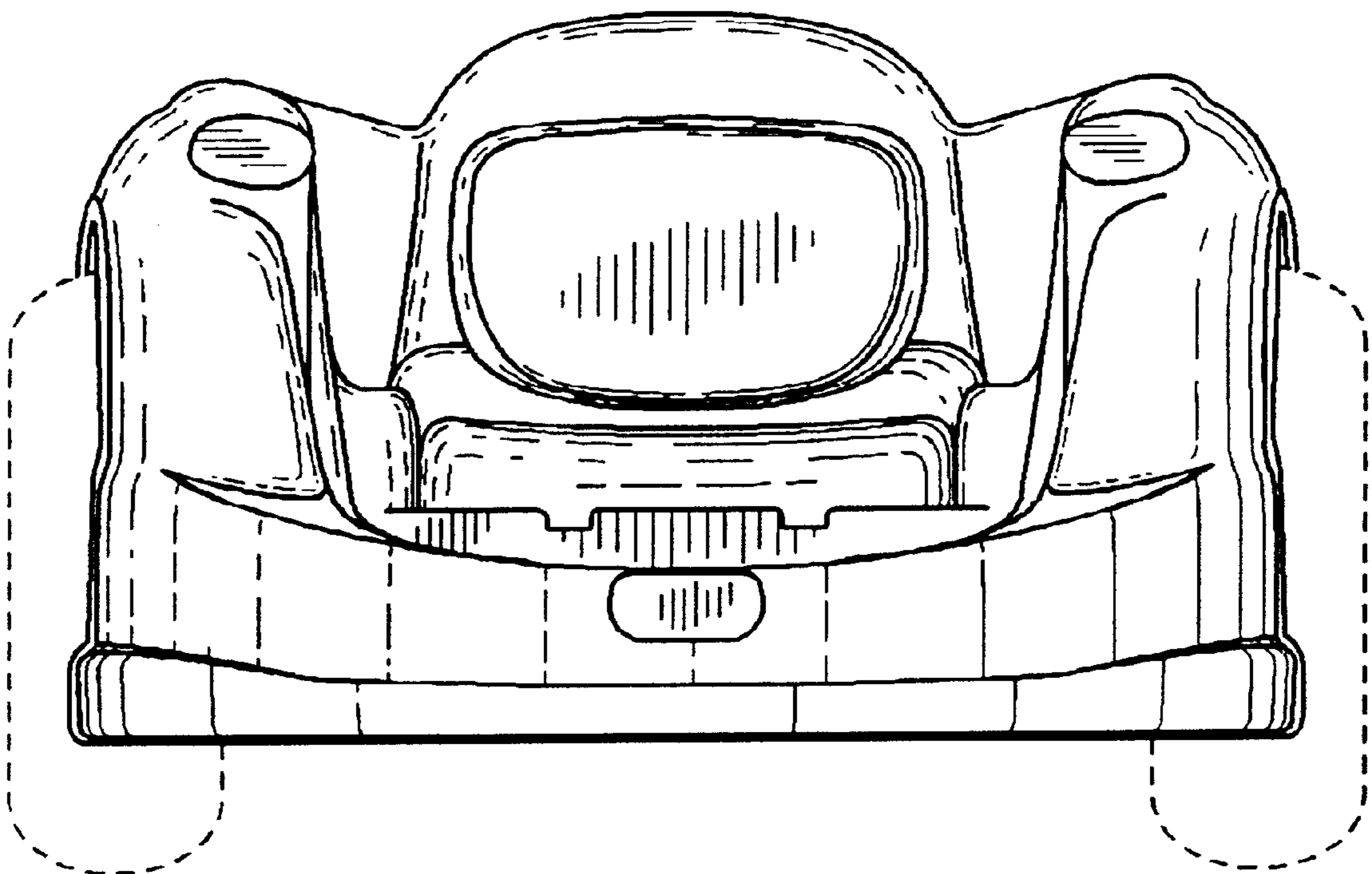

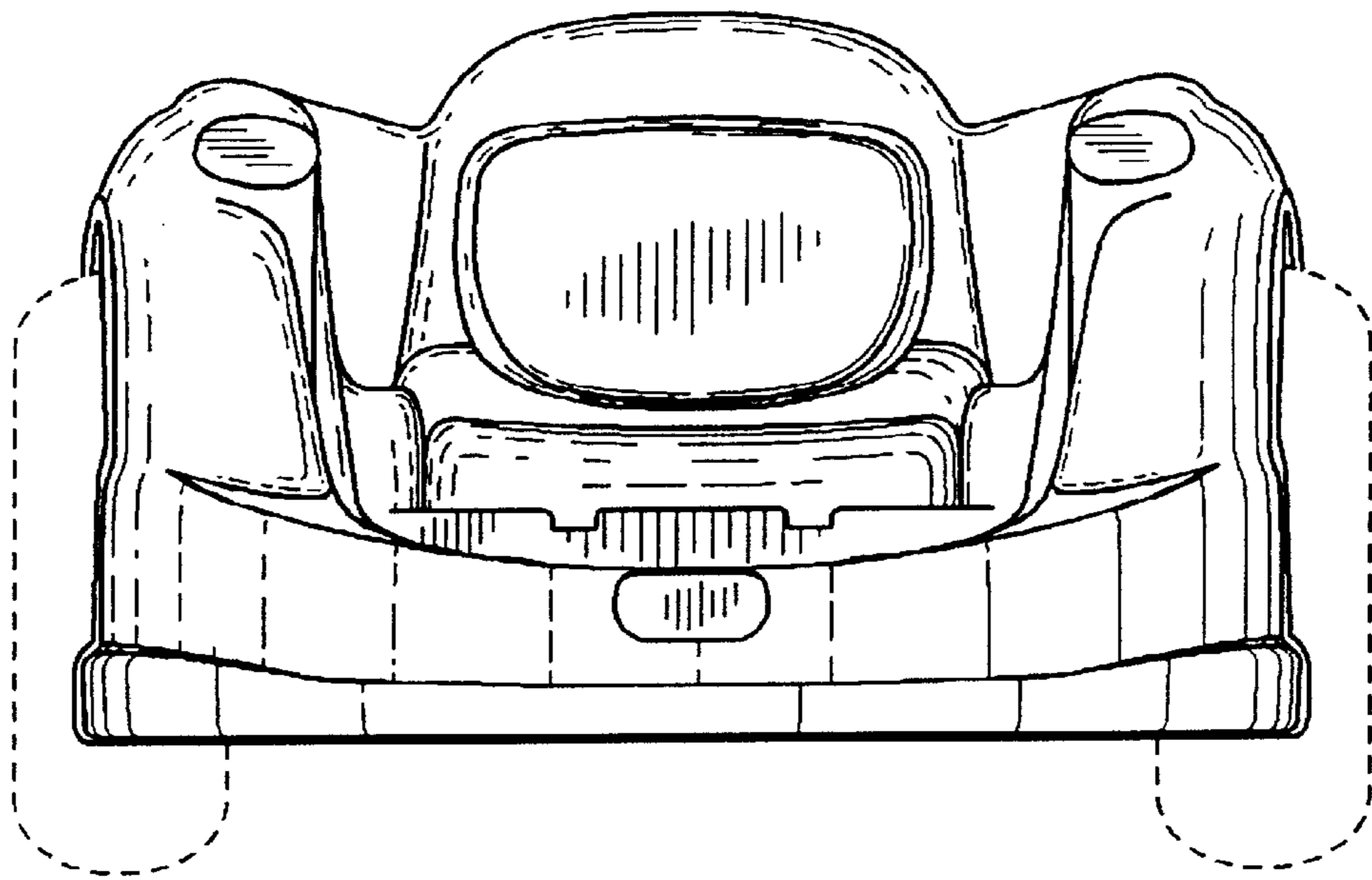

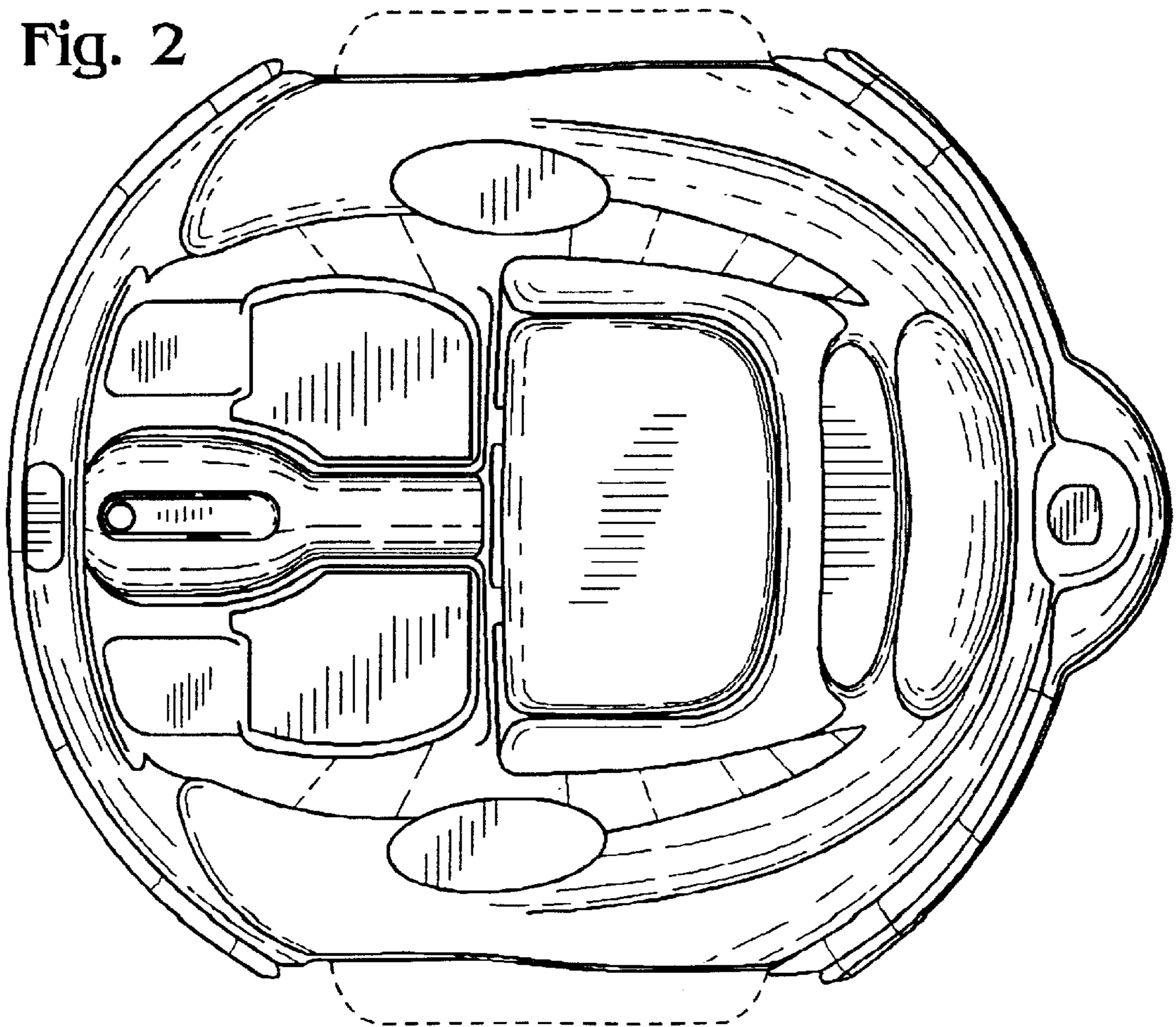

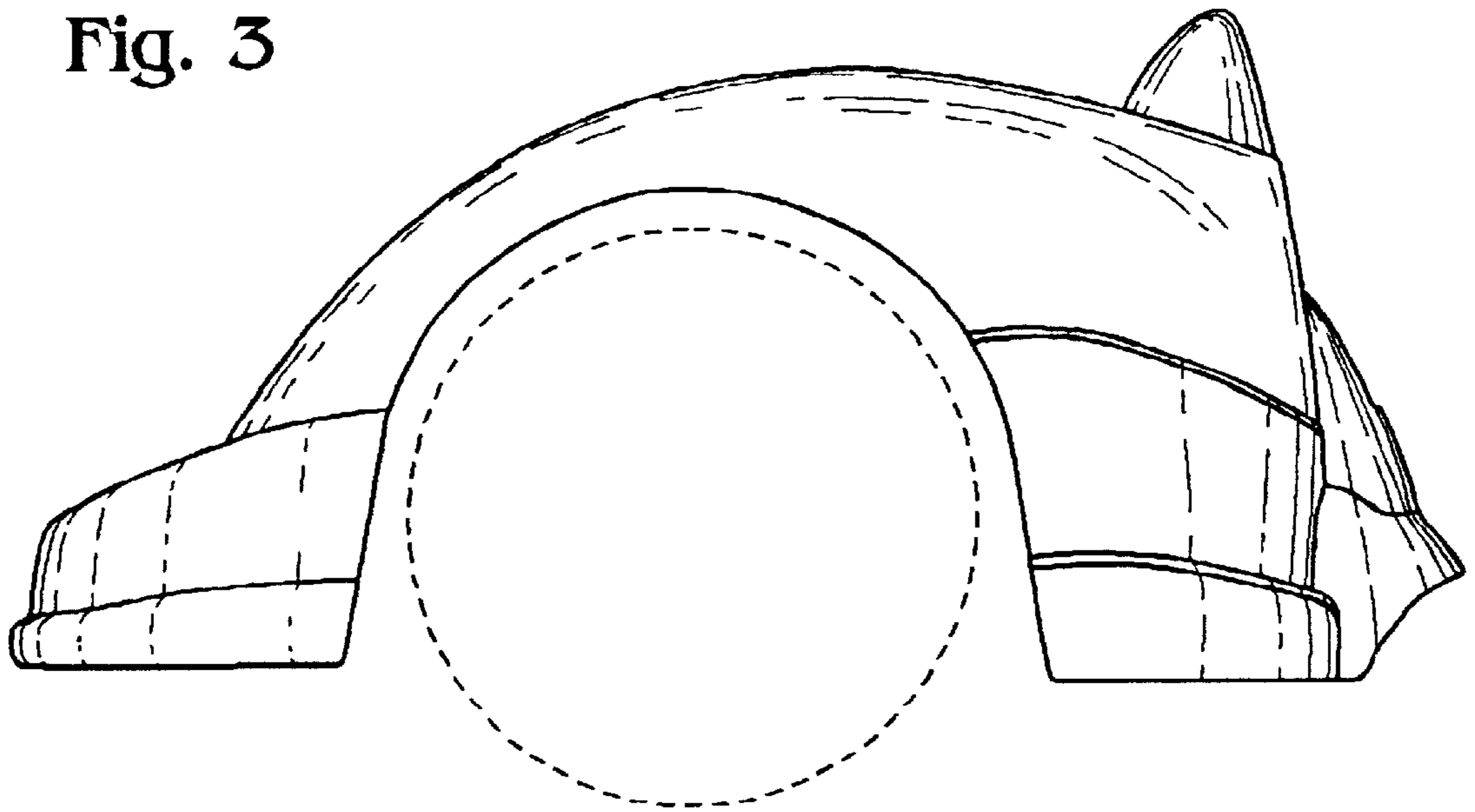

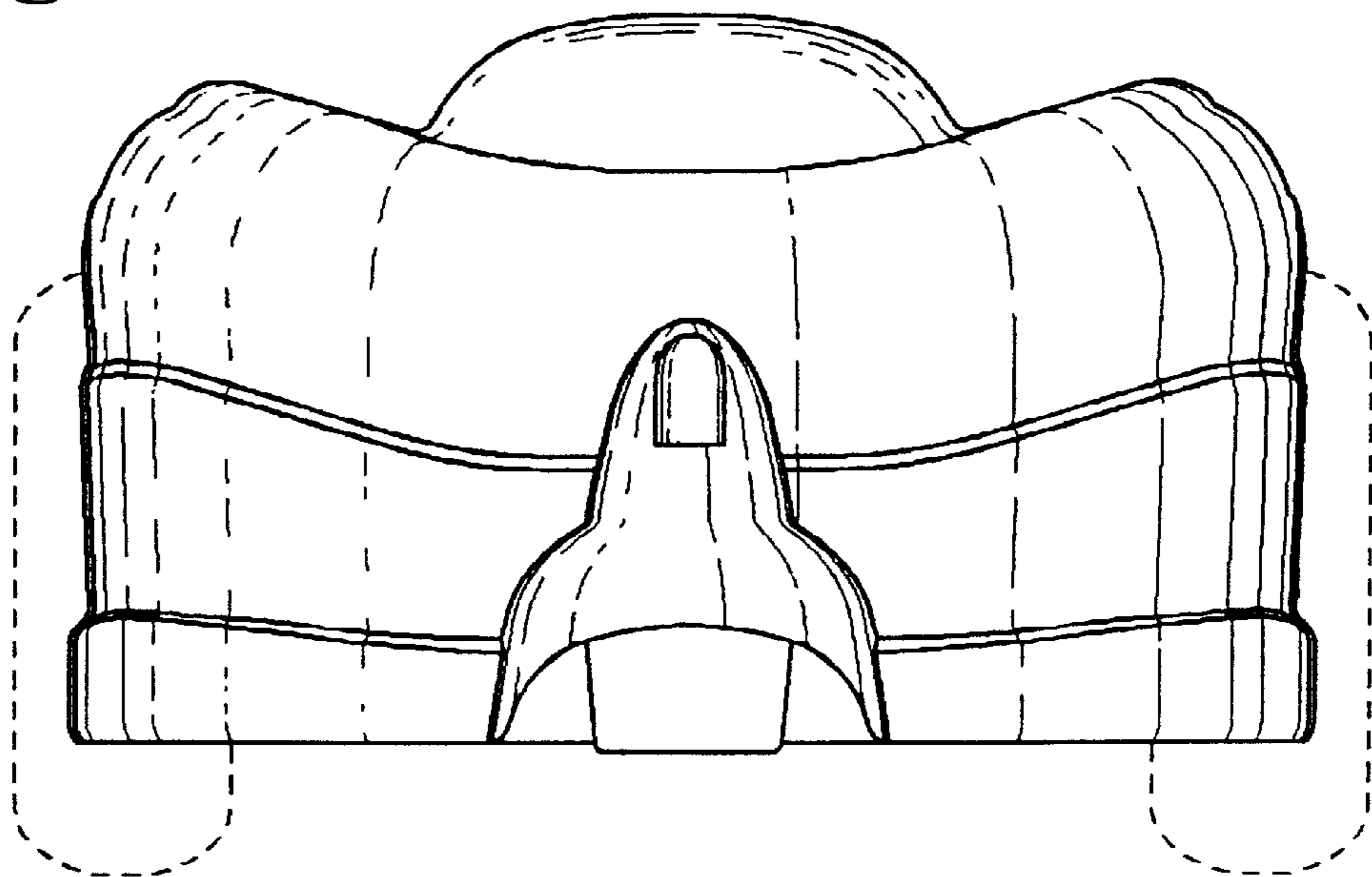

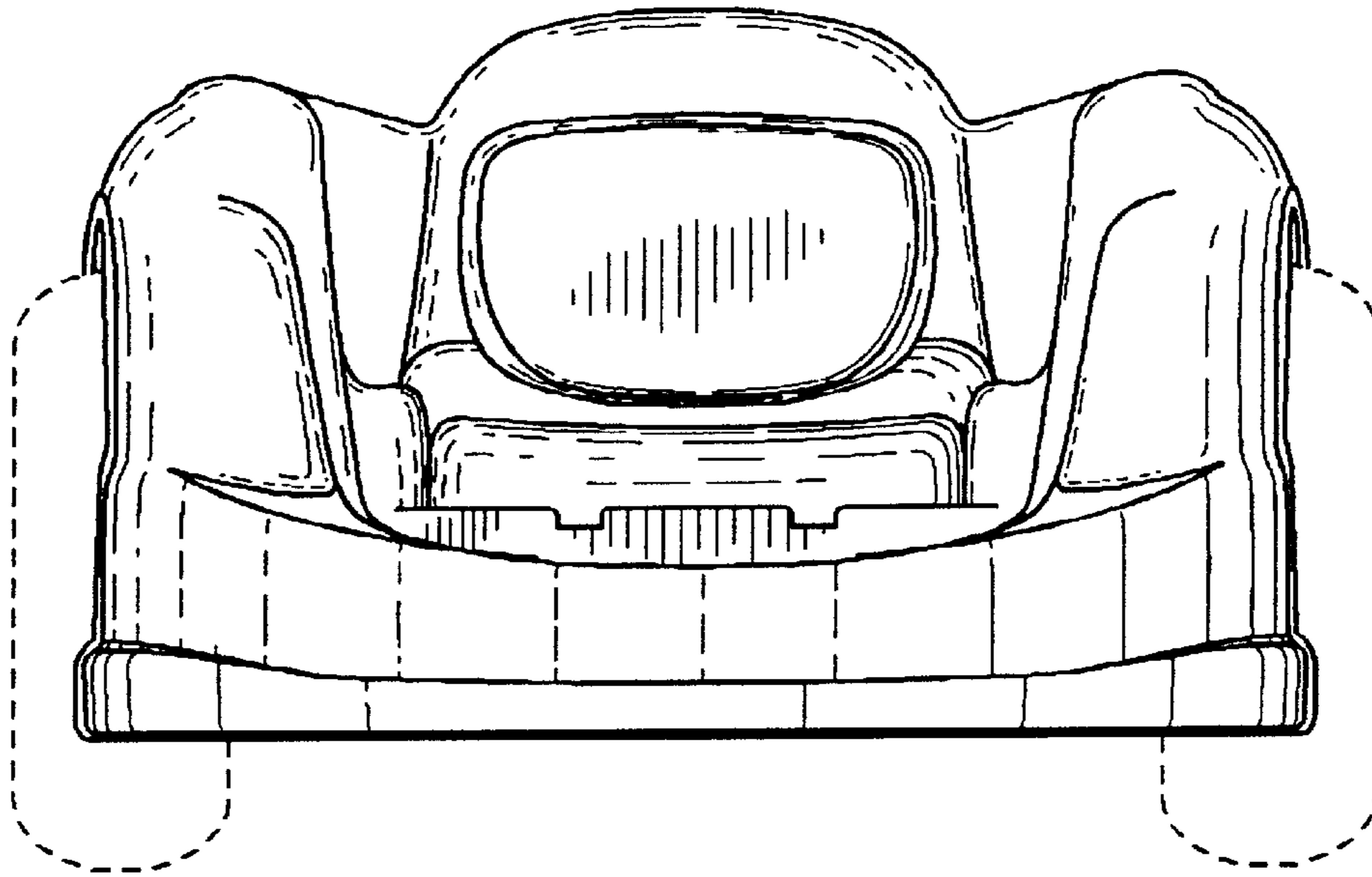

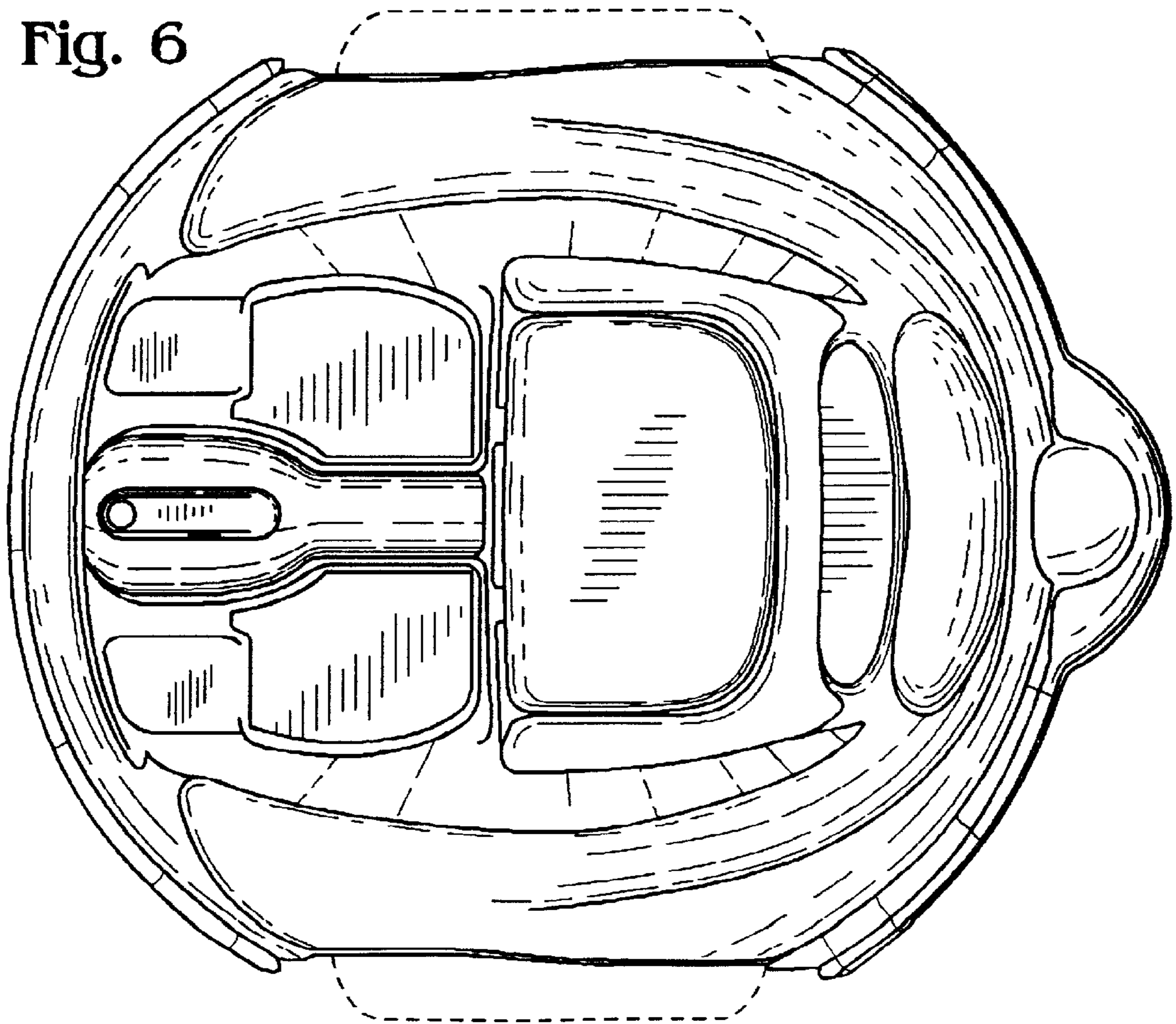

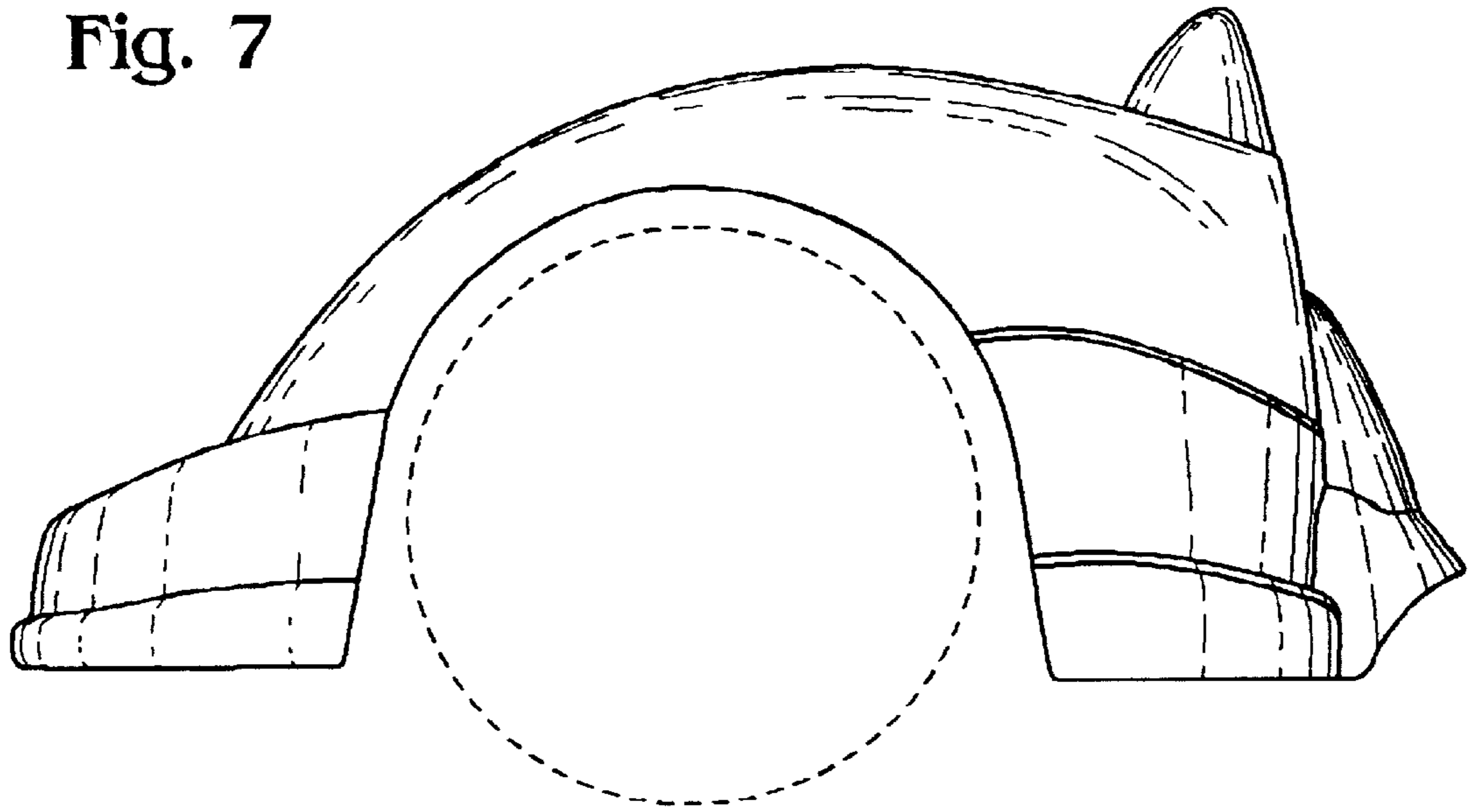
