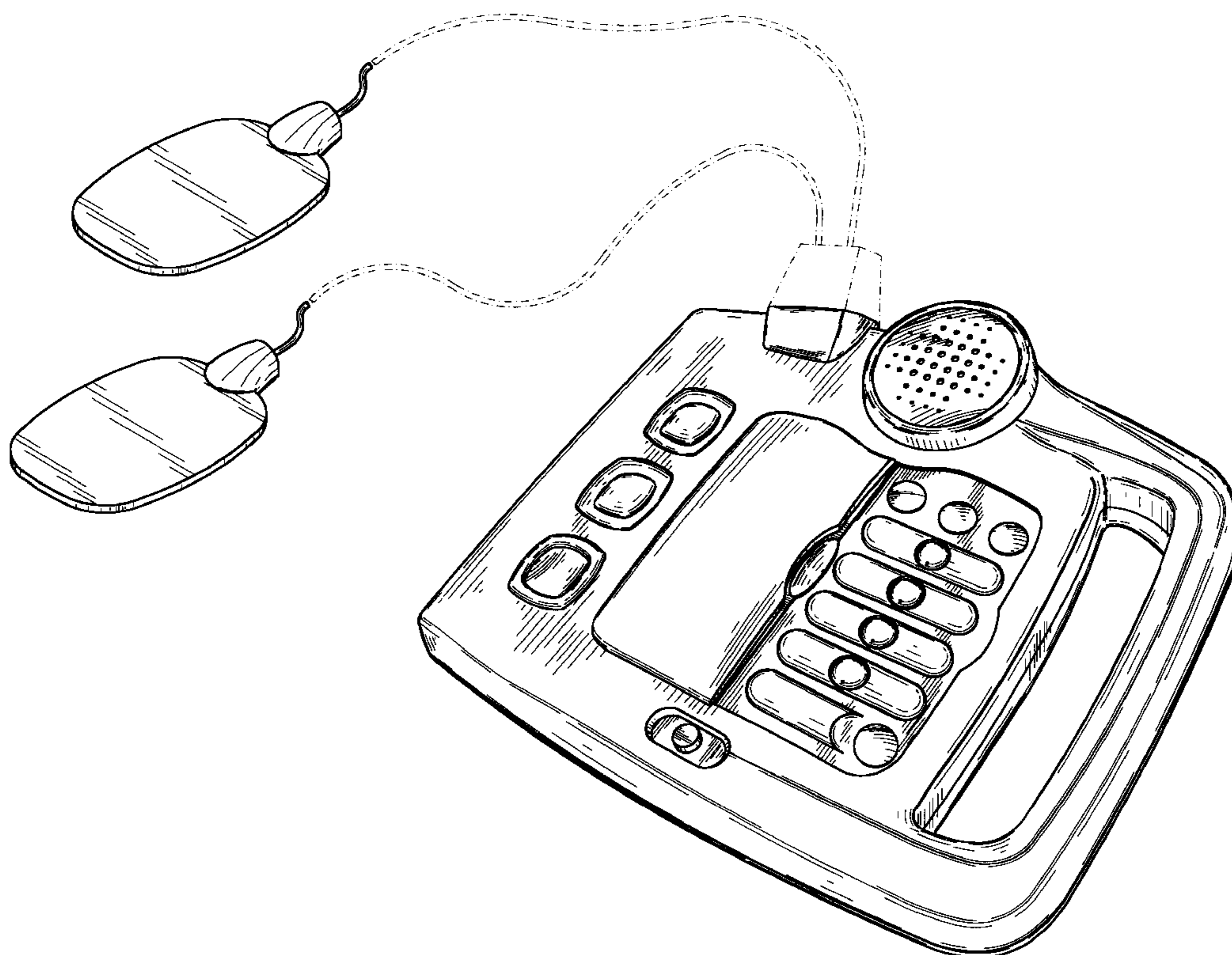
[57] CLAIM

The ornamental design for a defibrillator, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the defibrillator of our design, with the cover shown in the closed position; FIG. 2 is a top plan view of the defibrillator of FIG. 1; FIG. 3 is a bottom plan view of the defibrillator of FIG. 1; FIG. 4 is a bottom end view of the defibrillator of FIG. 1; FIG. 5 is a top end view of the defibrillator of FIG. 1; FIG. 6 is a left side view of the defibrillator of FIG. 1; FIG. 7 is a right side view of the defibrillator of FIG. 1; FIG. 8 is a perspective view of the defibrillator of our design, with the cover shown in the open position; FIG. 9 is a perspective view of the defibrillator of our design, shown with the cover in open position and a pair of paddles, cords, and a connecting plug; the broken line showing of cords and a connecting plug being for illustrative purposes only and forming no part of the claimed design; FIG. 10 is a bottom plan view one of the paddles and cord portion of FIG. 9; FIG. 11 is a top plan view the paddle and cord portion of FIG. 10; FIG. 12 is a side view of the paddle and cord portion of FIG. 10, the other side view being substantially the same; FIG. 13 is a front end view of the paddle and cord portion of FIG. 10; and, FIG. 14 is a back end view of the paddle and cord portion of FIG. 10.

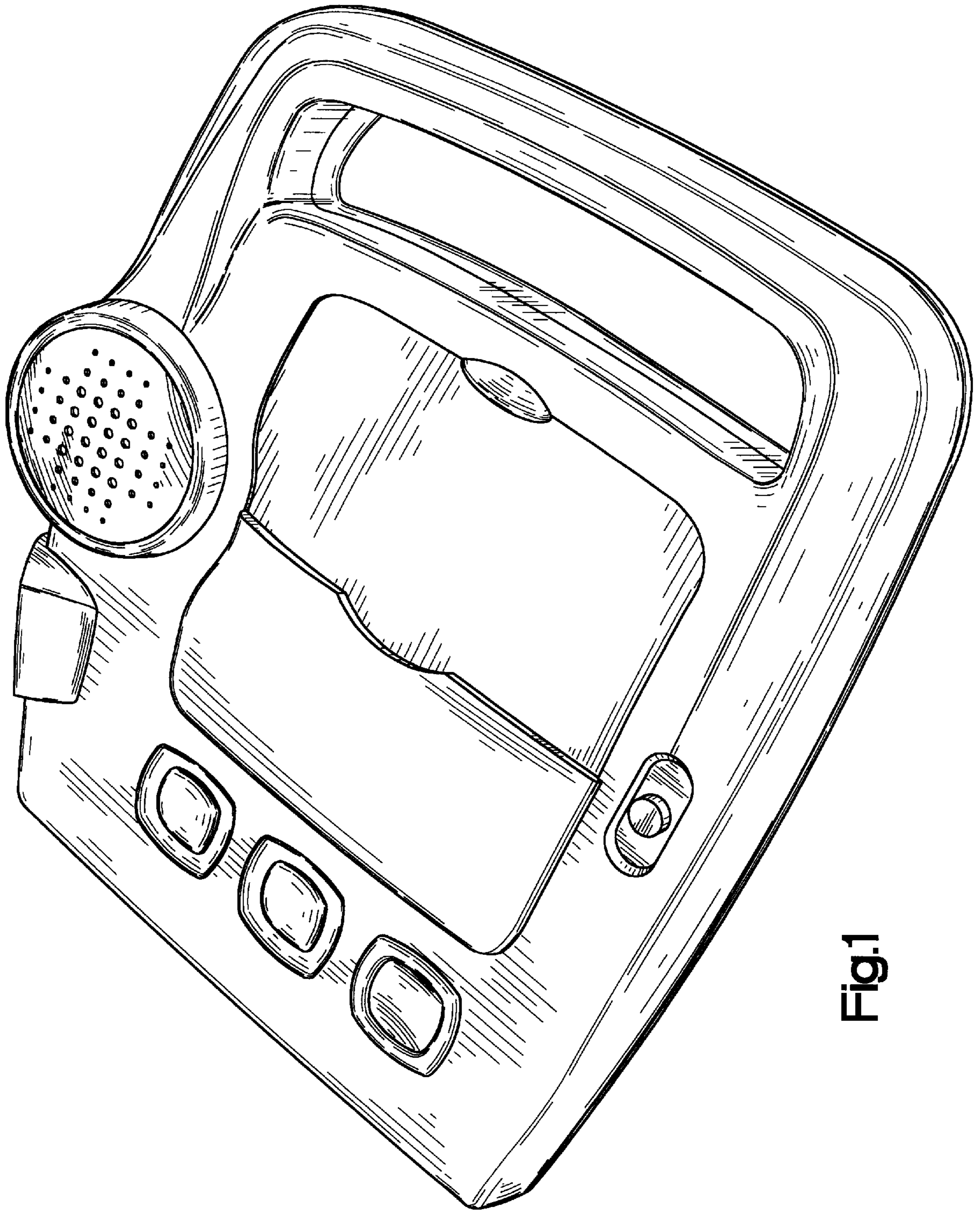

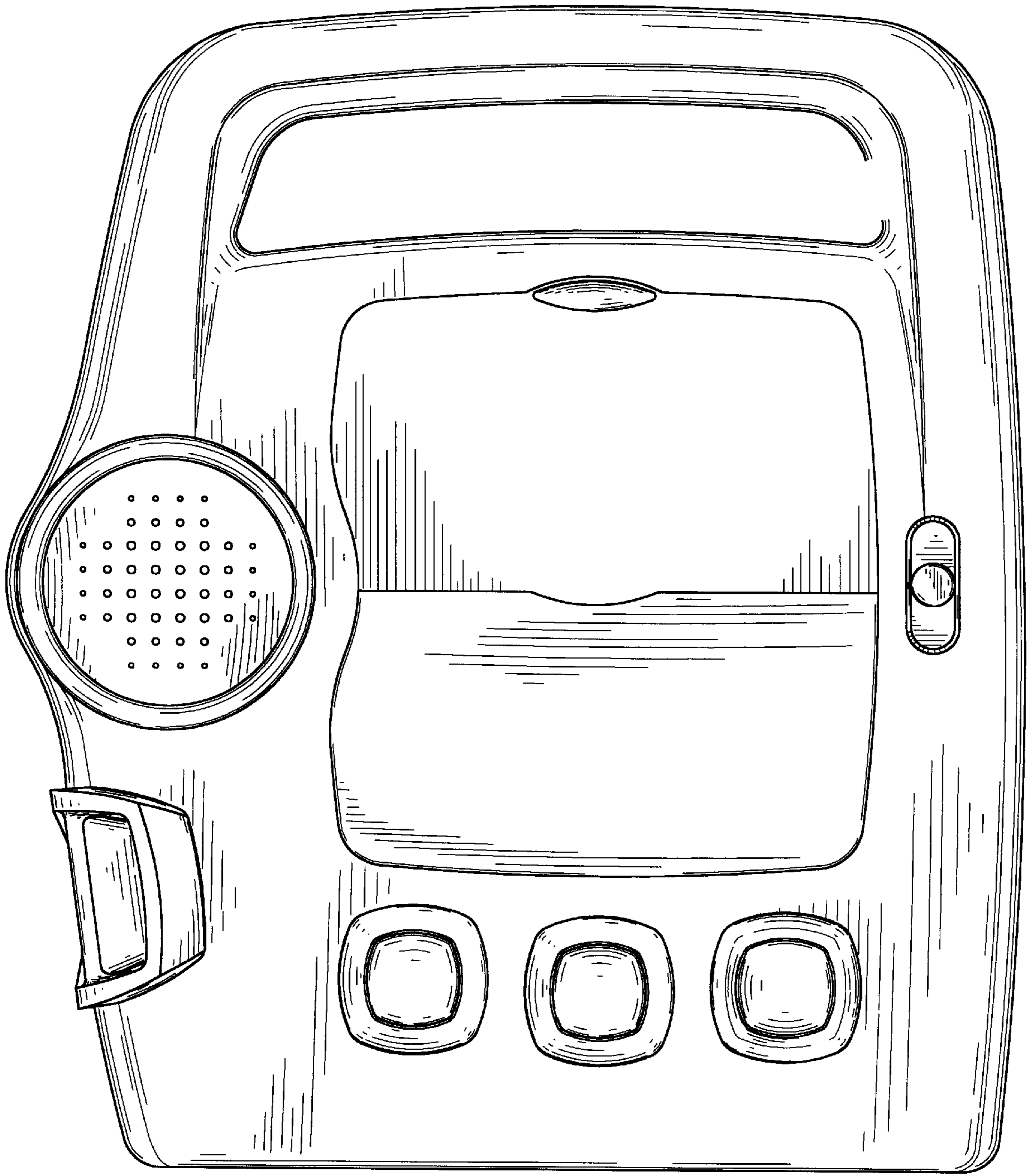

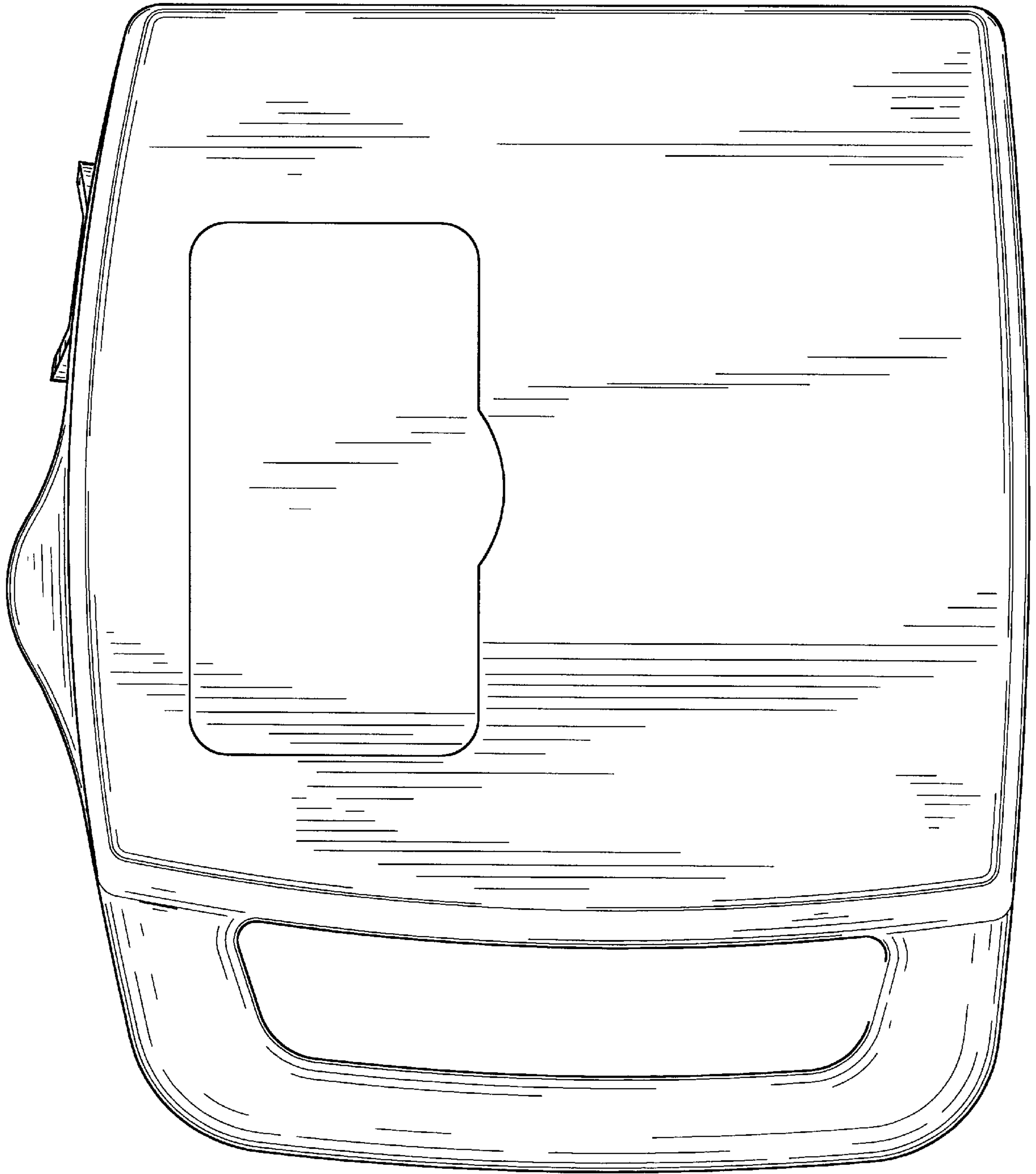

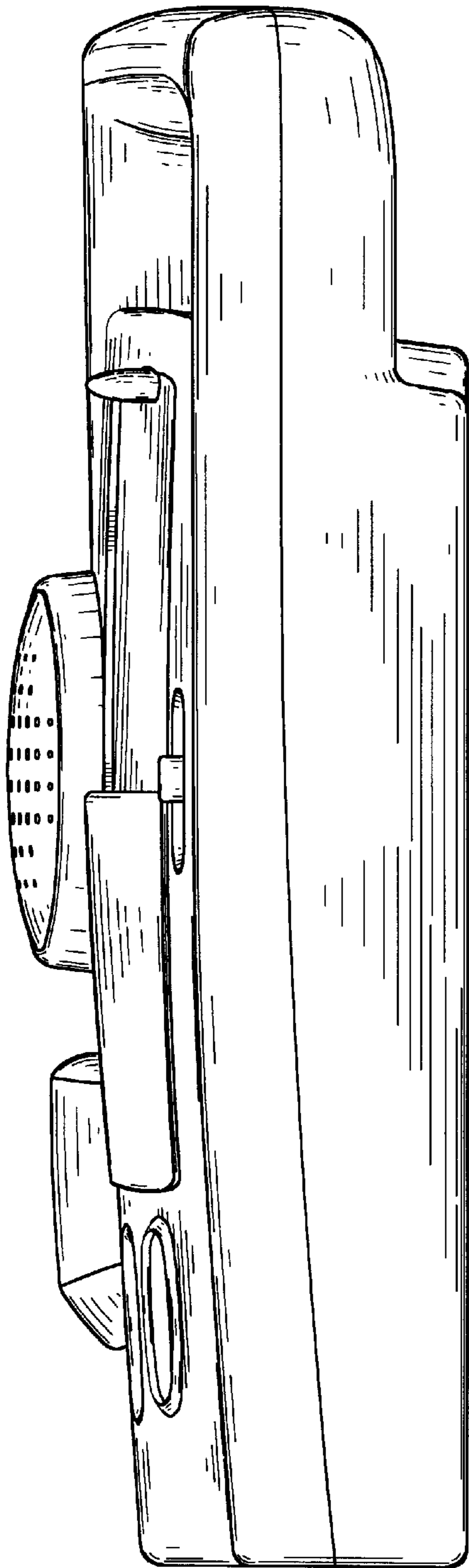

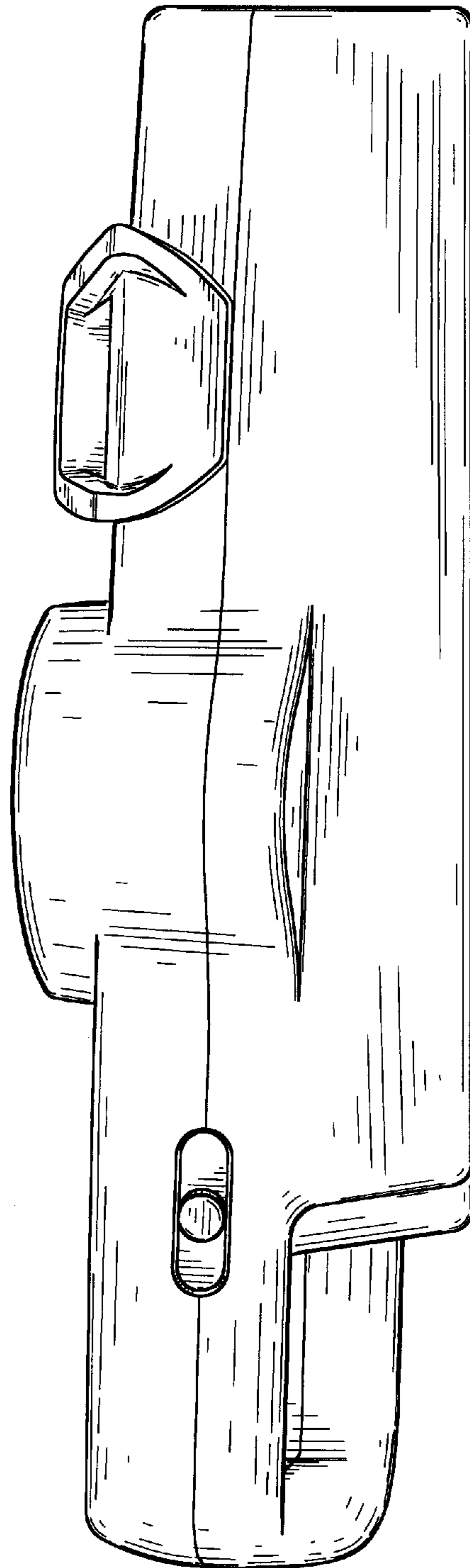

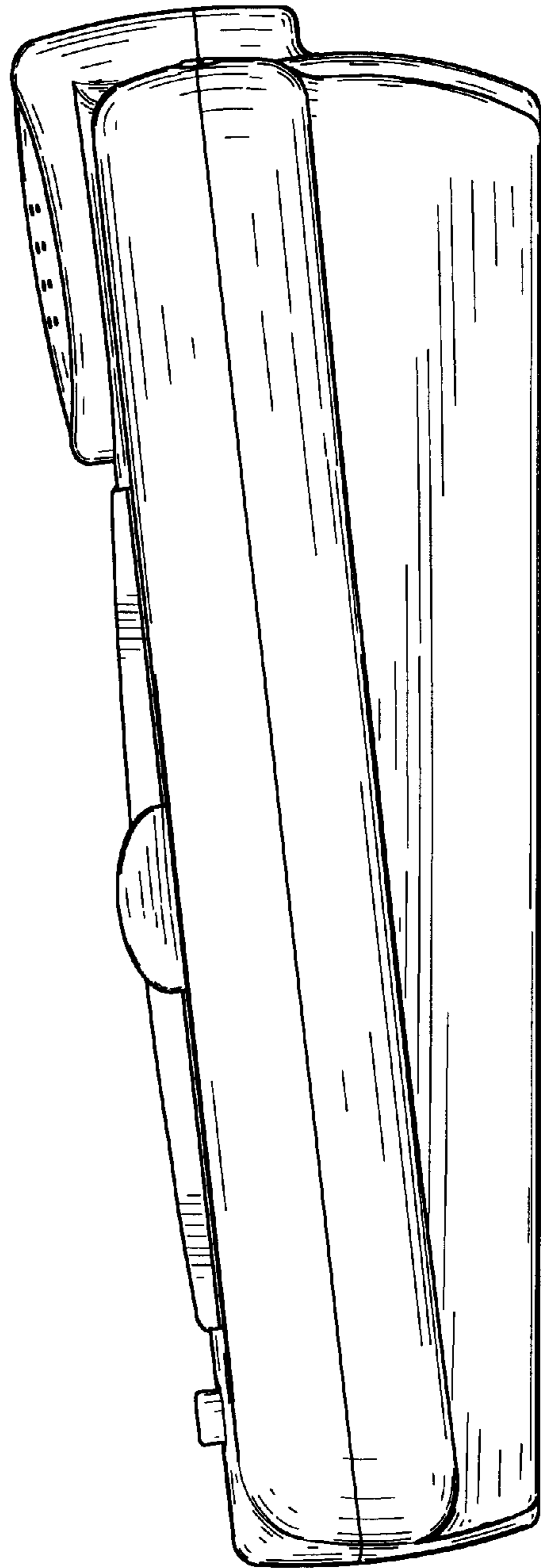

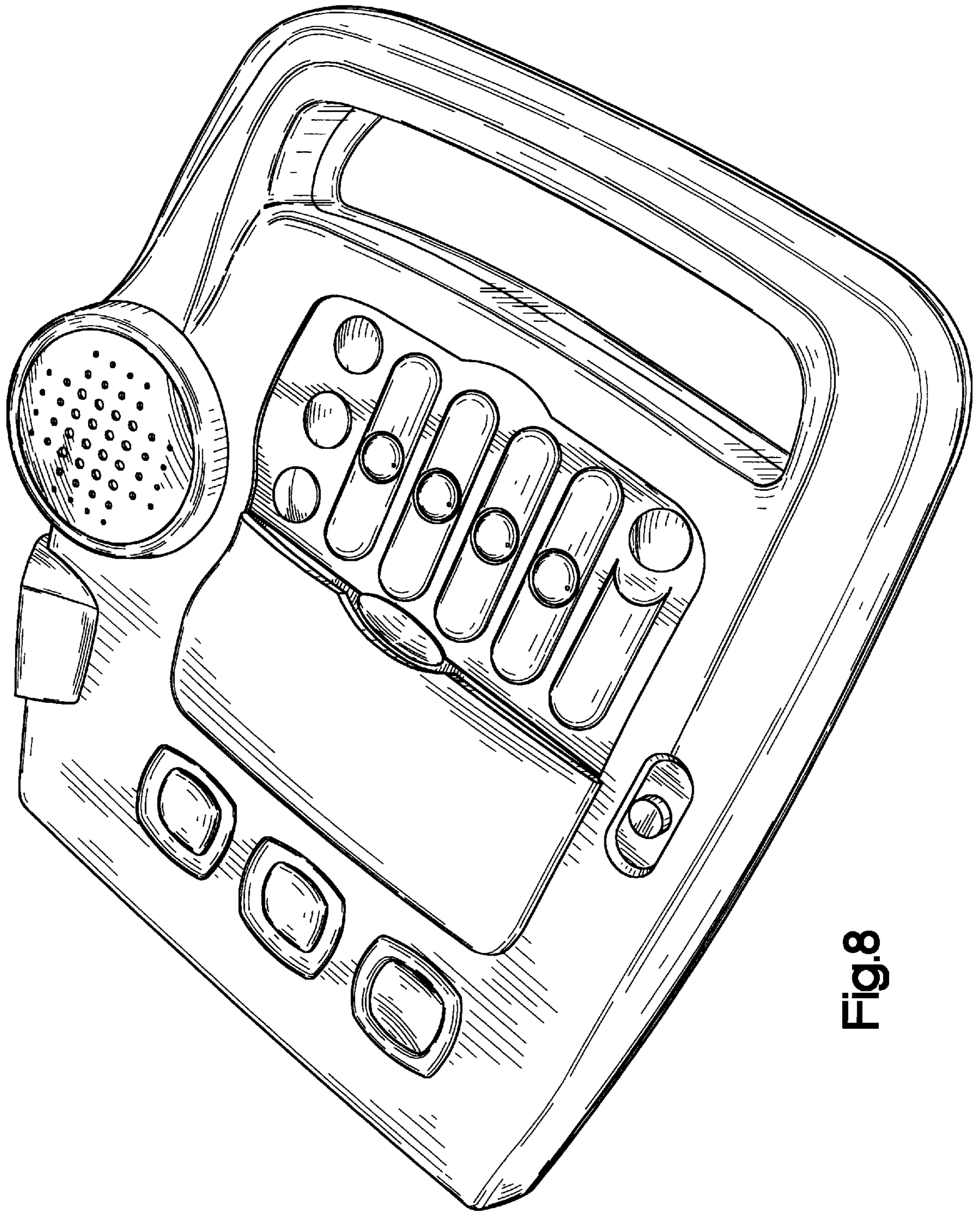

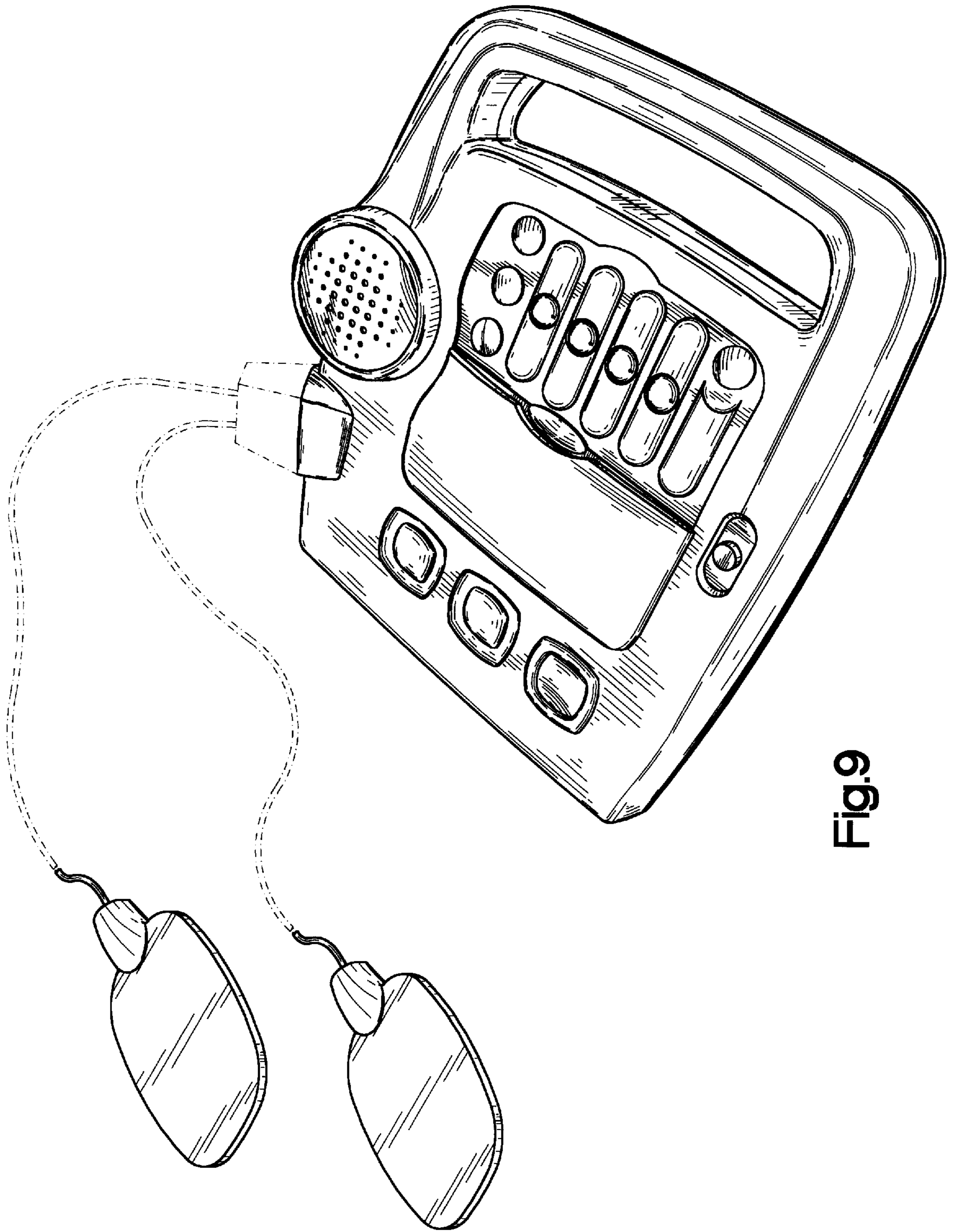

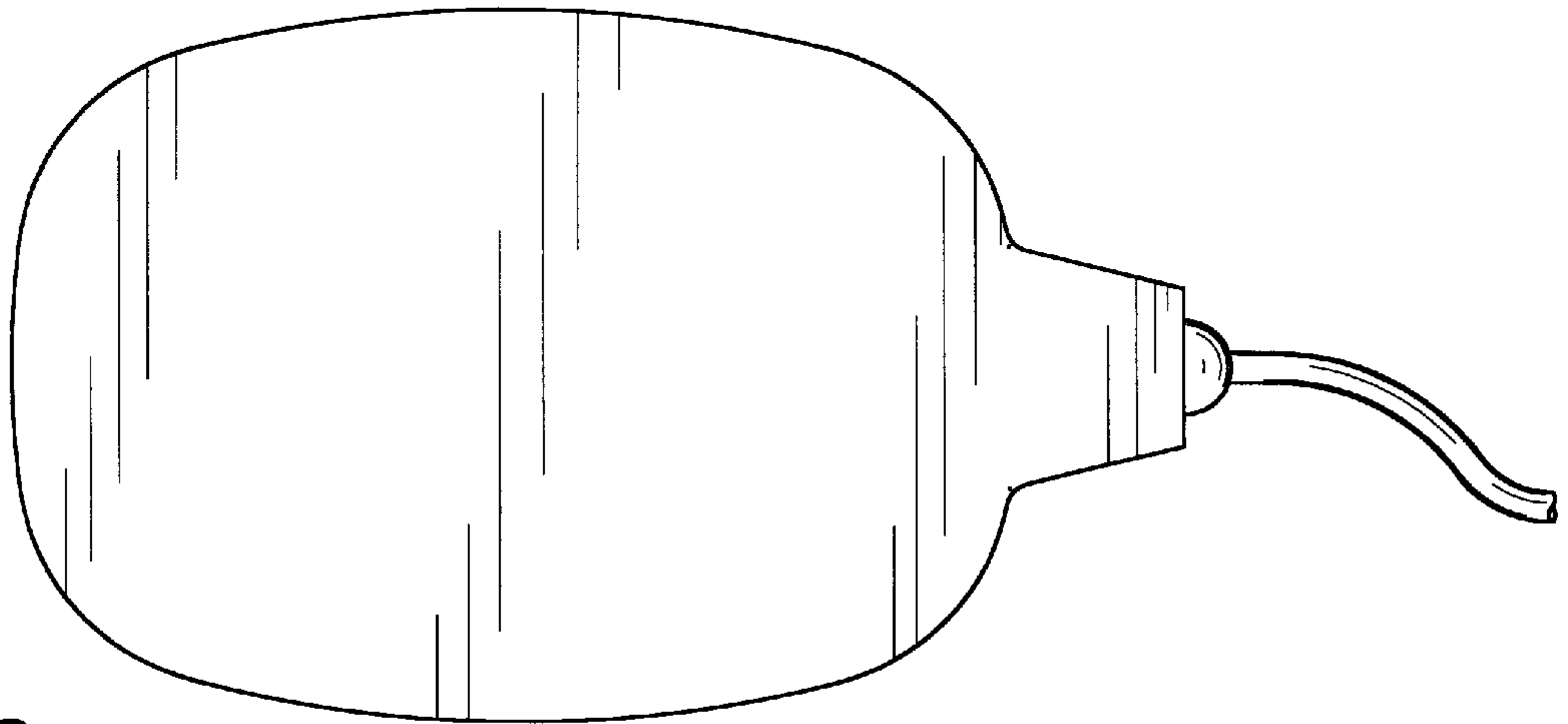

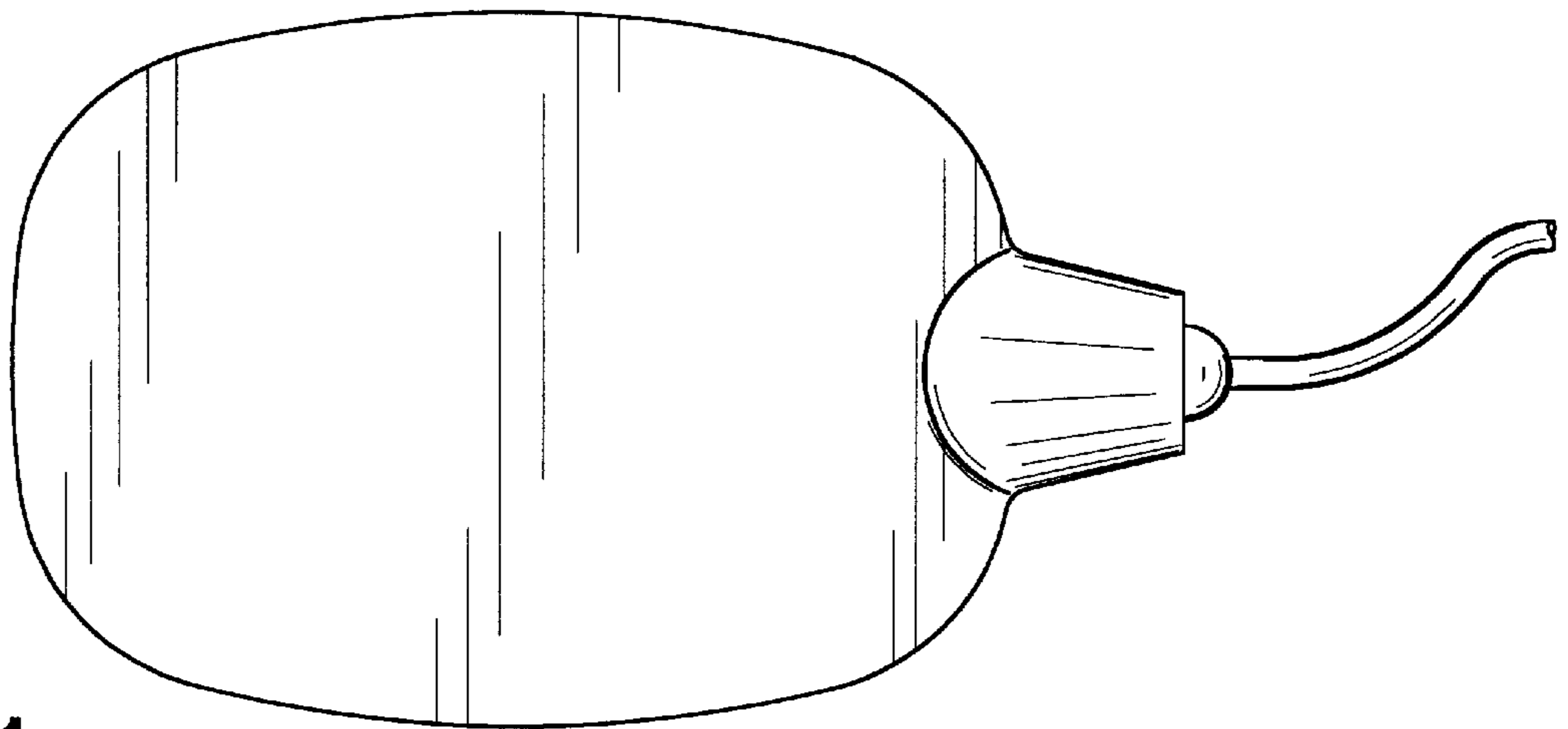

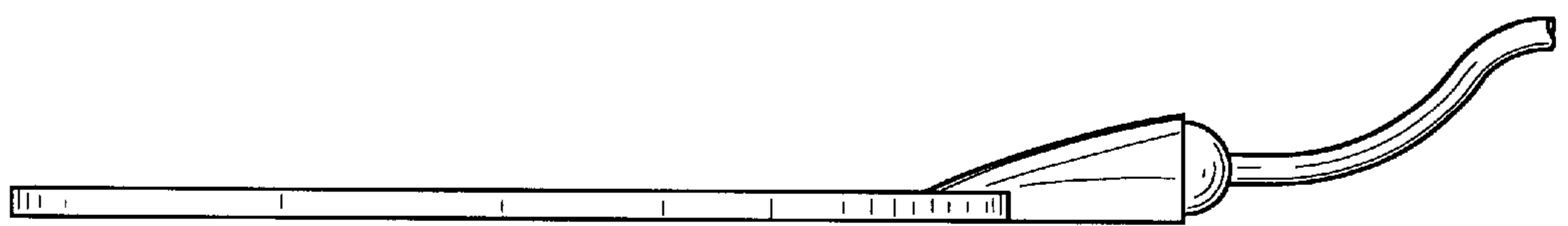

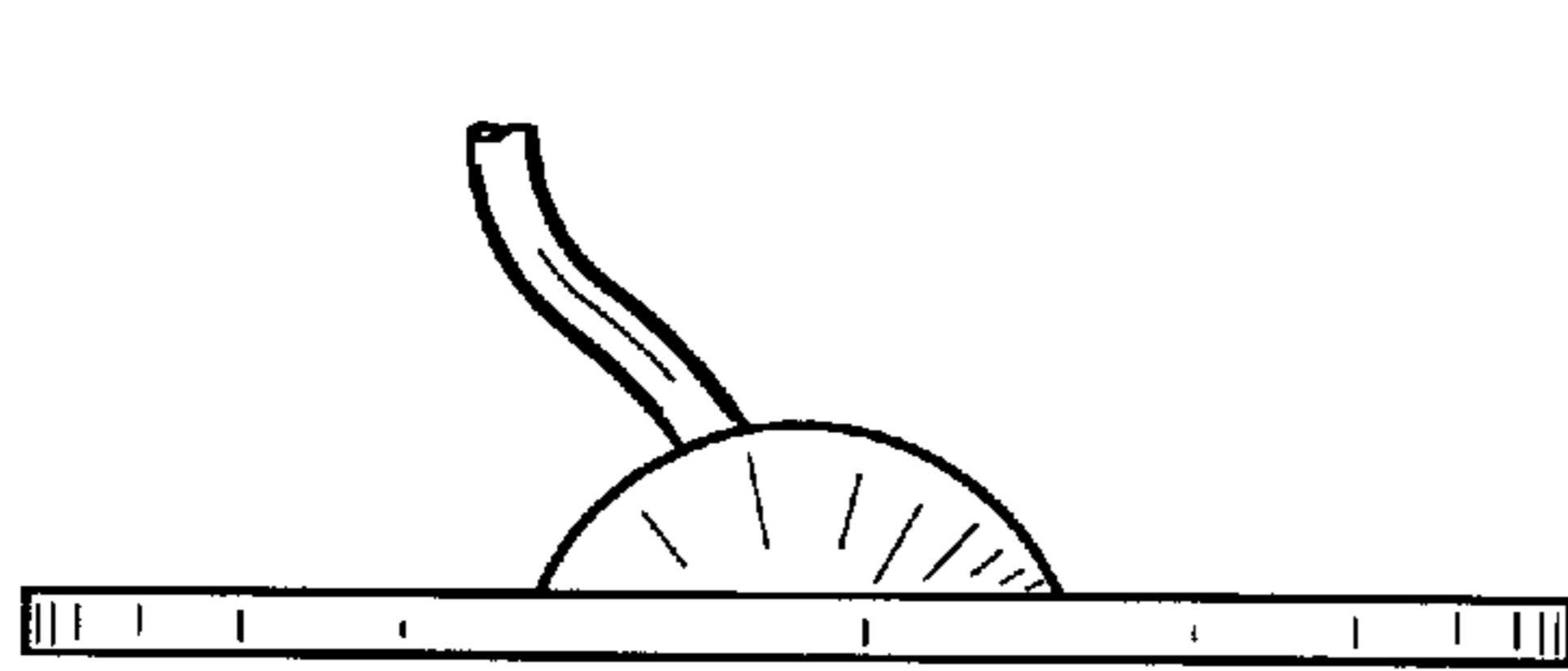

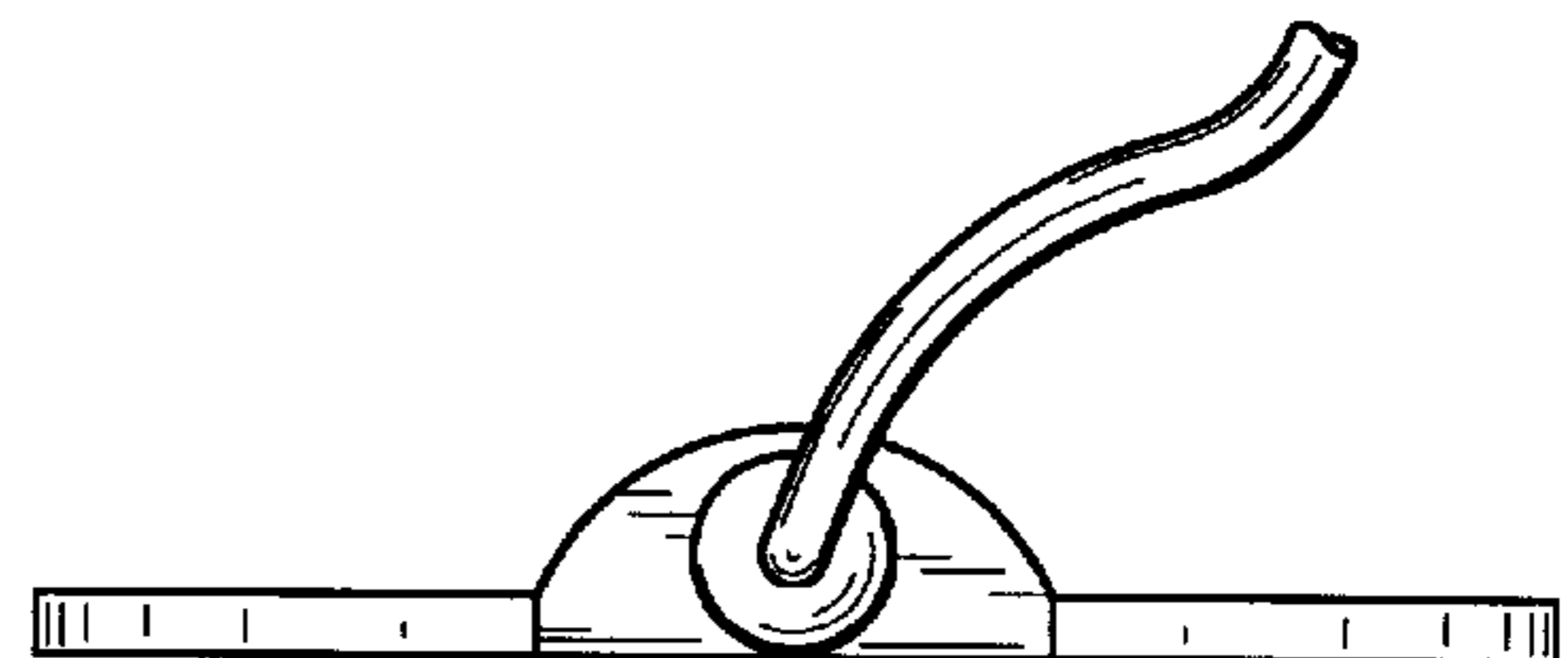
