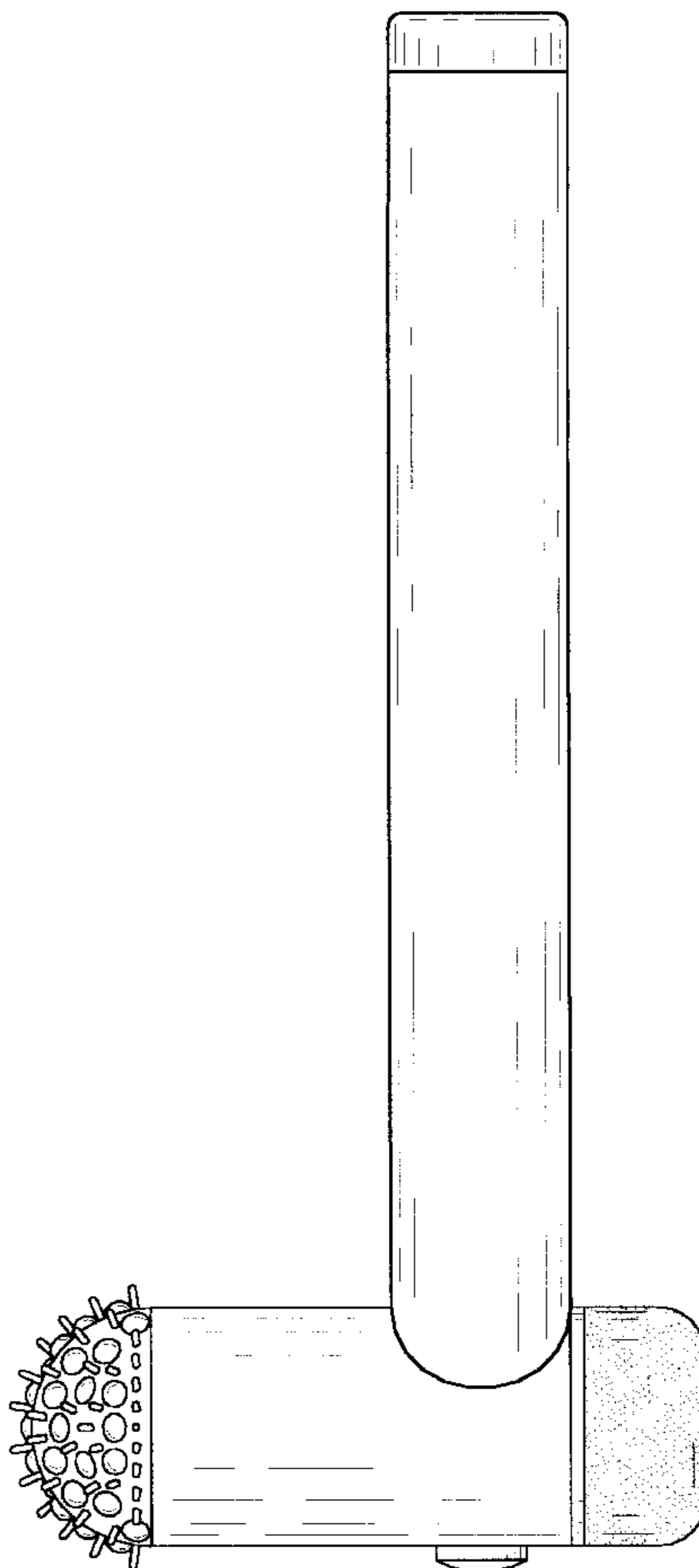
[57] **CLAIM**

The ornamental design for a combination hand-held lotion applicator with back scratcher portion, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of the combination hand-held lotion applicator with back scratcher portion showing my new design;

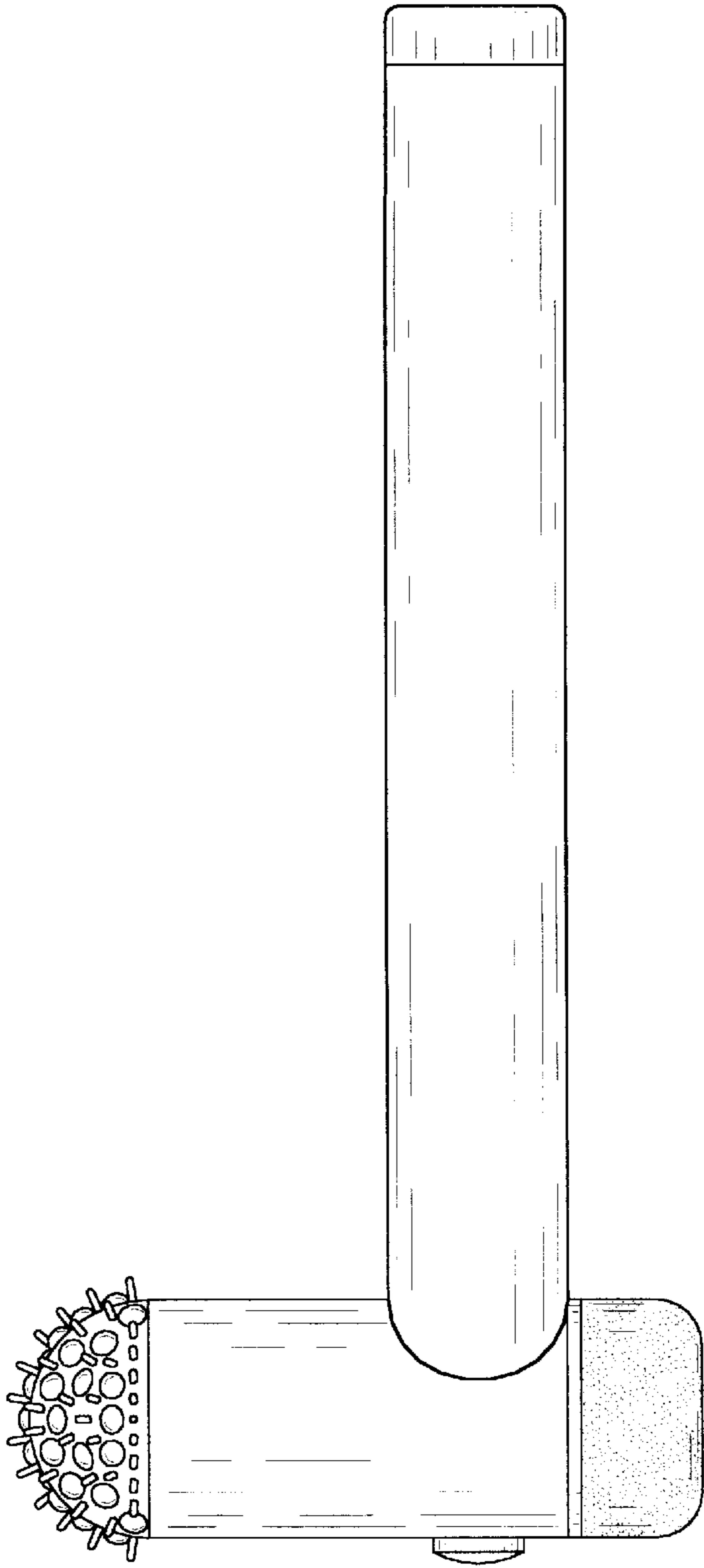

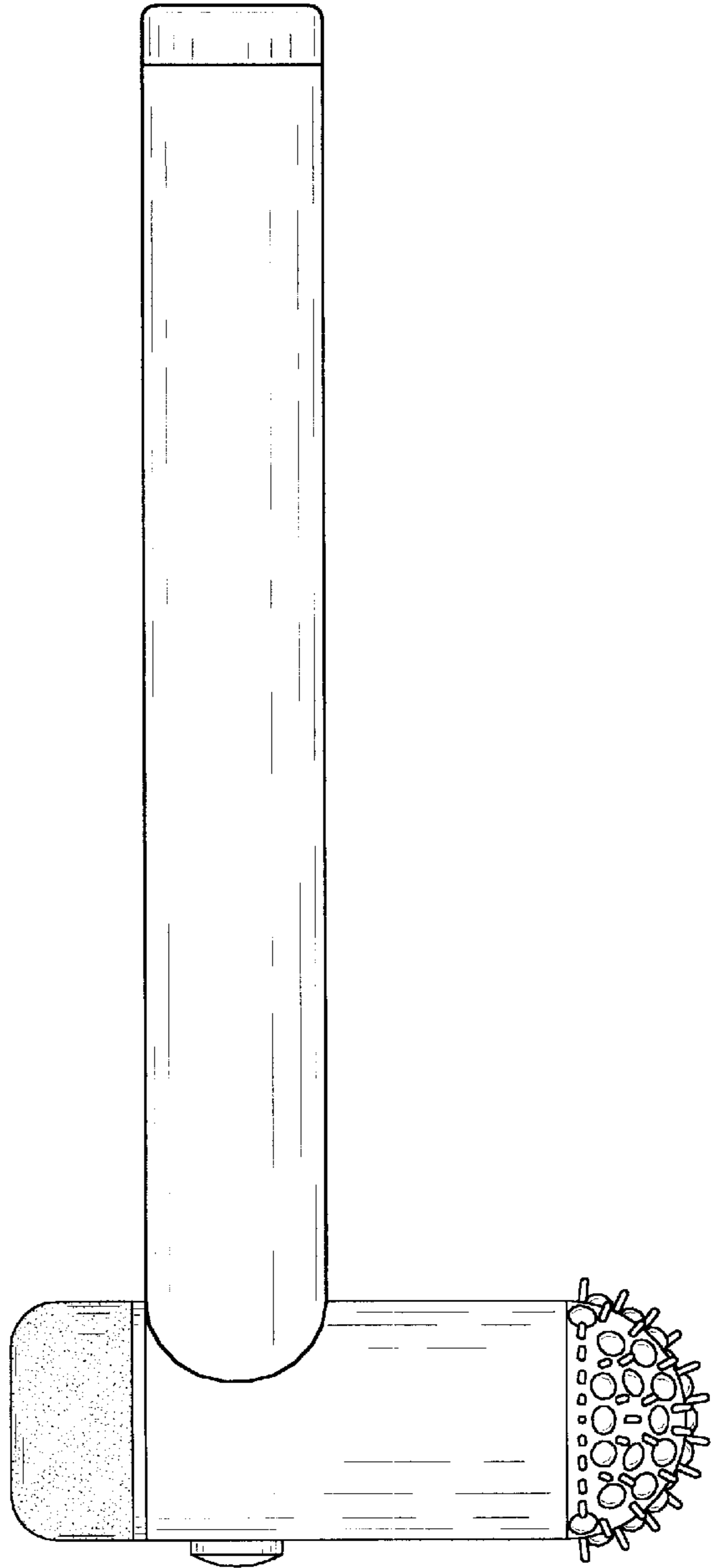

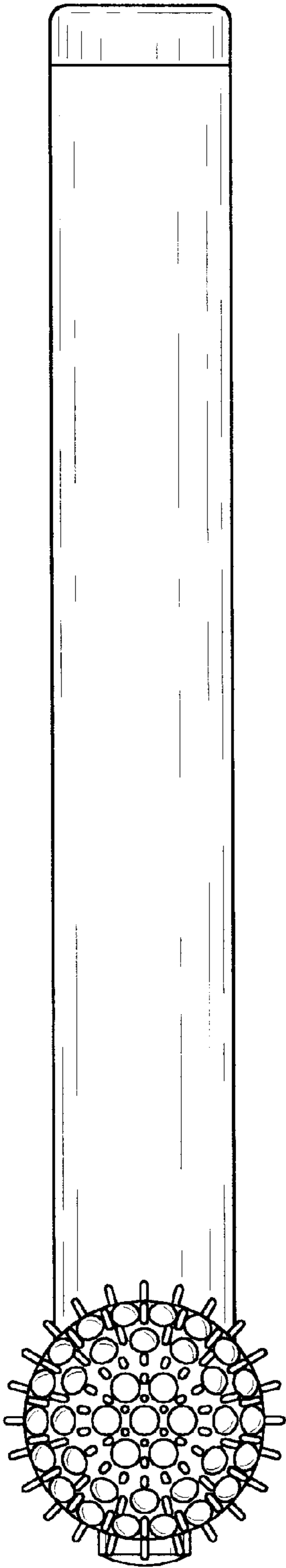

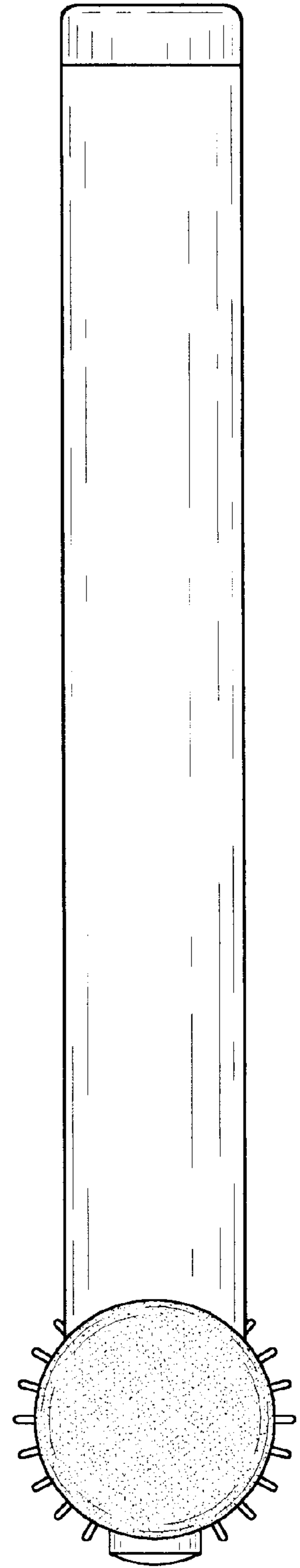

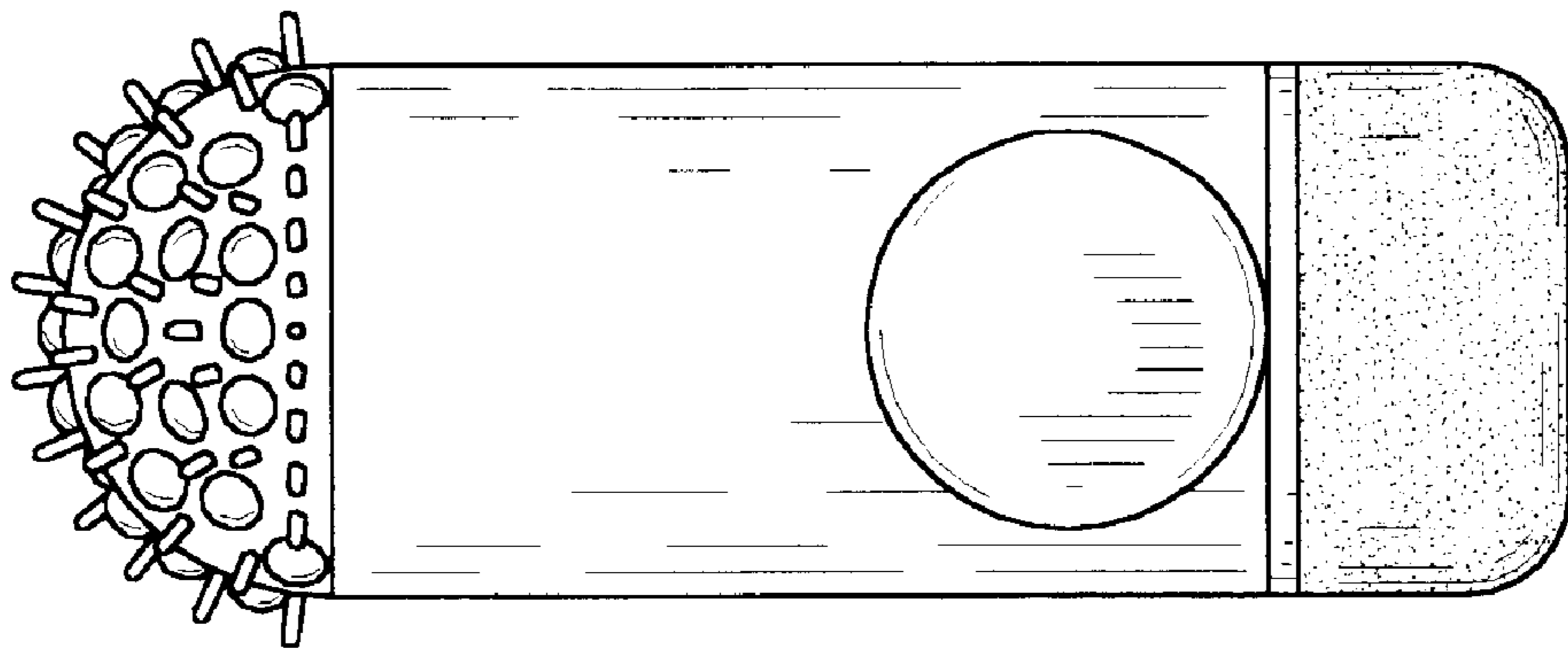

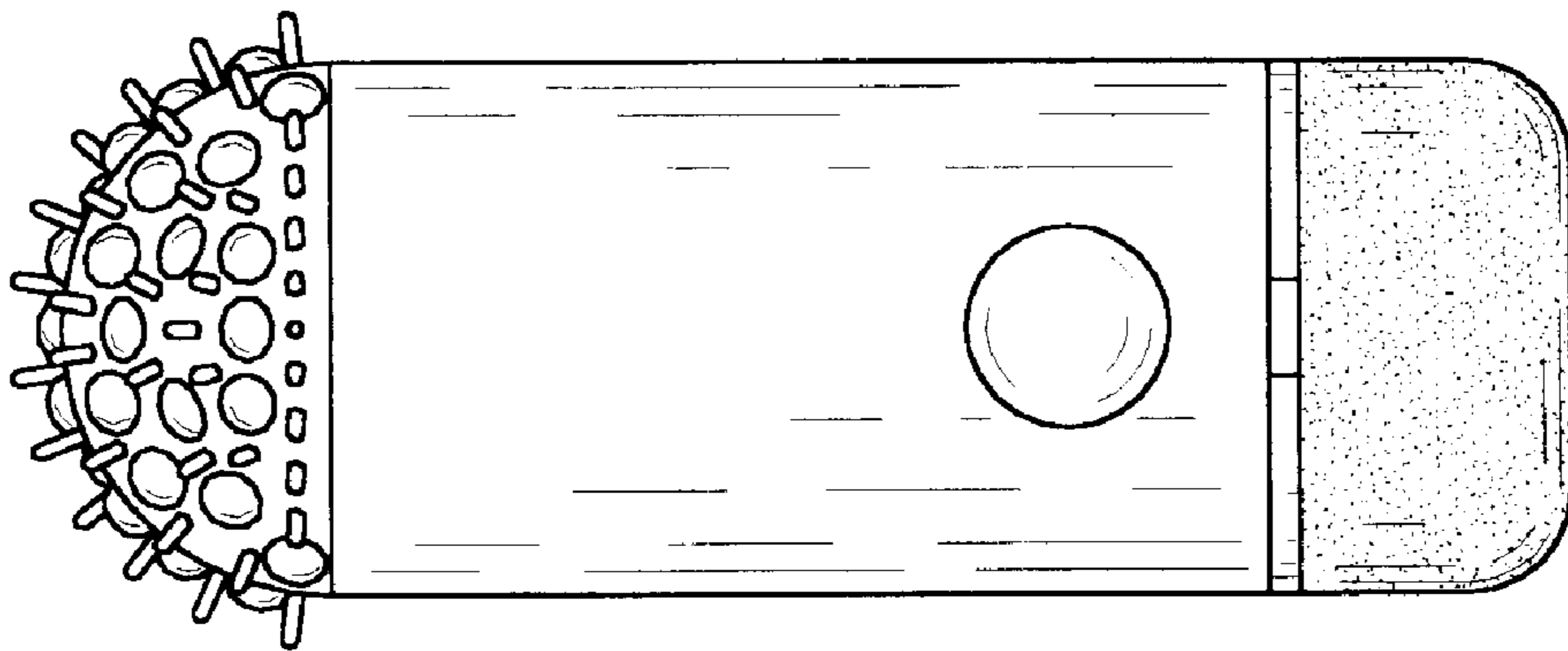
