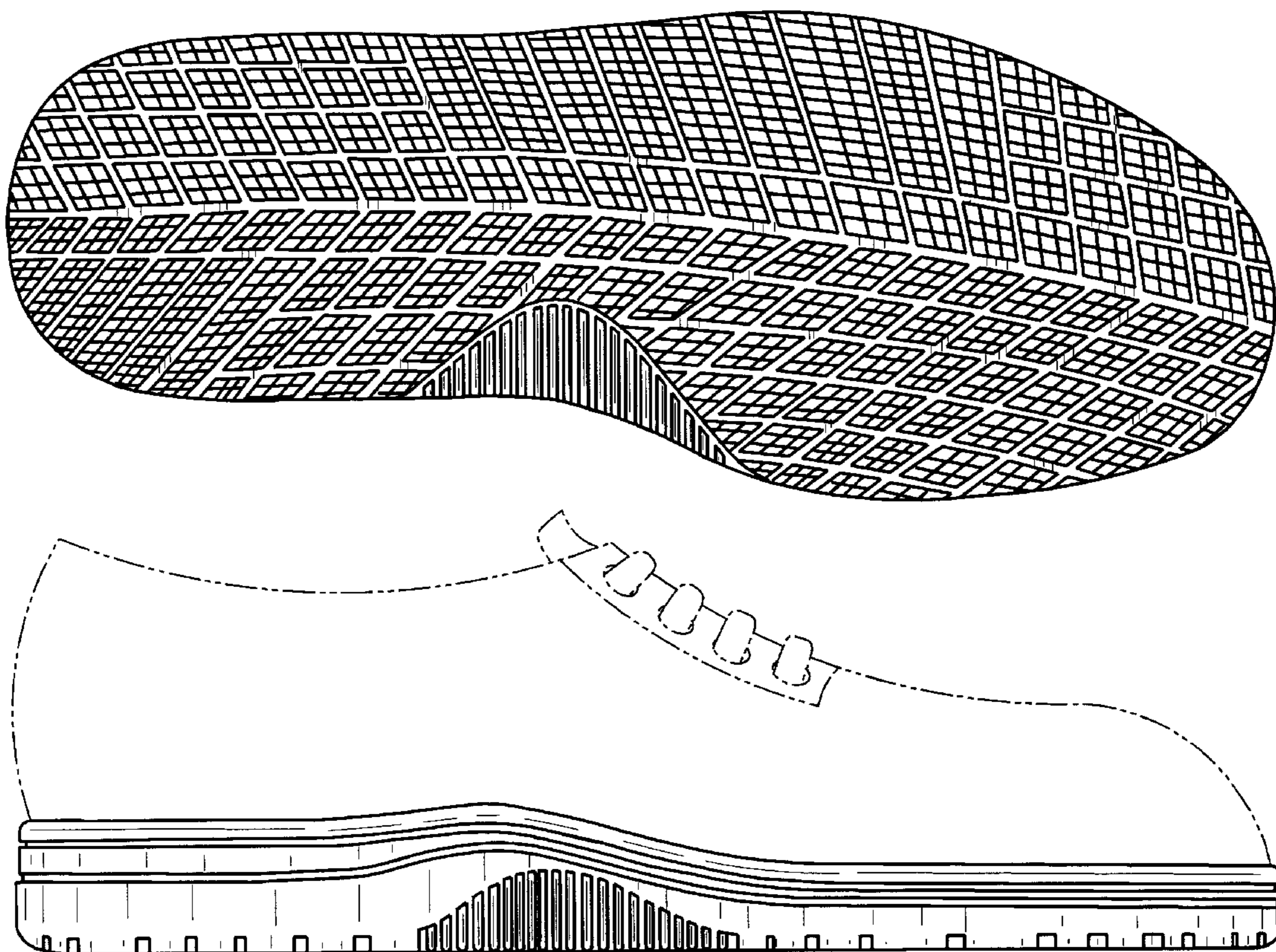
[57] **CLAIM**

I claim the ornamental design for a shoe sole, as shown and described.

DESCRIPTION

FIG. 1 is a bottom plan view of a shoe sole illustrating my new design;
FIG. 2 is a right side elevational view thereof;
FIG. 3 is a left side elevational view thereof;
FIG. 4 is a front elevational view thereof; and,
FIG. 5 is a rear elevational view thereof.
The broken line showing of a shoe upper in FIG. 2, and the partial broken line showing of the shoe upper in FIGS. 4 and 5 are for illustrative purposes only and form no part of the claimed design.

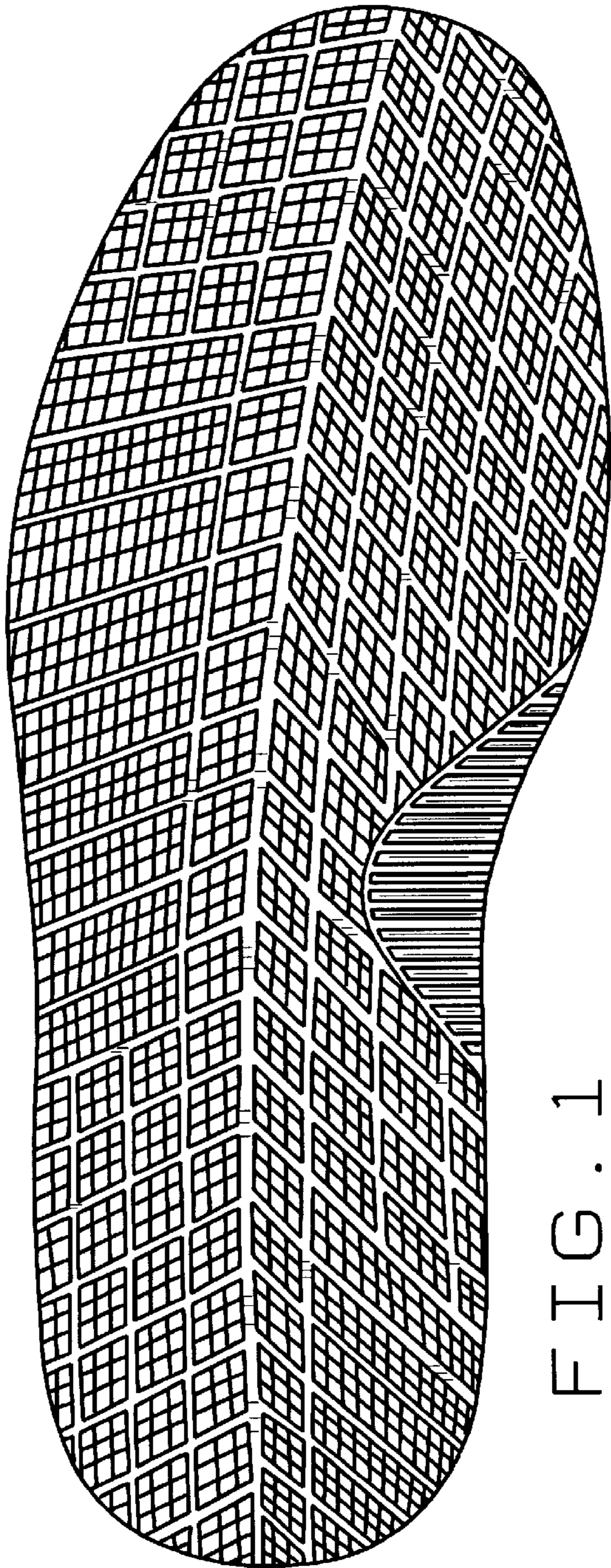

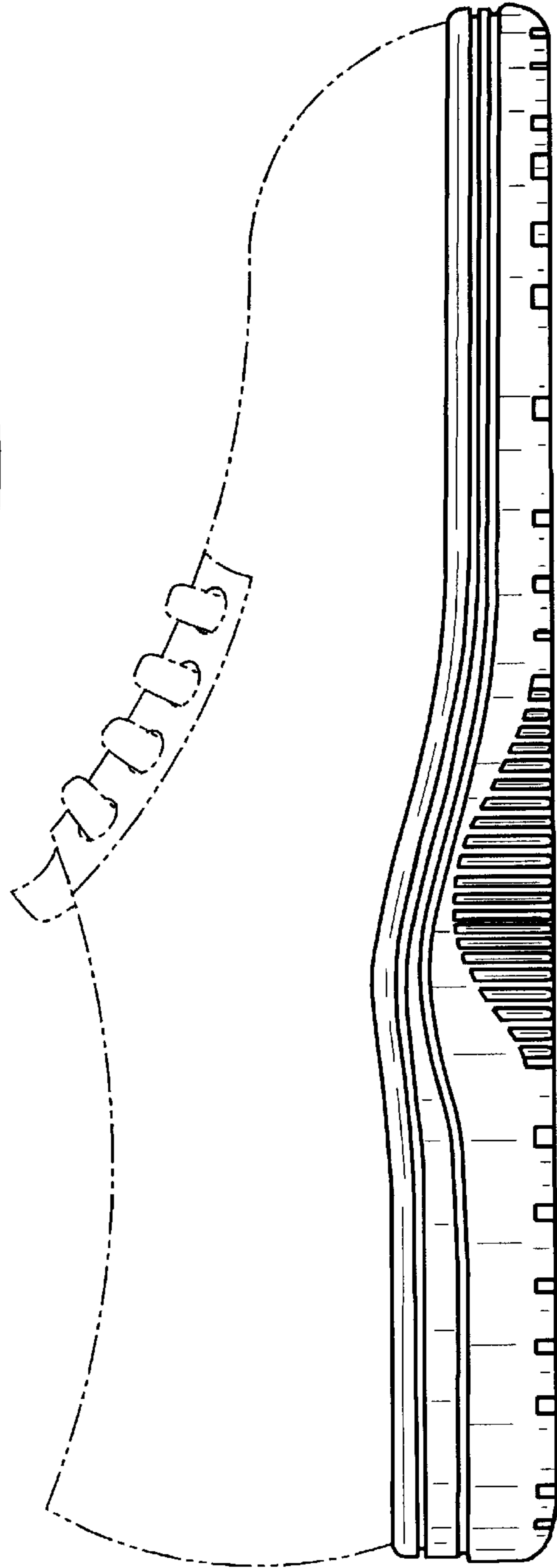

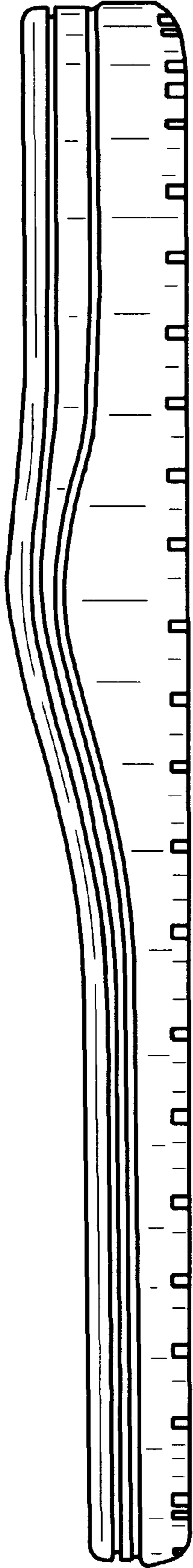

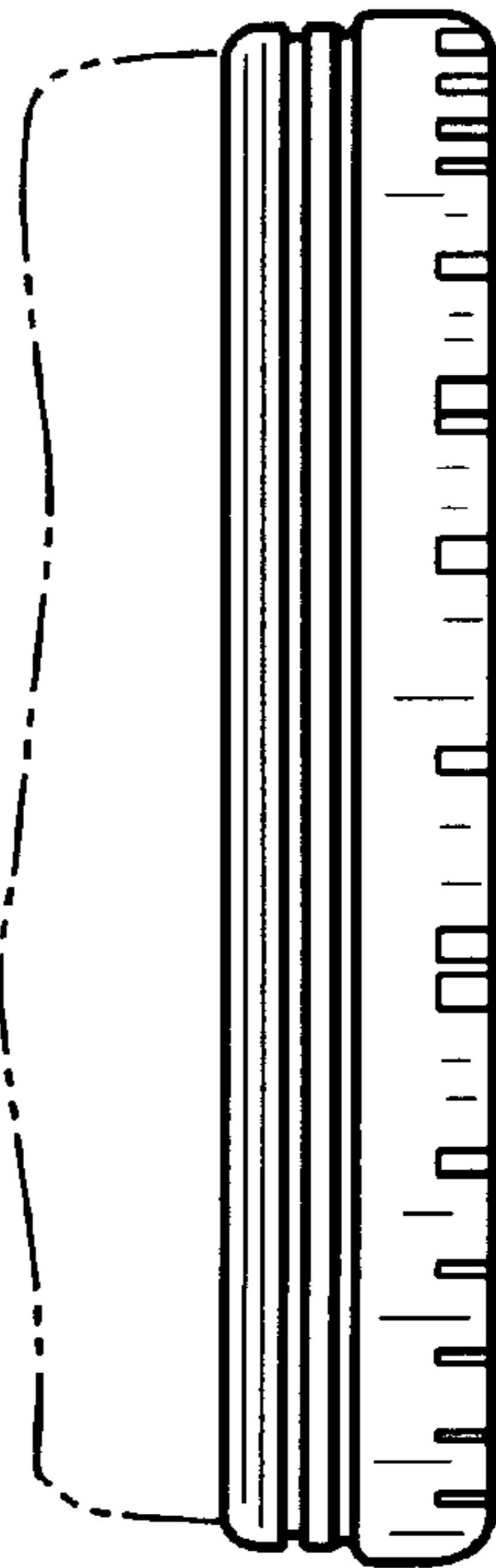
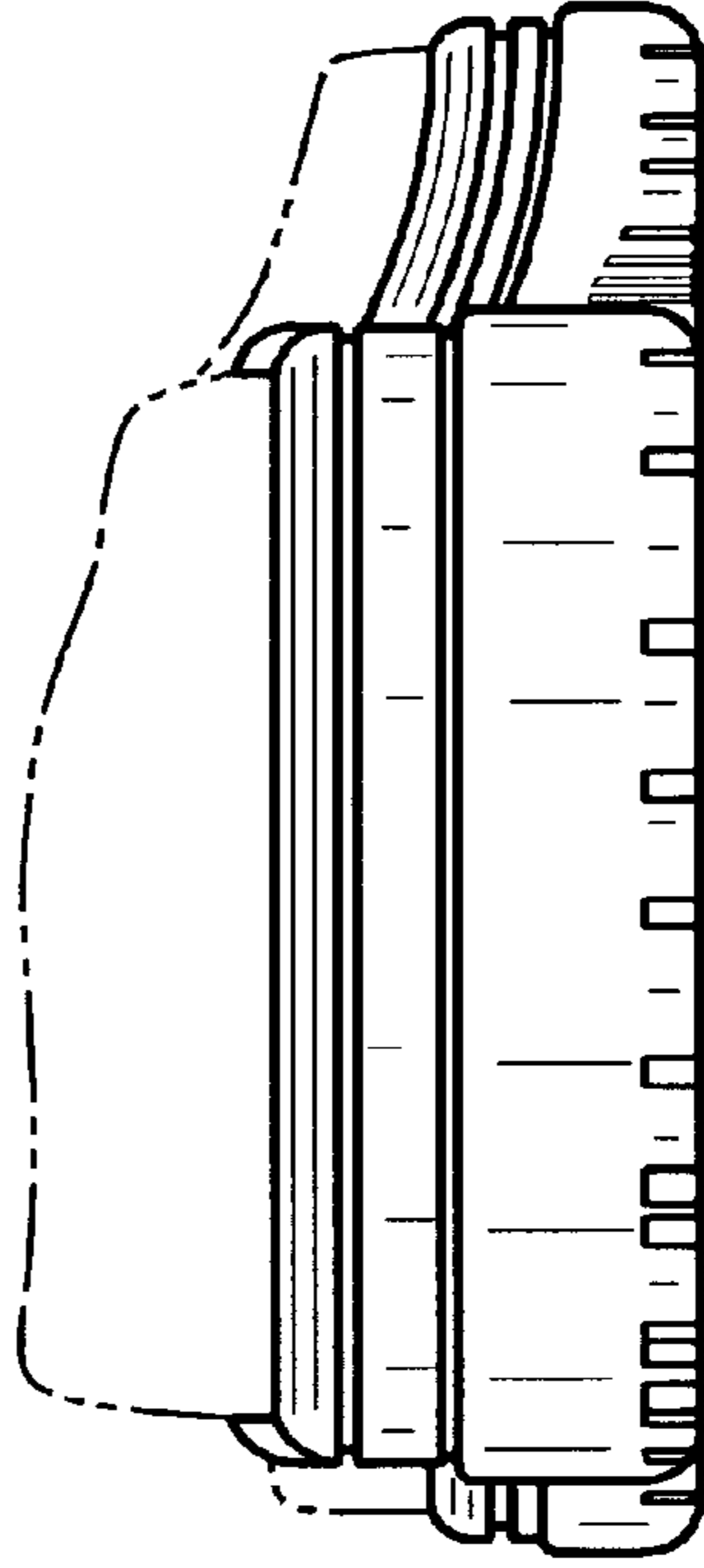
