DESCRIPTION

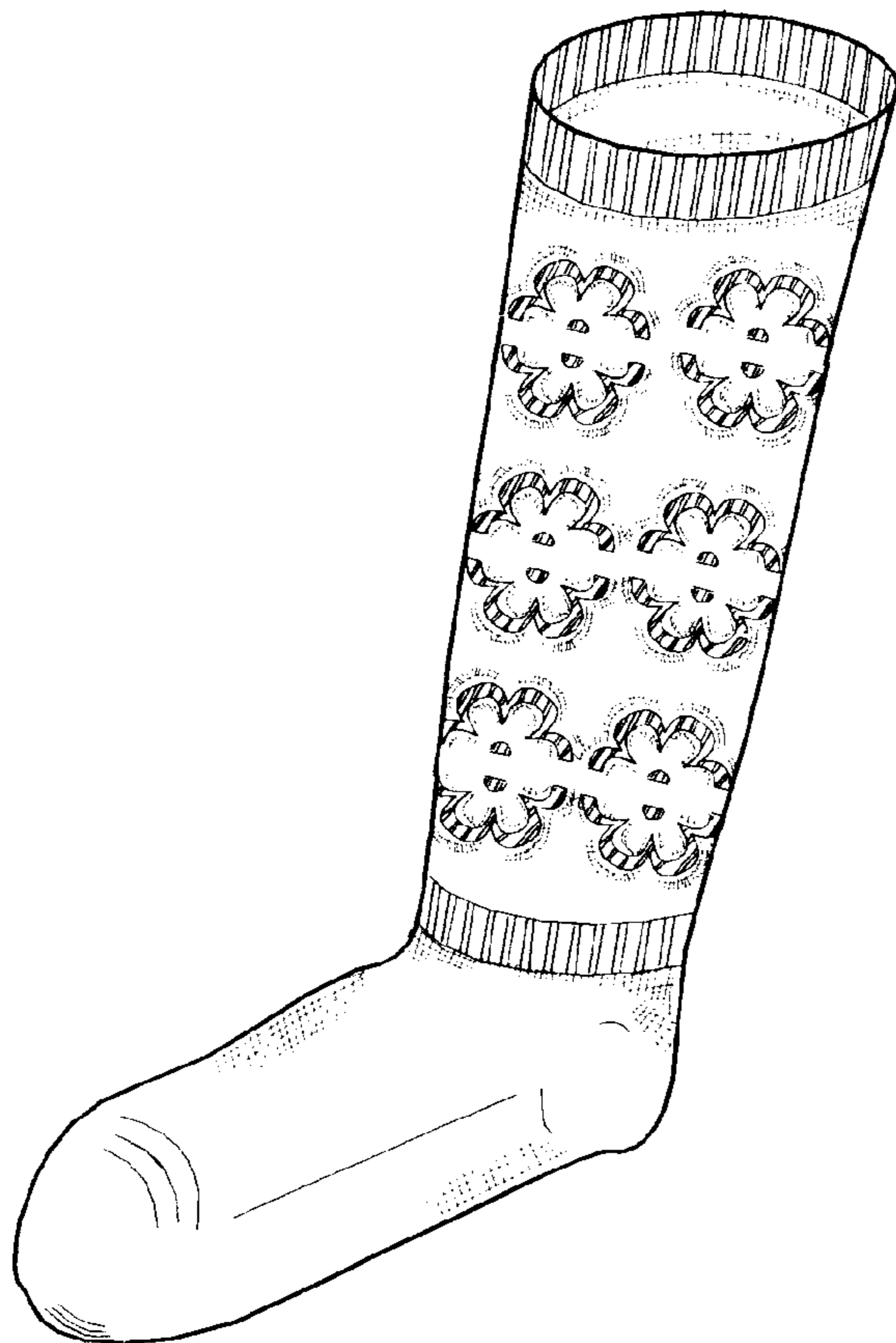

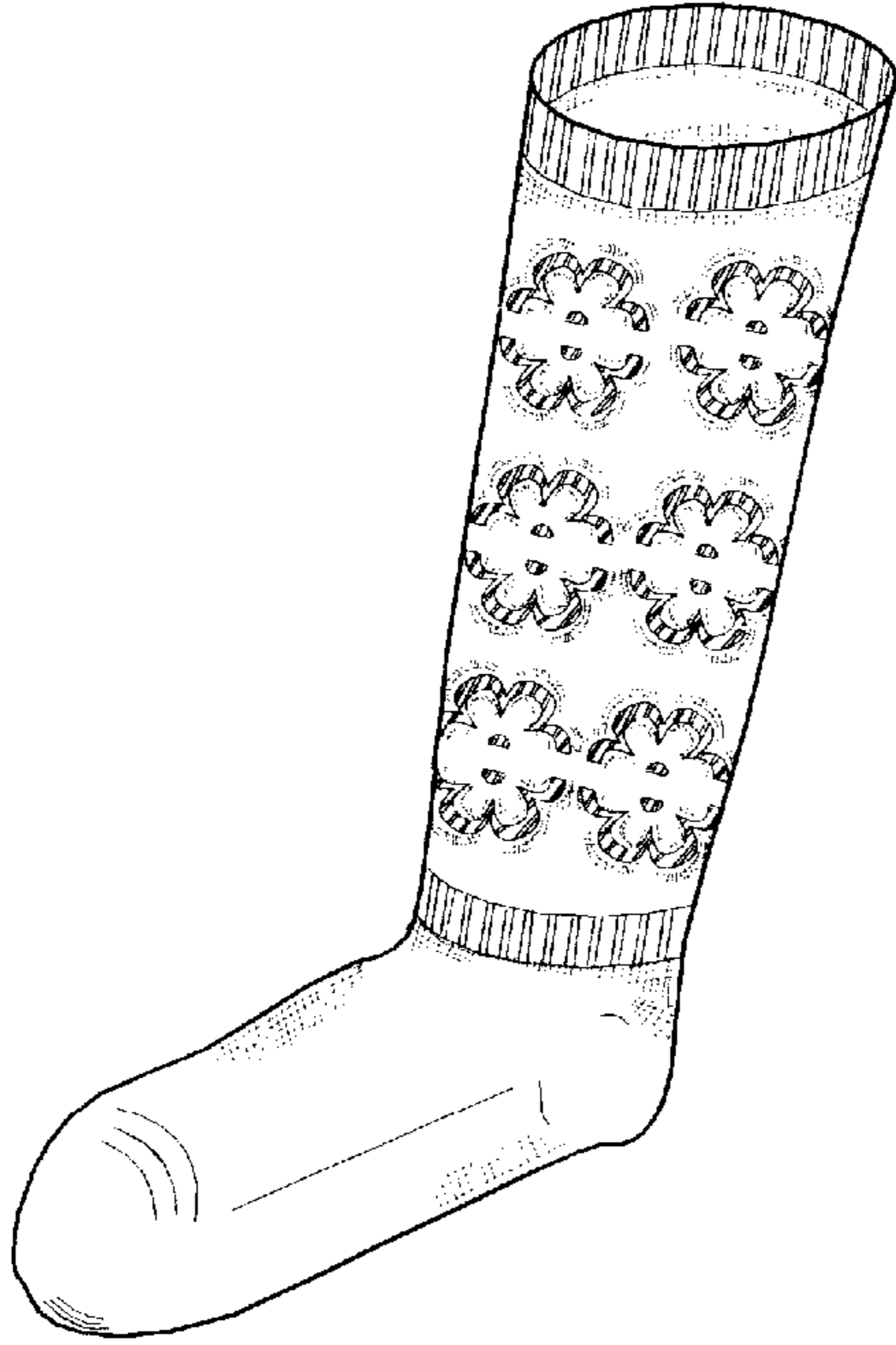

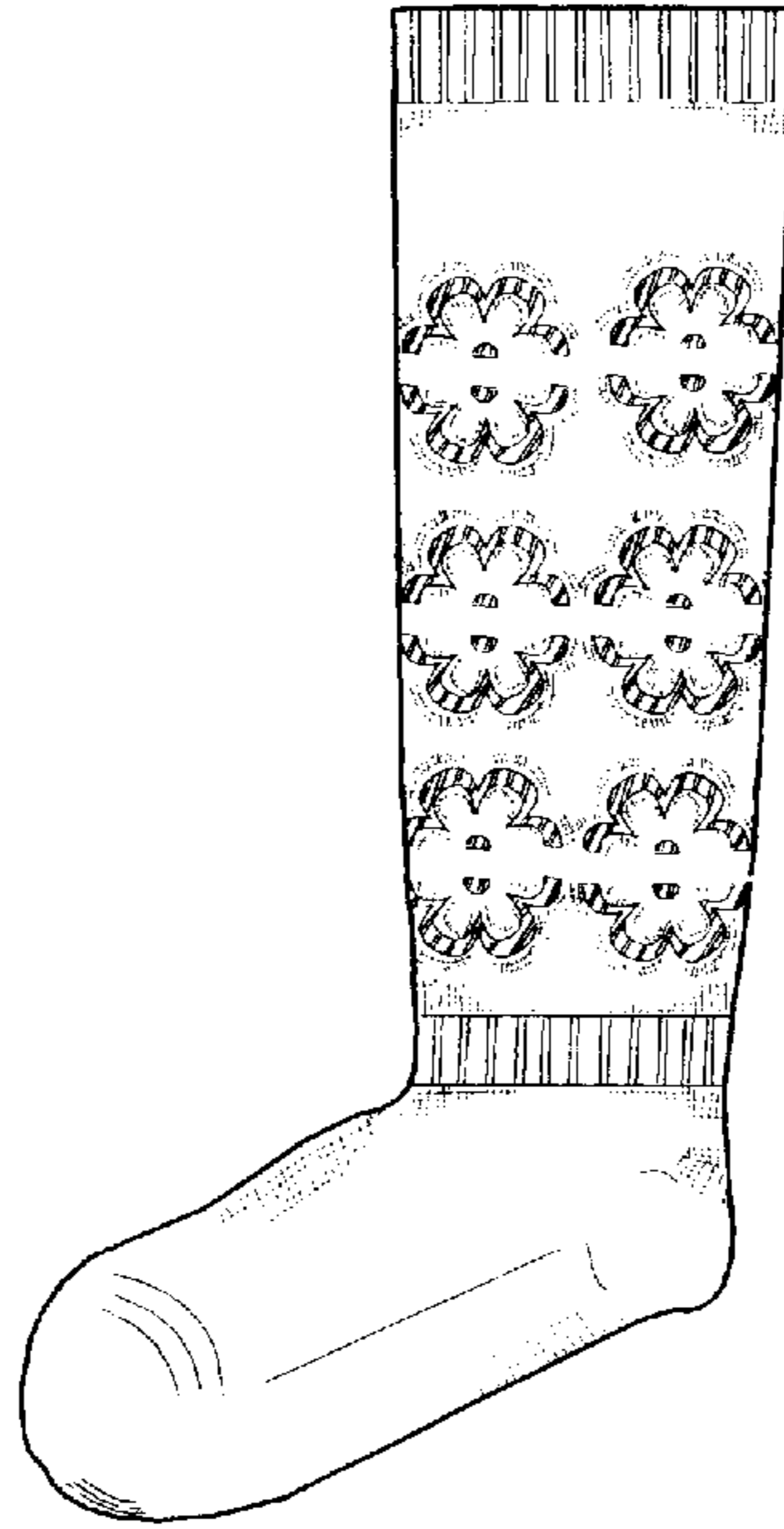

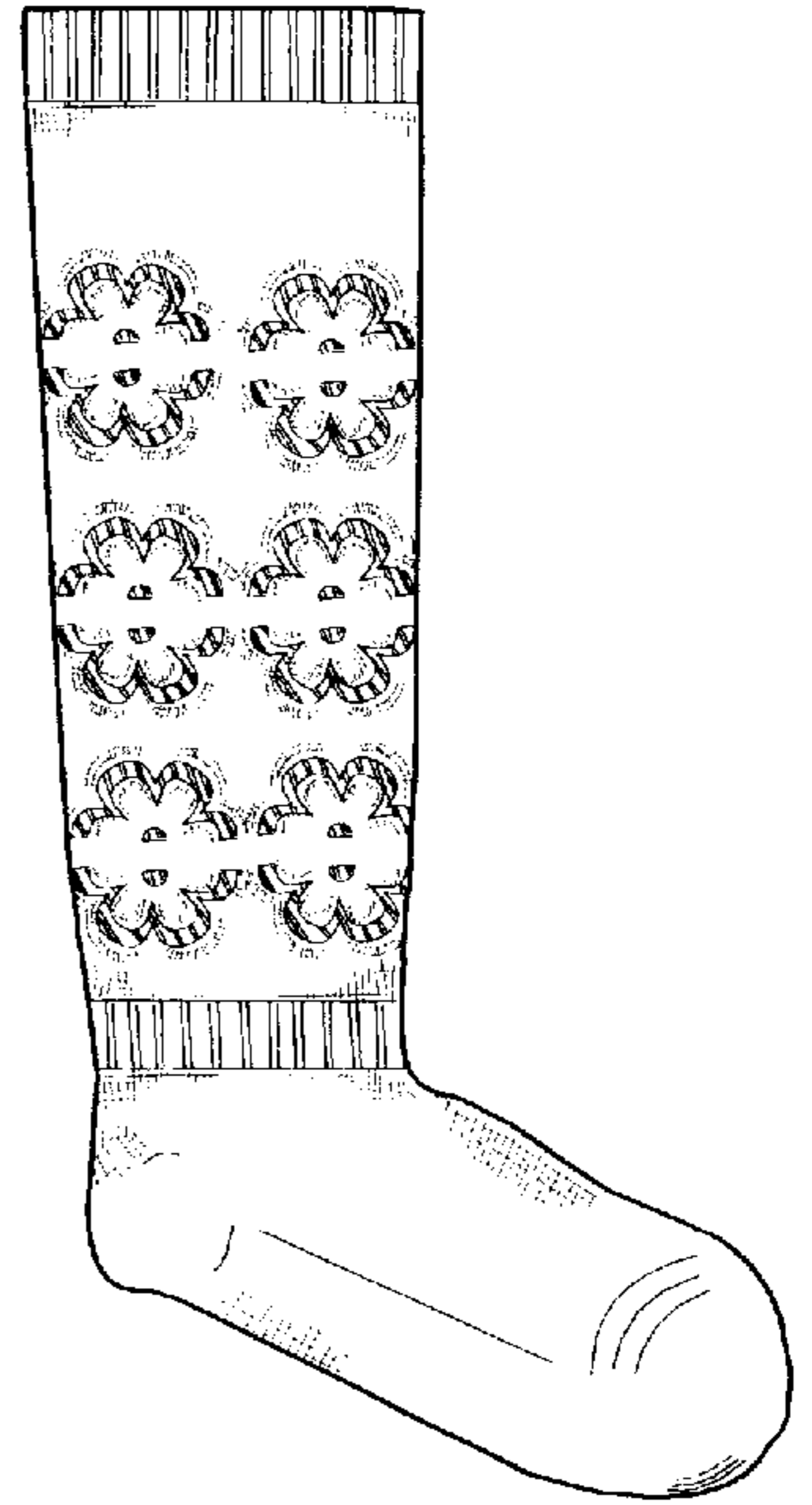

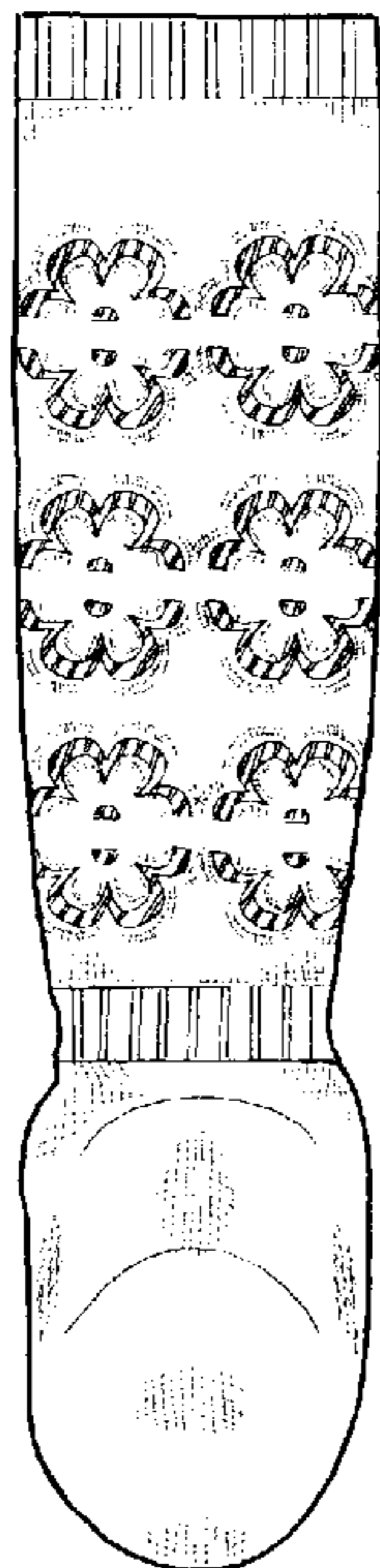

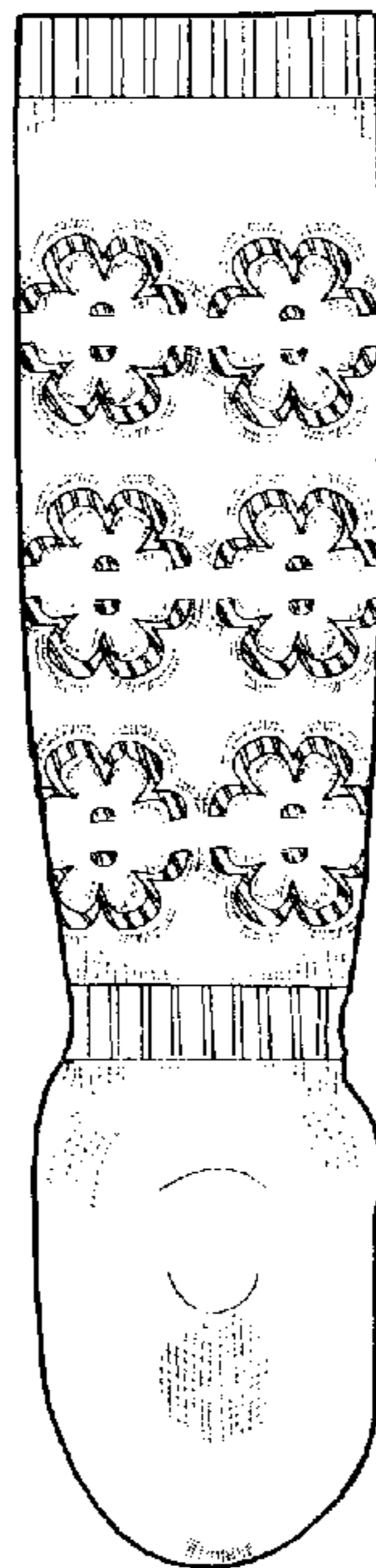

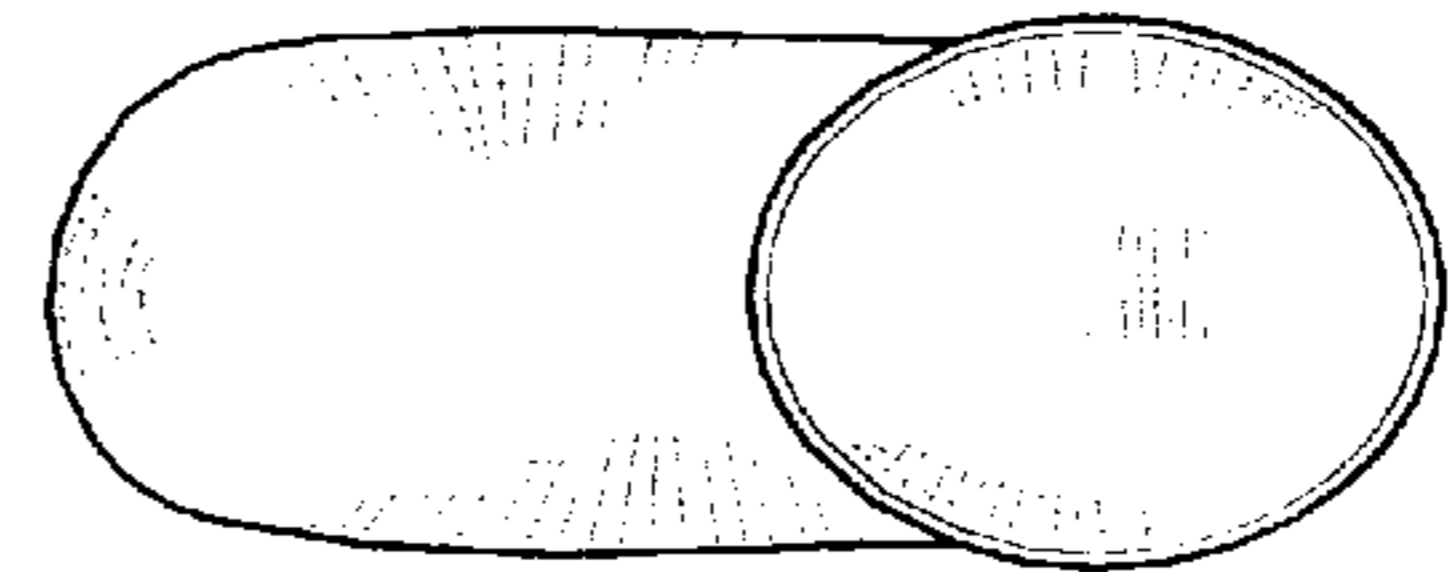

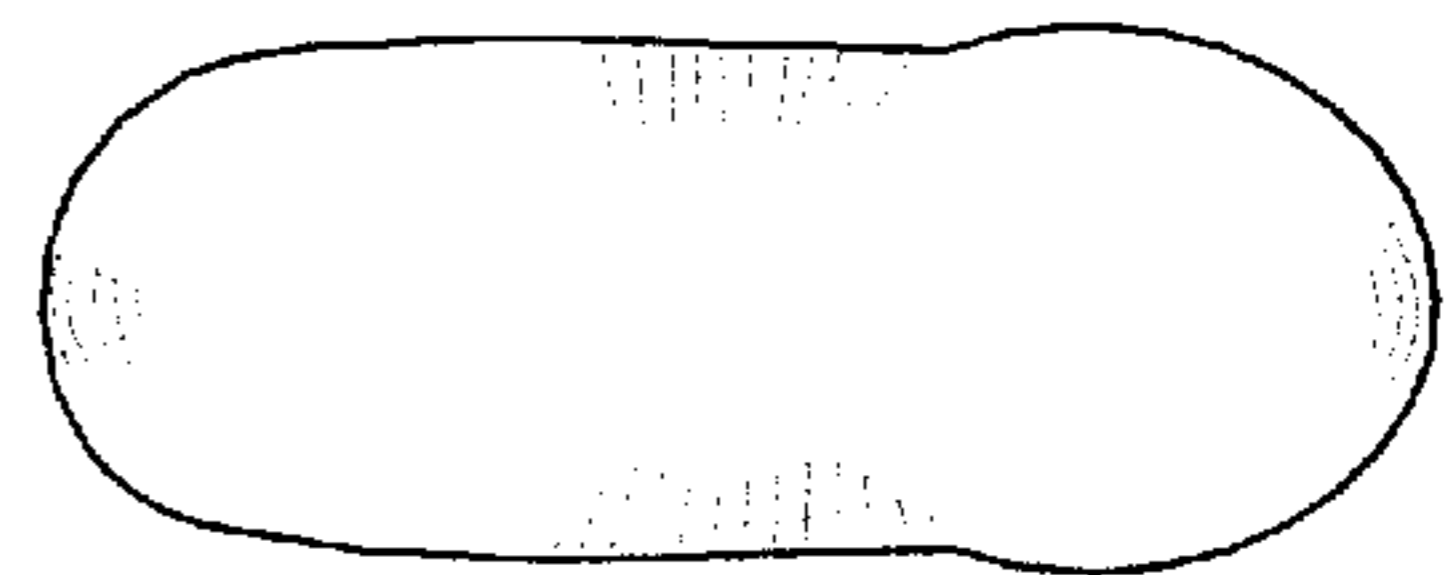

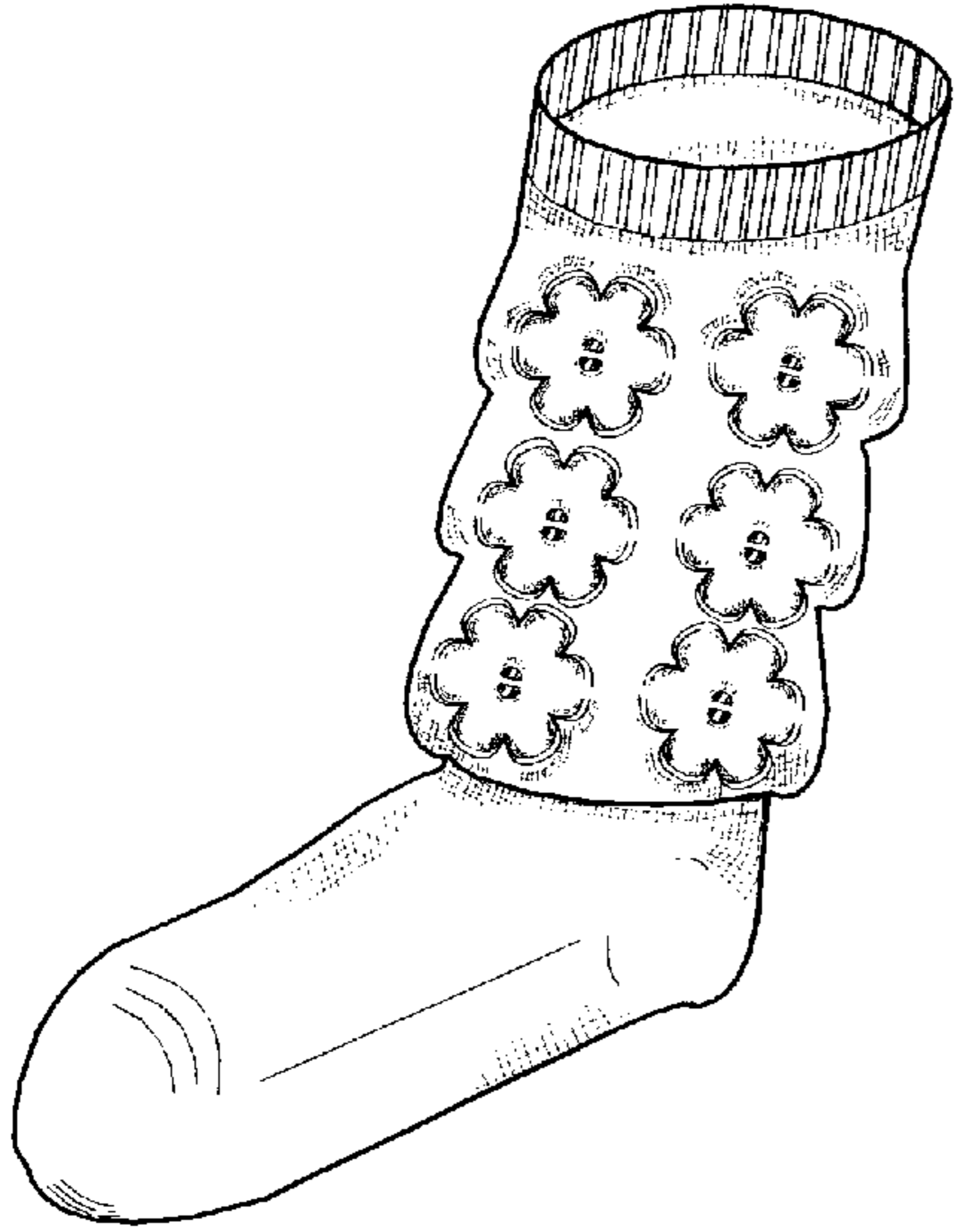

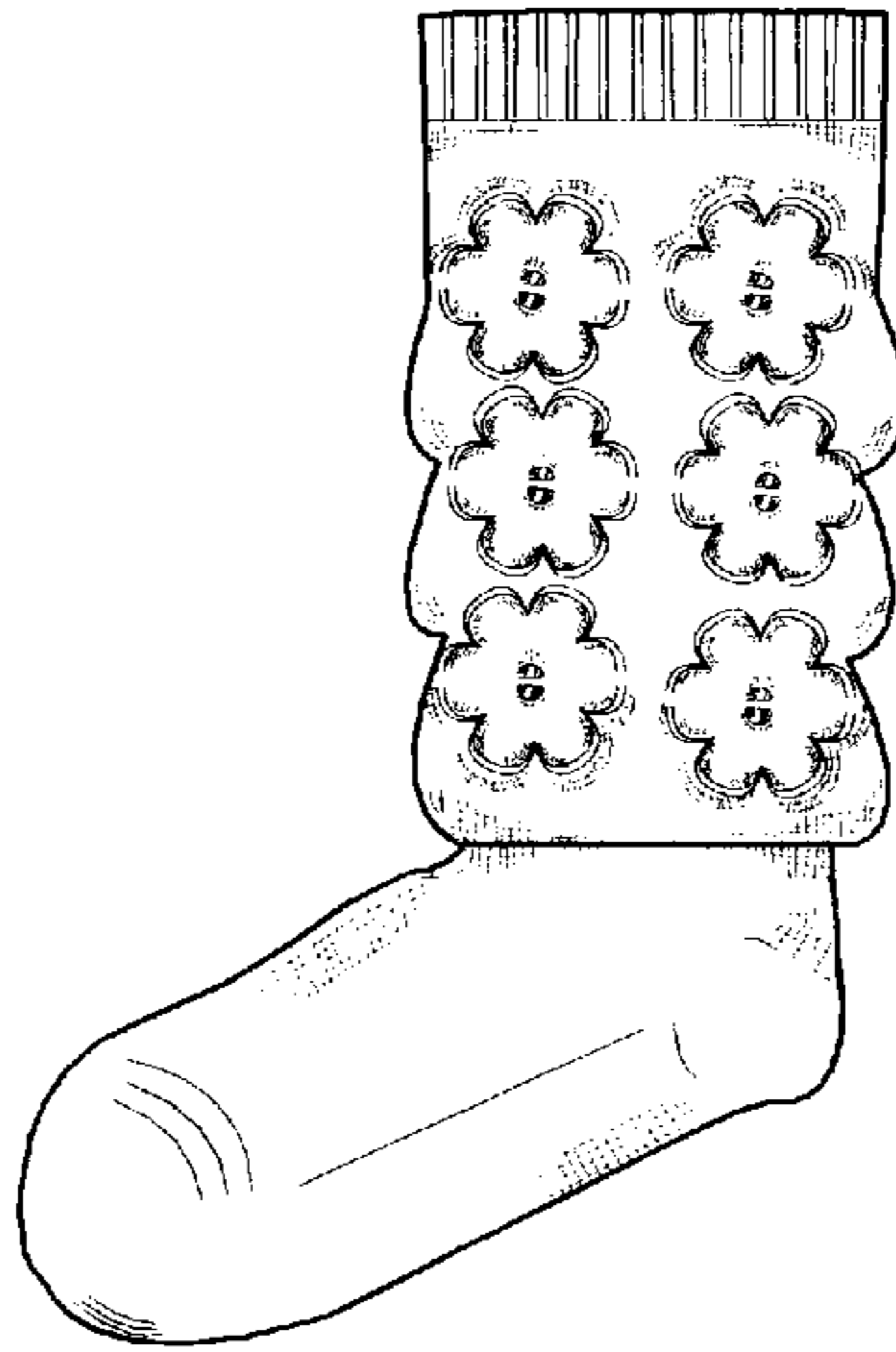

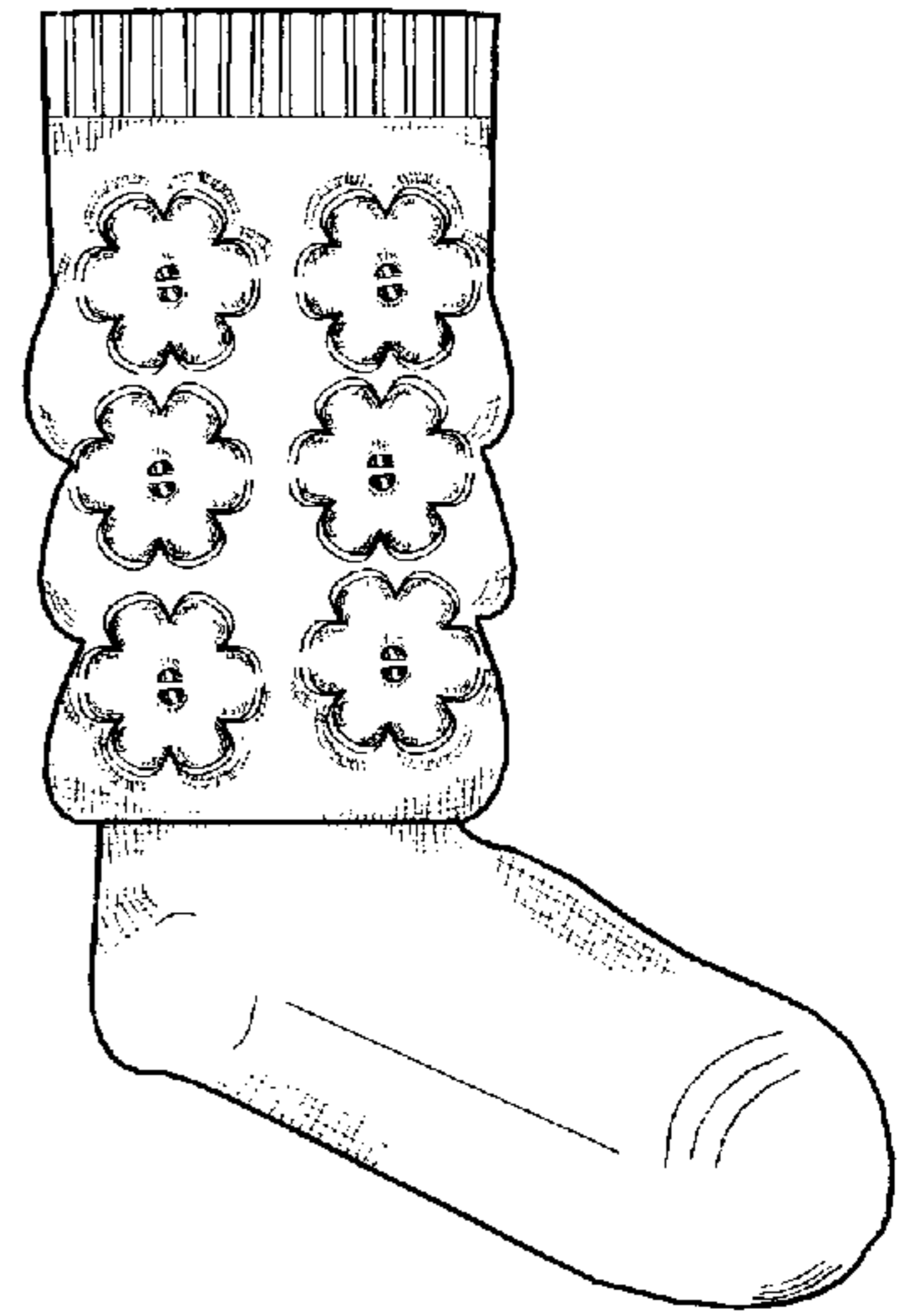

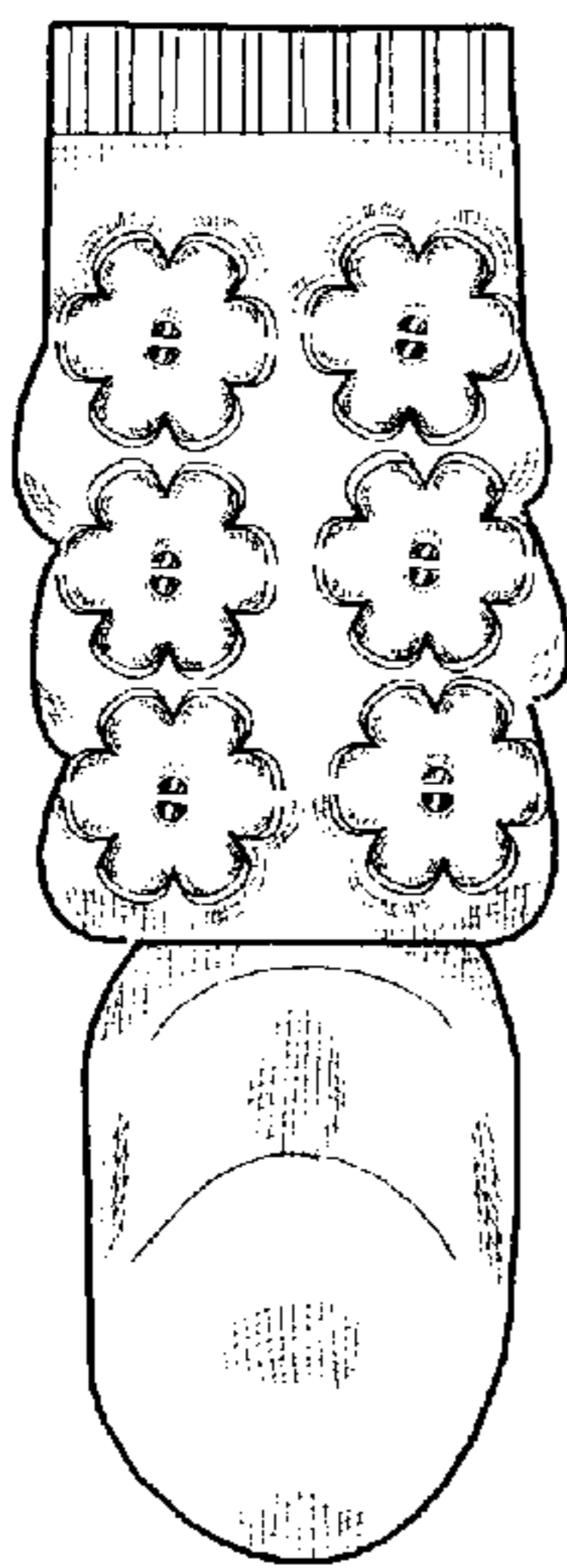

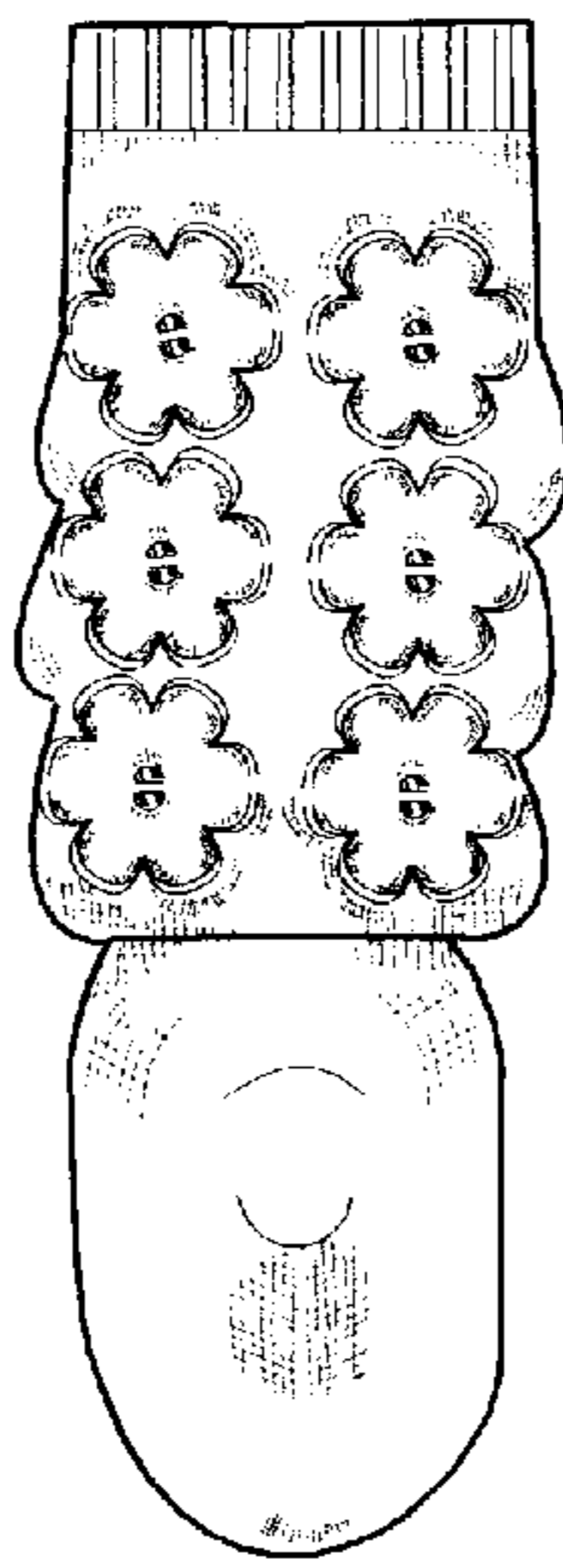

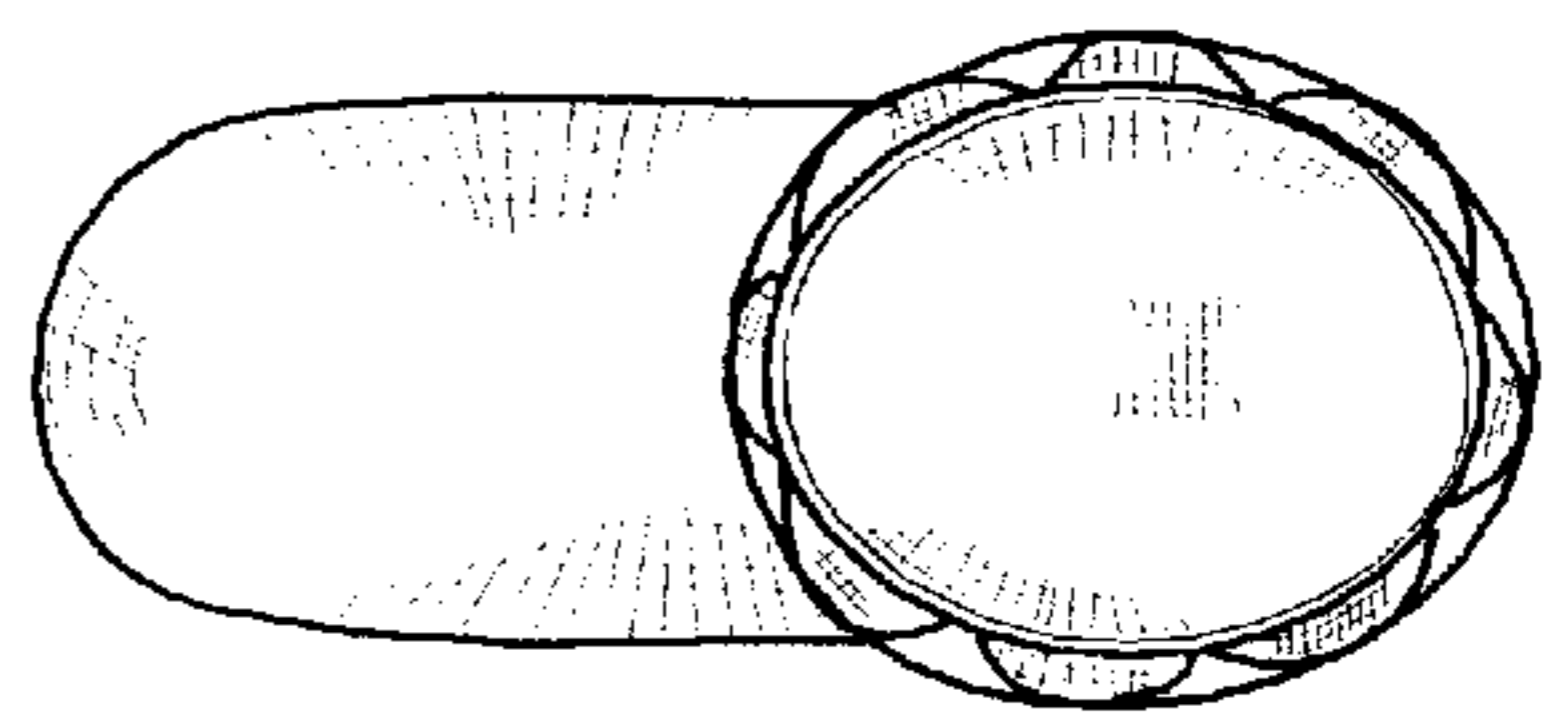
