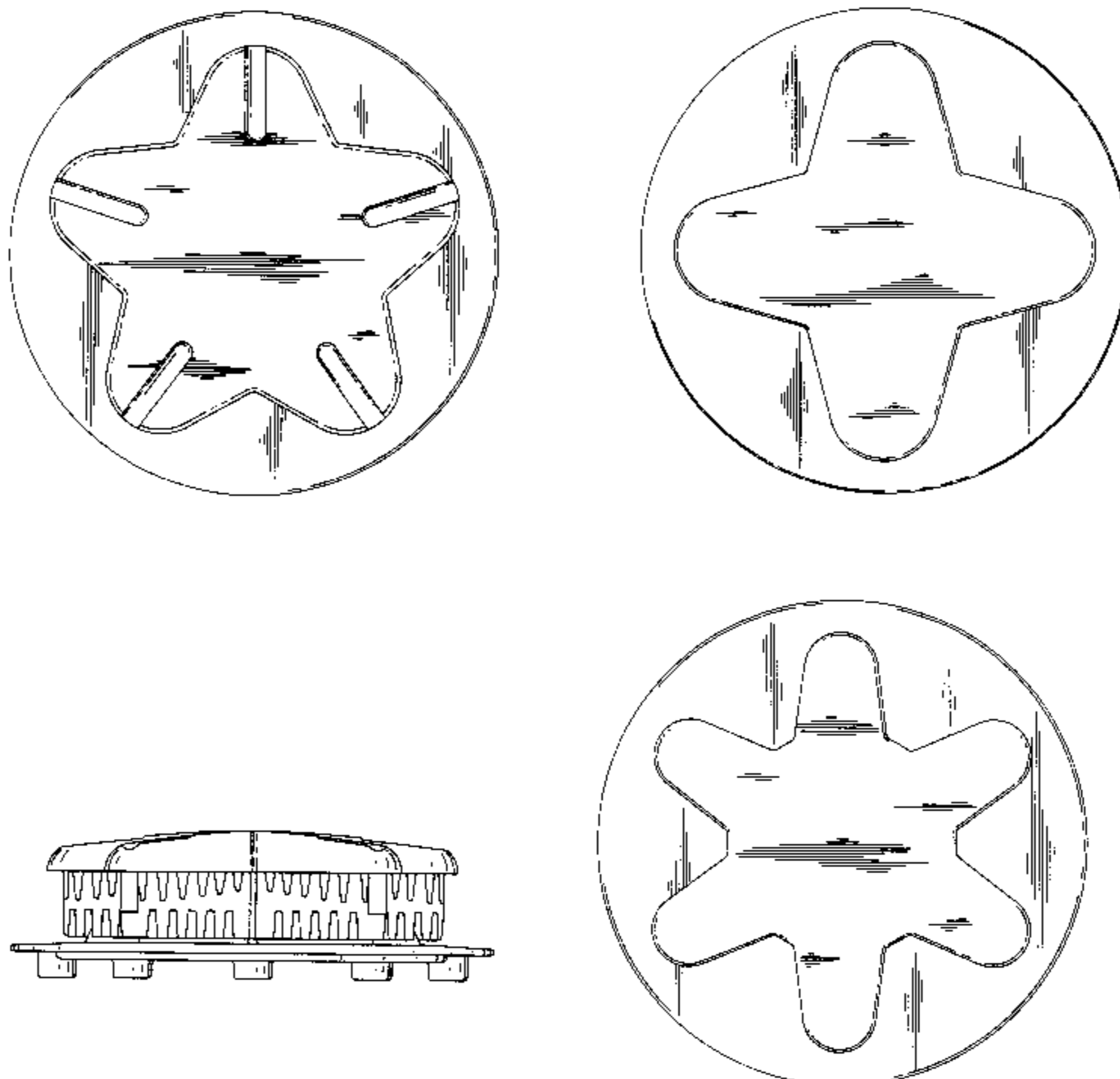
[57] **CLAIM**

The ornamental design for a stove burner, as shown.

DESCRIPTION

FIG. 1 is a top plan view of a stove burner showing my new design;
 FIG. 2 is a front elevational view of FIG. 1;
 FIG. 3 is a left side elevational view of FIG. 1;
 FIG. 4 is a right side elevational view of FIG. 1;
 FIG. 5 is a rear elevational view of FIG. 1;
 FIG. 6 is a bottom plan view of FIG. 1;
 FIG. 7 is a top plan view of a second embodiment thereof;
 FIG. 8 is a front elevational view of FIG. 7;
 FIG. 9 is a left side elevational view of FIG. 7;
 FIG. 10 is a bottom plan view of FIG. 7;
 FIG. 11 is a top plan view of a third embodiment thereof;
 FIG. 12 is a front elevational view of FIG. 11;
 FIG. 13 is a side elevational view of FIG. 11; and,
 FIG. 14 is a bottom plan view of FIG. 11.

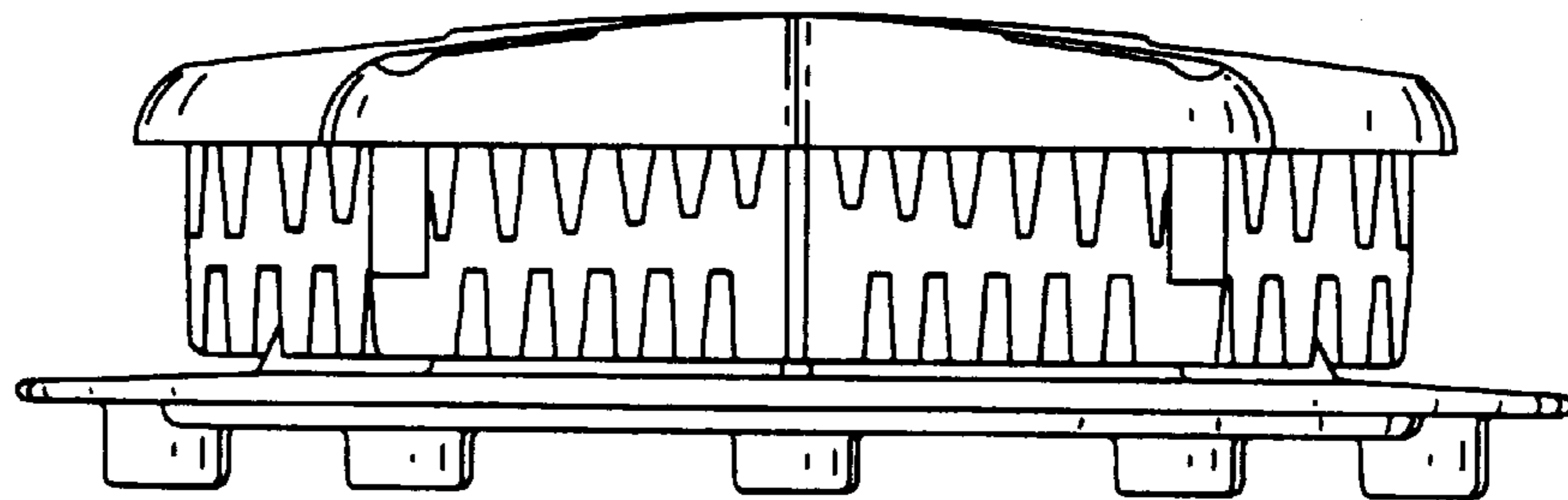
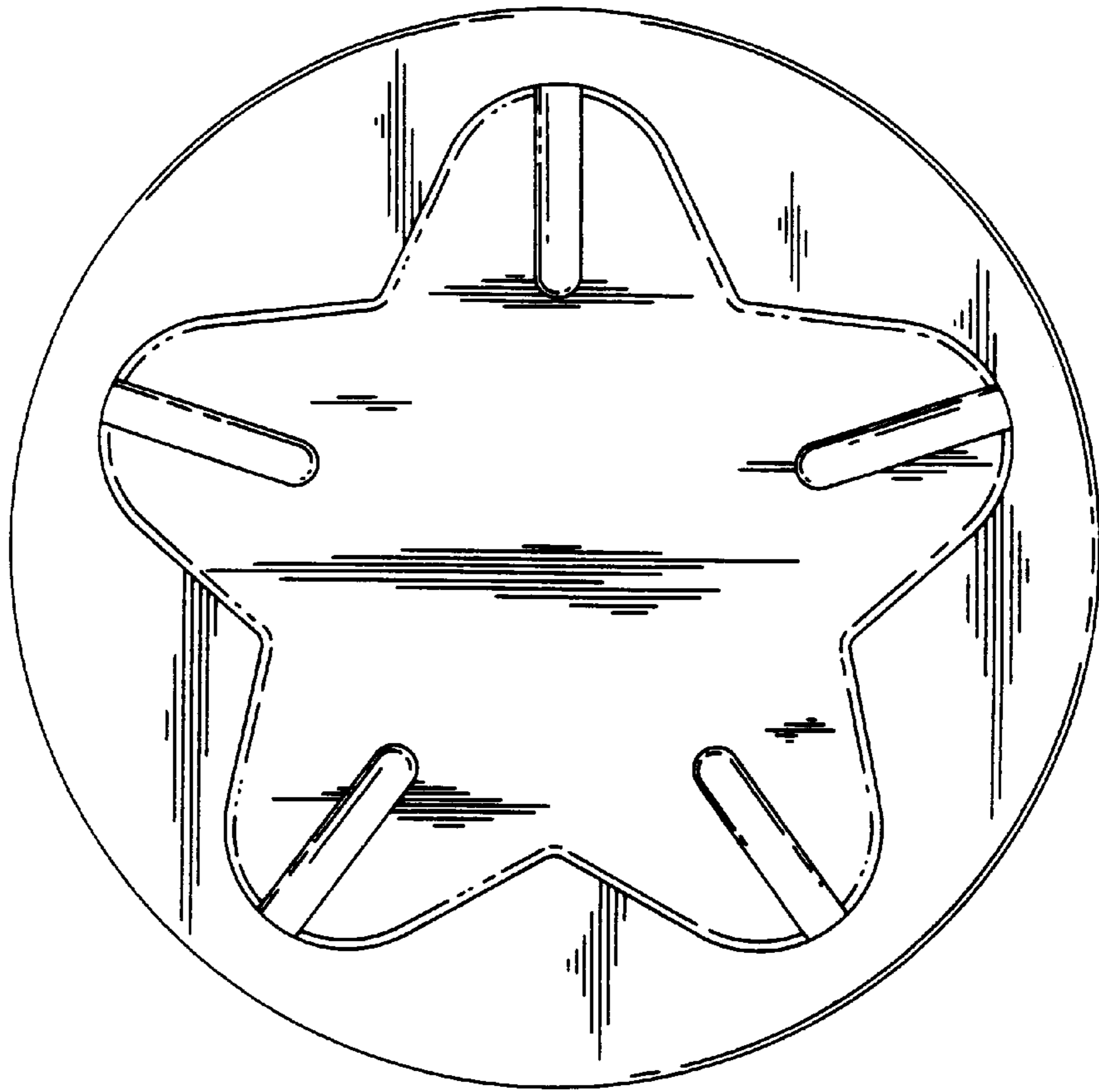

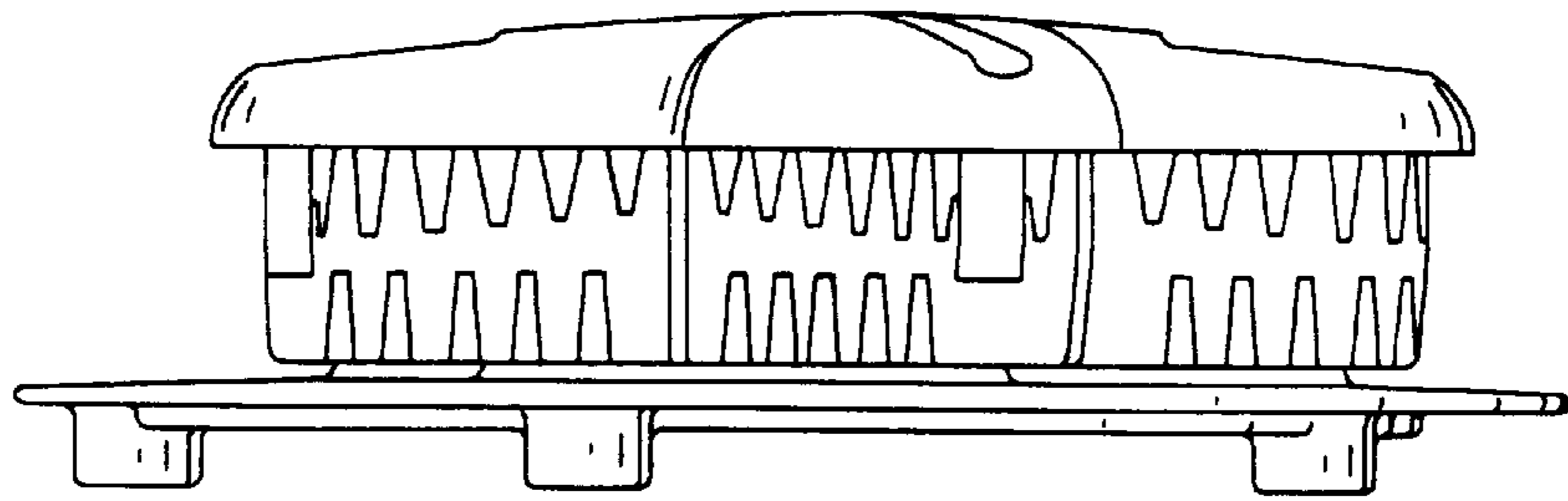

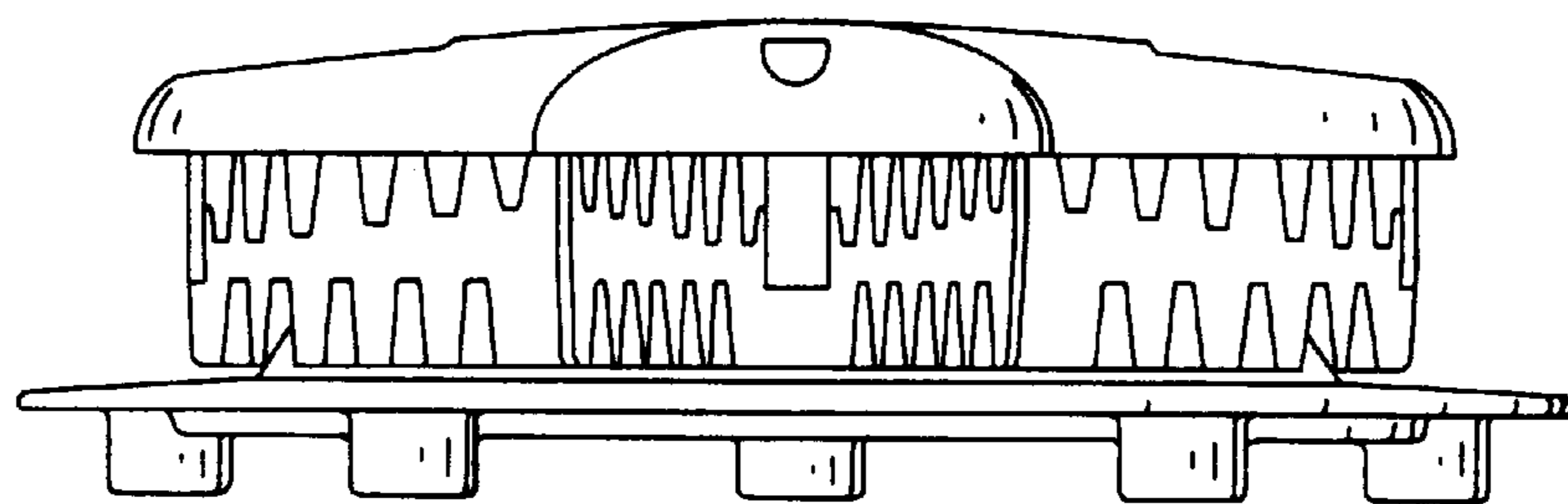
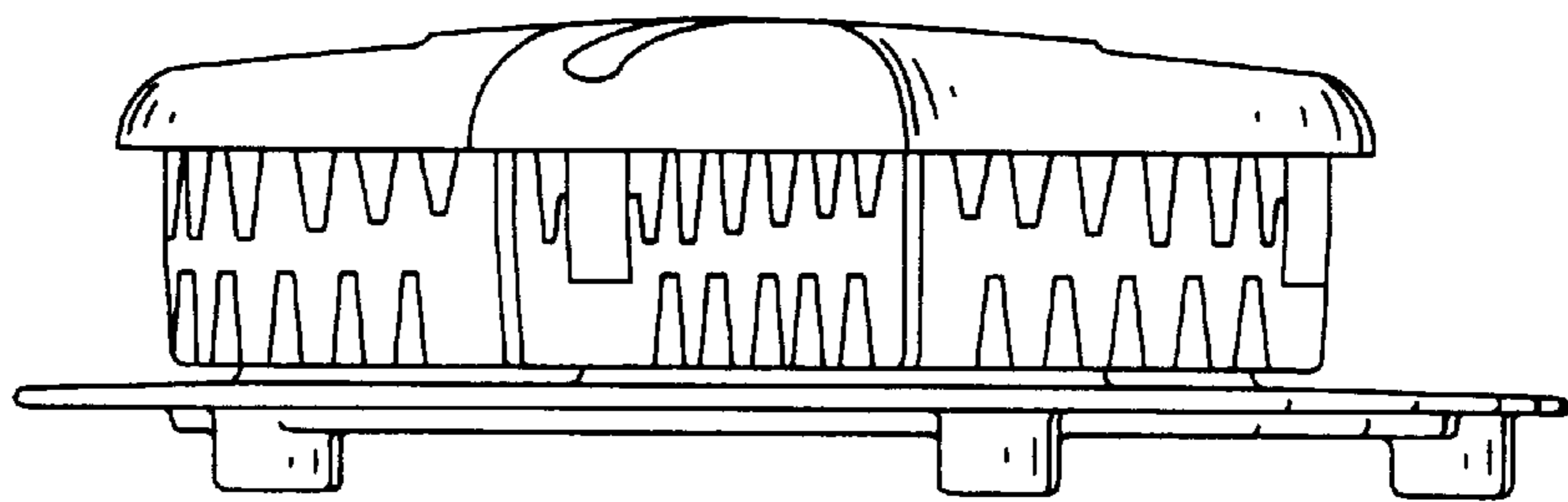

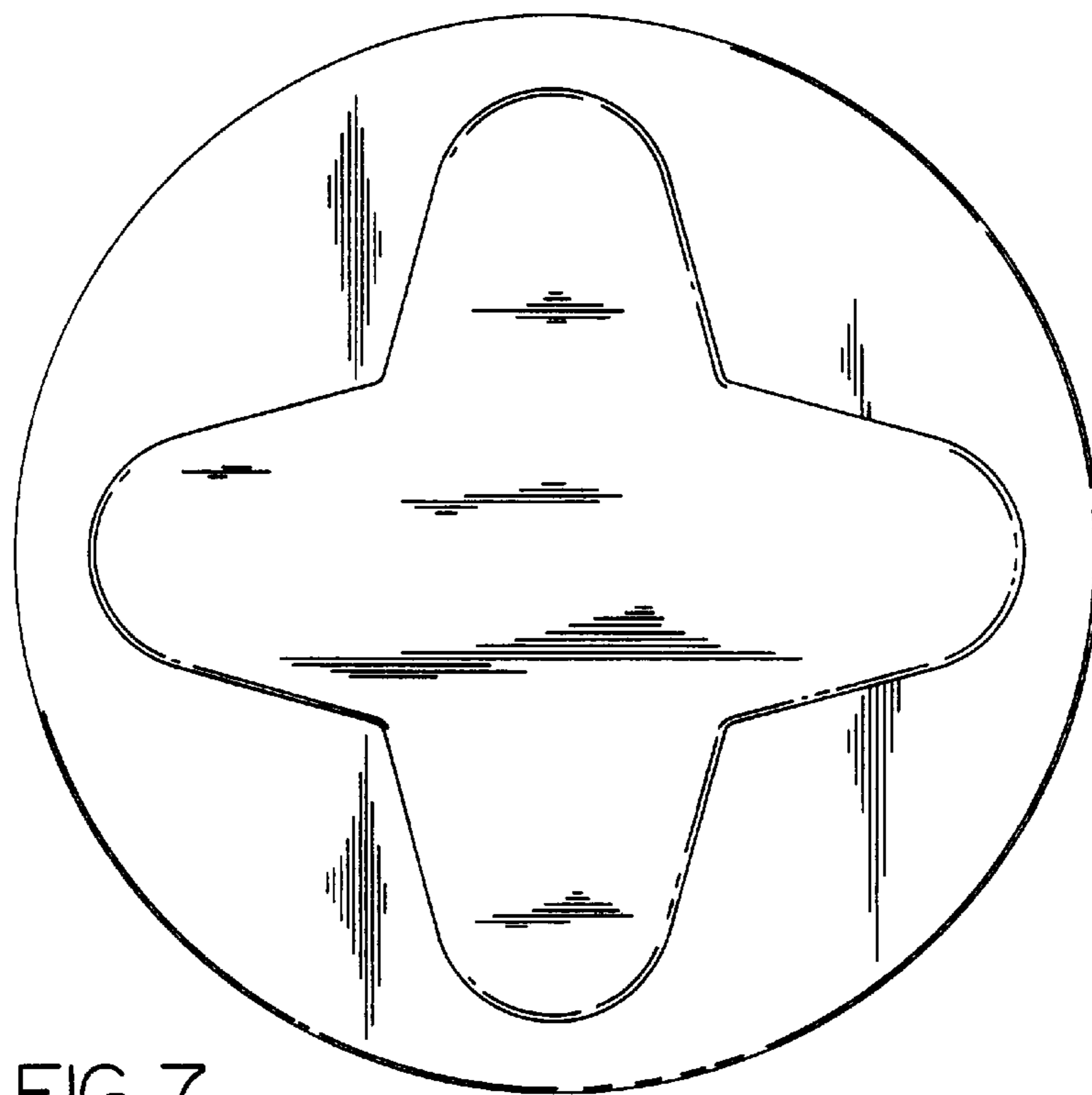
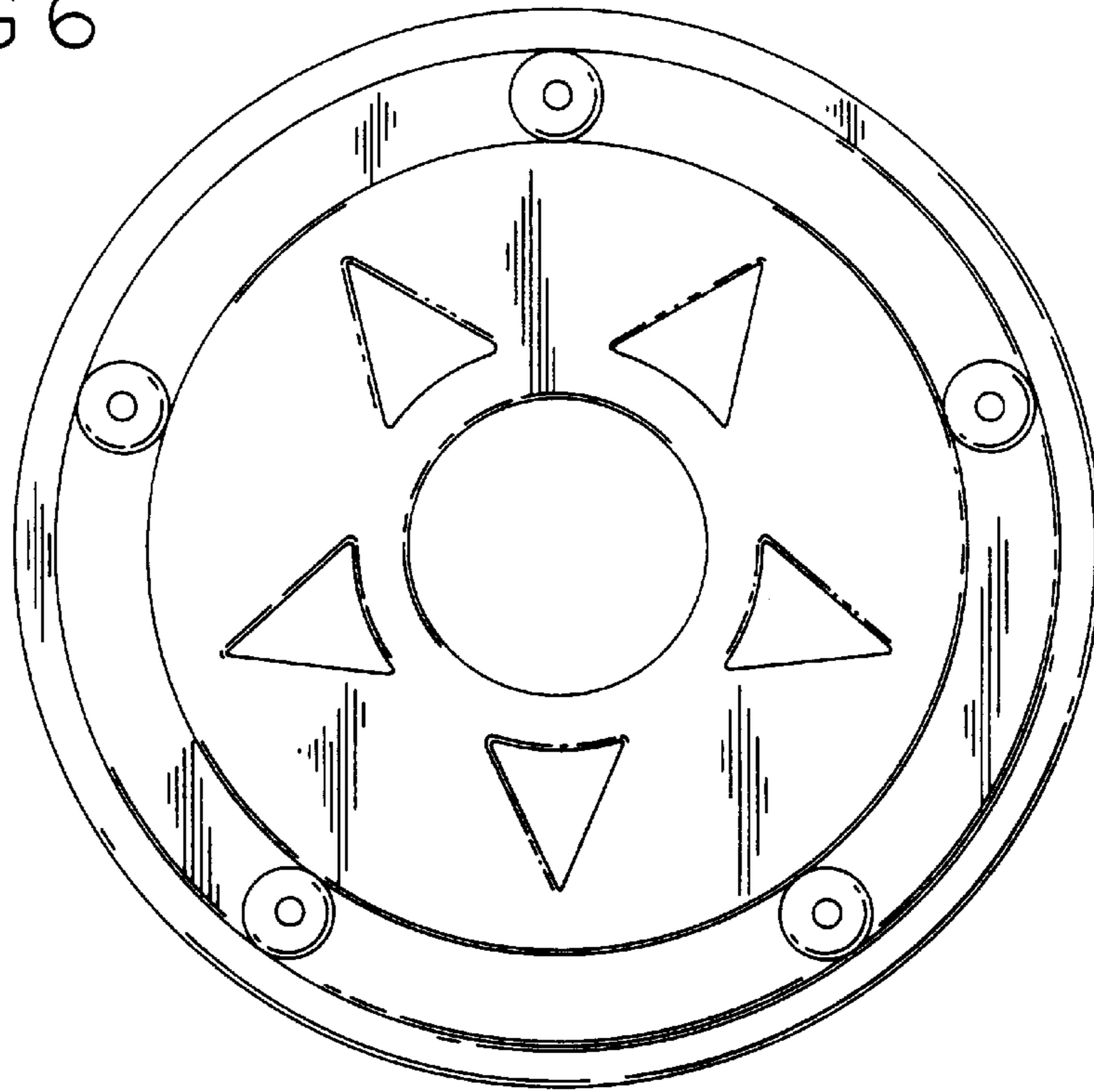

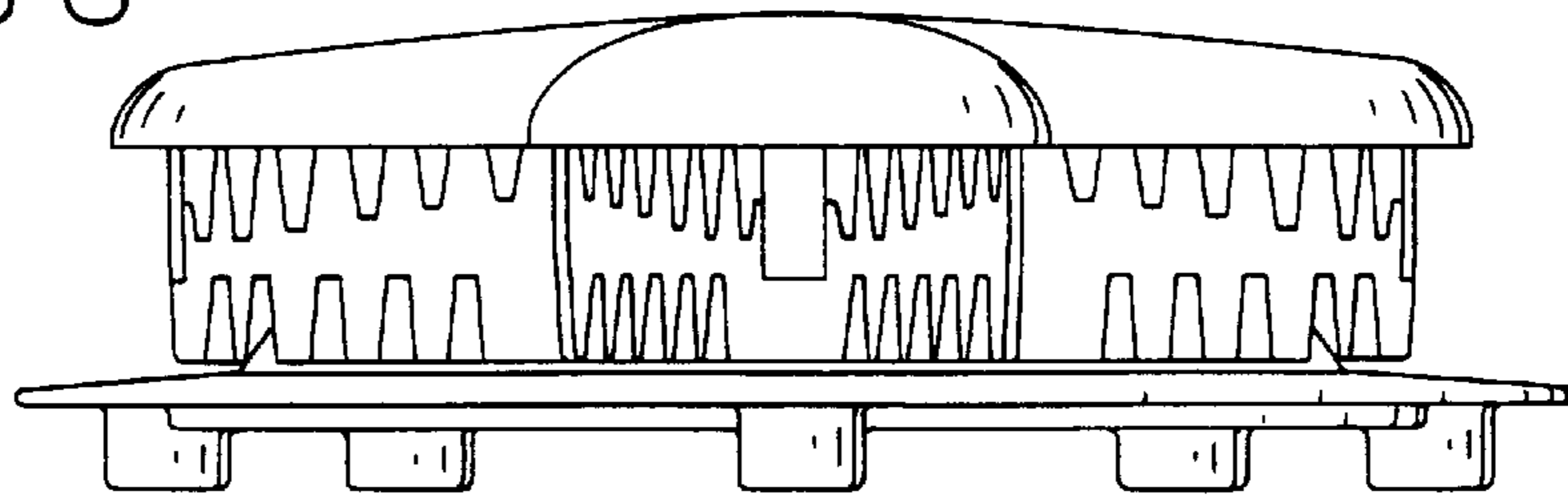

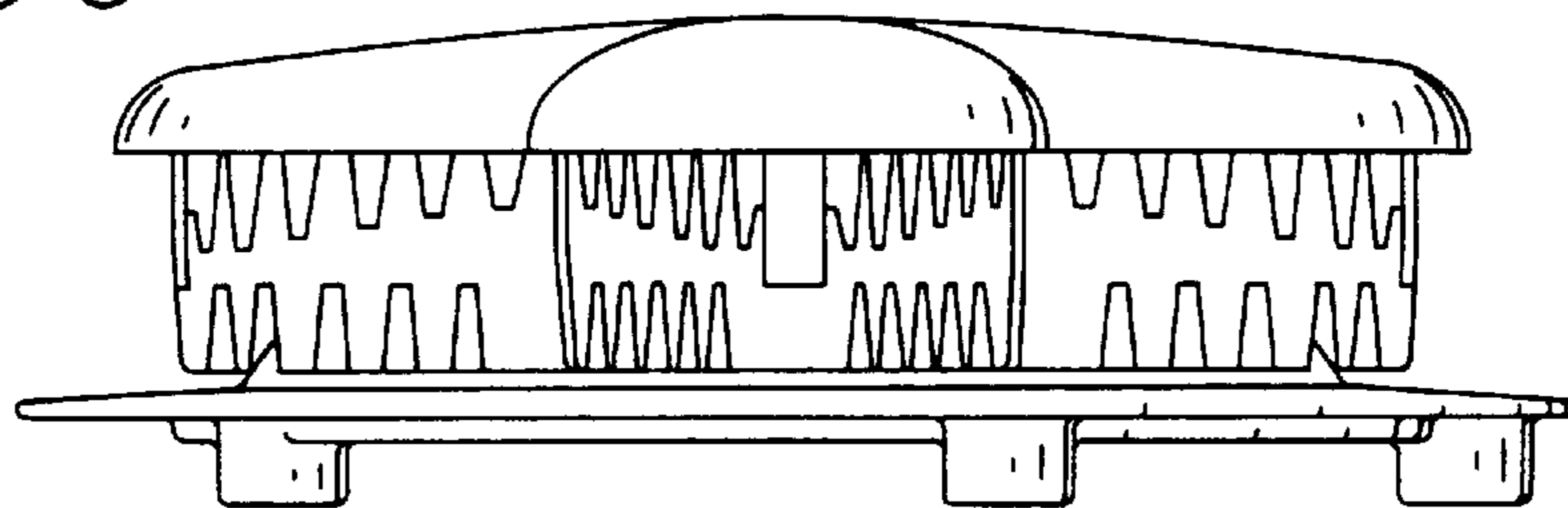

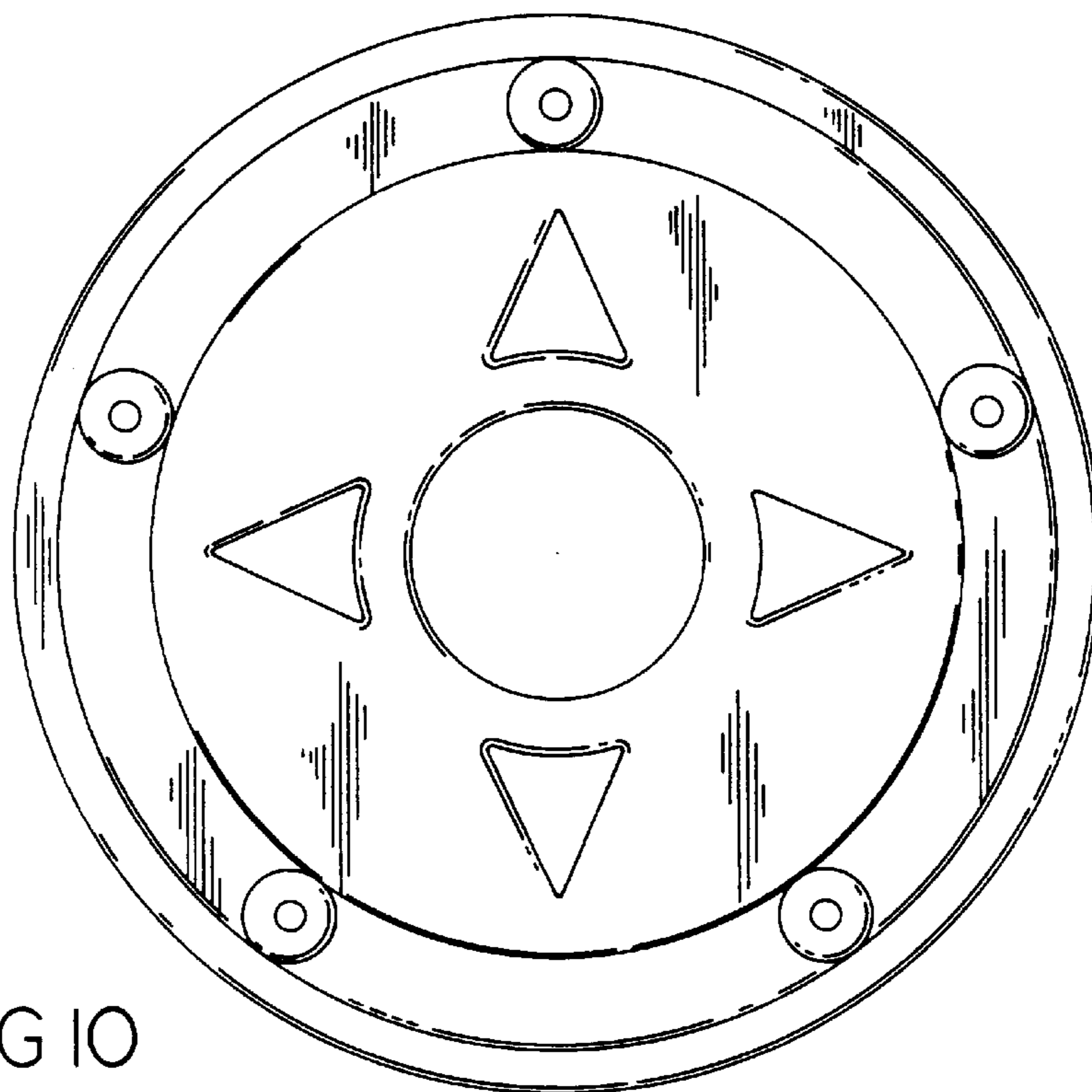

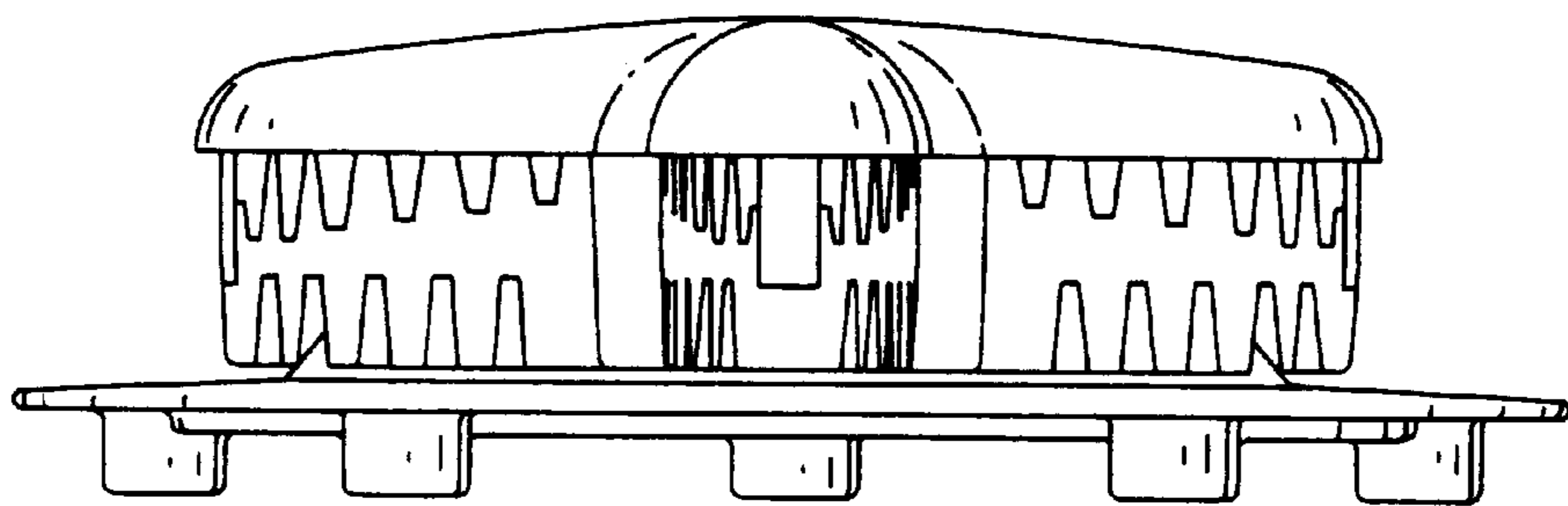
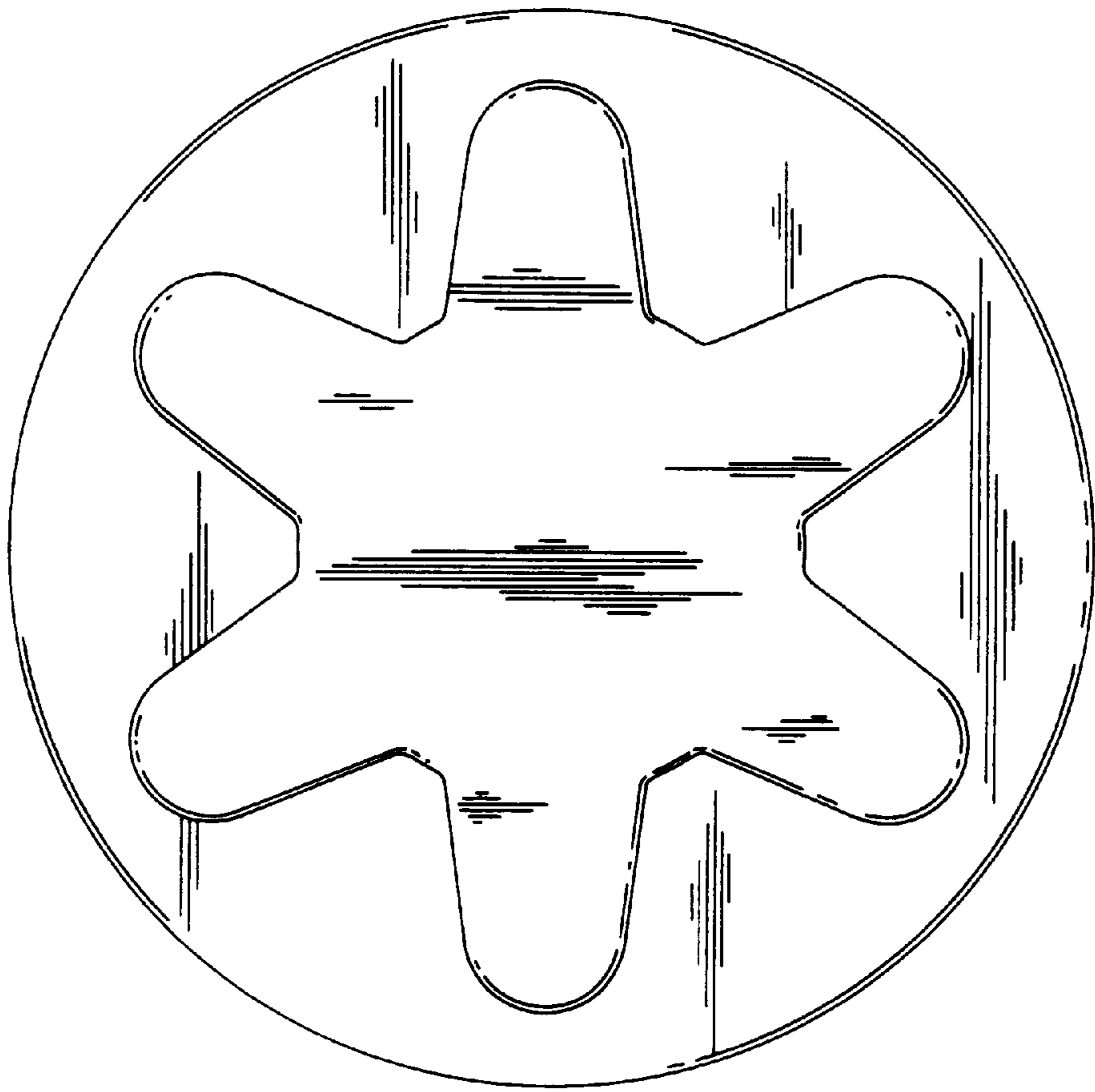

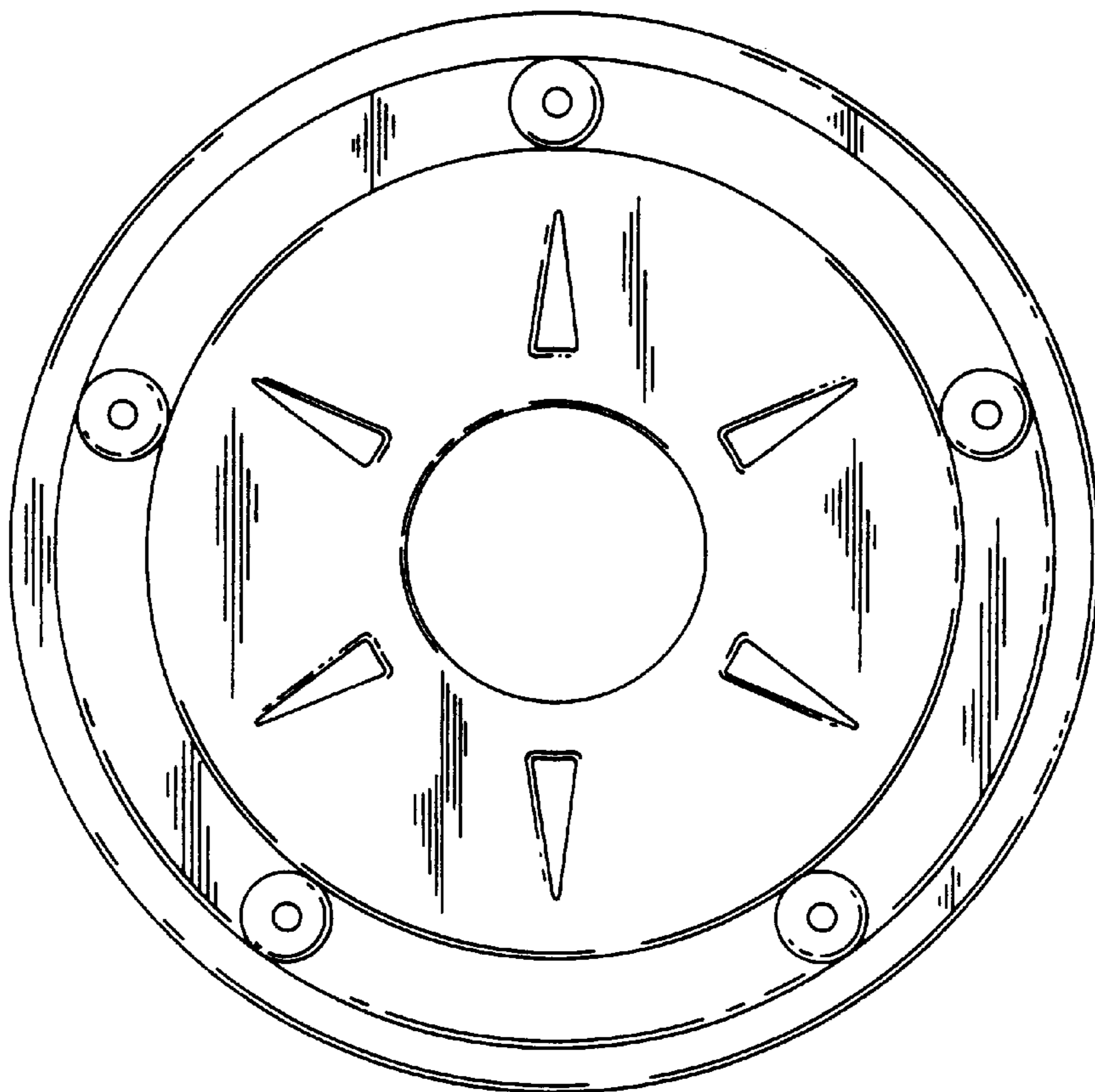
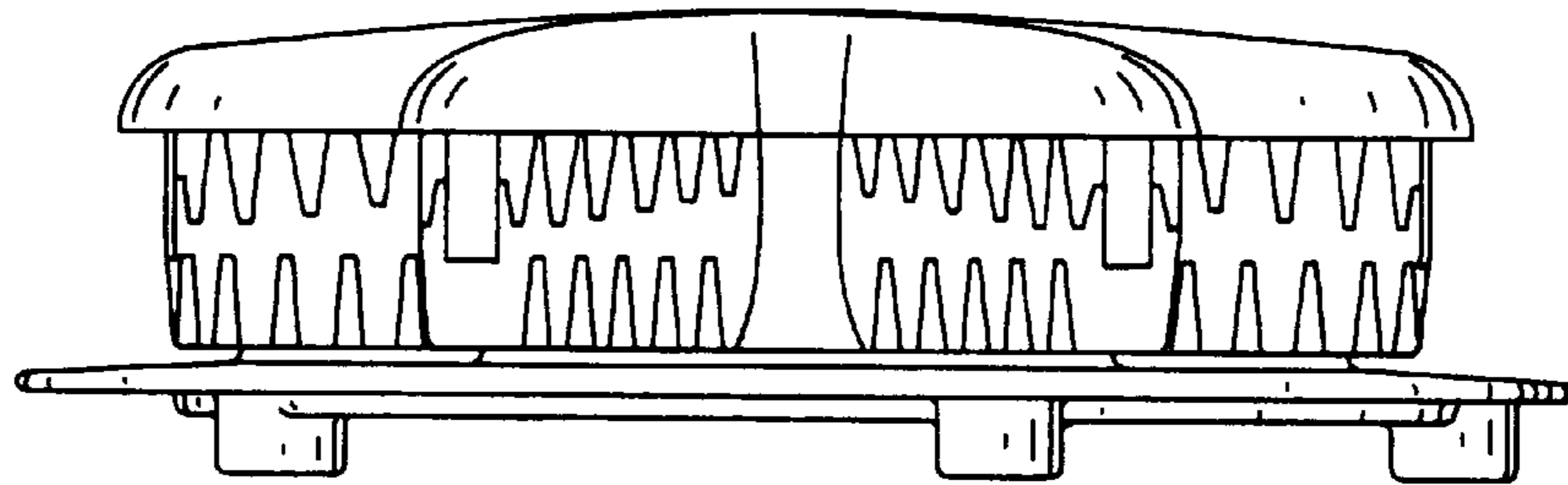
