[57] **CLAIM**

The ornamental design for a “container,” as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a container.  
FIG. 2 is a side elevational view of the container of FIG. 1, it being understood that the opposite side is a mirror image thereof.  
FIG. 3 is a plan view of the container of FIG. 1.  
FIG. 4 is a front elevational view of the container of FIG. 1; and,  
FIG. 5 is a rear elevational view of the container of FIG. 1. The neck shown at the top in broken lines is for illustrative purposes only and forms no part of the claimed design.

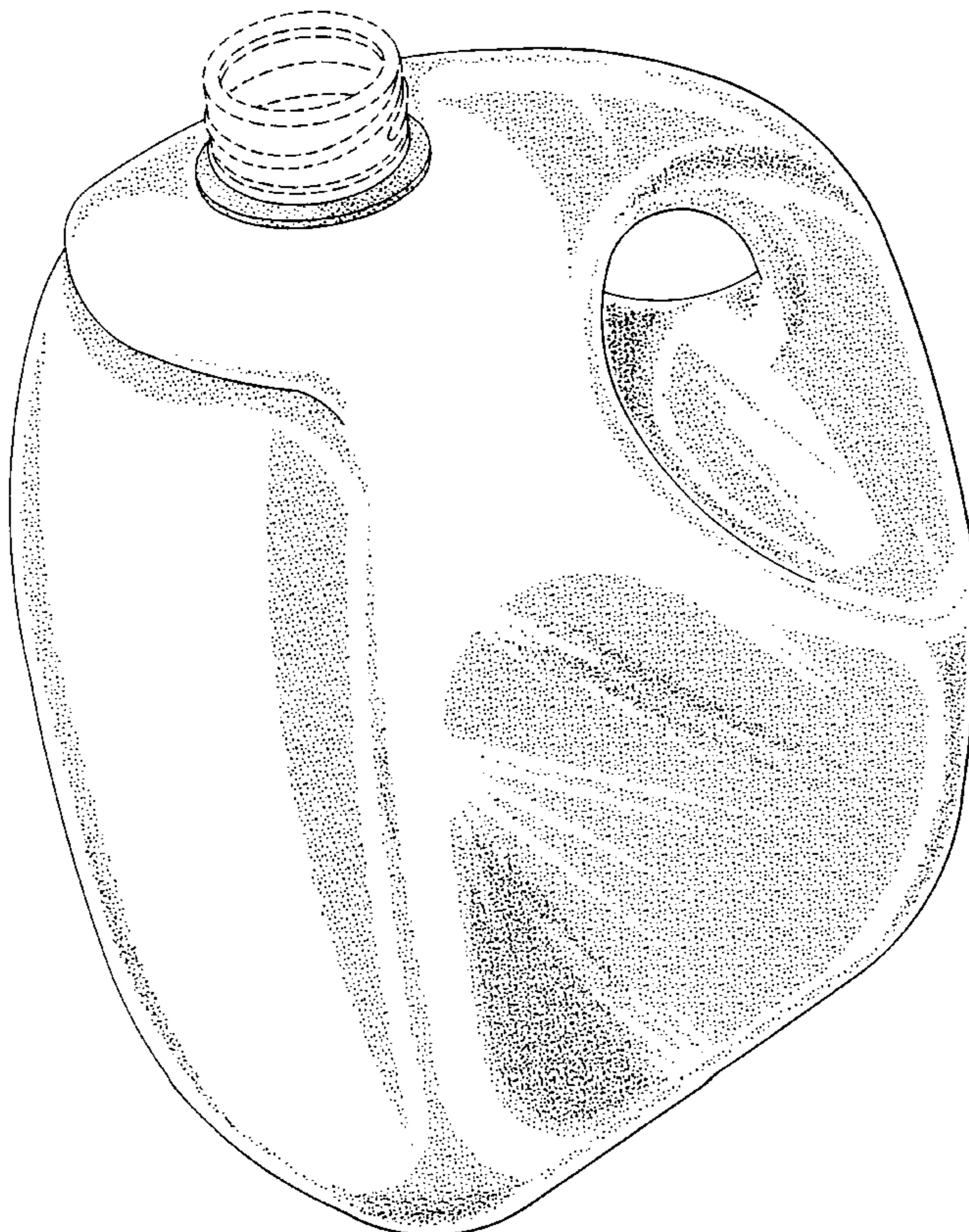
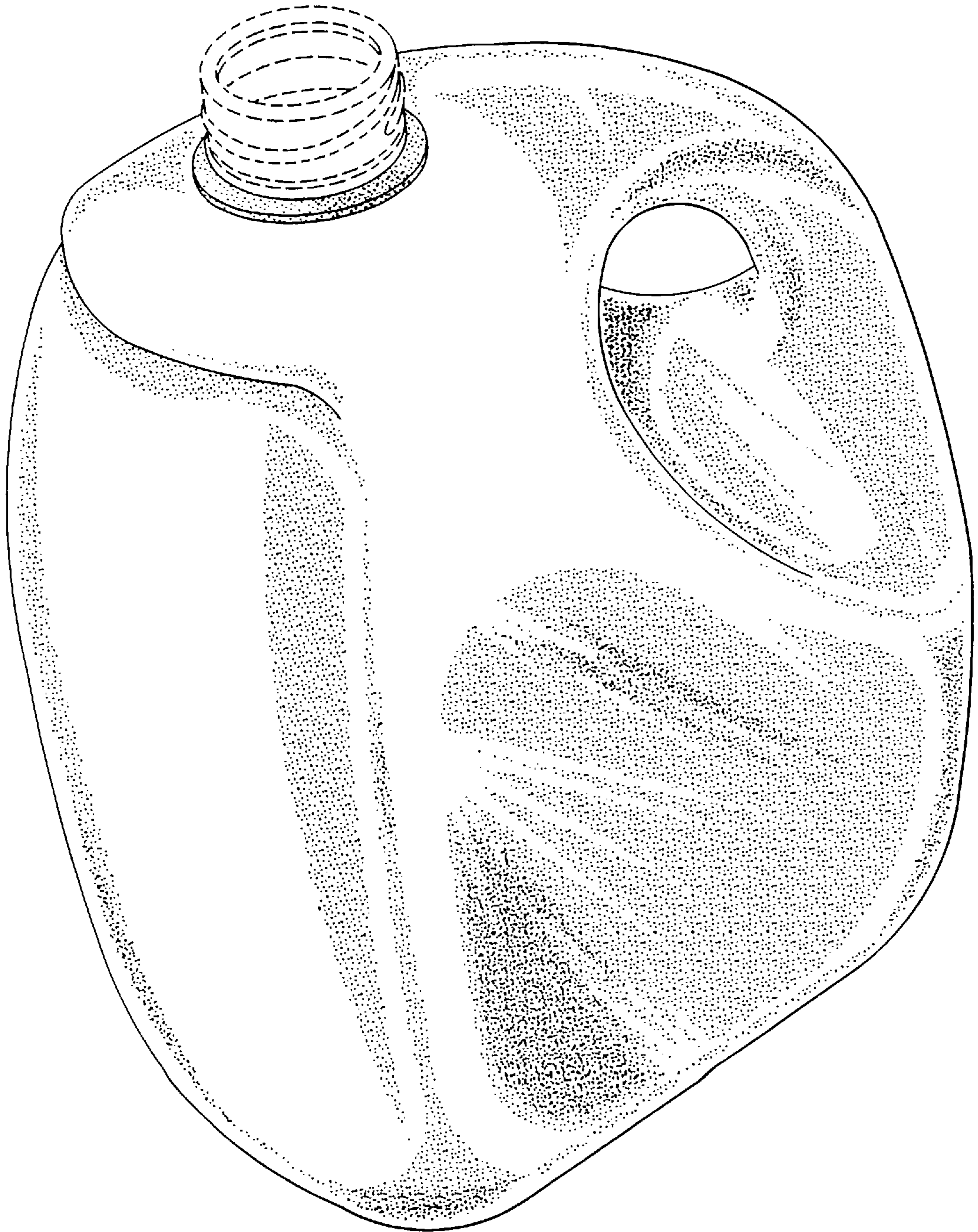

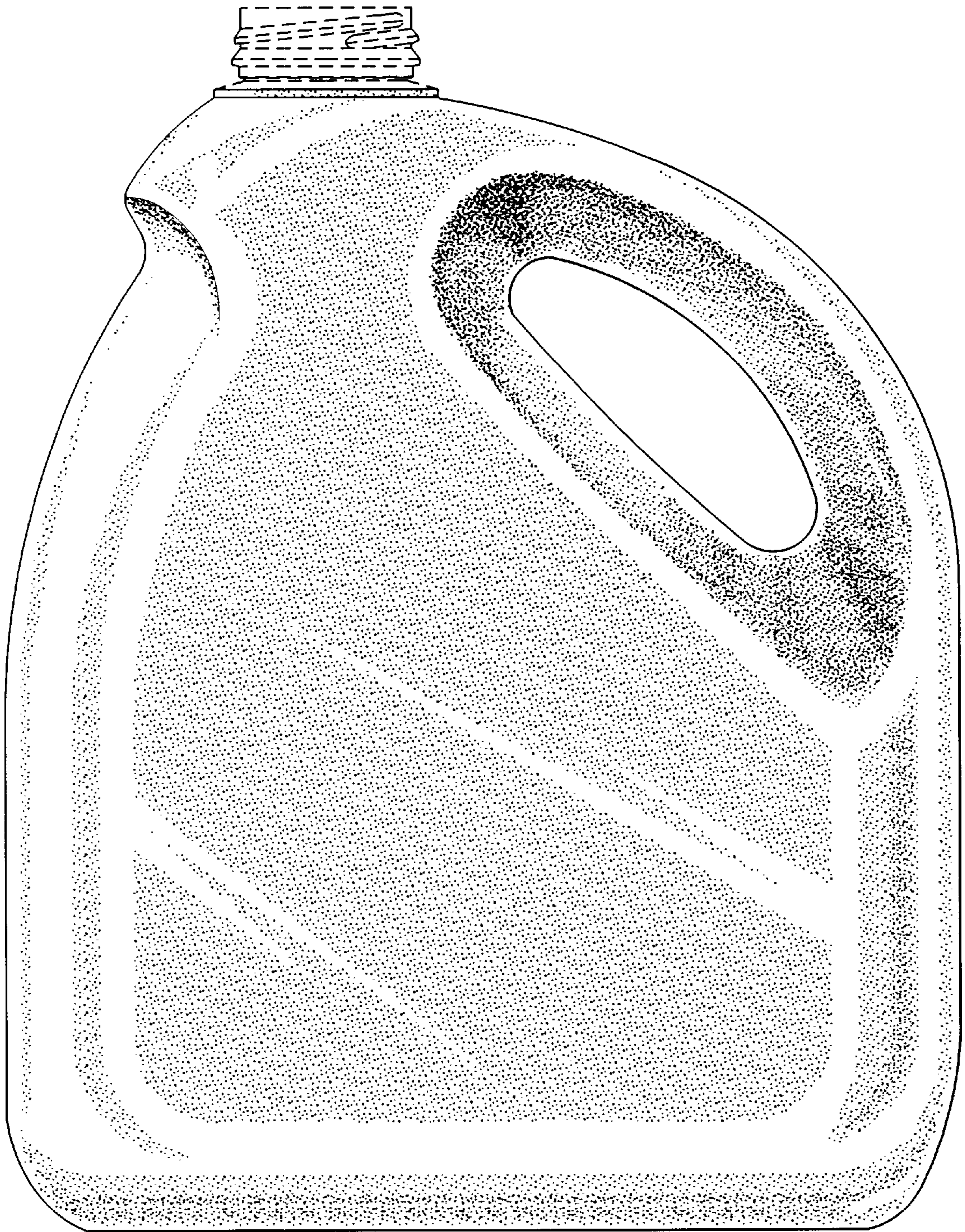

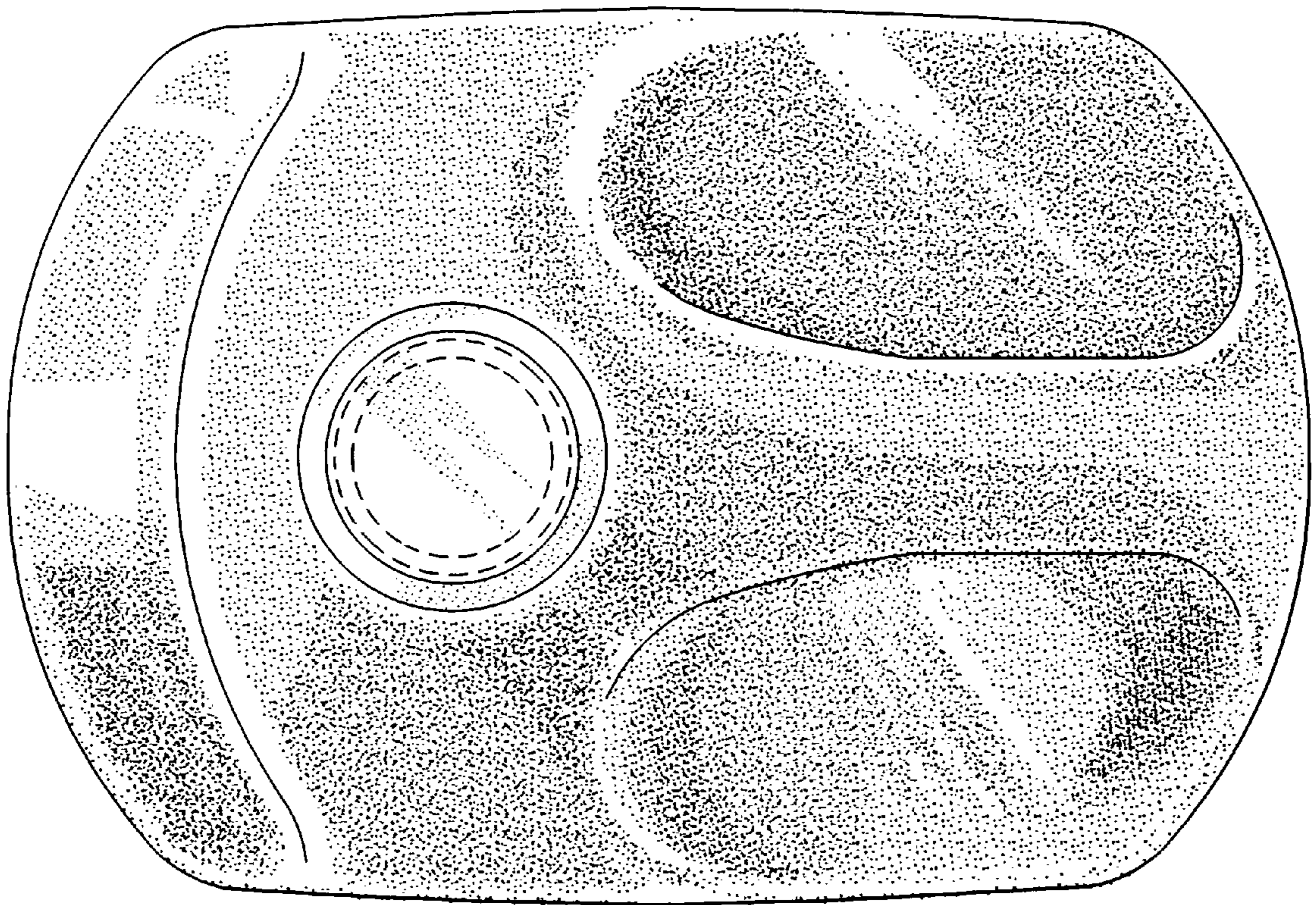

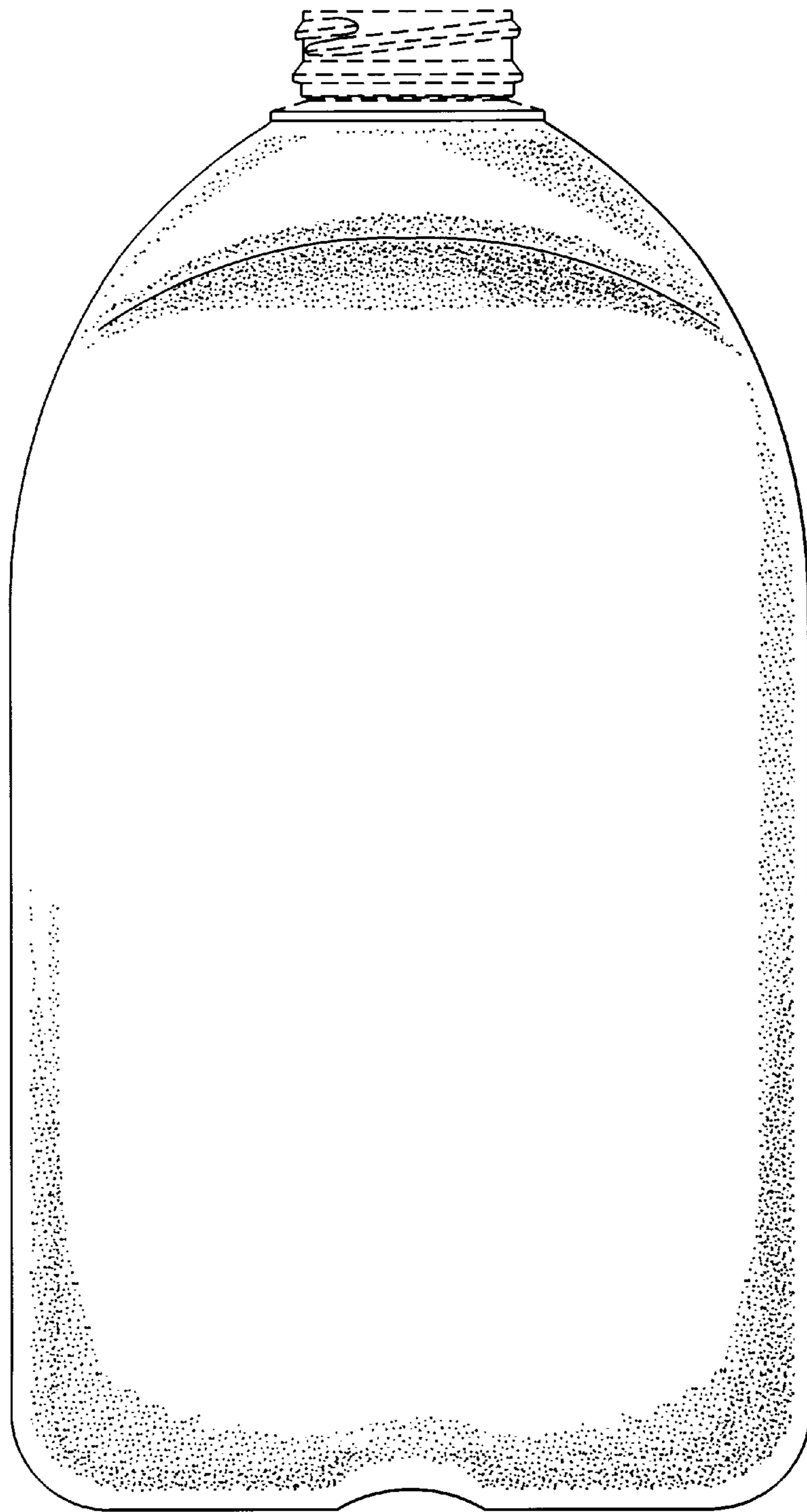
