The ornamental design for a automobile body, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view illustrating a first embodiment of an automobile body constructed in accordance with the teachings of the present invention.

FIG. 2 is a rear perspective view thereof.

FIG. 3 is a left view thereof, the opposite side being a substantial mirror image.

FIG. 4 is a front view thereof.

FIG. 5 is a rear view thereof.

FIG. 6 is a front perspective view illustrating a second embodiment of an automobile body constructed in accordance with the teachings of the present invention.

FIG. 7 is a rear perspective view of FIG. 6.

FIG. 8 is a left view of FIG. 6, the opposite side being a substantial mirror image.

FIG. 9 is a front view of FIG. 6; and.

FIG. 10 is a rear view of FIG. 6.

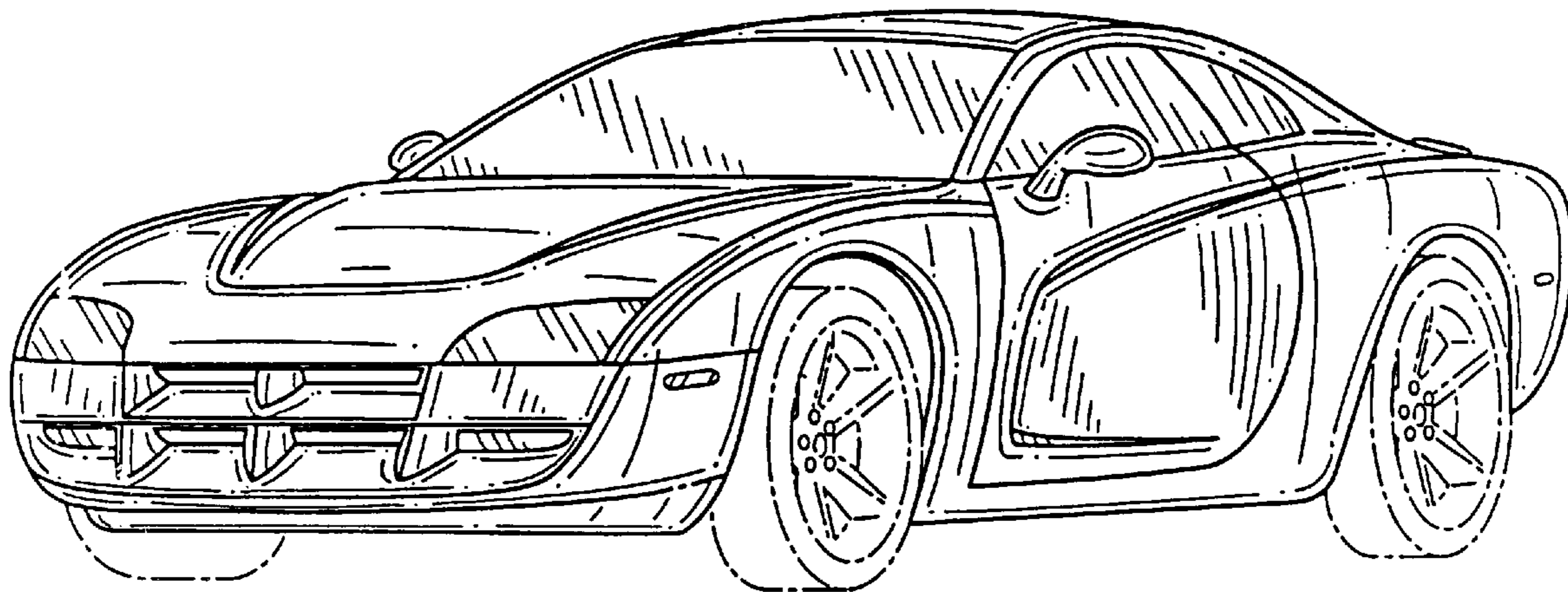

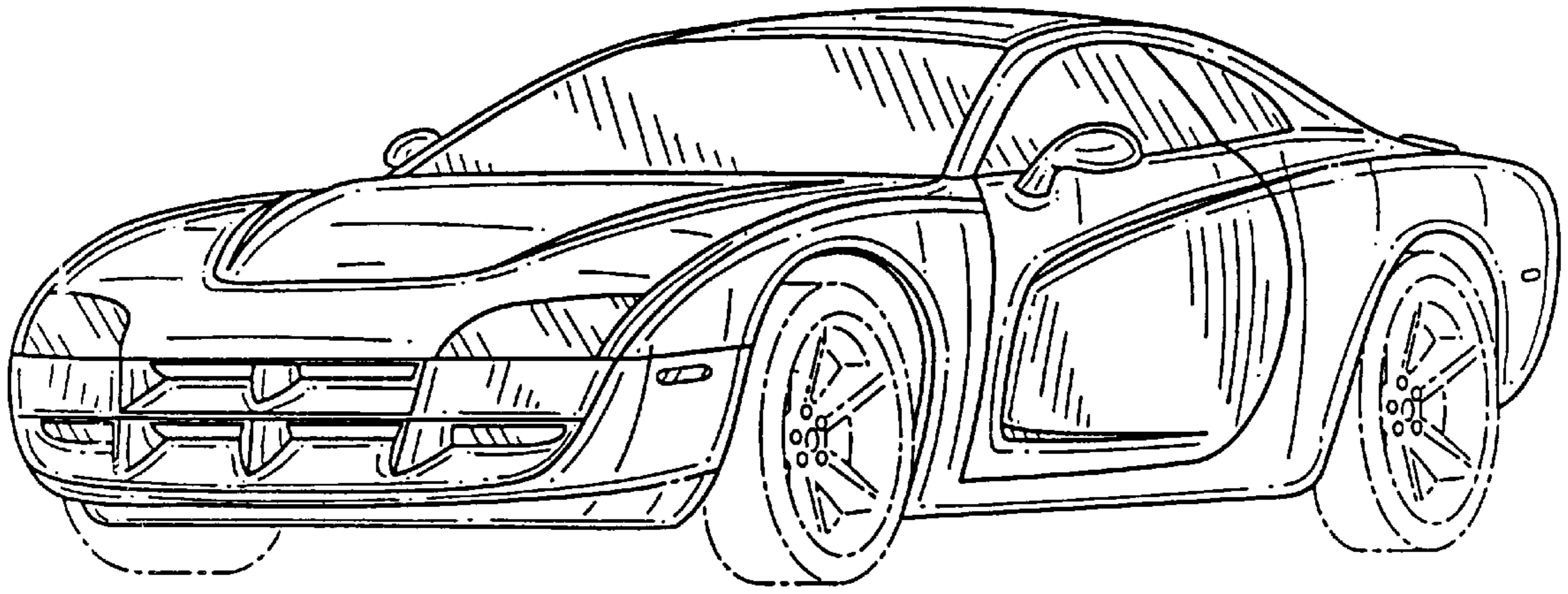
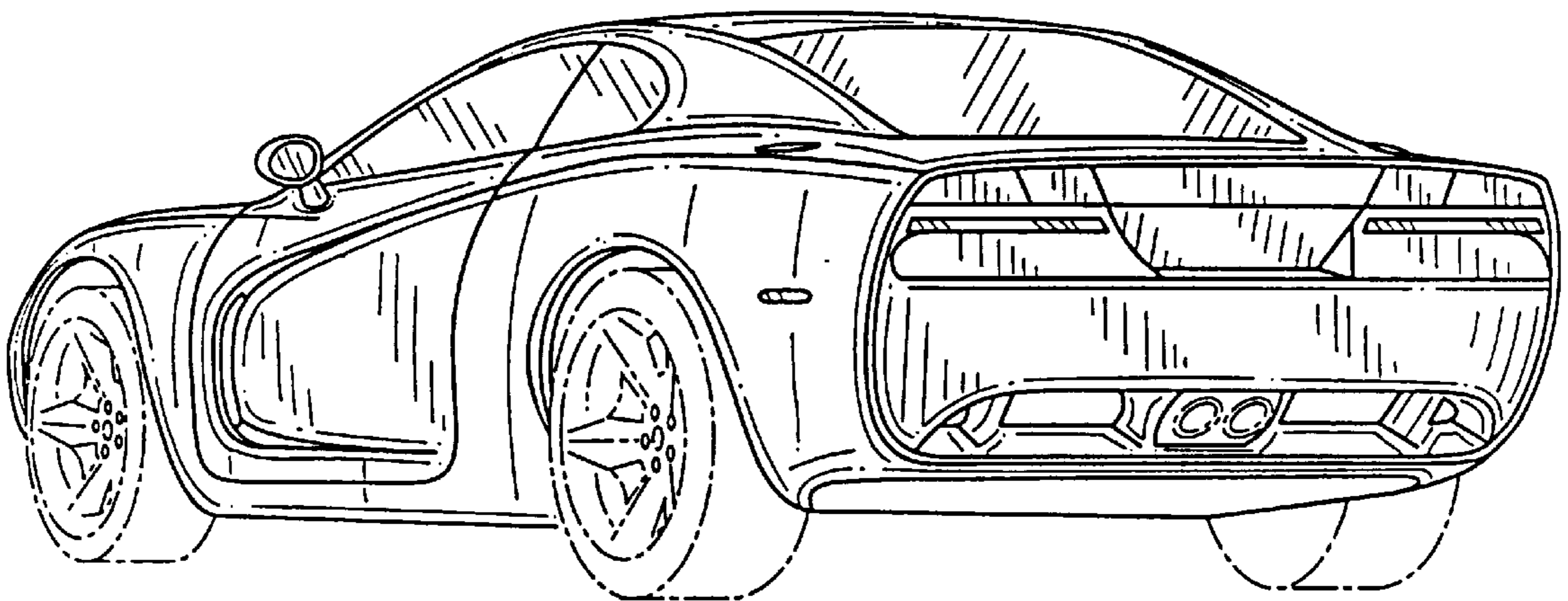

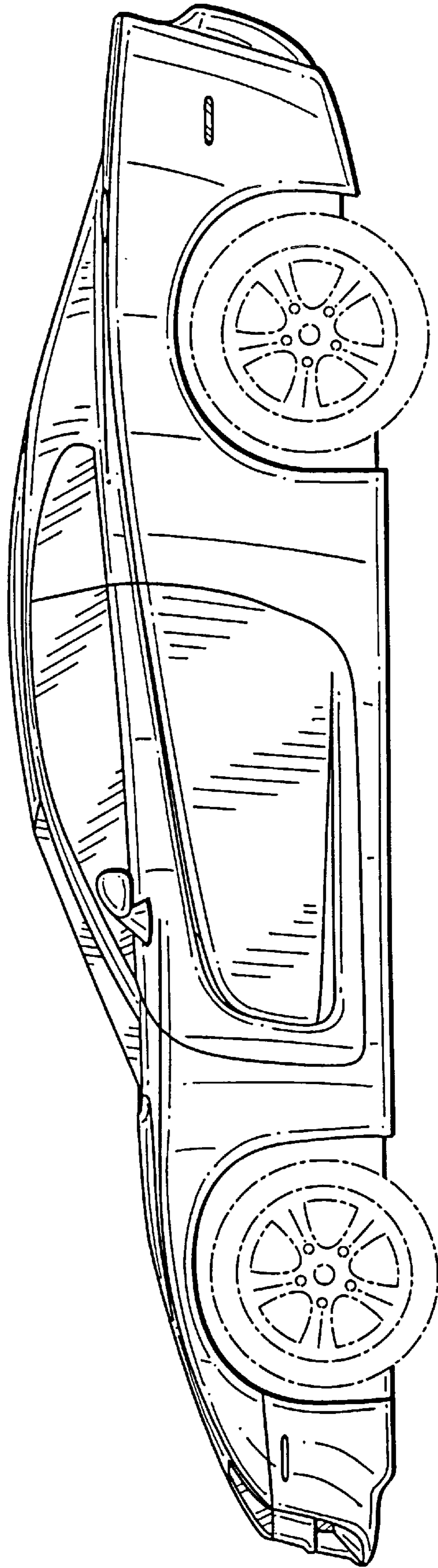

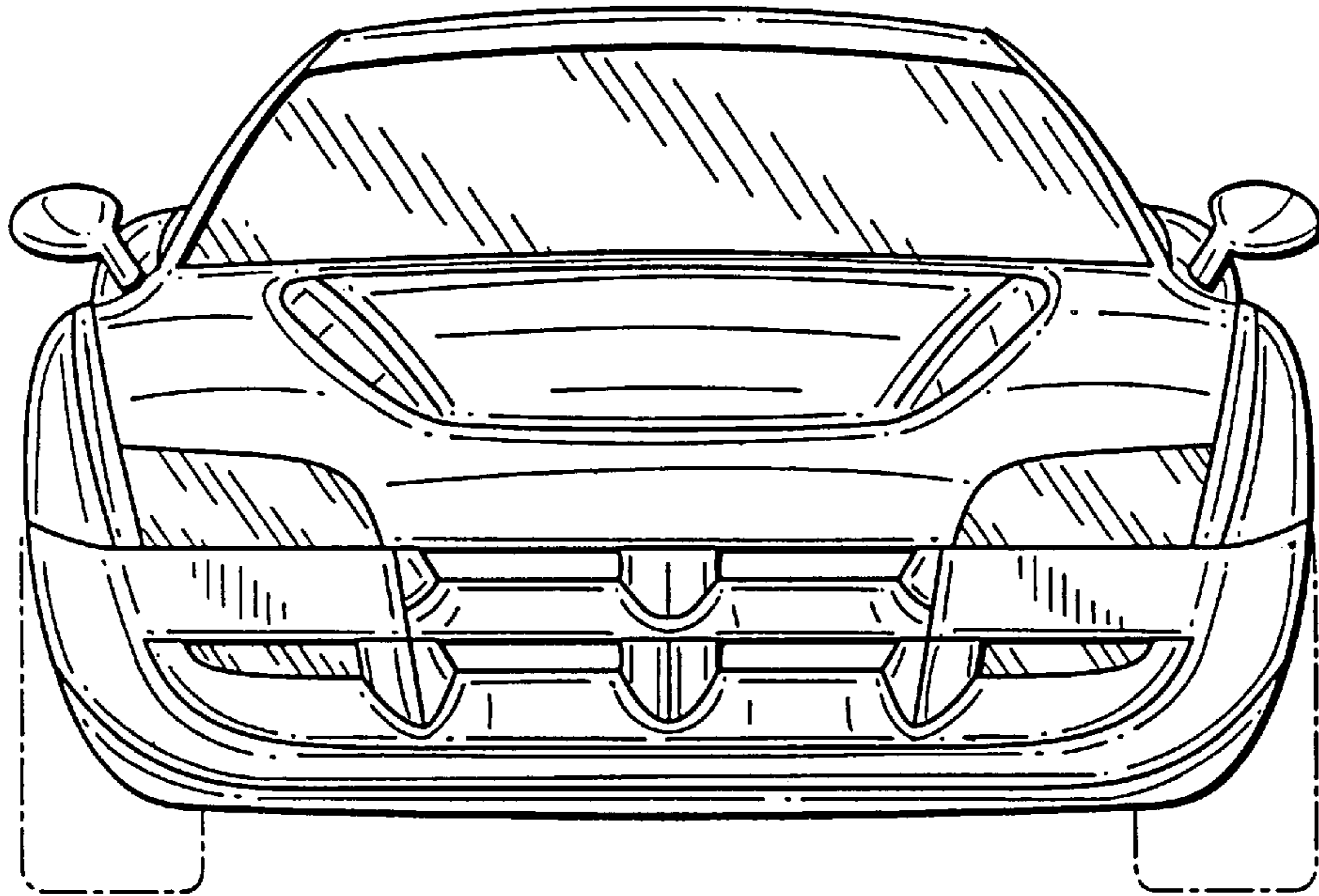

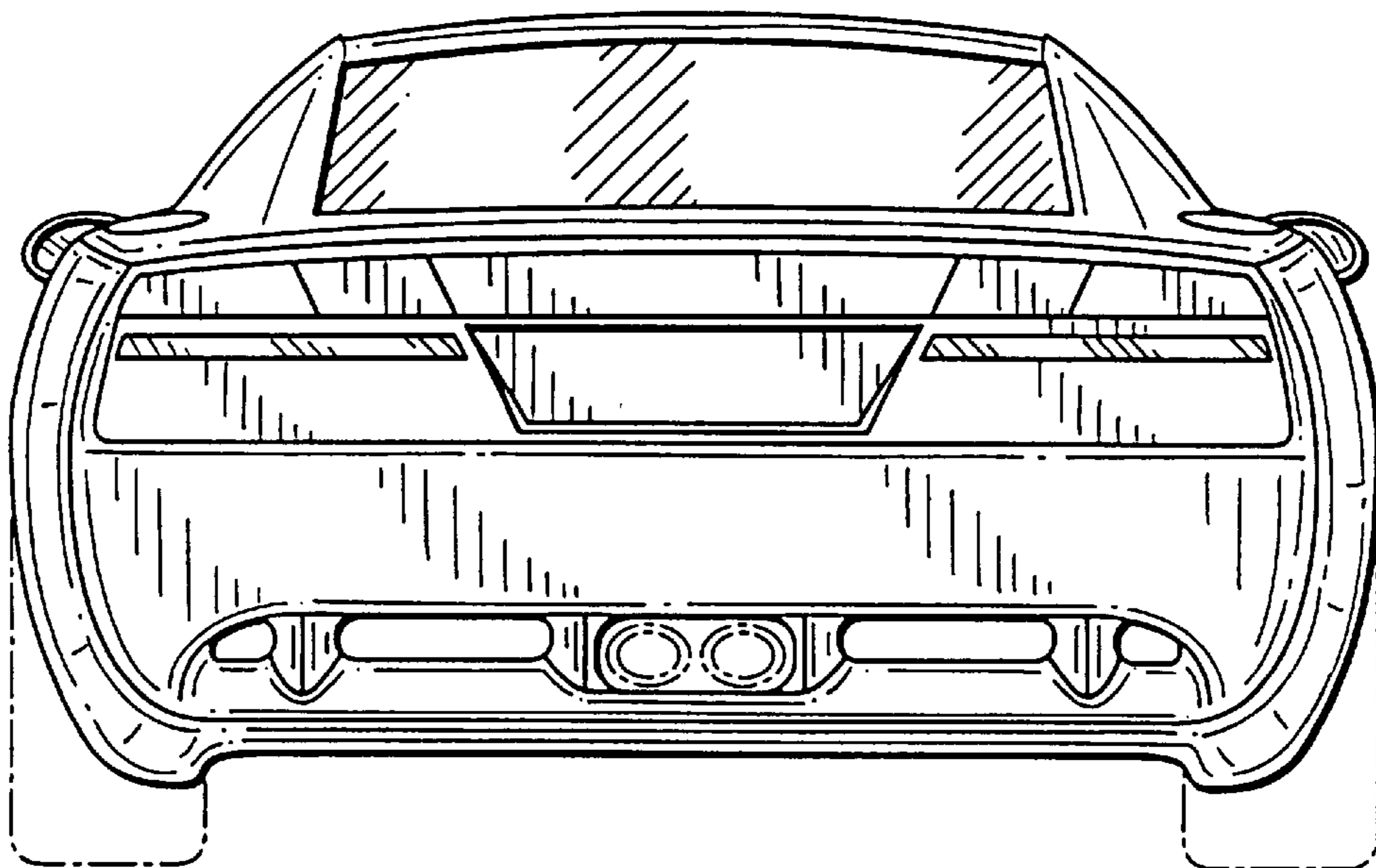

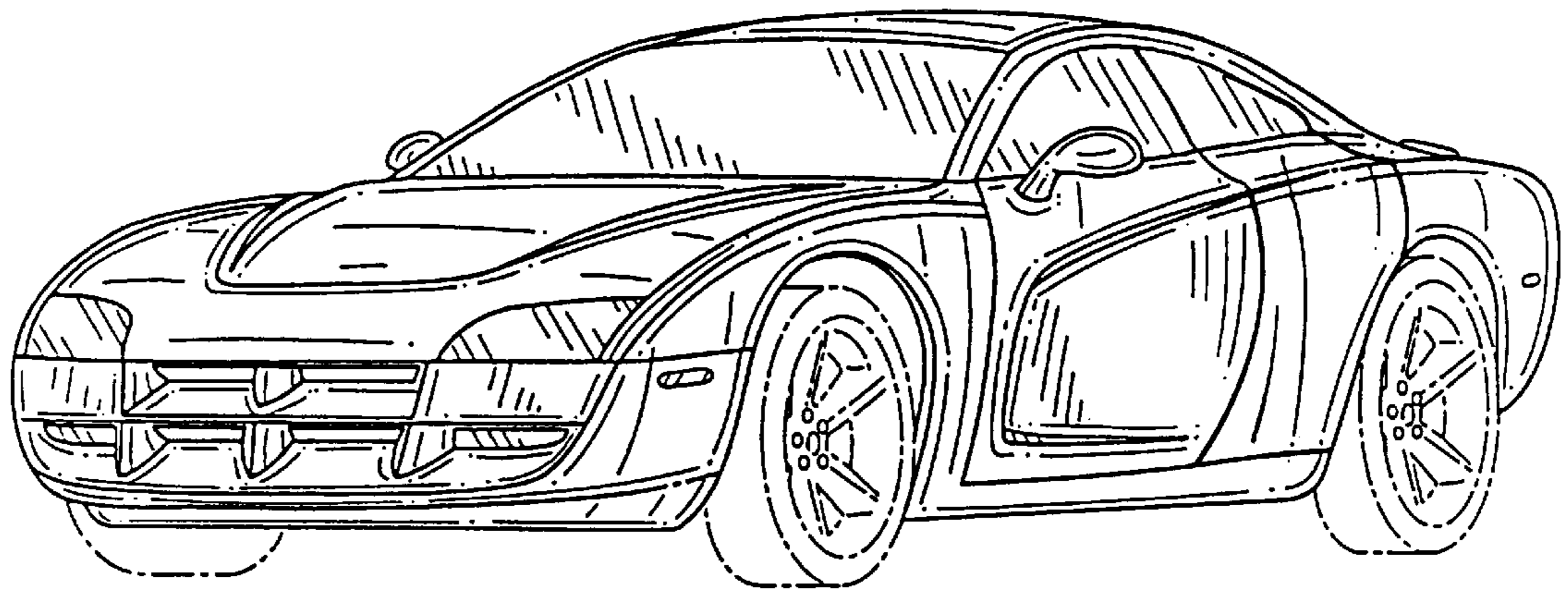
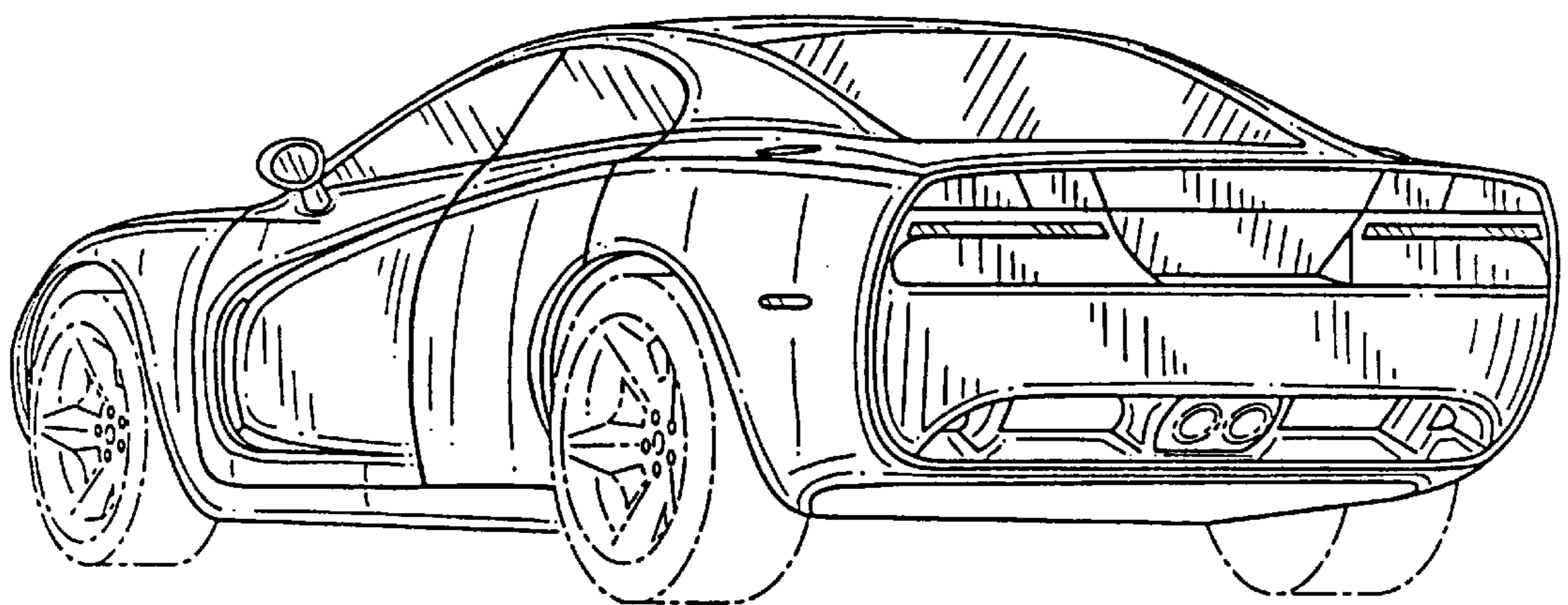

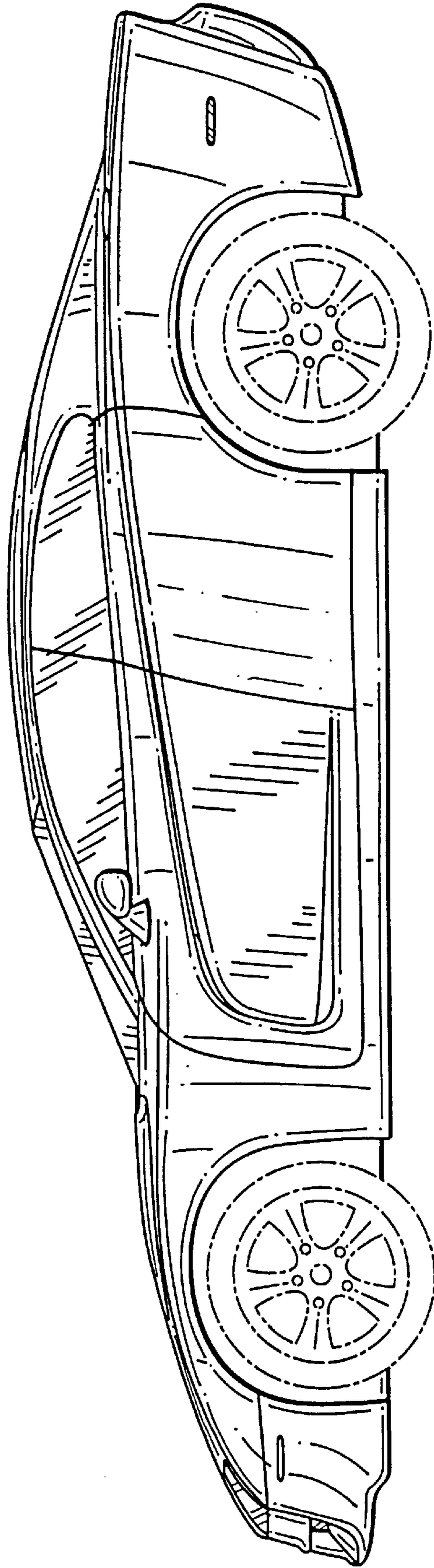

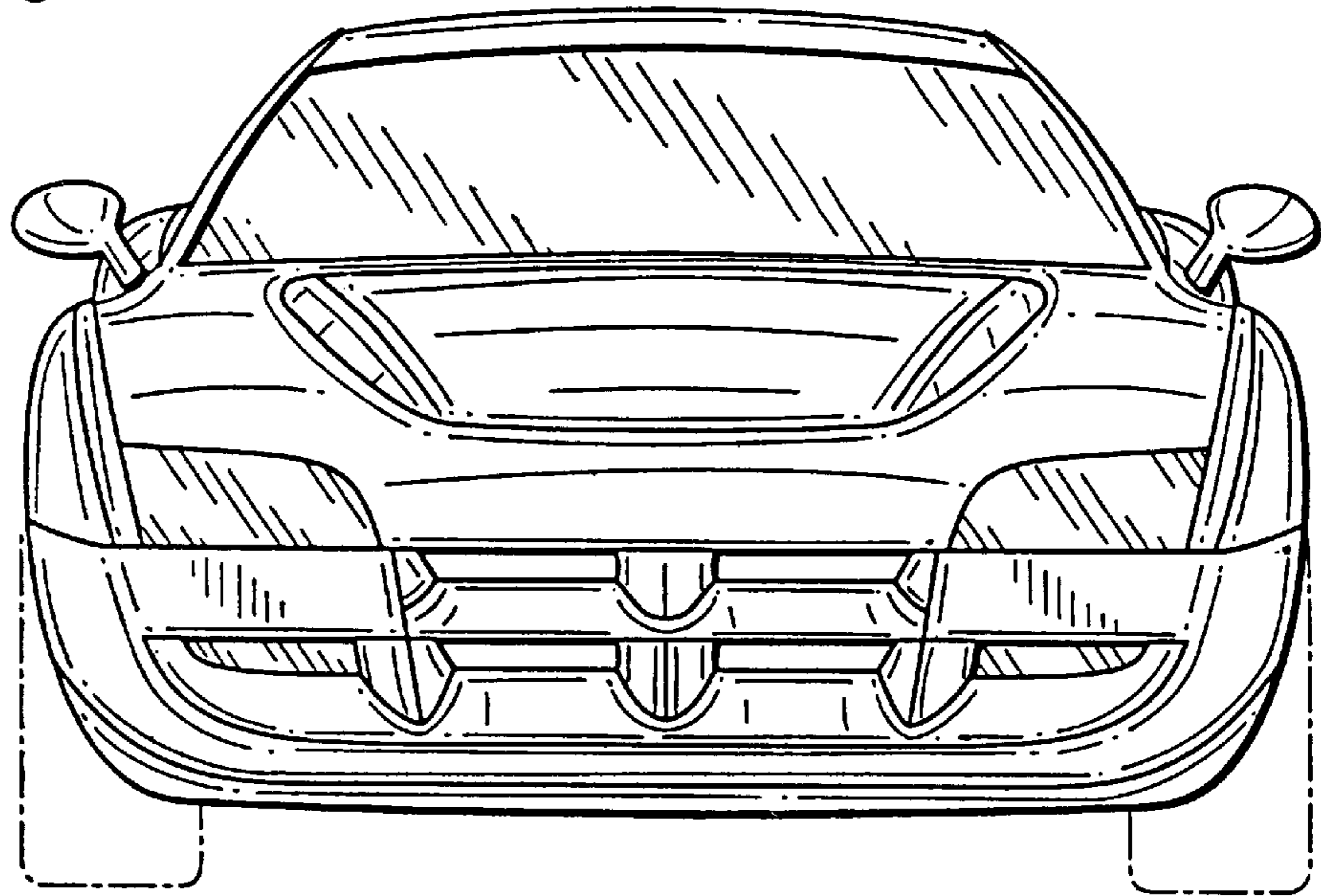
