The ornamental design for telephone handset with base, as shown and described.

DESCRIPTION

FIG. 18 is a left elevational view thereof;

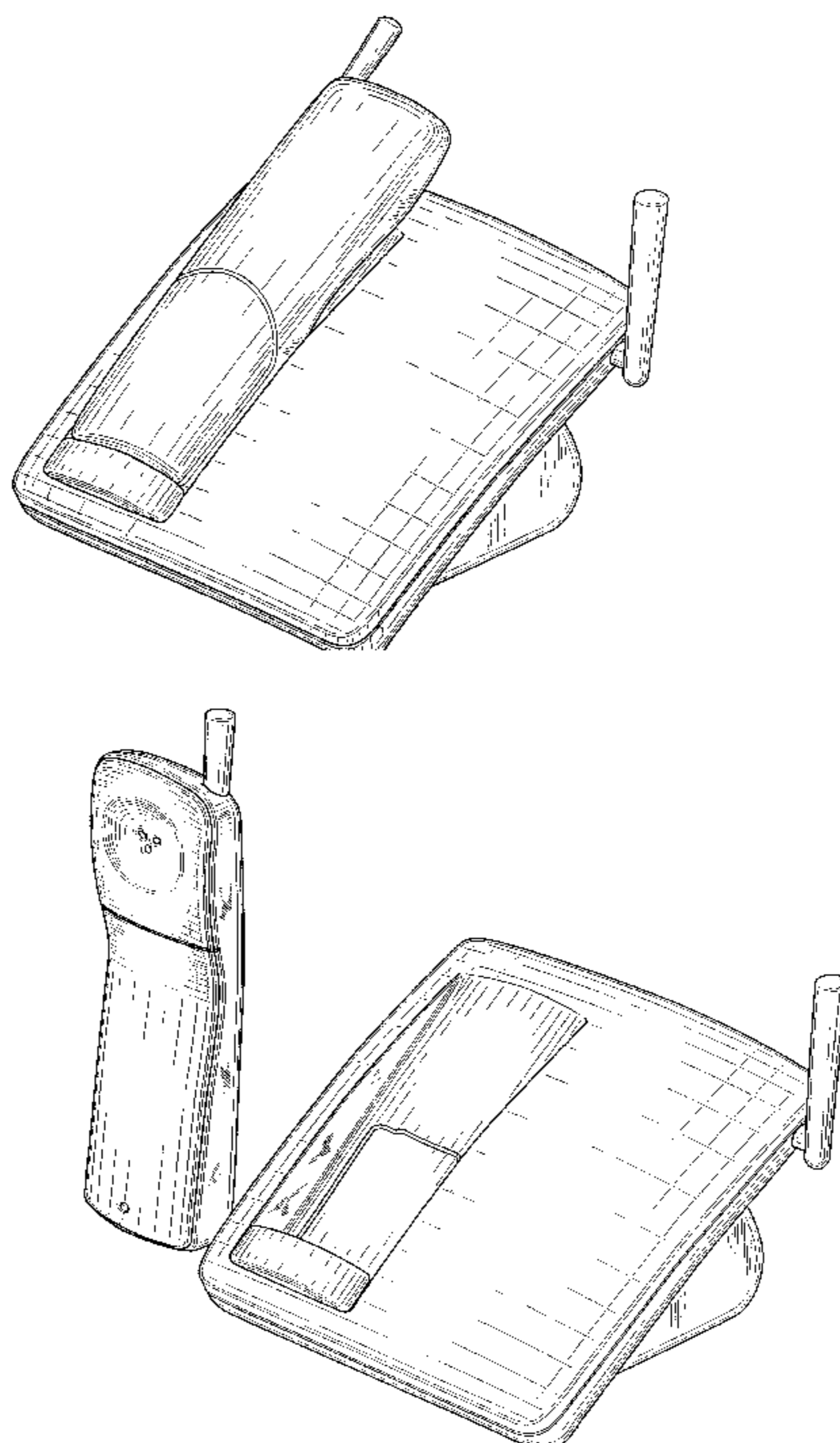
FIG. 19 is a right elevational view thereof;

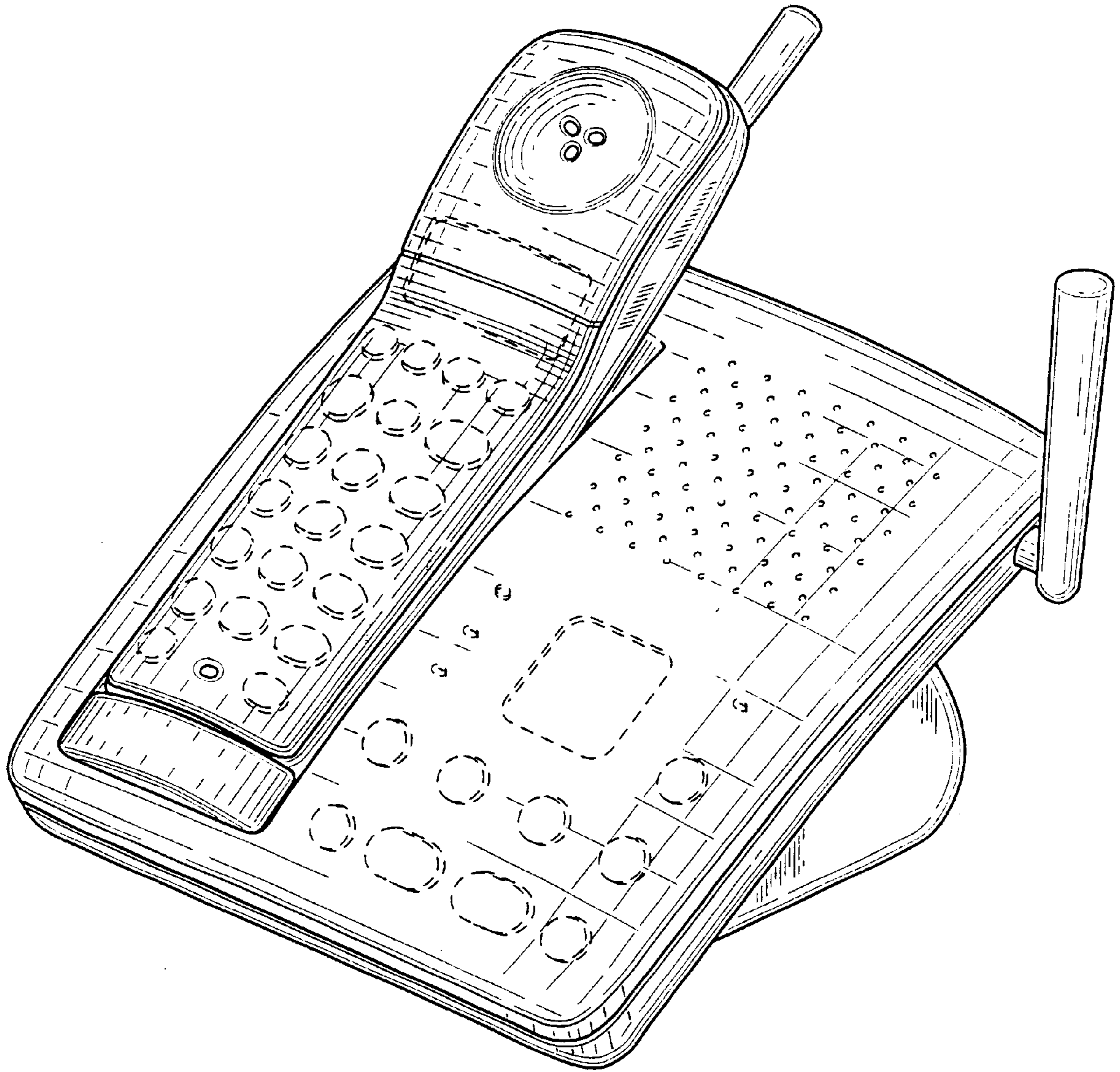

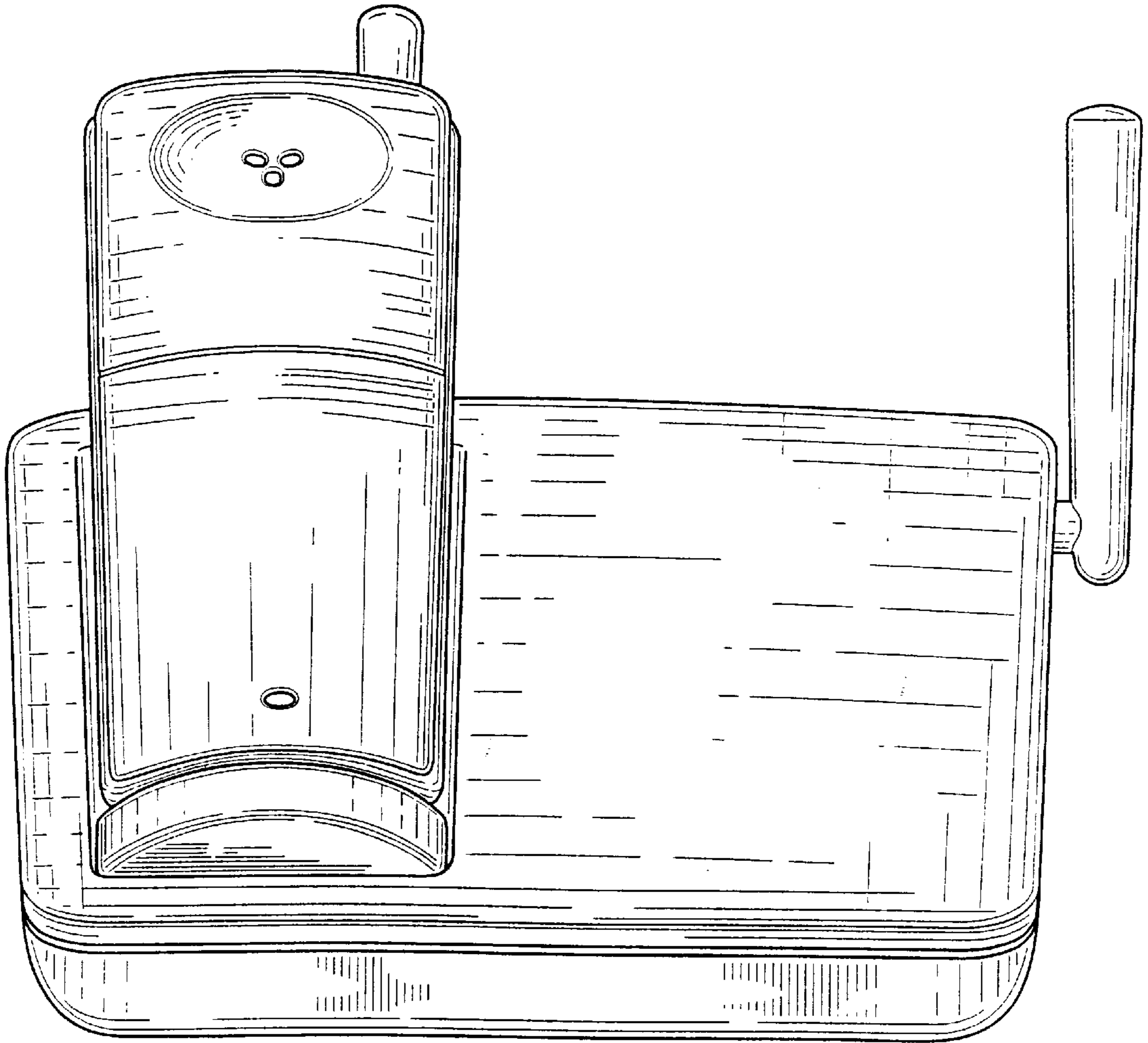

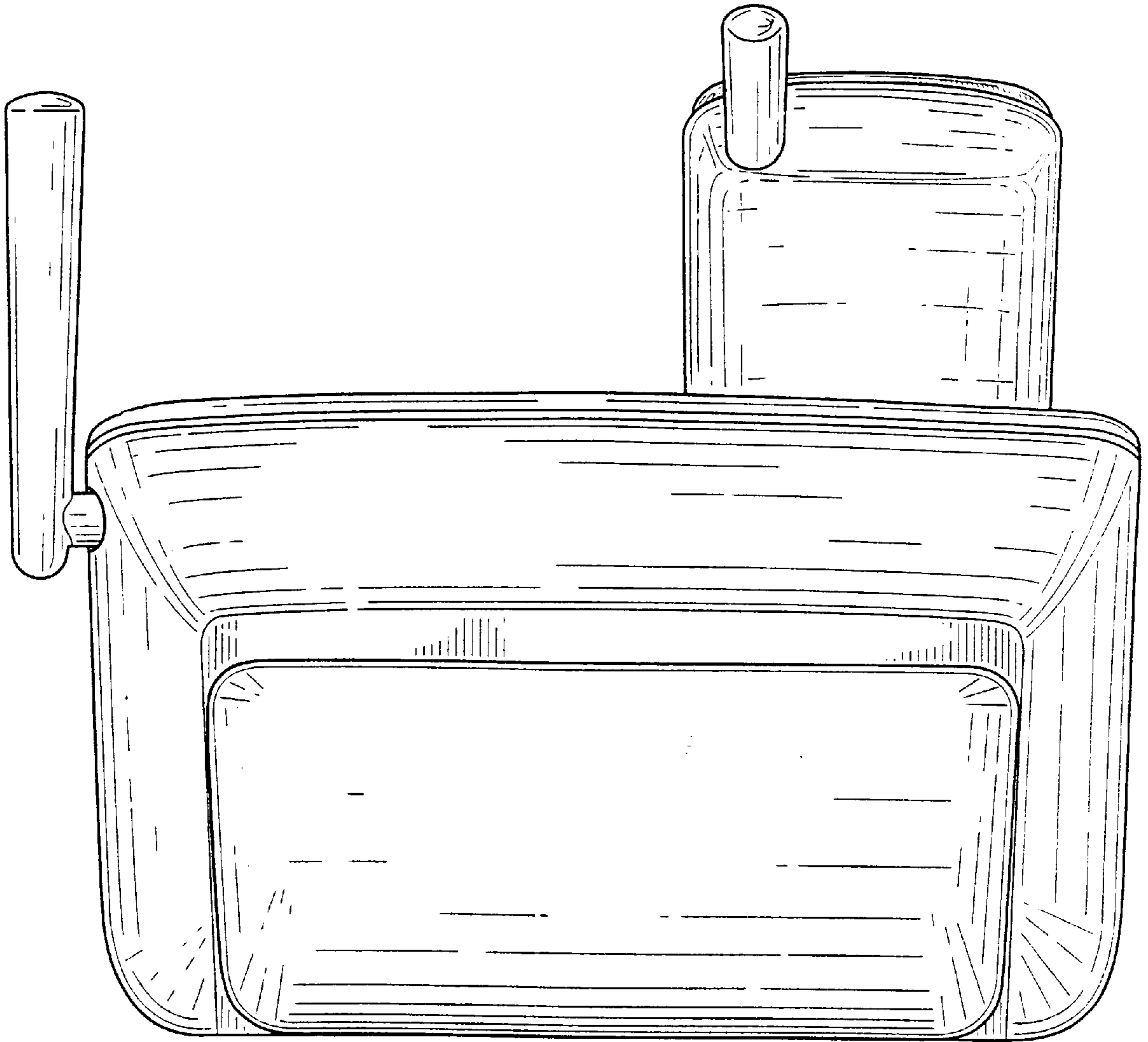

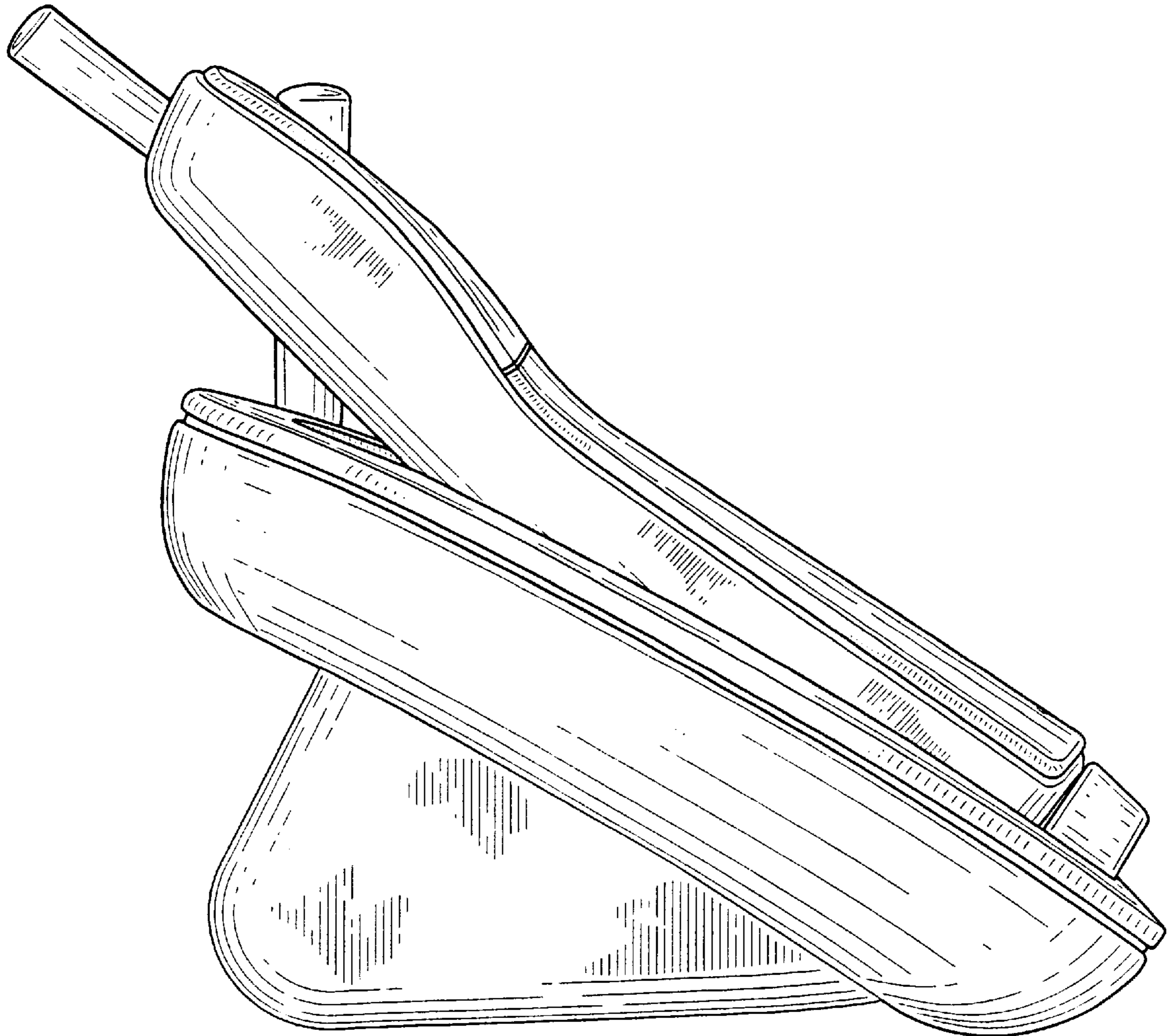

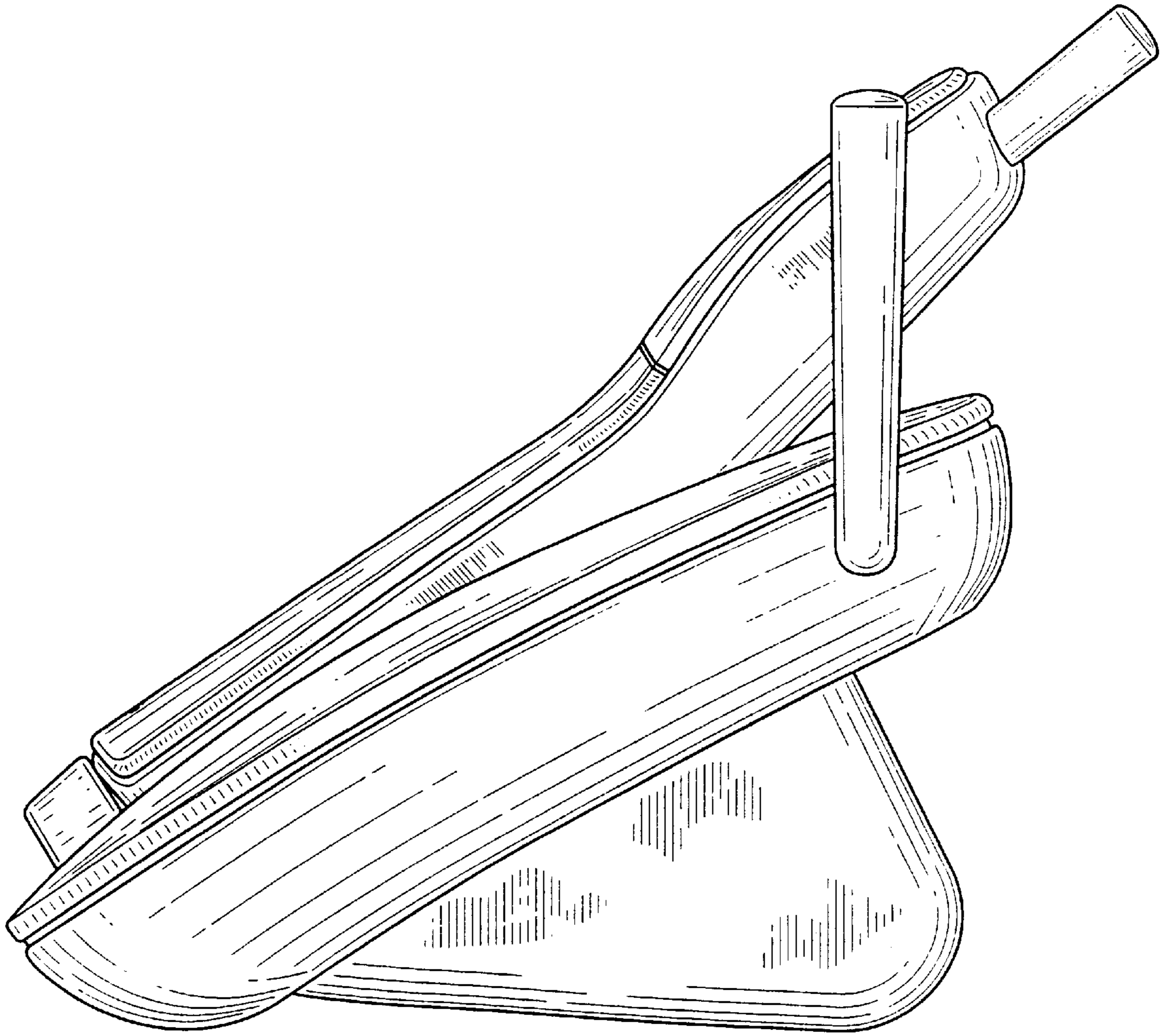

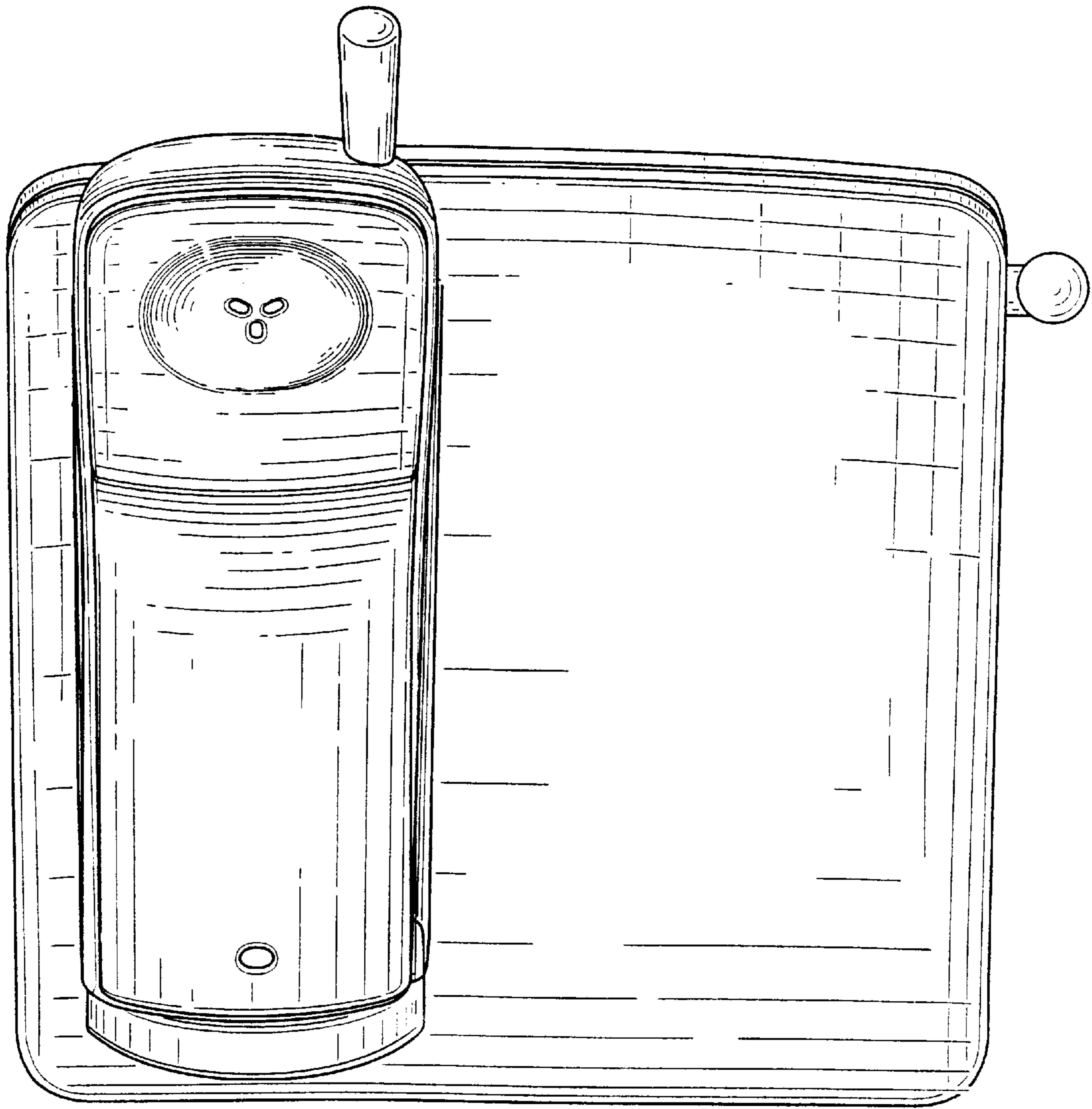

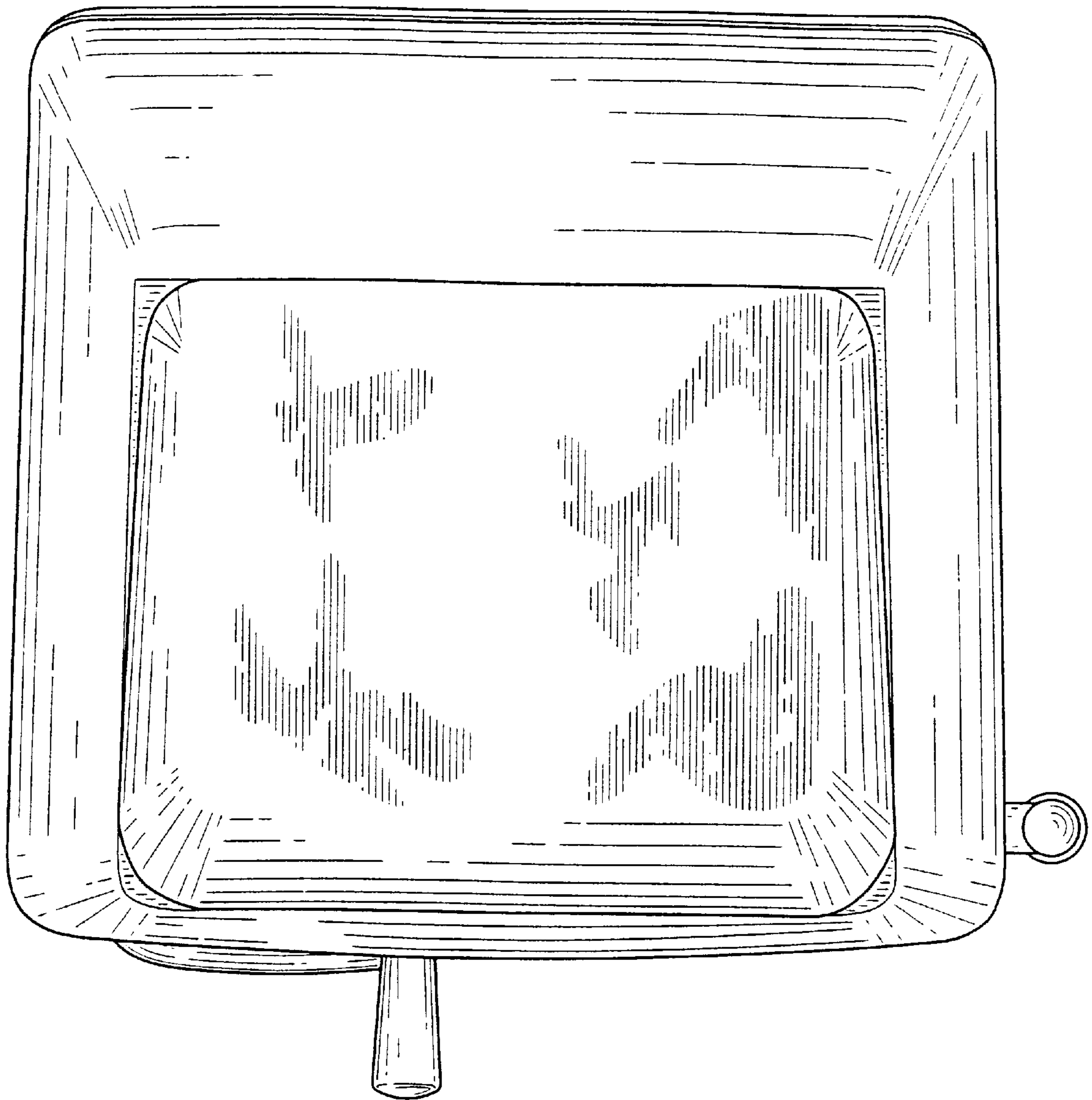

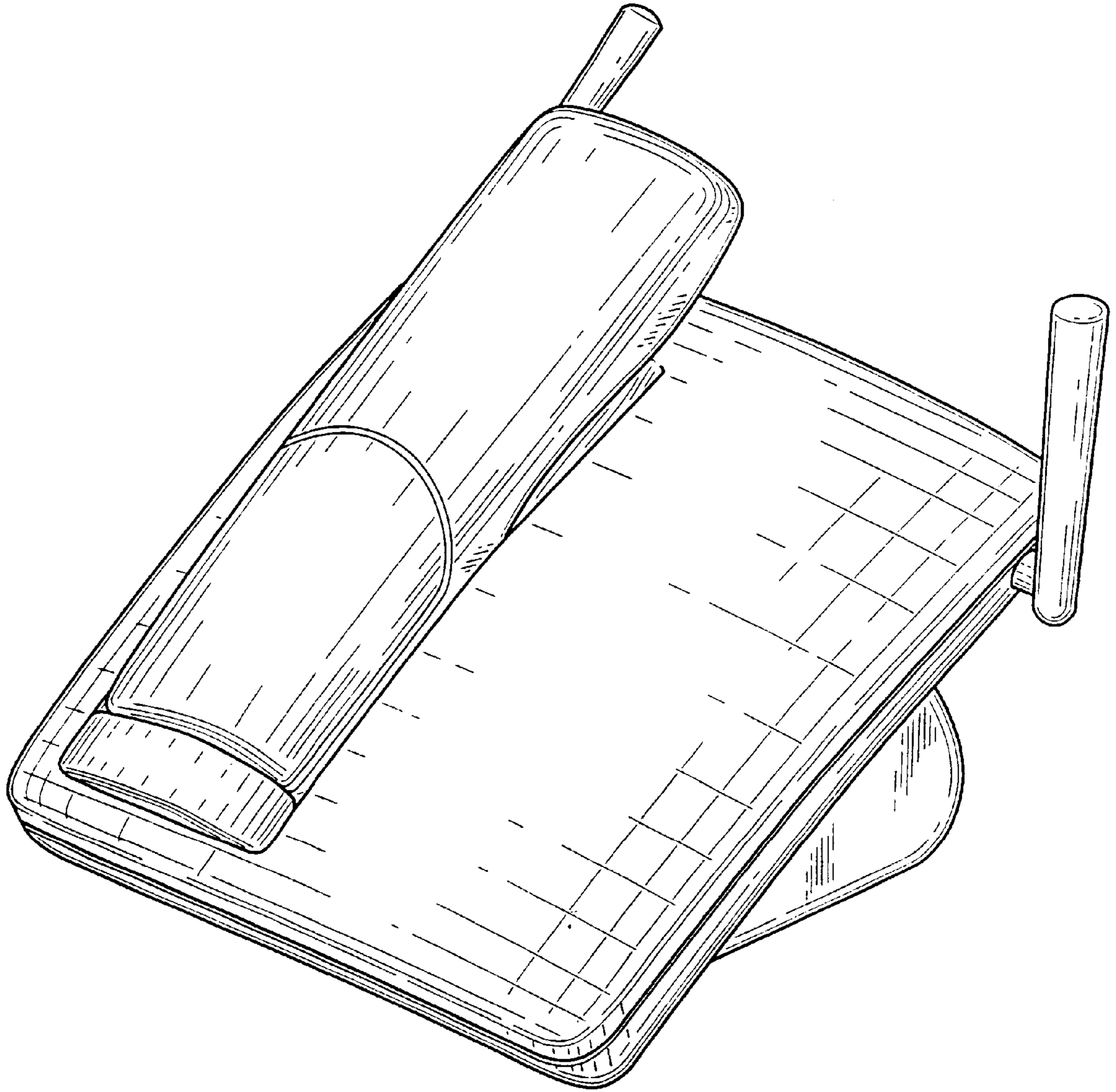

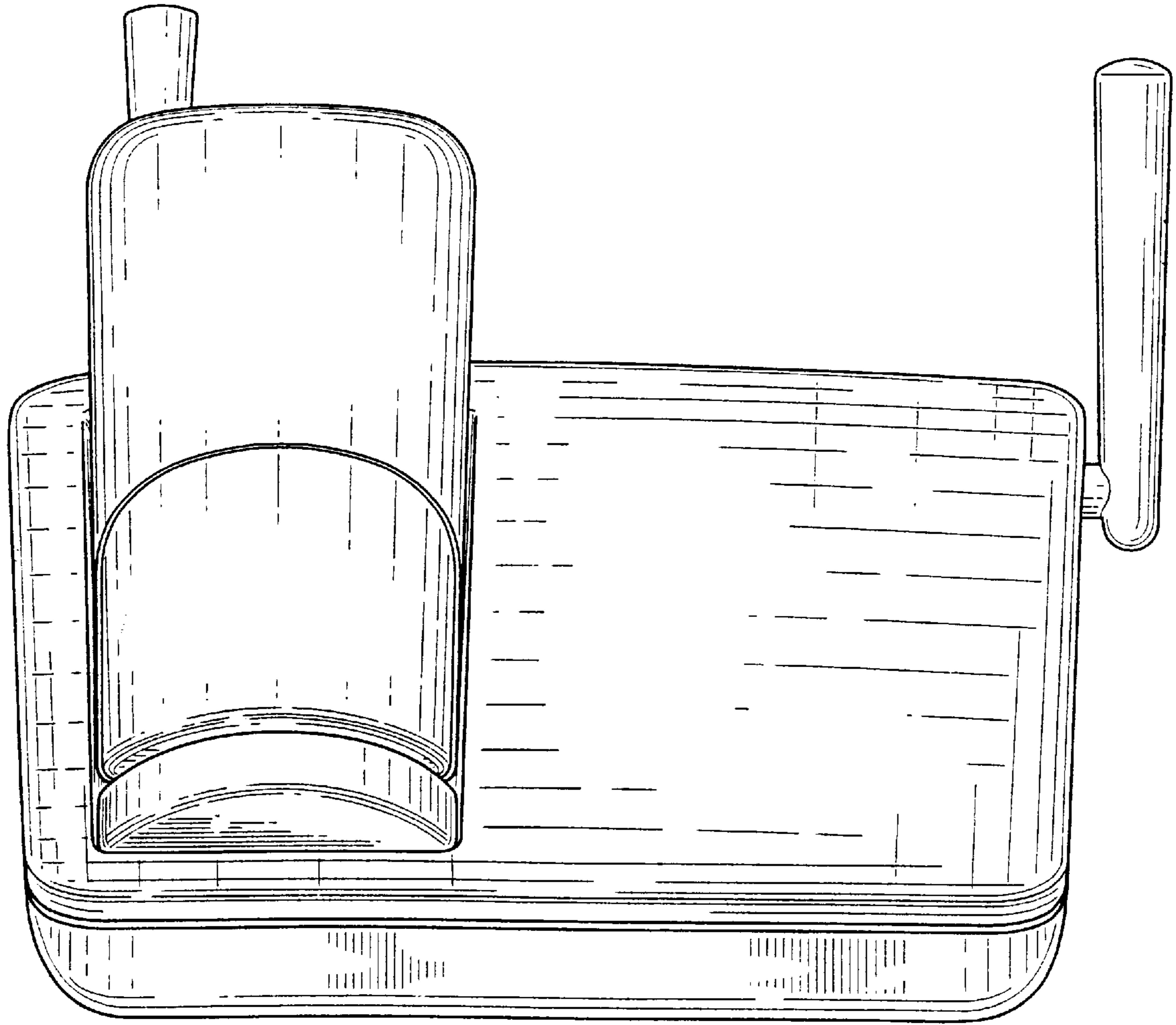

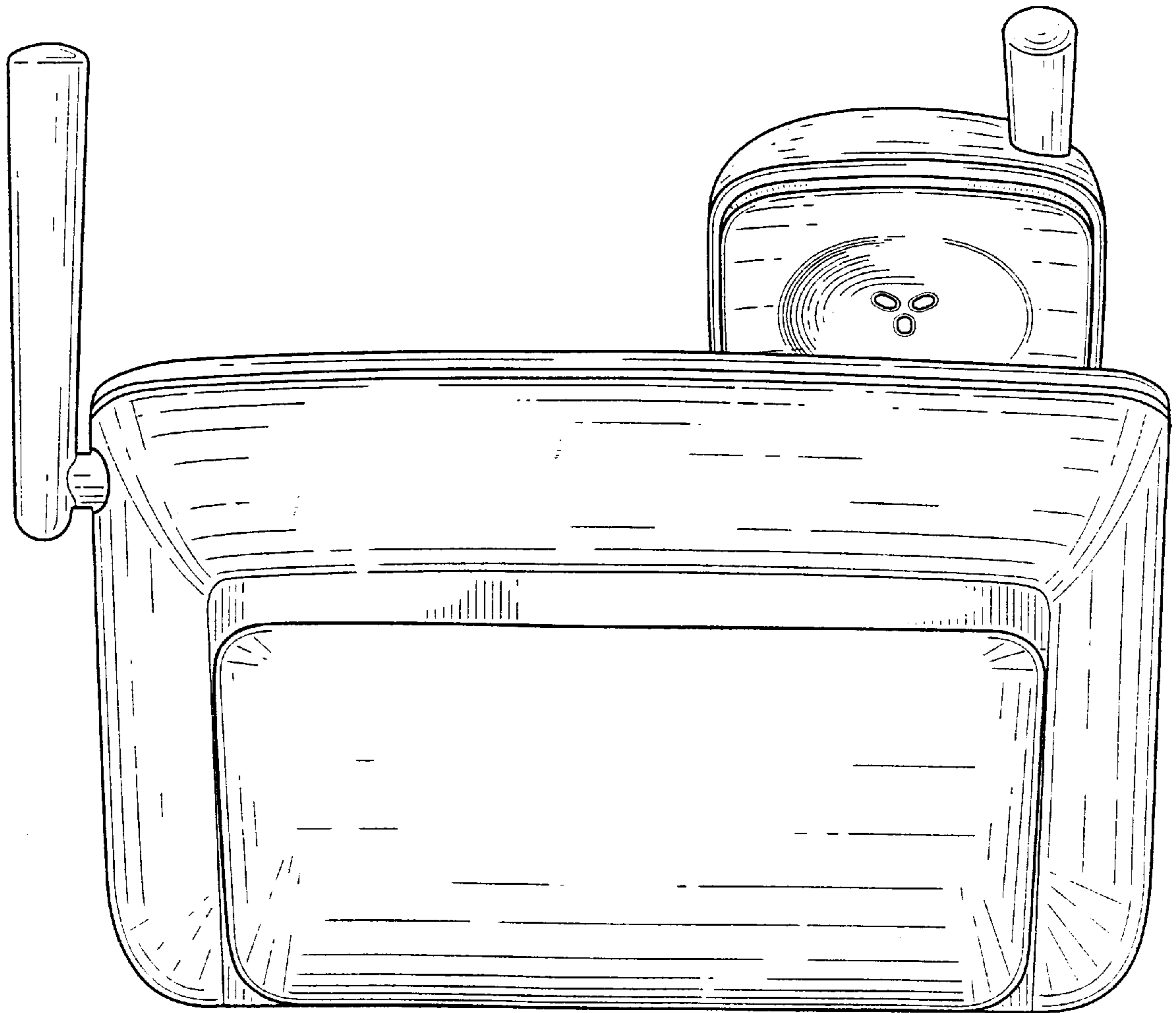

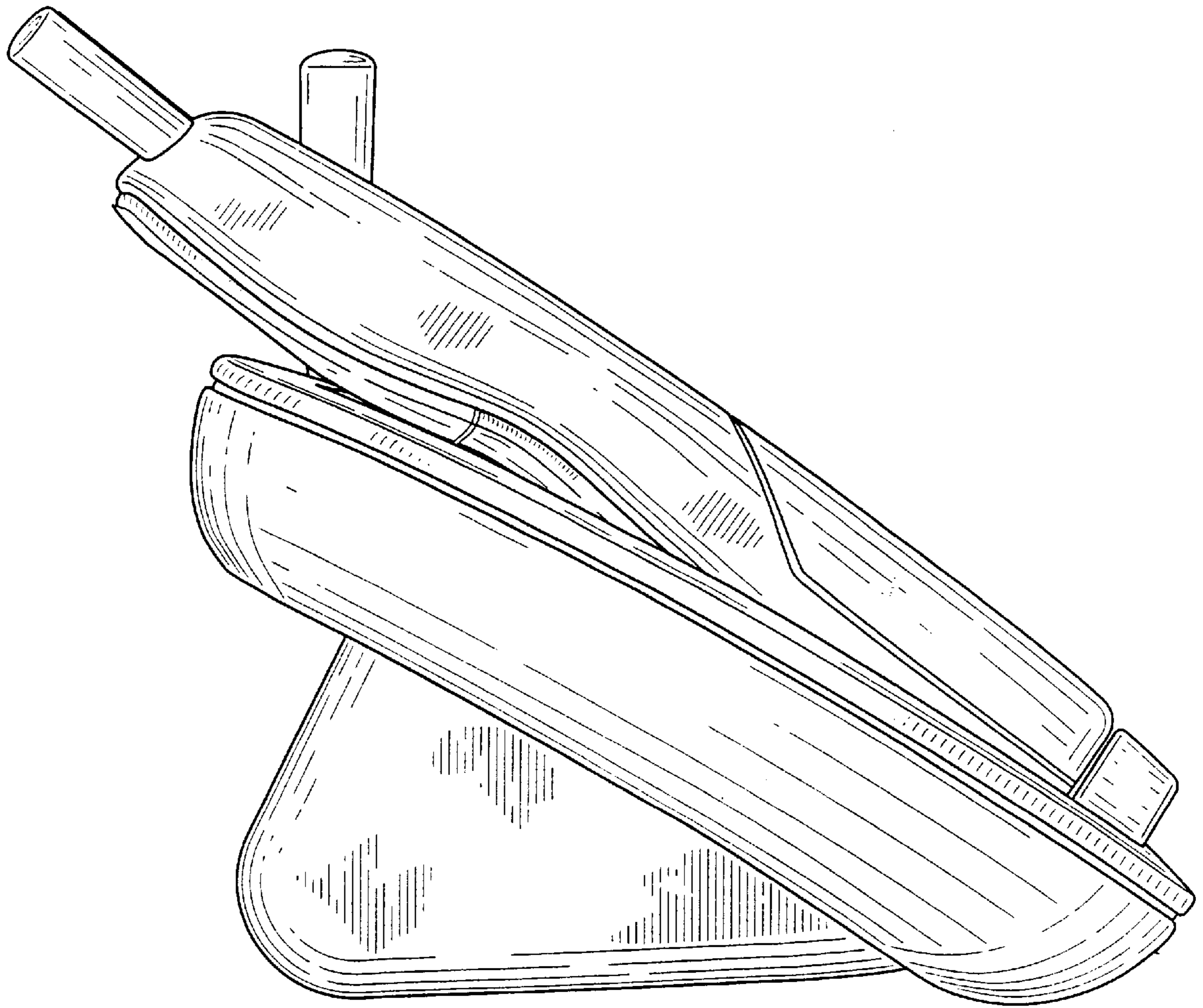

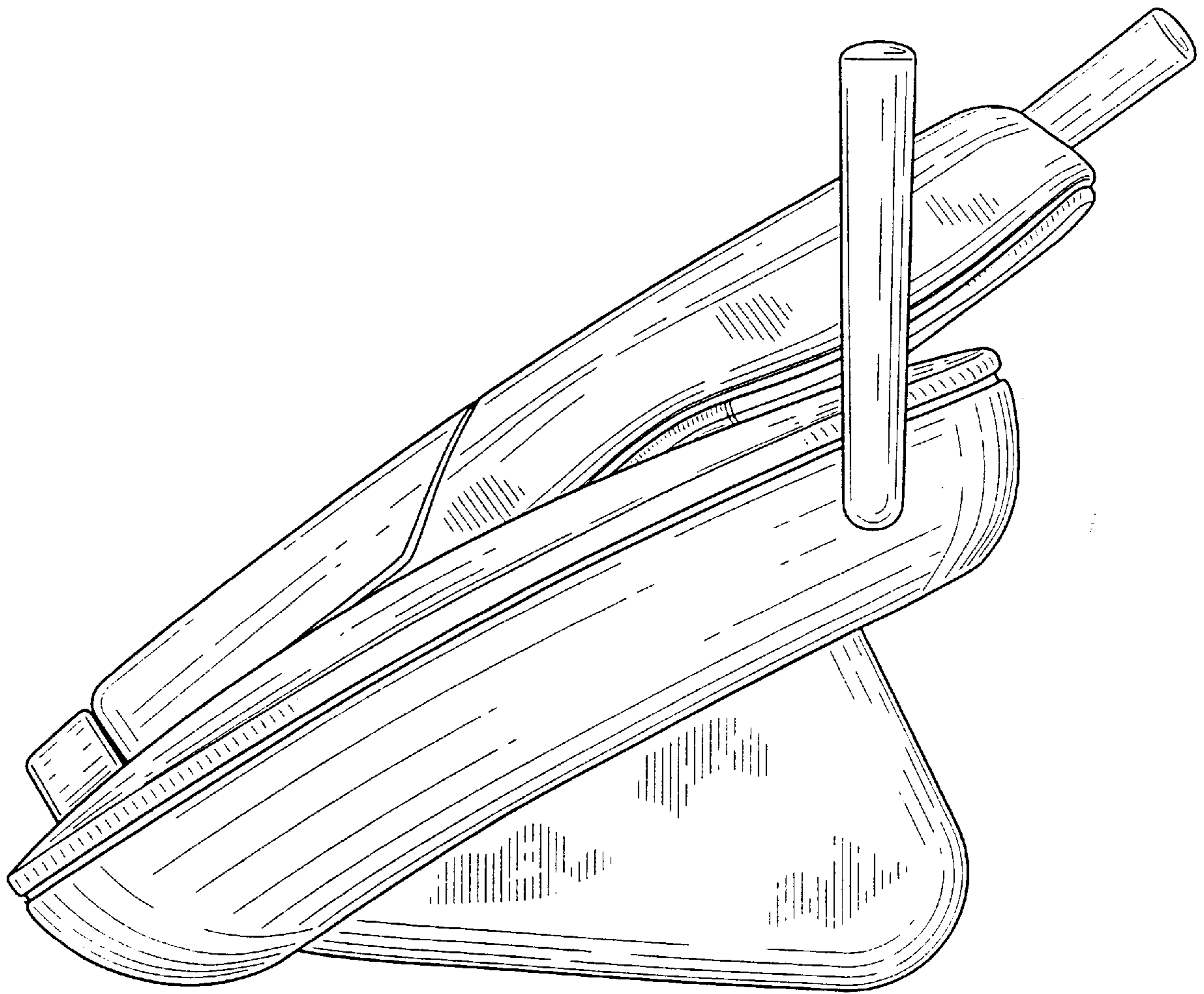

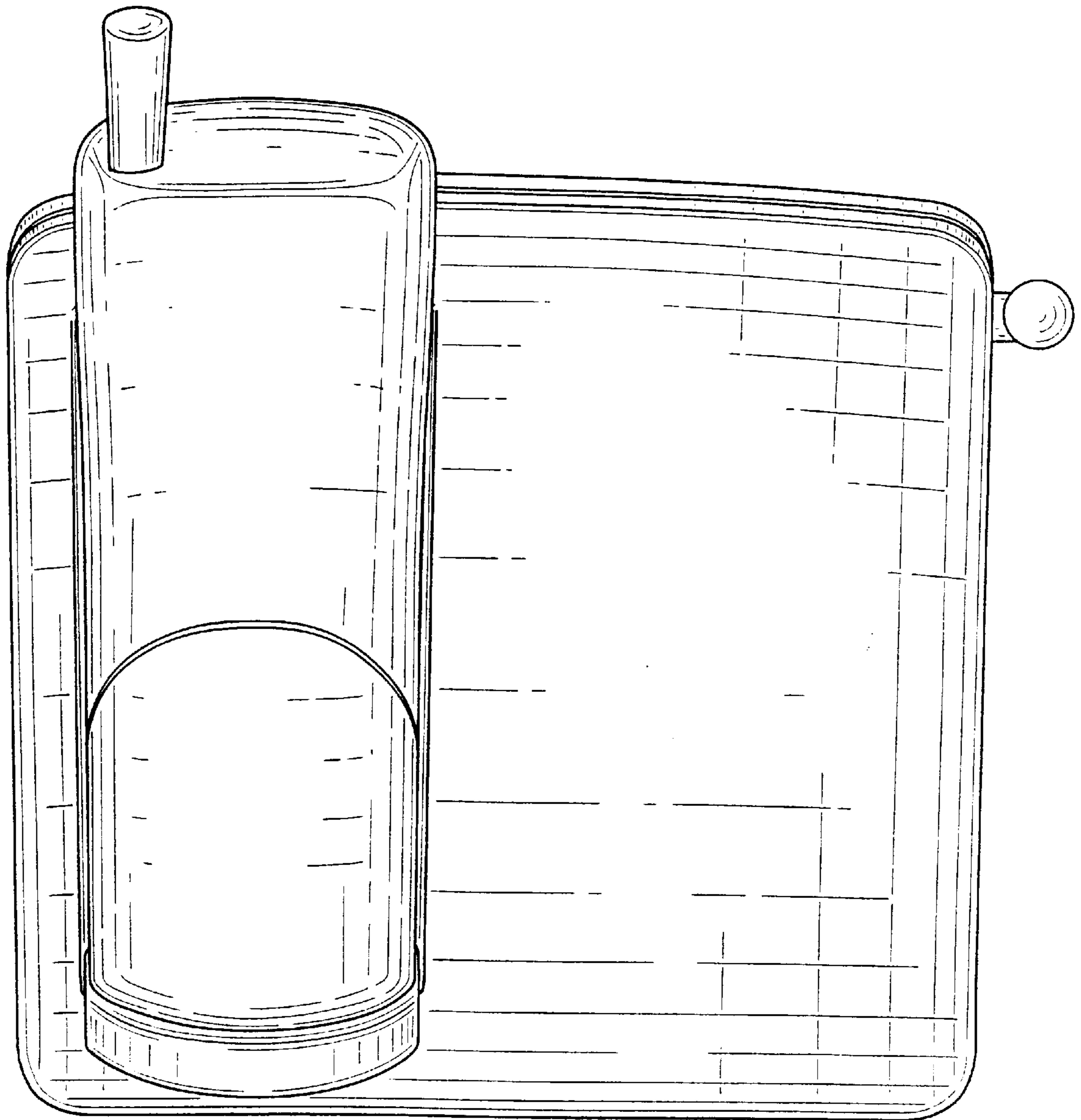

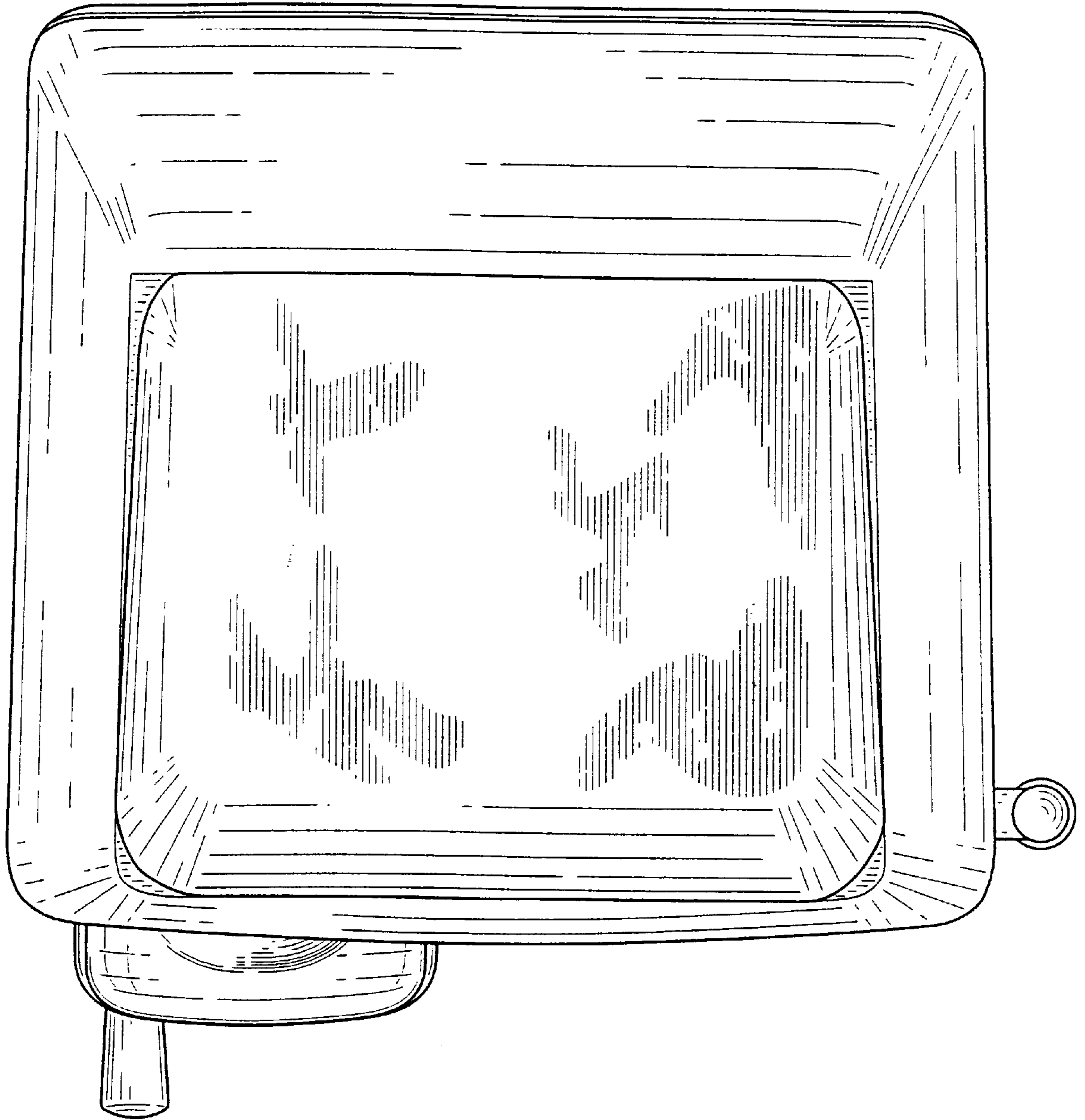

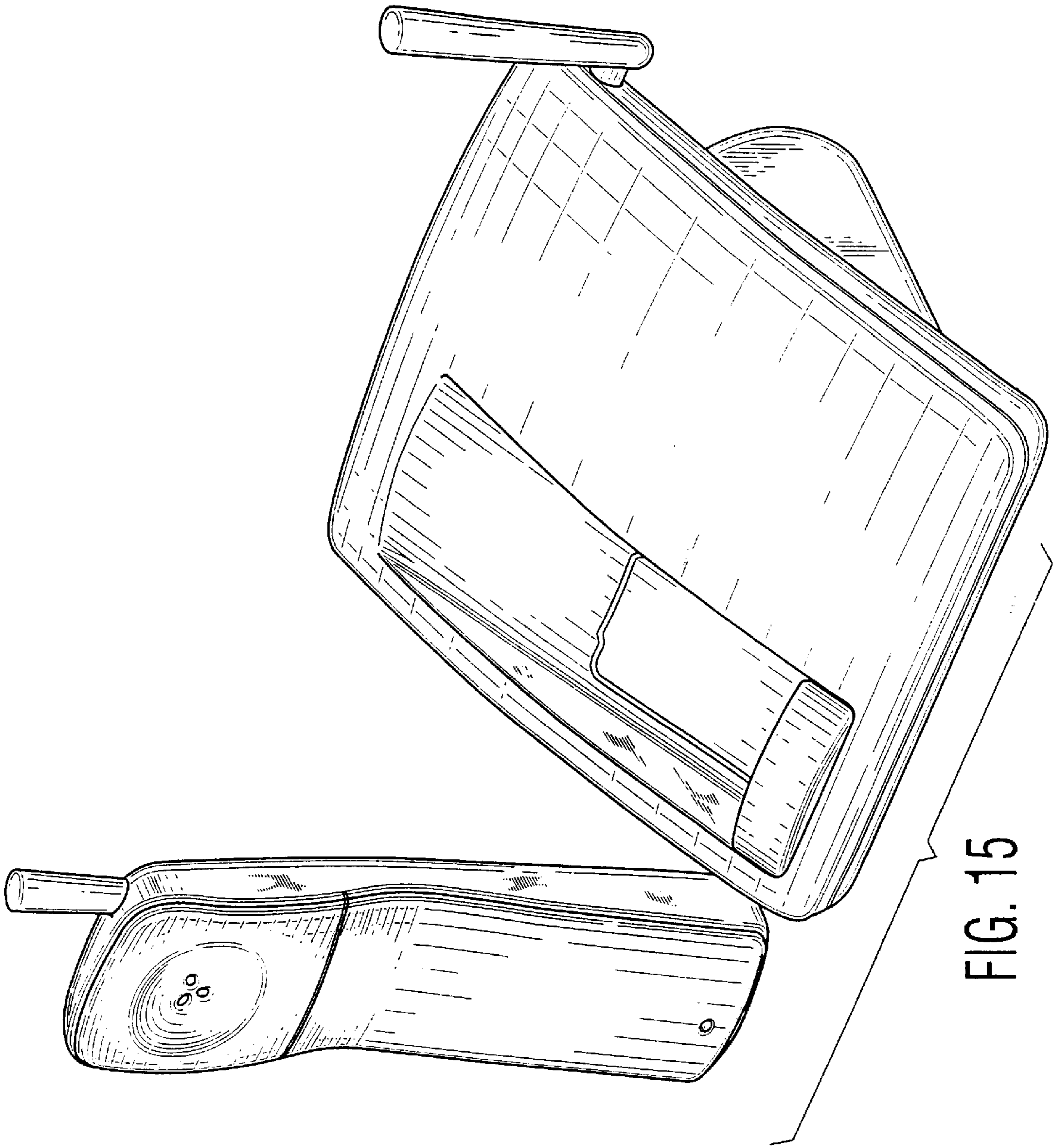

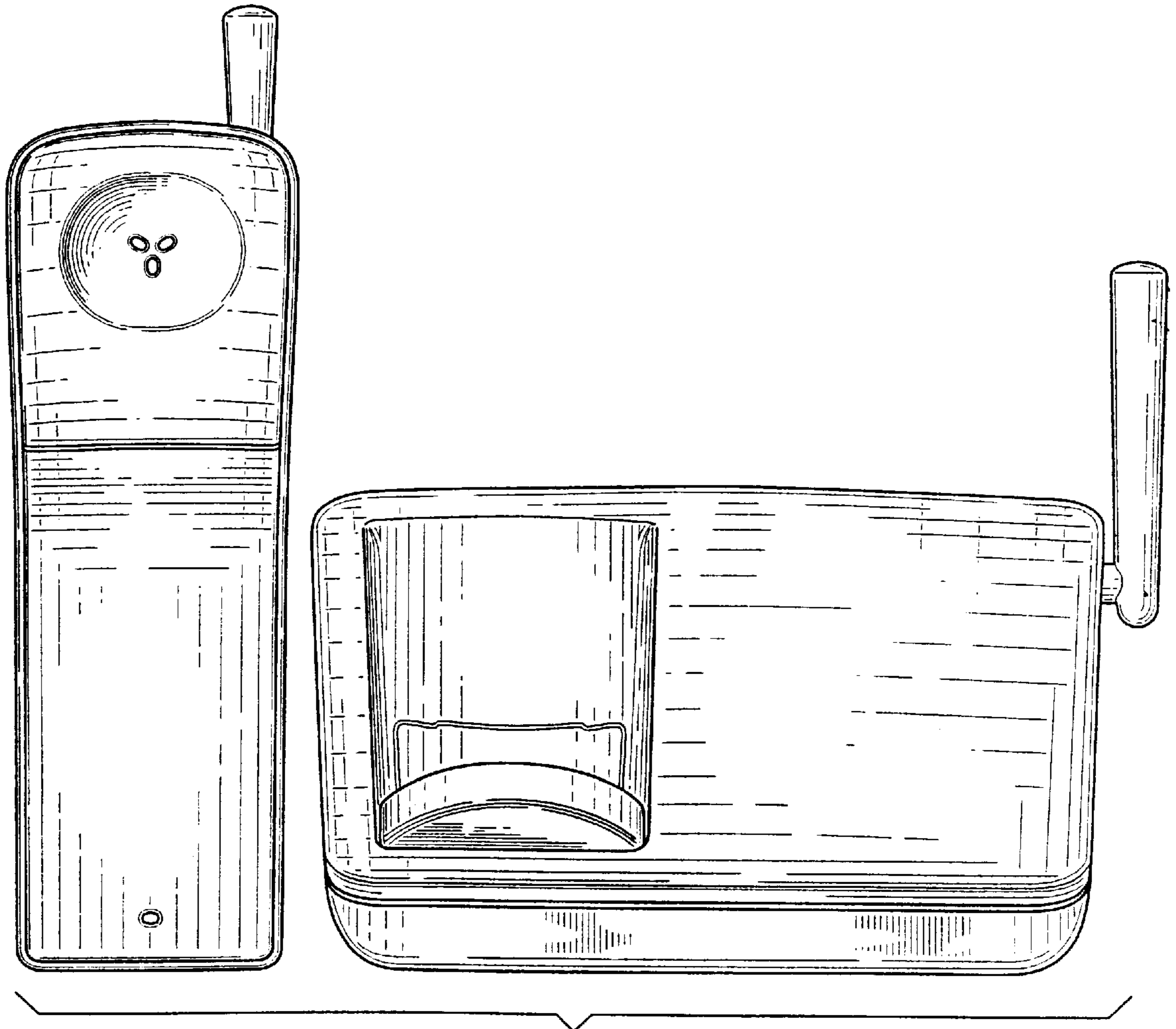

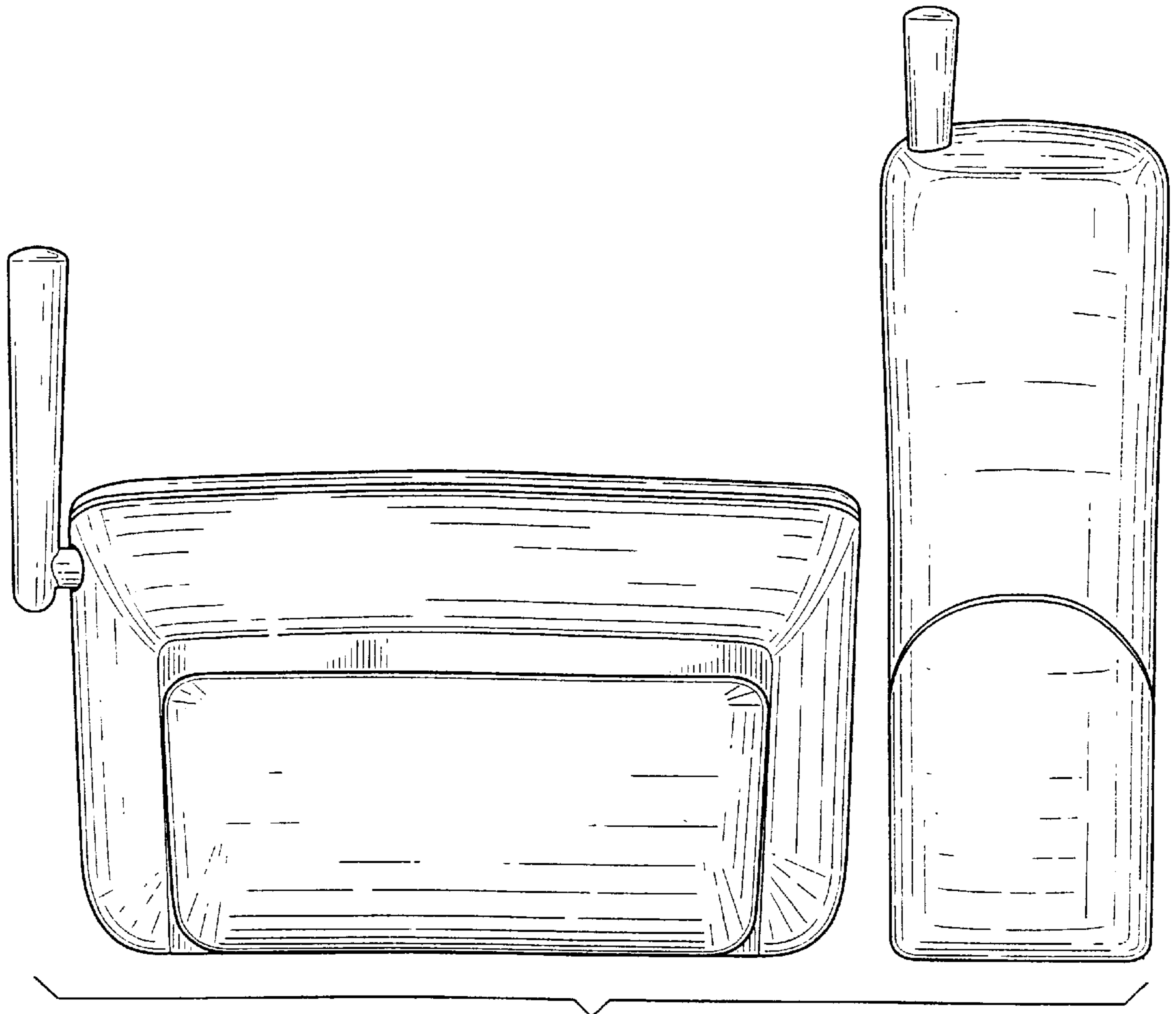

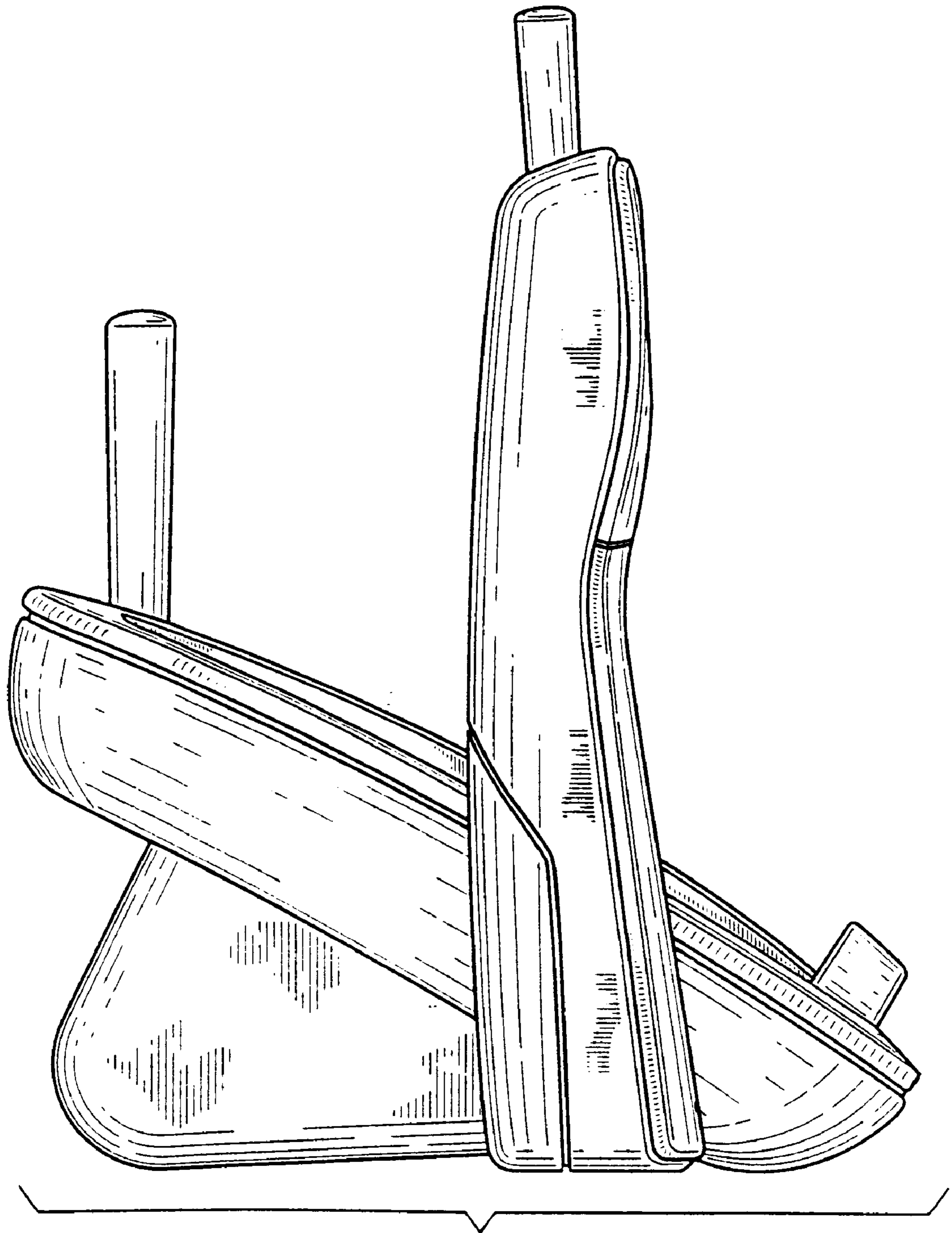

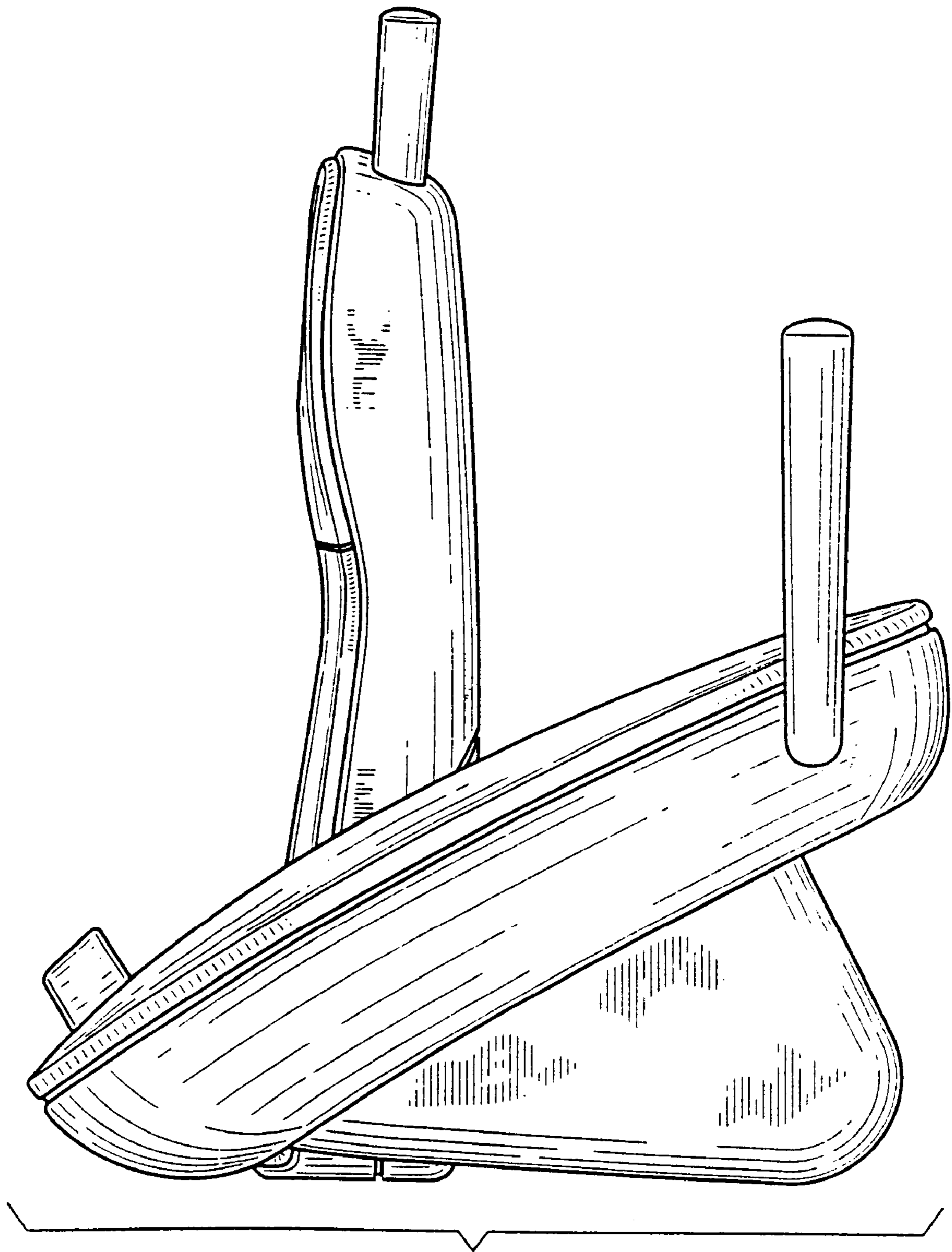

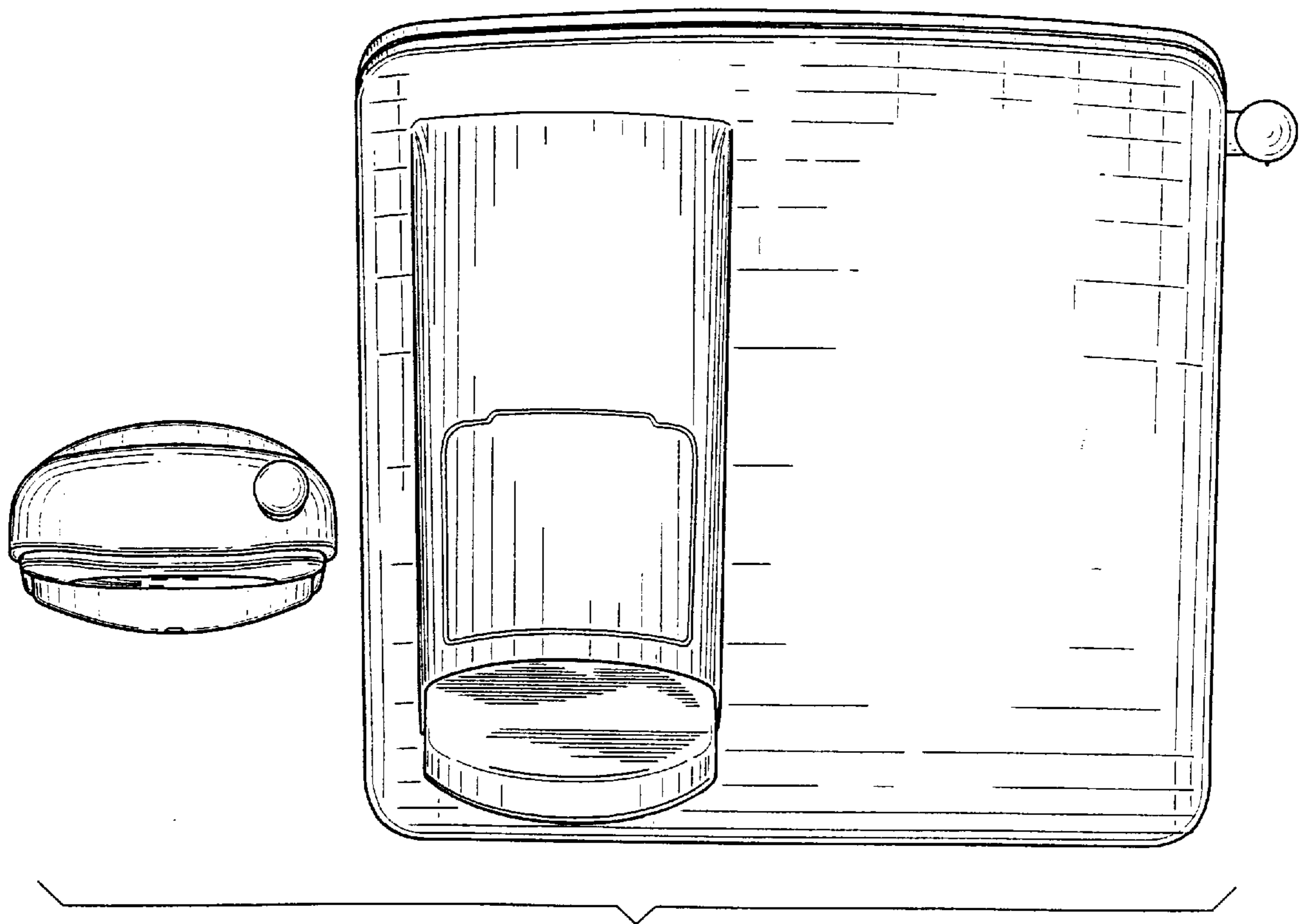

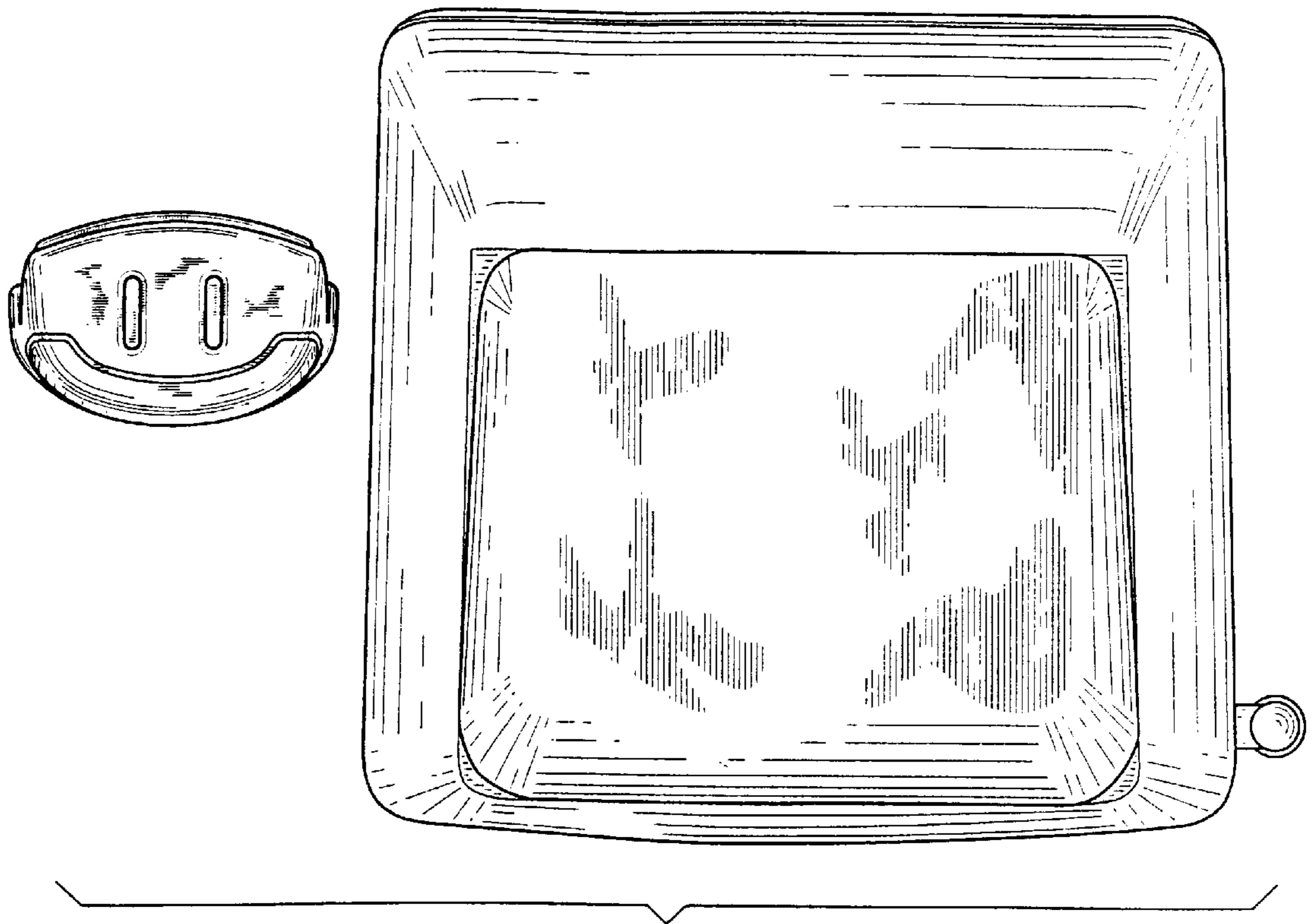
