FIG. 21 is a bottom elevational view thereof.

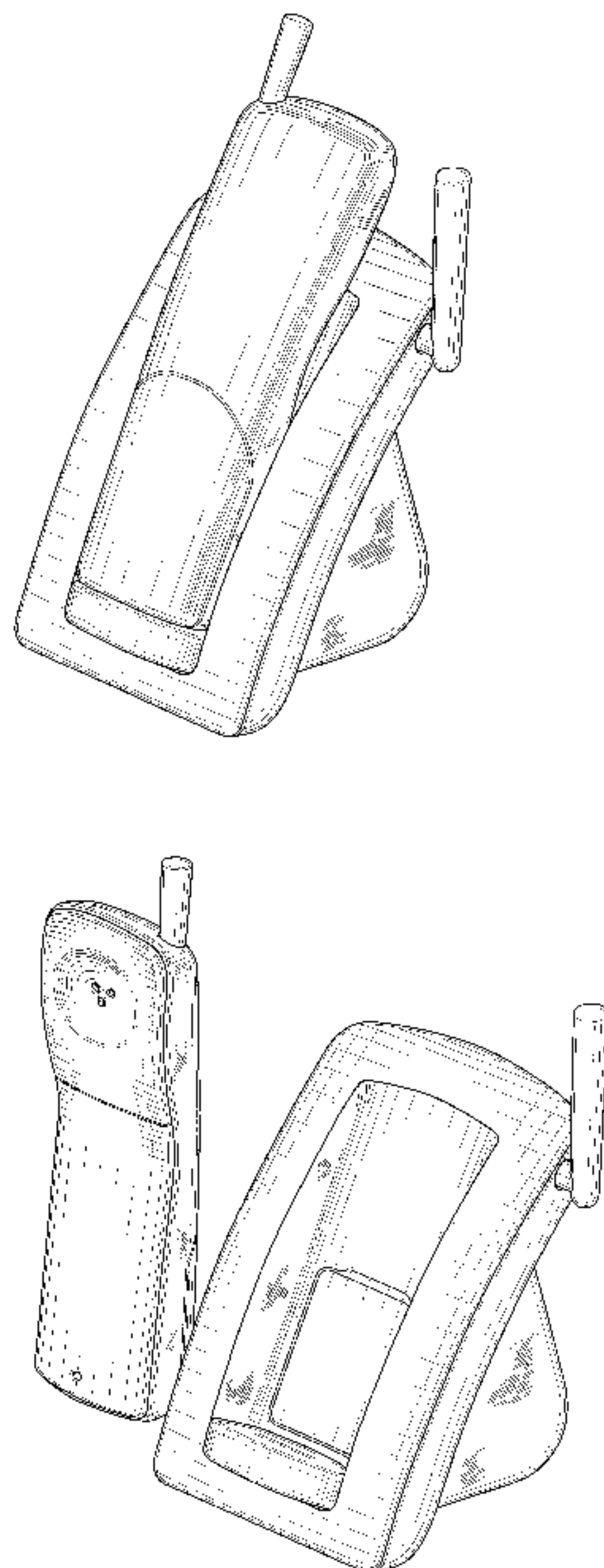

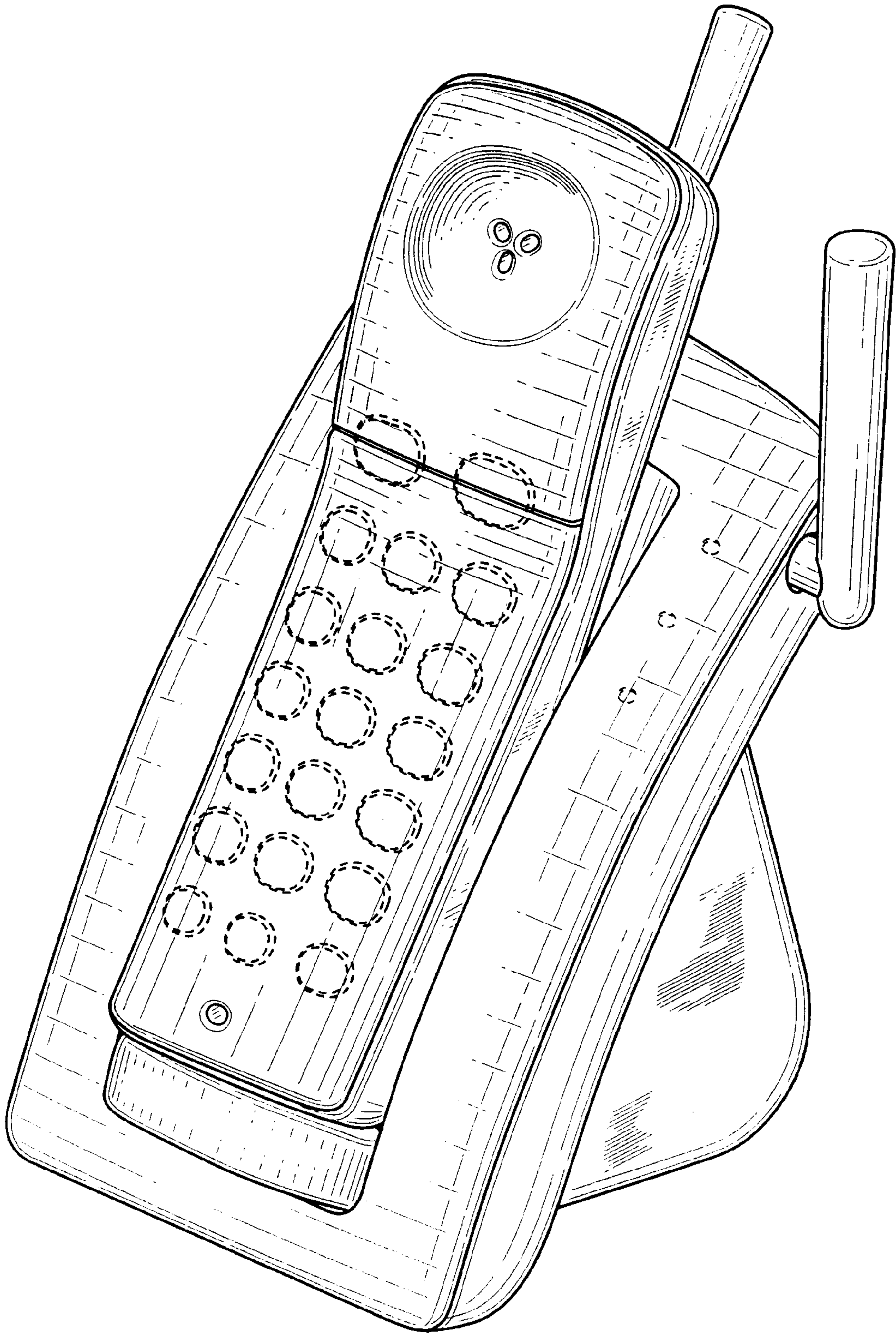

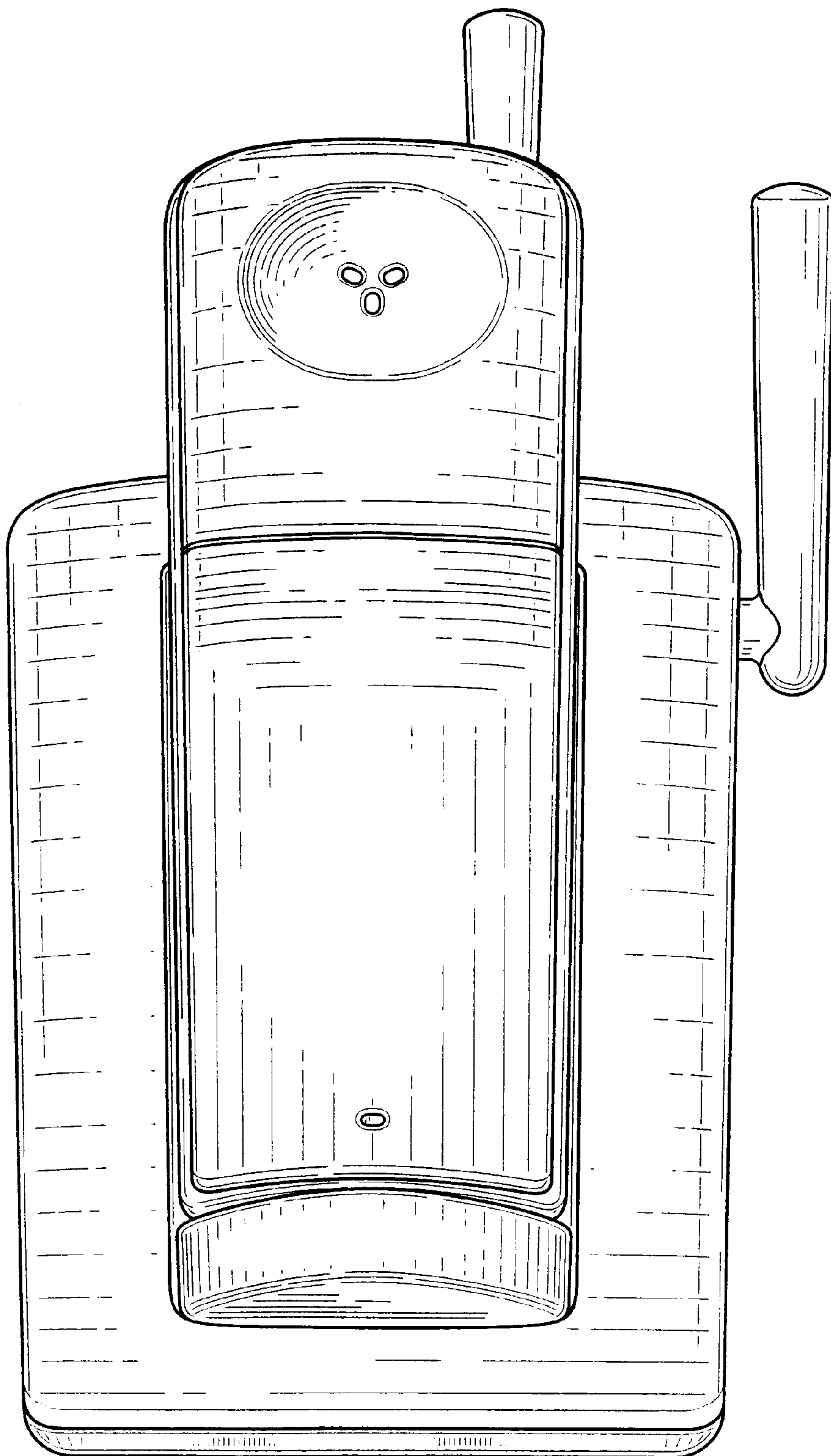

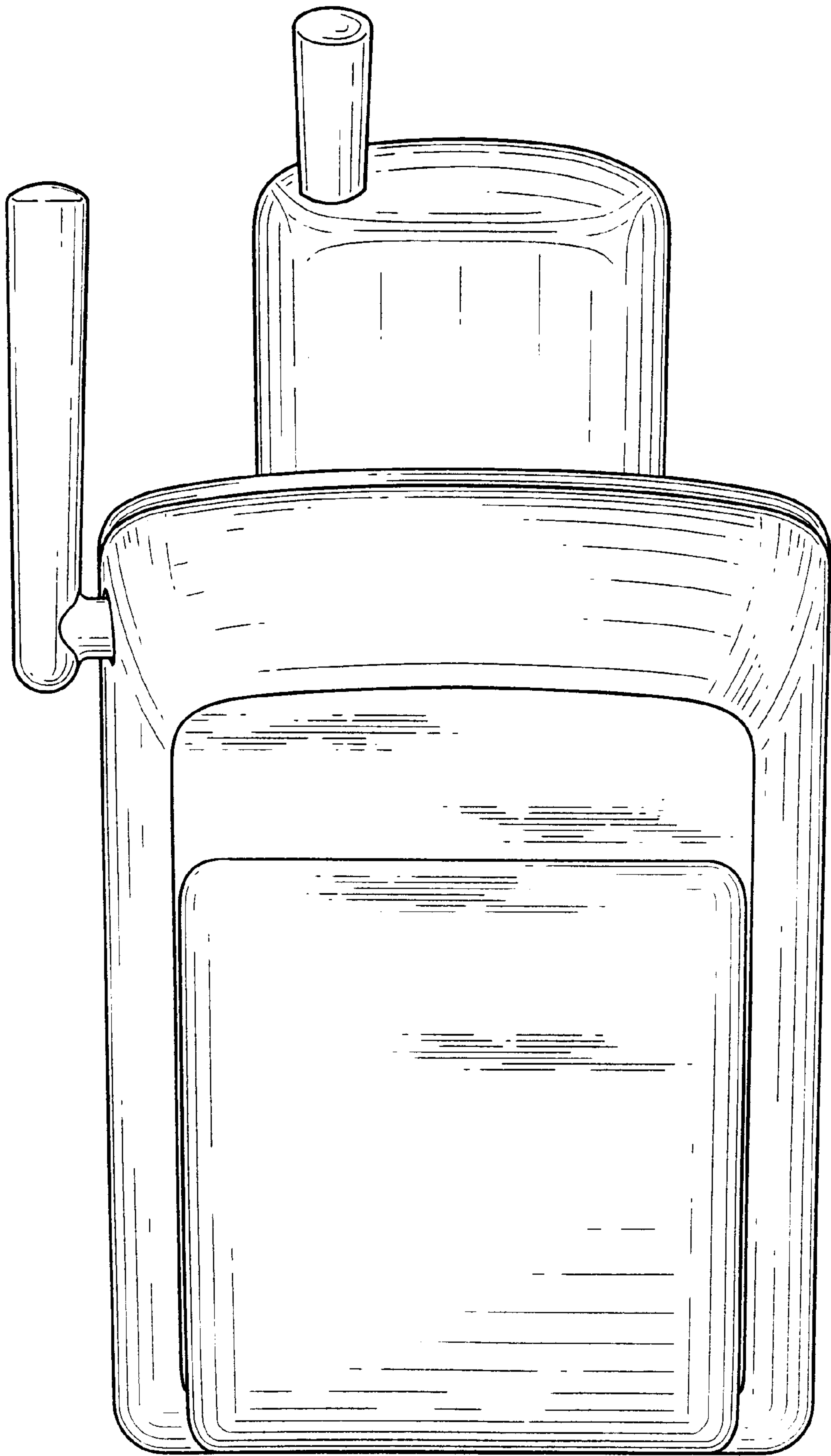

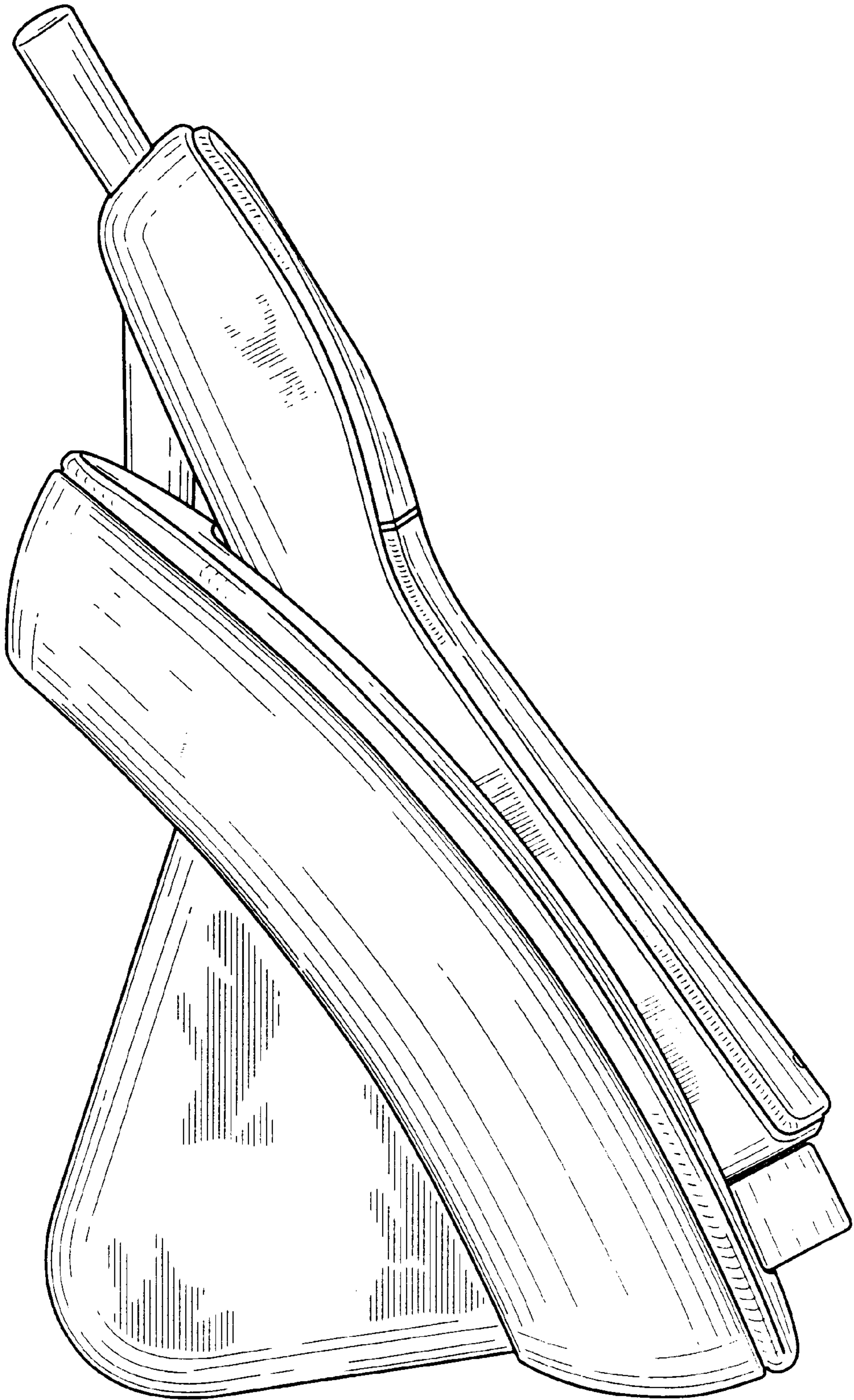

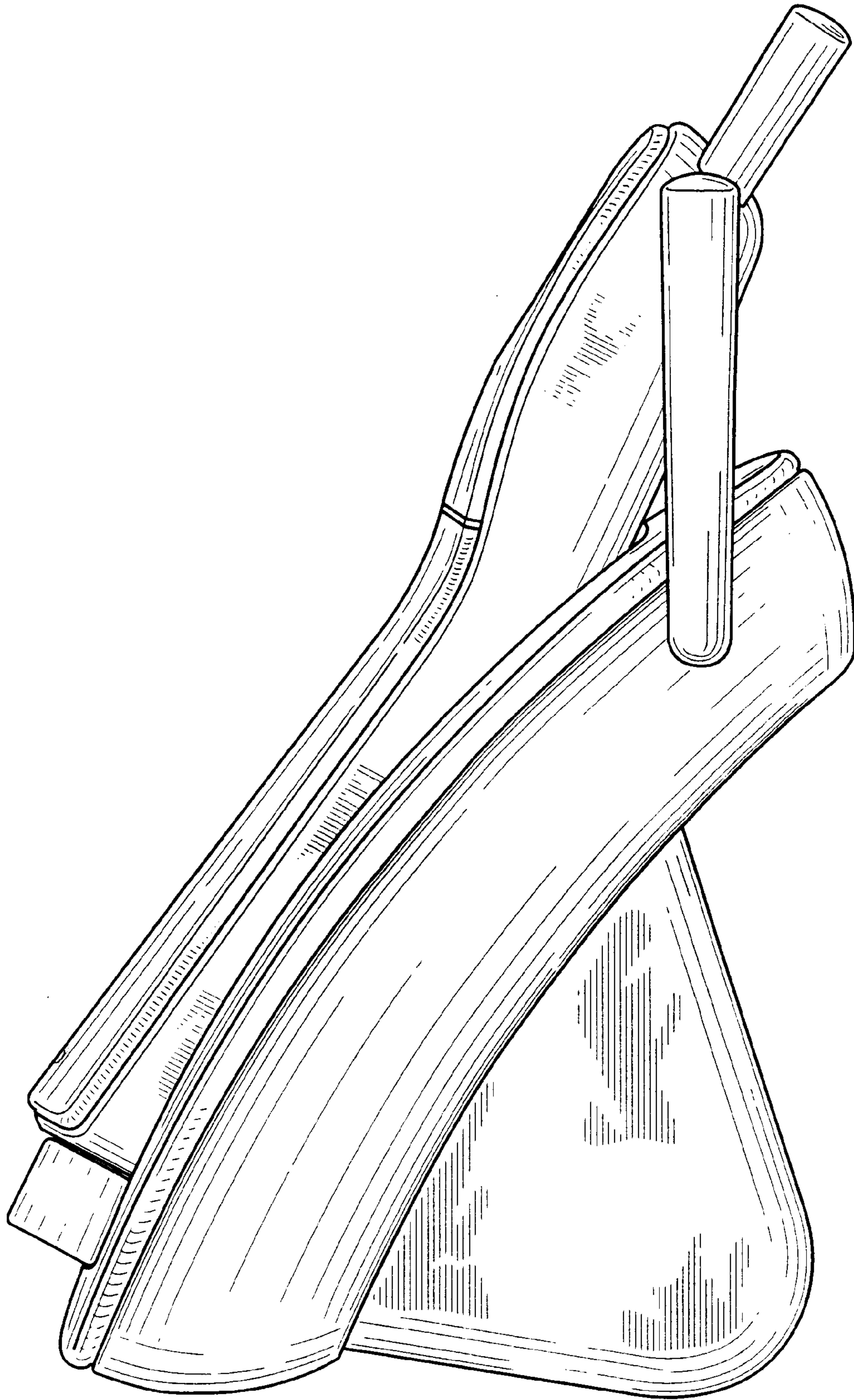

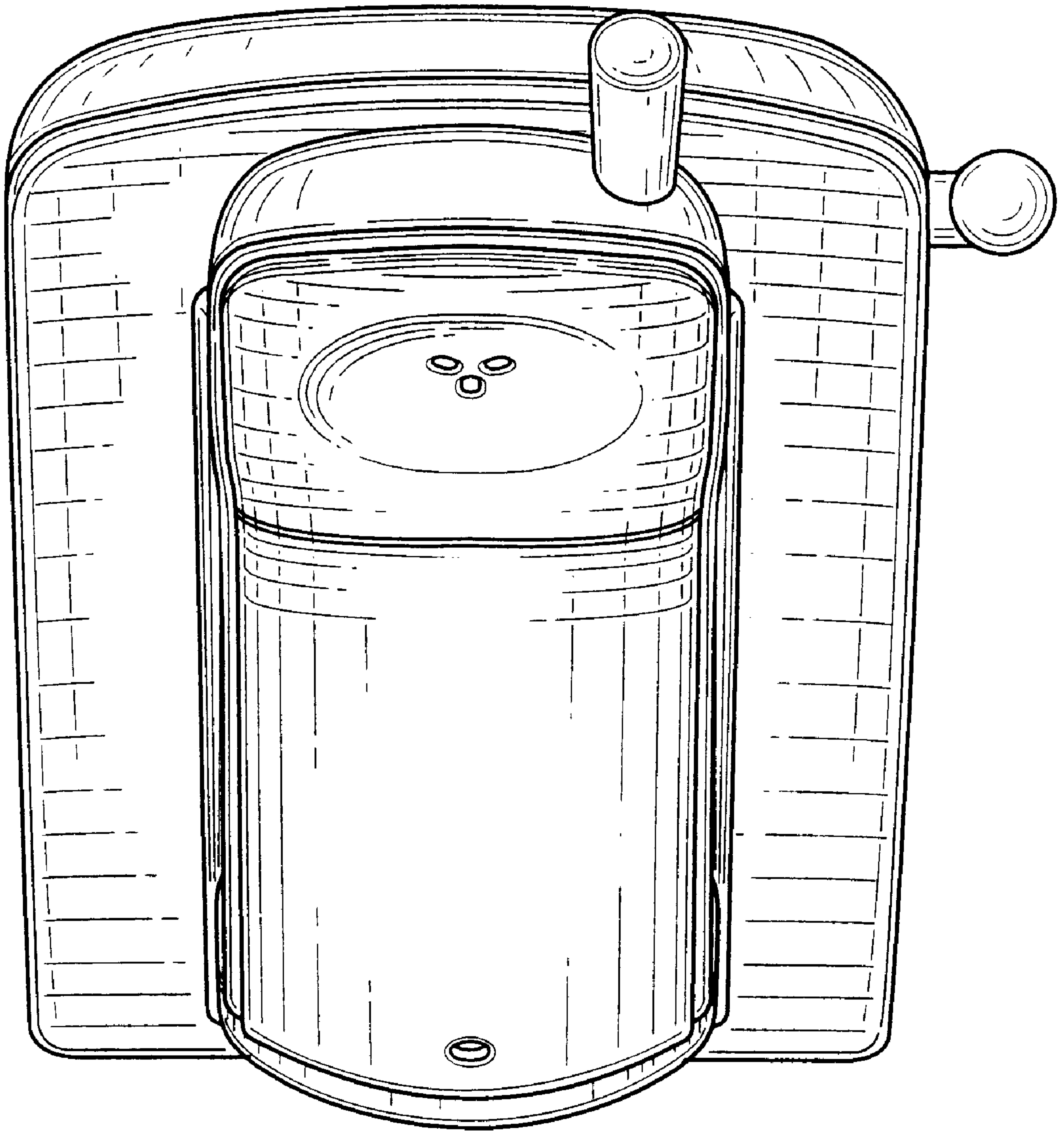

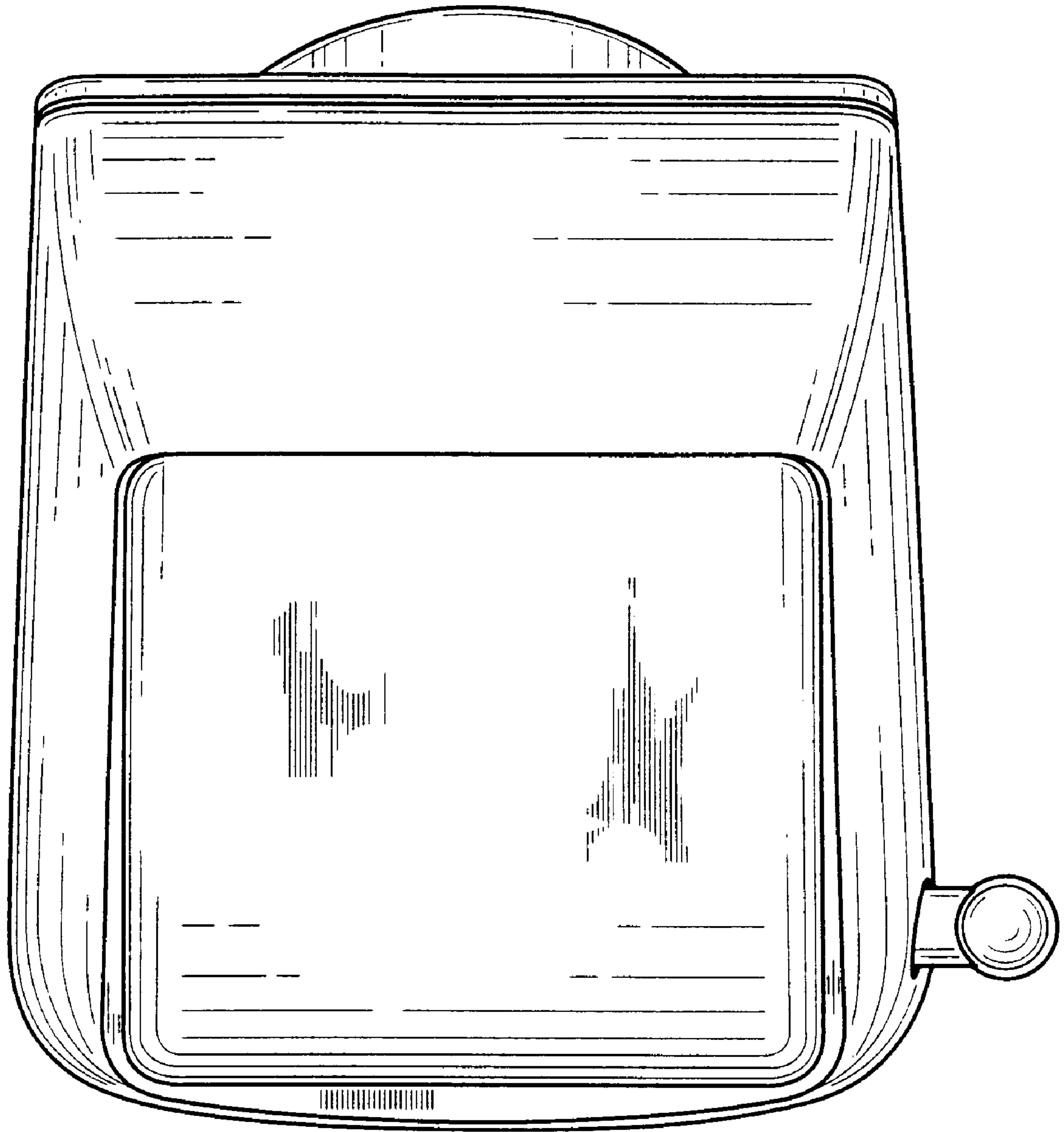

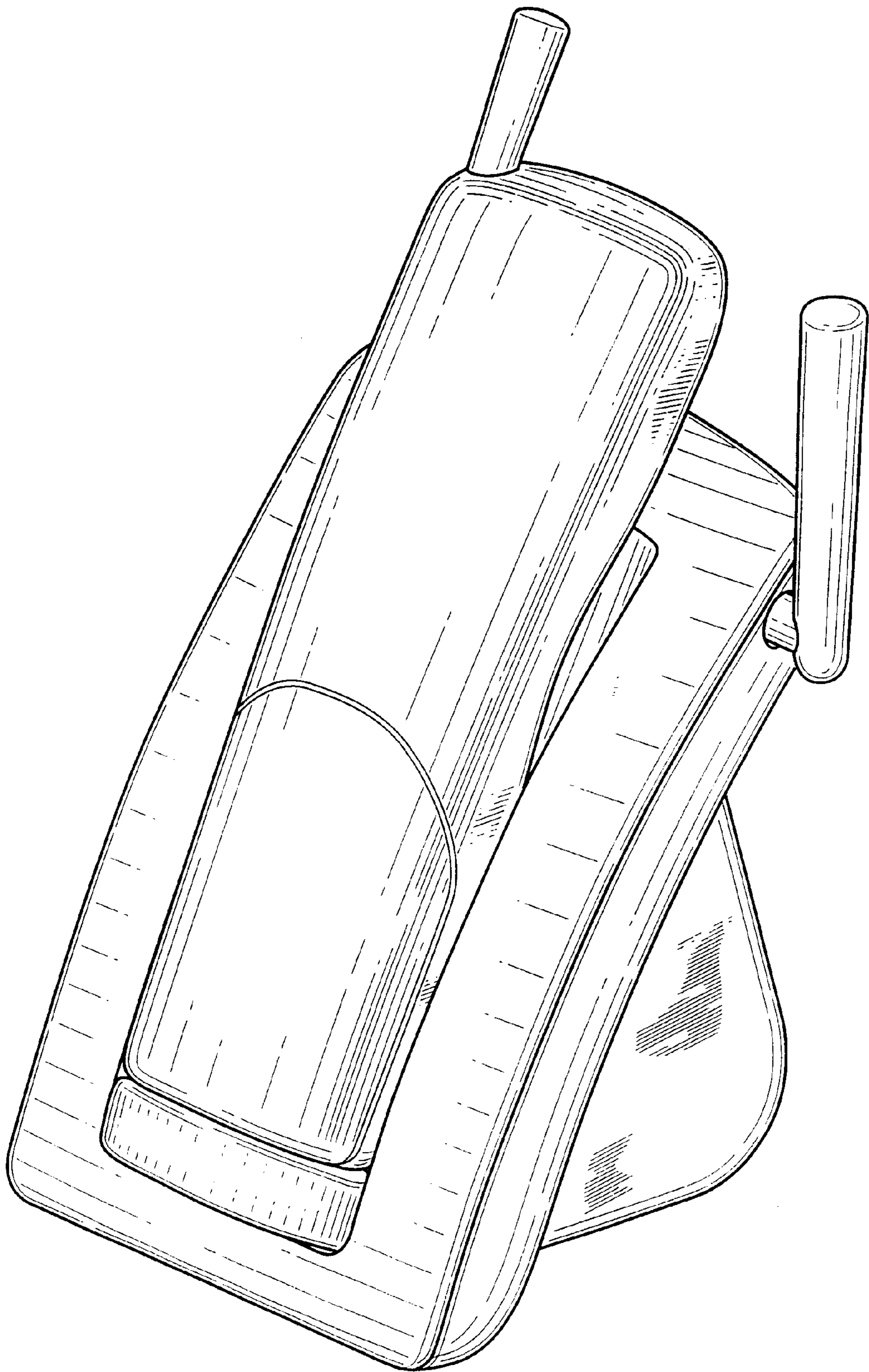

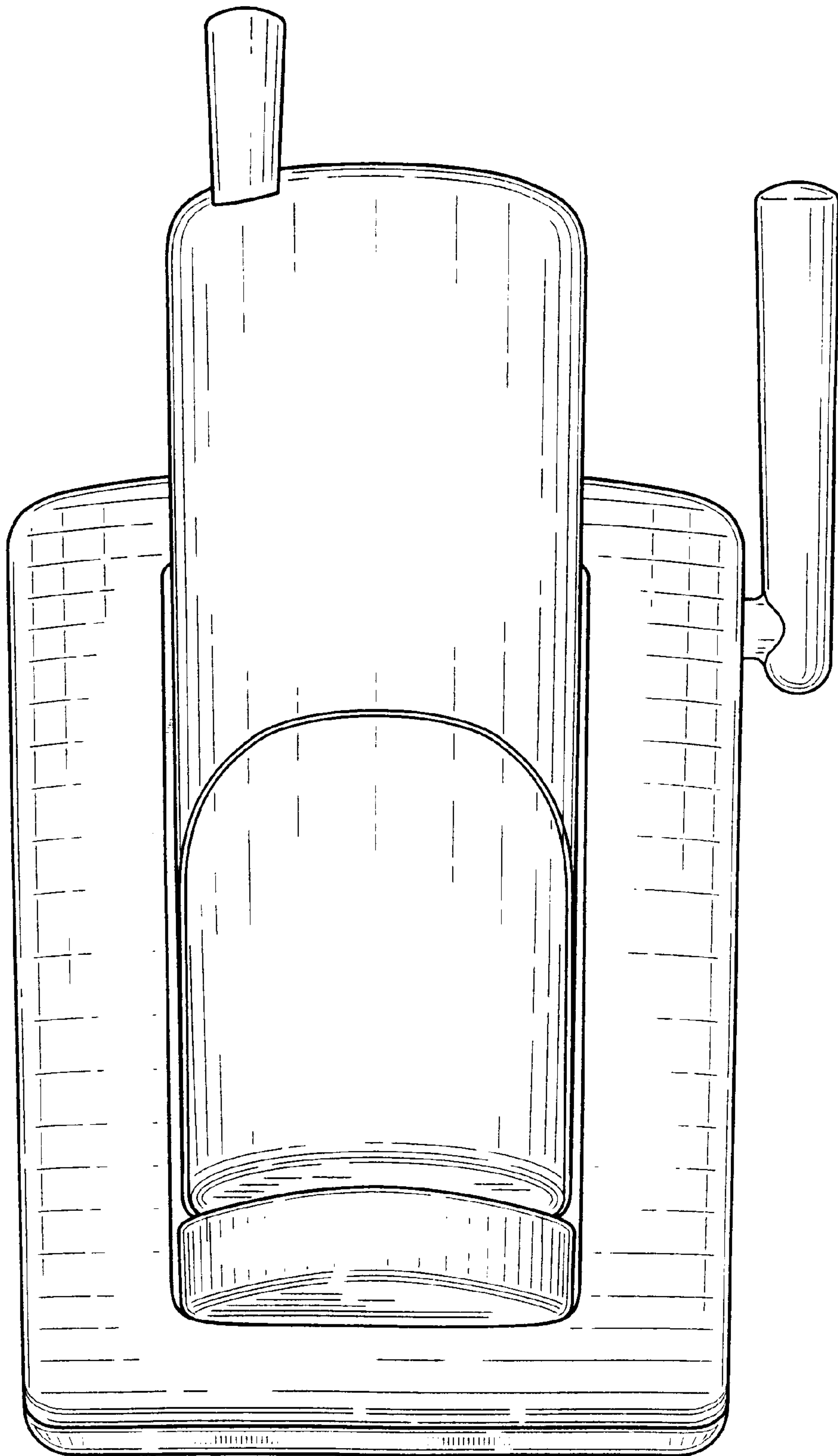

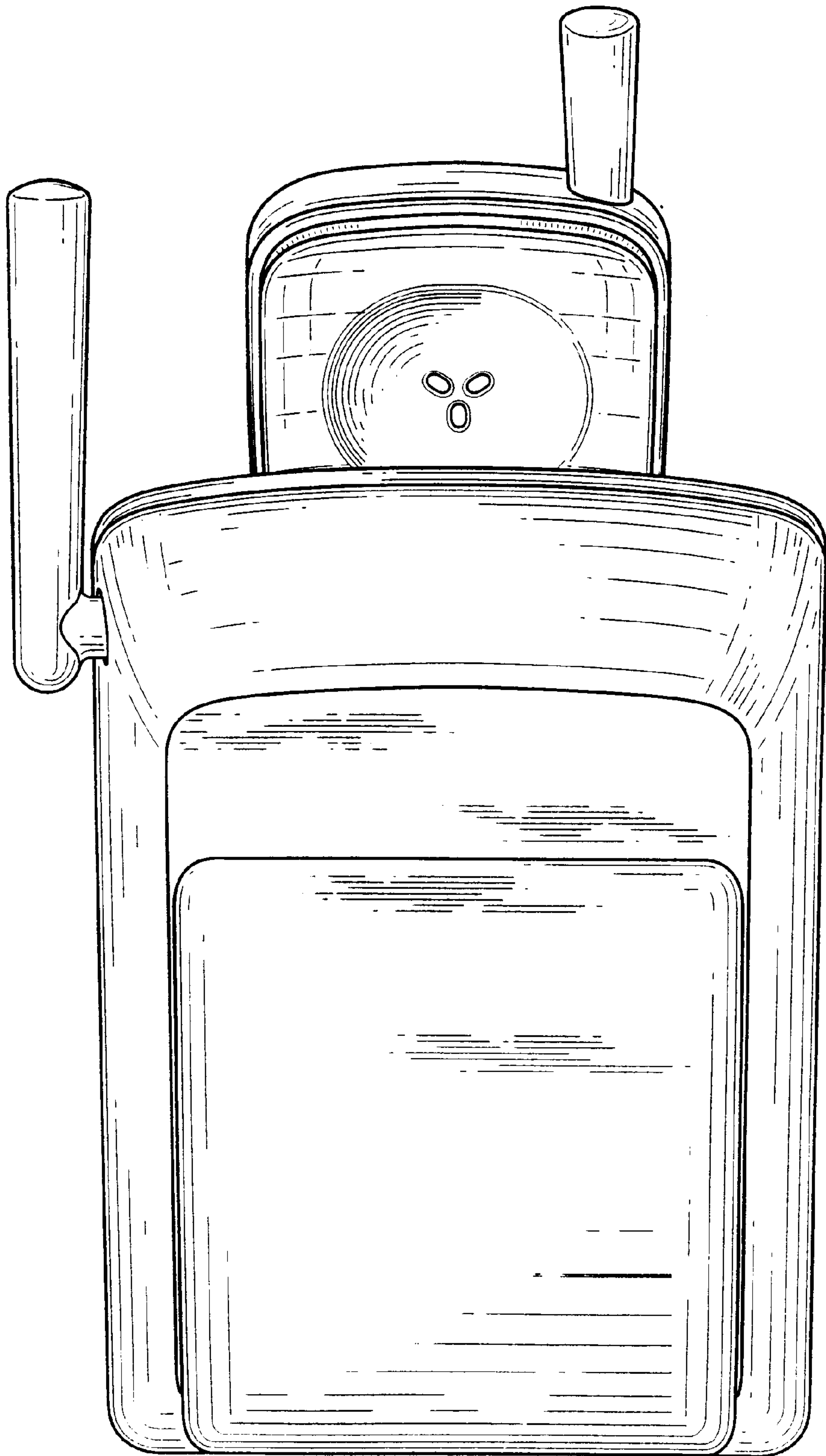

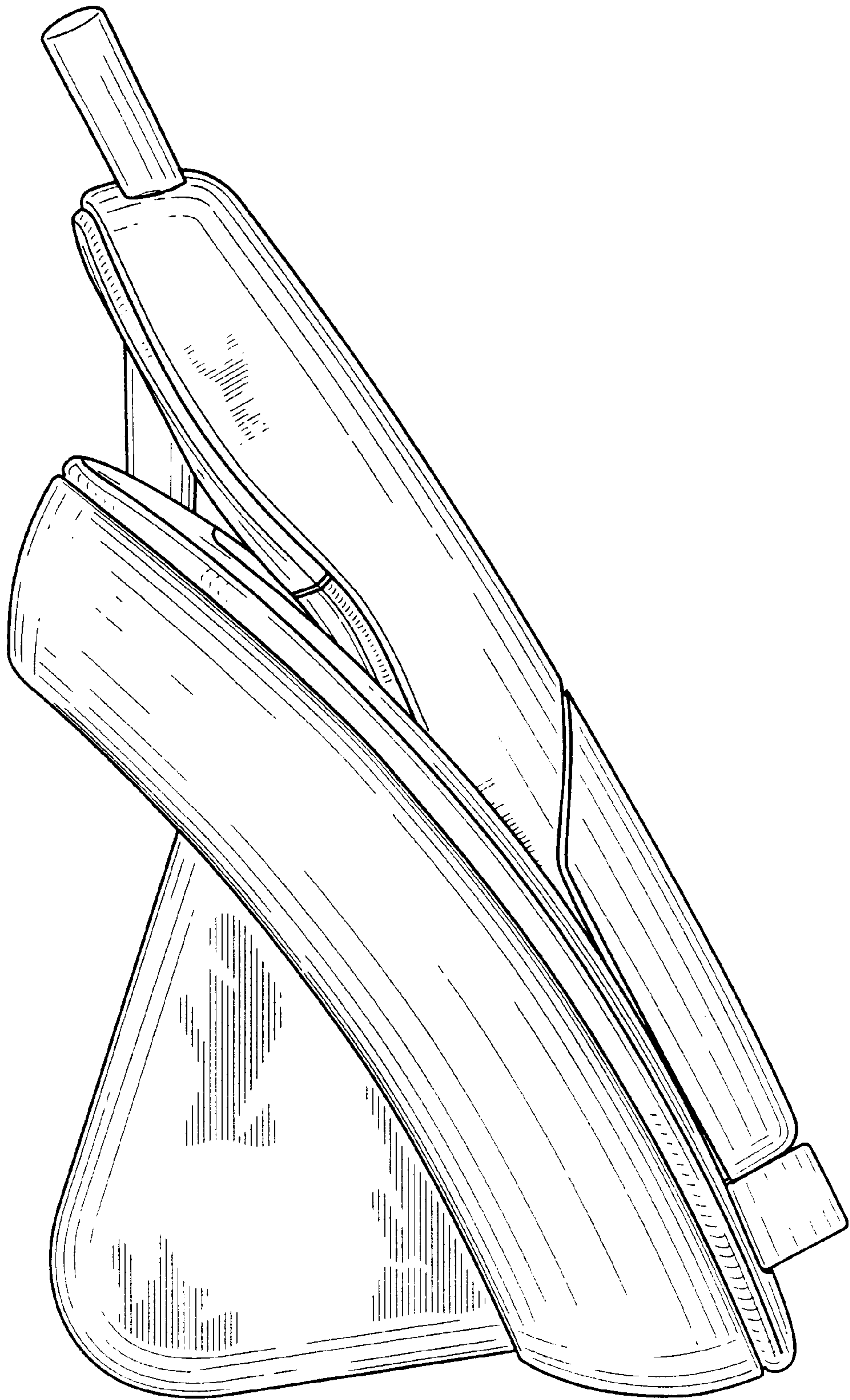

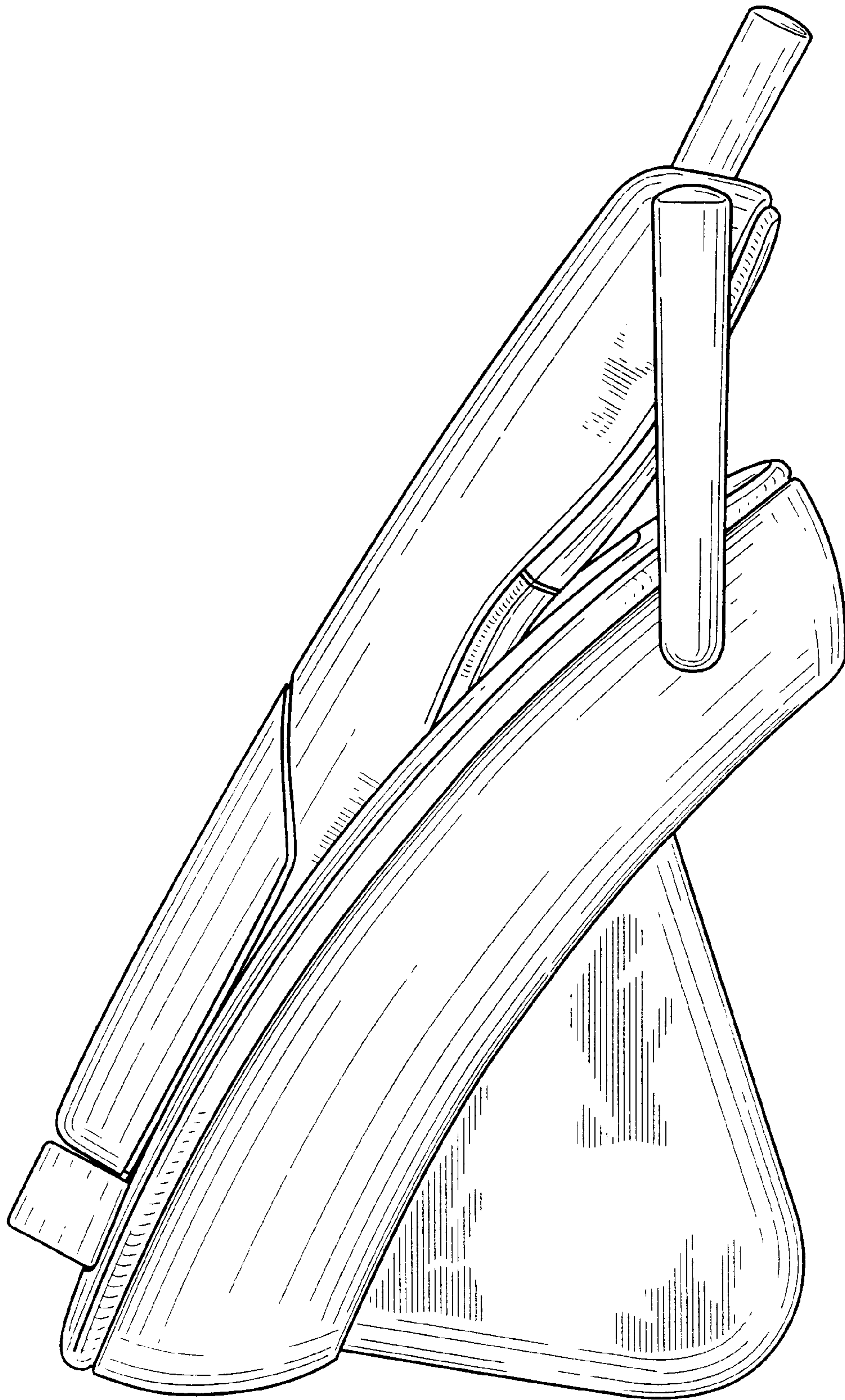

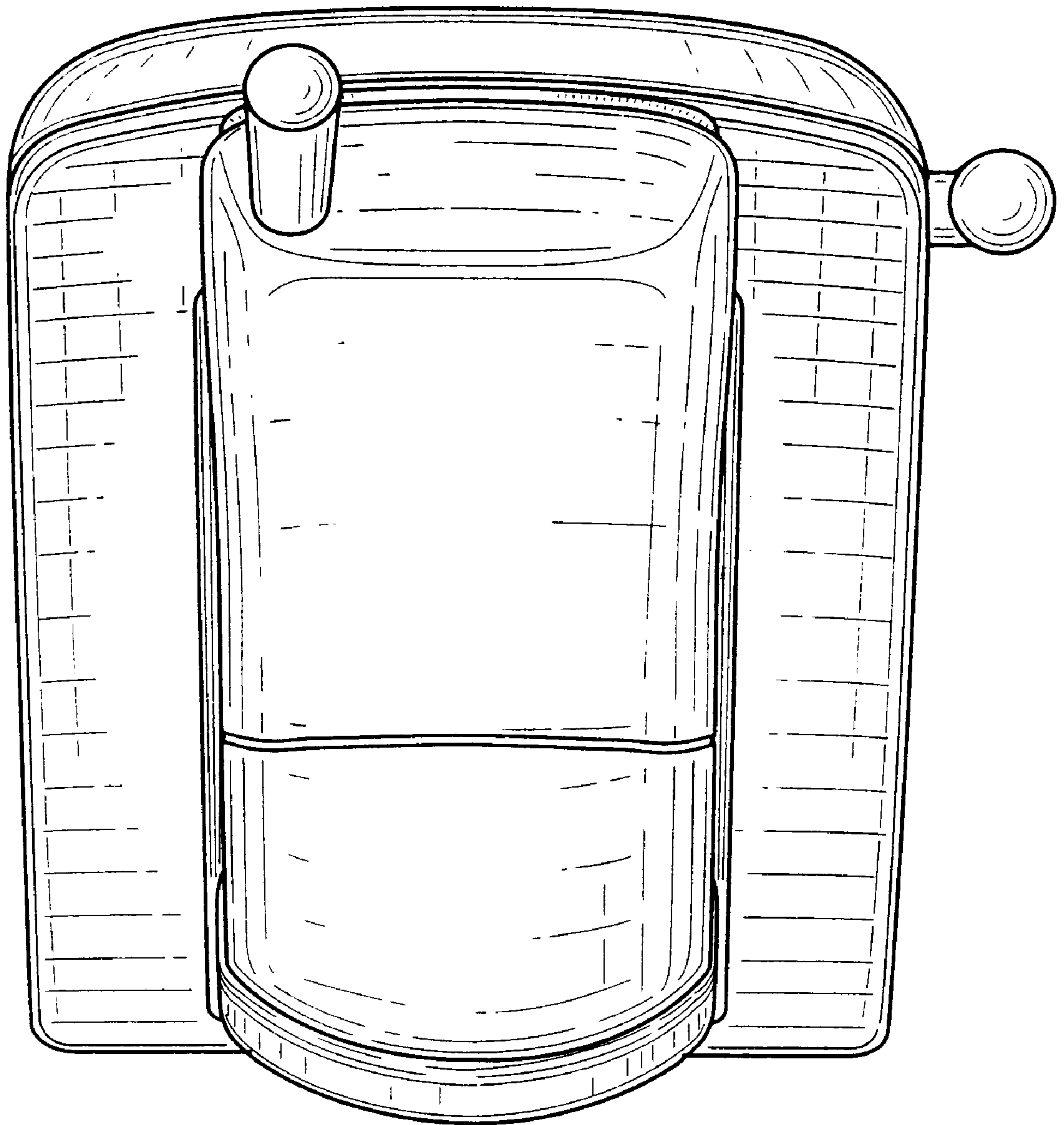

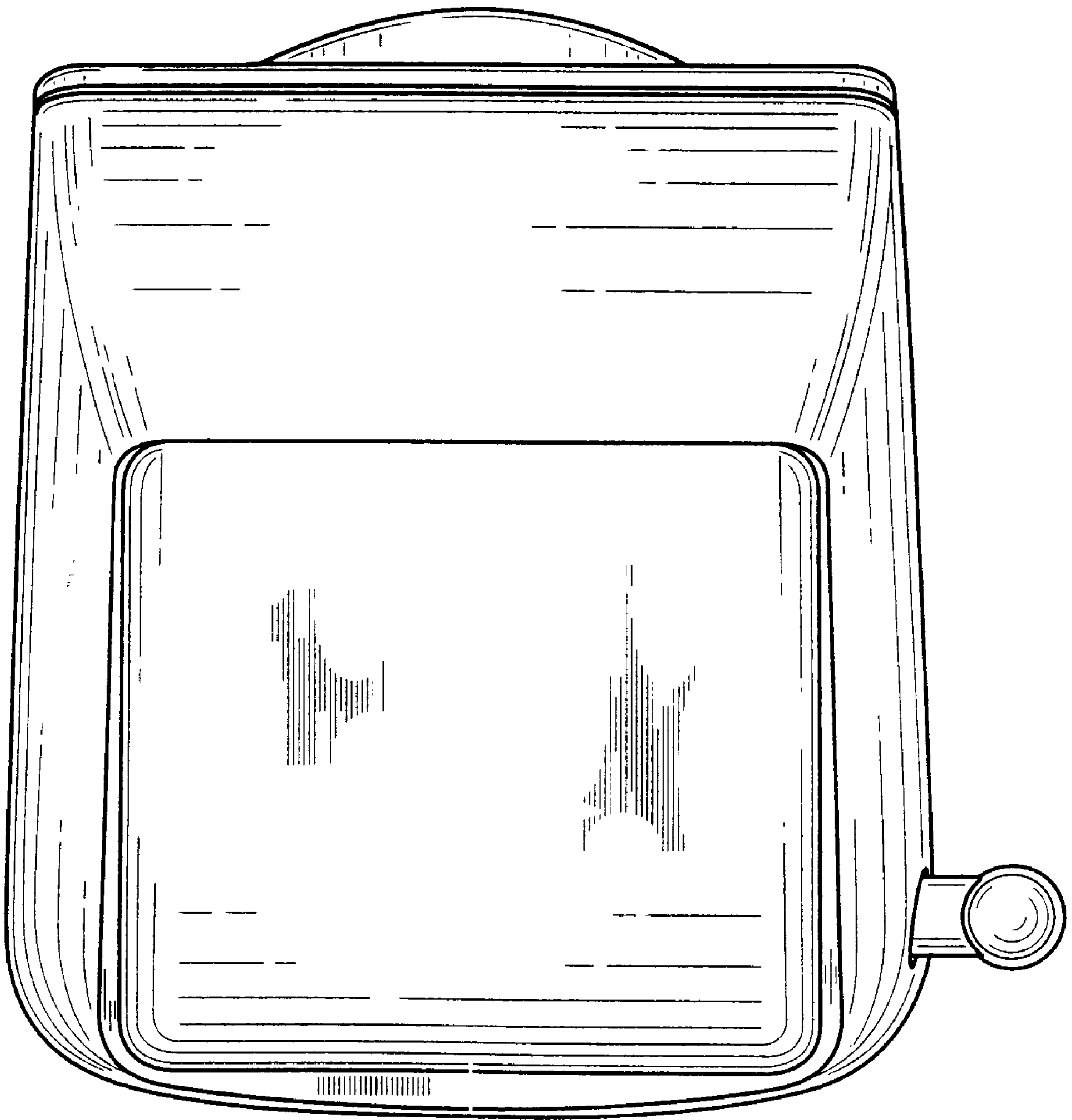

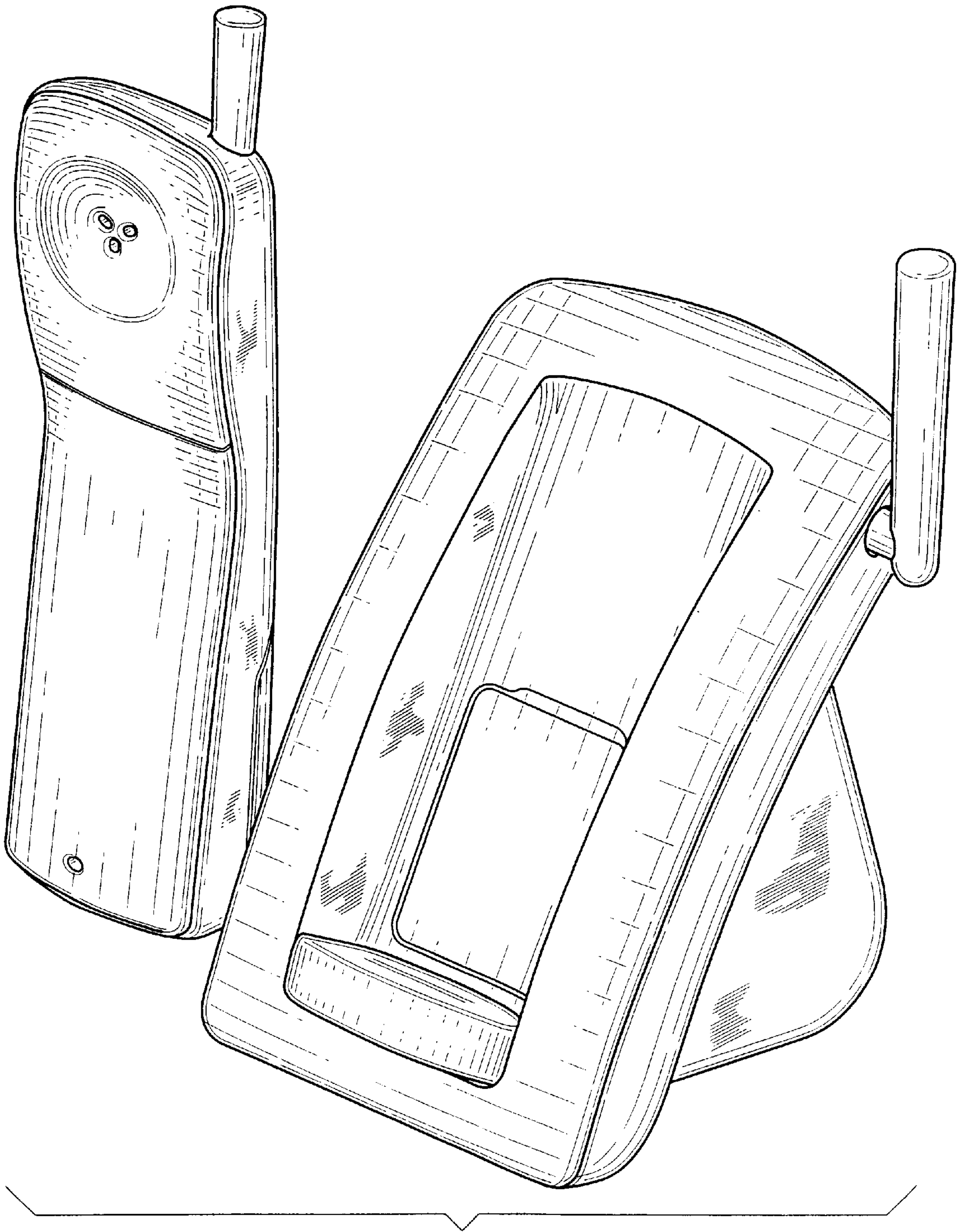

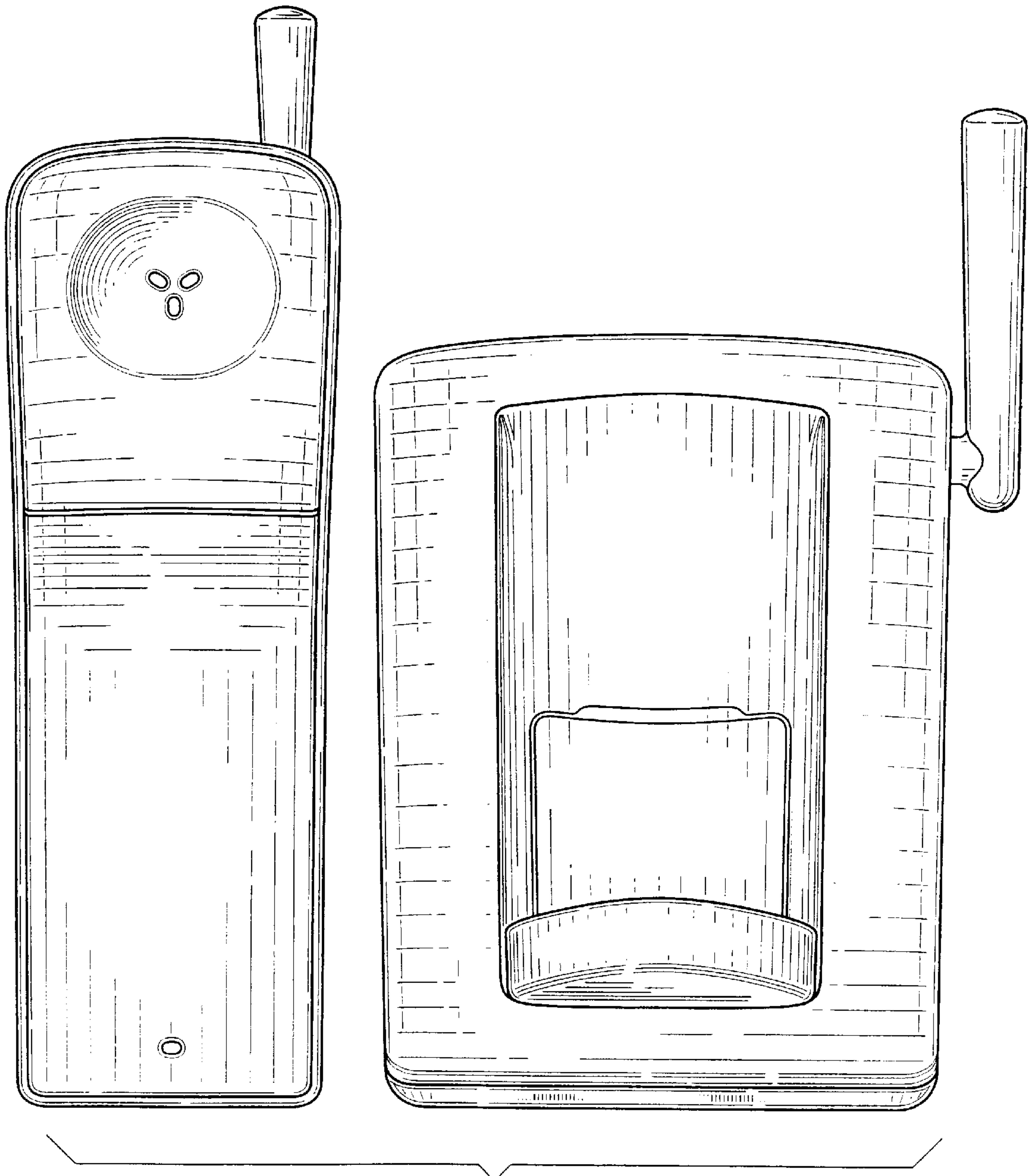

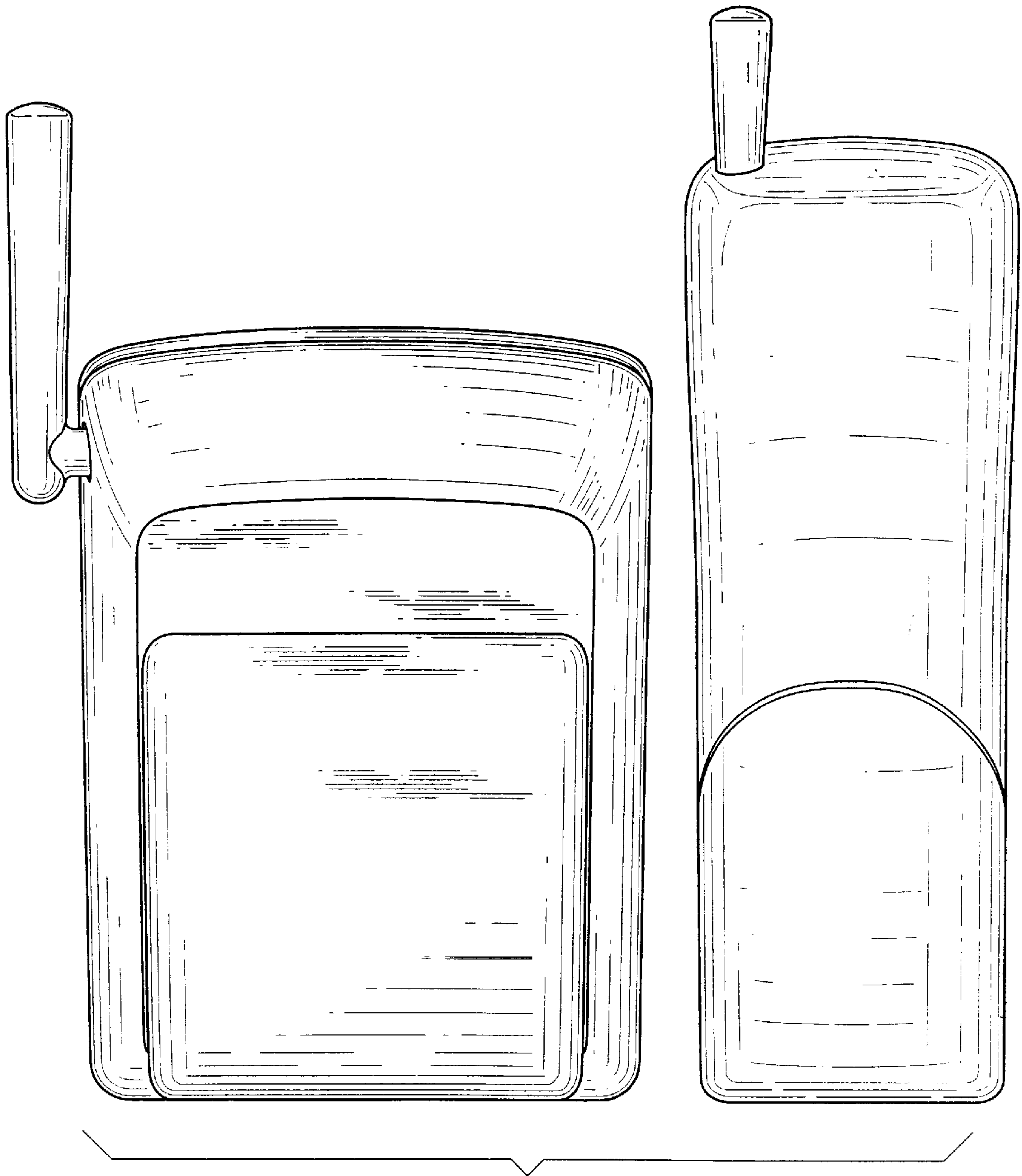

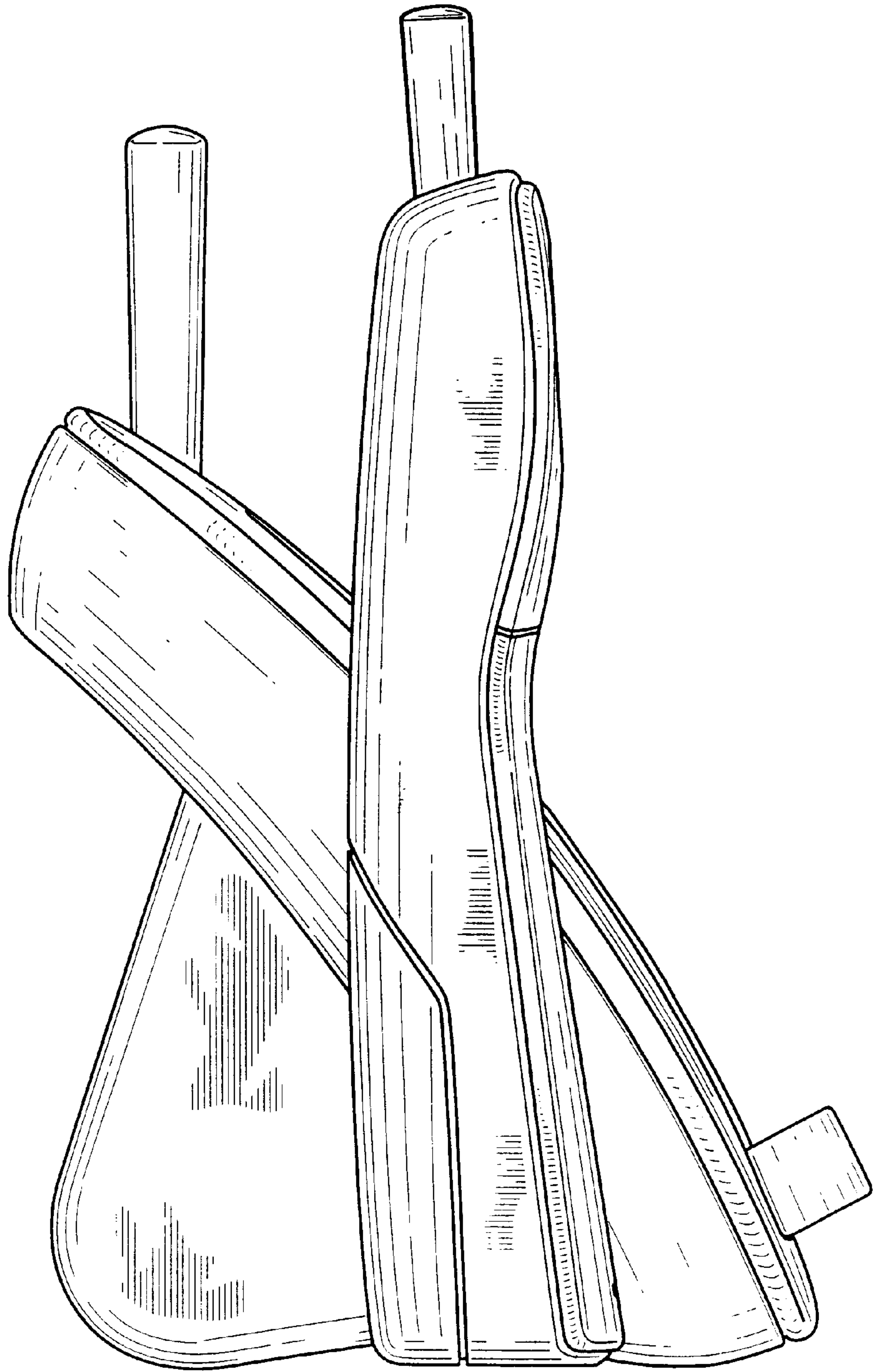

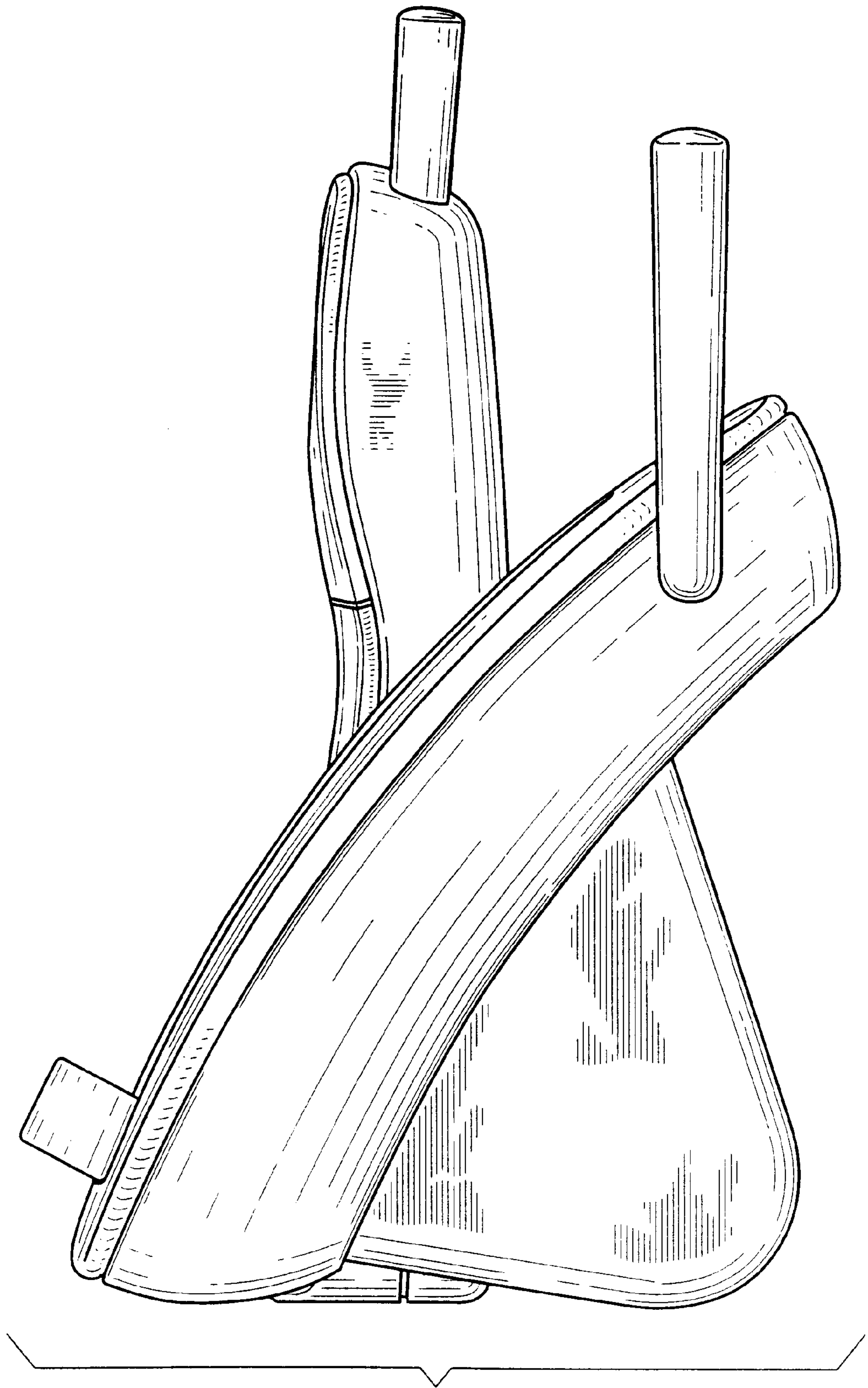

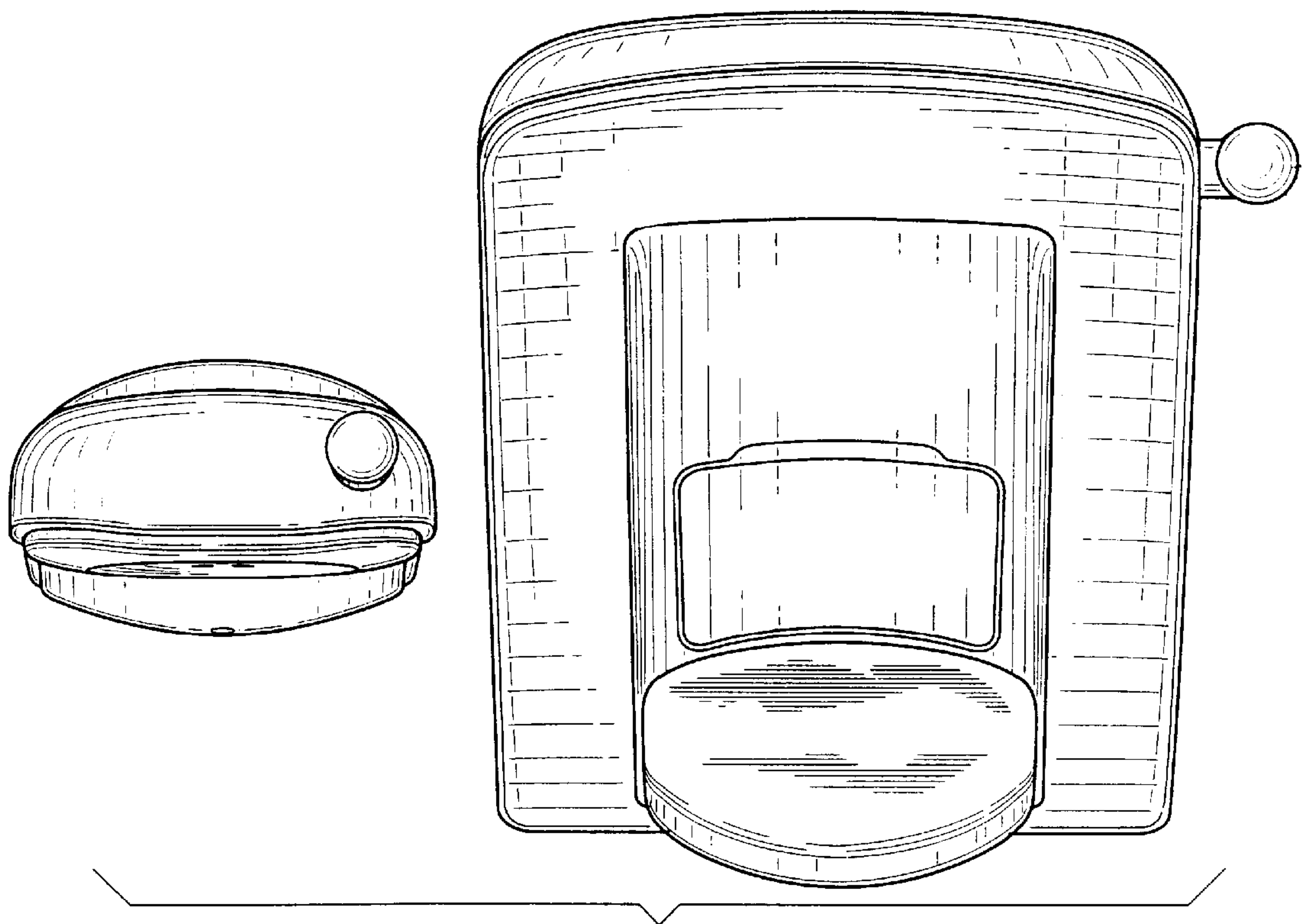

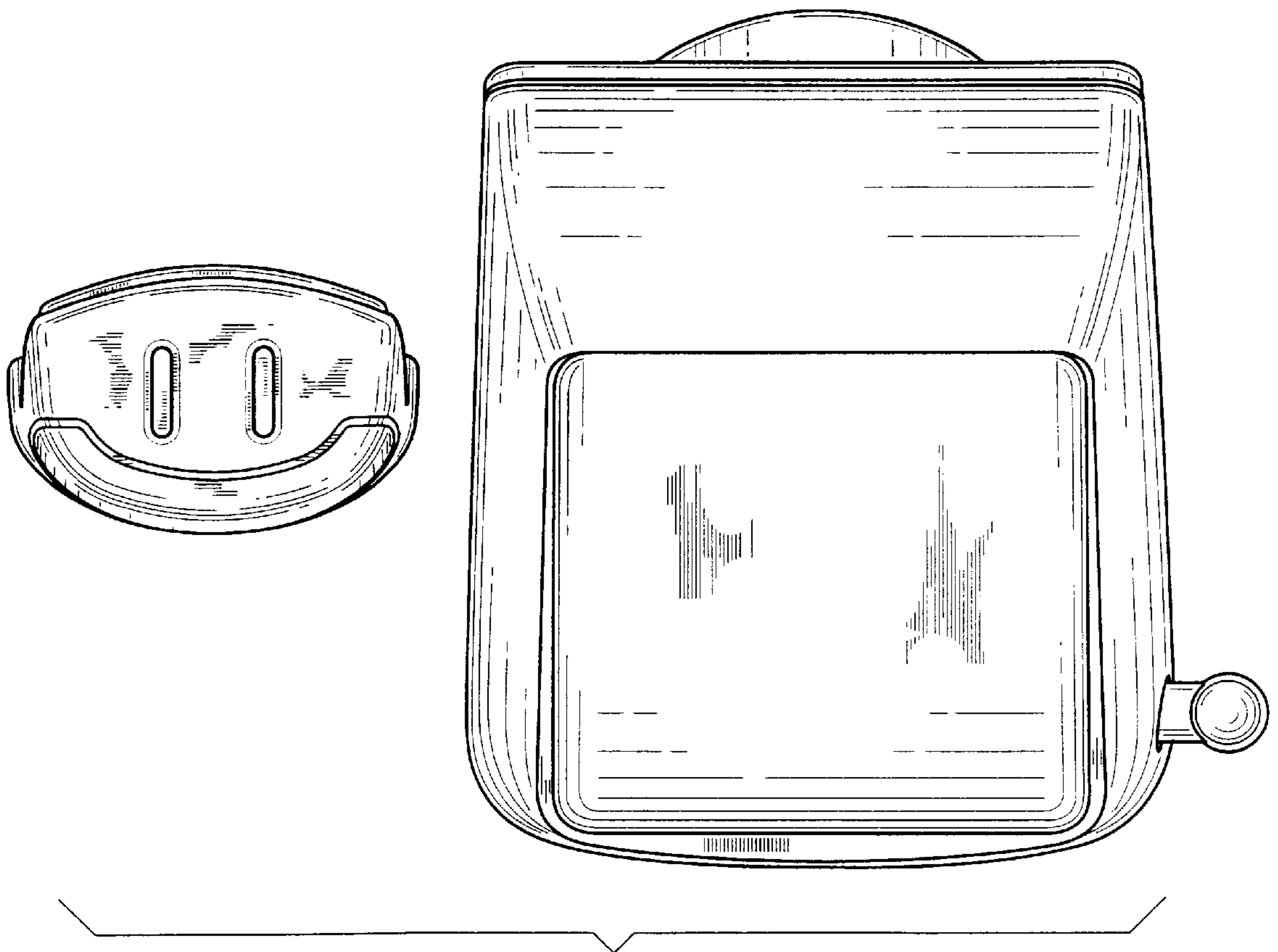
