[57] CLAIM

The ornamental design for a table tennis game machine, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a table tennis game machine; FIG. 2 is a front view of the table tennis game machine; FIG. 3 is a rear view of the table tennis game machine; FIG. 4 is a left side view of the table tennis game machine; FIG. 5 is a right side view of the table tennis game machine; FIG. 6 is a top view of the table tennis game machine; FIG. 7 is a bottom view of the table tennis game machine; FIG. 8 is a sectional view taken along the line 8—8 in FIG. 2; FIG. 9 is a sectional view taken along the line 9—9 in FIG. 2; FIG. 10 is a perspective view for reference of the table tennis game machine with nets removed; FIG. 11 is a front view for reference of the table tennis game machine with nets removed; FIG. 12 is a rear view for reference of the table tennis game machine with nets removed; FIG. 13 is a left side view for reference of the table tennis game machine with nets removed; FIG. 14 is a right side view for reference of the table tennis game machine with nets removed; FIG. 15 is a top view for reference of the table tennis game machine with nets removed; FIG. 16 is a bottom view for reference of the table tennis game machine with nets removed; FIG. 17 is a sectional view for reference of the table tennis game machine with nets removed, taken along line 17—17 in FIG. 17; and, FIG. 18 is a sectional view for reference with nets removed, taken along the line 18—18 in FIG. 18.































