[57] **CLAIM**

The ornamental design for a golf club holder, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a golf club holder, the undisclosed rear being plain and unornamented.

FIG. 2 is an edge view of the golf club holder of FIG. 1 as seen from the right side the undisclosed left side being a mirror image.

FIG. 3 is an edge view of the golf club holder of FIG. 1 as seen from the top side.

FIG. 4 is a front view of a second embodiment of the golf club holder as disclosed in FIG. 1, the undisclosed rear being plain and unornamented.

FIG. 5 is an edge view of the golf club holder of FIG. 4 as seen from the right side the undisclosed left side being a mirror image.

FIG. 6 is an edge view of the golf club holder of FIG. 4 as seen from the top side.

FIG. 7 is a front view of a third embodiment of the golf club holder as disclosed in FIG. 1, the undisclosed rear being plain and unornamented.

FIG. 8 is an edge view of the golf club holder of FIG. 7 as seen from the right side the undisclosed left side being a mirror image.

FIG. 9 is an edge view of the golf club holder of FIG. 7 as seen from the top side.

FIG. 10 is a front view of a fourth embodiment of the golf club holder as disclosed in FIG. 1, the disclosed rear being plain and unornamented.

FIG. 11 is an edge view of the golf club holder of FIG. 10 as seen from the right side the undisclosed left side being a mirror image.

FIG. 12 is an edge view of the golf club holder of FIG. 10 as seen from the top side.

FIG. 13 is a front view of a fifth embodiment of the golf club holder as disclosed in FIG. 1, the undisclosed rear being plain and unornamented.

FIG. 14 is an edge view of the golf club holder of FIG. 13 as seen from the right side the undisclosed left side being a mirror image.

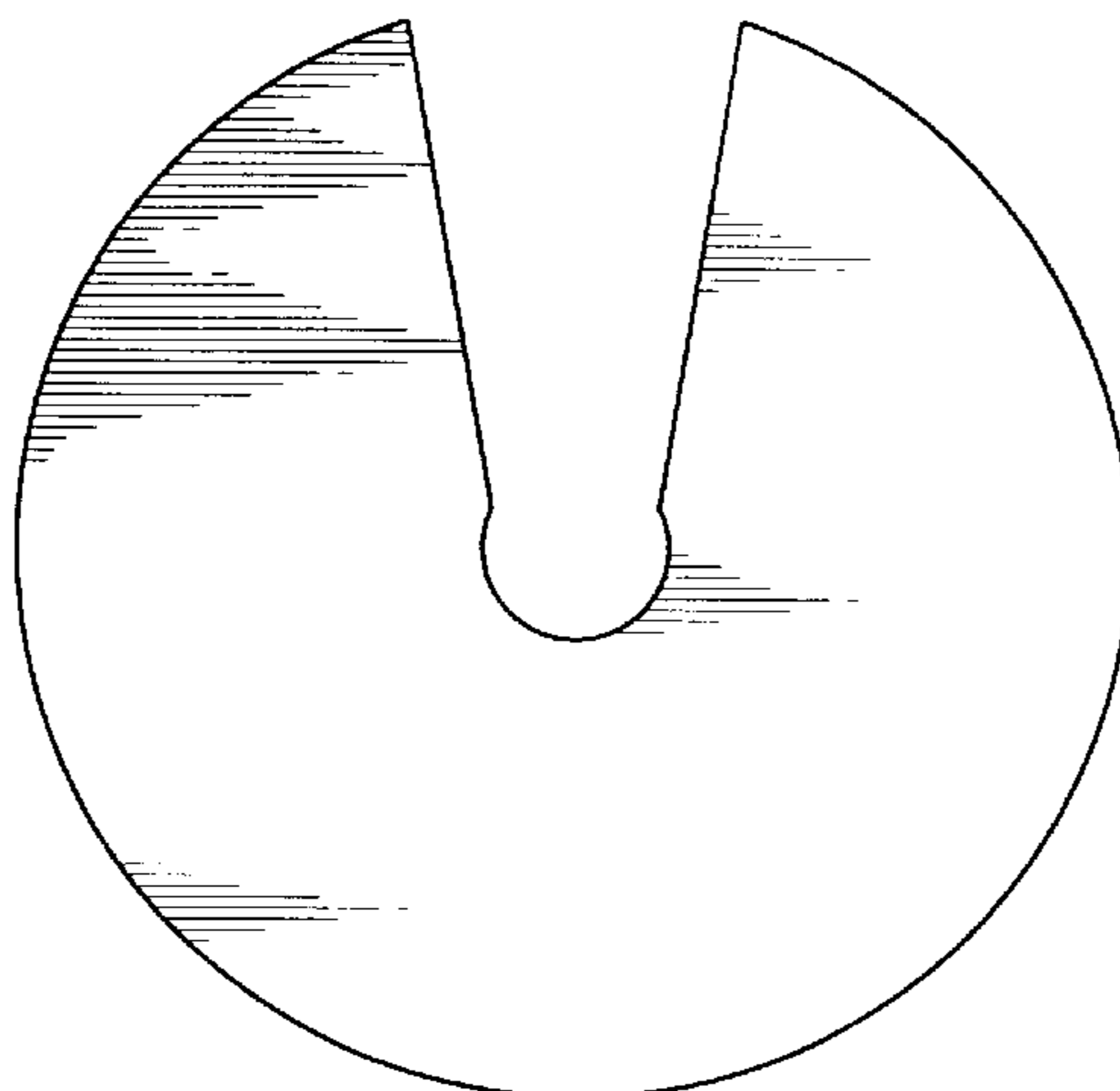
FIG. 15 is an edge view of the golf club holder of FIG. 13 as seen from the top side.

FIG. 16 is a front view of a sixth embodiment of the golf club holder as disclosed in FIG. 1, the undisclosed rear being plain and unornamented.

FIG. 18 is an edge view of the golf club holder of FIG. 16 as seen from the top side.

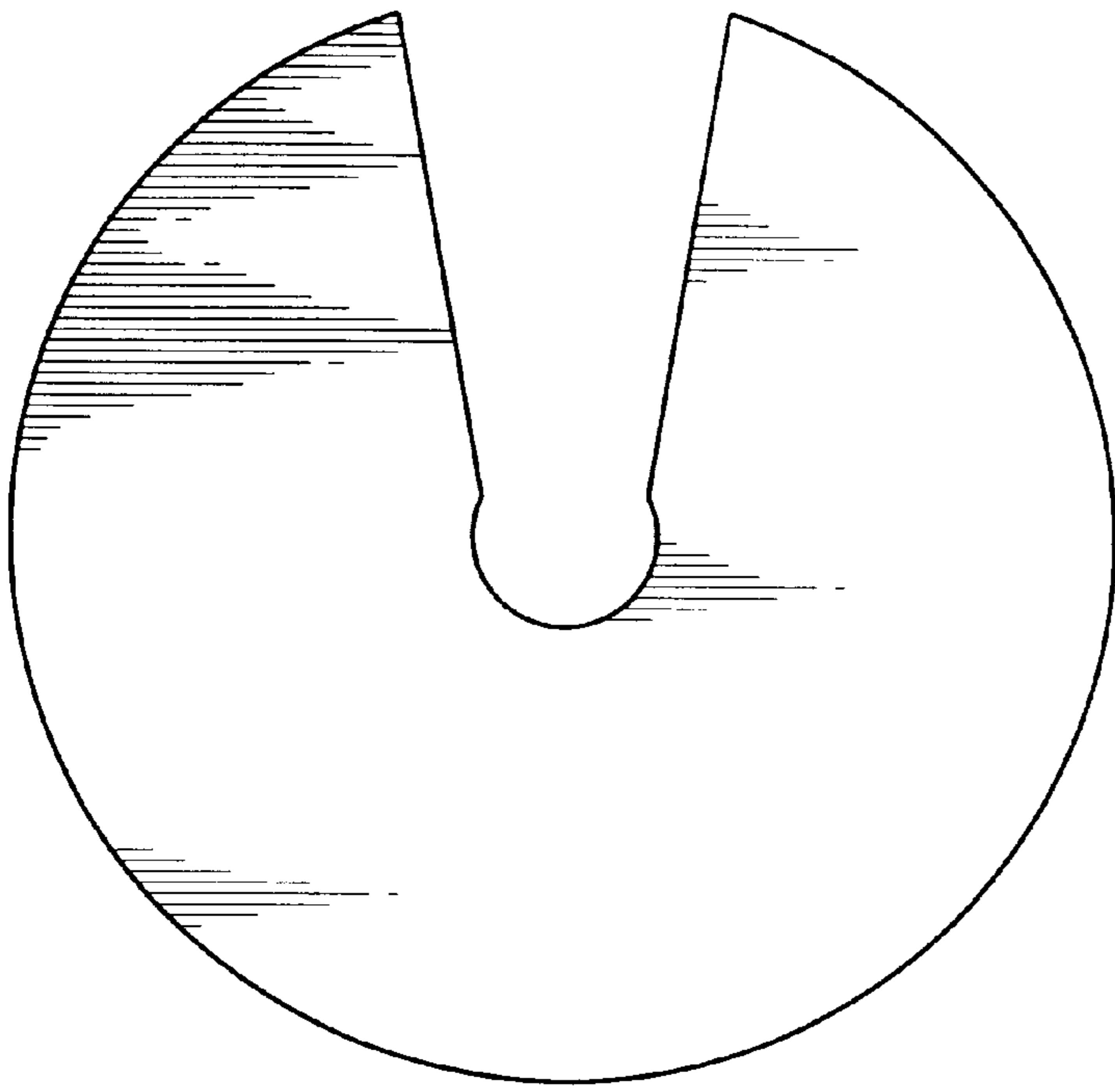

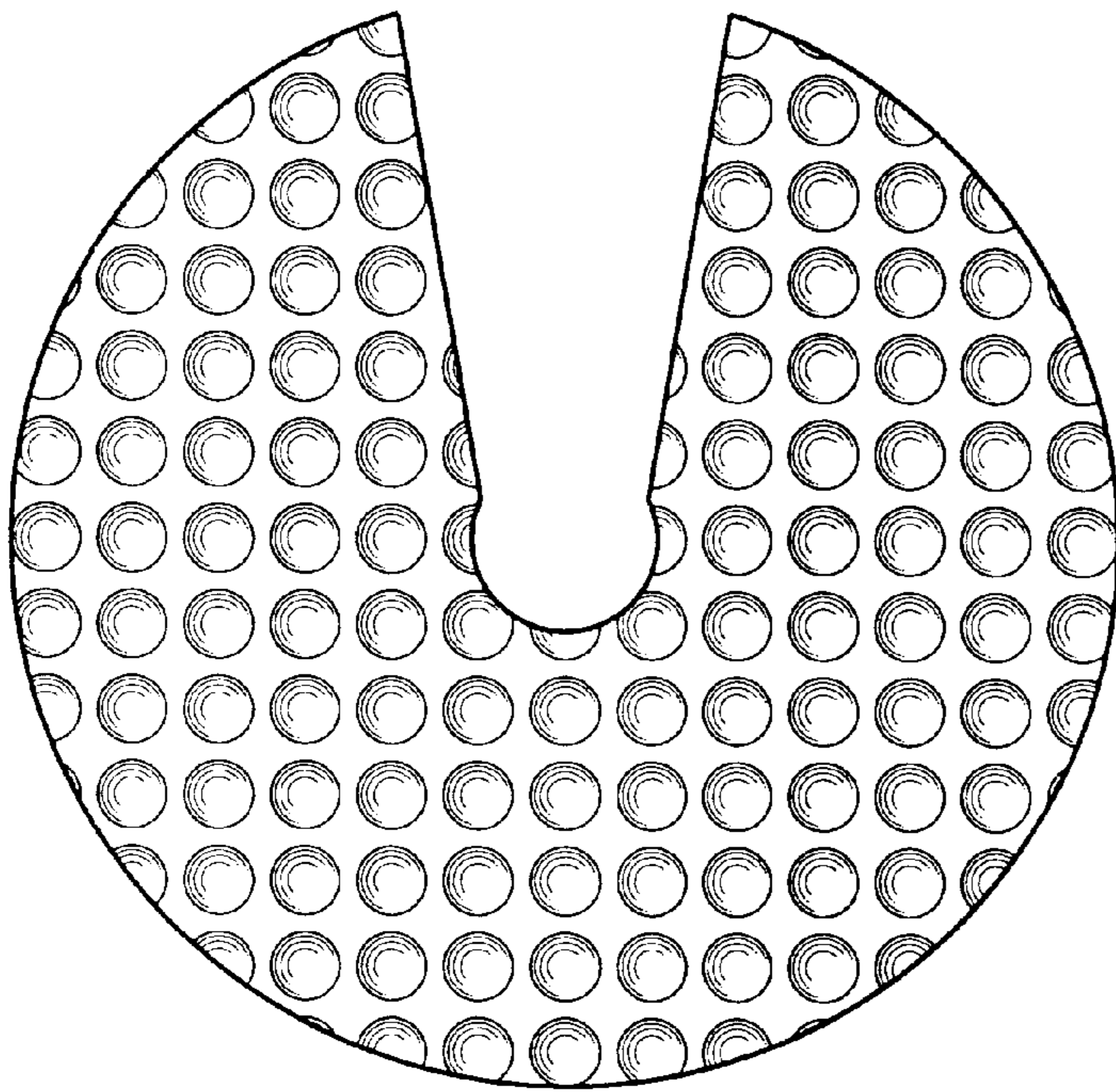

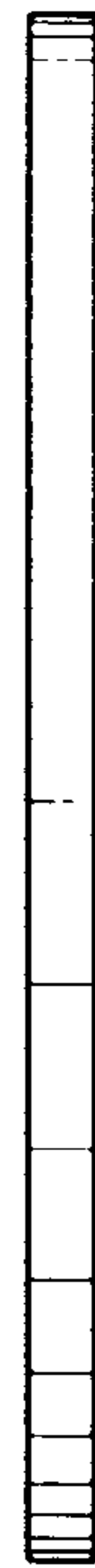

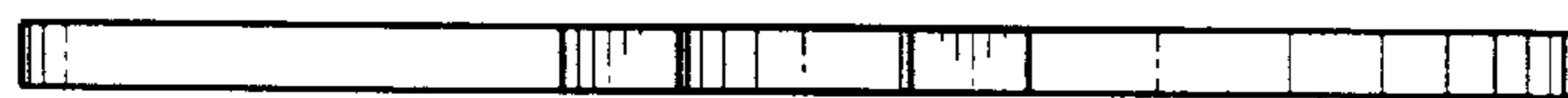

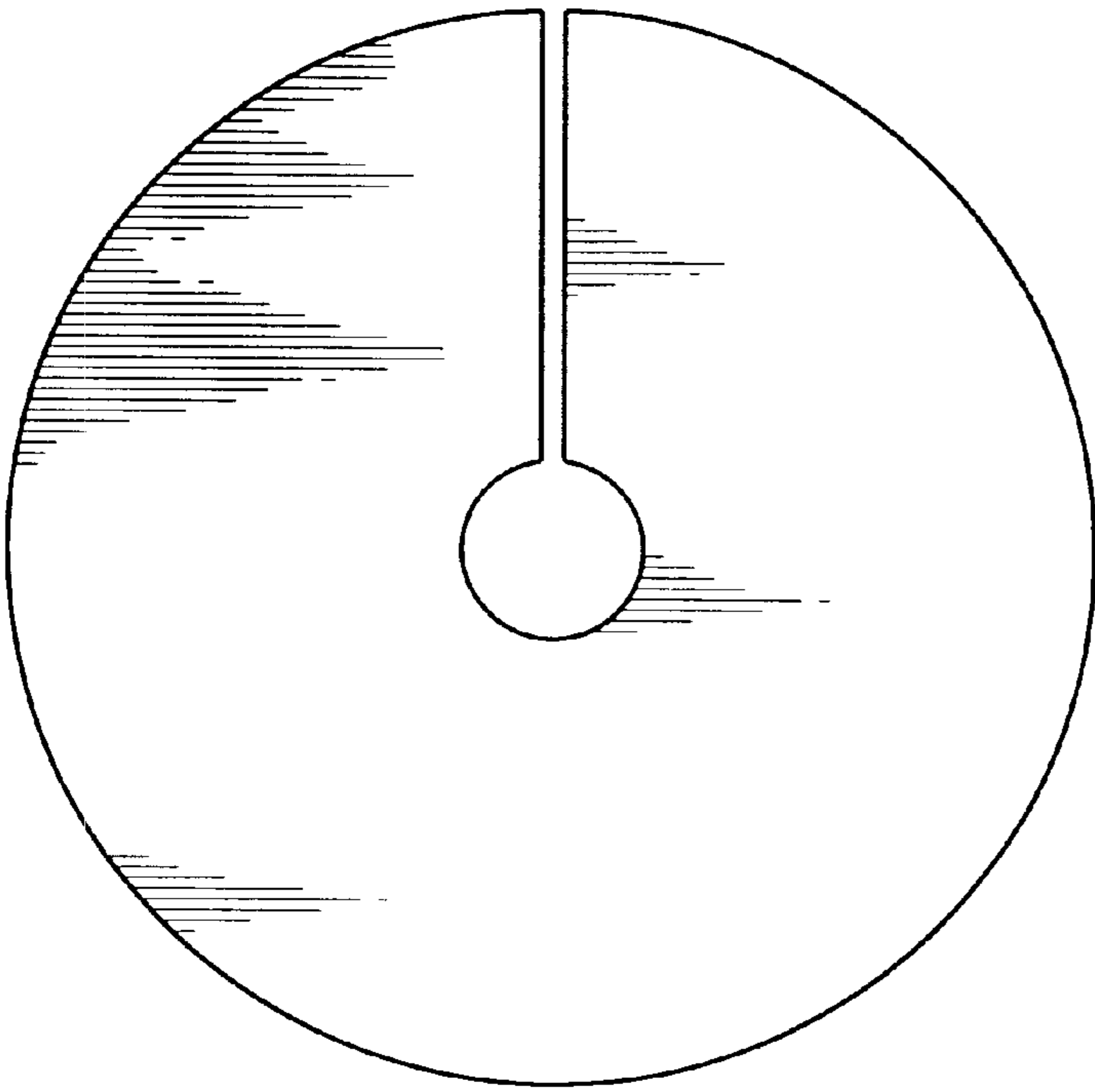

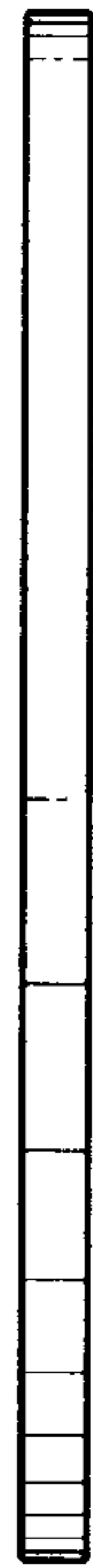

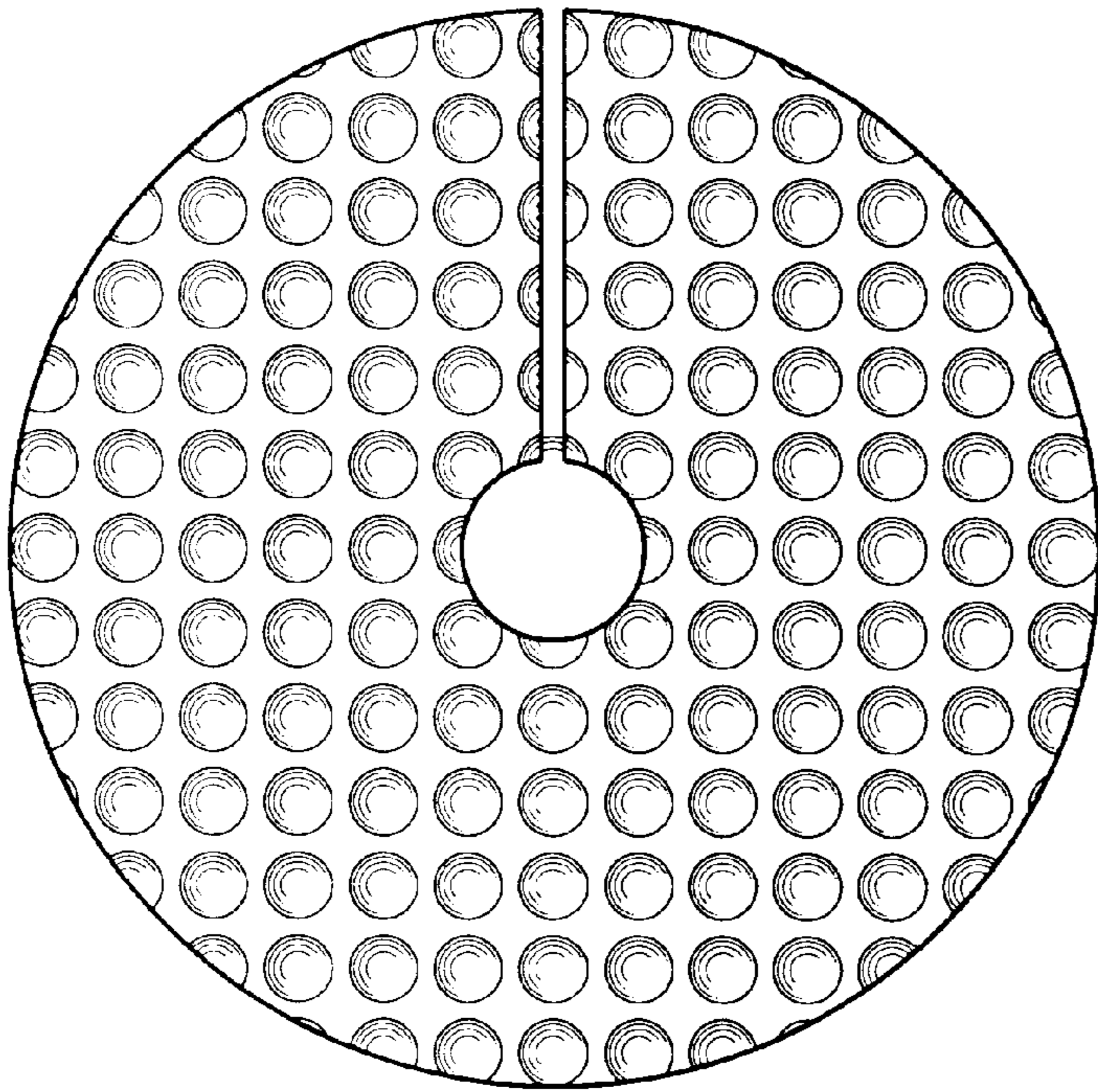

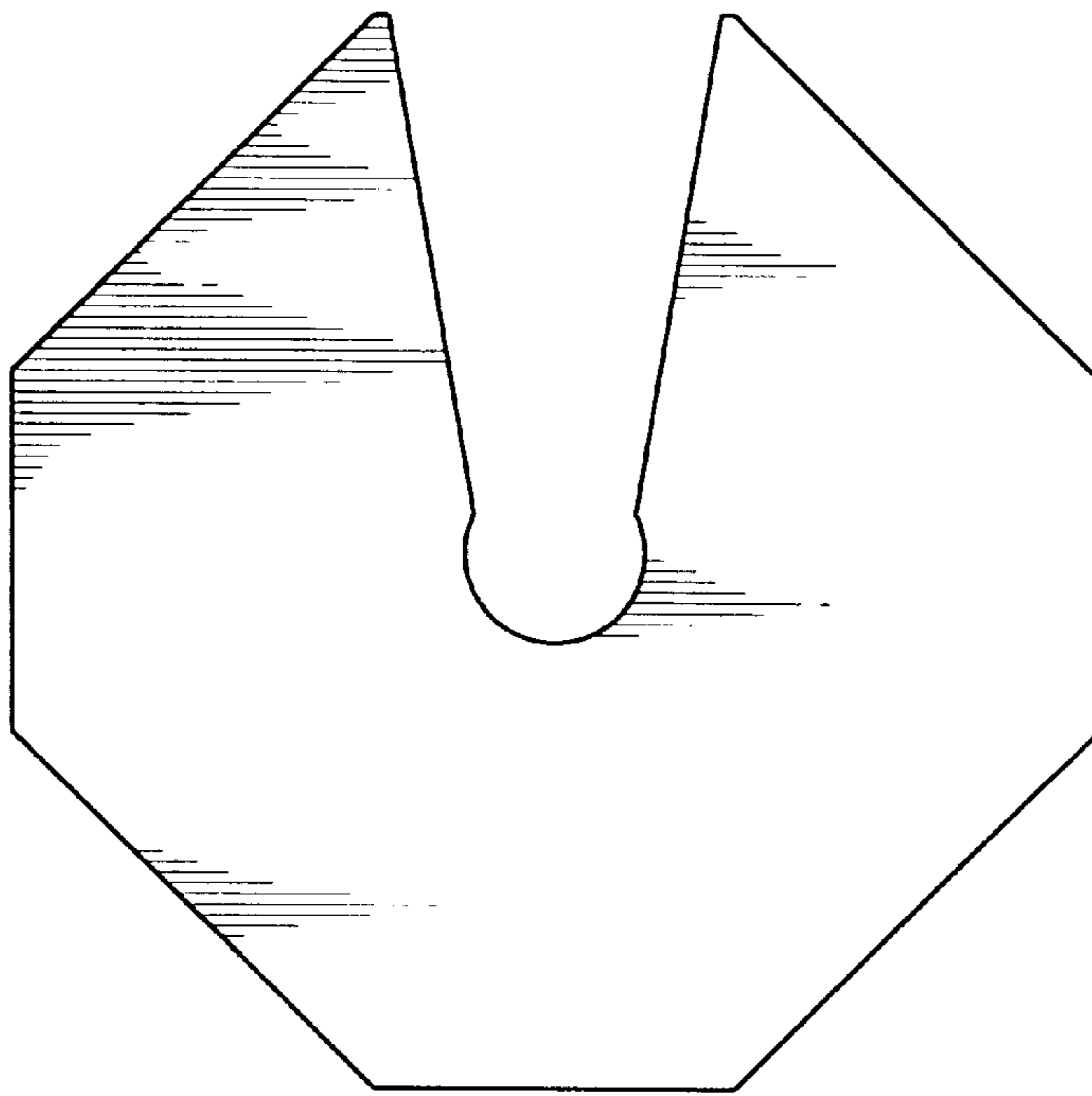

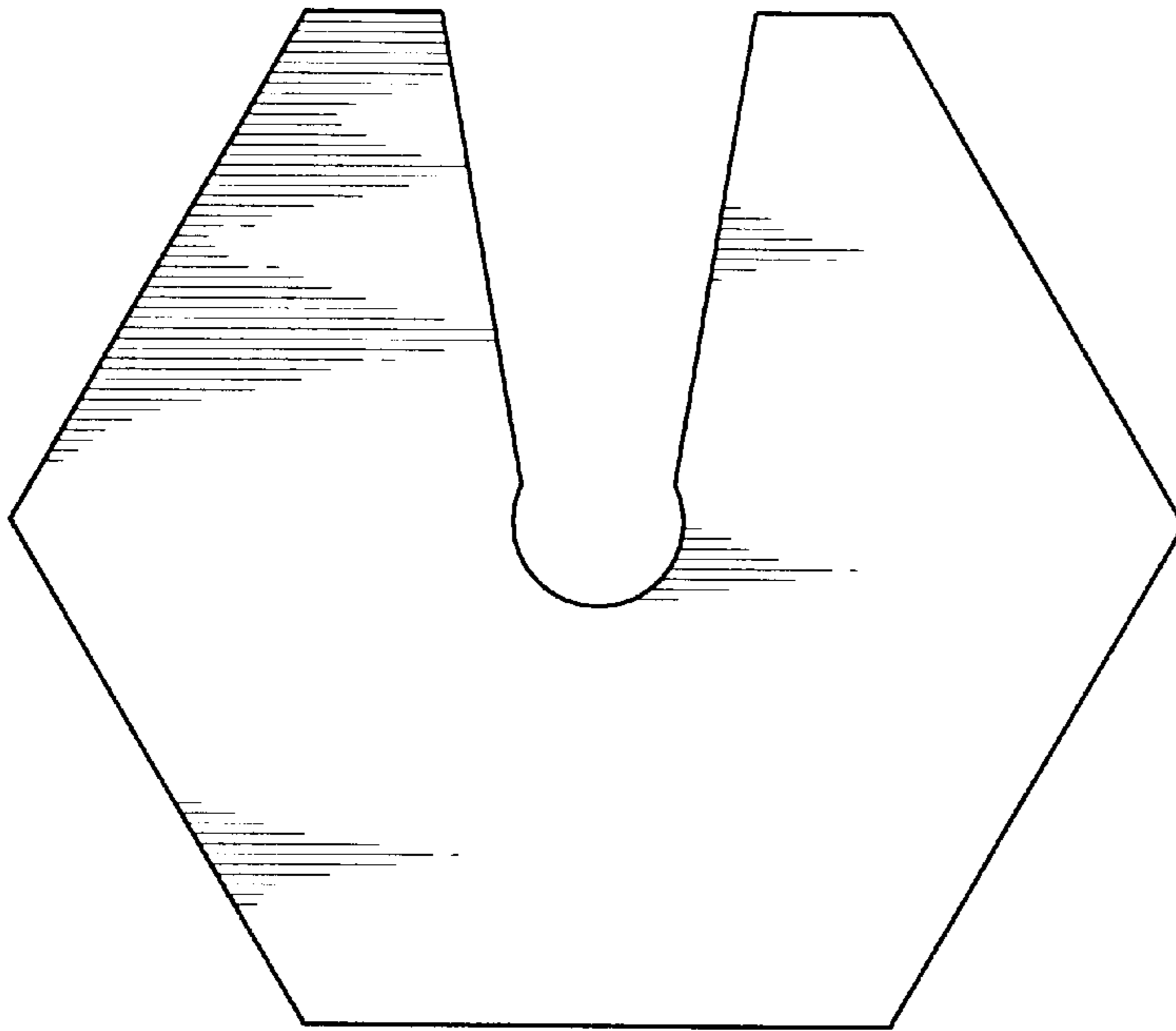

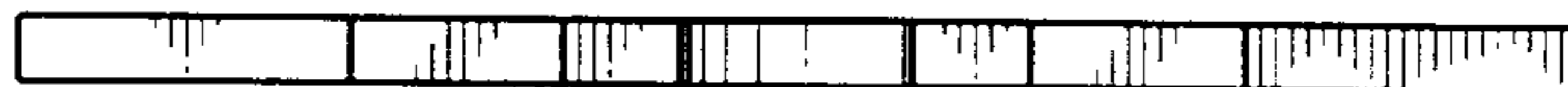
