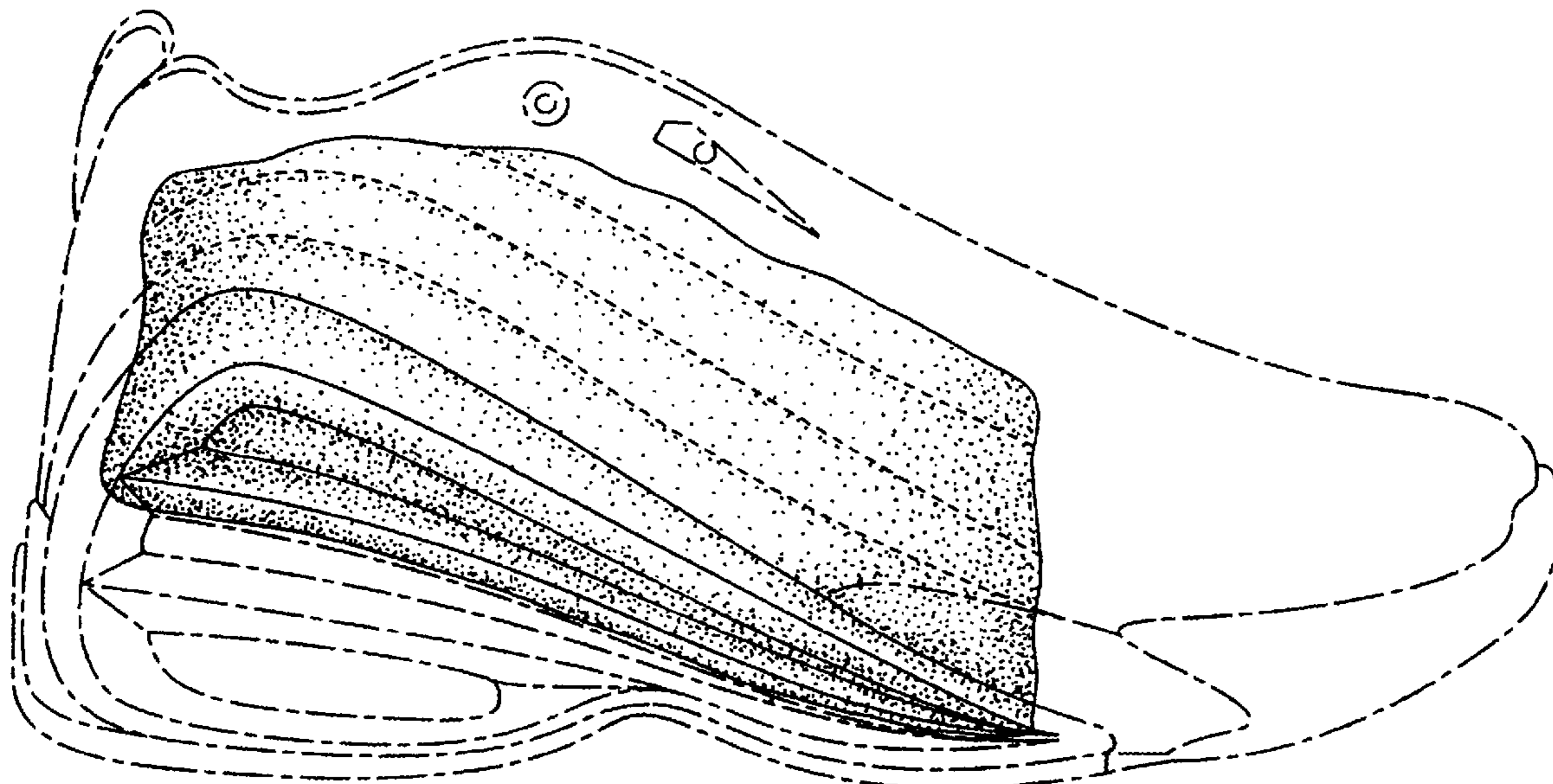
[57] **CLAIM**
The ornamental design for a portion of a shoe upper, as shown and described.

DESCRIPTION
FIG. 1 is a frontal perspective view of a portion of a shoe upper showing my new design;
FIG. 2 is a rear perspective view thereof;
FIG. 3 is a side elevational view thereof; and,
FIG. 4 is a top plan view thereof.

The uneven broken line showing of the partial panel in the forward area and the remainder of the shoe is for illustrative purposes only and forms no part of the claimed design.

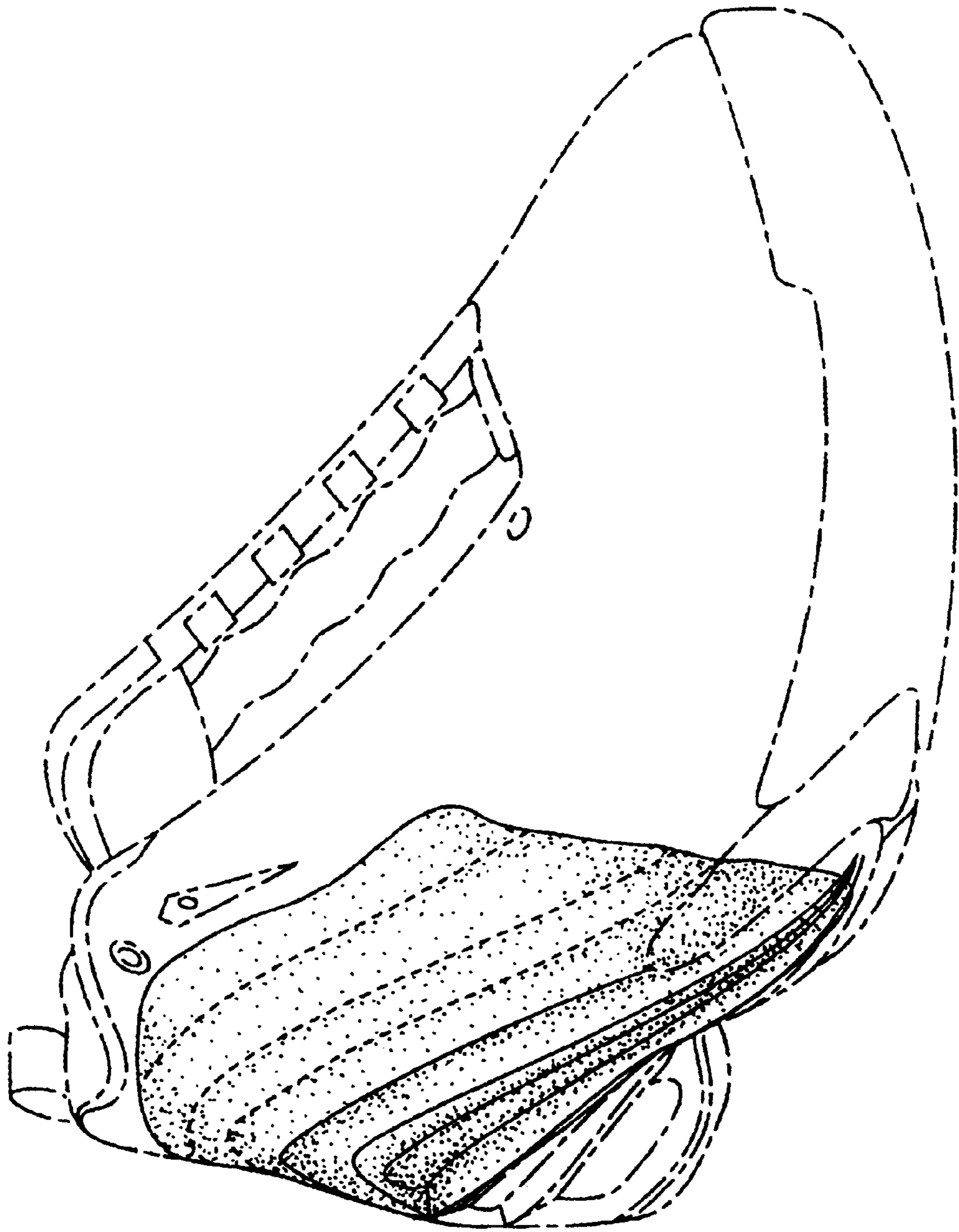

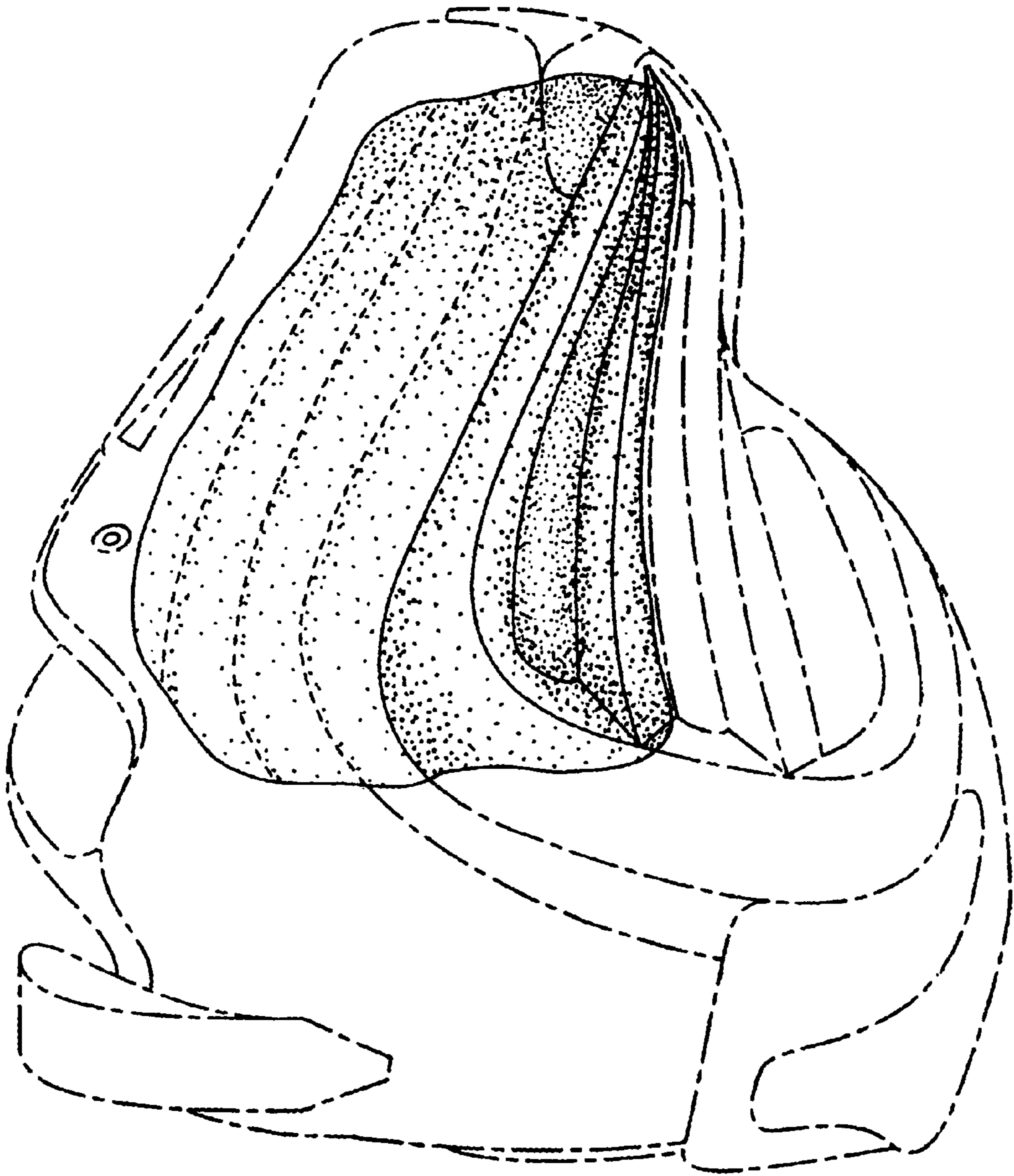

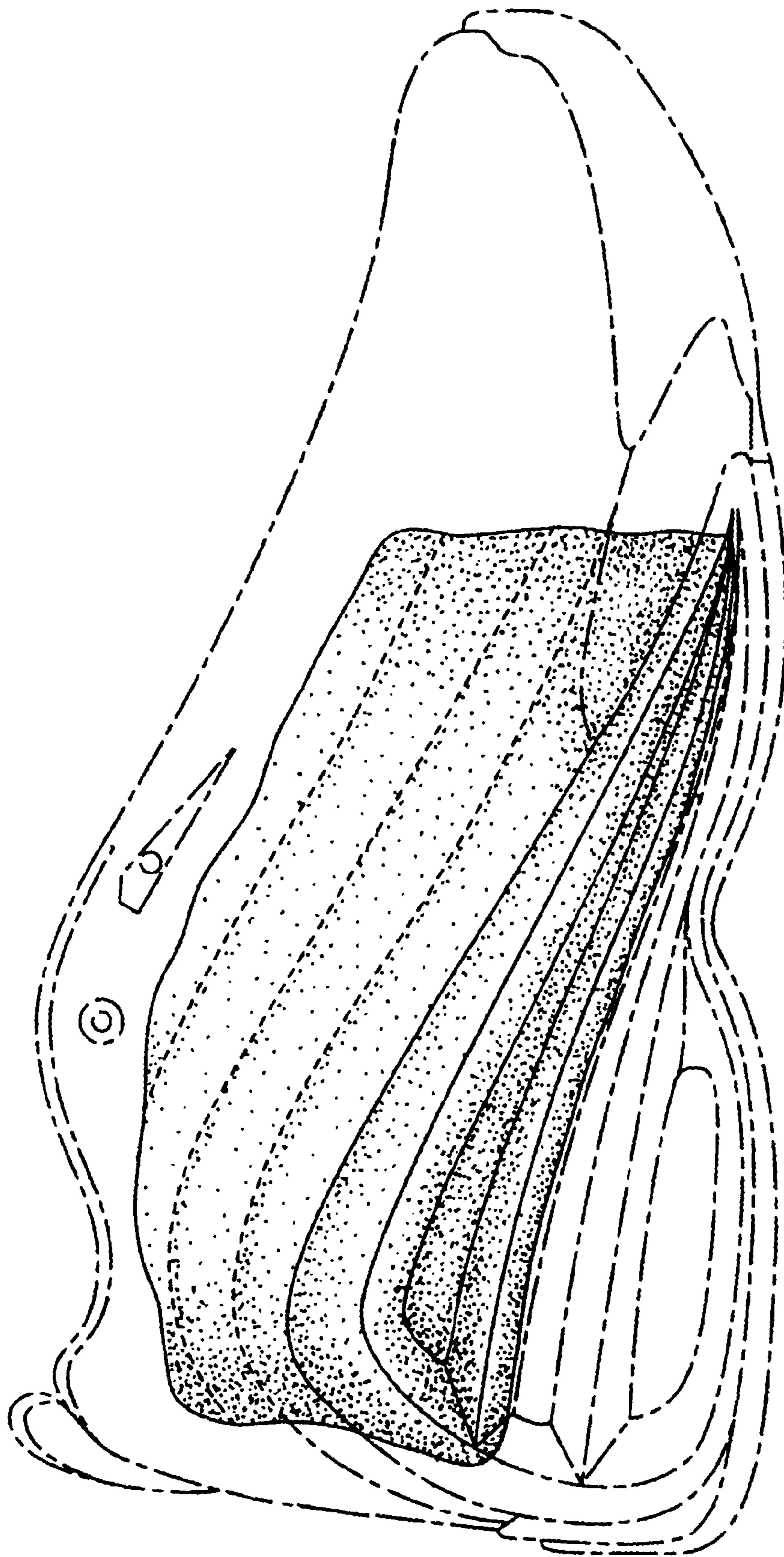

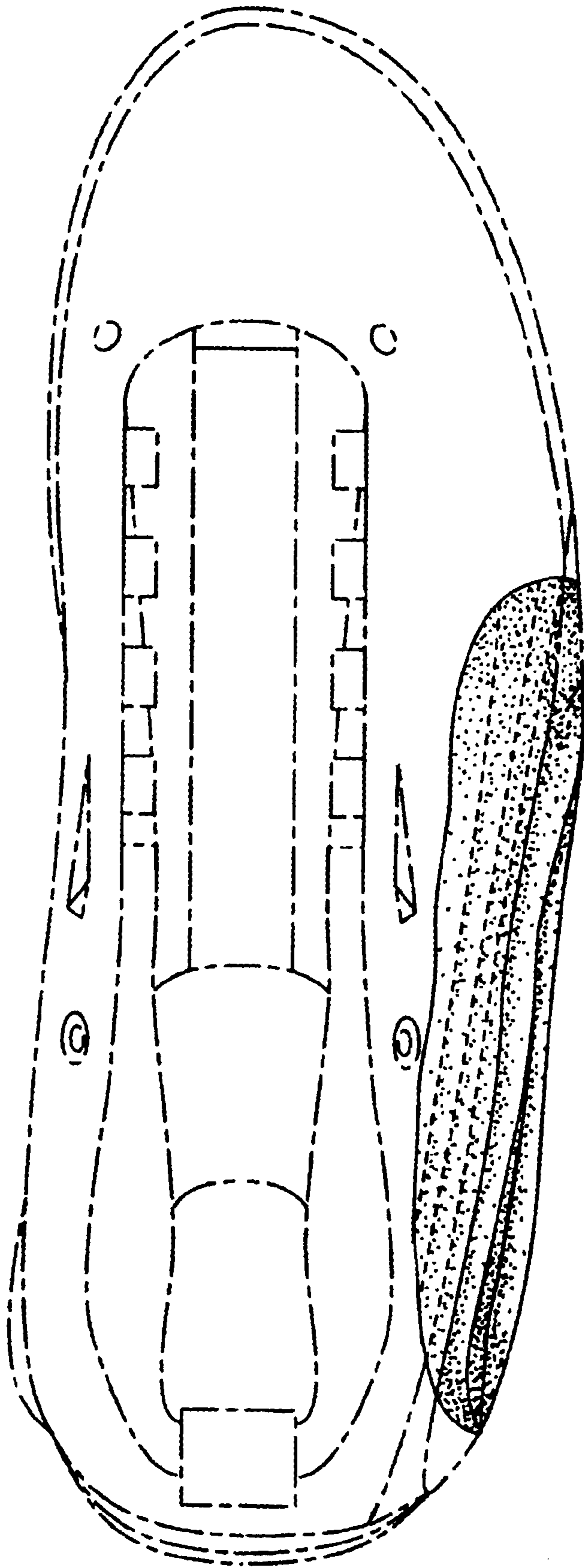
