FIG. 5 is a side view thereof;

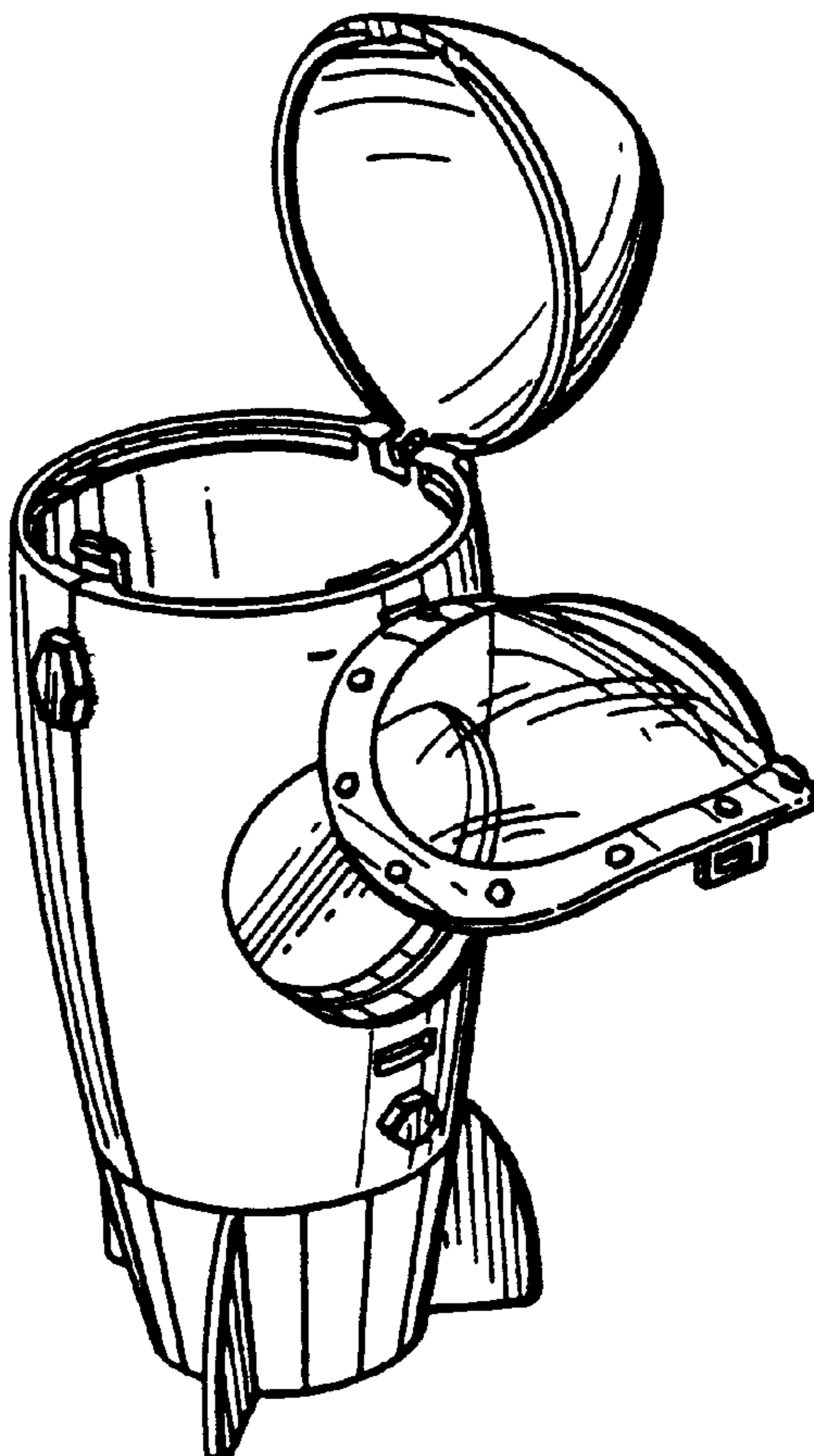
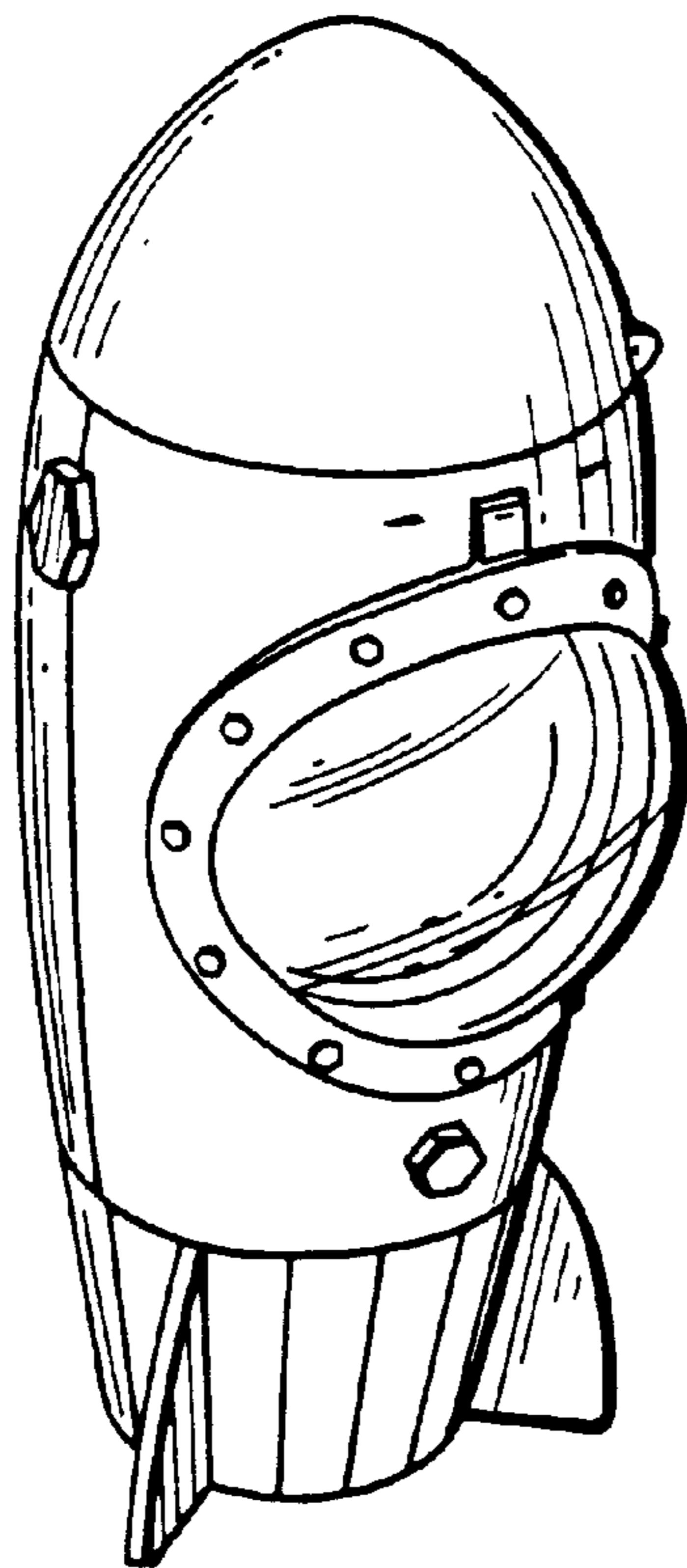
FIG. 6 is an opposite side view thereof;

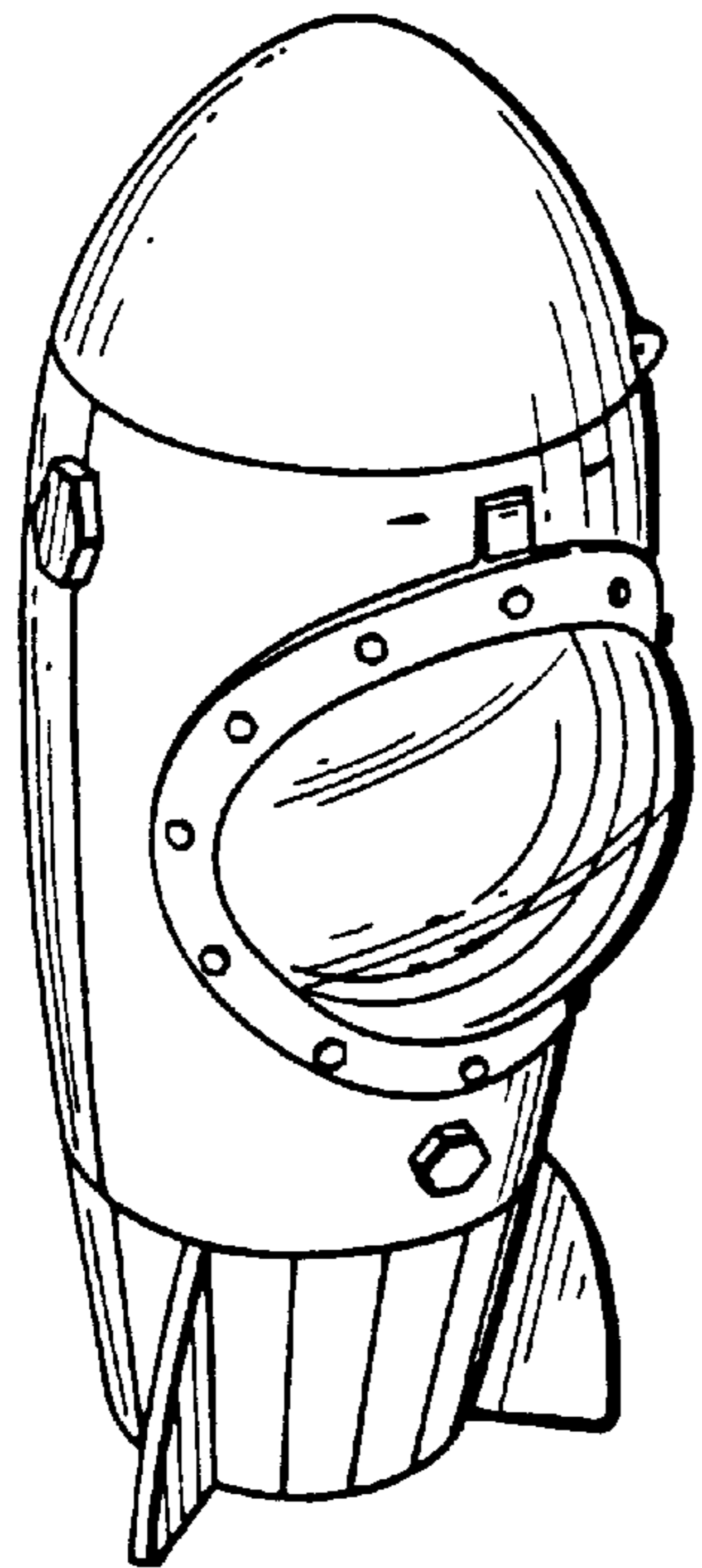
FIG. 7 is a top plan view thereof;

FIG. 9 is a perspective view thereof with parts in an alternative position.

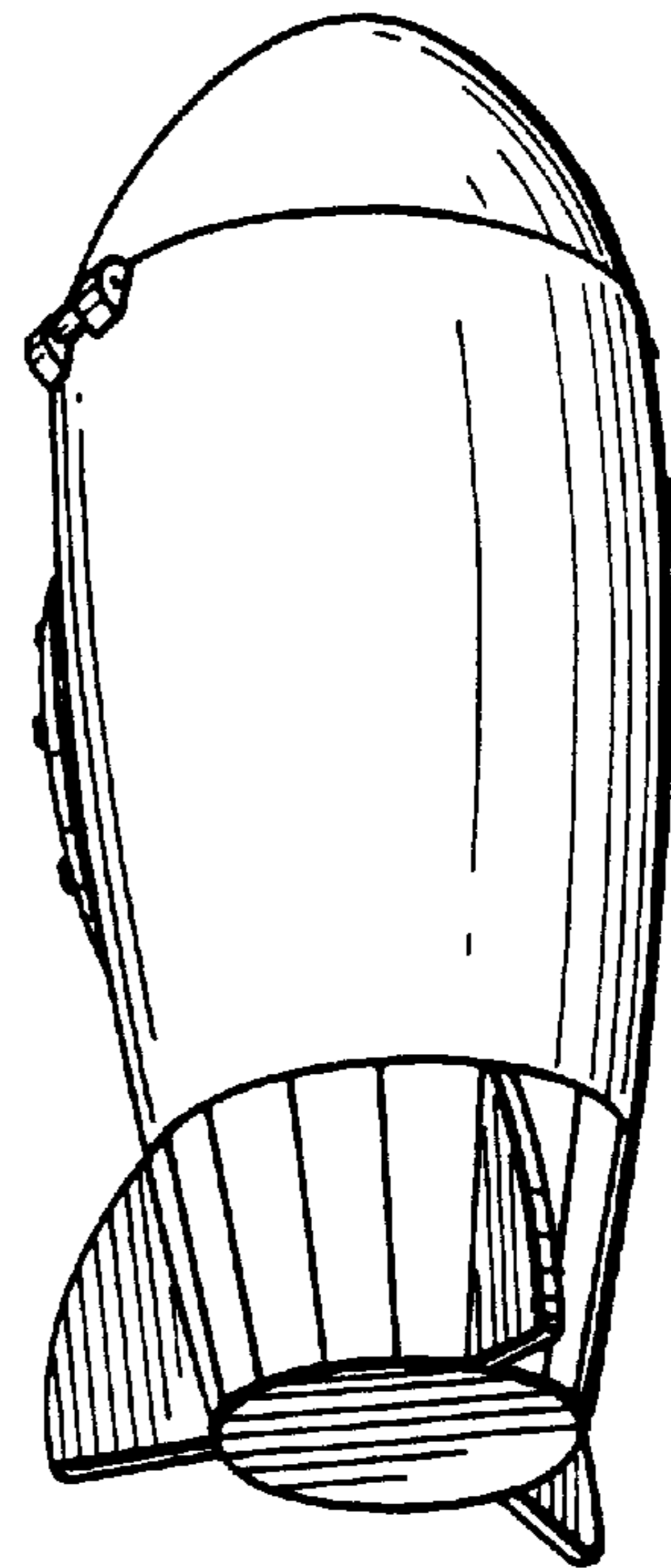

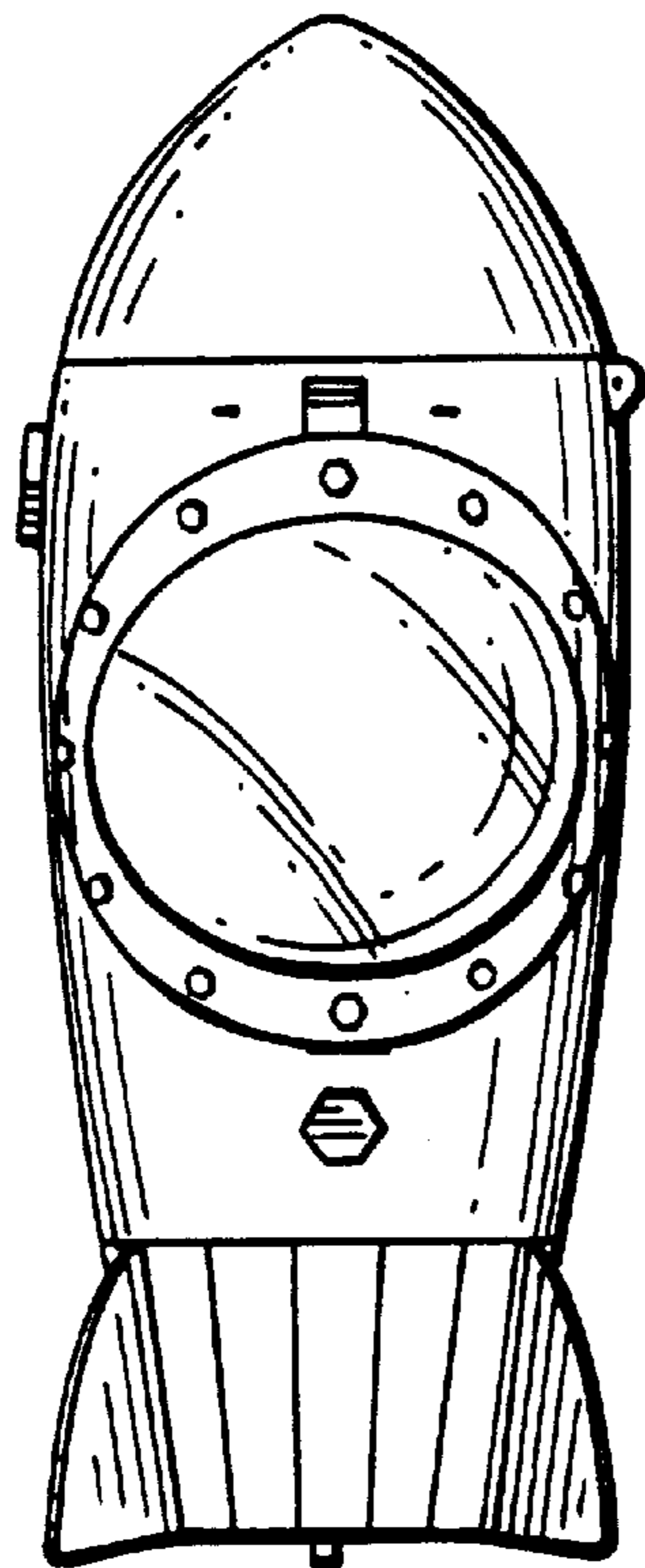

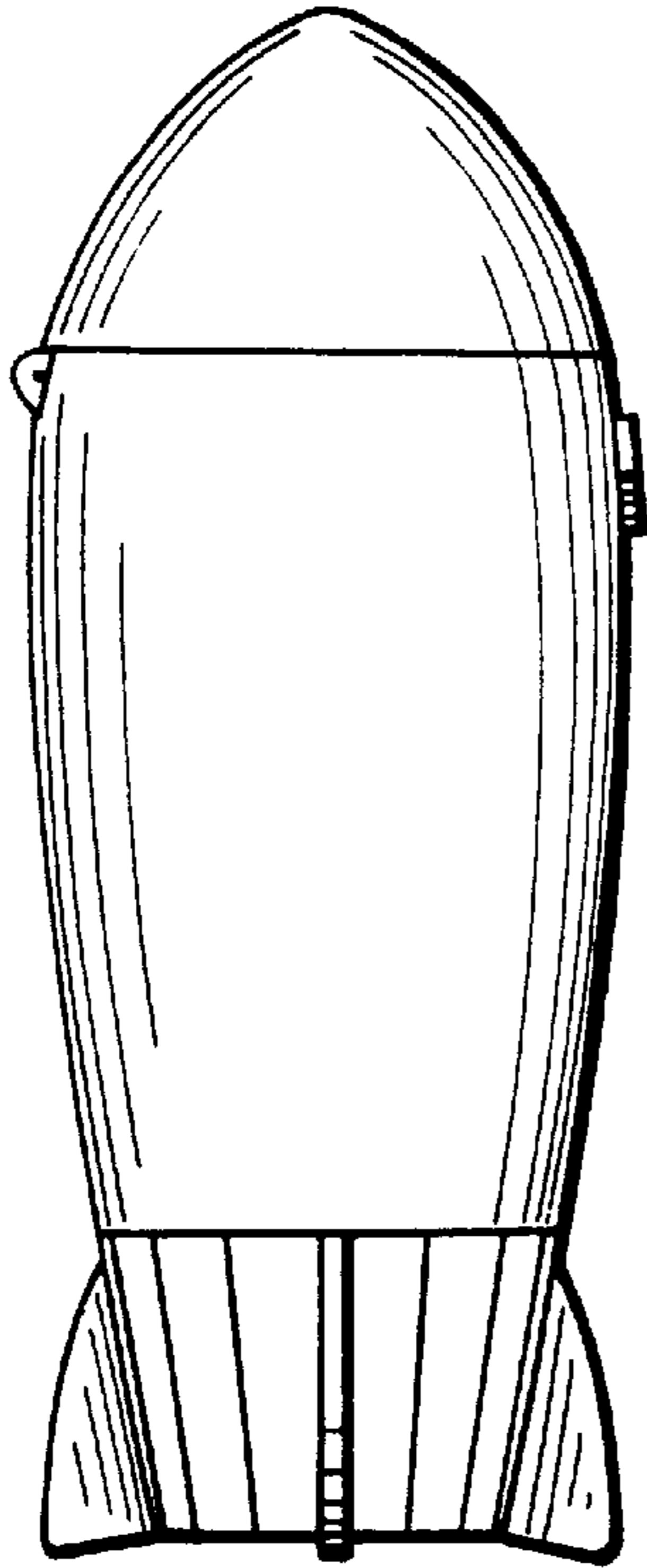

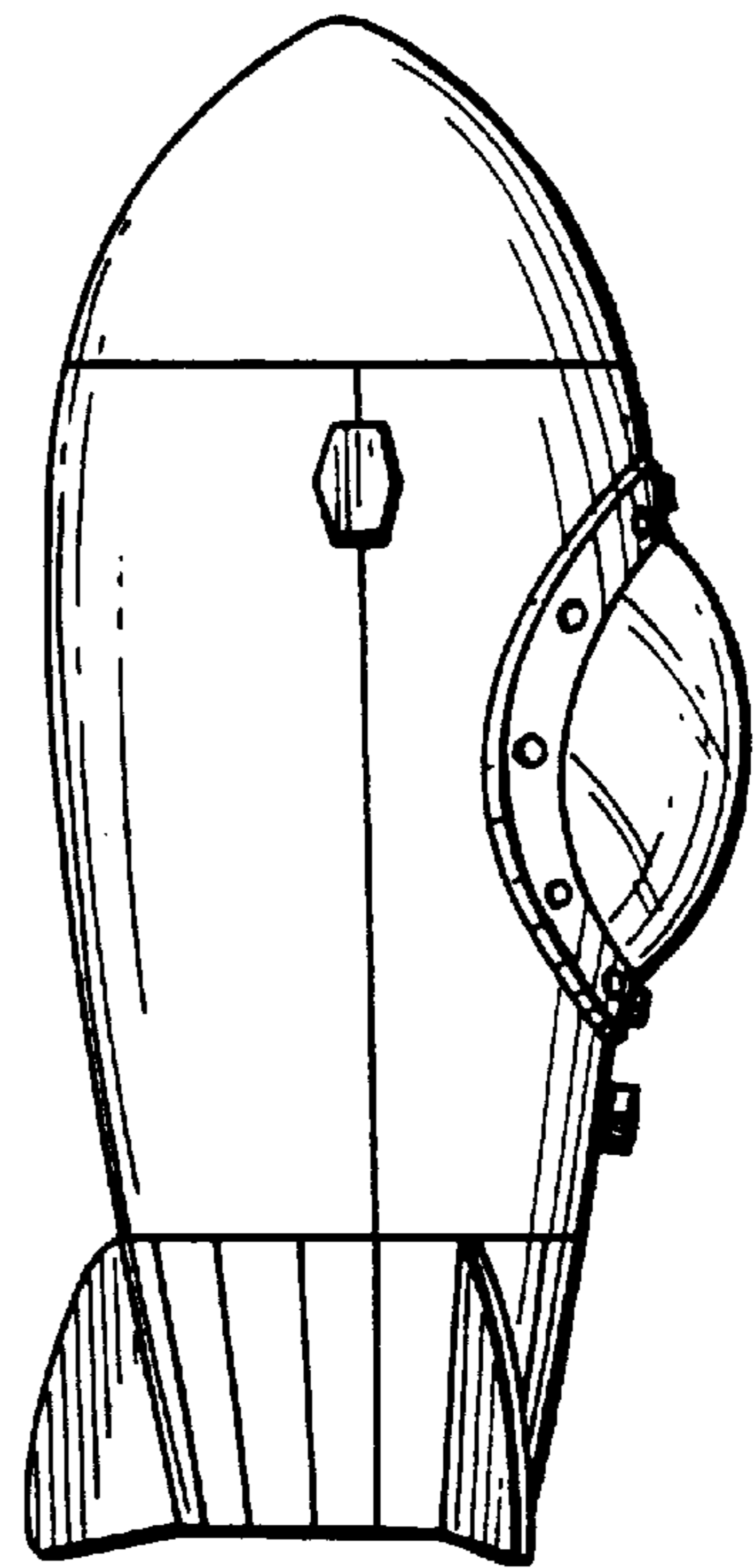

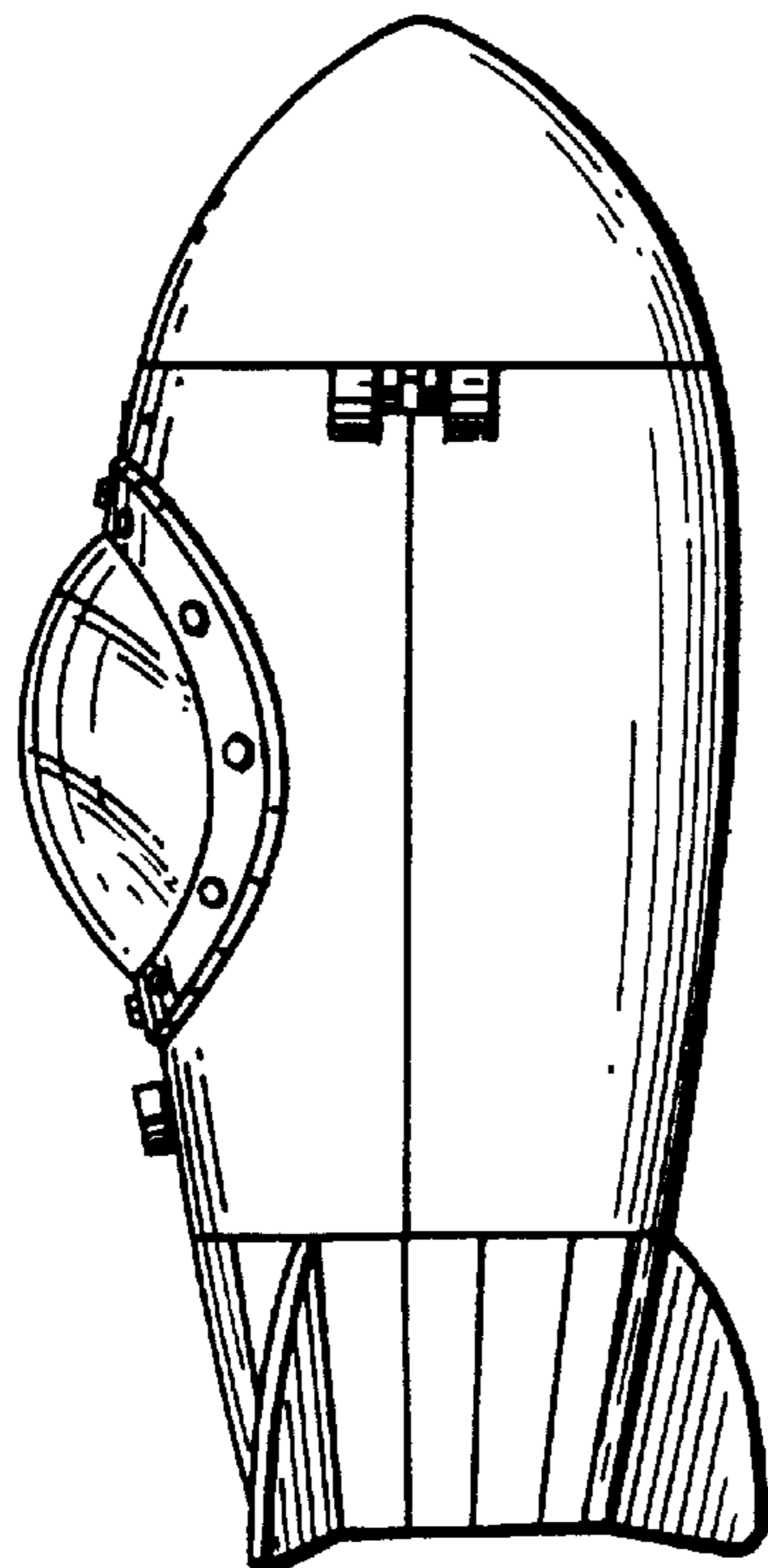

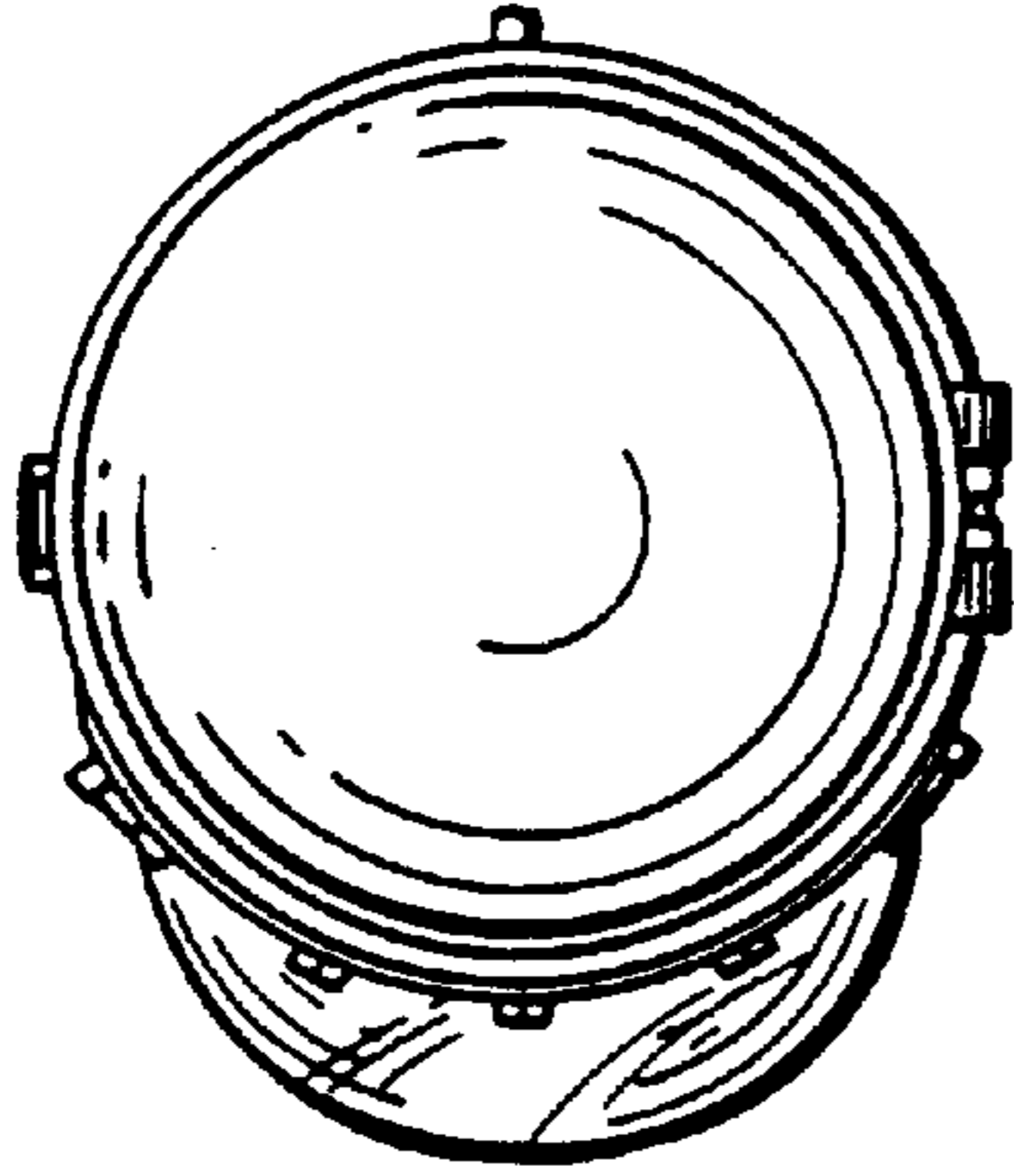

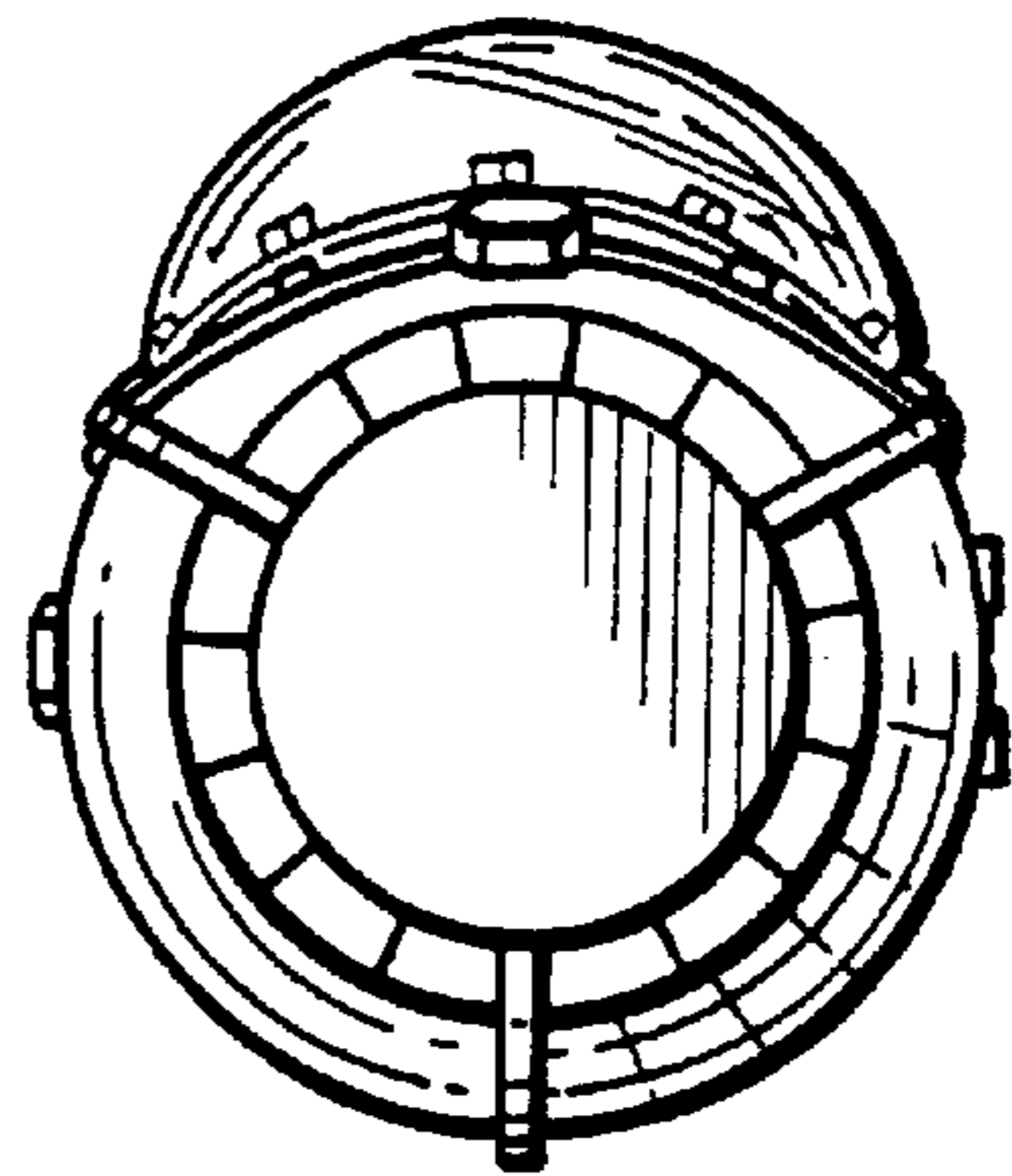
