DESCRIPTION

FIG. 1 is a perspective view of a chair embodying my novel design.

FIG. 2 is a top plan view of the chair.

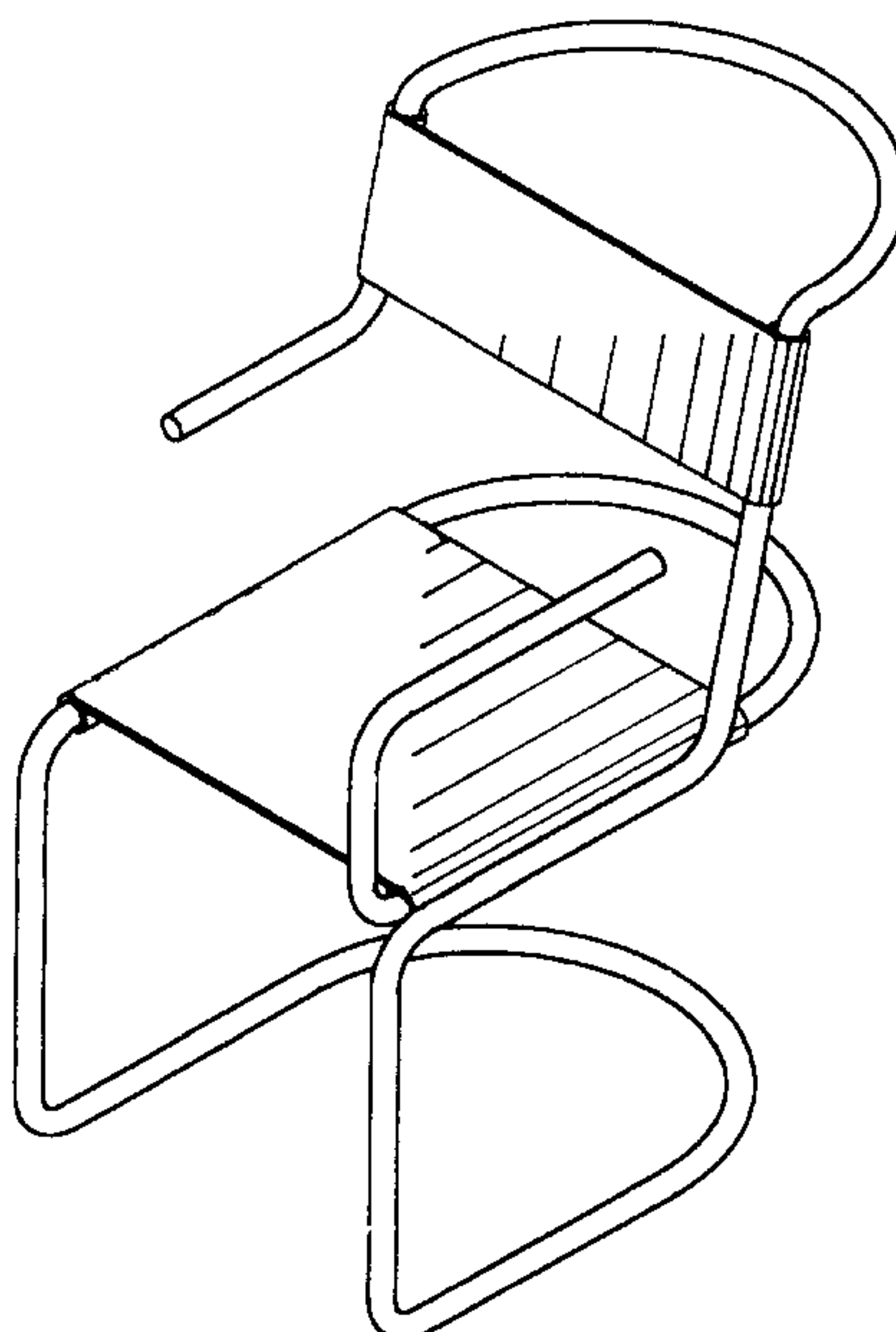
FIG. 3 is a front elevational view of the chair.

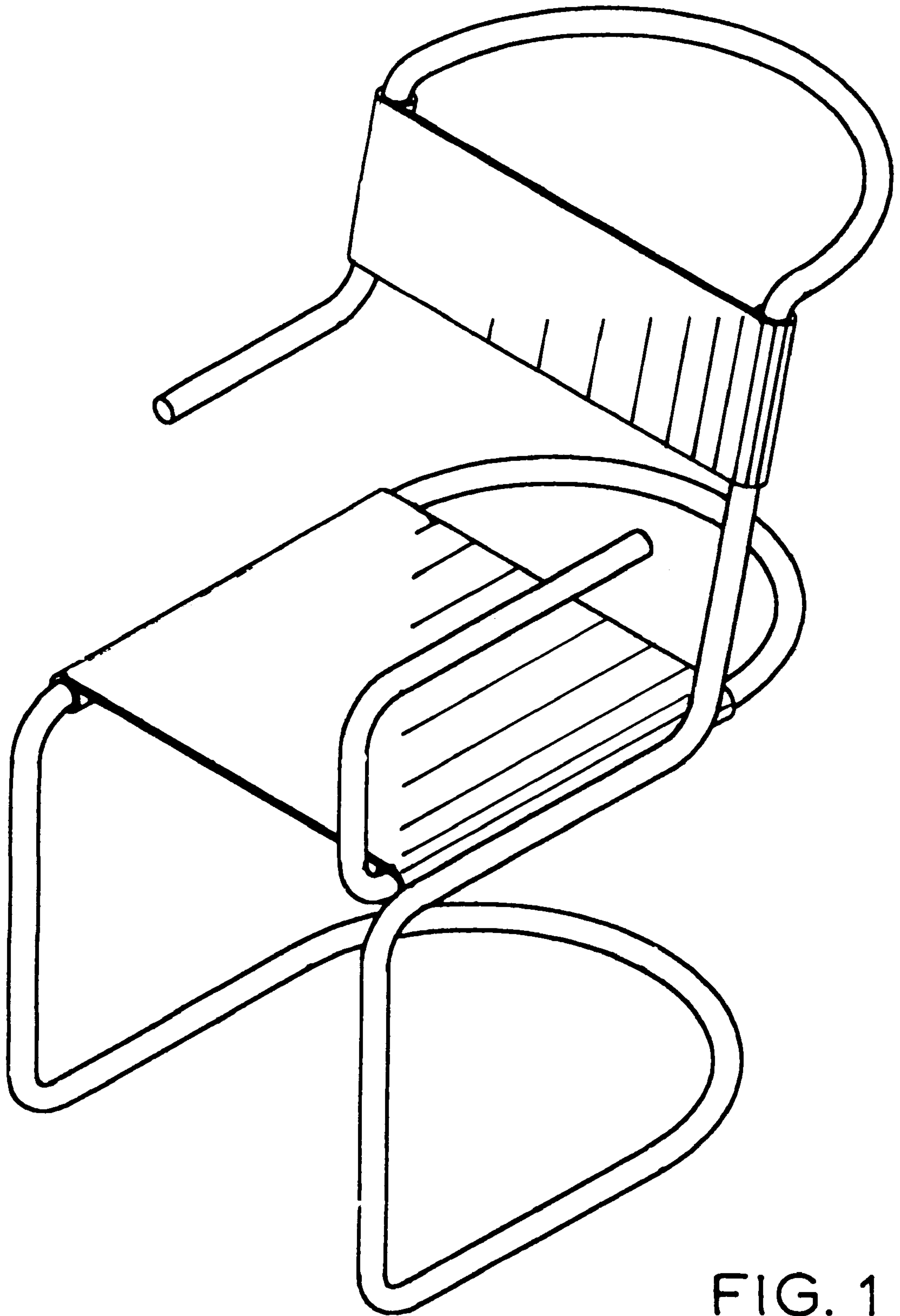

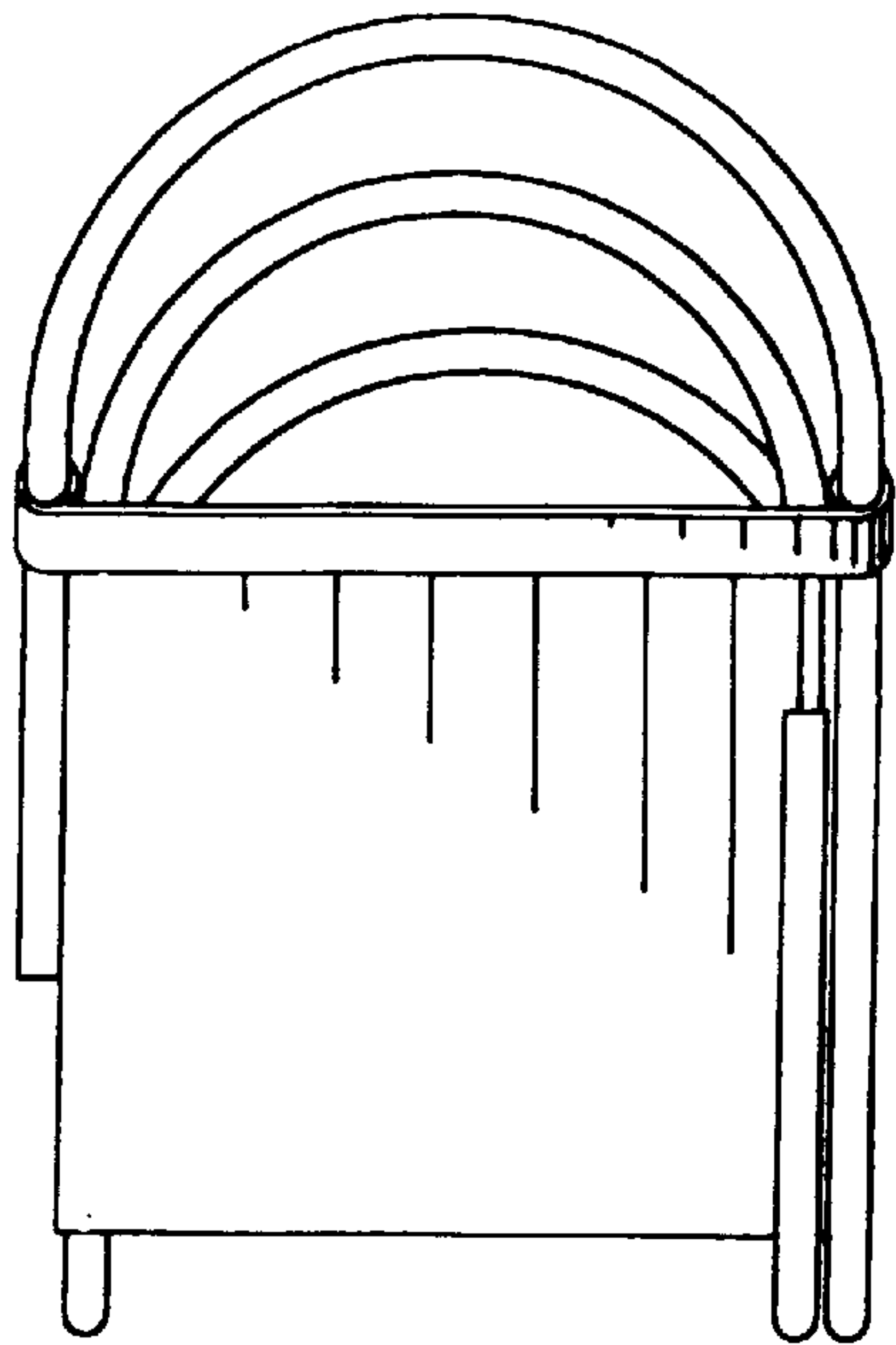

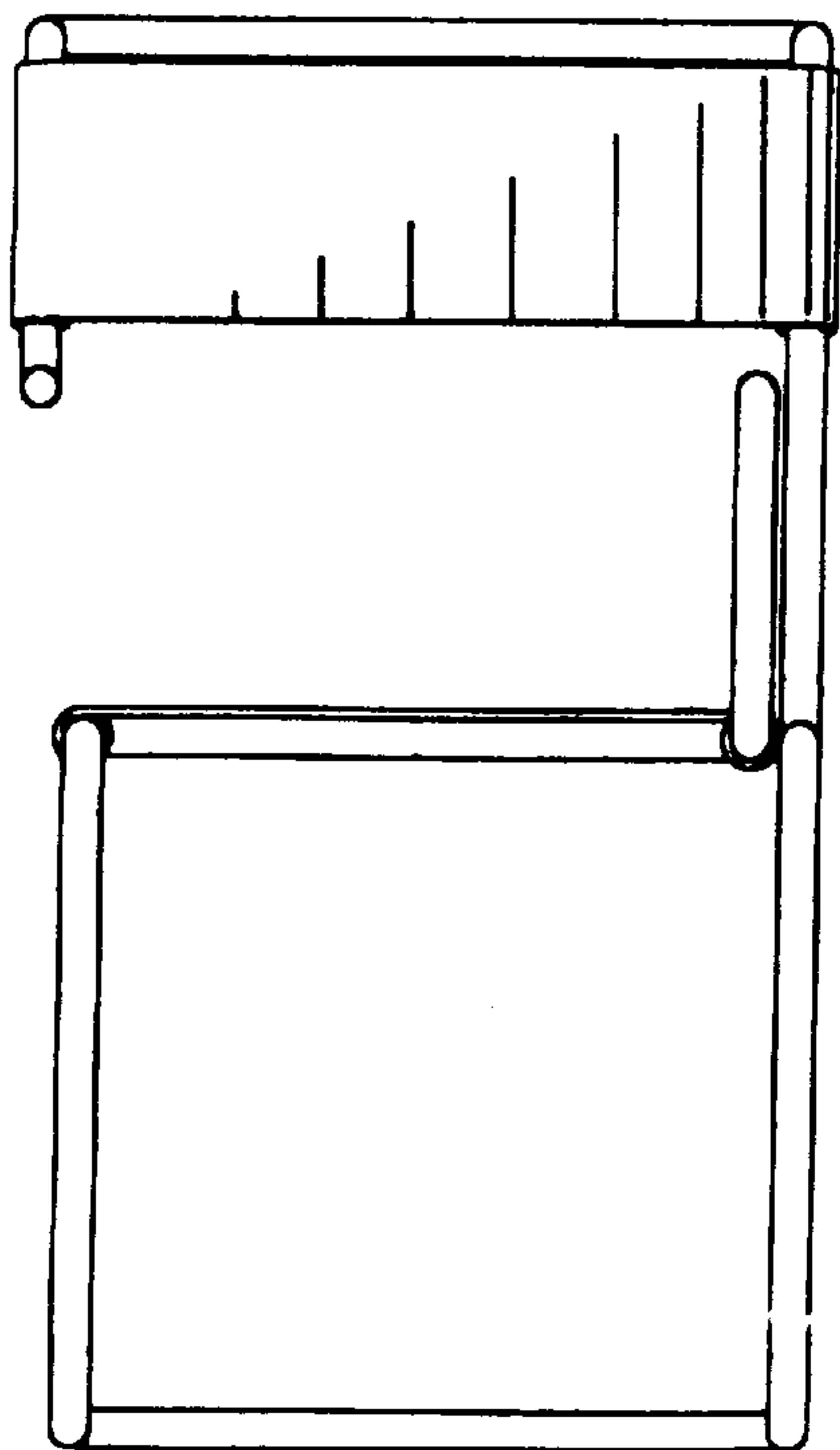

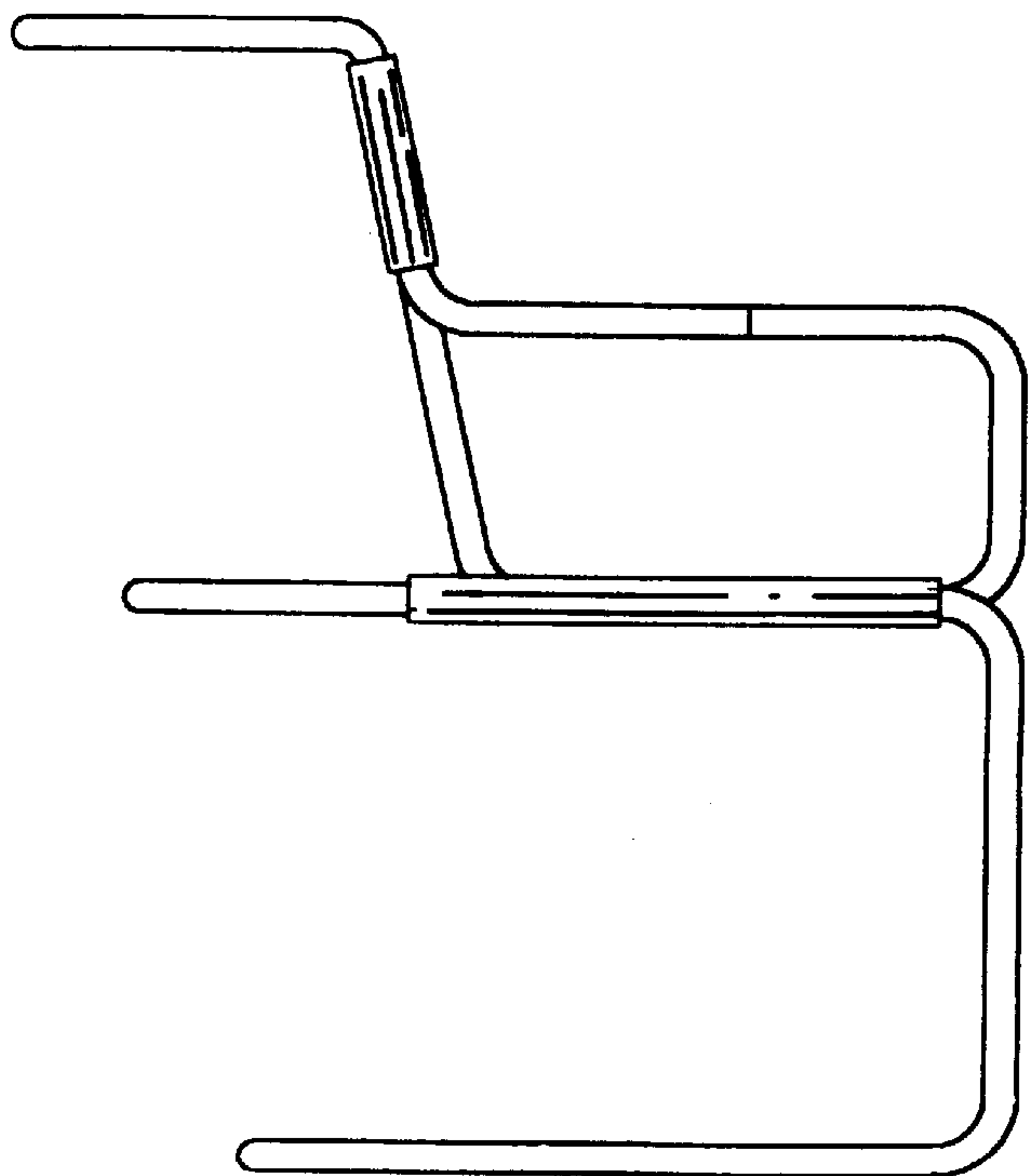

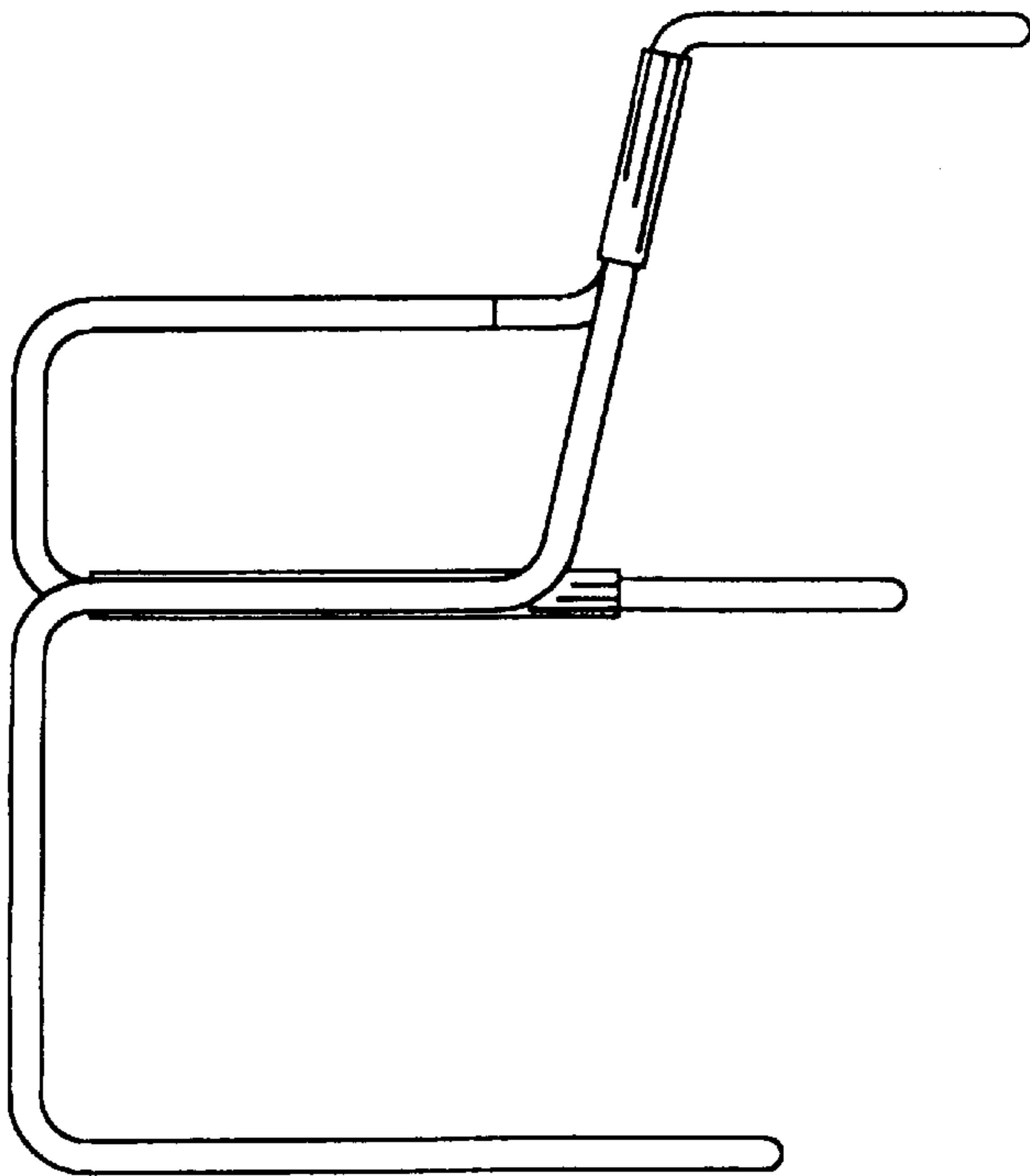

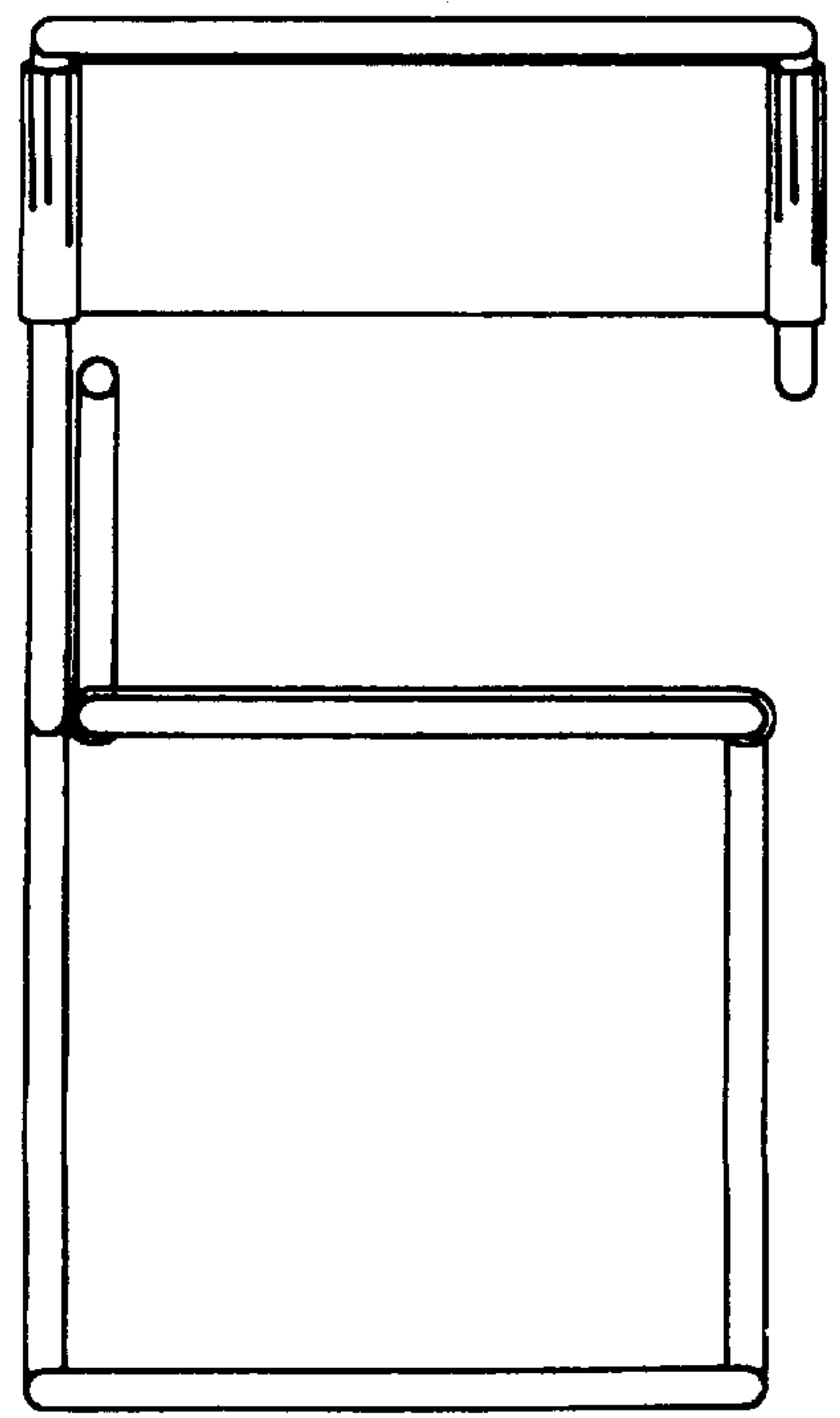
