[57] **CLAIM**

The ornamental design for a pull saw with retractable blade, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of a pull saw with retractable blade showing my new design; FIG. 2 is a front elevation view thereof; FIG. 3 is a back elevation view thereof; FIG. 4 is a right side elevation view thereof; FIG. 5 is a left side elevation view thereof; FIG. 6 is a top plan view thereof; FIG. 7 is a bottom plan view thereof; FIG. 8 is a perspective view of a second embodiment of a pull saw with retractable blade showing my new design; FIG. 9 is a front elevation view thereof; FIG. 10 is a back elevation view thereof; FIG. 11 is a right side elevation view thereof; FIG. 12 is a left side elevation view thereof; FIG. 13 is a top plan view thereof; FIG. 14 is a bottom plan view thereof; and, FIG. 15 is a perspective view thereof, wherein the blade portion is in a retracted position.

The broken line portions of FIGS. 1 through 7 are for illustrative purposes only and form no part of the claimed design.

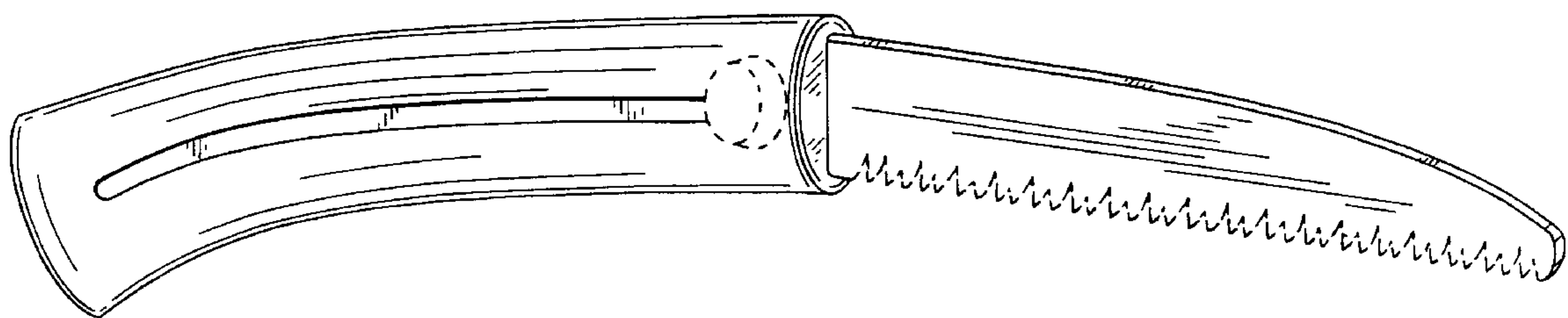

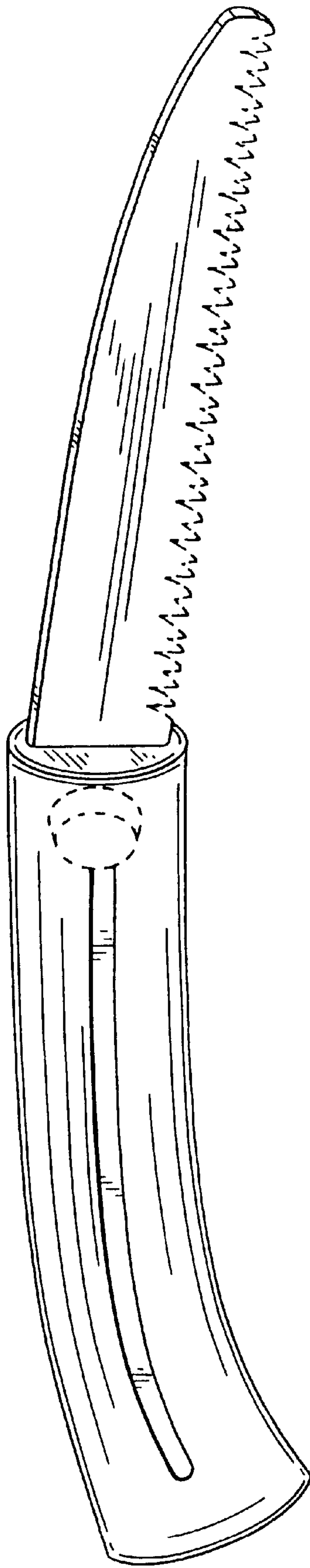

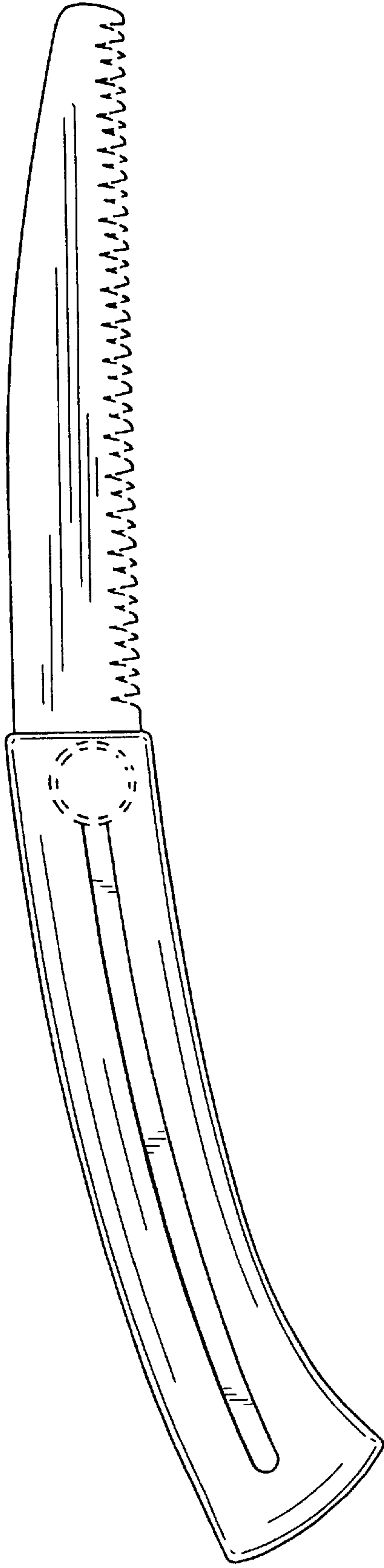

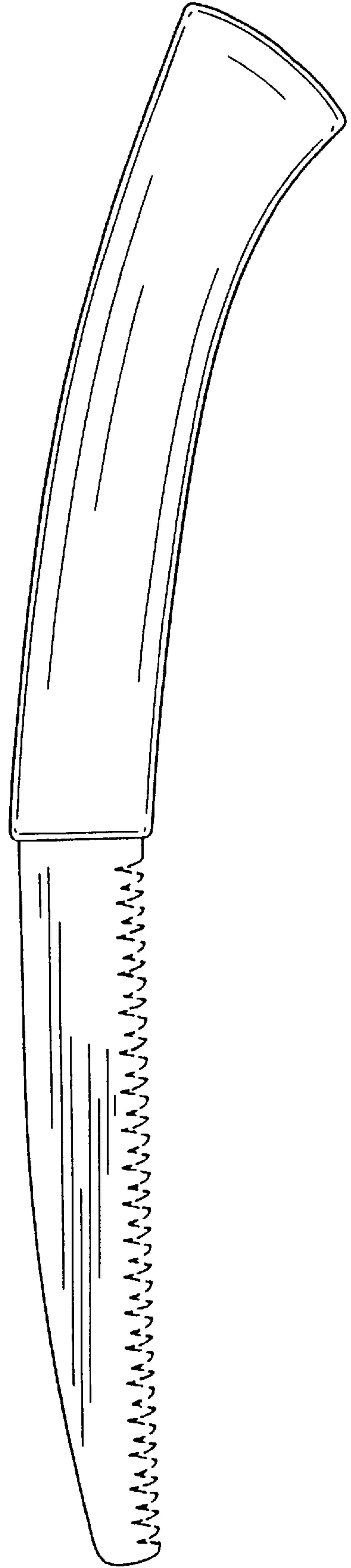

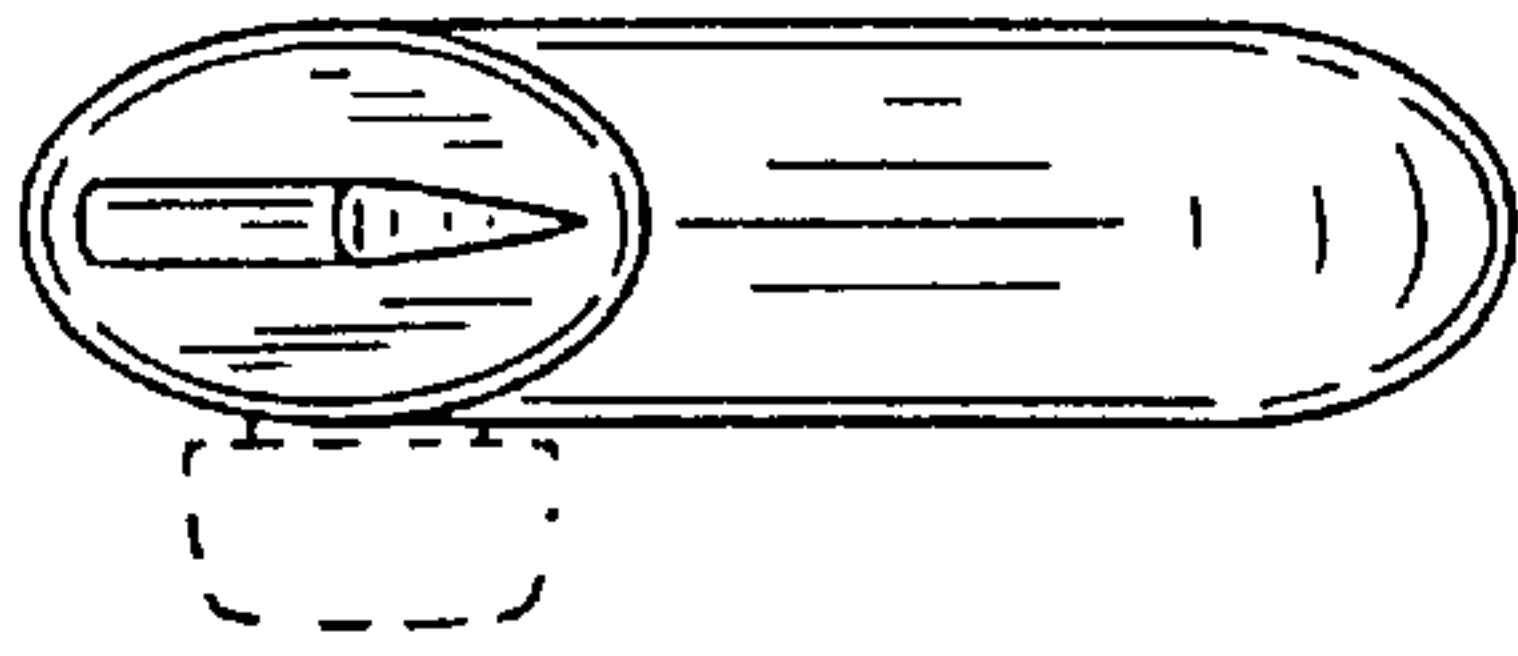

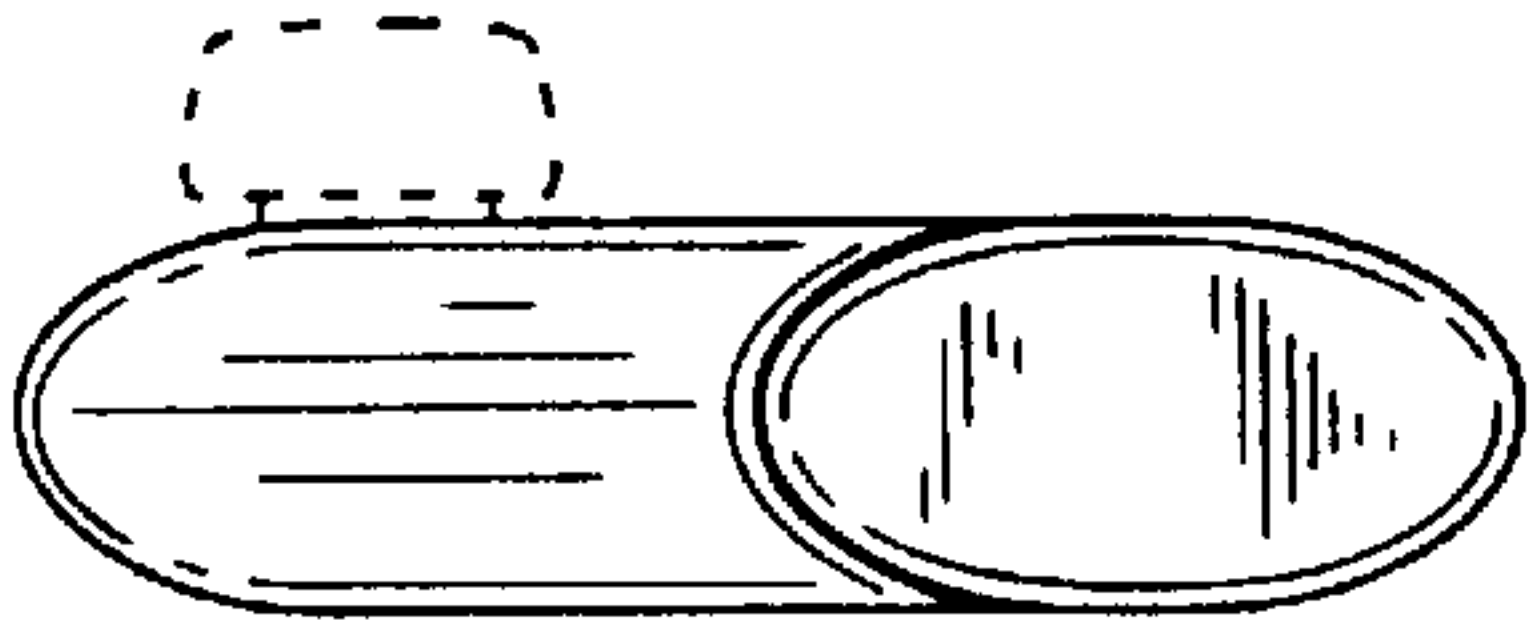

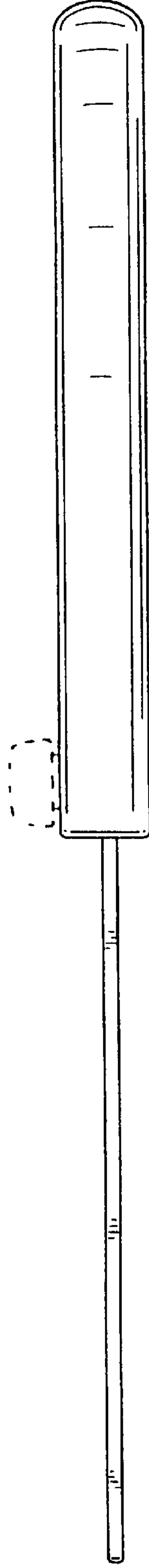

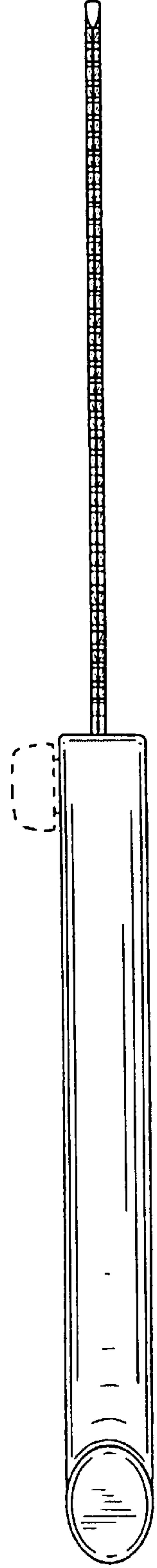

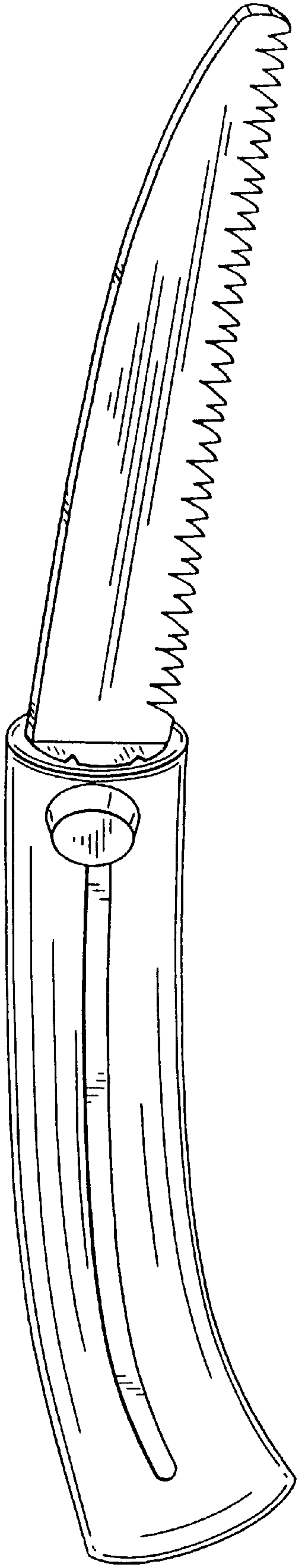

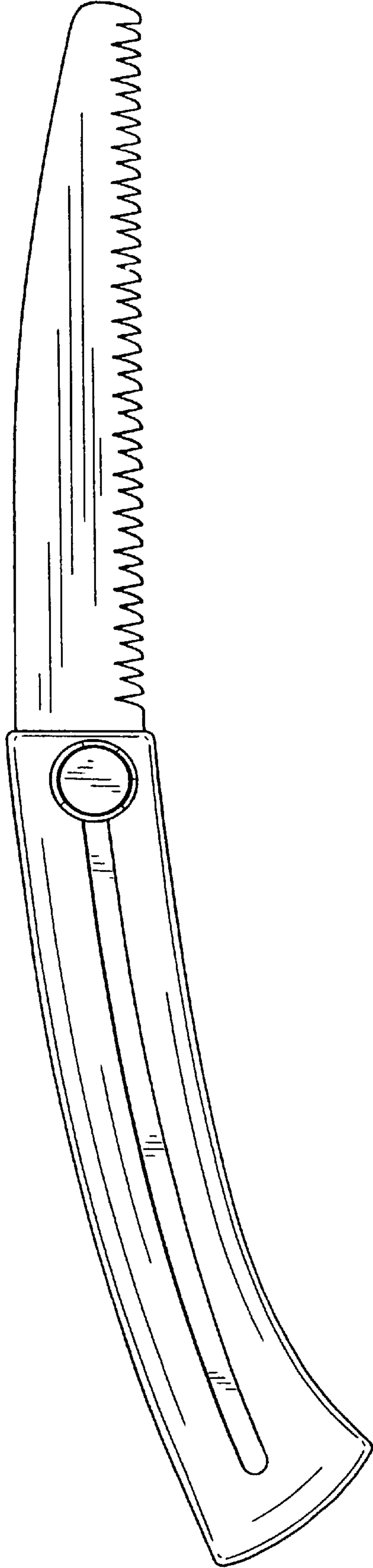

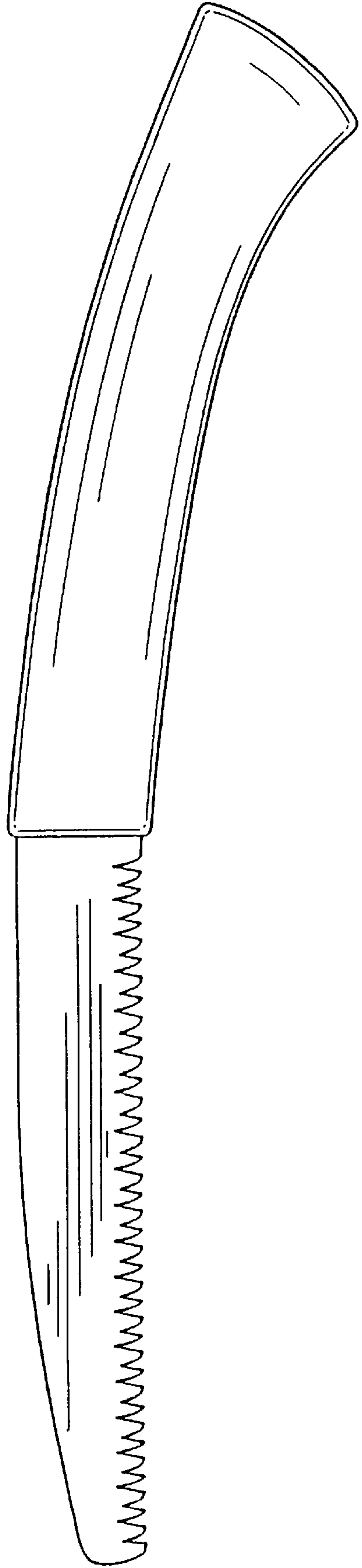

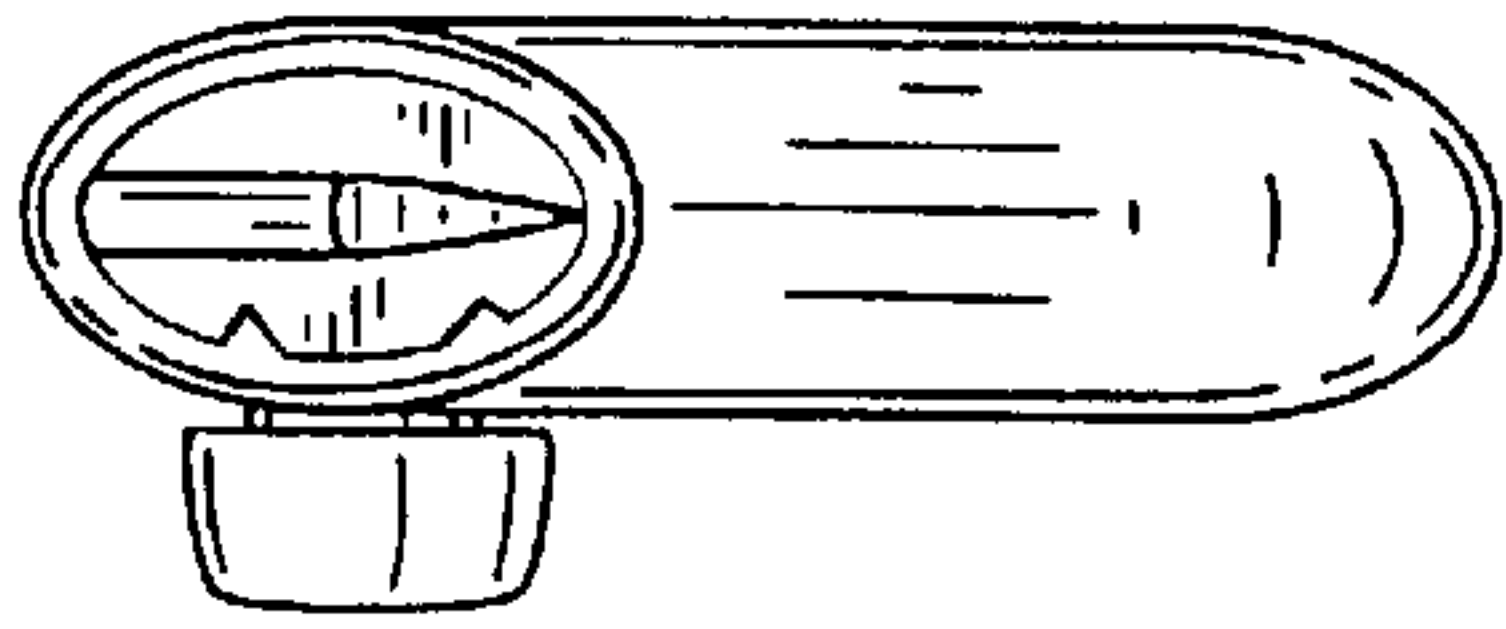

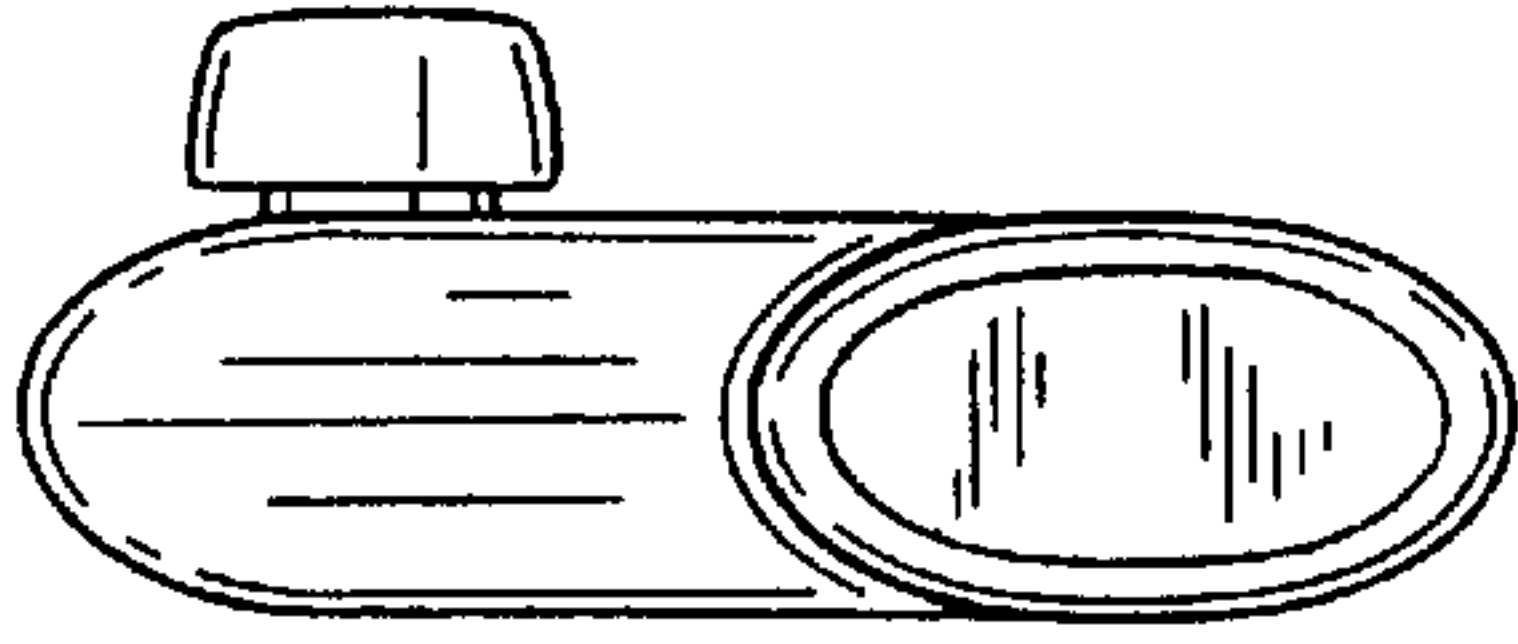

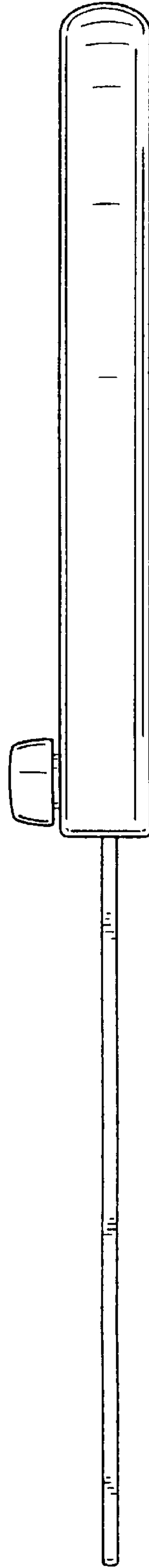
