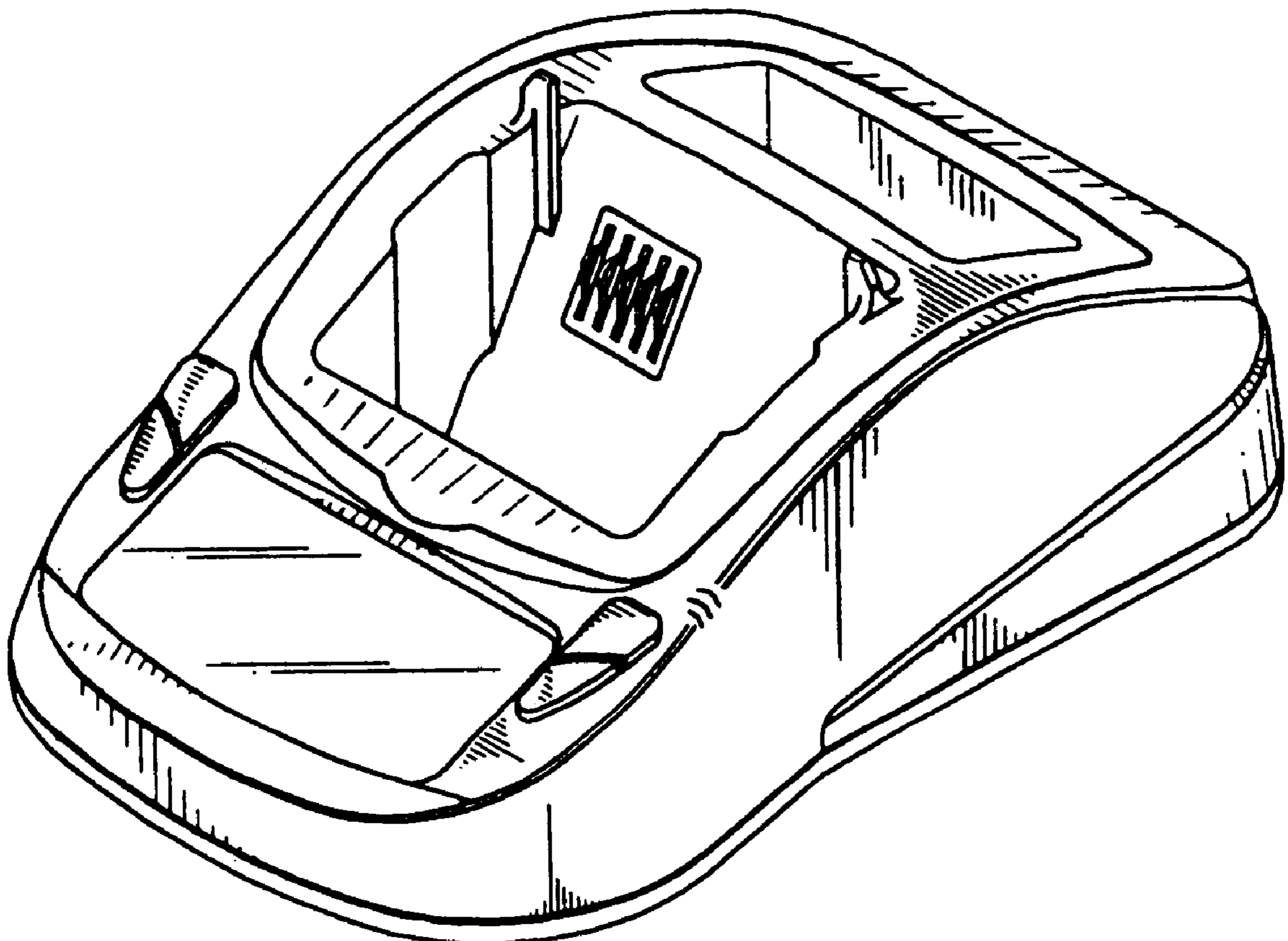
[57] **CLAIM**

The ornamental design for a battery recharger, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a battery recharger showing my new design;

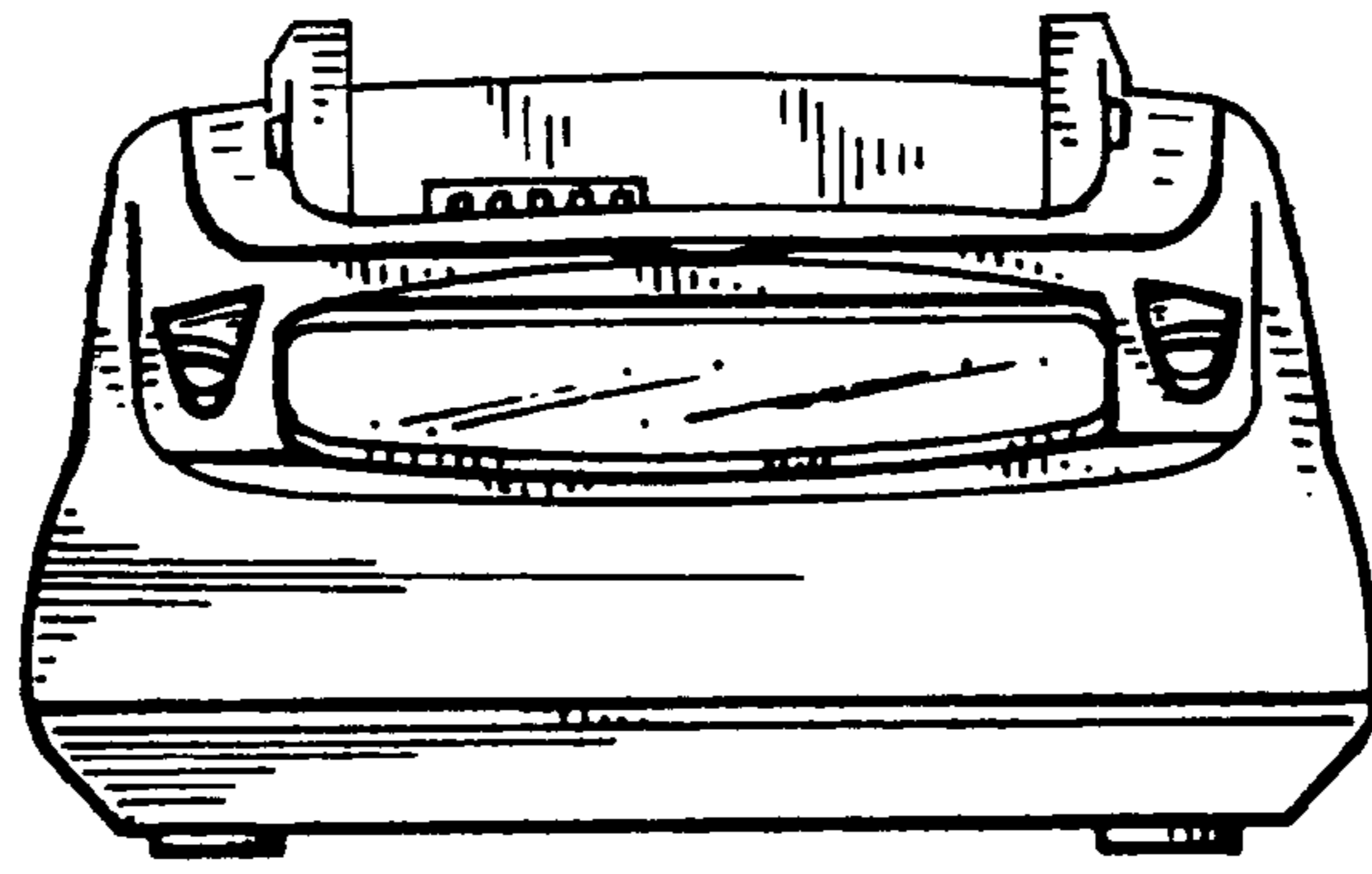

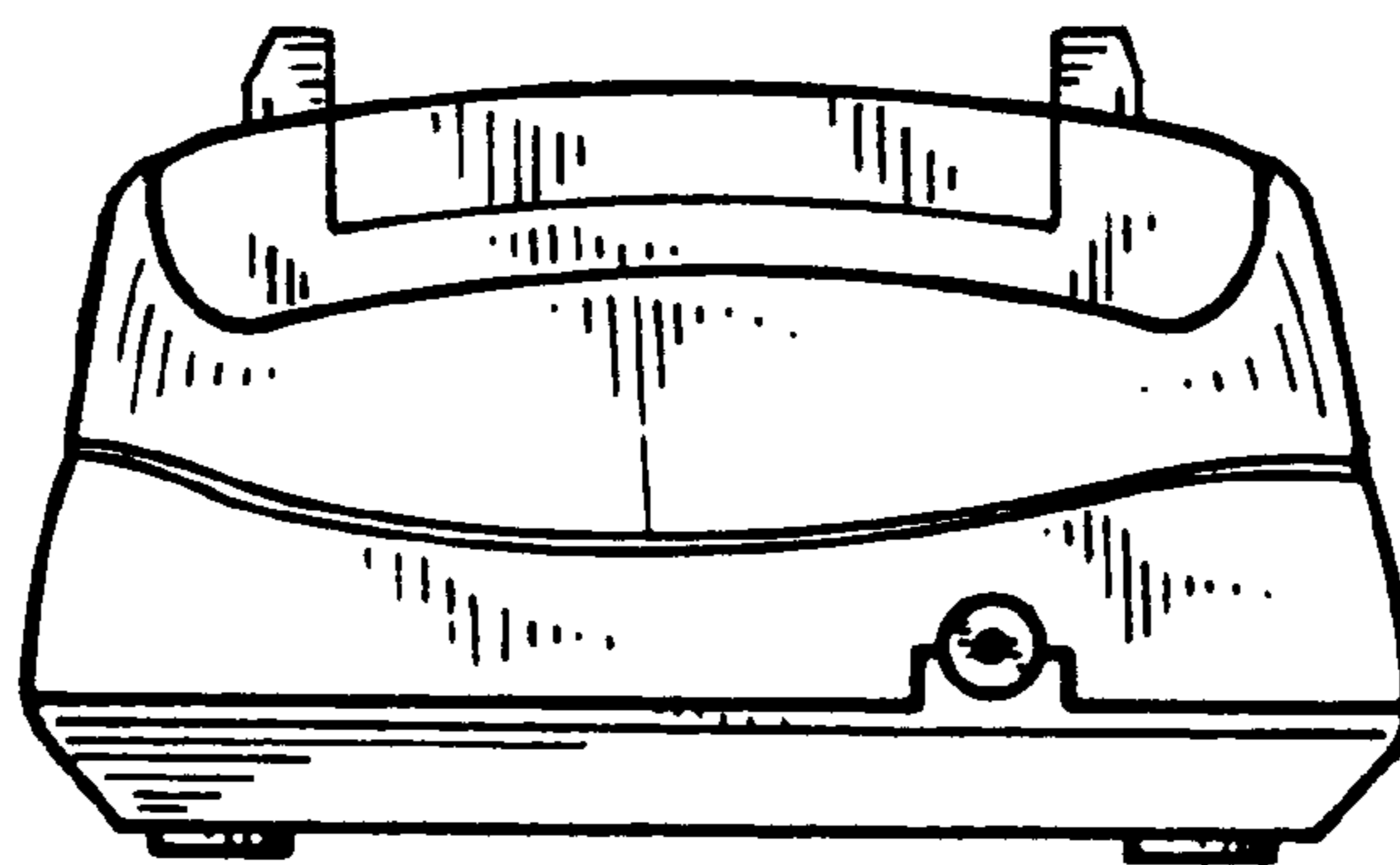

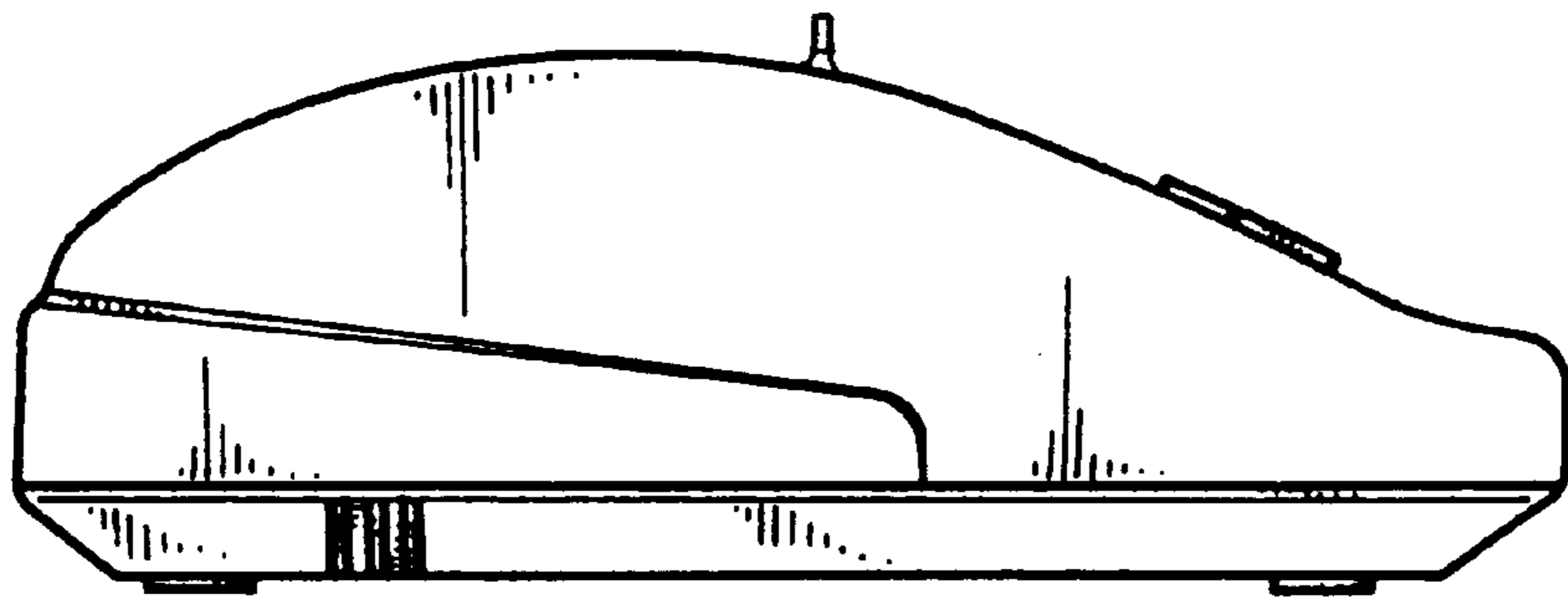

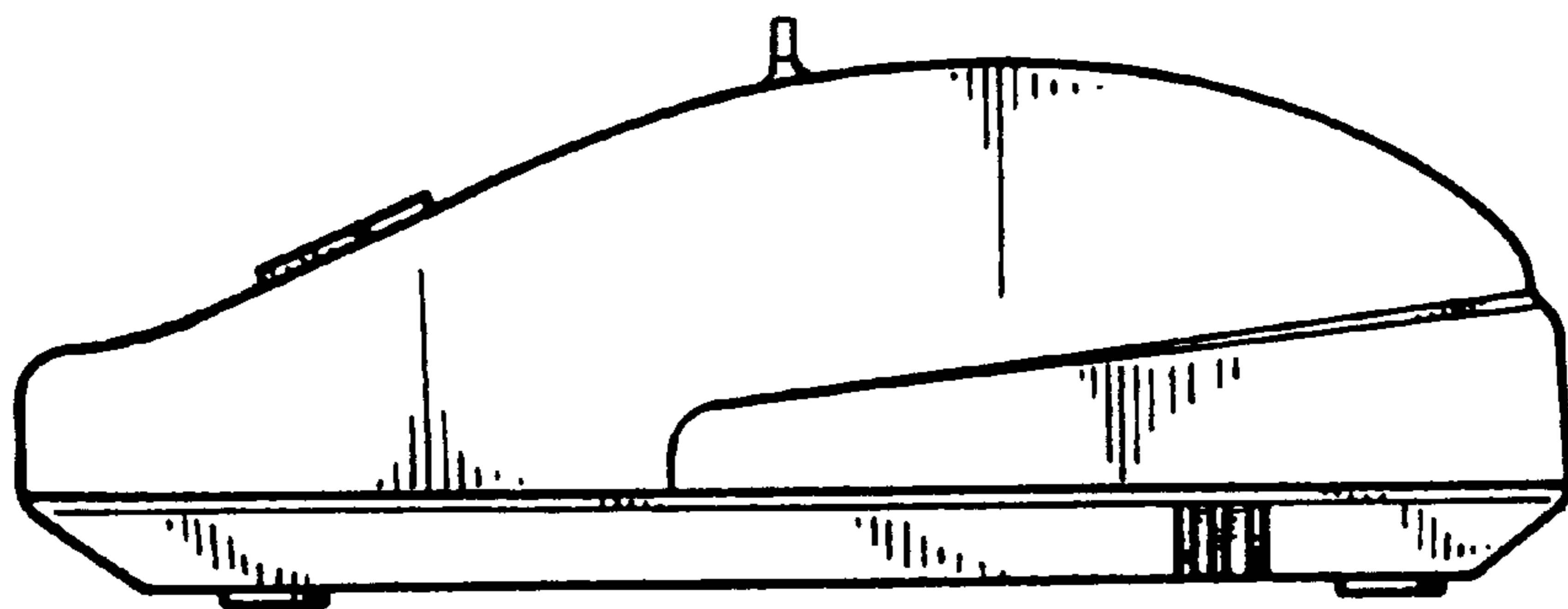

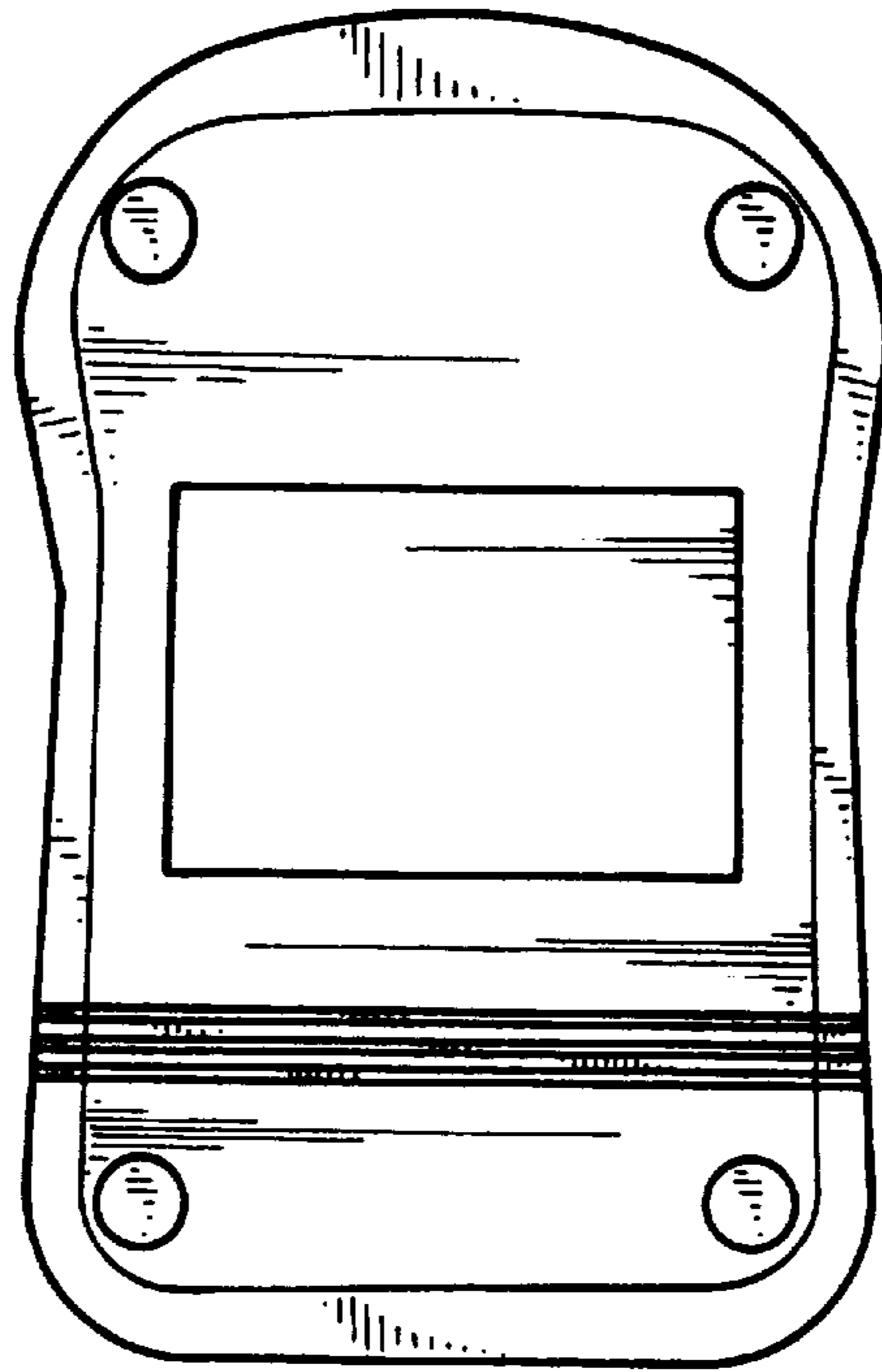

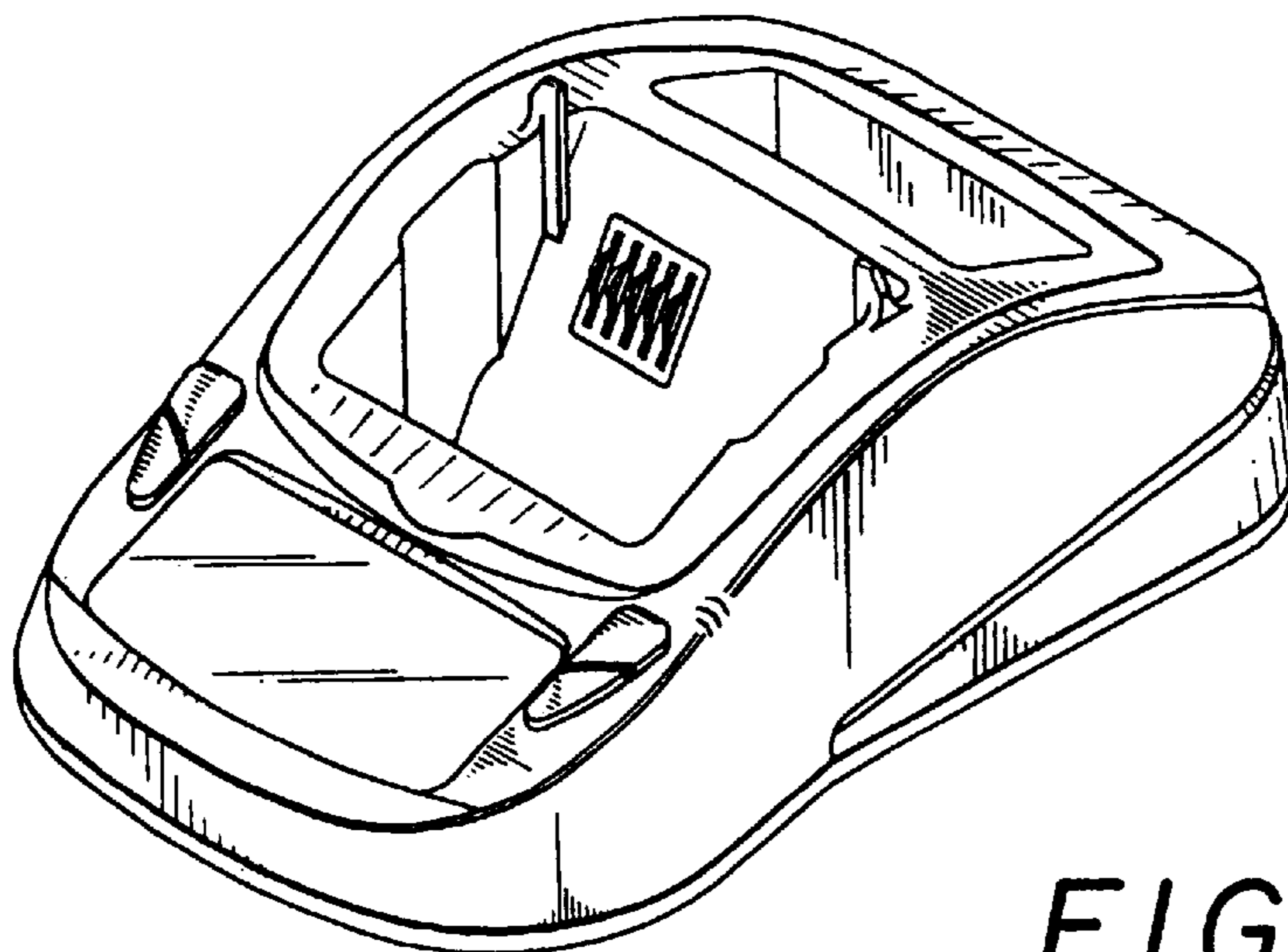
