The ornamental design for an inline fuseholder, as shown.

**DESCRIPTION**

FIG. 1 is a perspective view of a first embodiment of my inline fuseholder showing my new design;

FIG. 2 is an opposite perspective view of the inline fuseholder of FIG. 1;

FIG. 3 is a front elevation view of the inline fuseholder of FIG. 1;

FIG. 4 is a rear elevation view of the inline fuseholder of FIG. 1;

FIG. 5 is a side elevation view of the inline fuseholder of FIG. 1;

FIG. 6 is a top view of the inline fuseholder of FIG. 1;

FIG. 7 is a bottom view of the inline fuseholder of FIG. 1;

FIG. 8 is a perspective view of the inline fuseholder of FIG. 1 with its cover disengaged from the fuseholder body;

FIG. 9 is a perspective view of a second embodiment of my inline fuseholder showing my new design;

FIG. 10 is an opposite perspective view of the inline fuseholder of FIG. 9;

FIG. 11 is a front elevation view of the inline fuseholder of FIG. 9;

FIG. 12 is a rear elevation view of the inline fuseholder of FIG. 9;

FIG. 13 is a side elevation view of the inline fuseholder of FIG. 9;

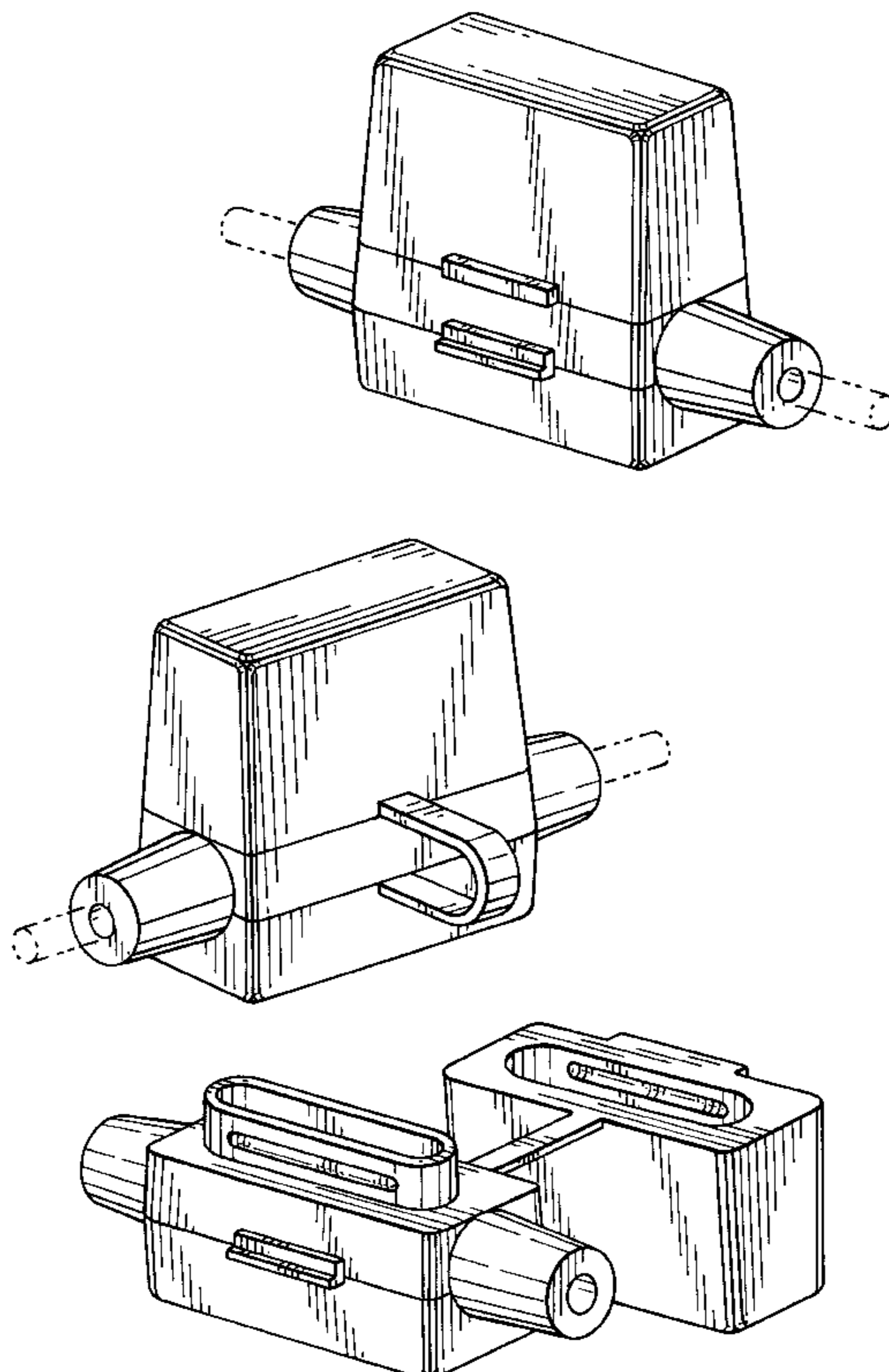
FIG. 14 is a top view of the inline fuseholder of FIG. 9;

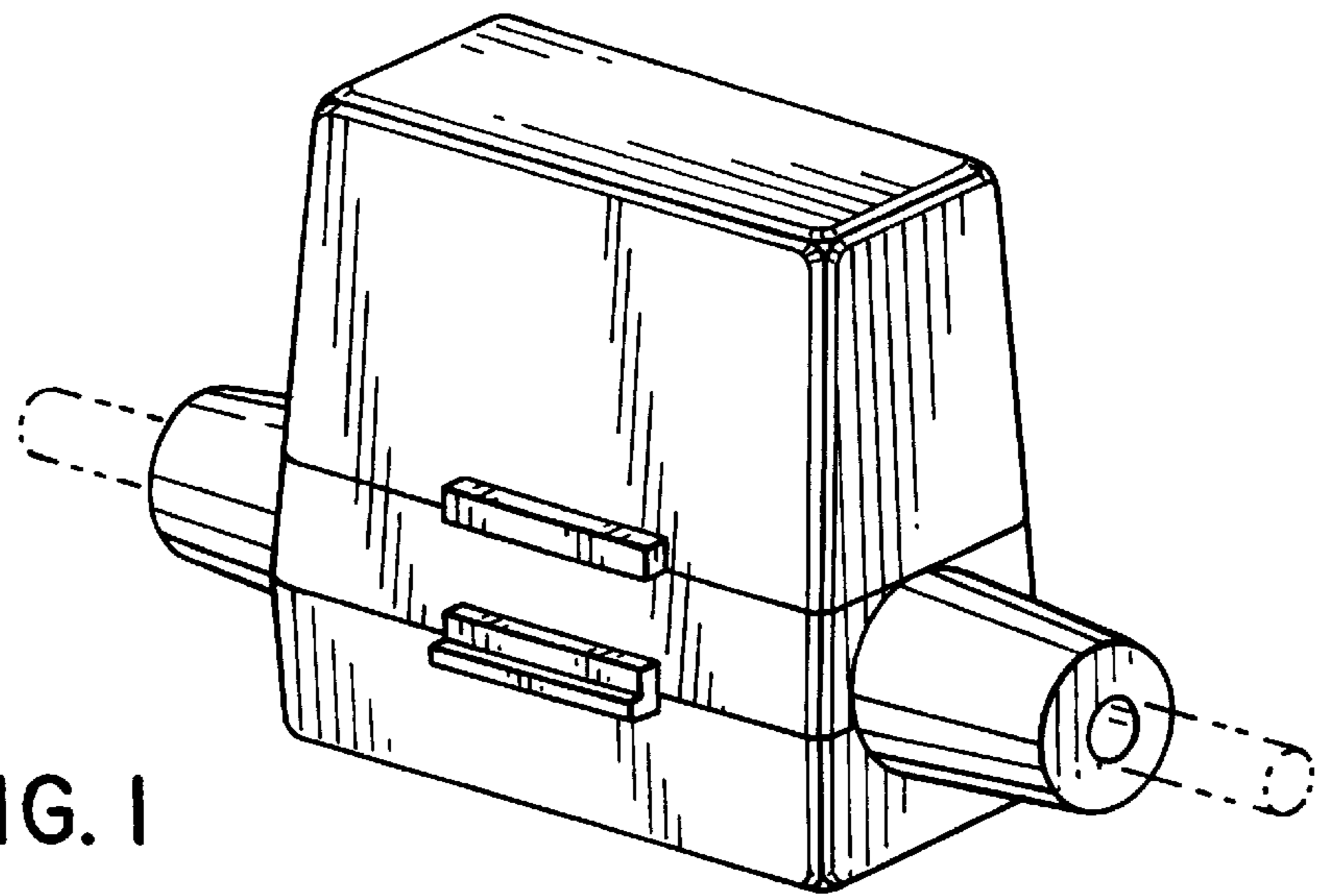

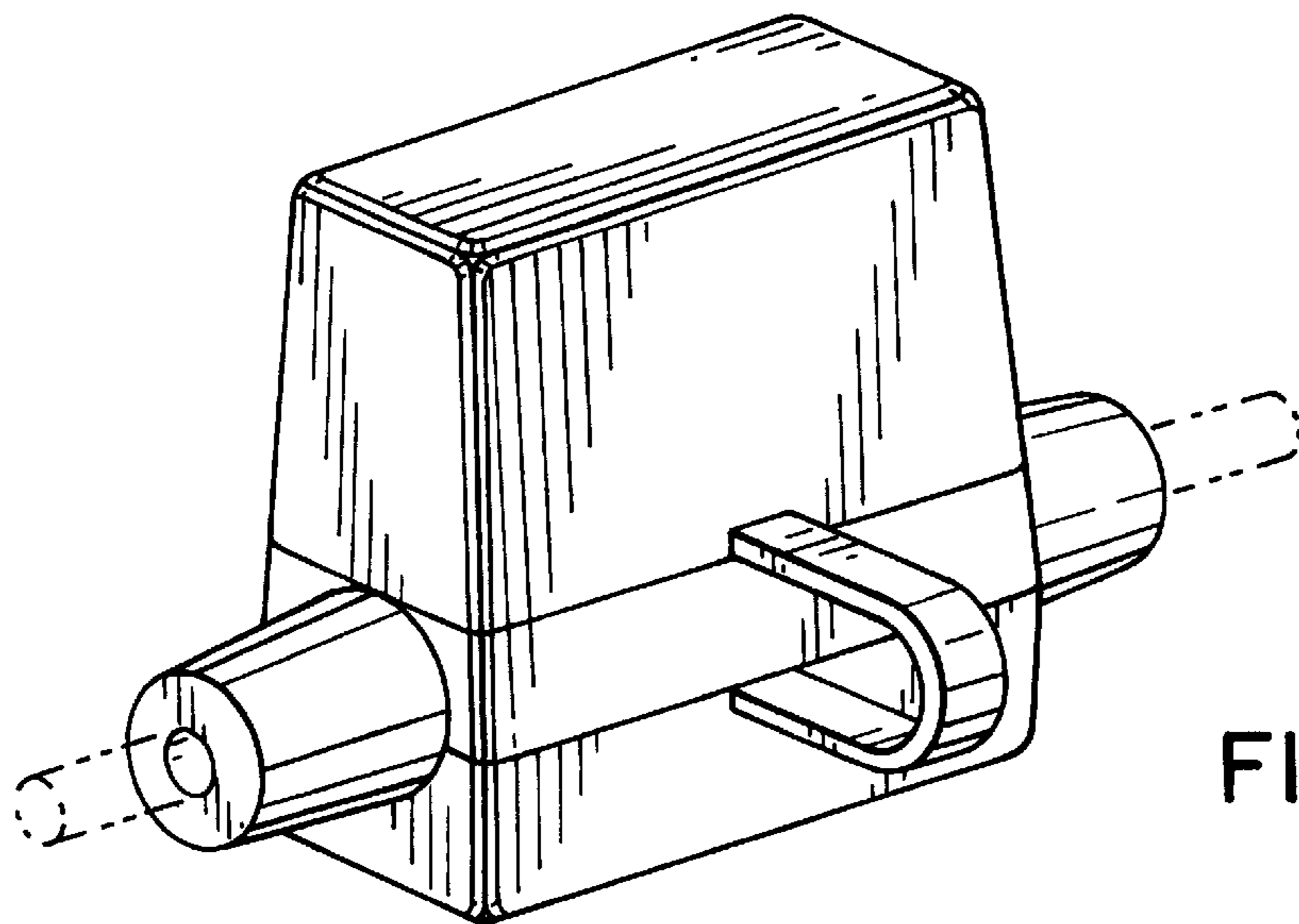

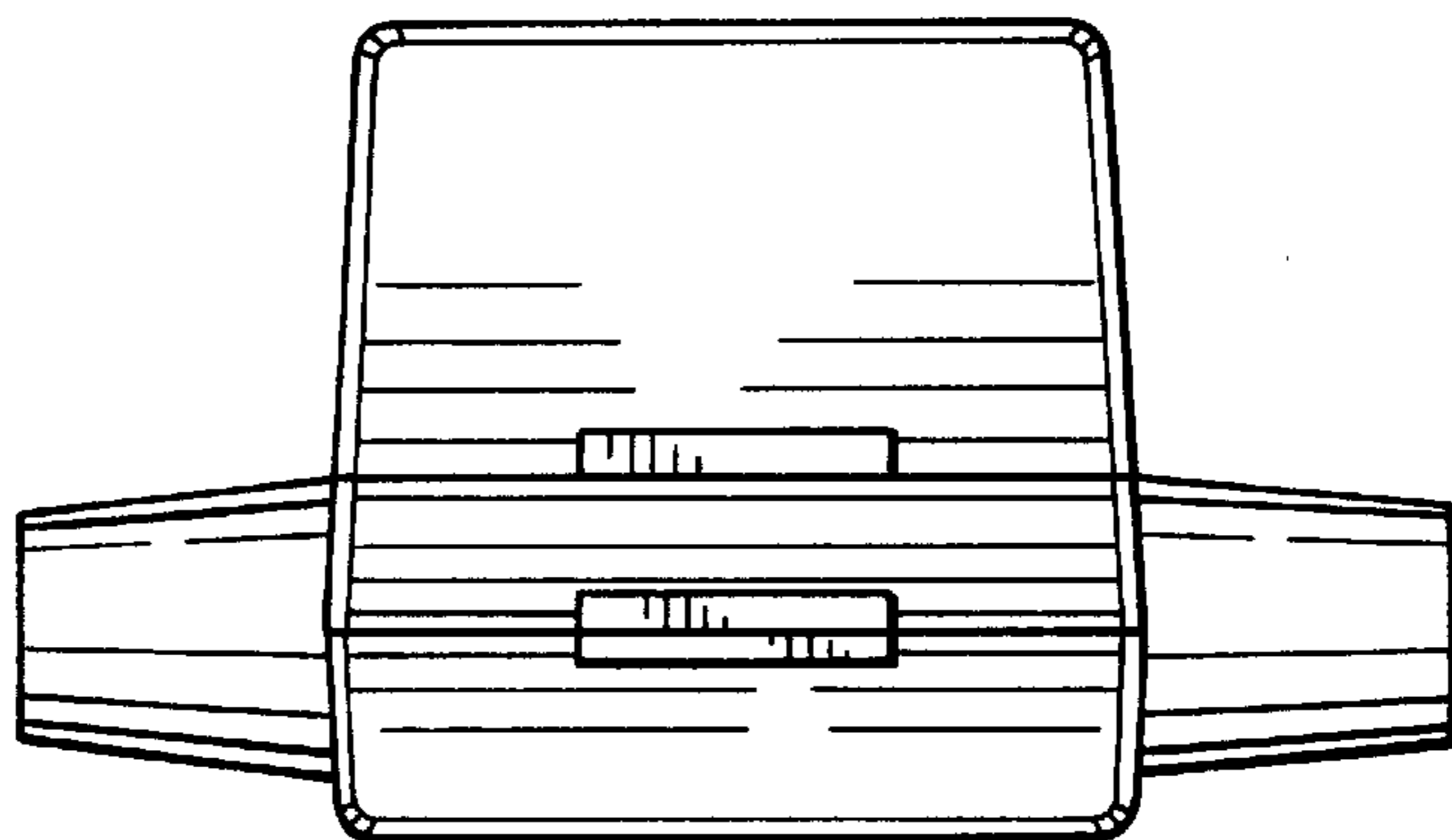

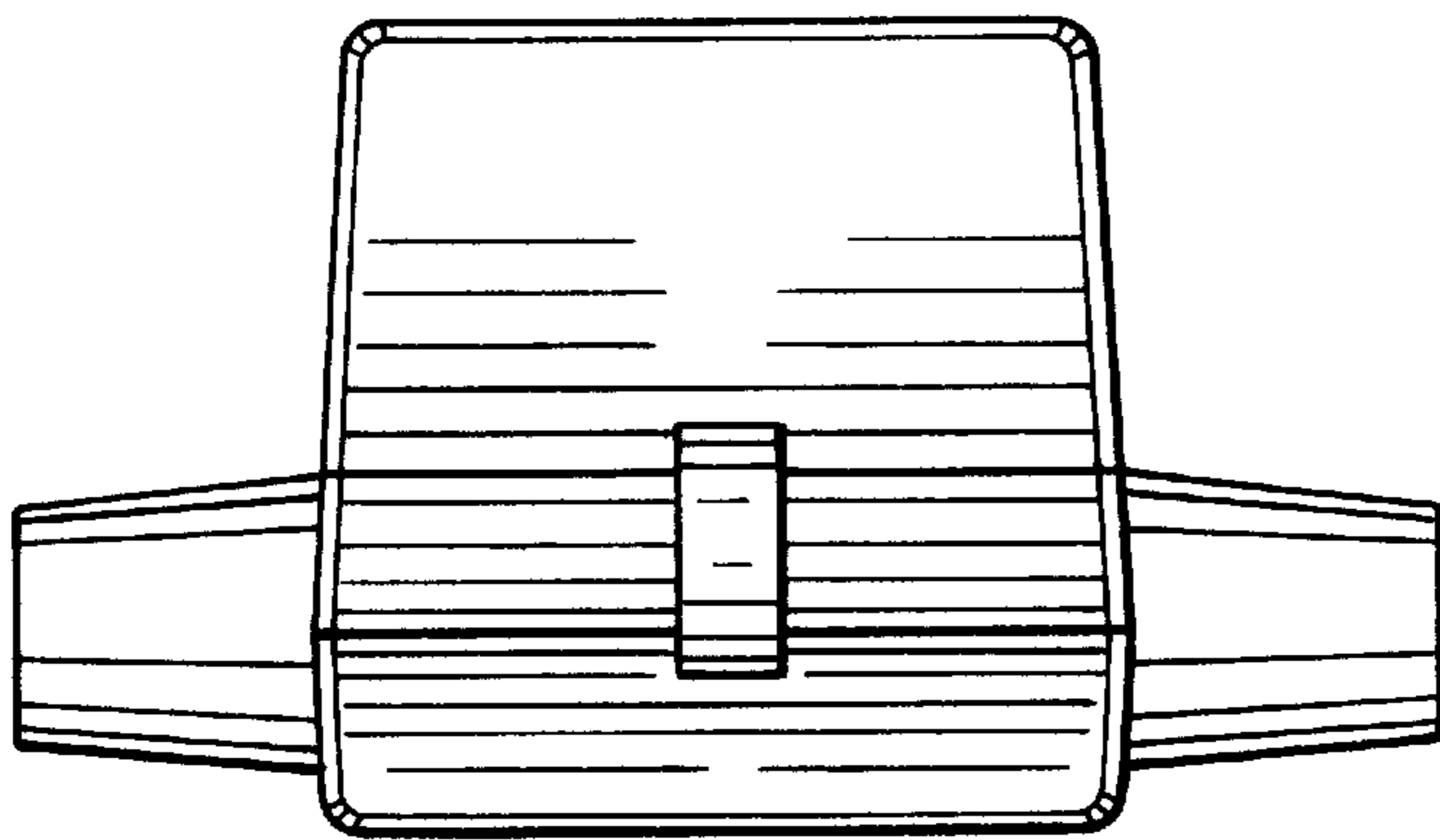

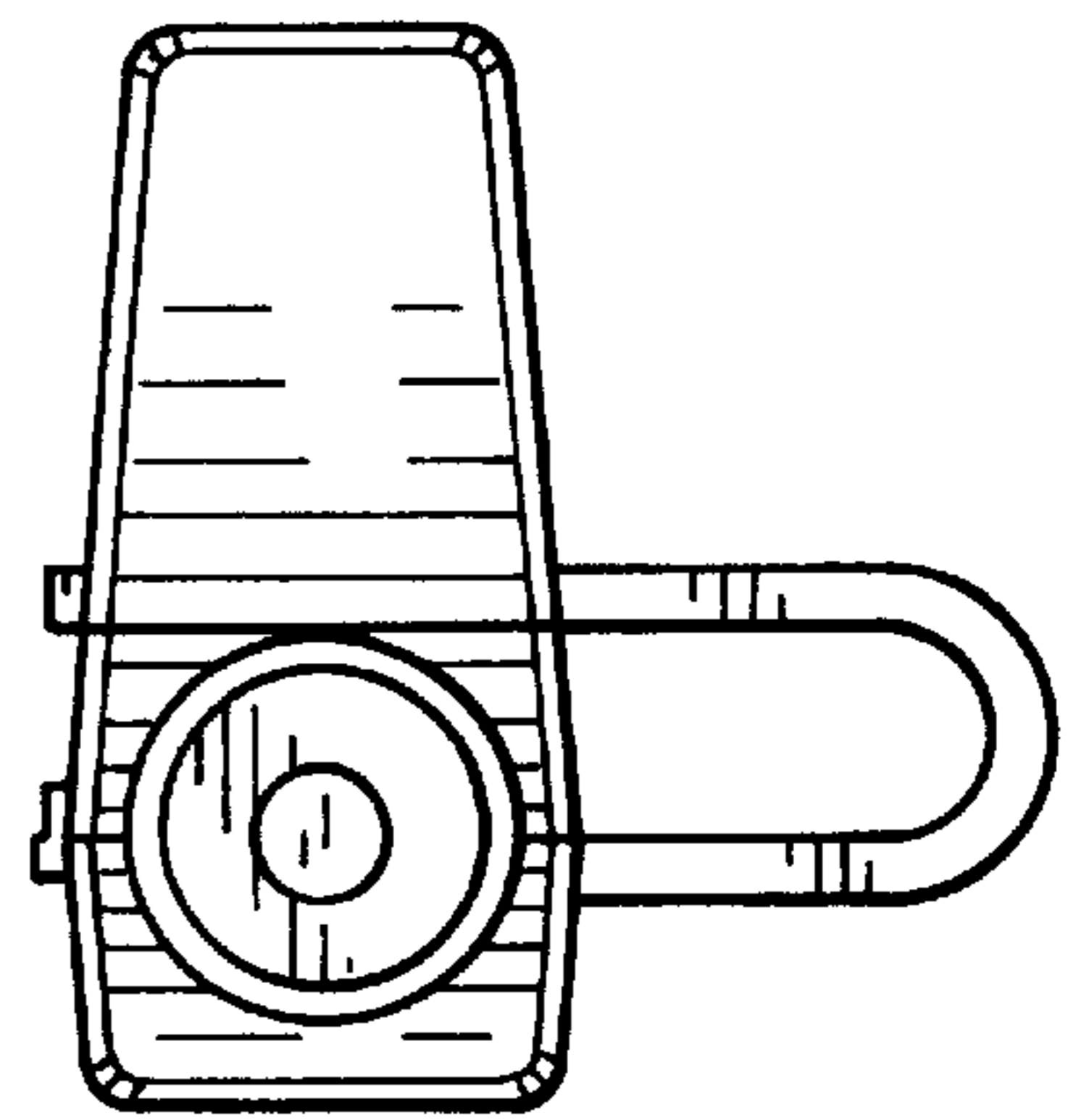

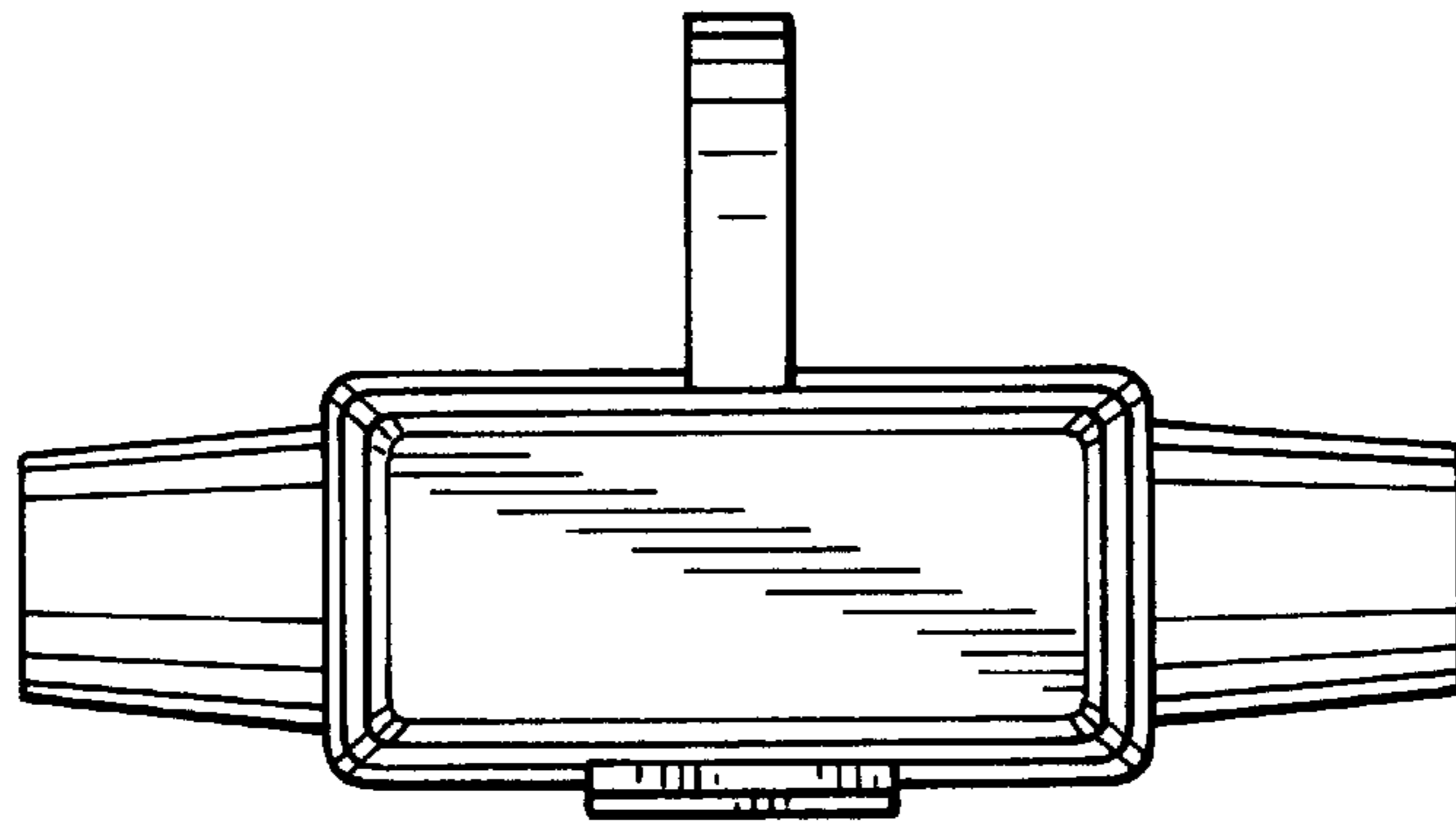

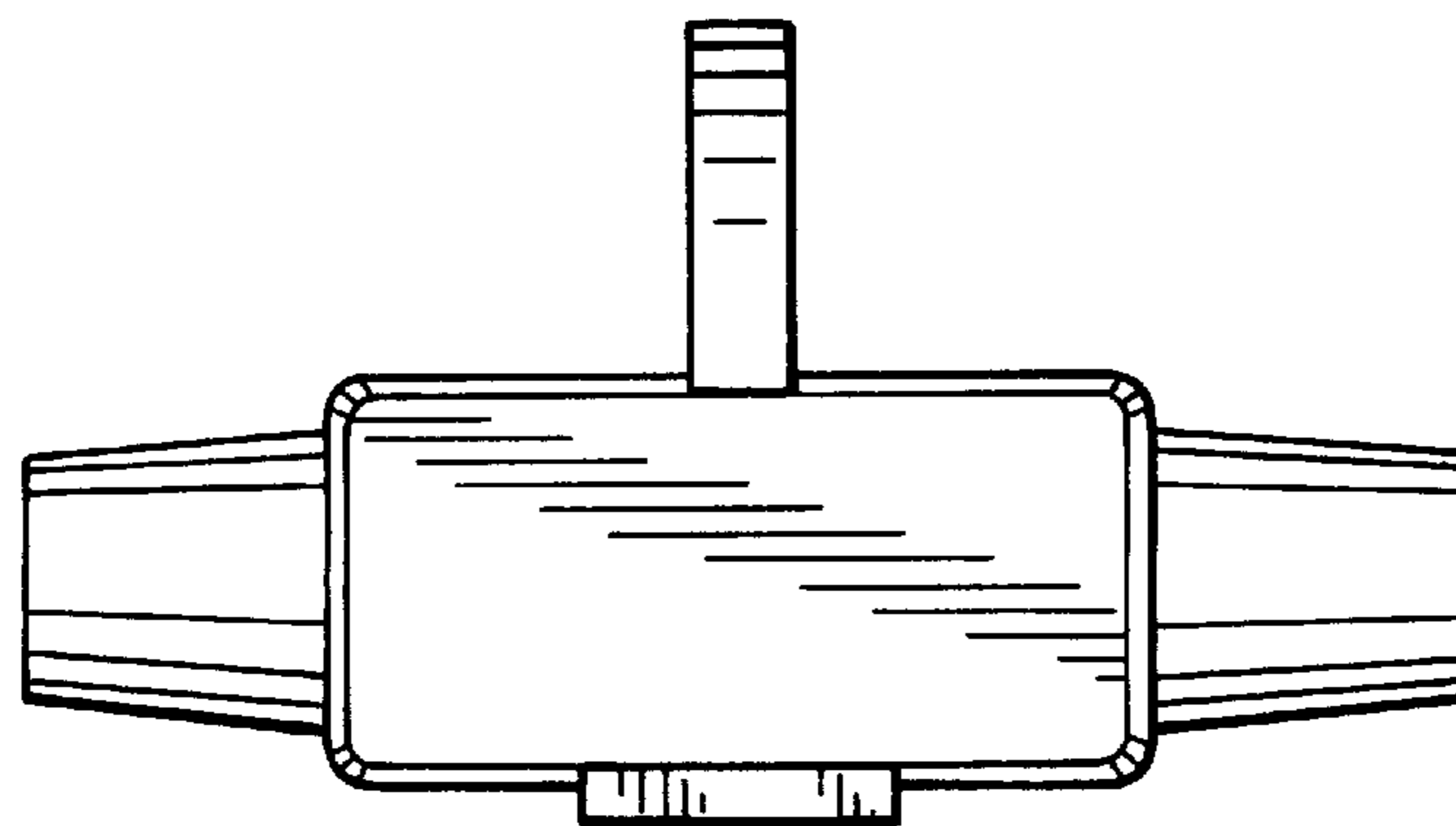

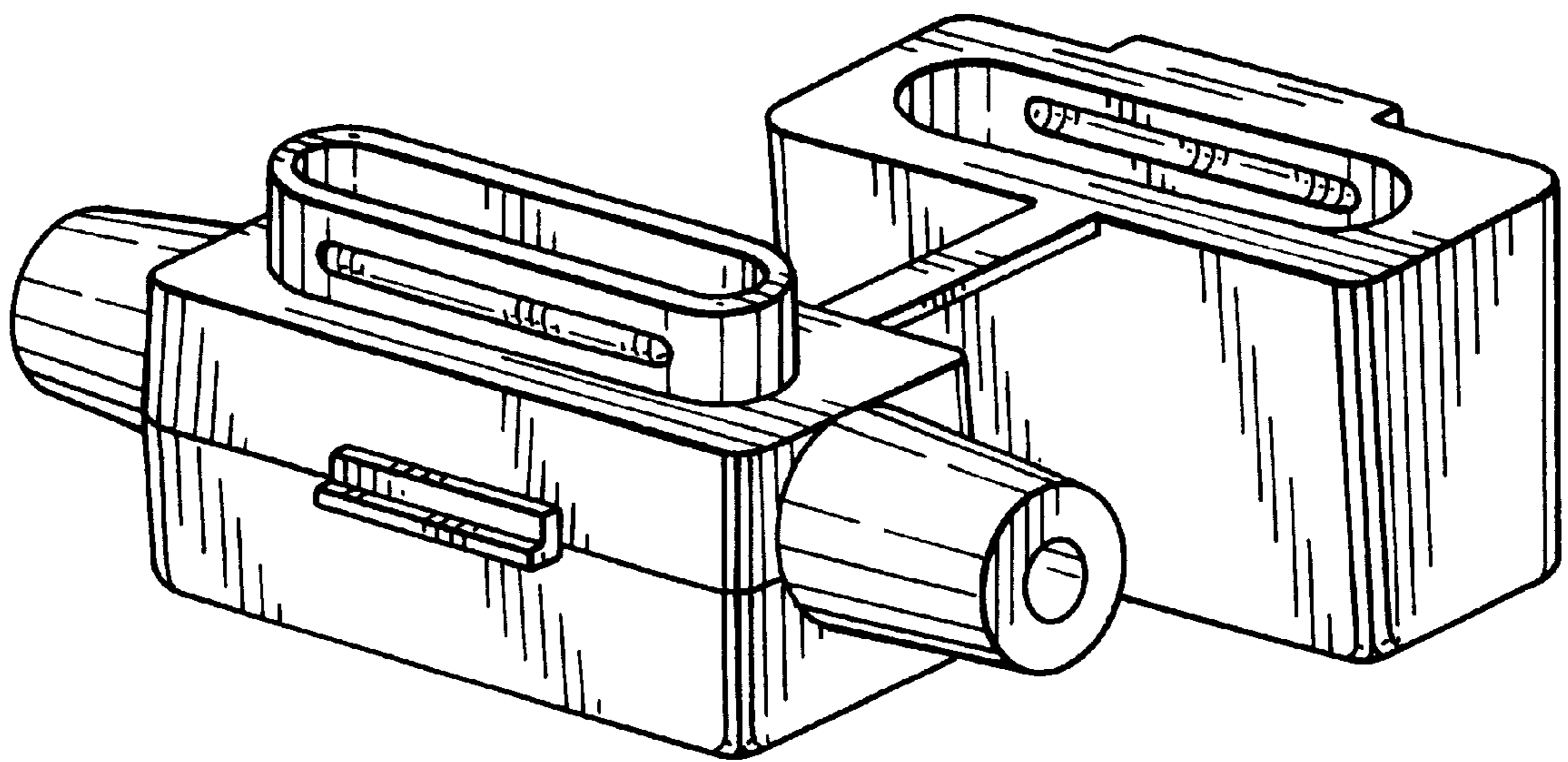

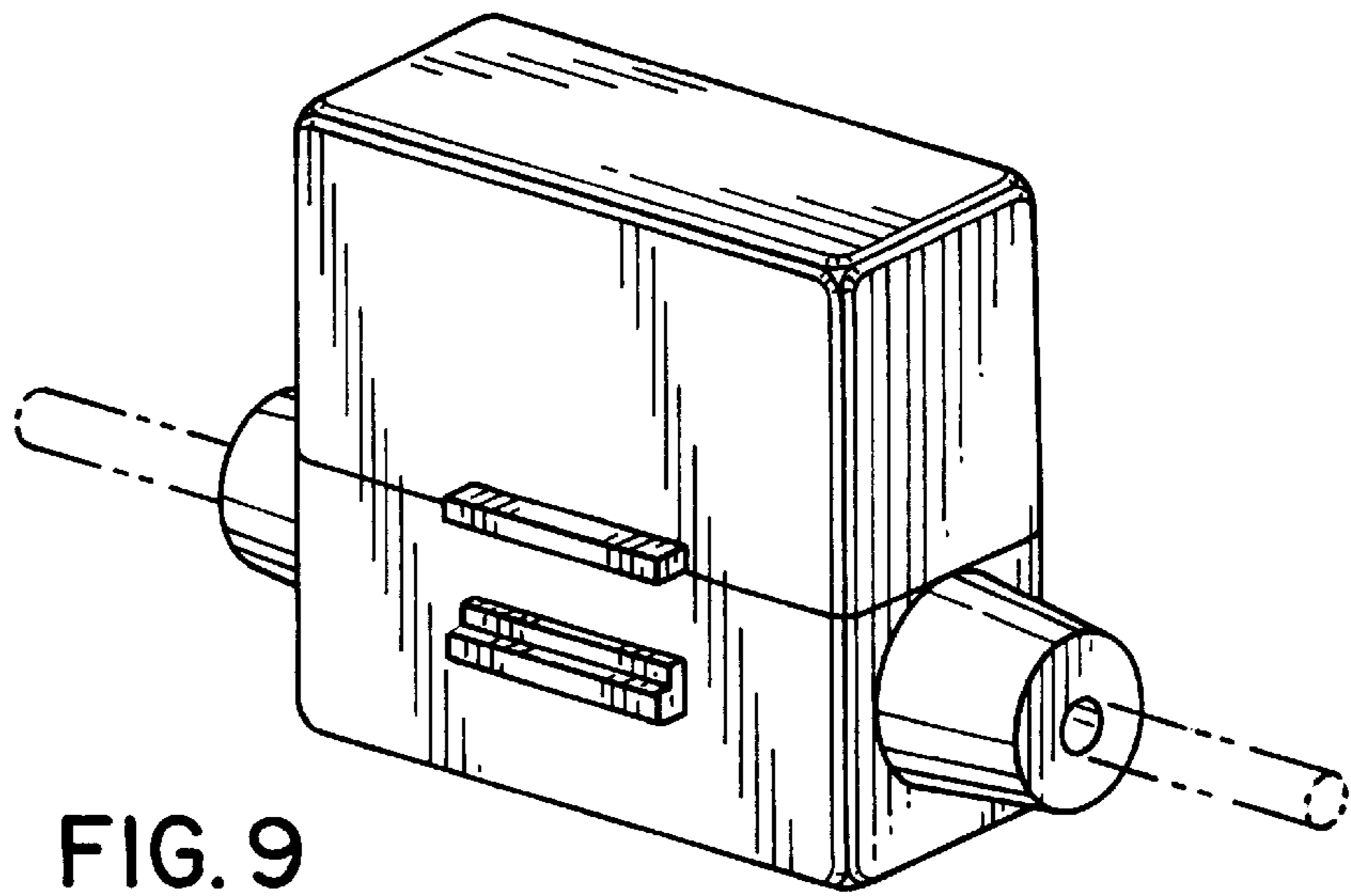

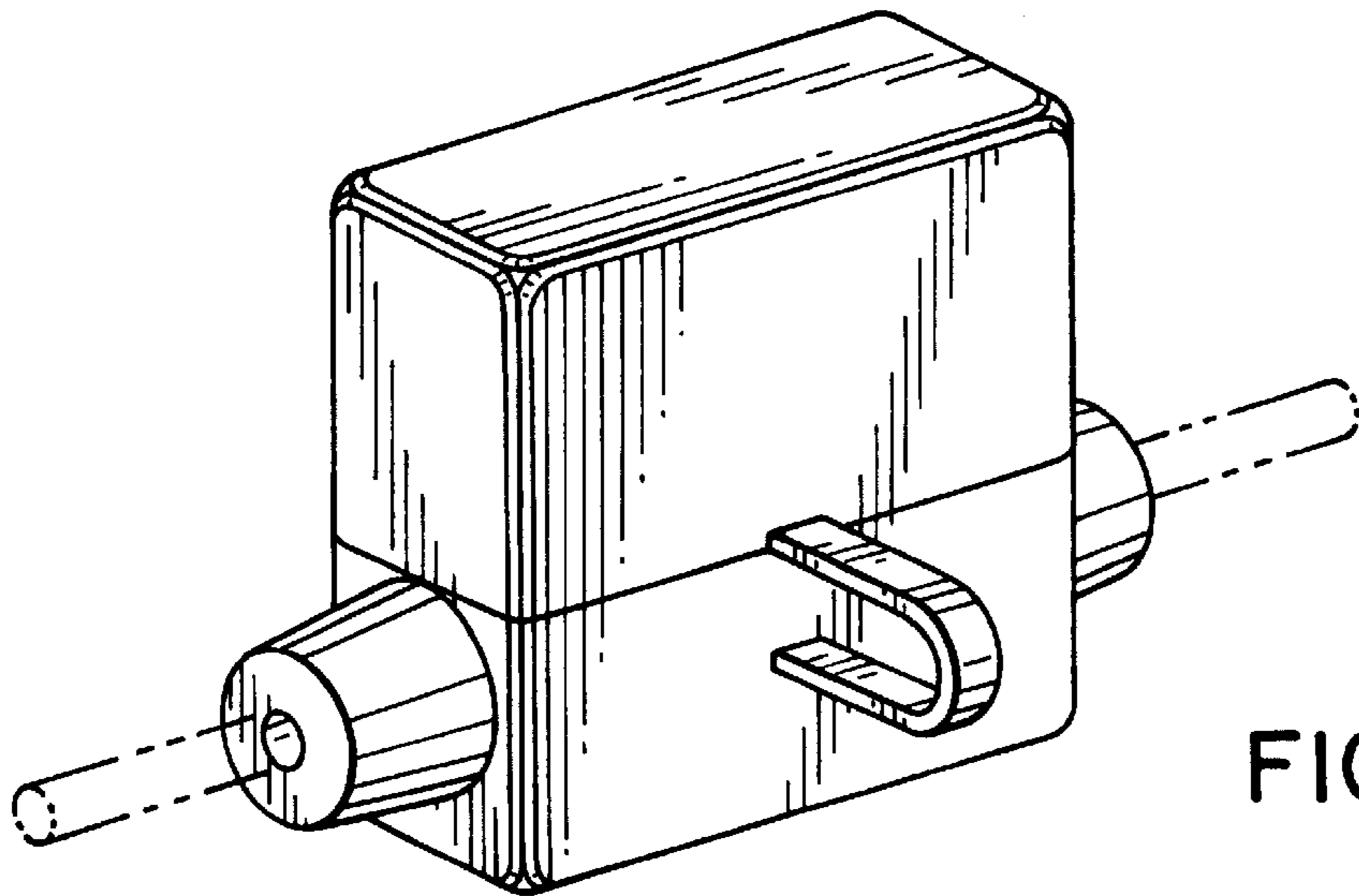

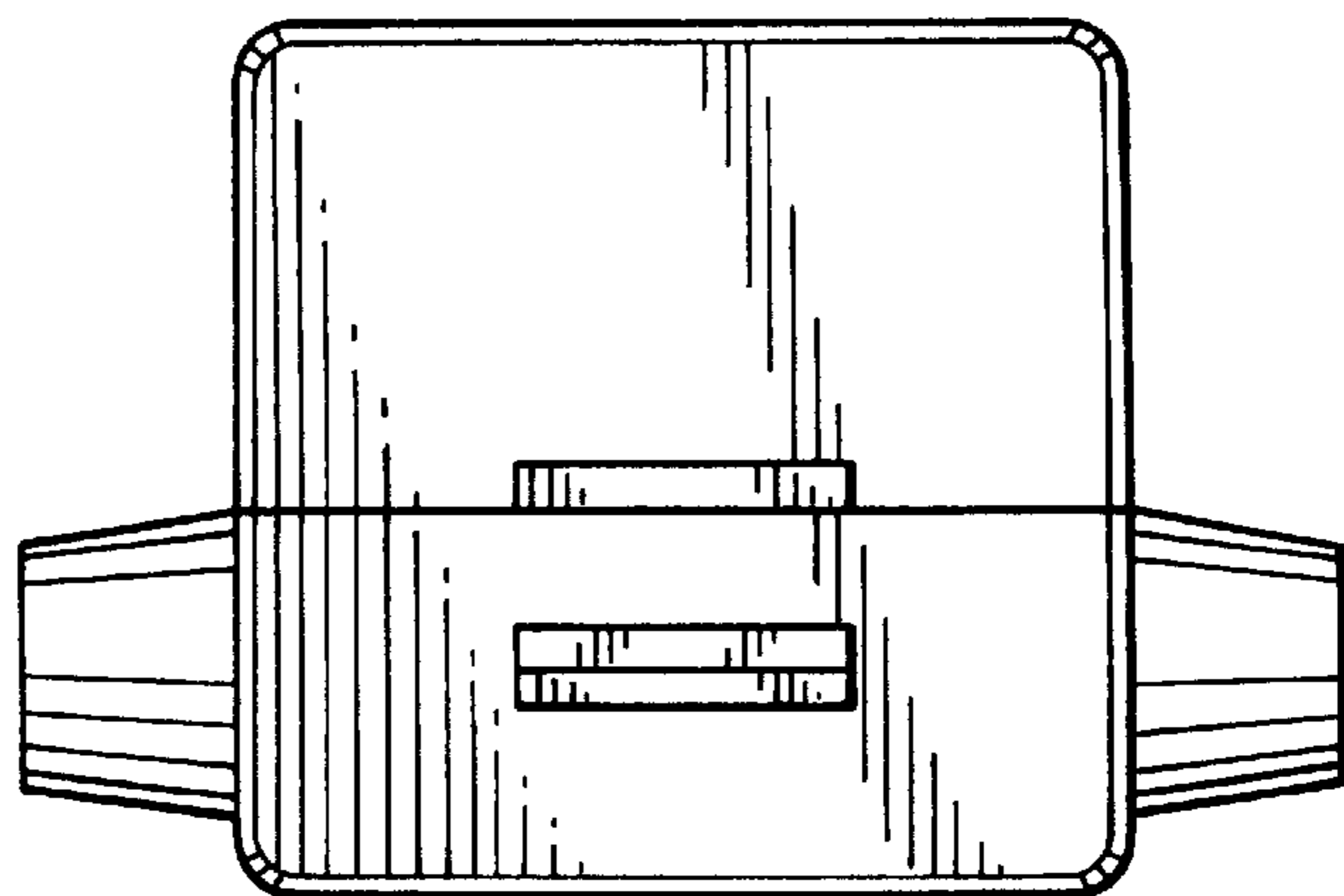

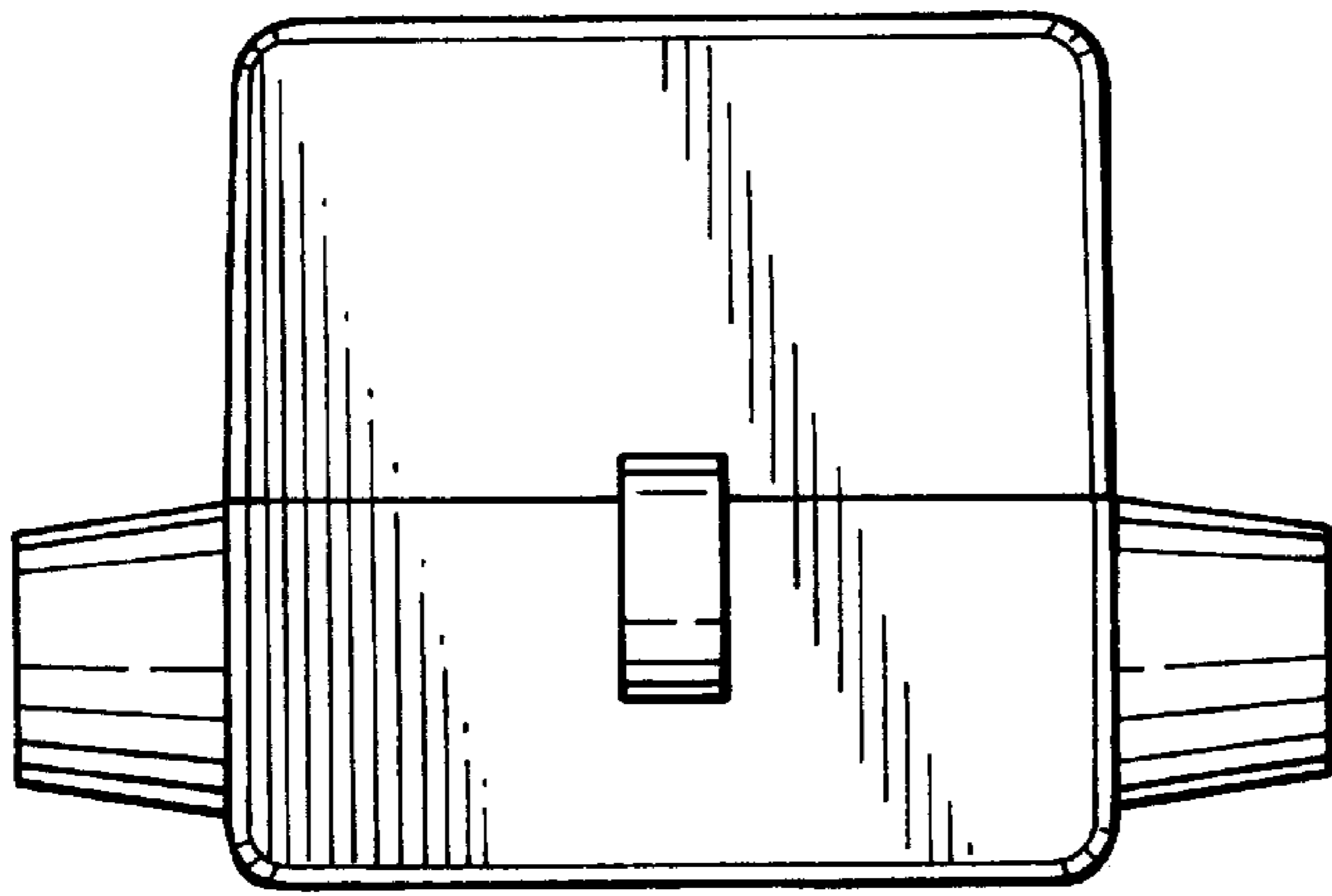

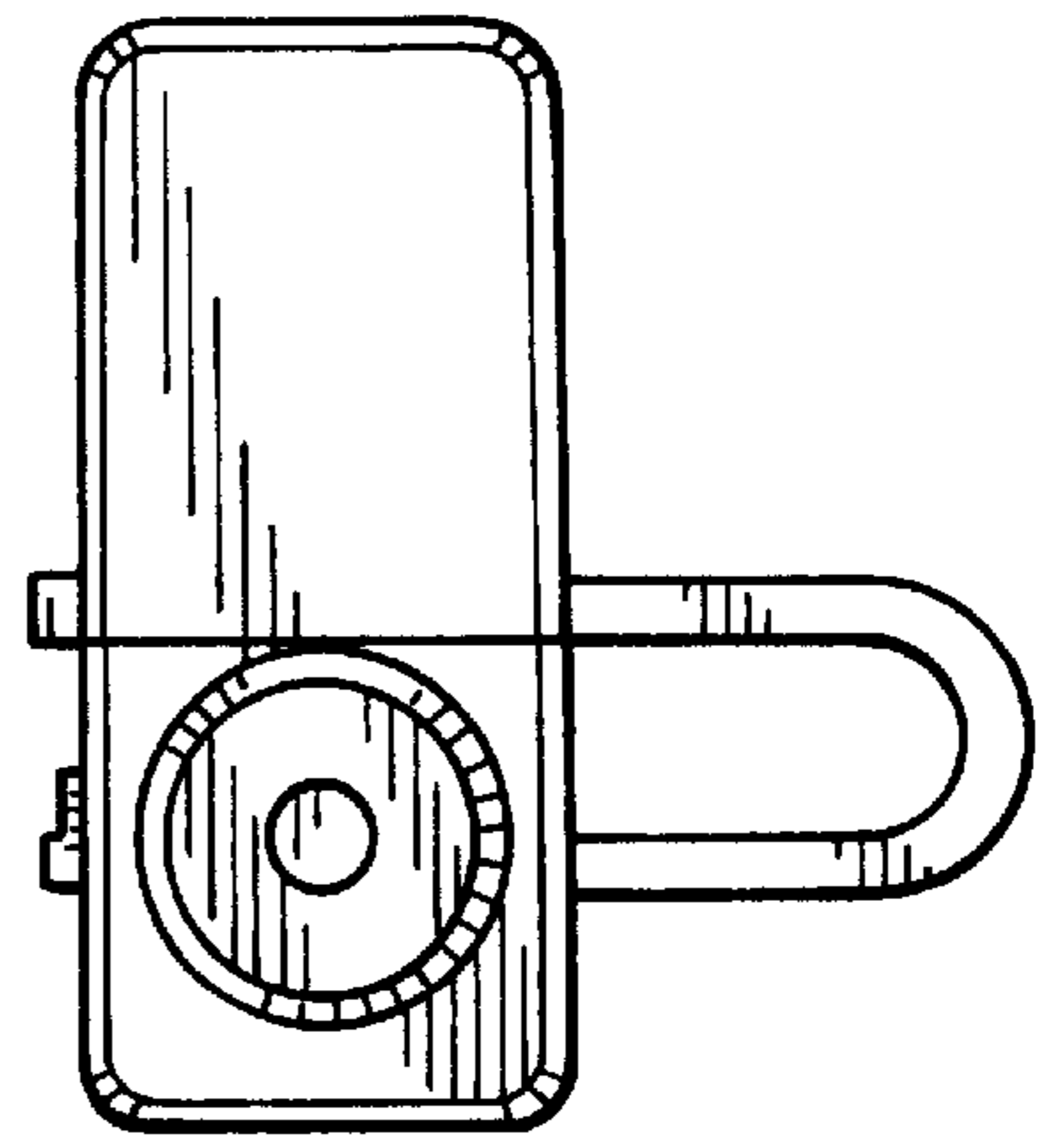

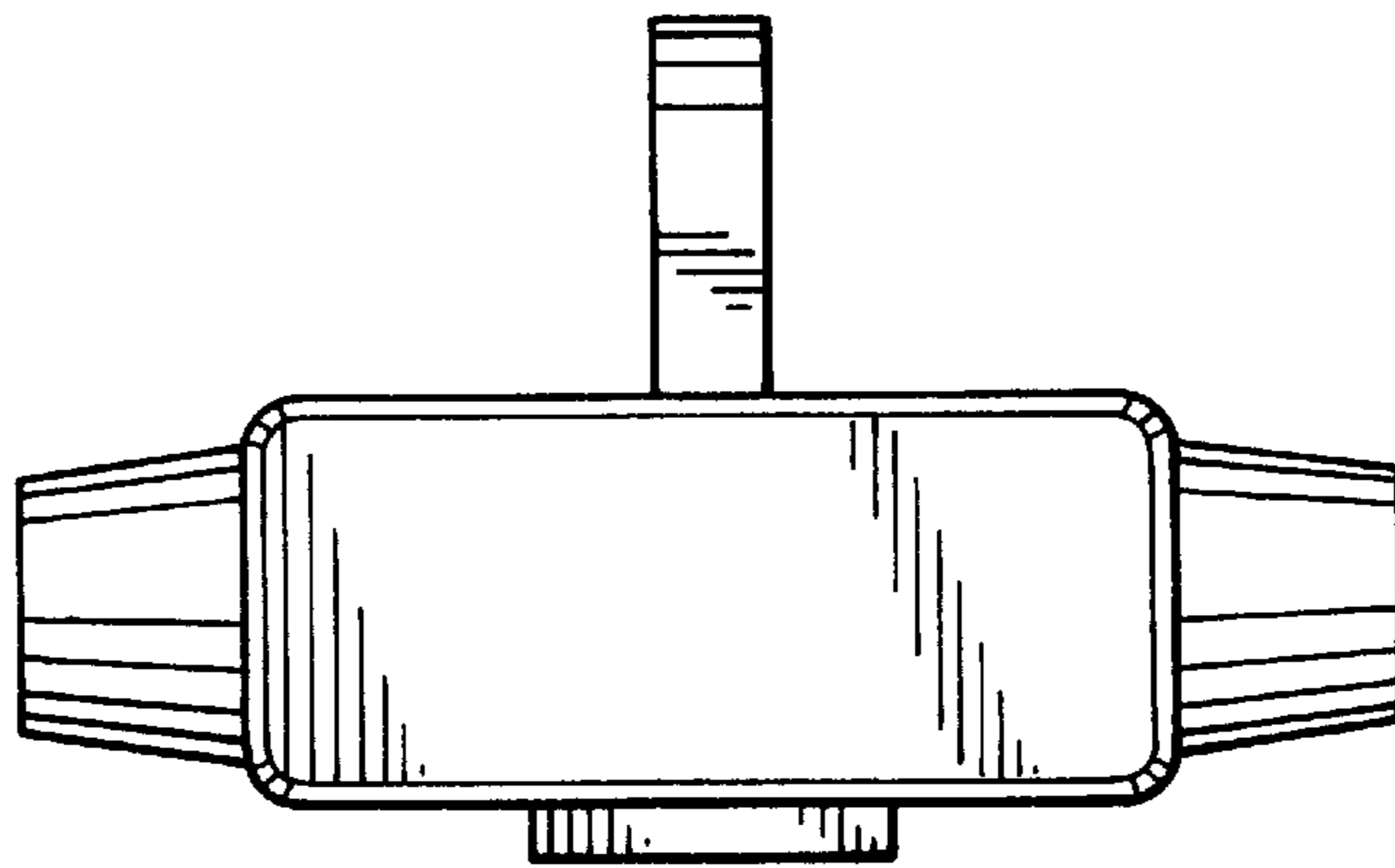

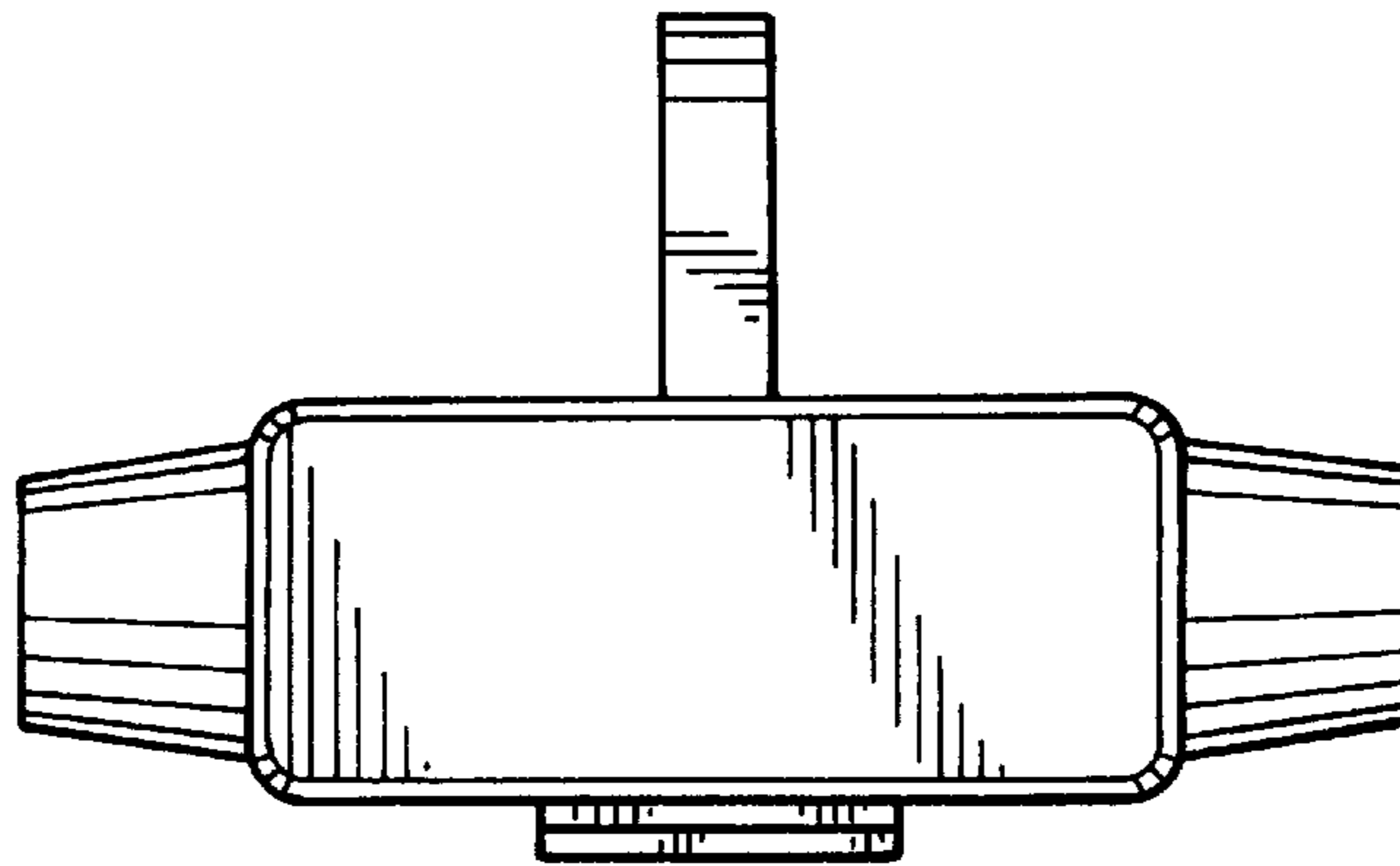

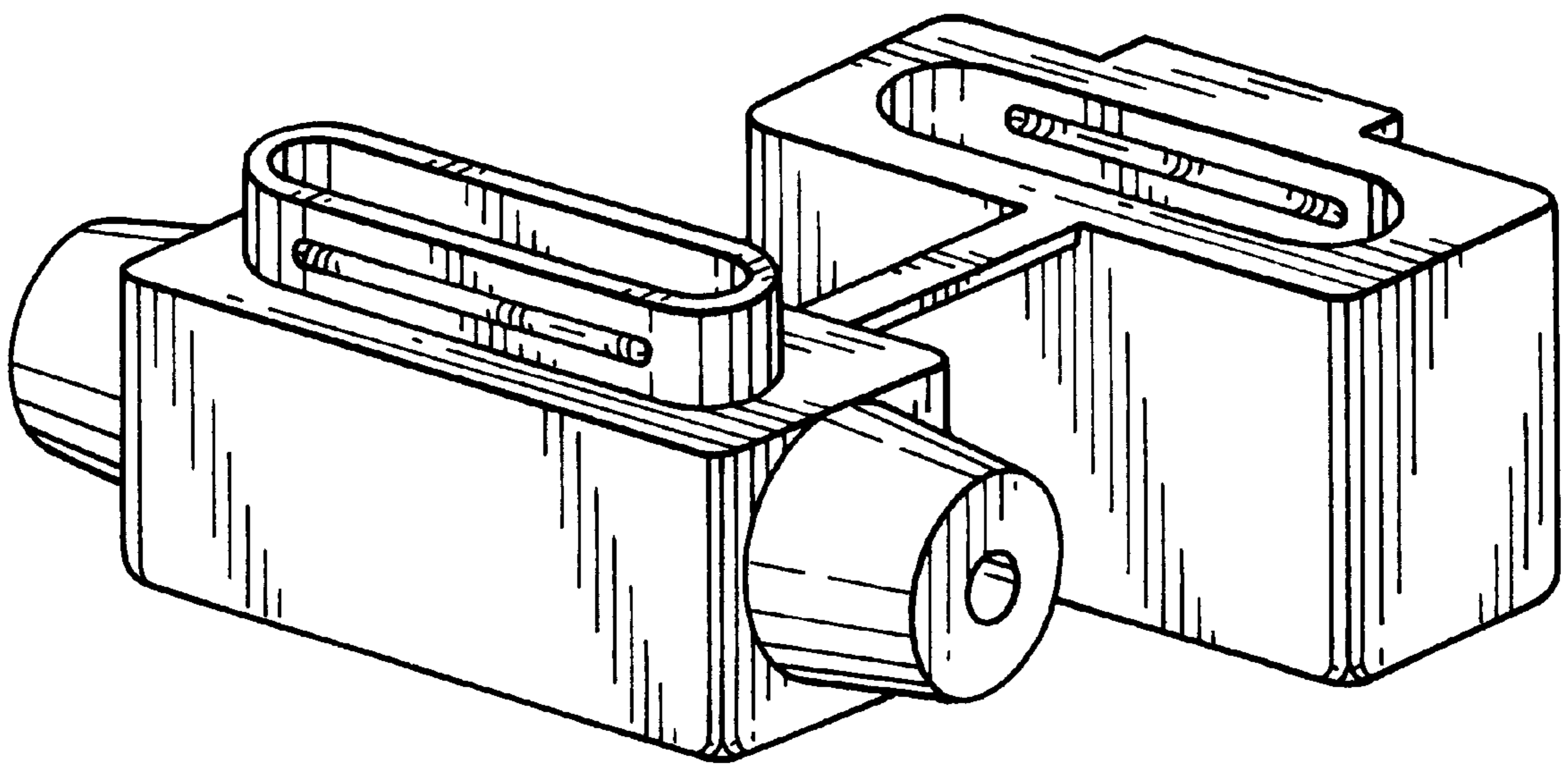
