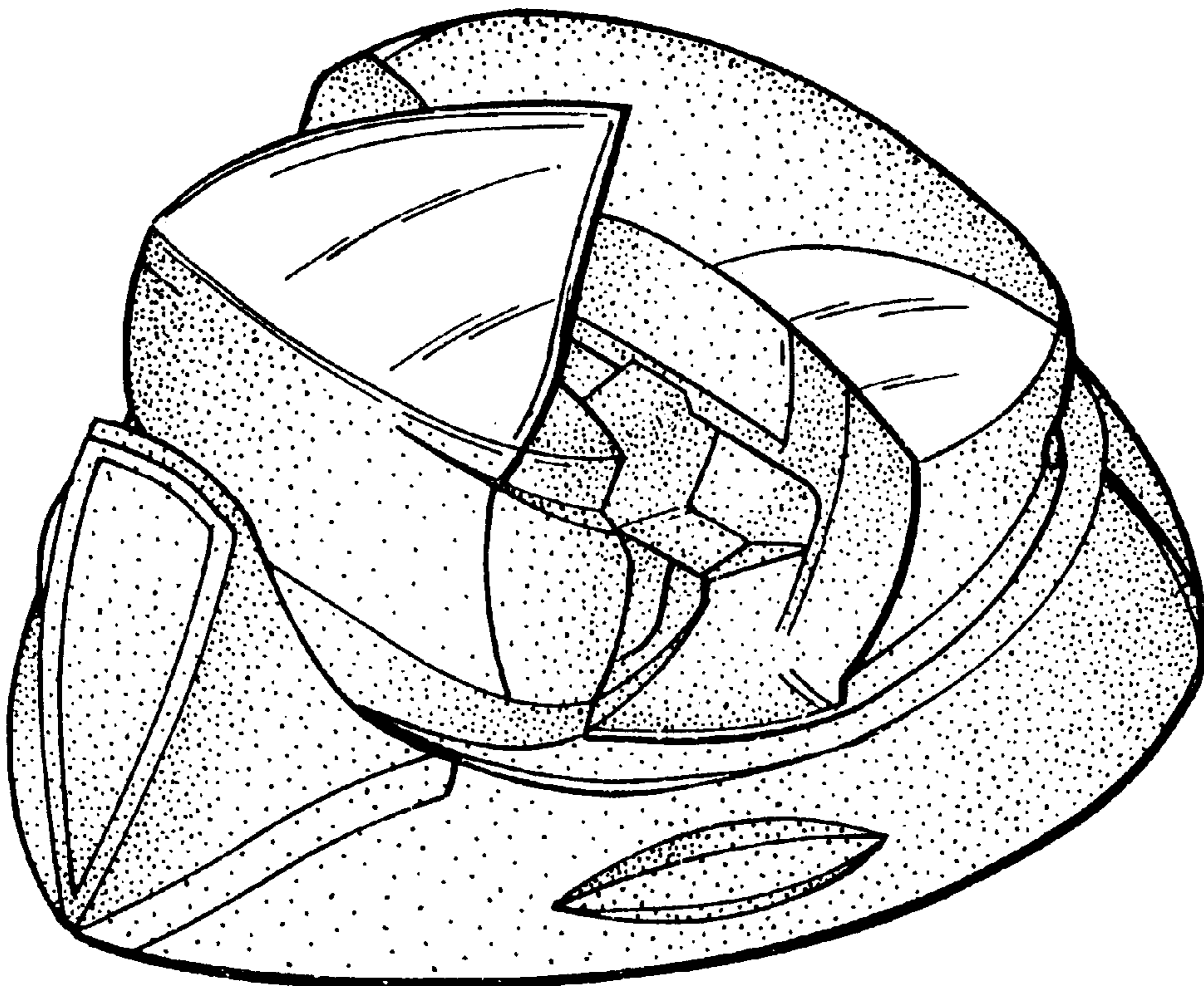
[57] **CLAIM**

The ornamental design for “a simulator capsule,” as shown and described.

DESCRIPTION

FIG. 1 is a top, rear and left side perspective view of a simulator capsule according to our design;
FIG. 2 is a top plan view thereof;
FIG. 3 is a front elevational view thereof;
FIG. 4 is a left side elevational view thereof, the right side being a mirror image; and,
FIG. 5 is a rear elevational view thereof.

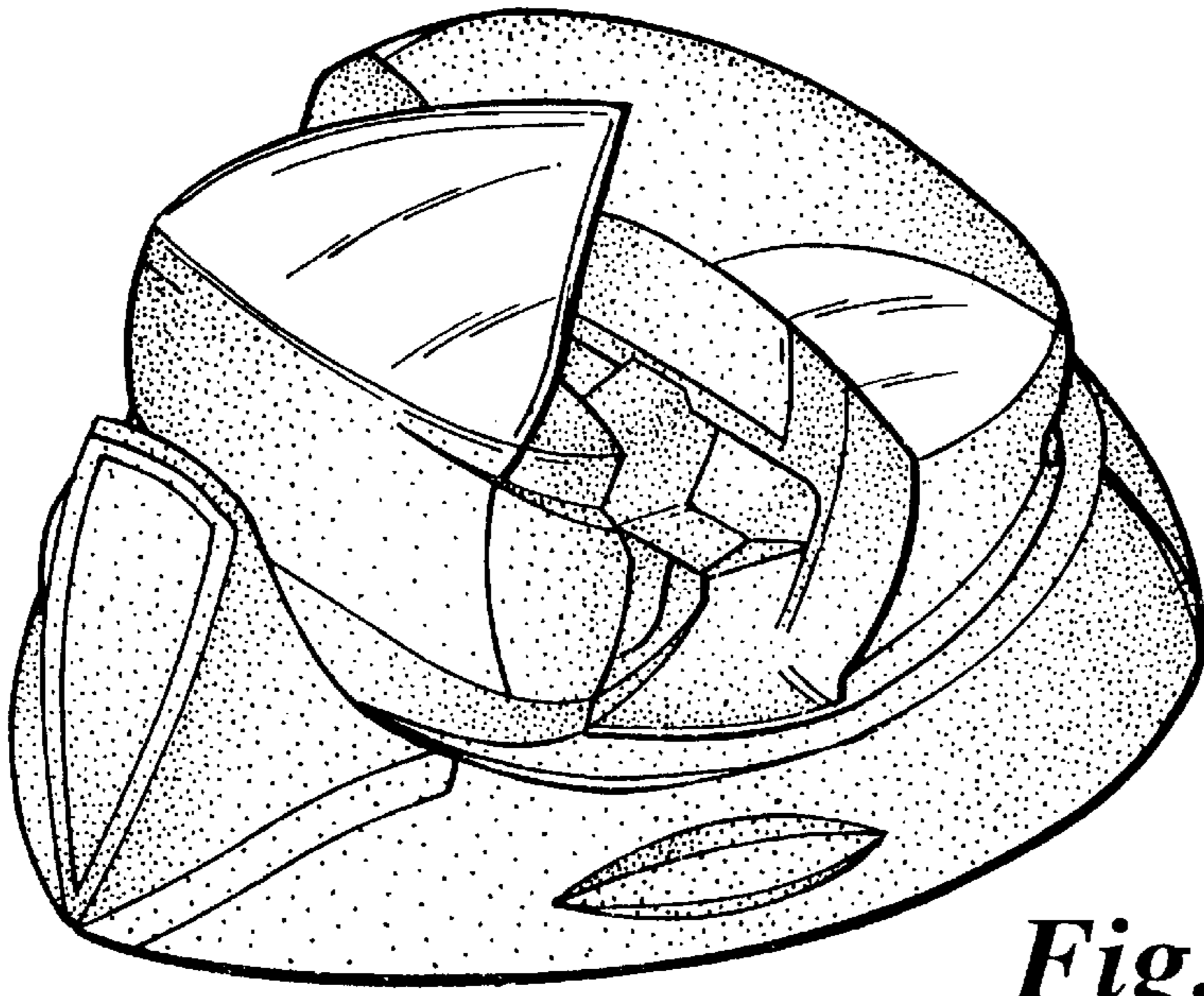

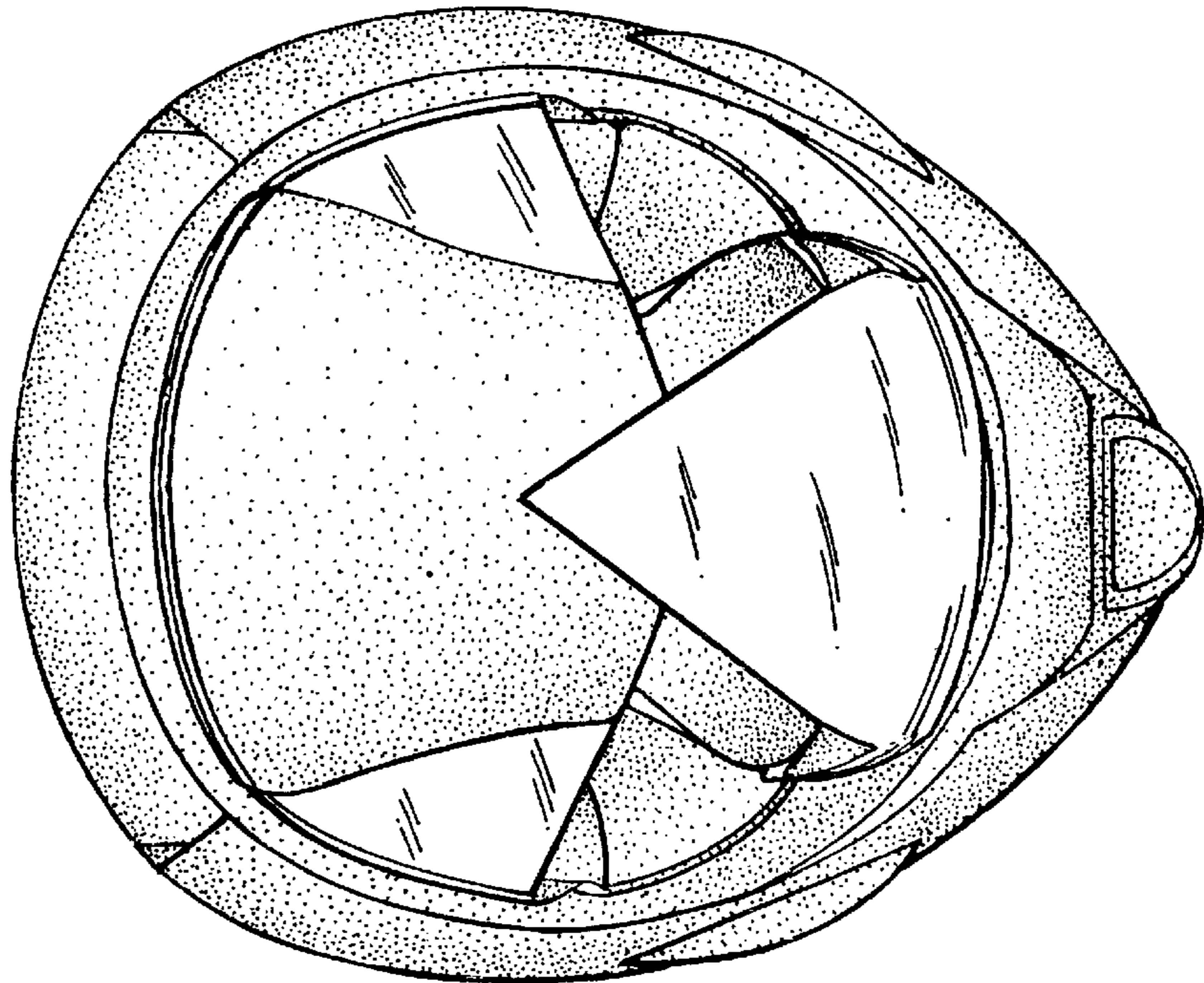

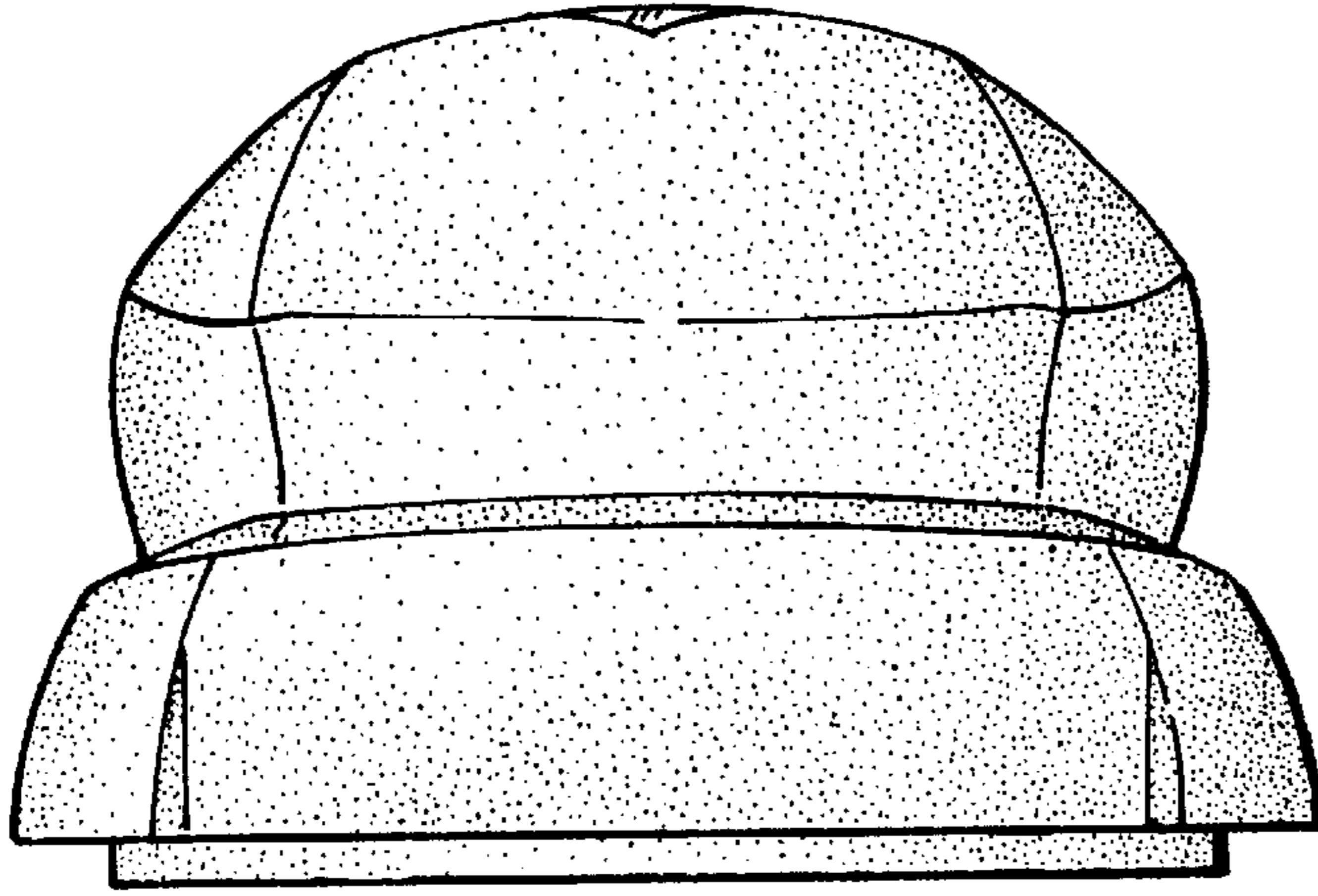

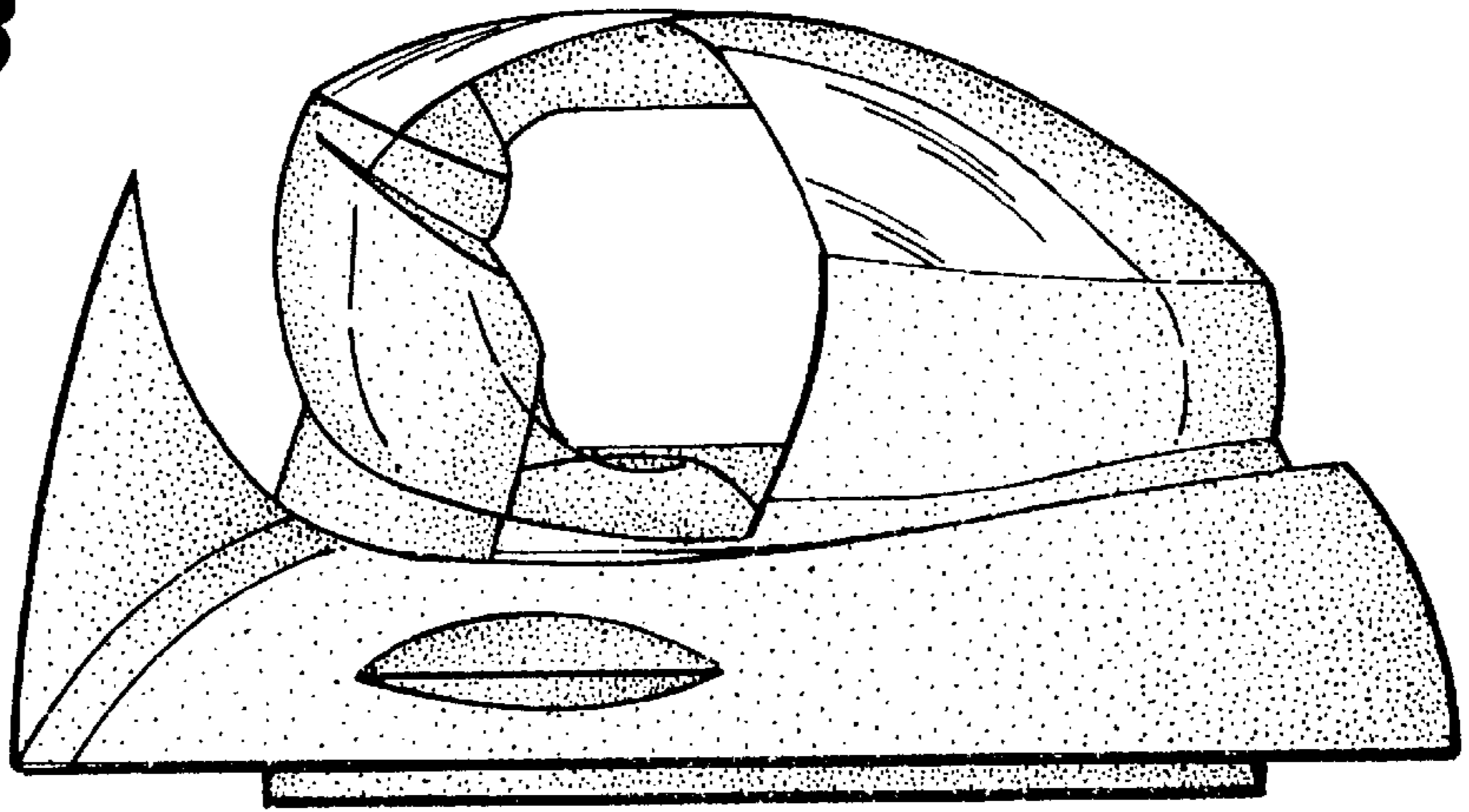

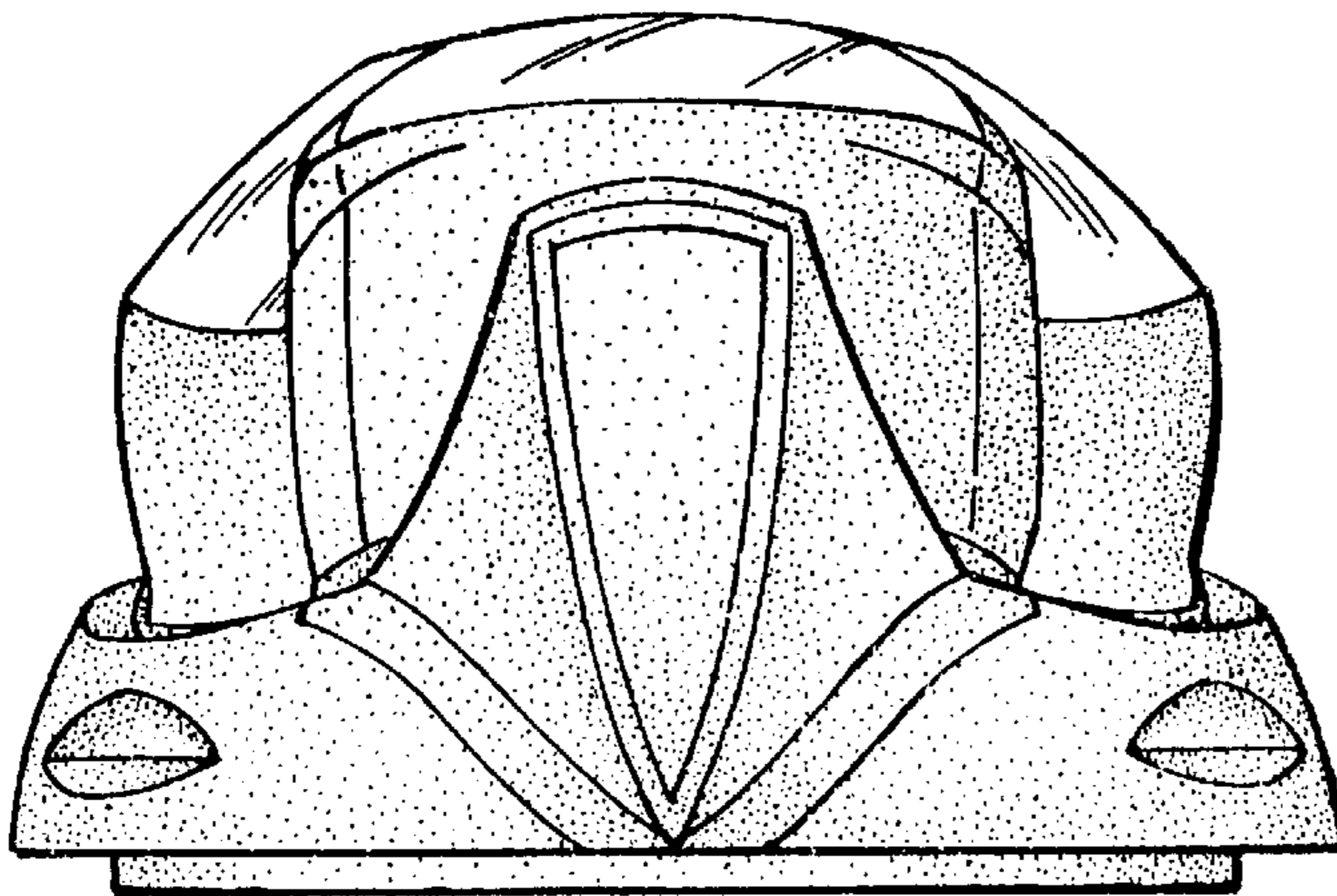
