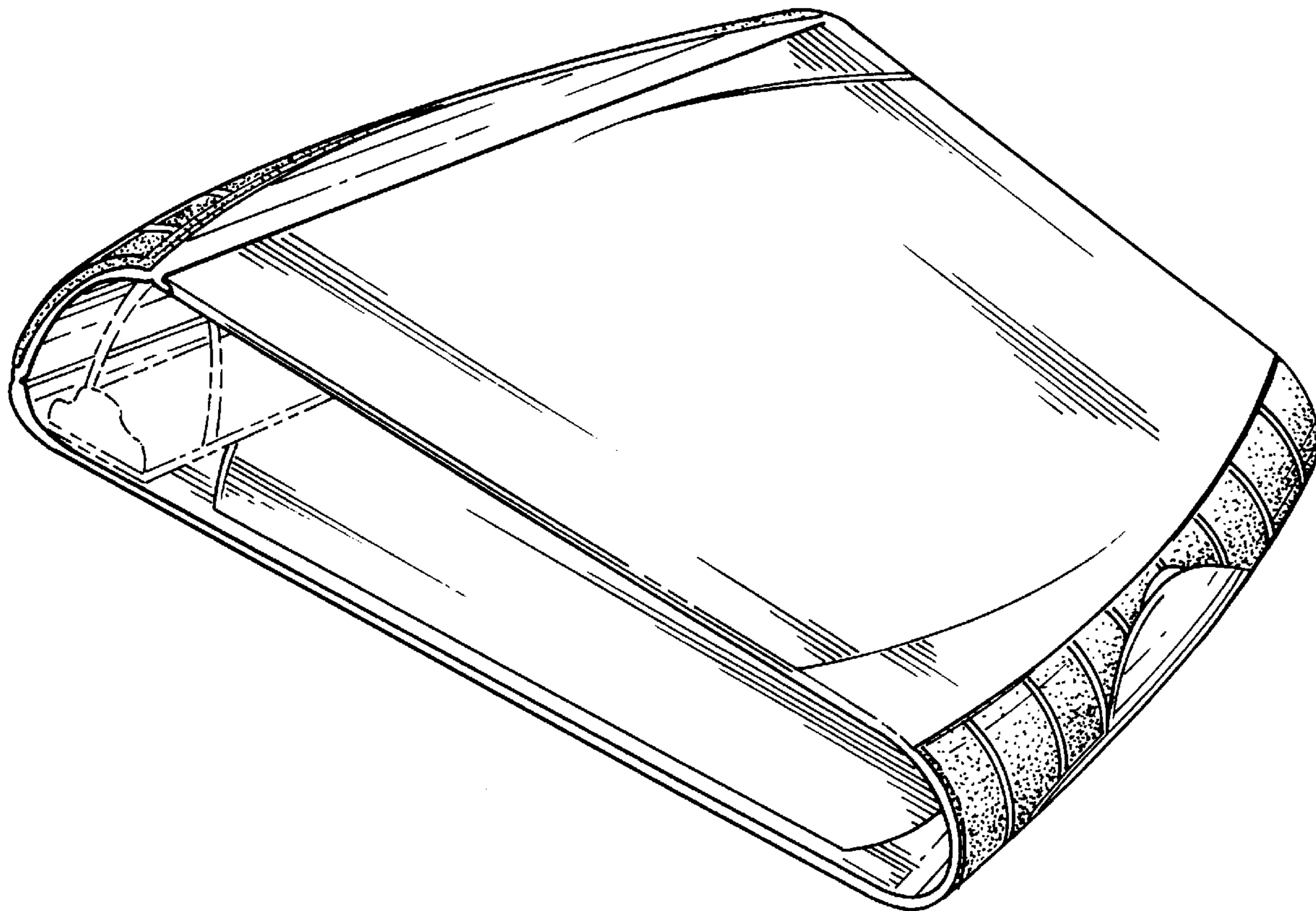
[57] **CLAIM**

The ornamental design for a curved configuration binder, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of our design; FIG. 2 is a front view of our design; FIG. 3 is a rear view of our design; FIG. 4 is a right side view of our design; FIG. 5 is a left side view of our design; FIG. 6 is a top view of our design; and, FIG. 7 is a bottom view of our design. The ring binding structure depicted by means of broken lines in FIGS. 1, 6 and 7 has been shown for illustrative purposes only and forms no part of the claimed design.

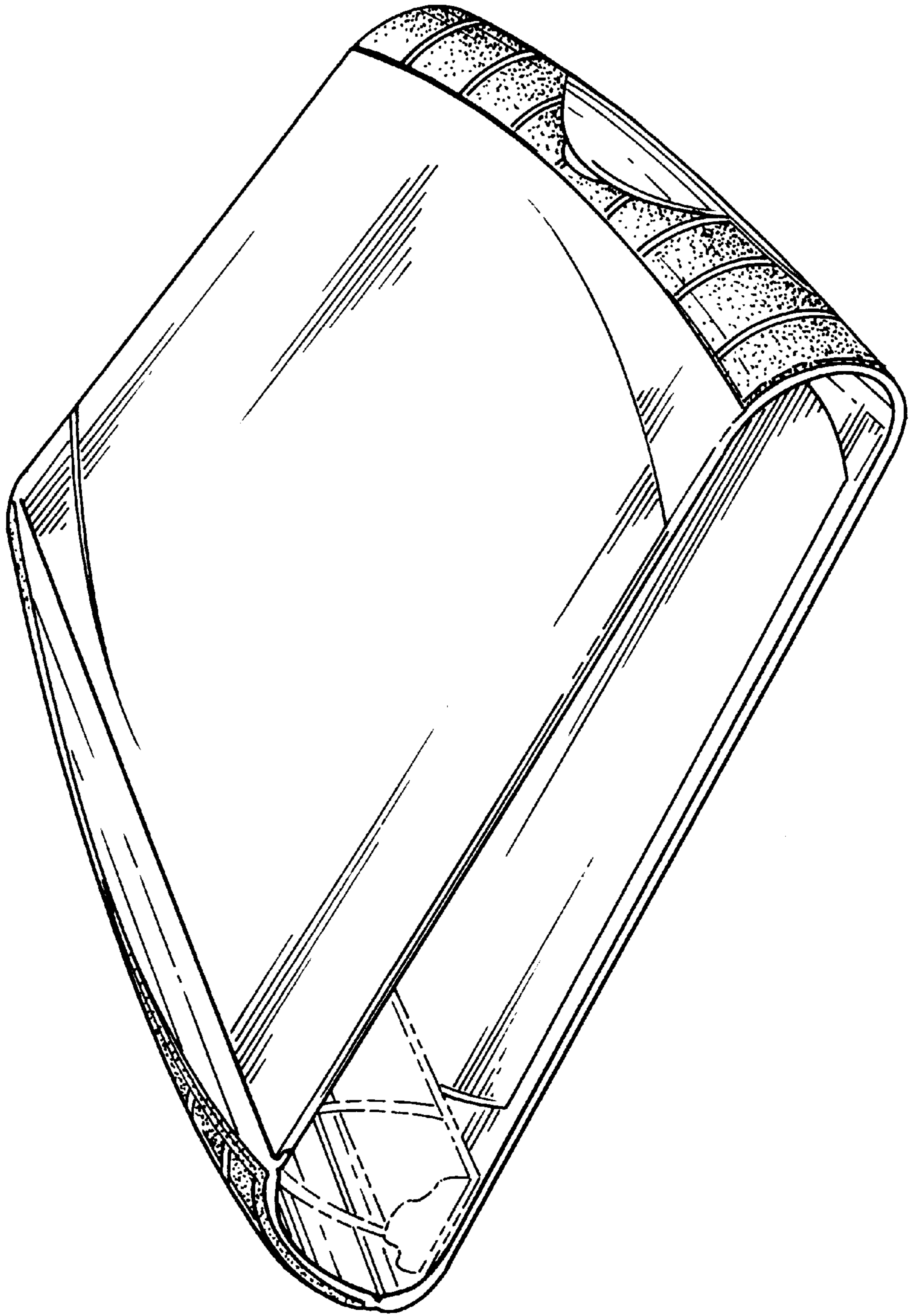

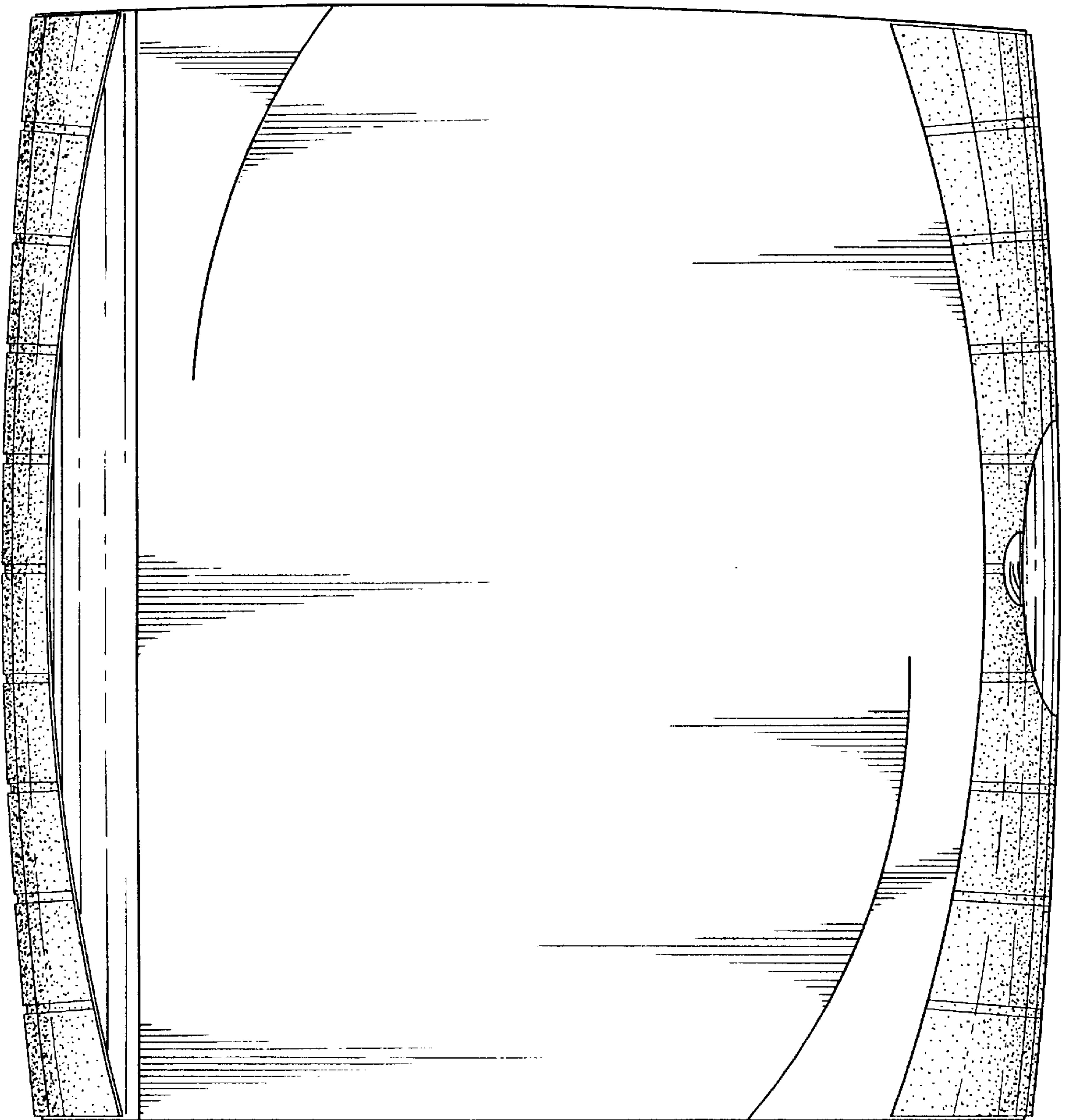

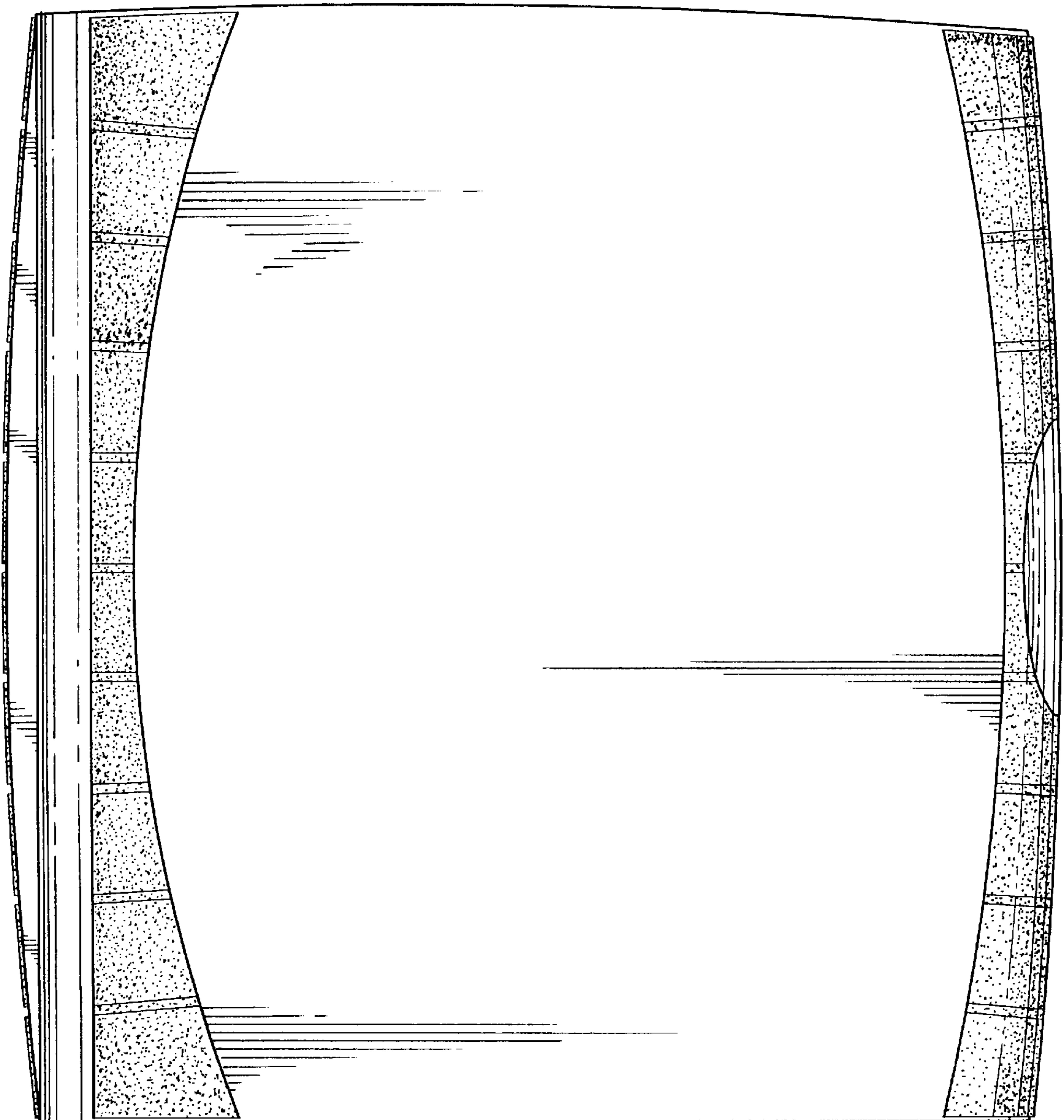

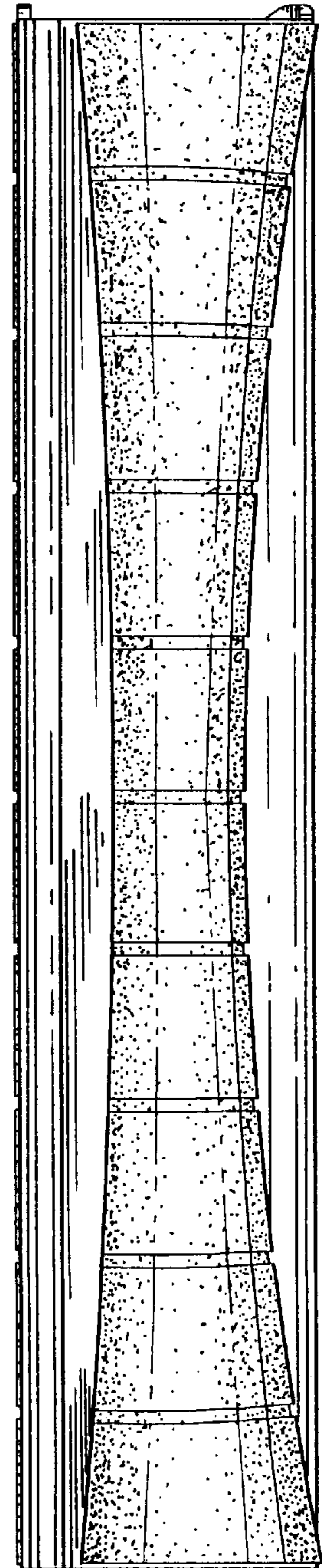

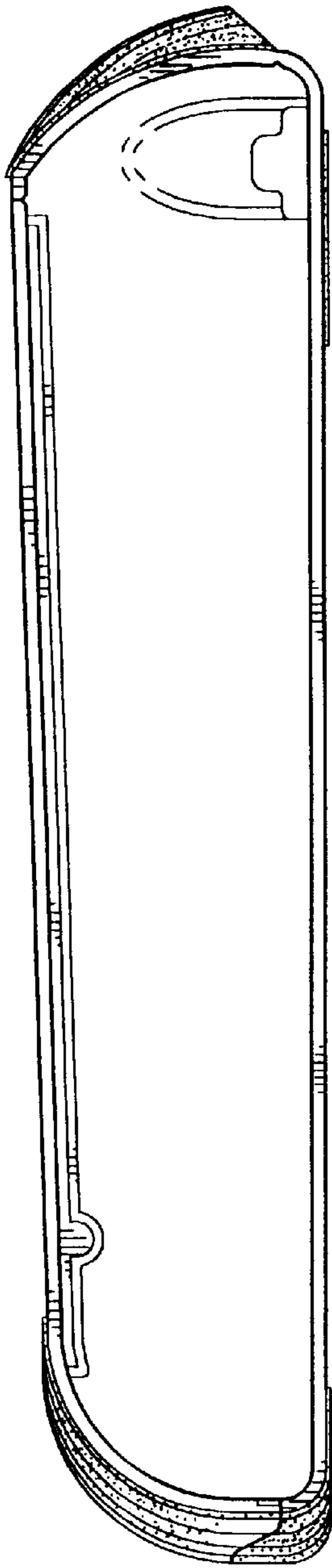

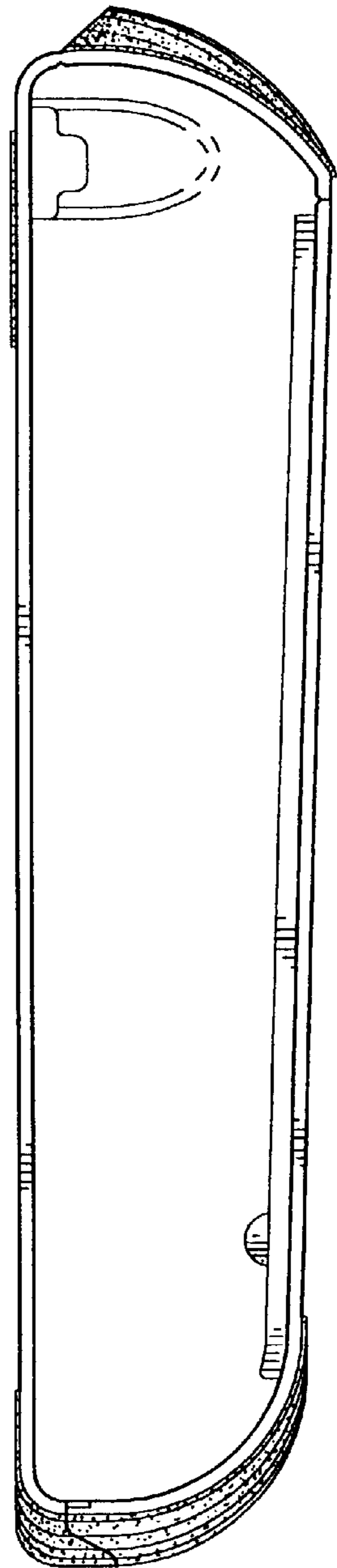
