**DESCRIPTION**

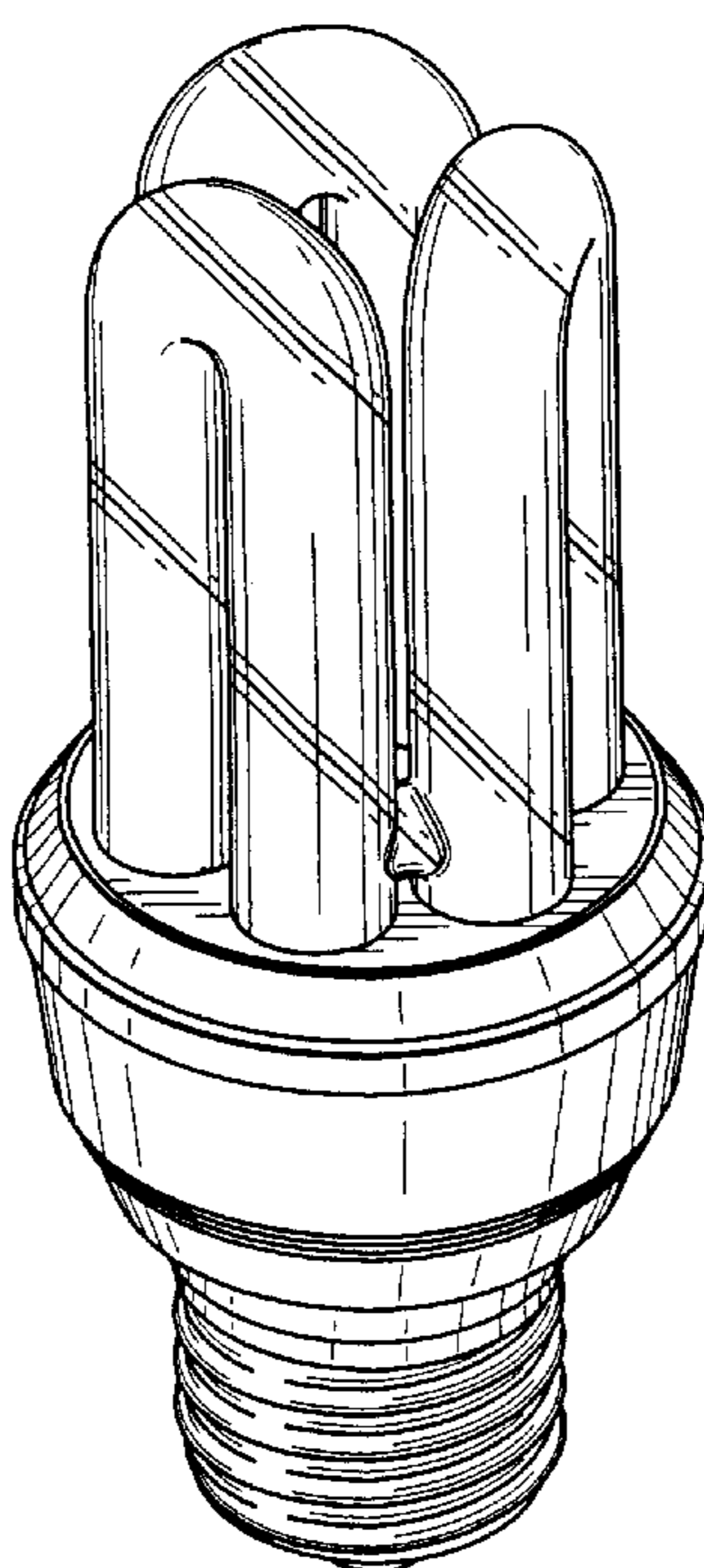

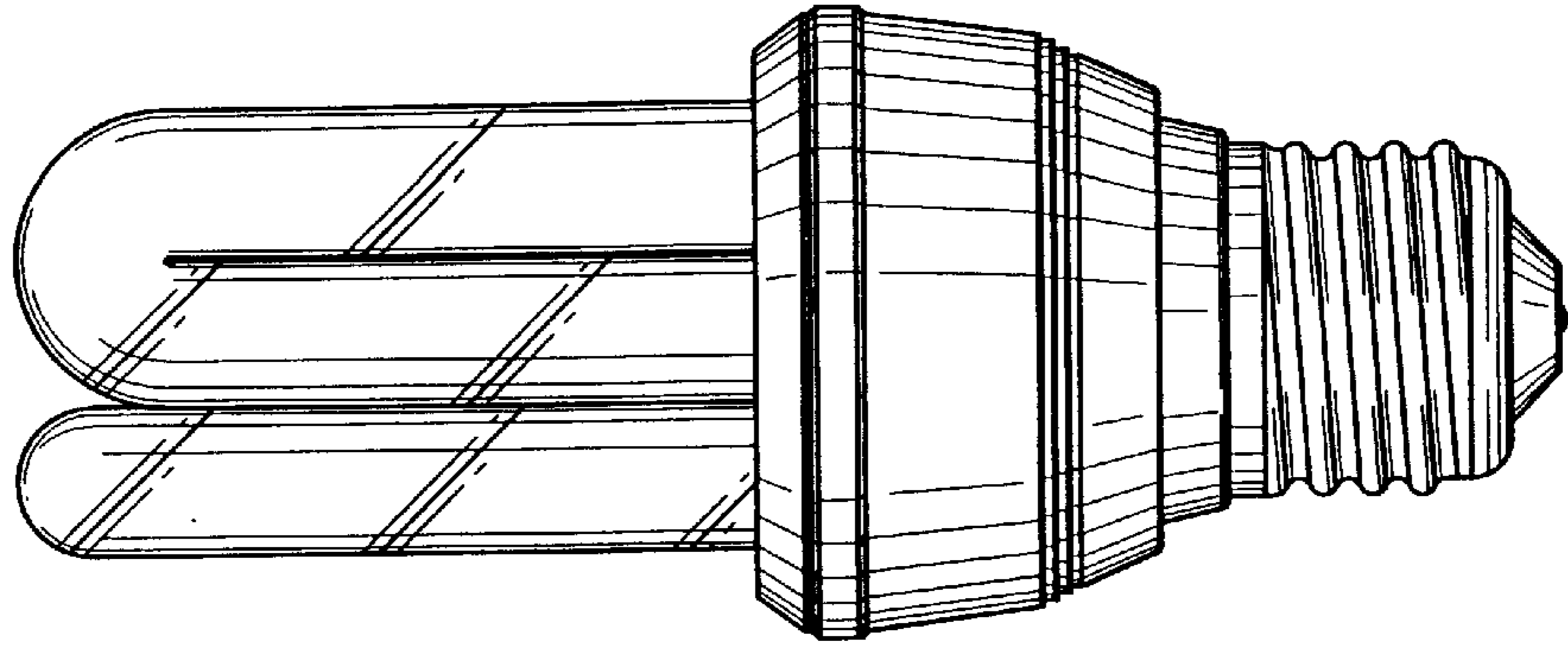

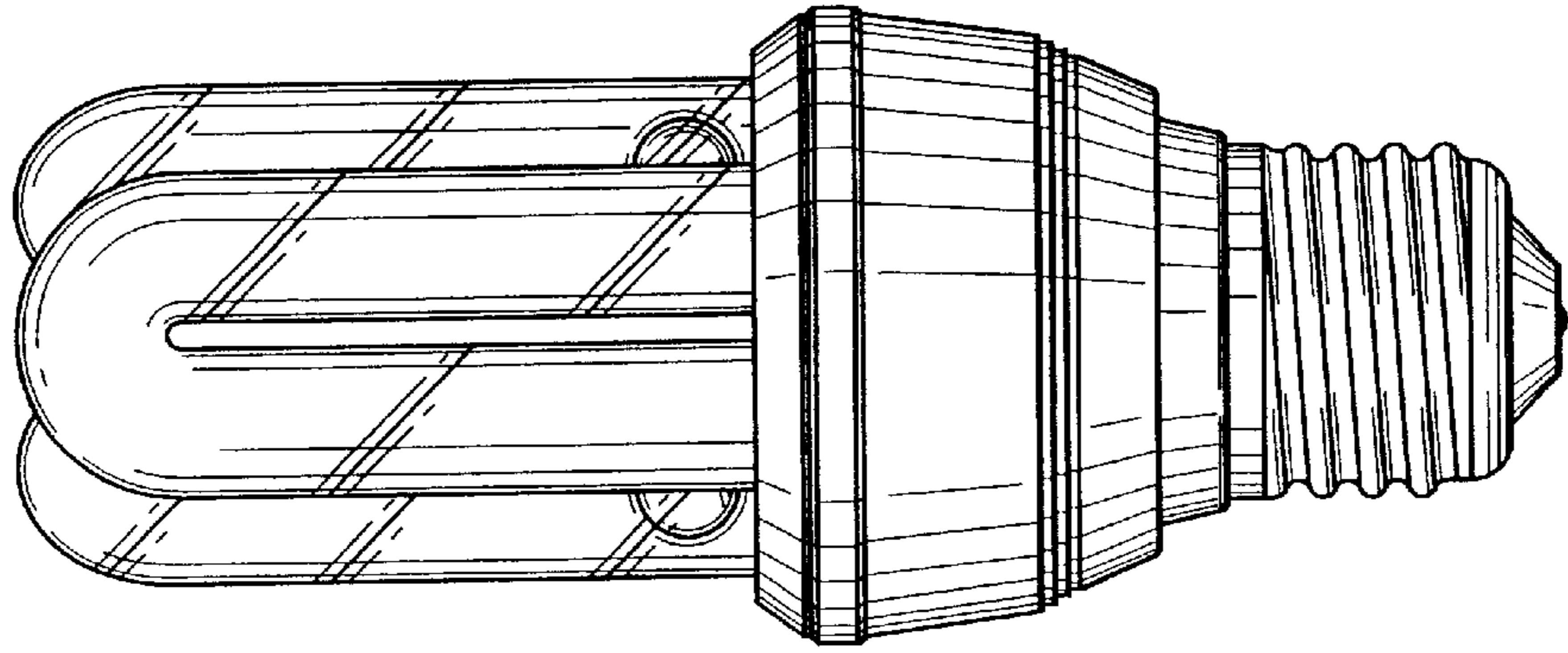
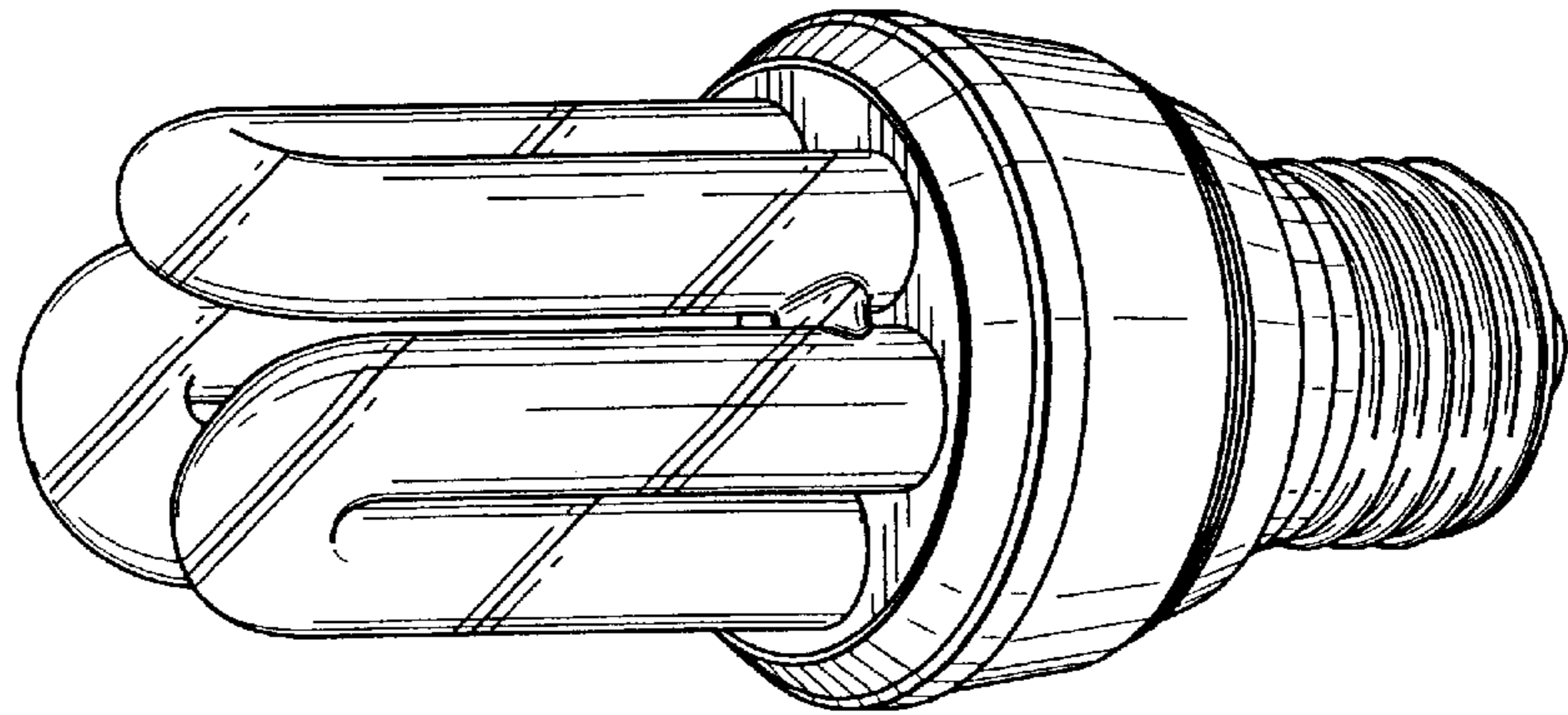
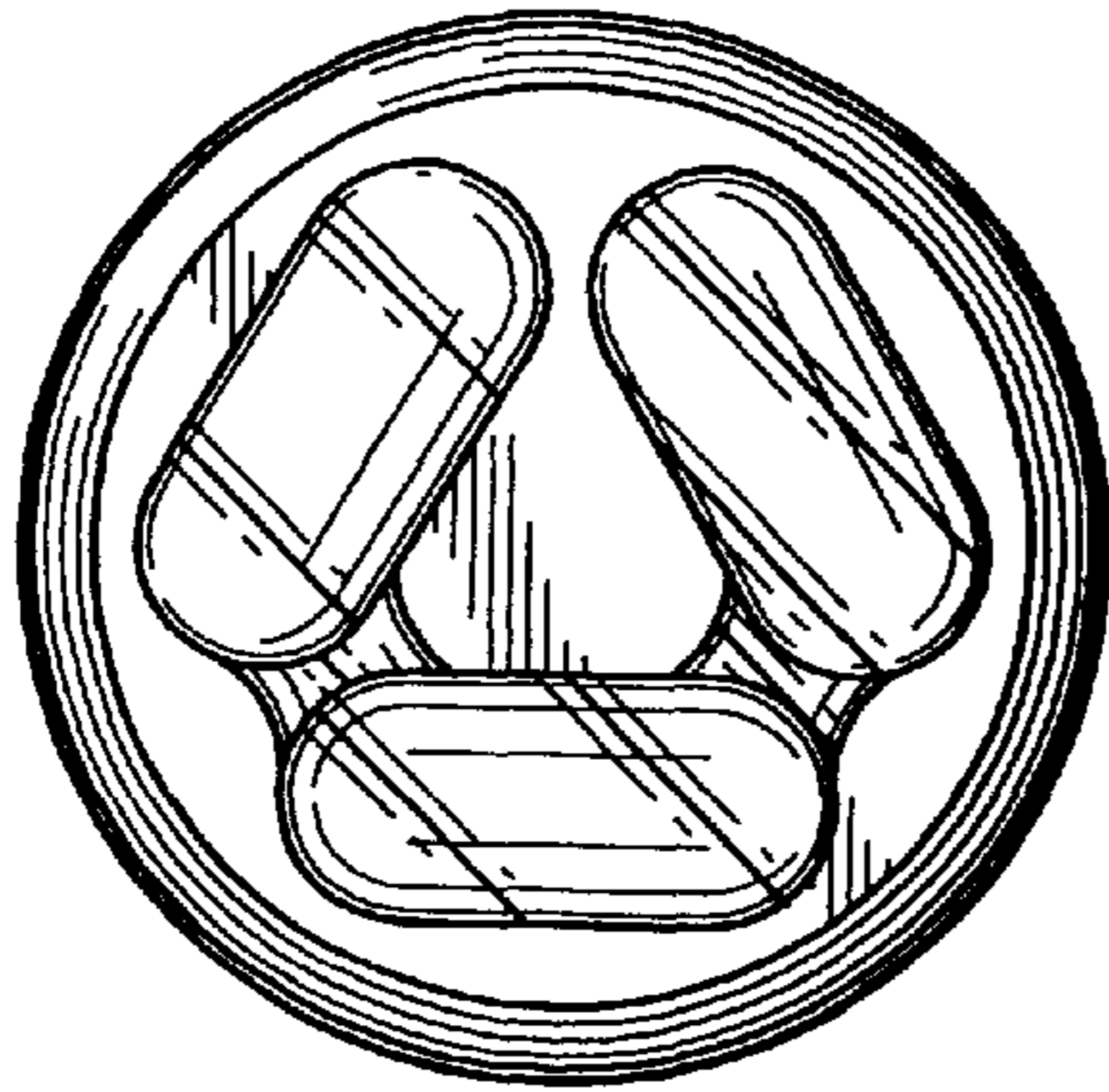


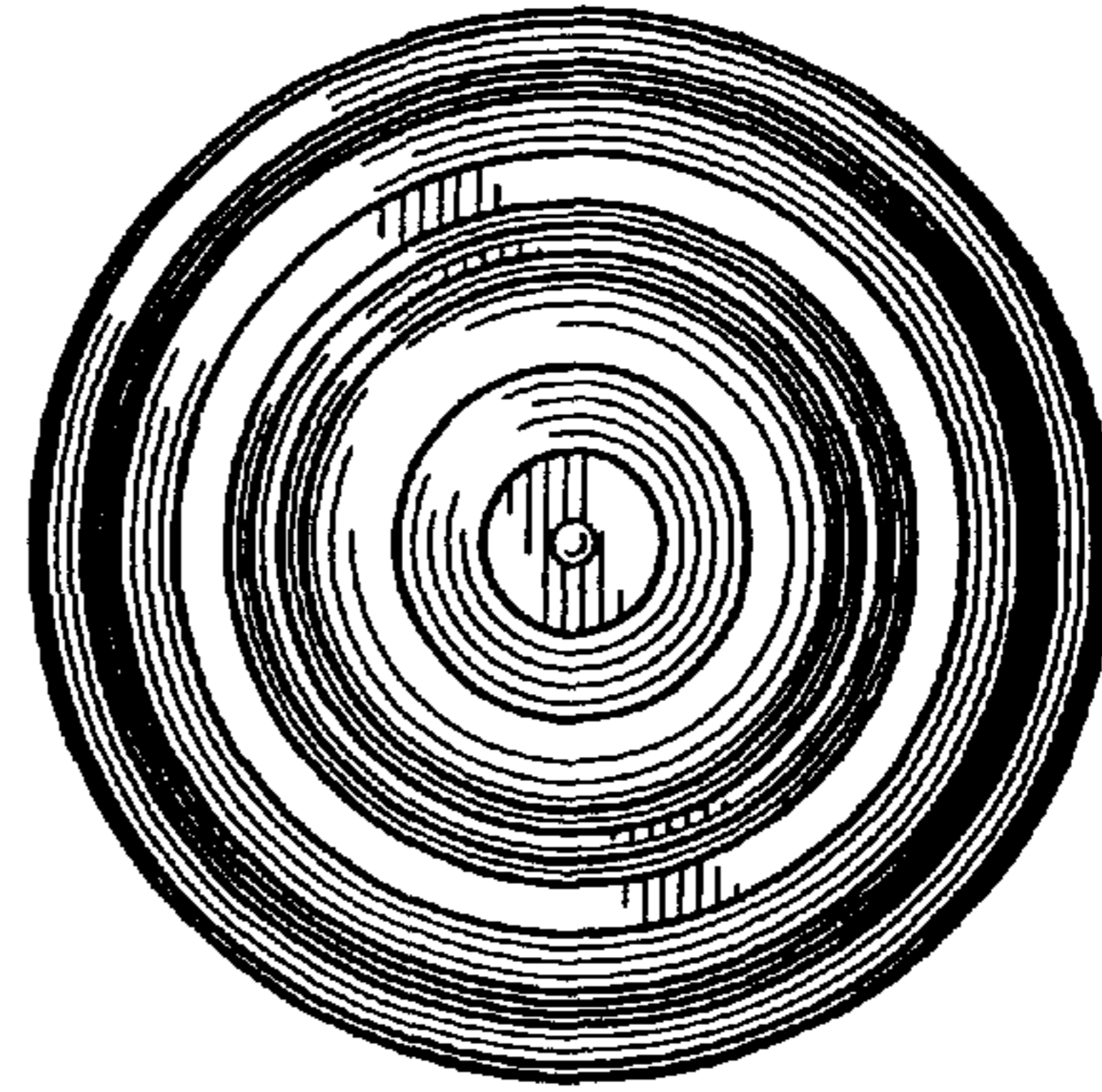

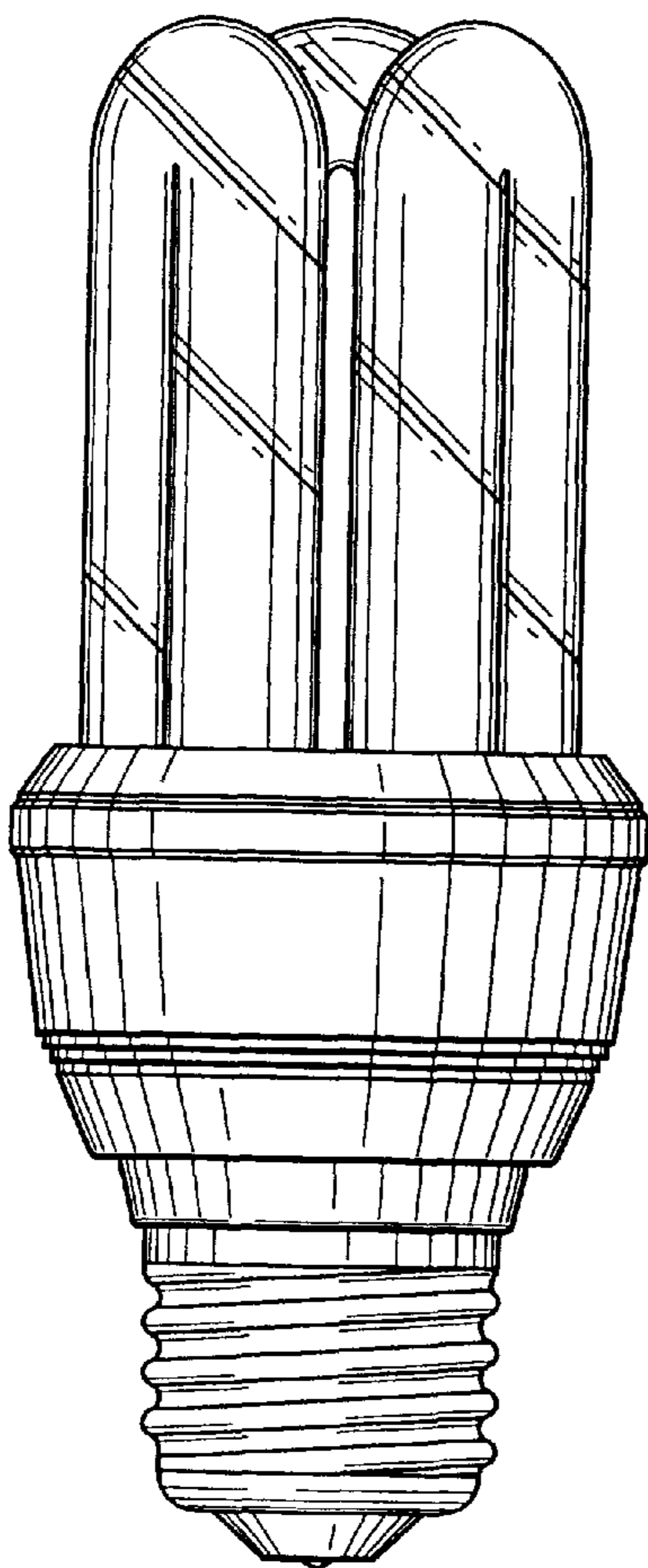
