

The ornamental design for a portable humidor, as shown and
described.

DESCRIPTION

FIG. 1 is a top, front and left side perspective view of a
portable humidor showing our new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a top plan view thereof;
FIG. 4 is a right side elevational view thereof;
FIG. 5 is a bottom plan view thereof;
FIG. 6 is a rear elevational view thereof;
FIG. 7 is a top, front and left side perspective view of a
second embodiment of our design for a portable humidor
which differs from the first embodiment by not having a
humidistat;
FIG. 8 is a front elevational view of the second embodiment,
FIGS. 3 through 6 being generic with respect to the first and
second embodiments;
FIG. 9 is a bottom plan view of a third embodiment of our
design for a portable humidor which differs from the first
embodiment solely with regard to the appearance of the
outer cover; and,
FIG. 10 is a rear elevational view of the third embodiment,
FIGS. 1 through 4 being generic with respect to the first and
third embodiments.

The broken lines in FIG. 1, showing a carrying strap with a
hook and ring strap connection, are intended for illustrative
purposes only and form no part of the claimed design.




















