### [57] CLAIM

The ornamental design for storage box, as shown and described.

### DESCRIPTION

FIG. 1 is a perspective view of a storage box showing our new design;

FIG. 2 is a front elevational view of the storage box of FIG. 1;

FIG. 3 is a rear elevational view of the storage box of FIG. 1;

FIG. 4 is a right end elevational view of the storage box of FIG. 1, the left end elevational view being a mirror image thereof;

FIG. 5 is a top plan view of the storage box of FIG. 1;

FIG. 6 is a perspective view of an alternative embodiment of the storage box showing our new design;

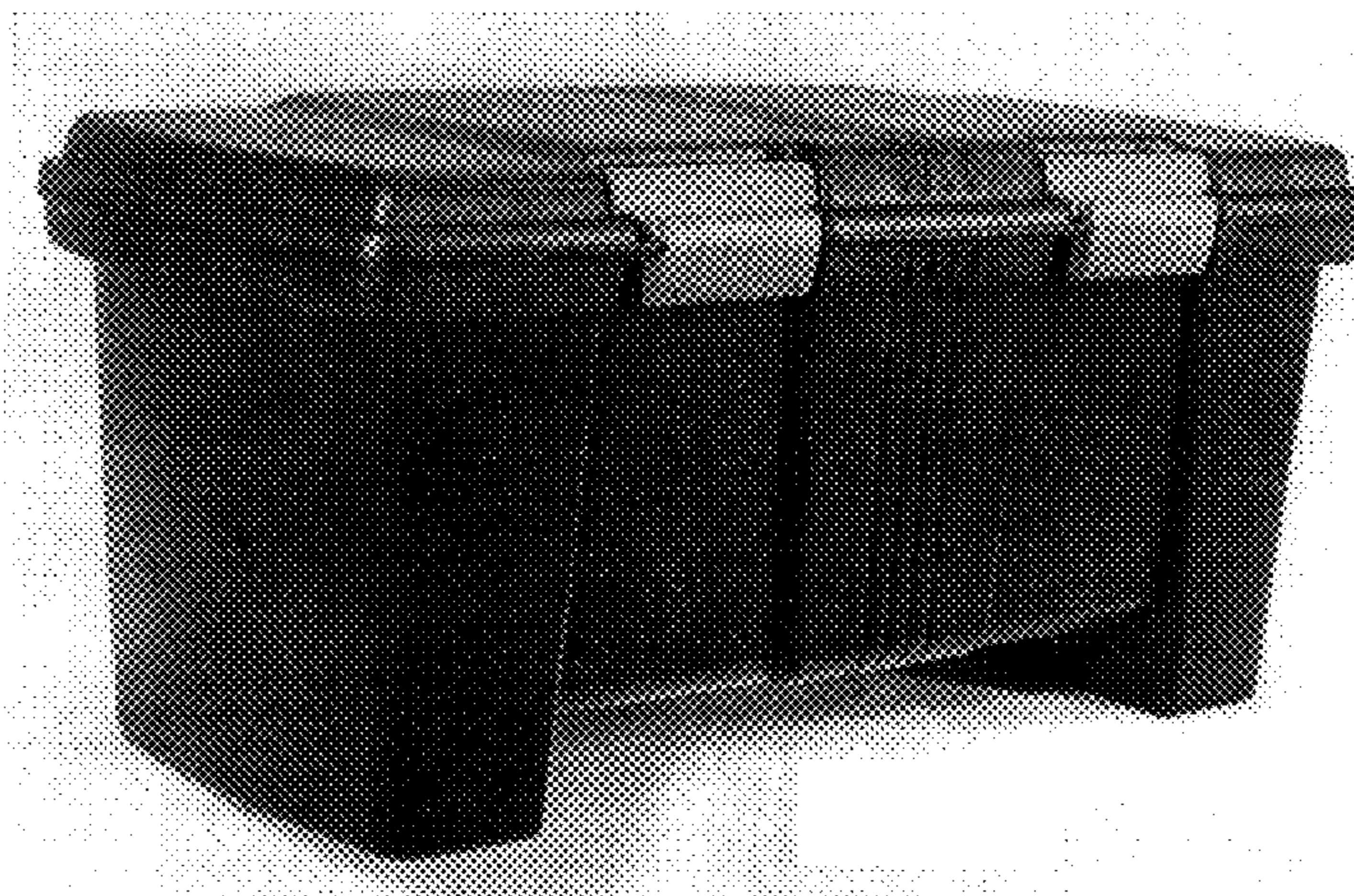
FIG. 7 is a front elevational view of the storage box of FIG. 6;

FIG. 8 is a rear elevational view of the storage box of FIG. 6;

FIG. 9 is a left end elevational view of the storage box of FIG. 6, the right end elevational view being a mirror image thereof; and,

FIG. 10 is a top plan view of the storage box of FIG. 6.

The bottom plan views are non-ornamental and form no part of the claimed design.

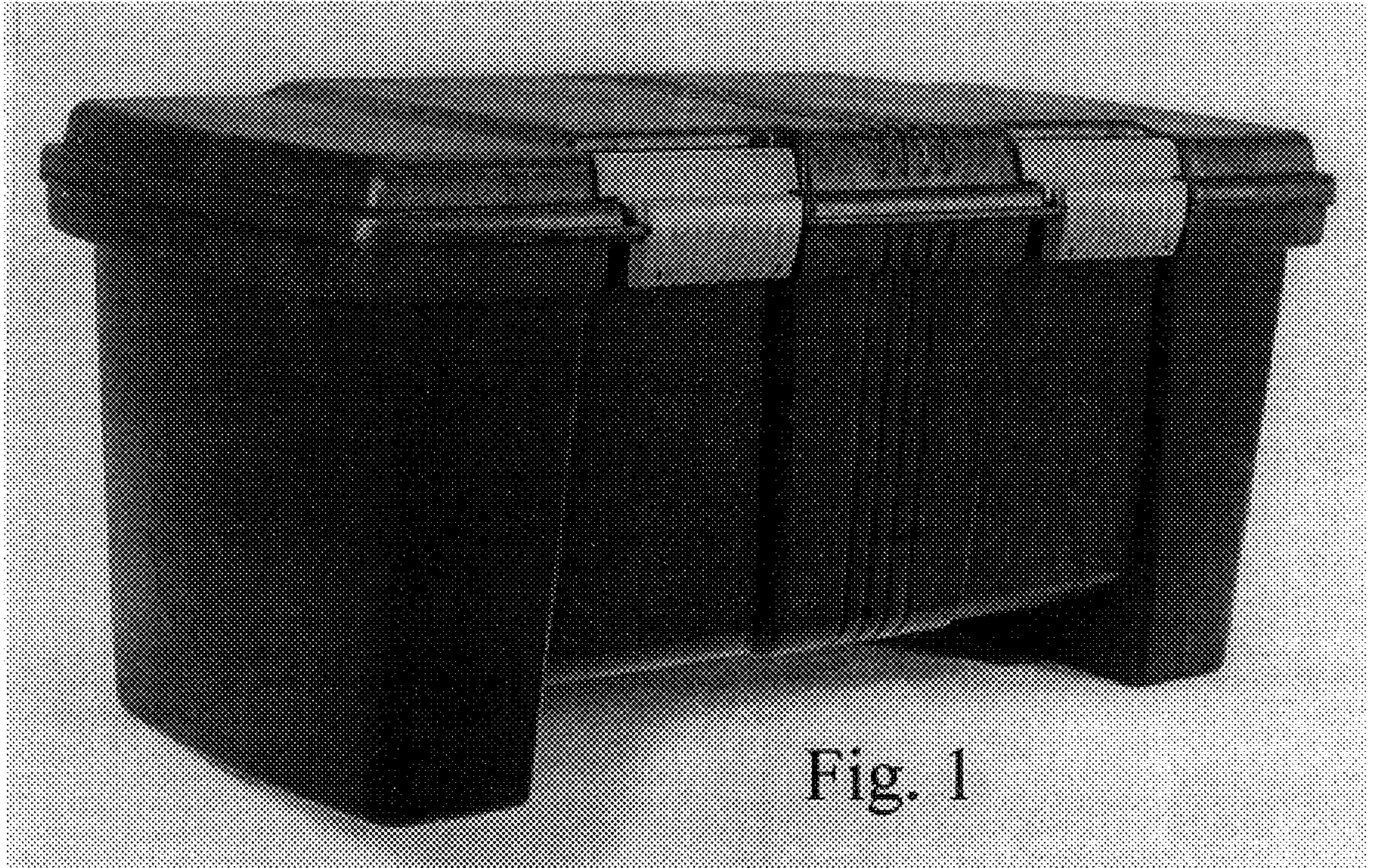

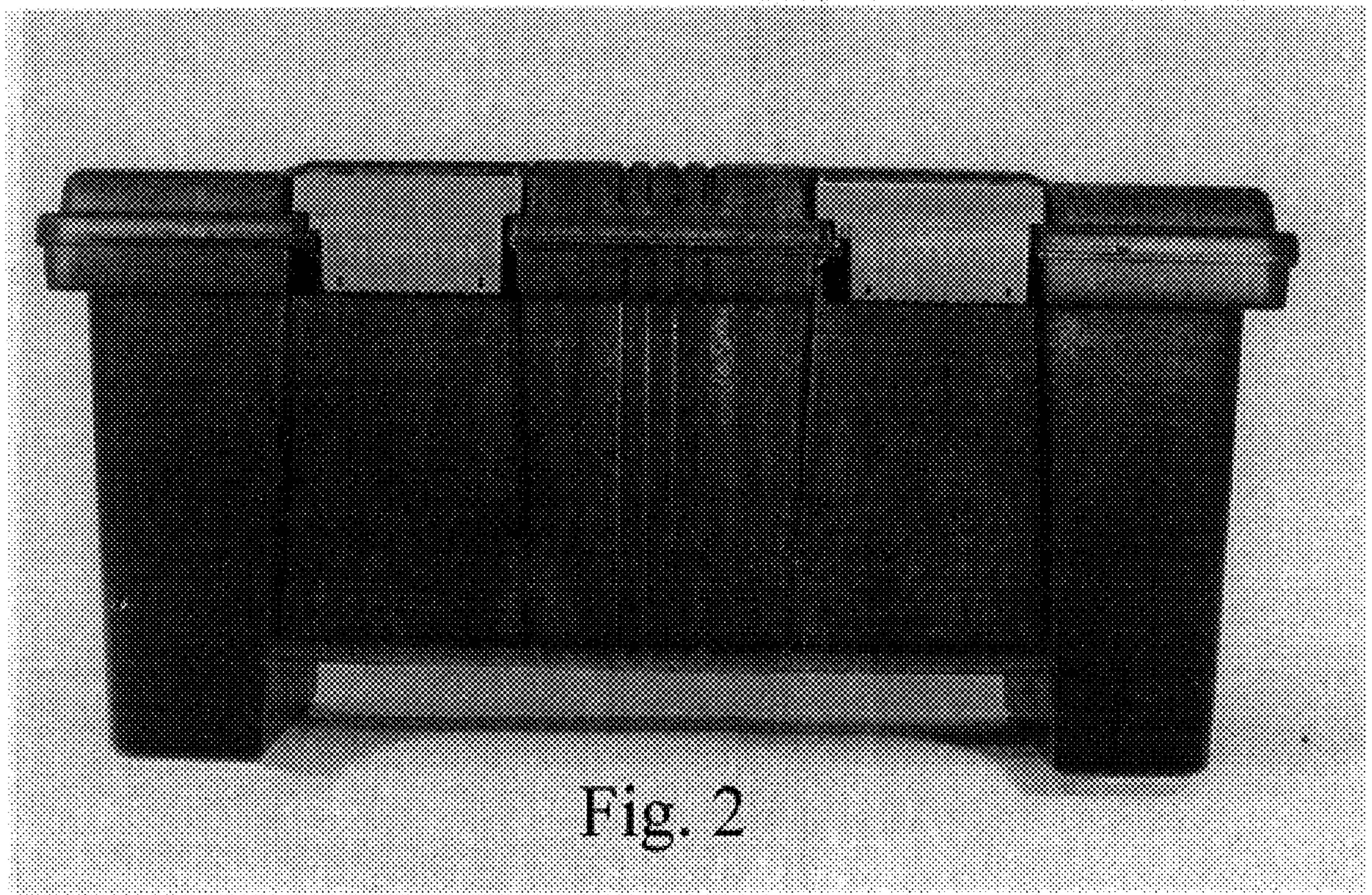
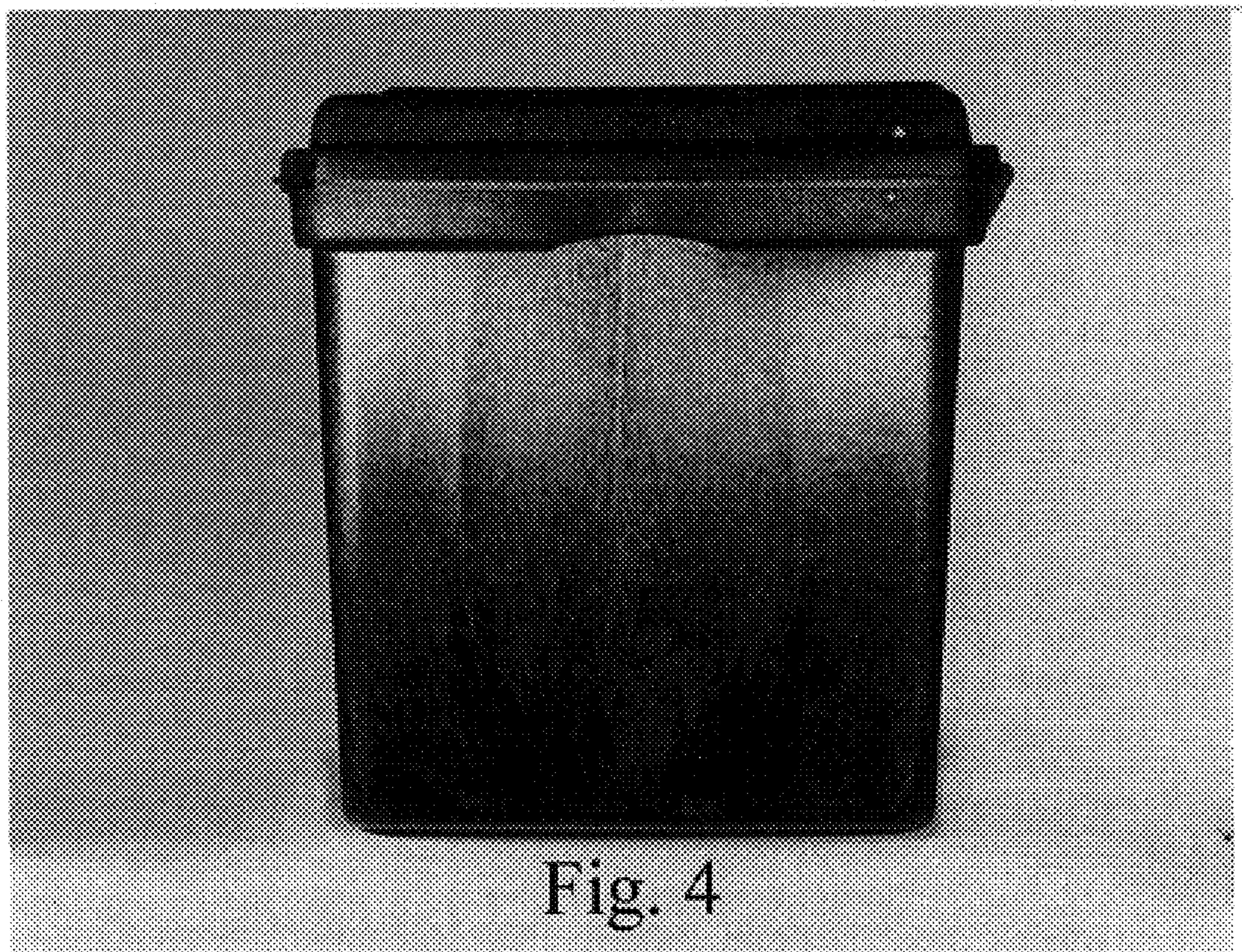
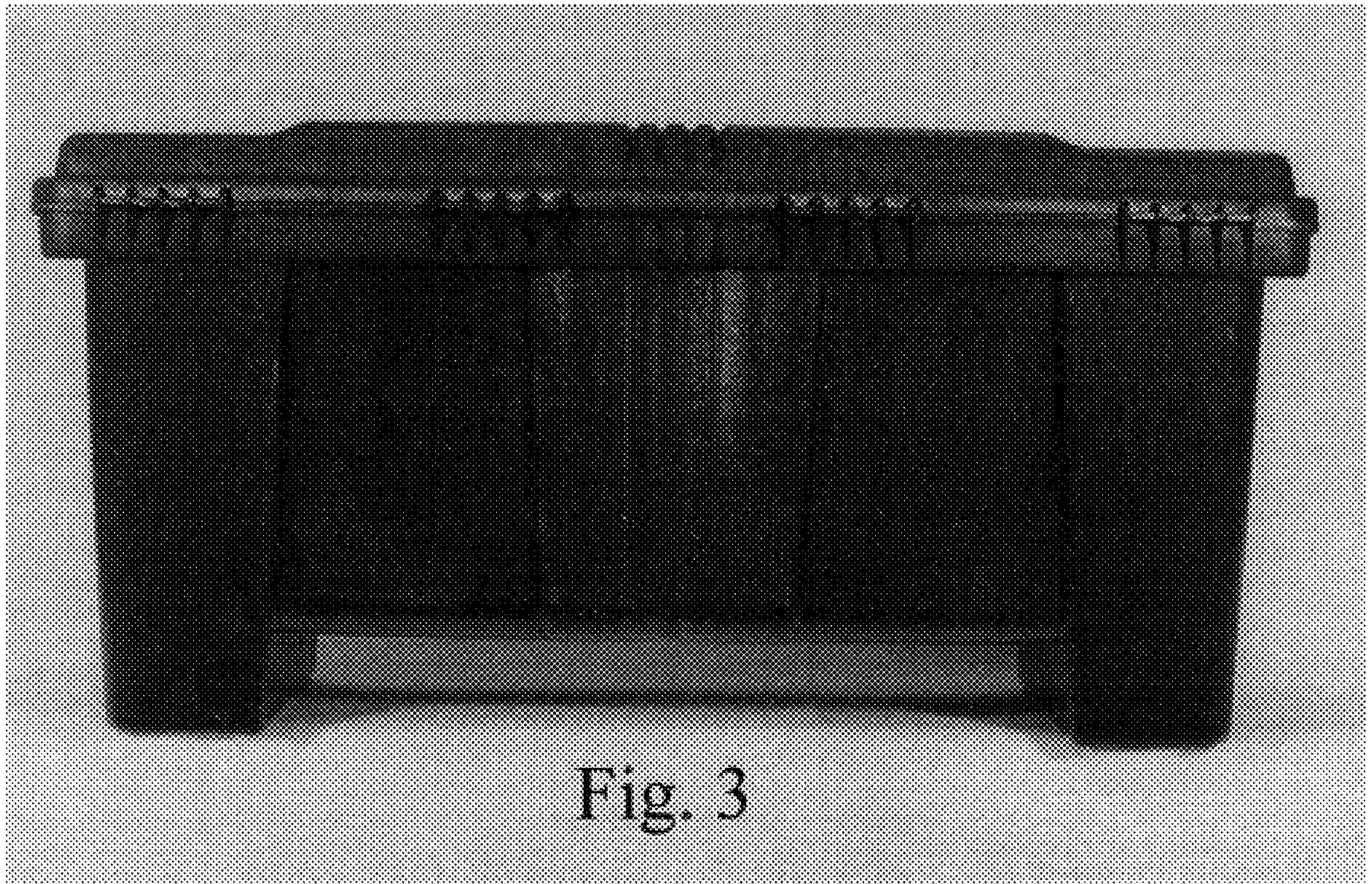
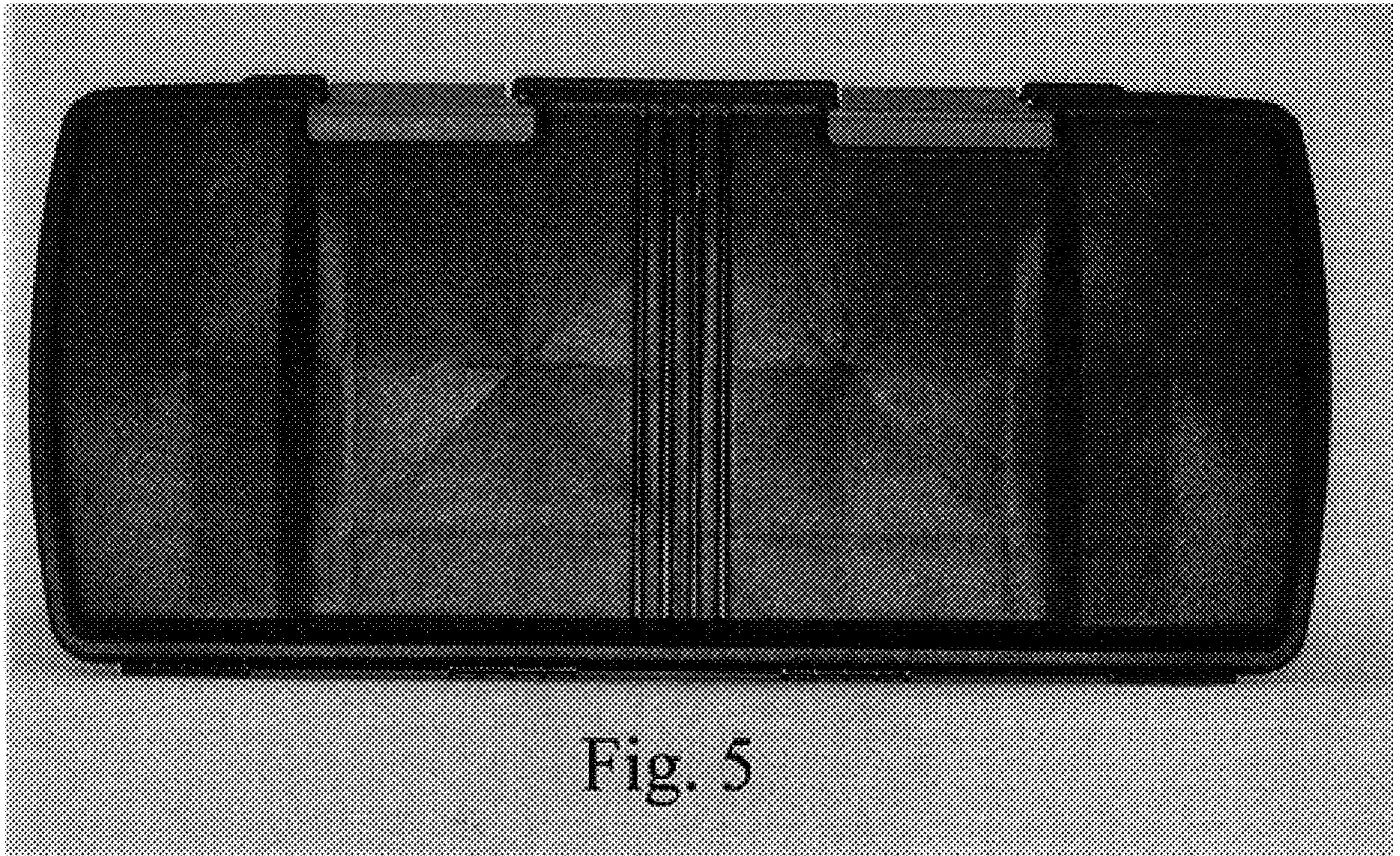

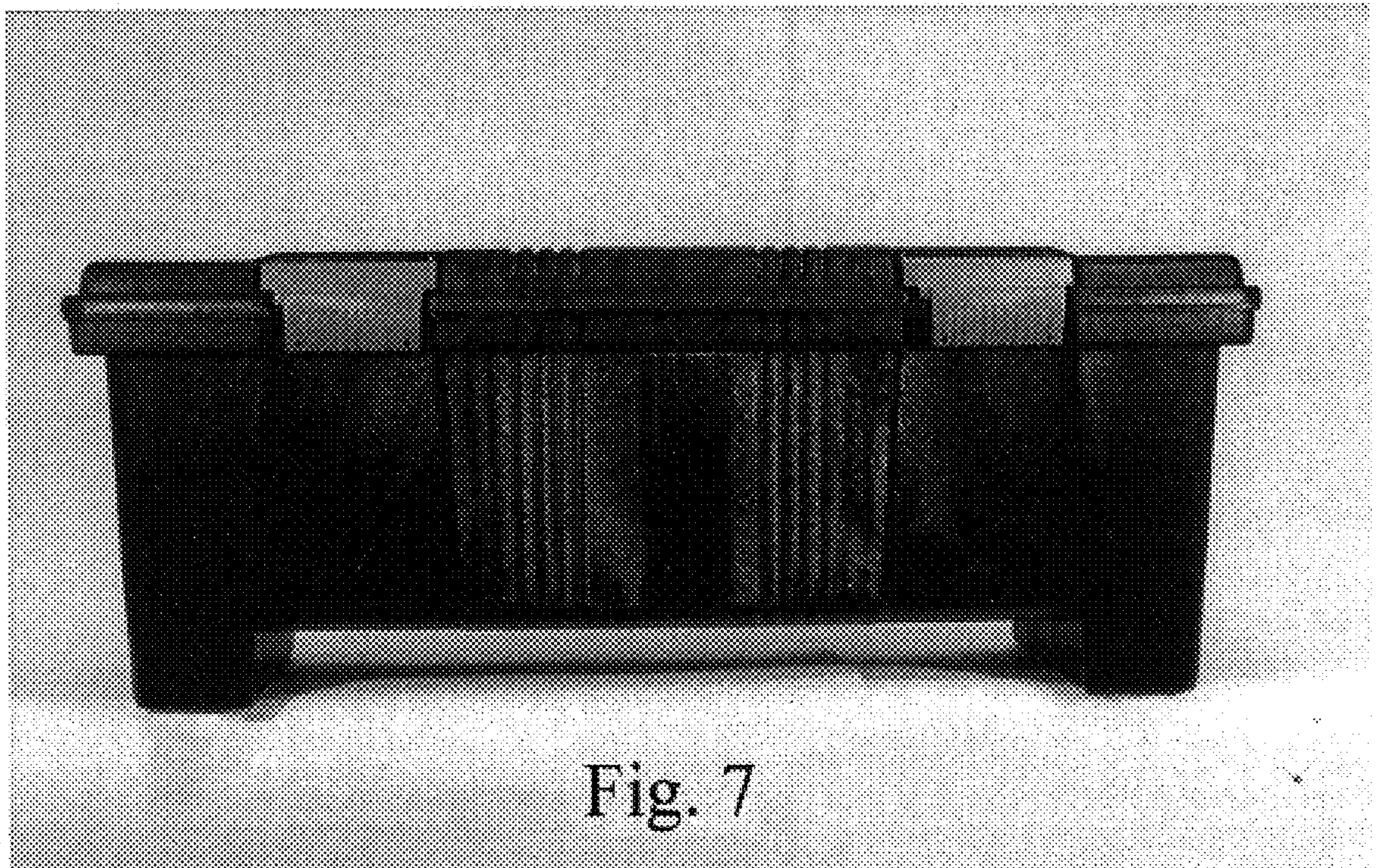
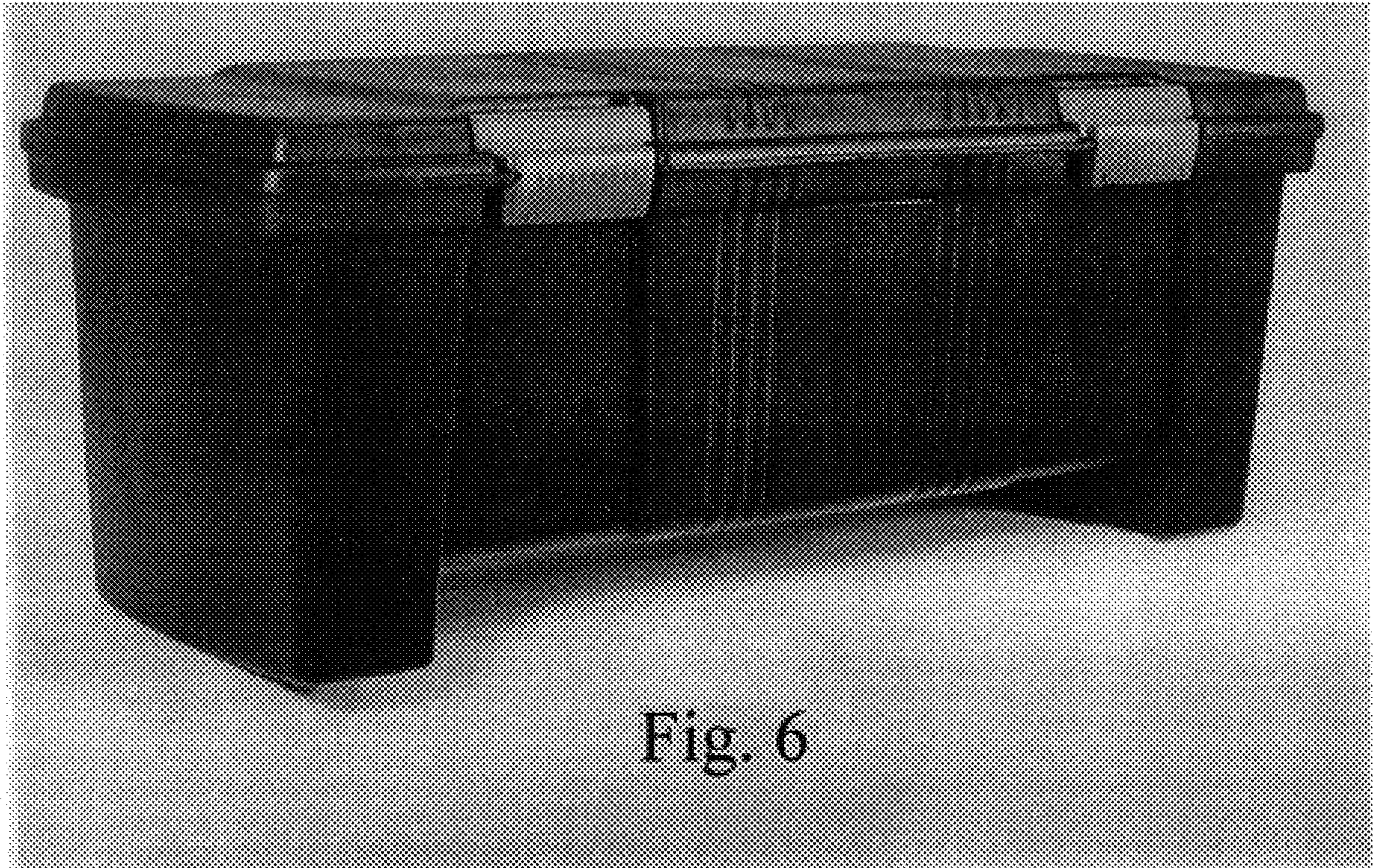














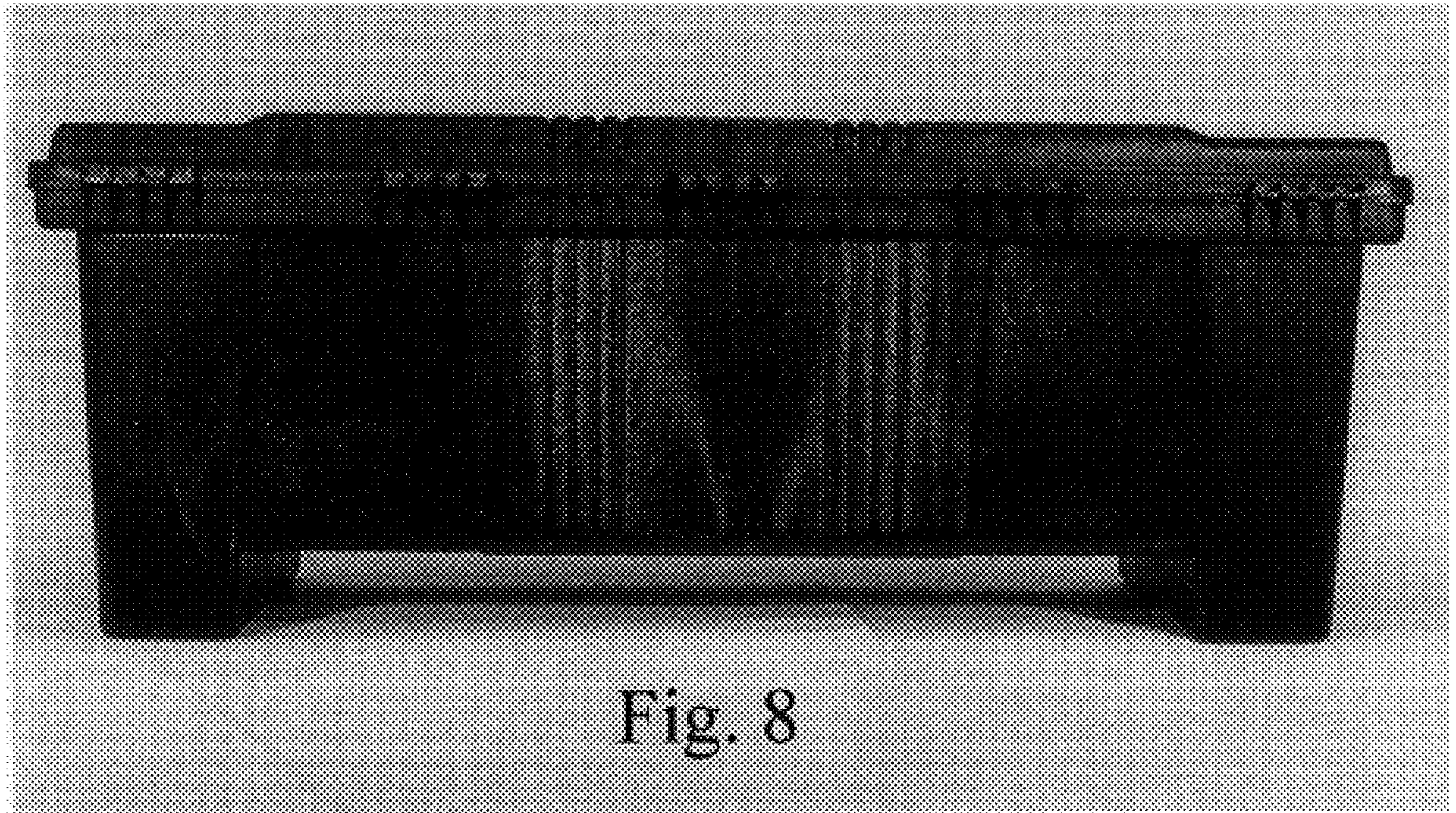

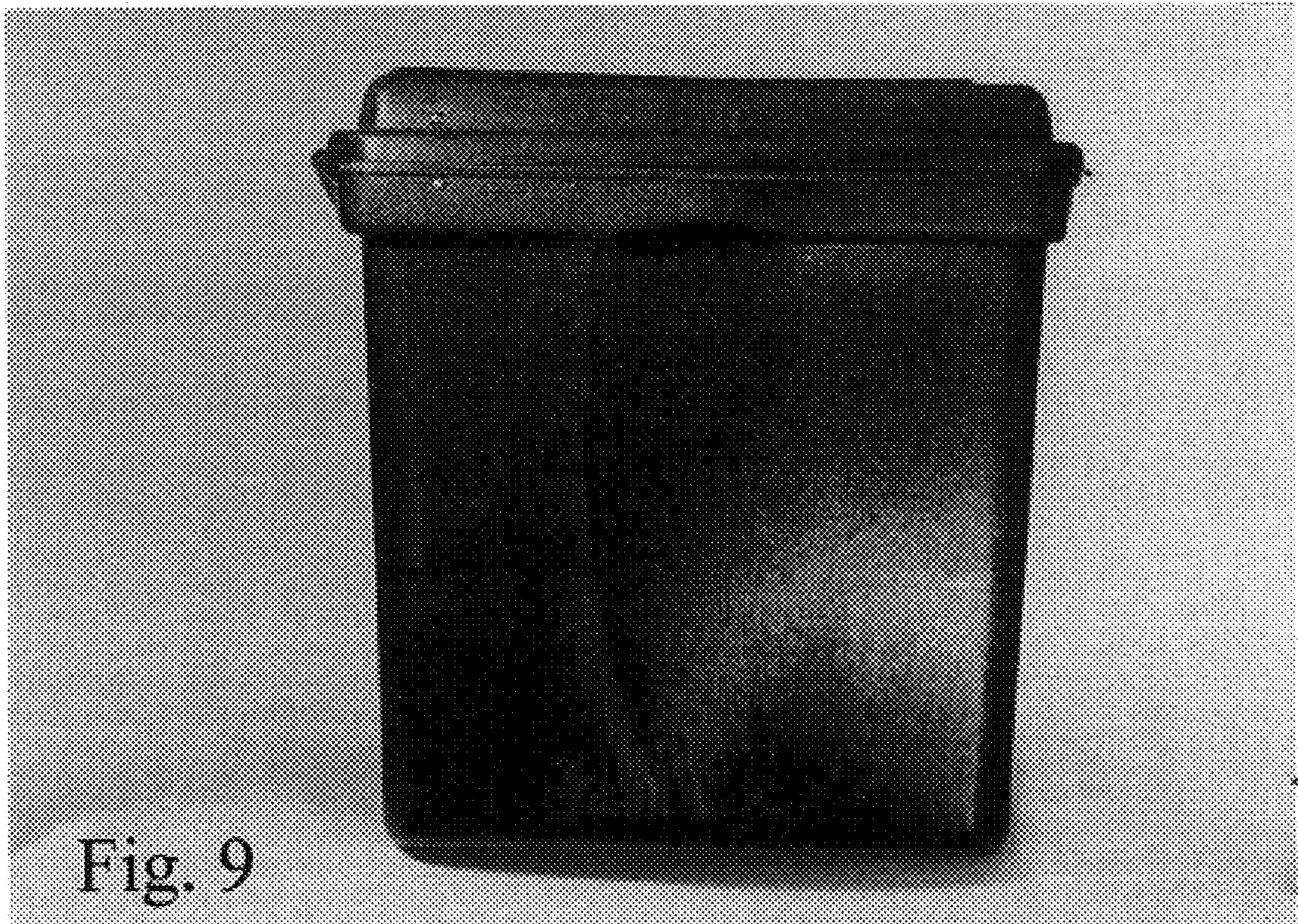

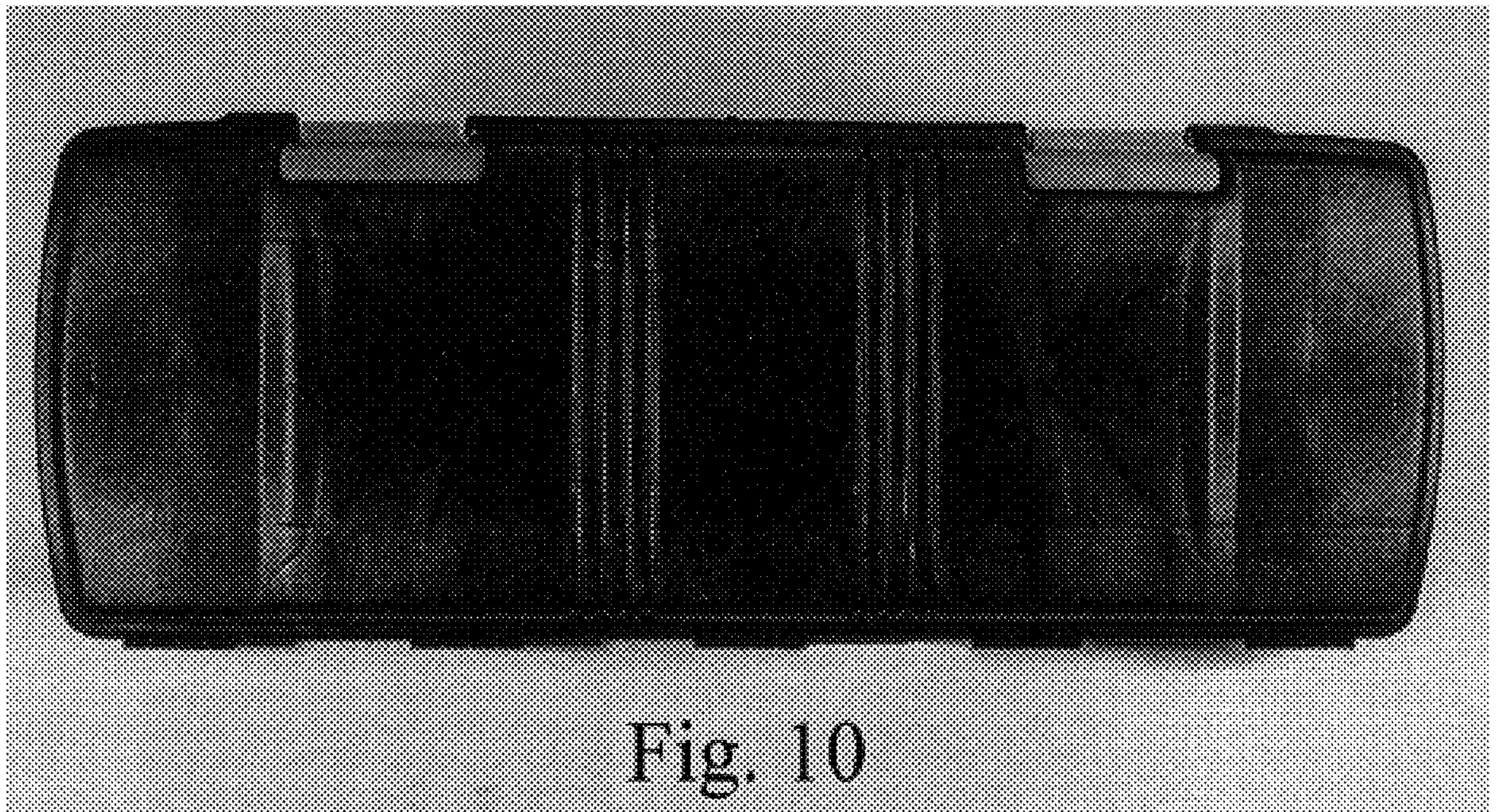
