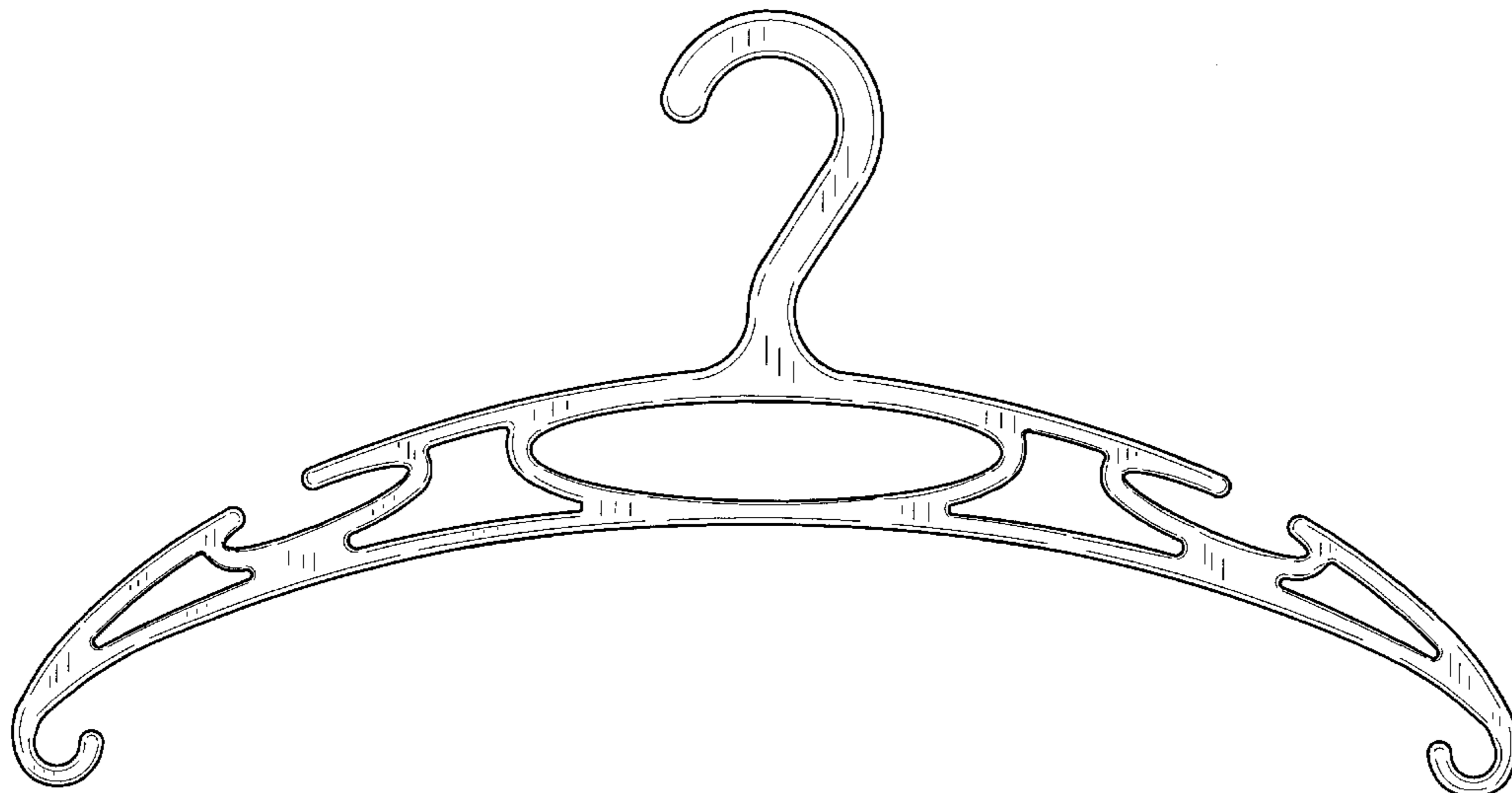
[57] **CLAIM**

The ornamental design for a shirt hanger, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of a shirt hanger showing my new design, the rear elevational view of the shirt hanger being a mirror image thereof;  
FIG. 2 is a top plan view of the shirt hanger of FIG. 1;  
FIG. 3 is a bottom plan view of the shirt hanger of FIG. 1;  
FIG. 4 is a left end elevational view of the shirt hanger of FIG. 1; and,  
FIG. 5 is a right end elevational view of the shirt hanger of FIG. 1.

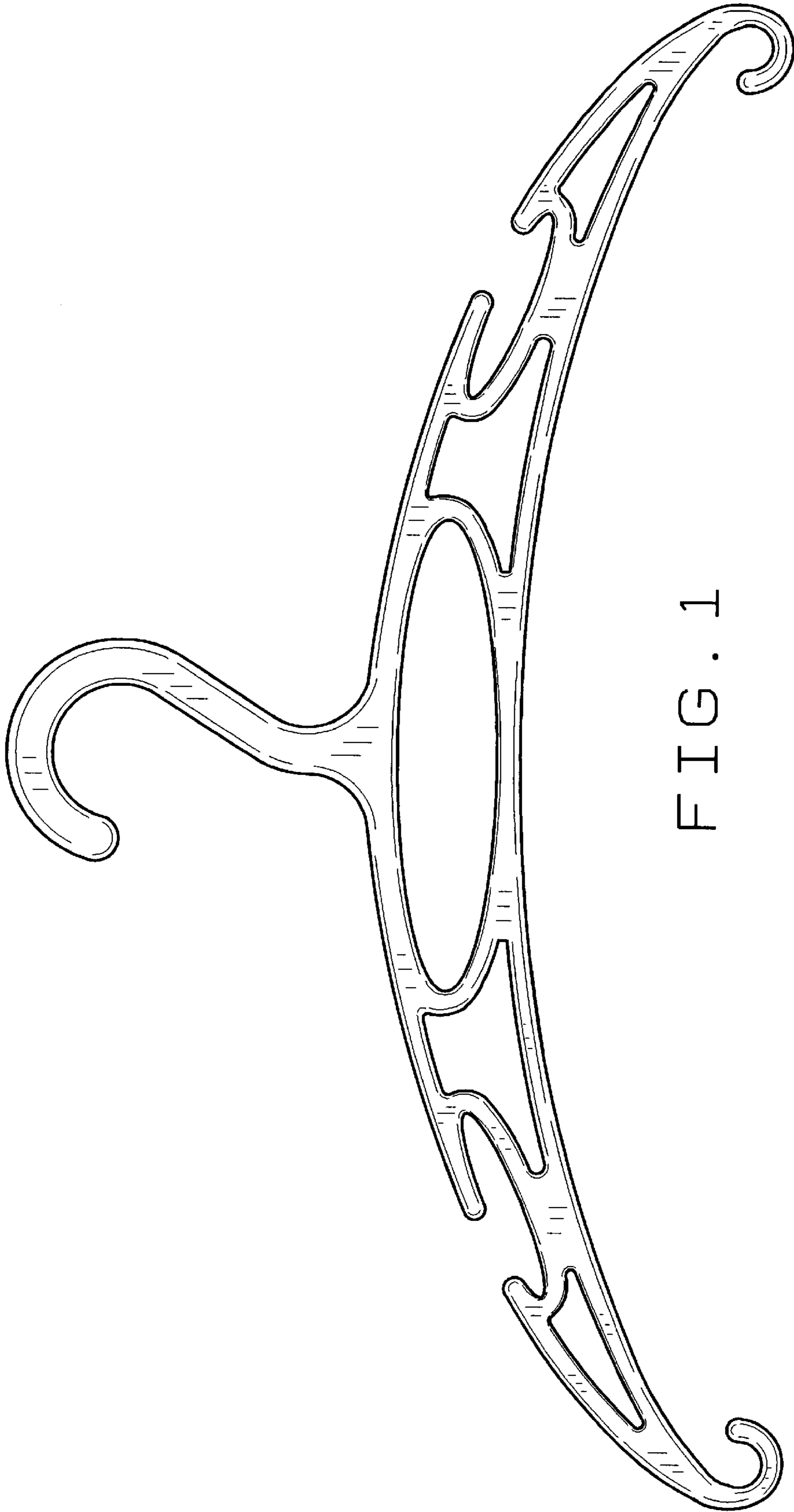

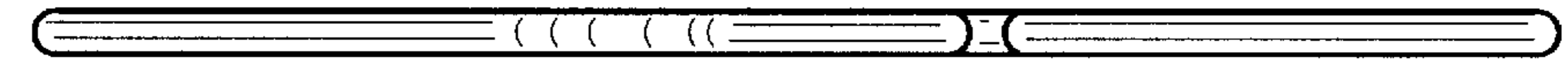

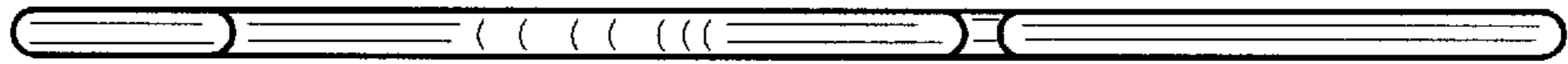
