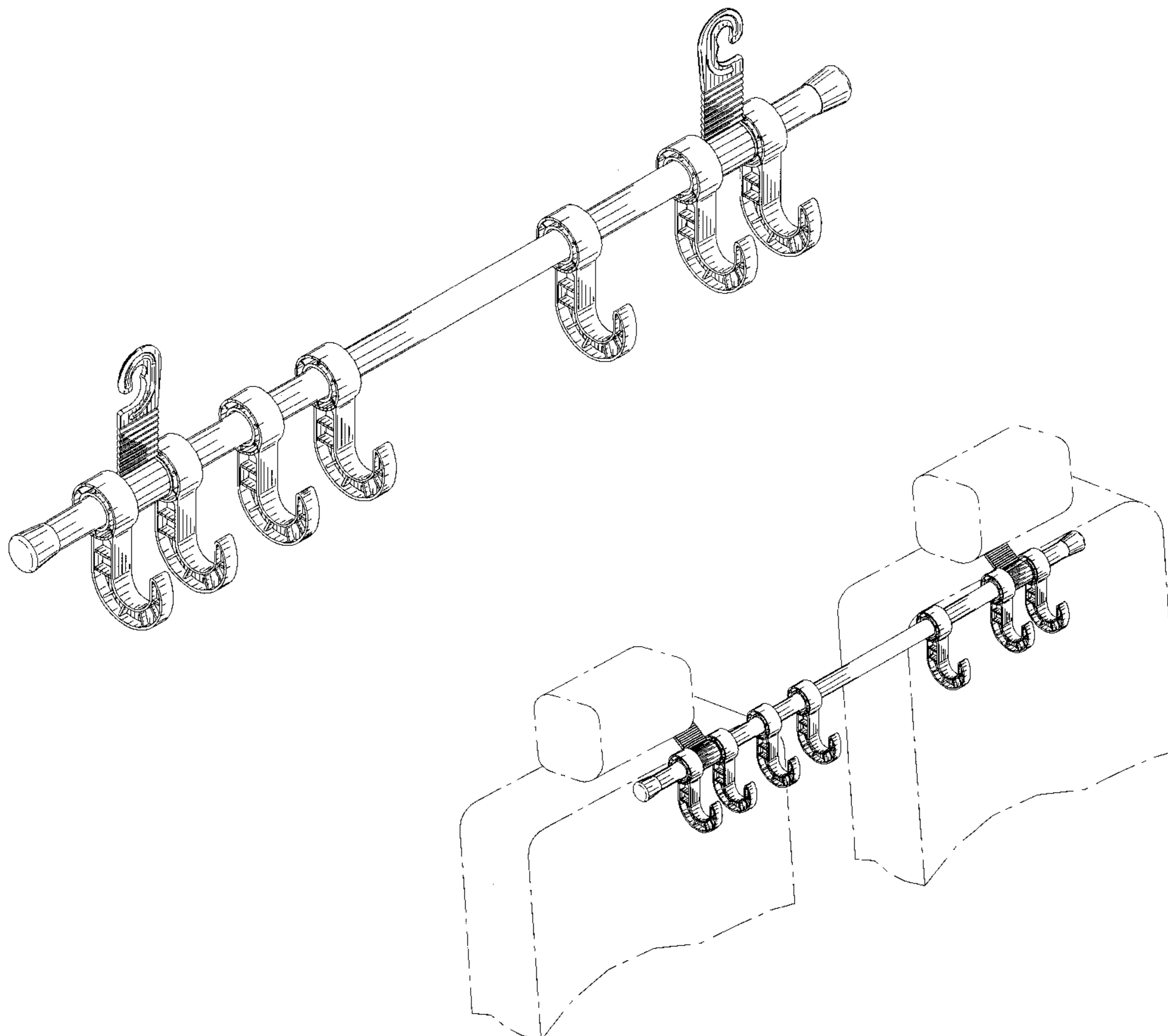
FIG. 1 is a perspective view of the article support arrangement;

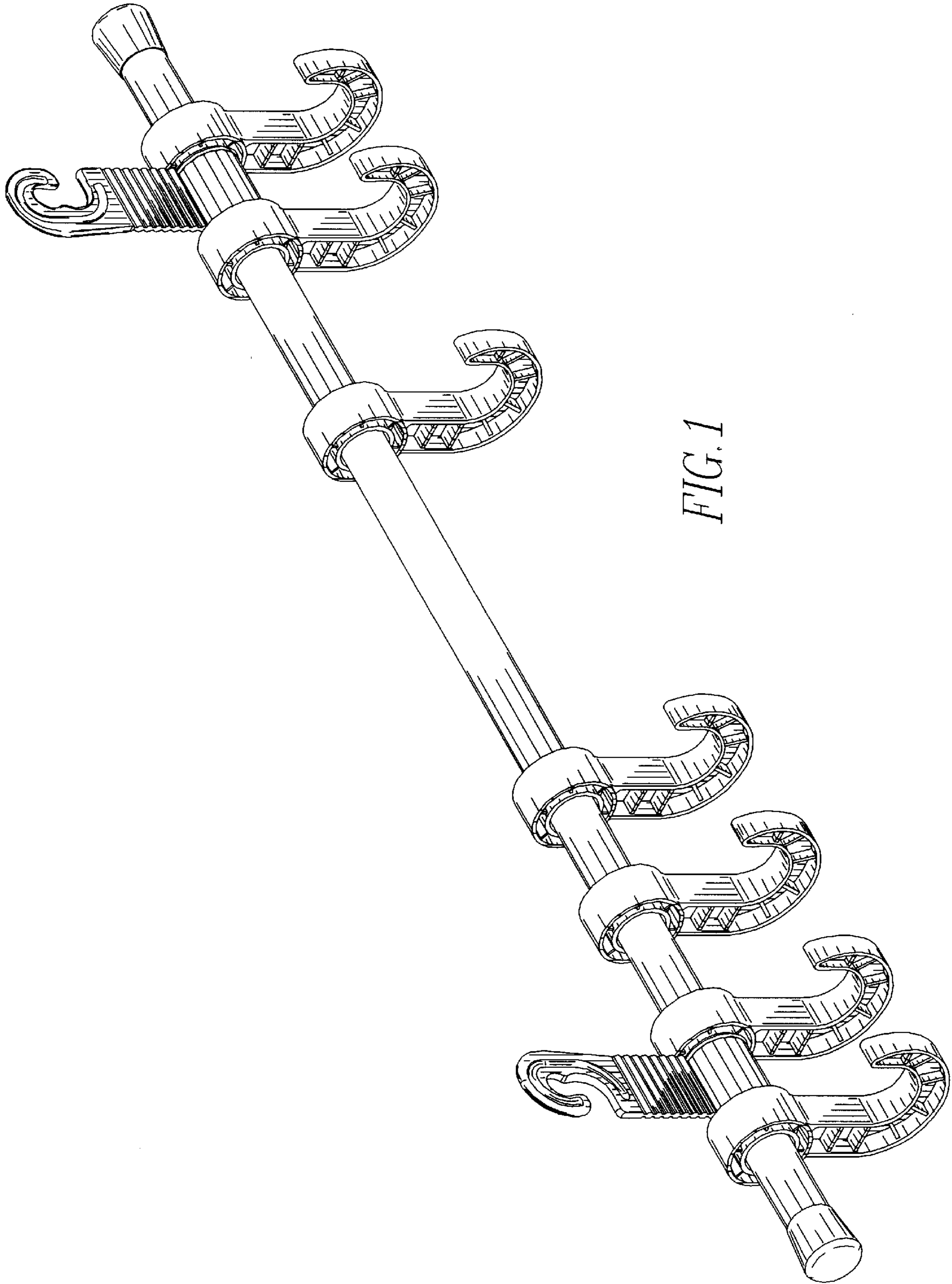

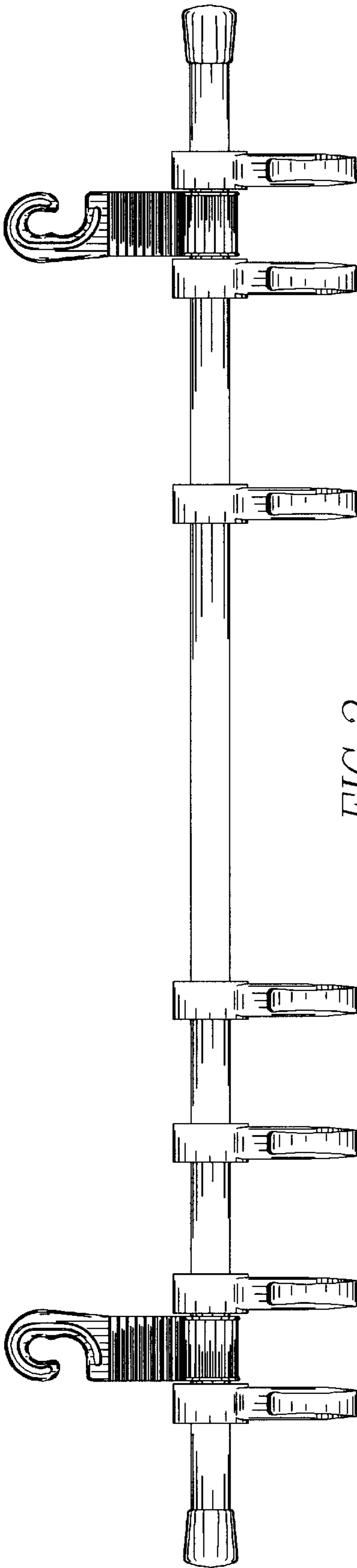

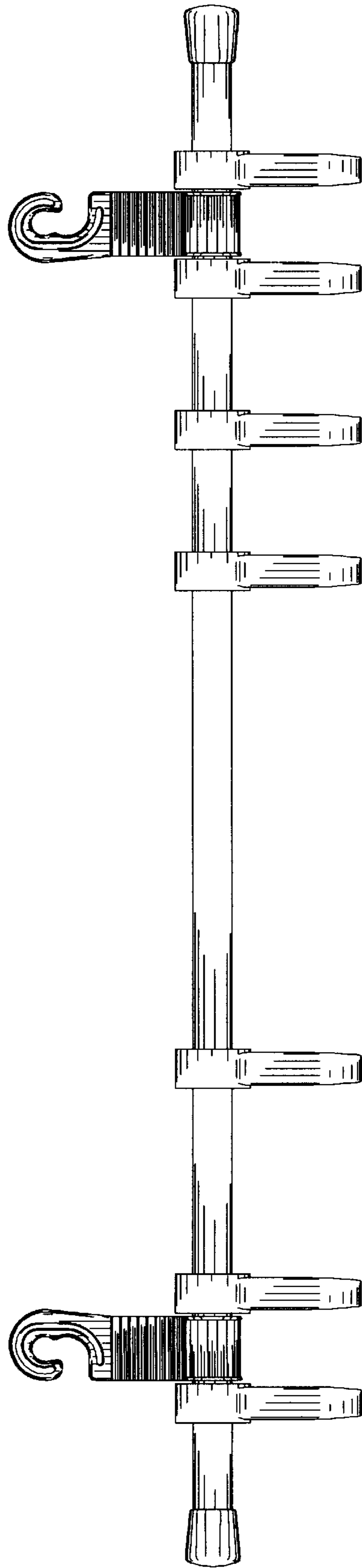
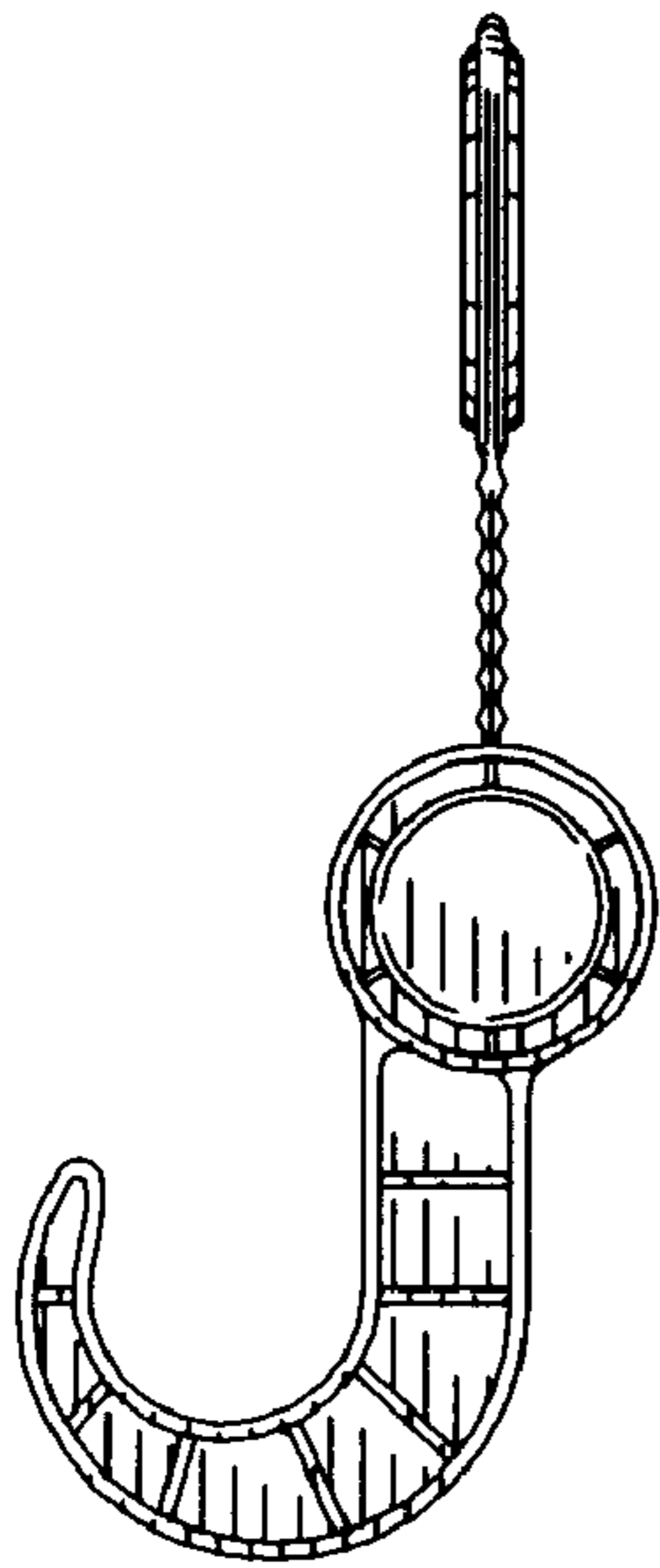
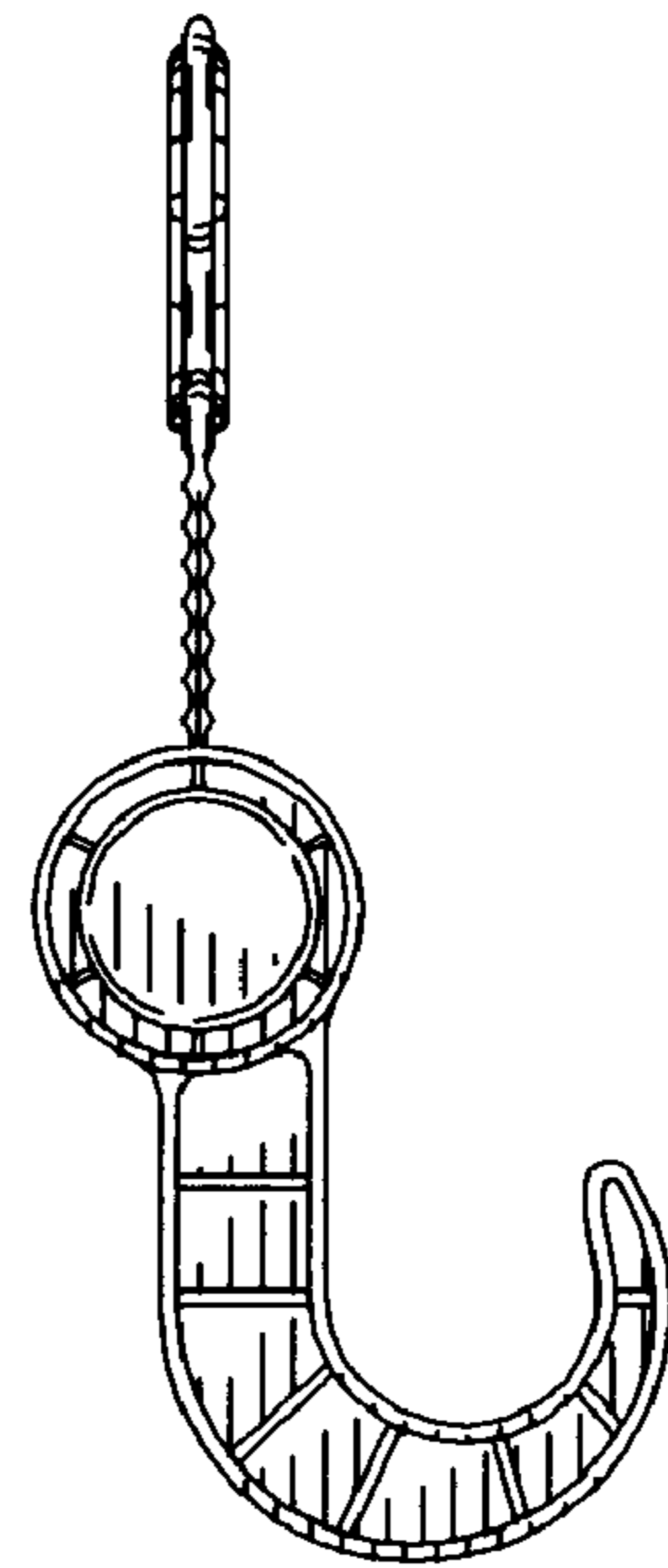

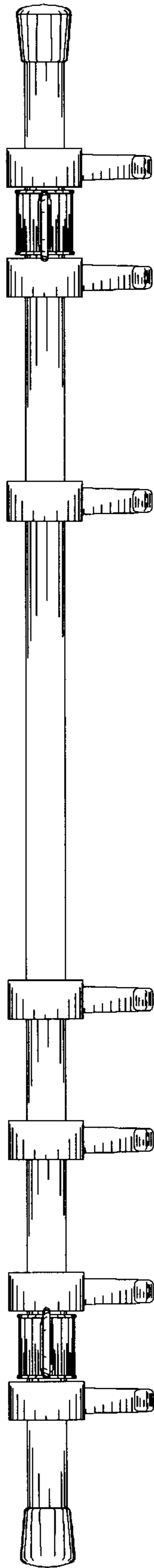

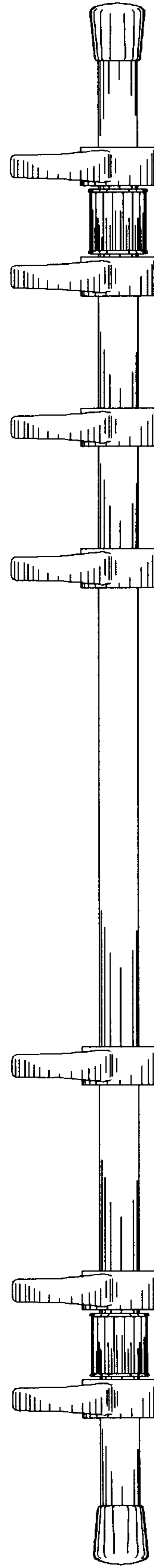

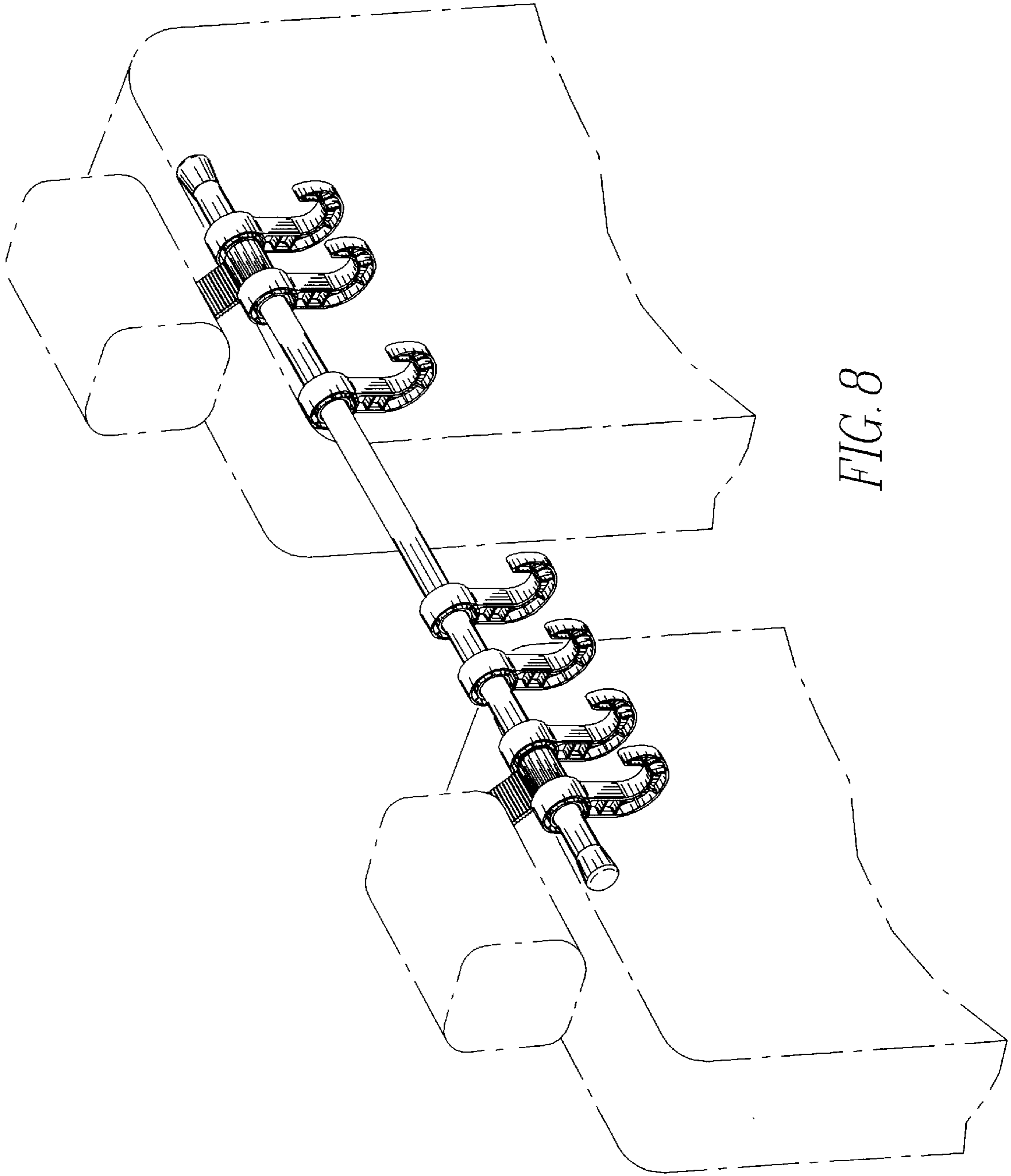
