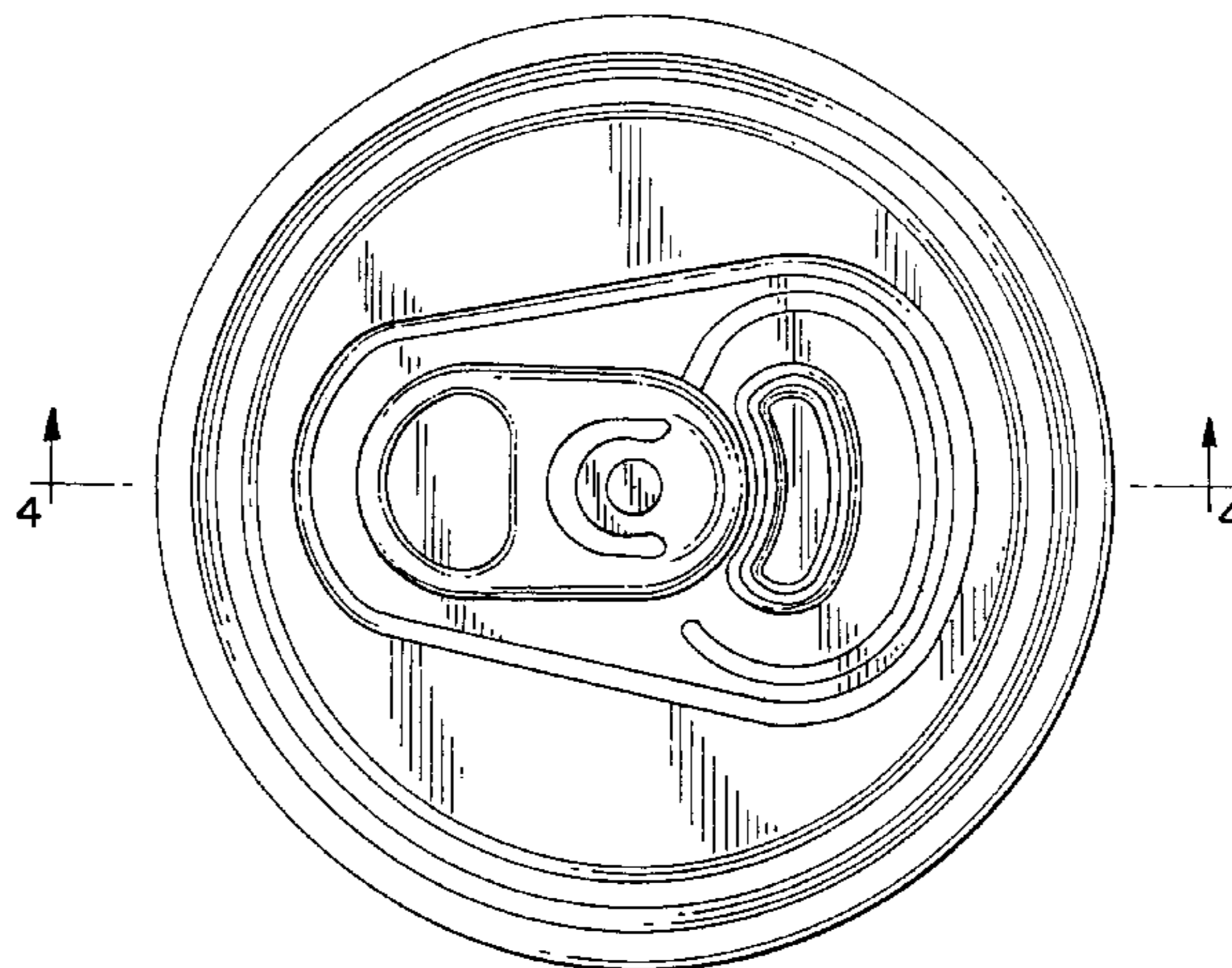
## [57] CLAIM

The ornamental design for a “can end”, as shown and described.

## DESCRIPTION

FIG. 1 is a top plan view of the can end incorporating our new design;  
 FIG. 2 is a side elevation thereof, the other side being the same as the side shown;  
 FIG. 3 is a bottom plan view thereof; and,  
 FIG. 4 is a sectional view taken along line 4—4 in FIG. 1, and shown at an enlarged scale.

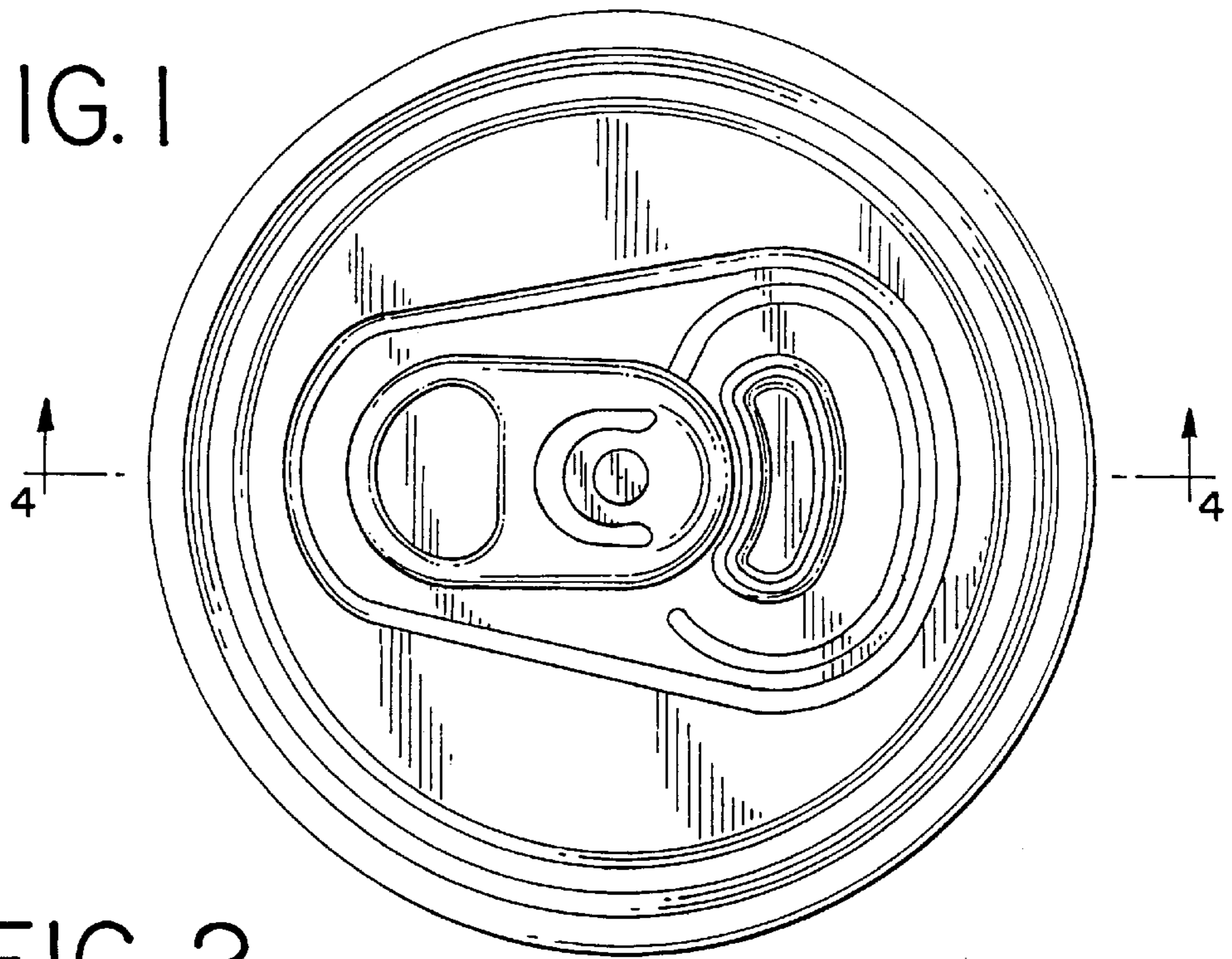

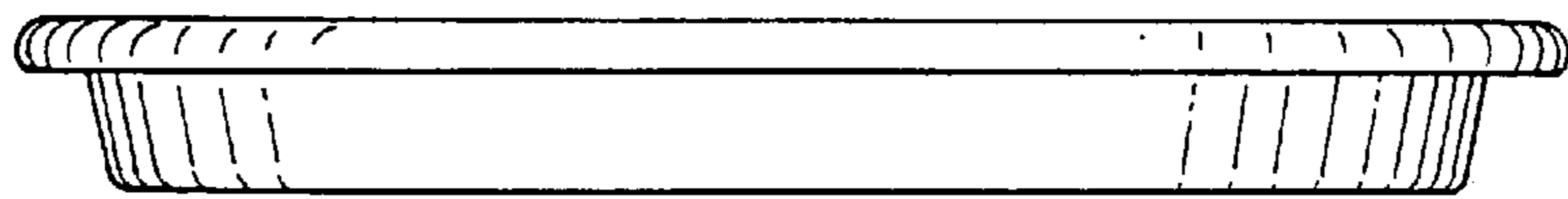

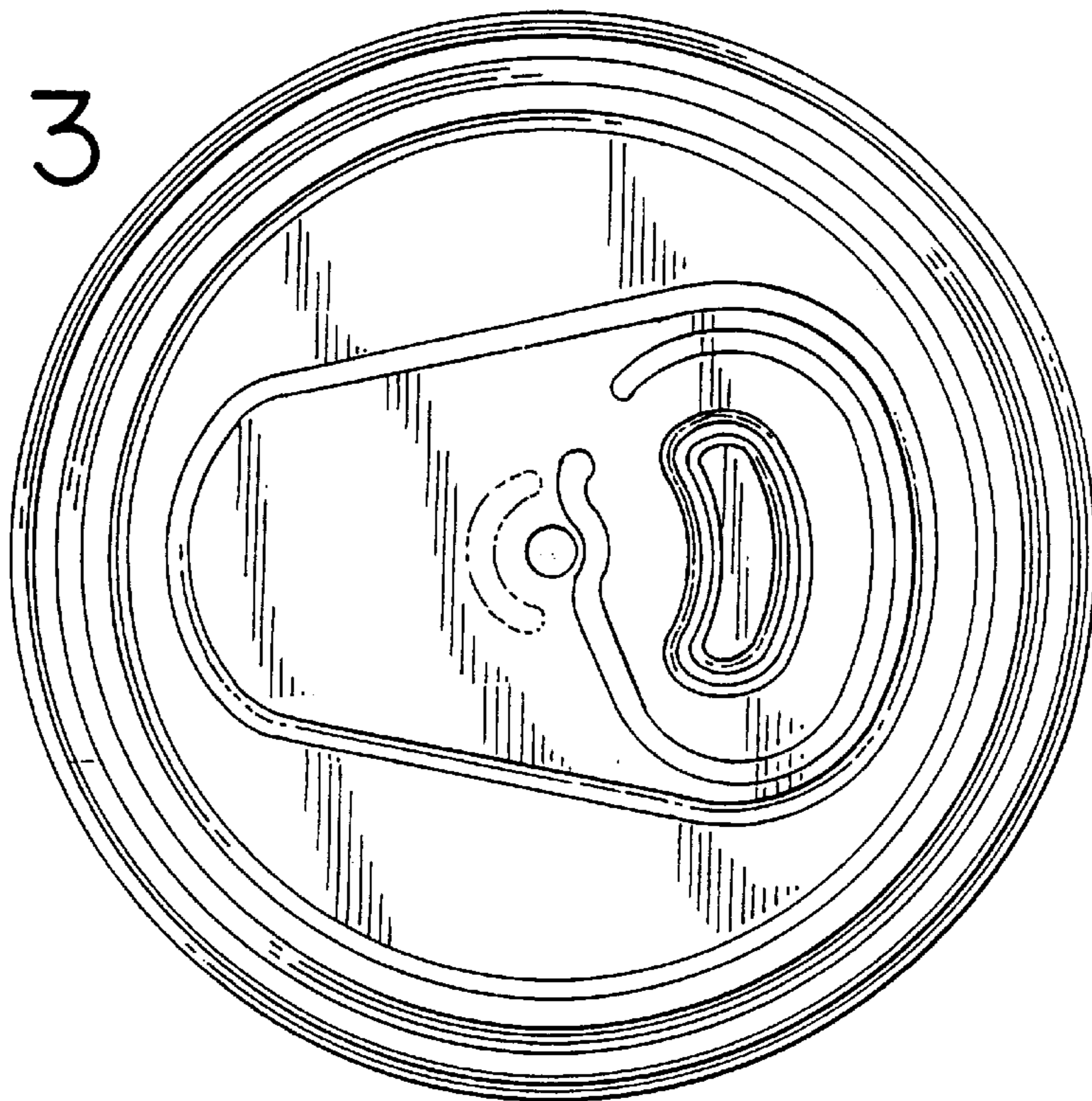
