DESCRIPTION

FIG. 1 is a prespective view of a first embodiment of the bottle;

FIG. 2 is a front elevation of the first embodiment of the bottle, the rear elevation is the same;

FIG. 3 is a side elevation of the first embodiment, the opposite side elevation is the same;

FIG. 4 is a top plan view of a first embodiment of the bottle;

FIG. 5 is a bottom plan view of a first embodiment of the bottle;

FIG. 6 is a prespective view of a second embodiment of the bottle;

FIG. 7 is a front elevation of the second embodiment, the rear elevation is the same;

FIG. 8 is a side elevation of the second embodiment, the opposite side elevation is the same;

FIG. 9 is a top plan view of a second embodiment of the bottle;

FIG. 10 is a bottom plan view of a second embodiment of the bottle;

FIG. 11 is a prespective view of a third embodiment of the bottle;

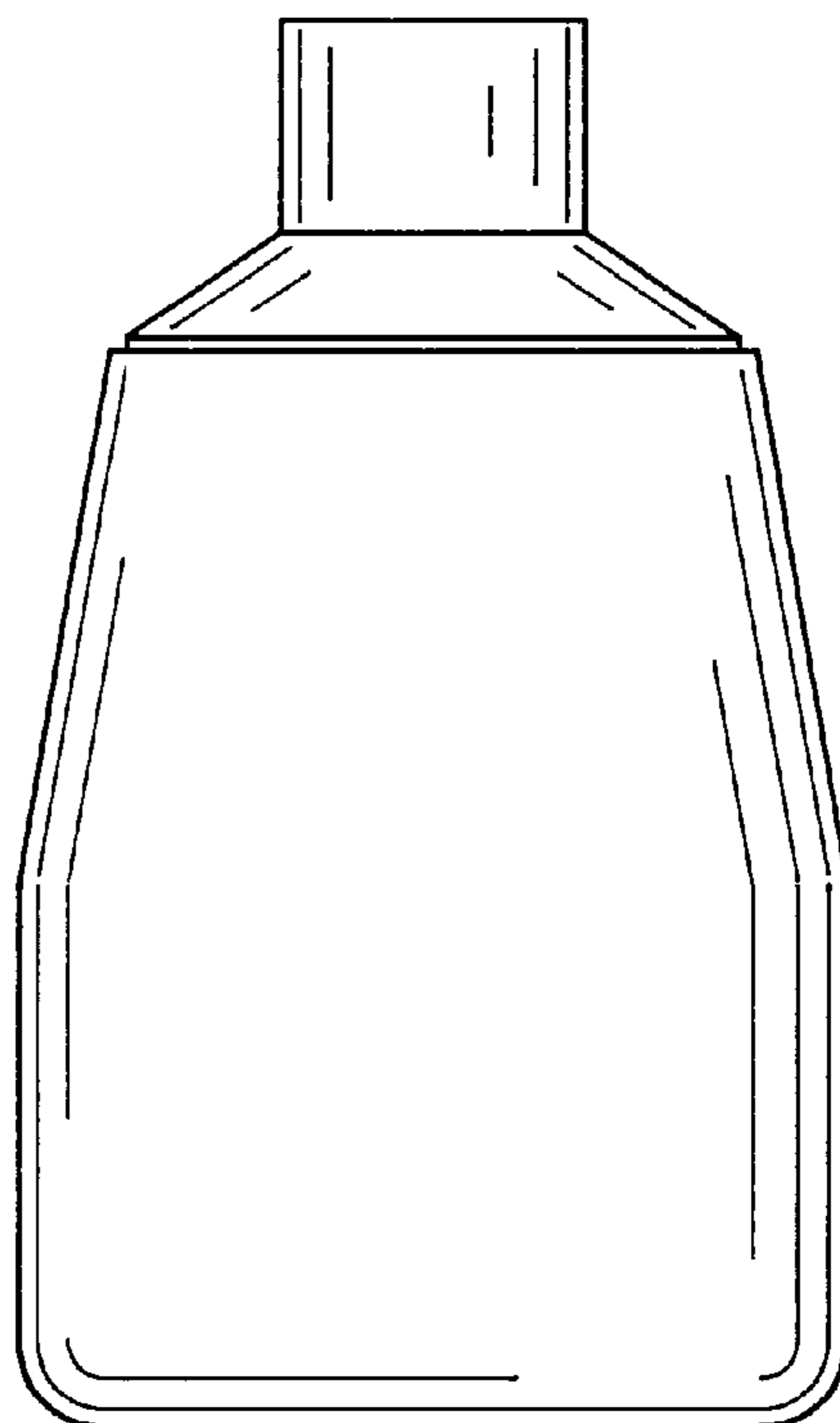
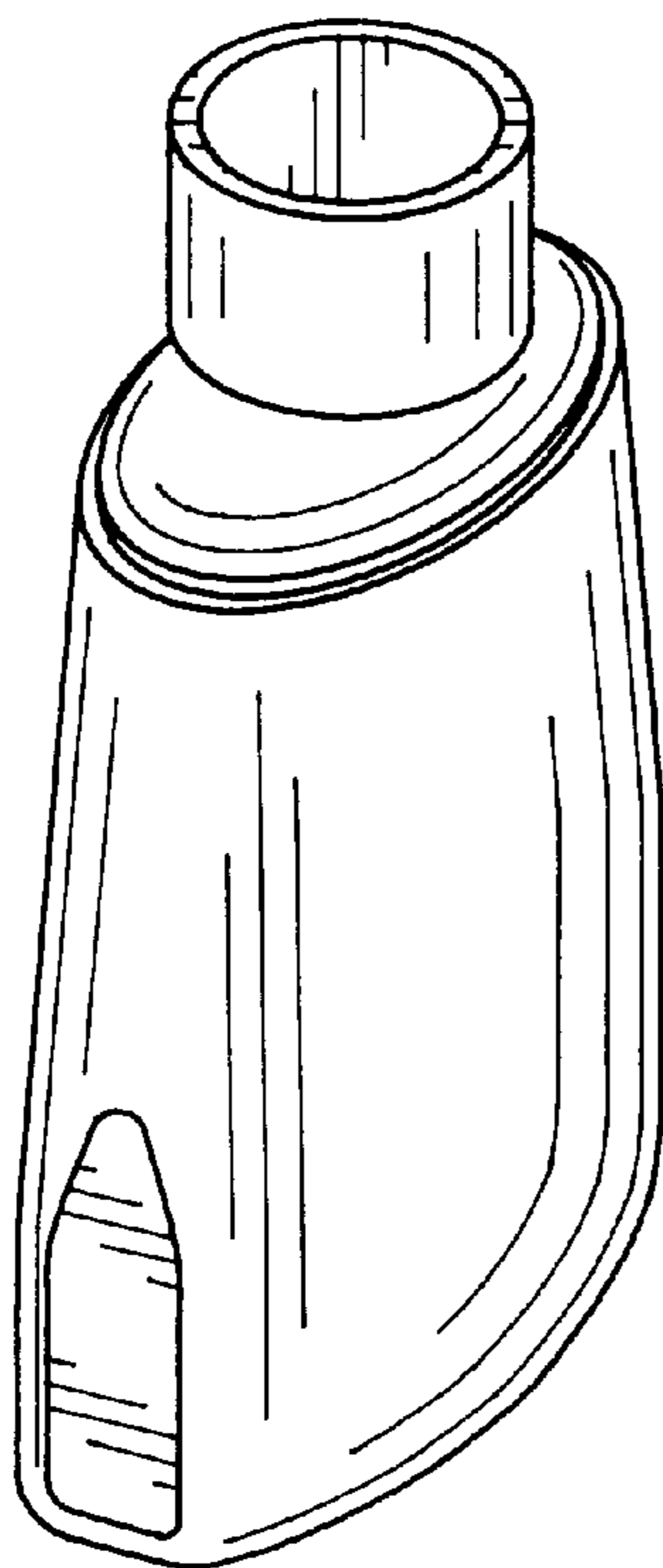
FIG. 12 is a front elevation of the third embodiment, the rear elevation is the same;

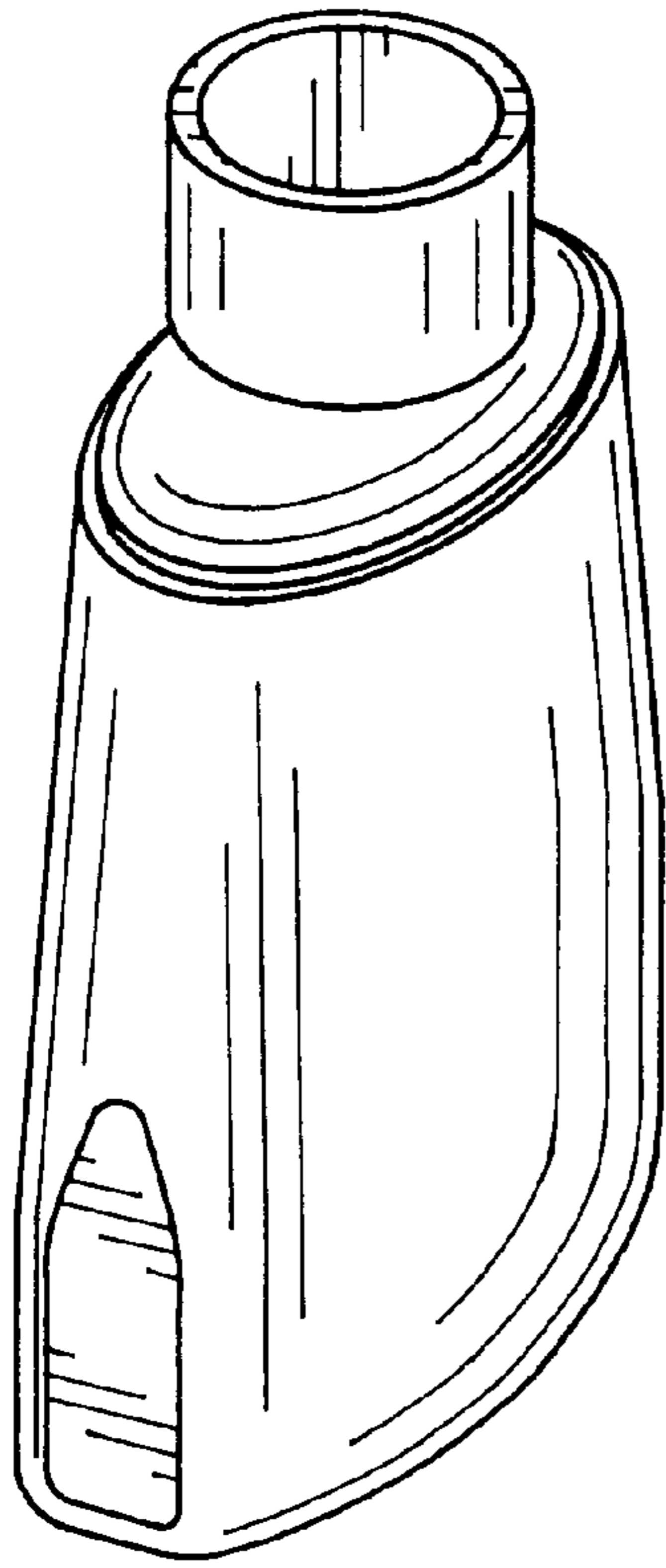

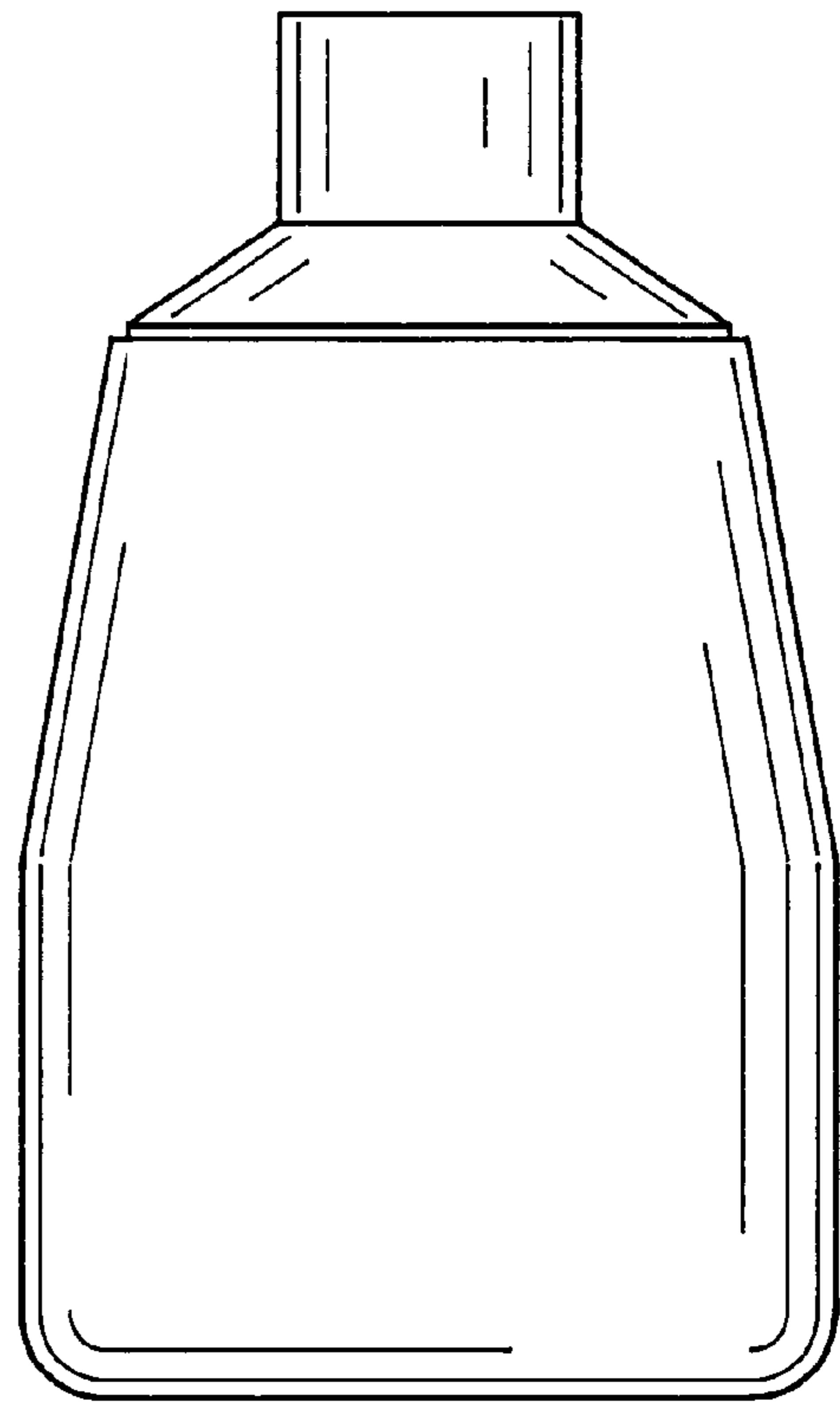

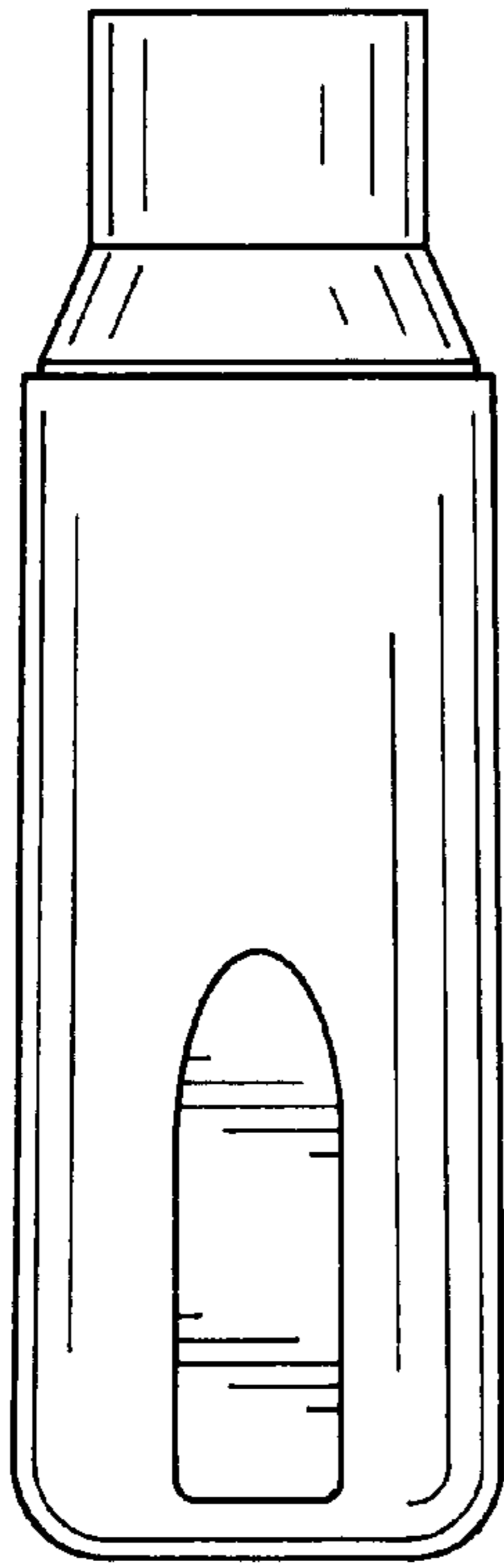

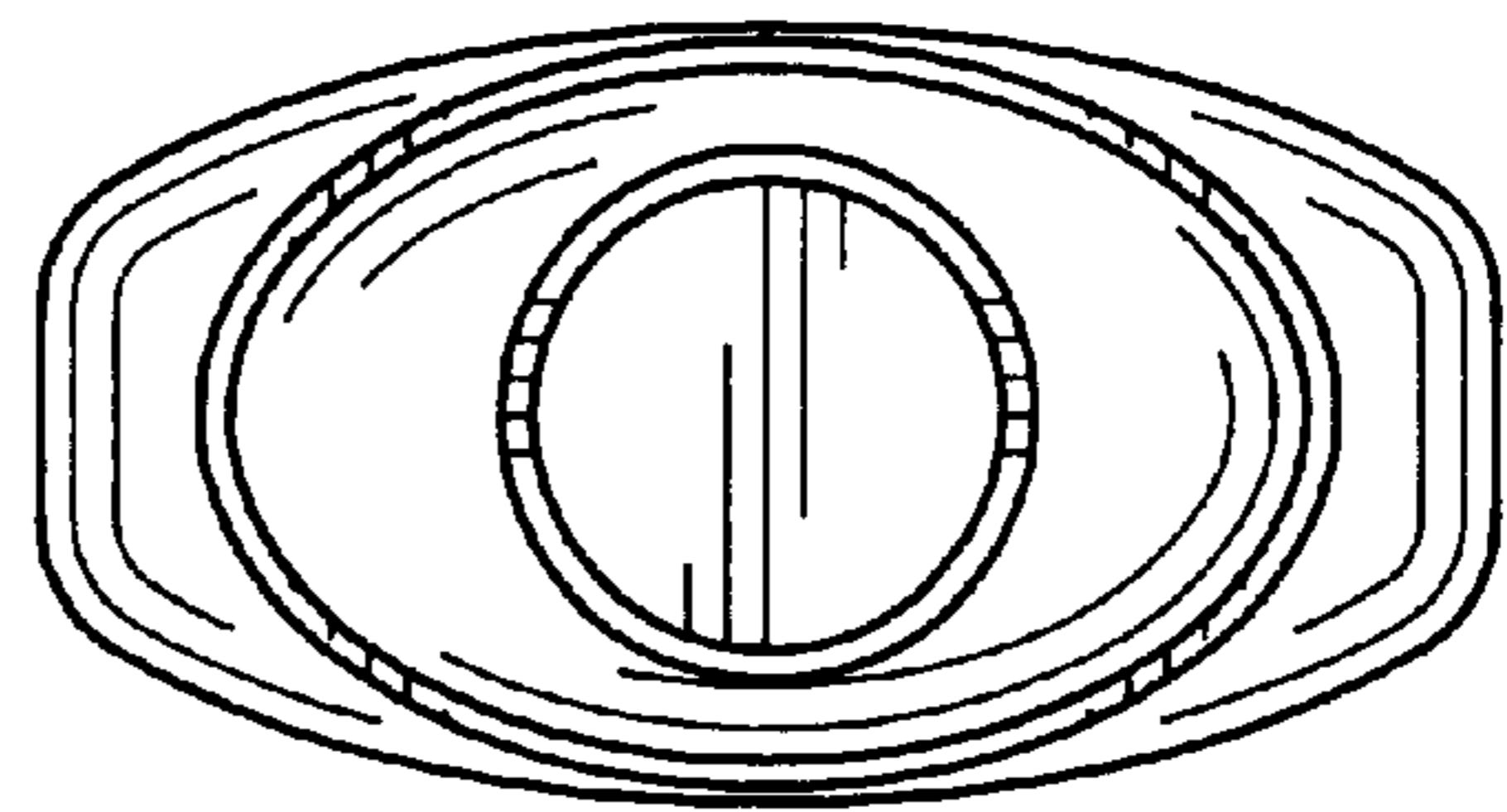

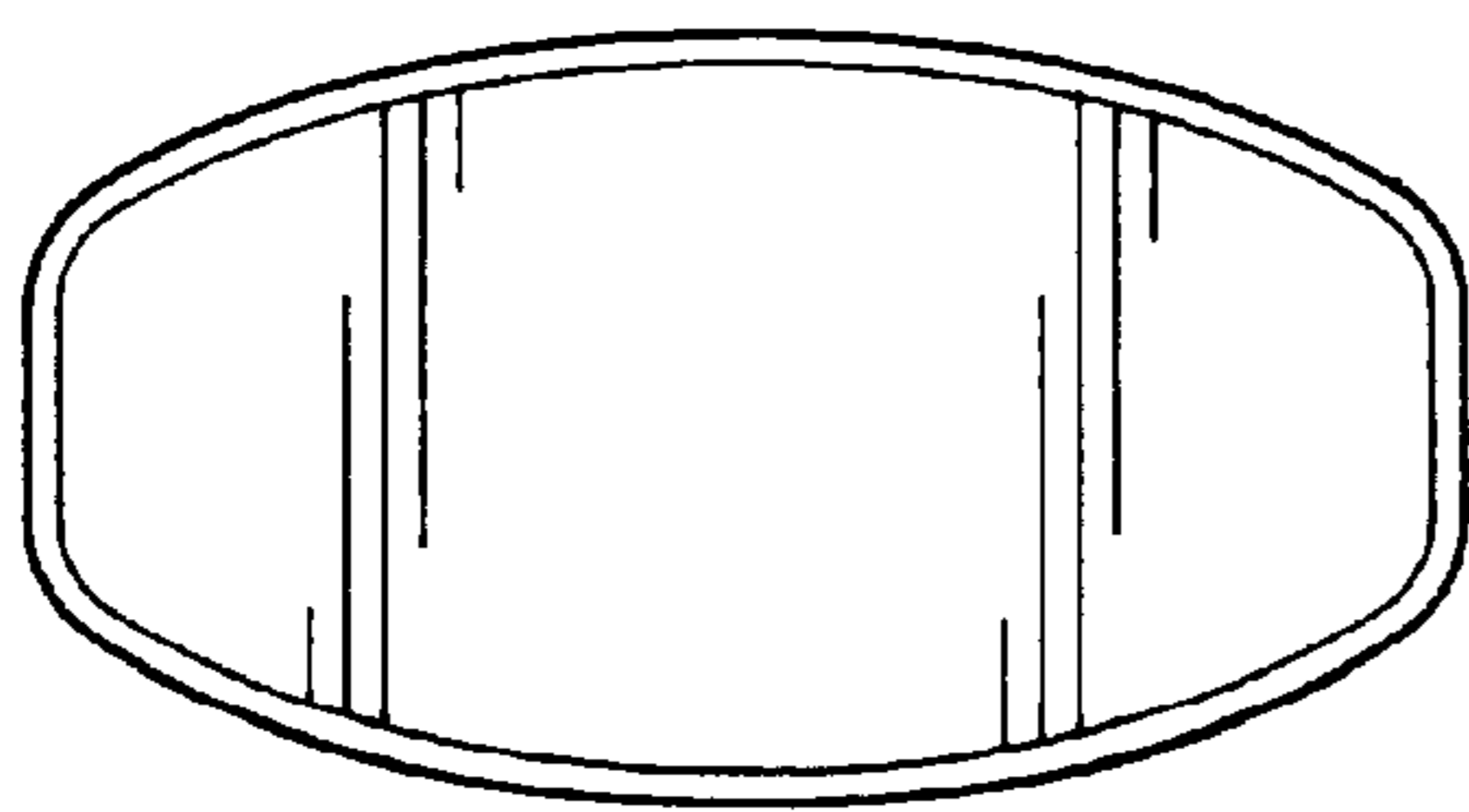

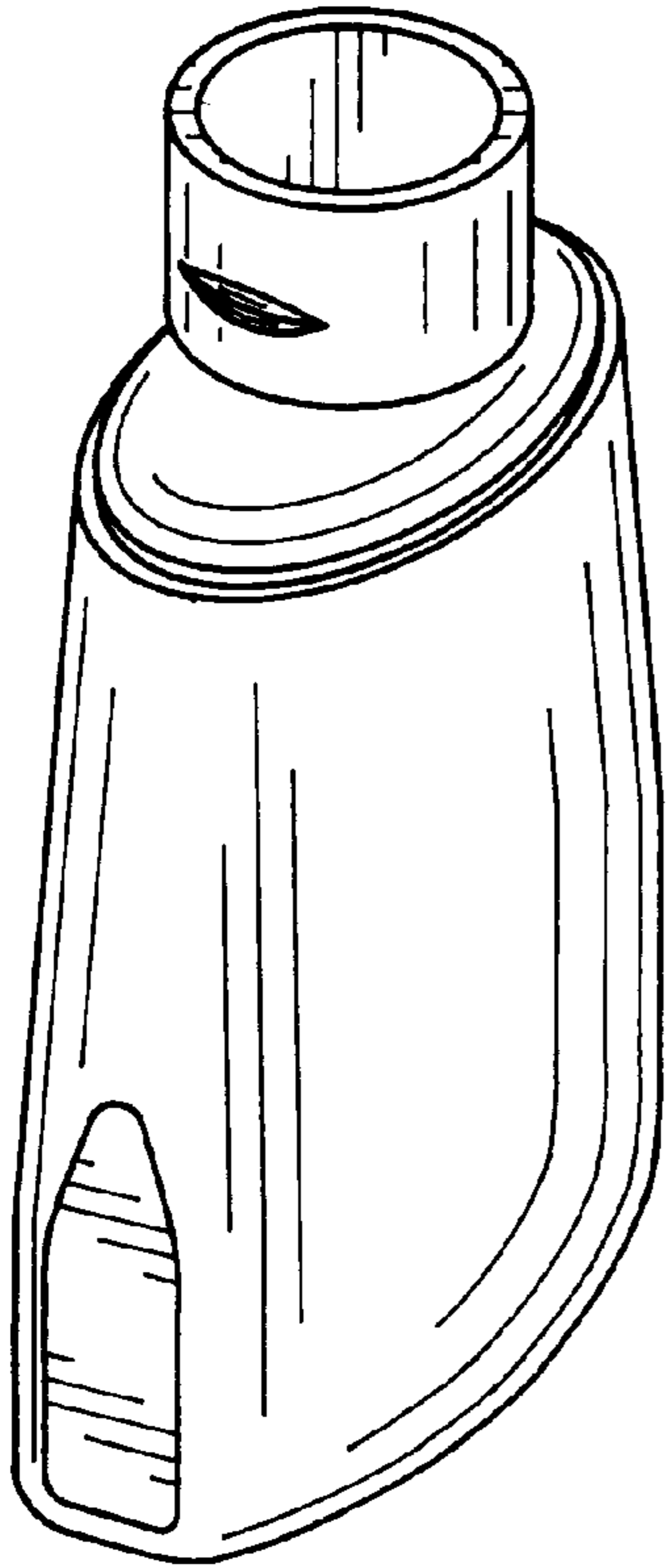

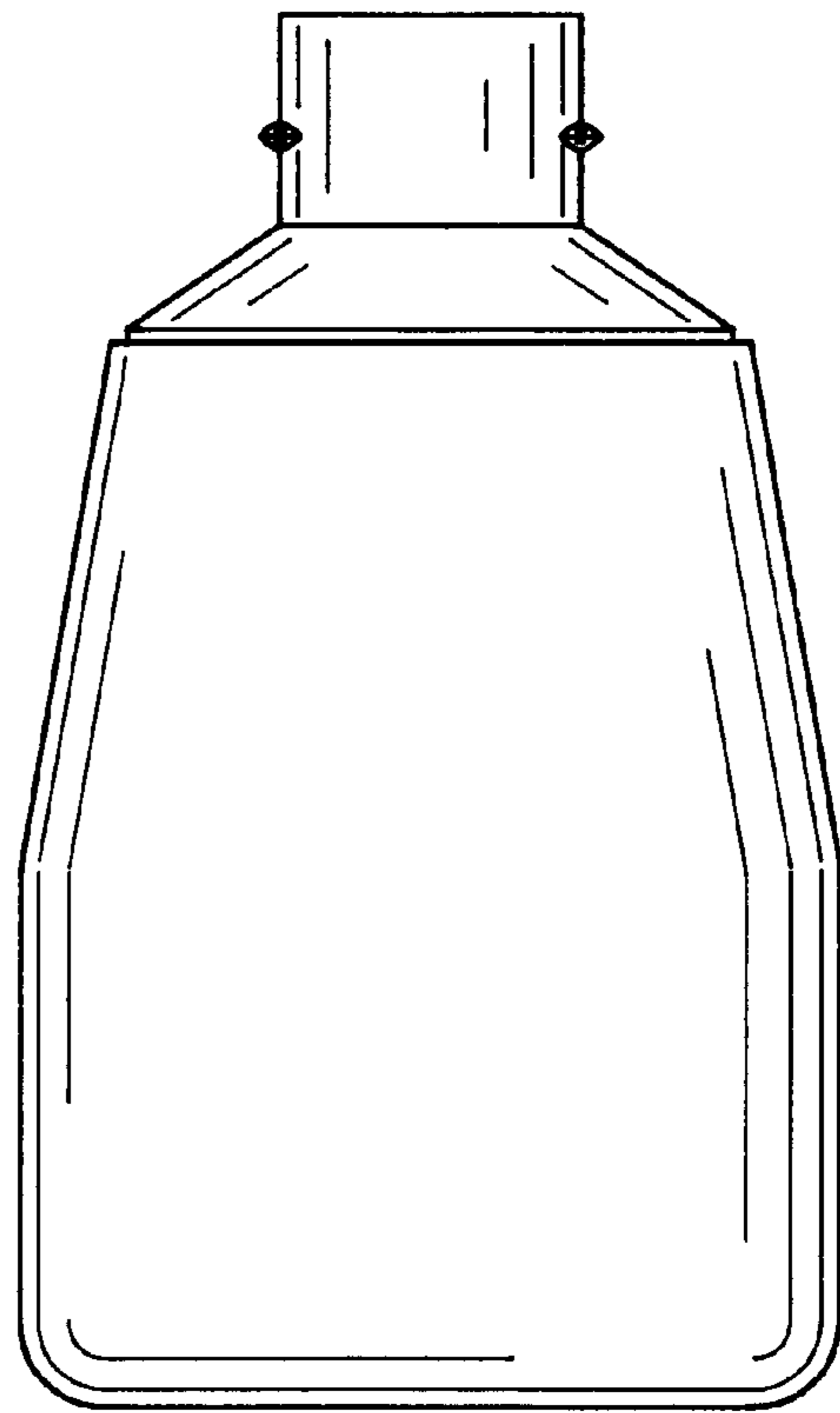

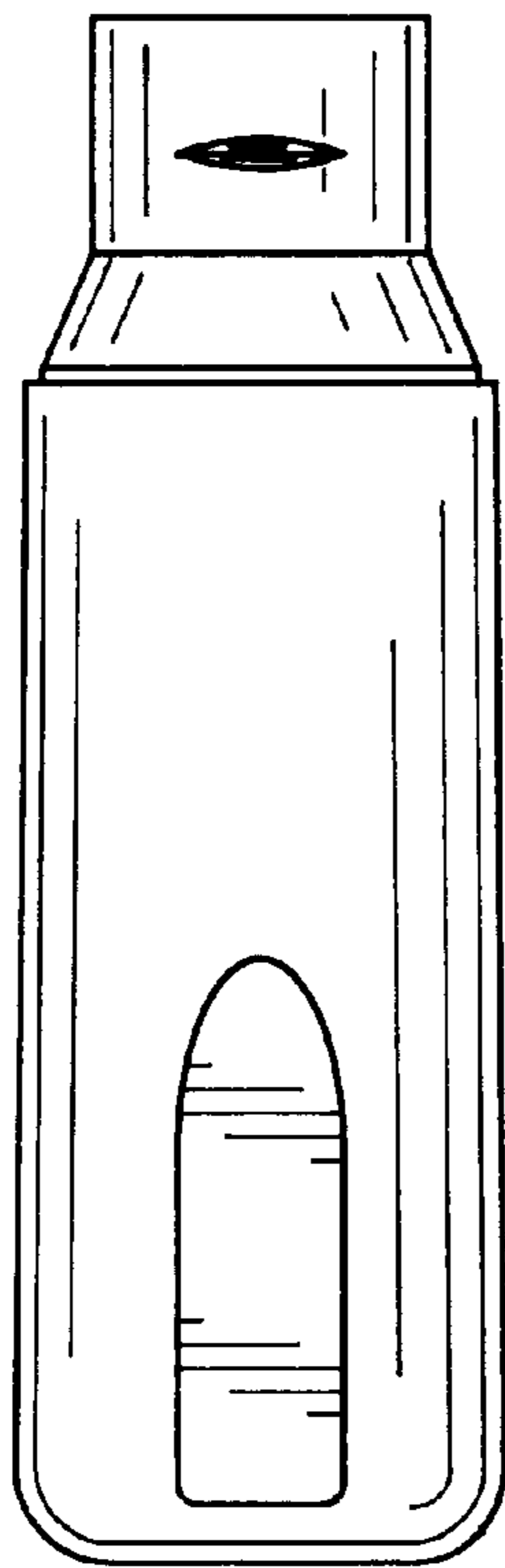

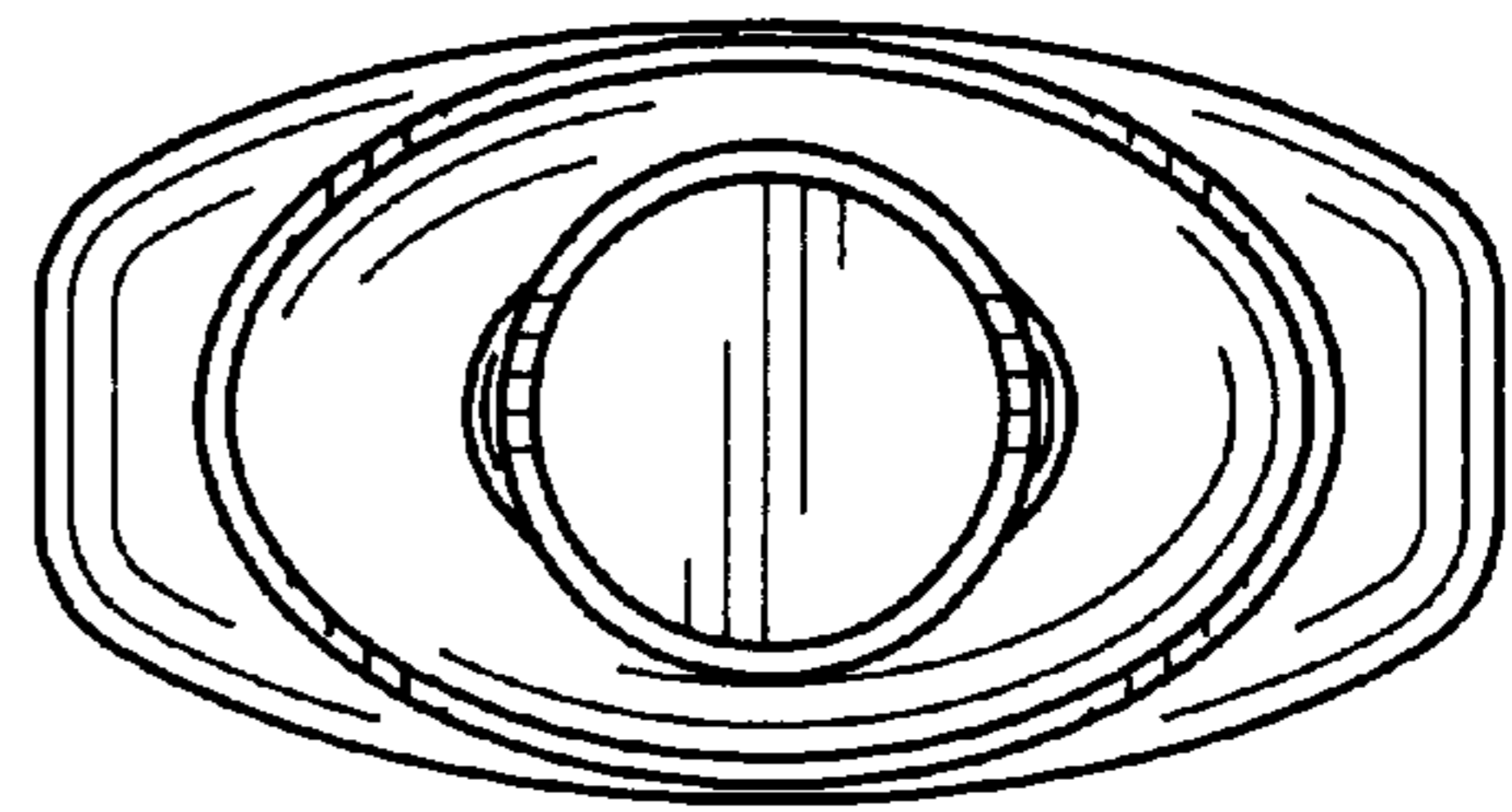

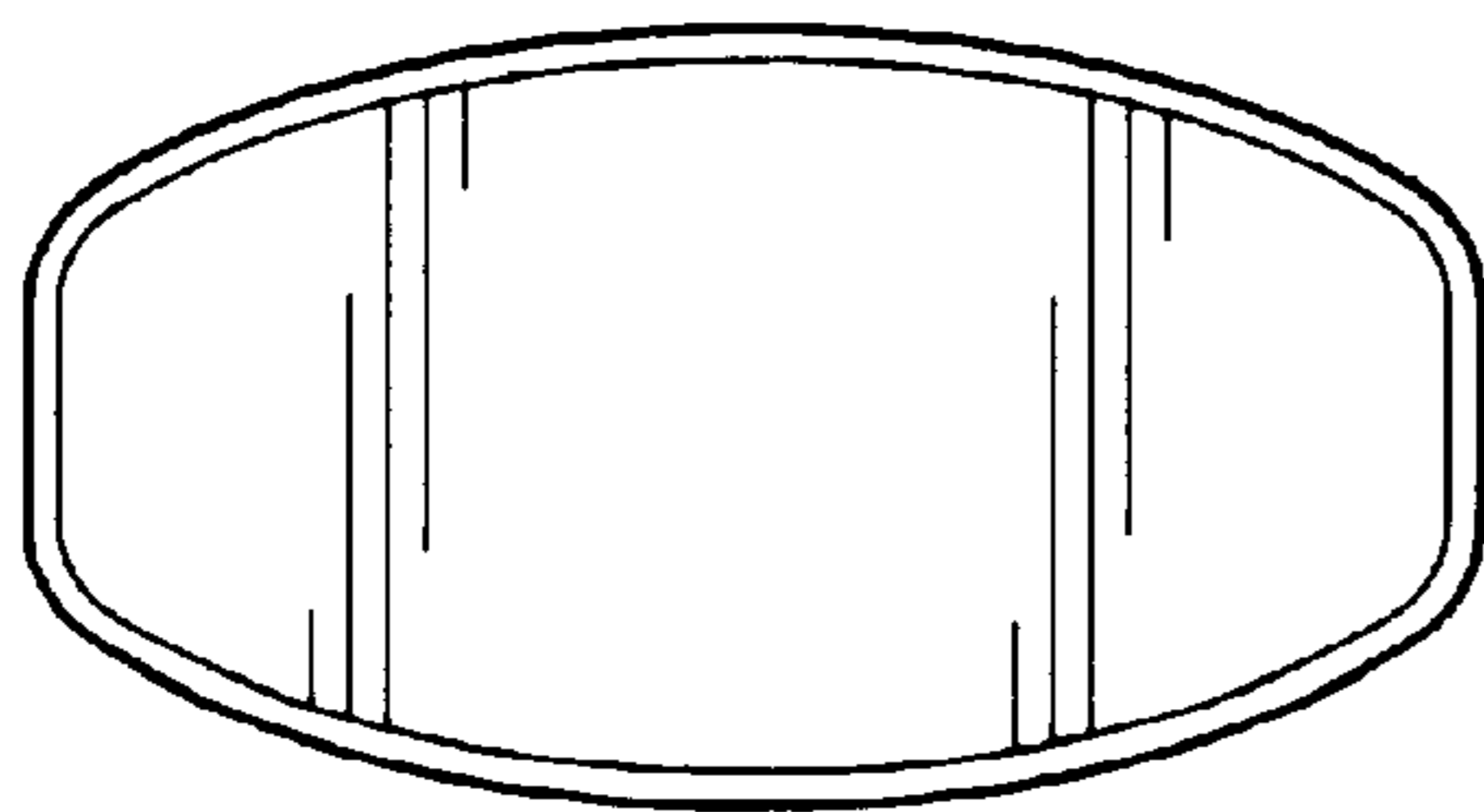

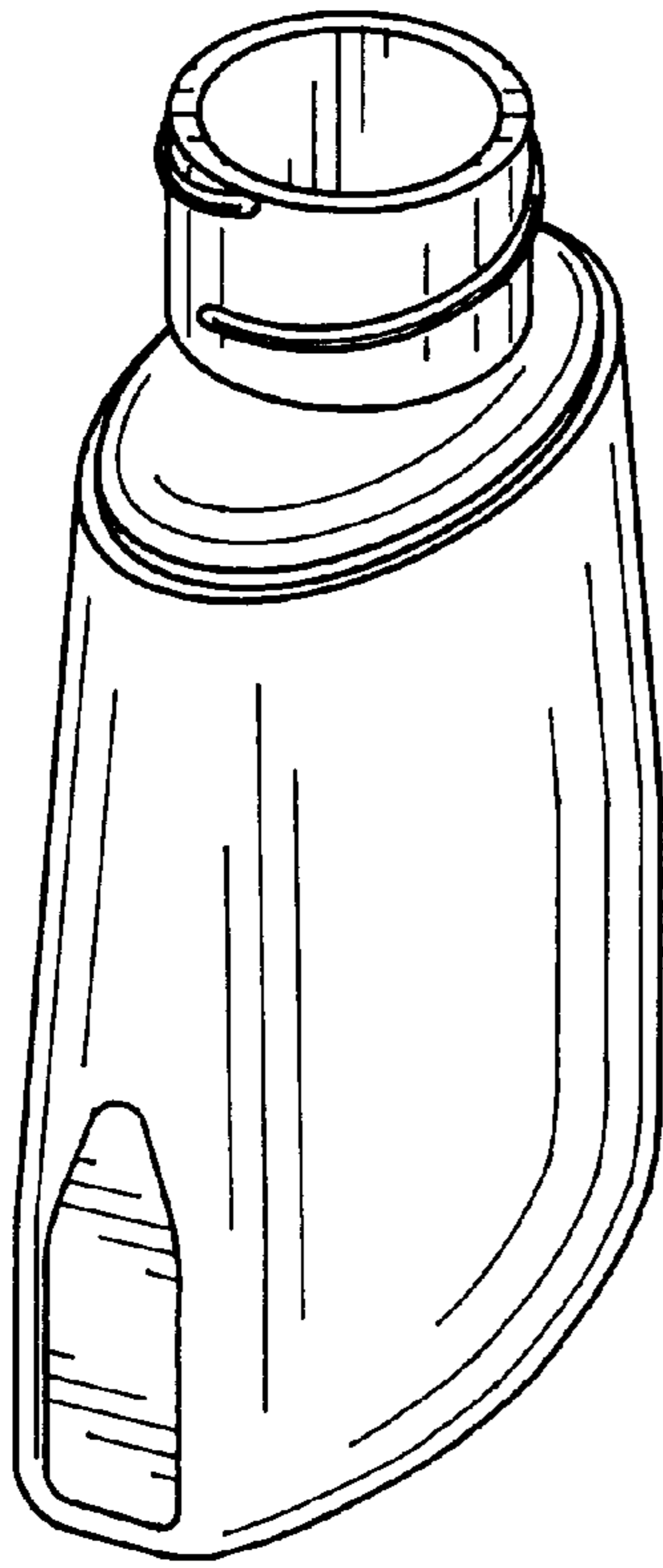

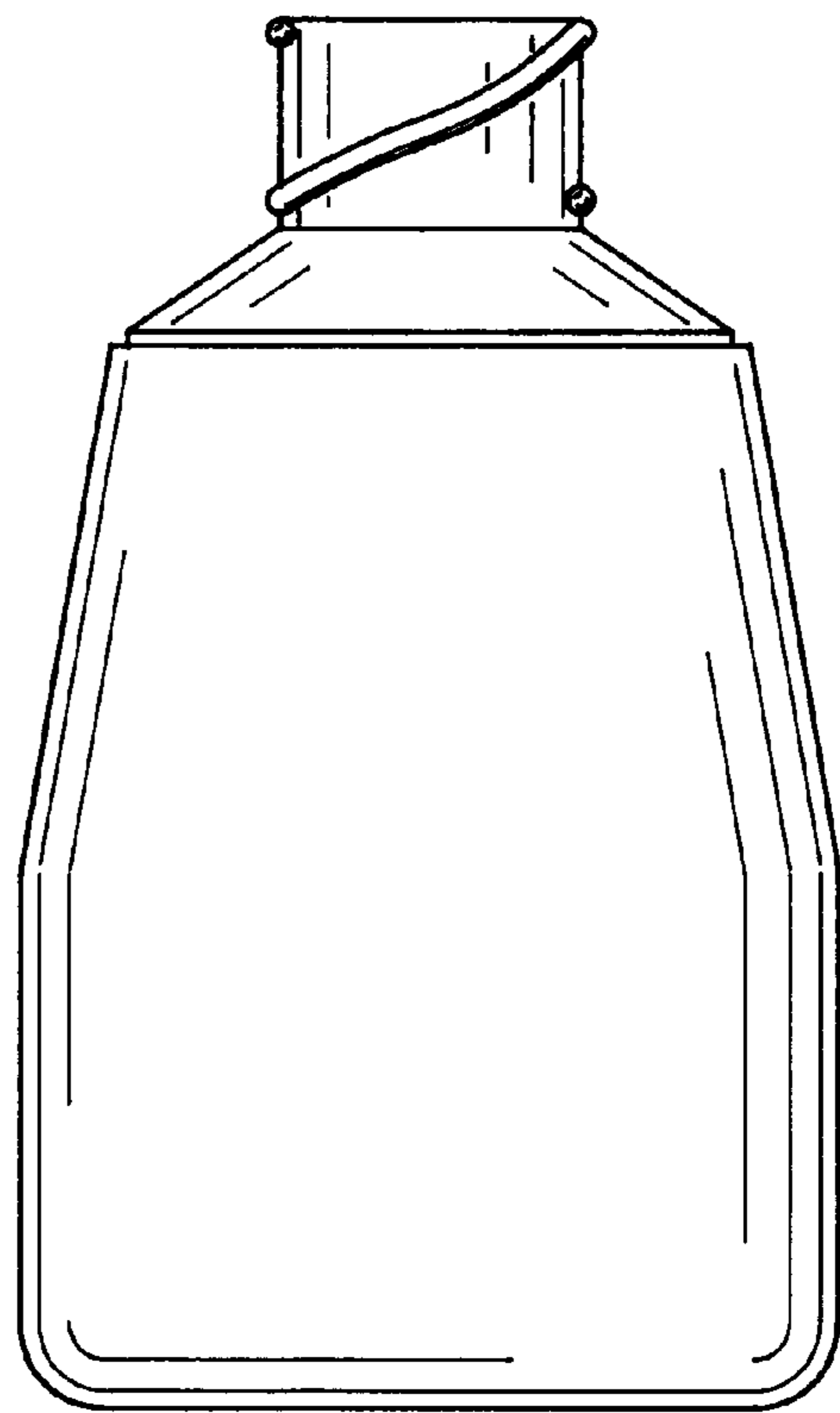

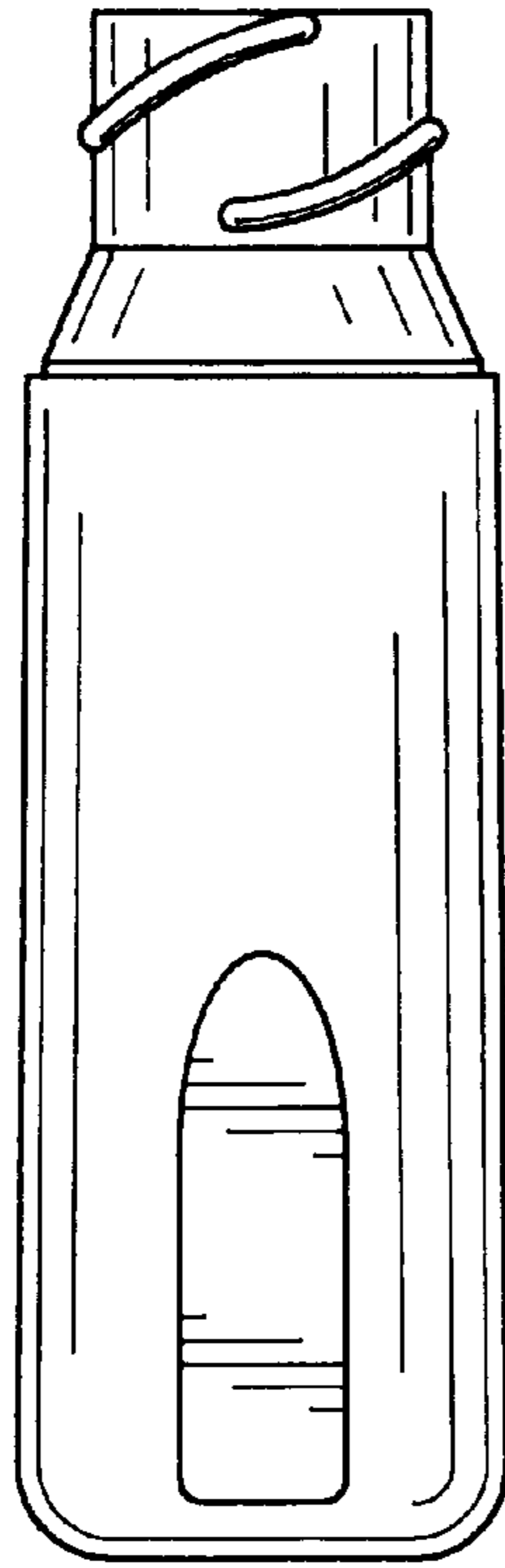

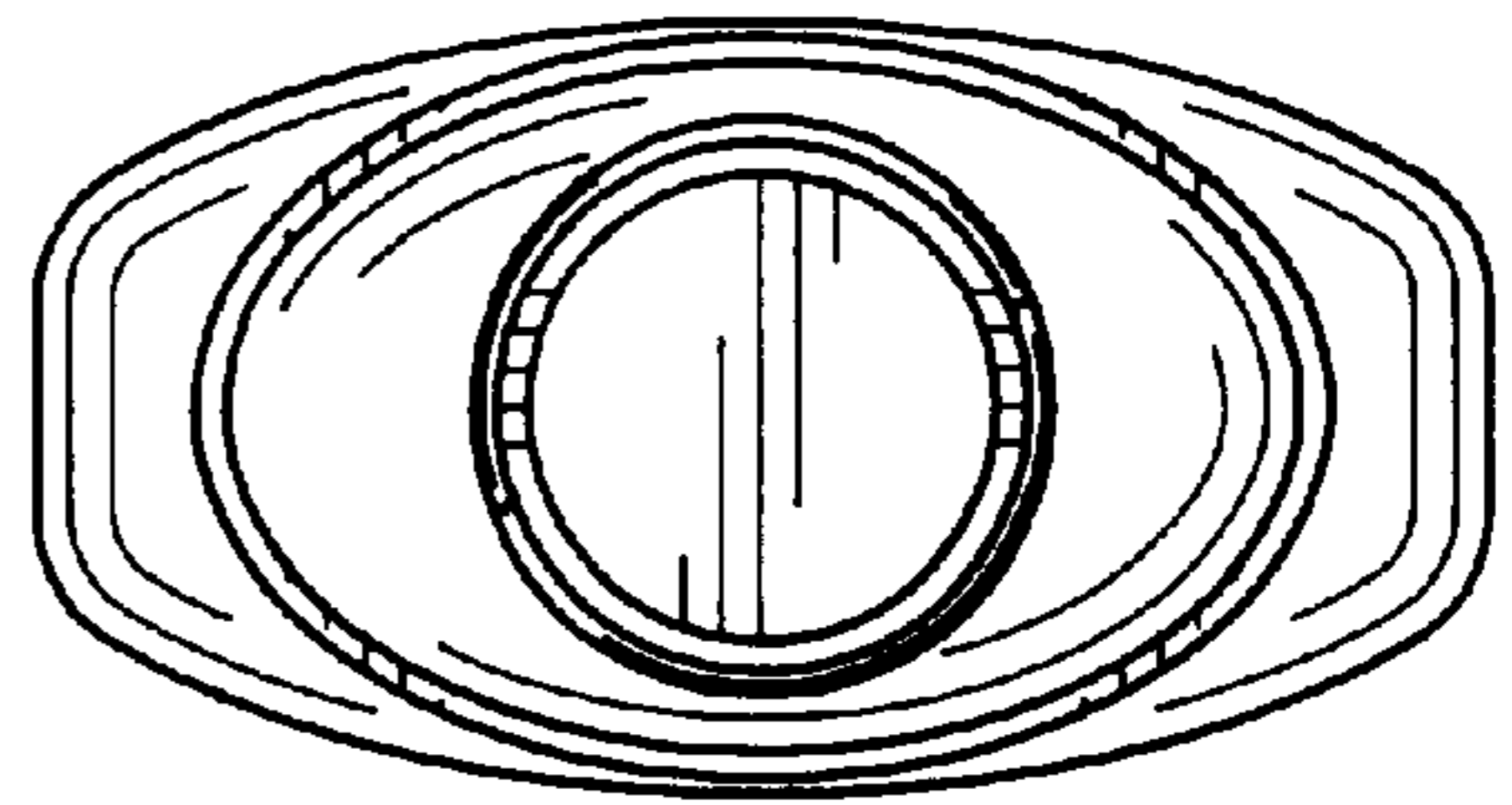

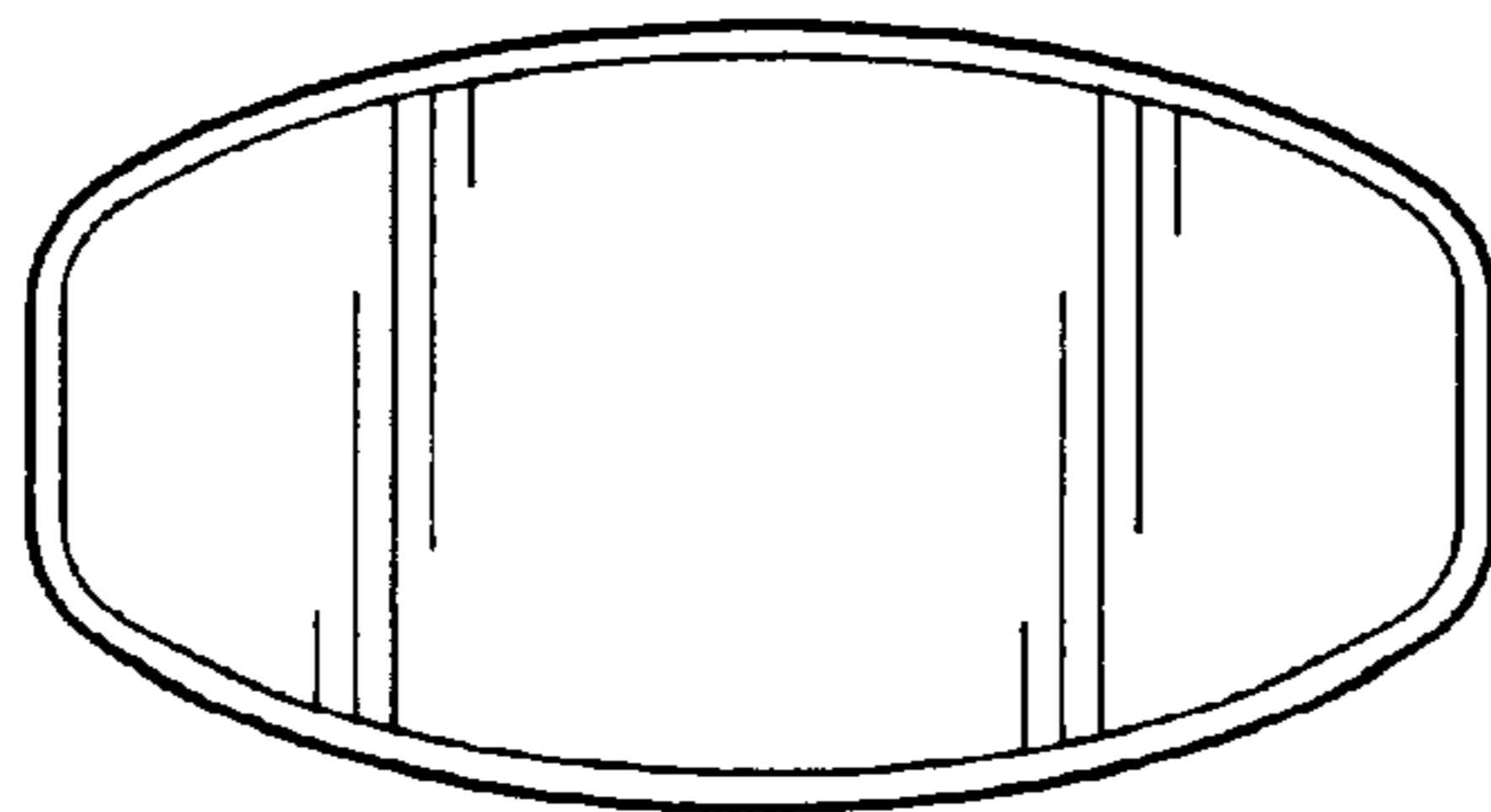
