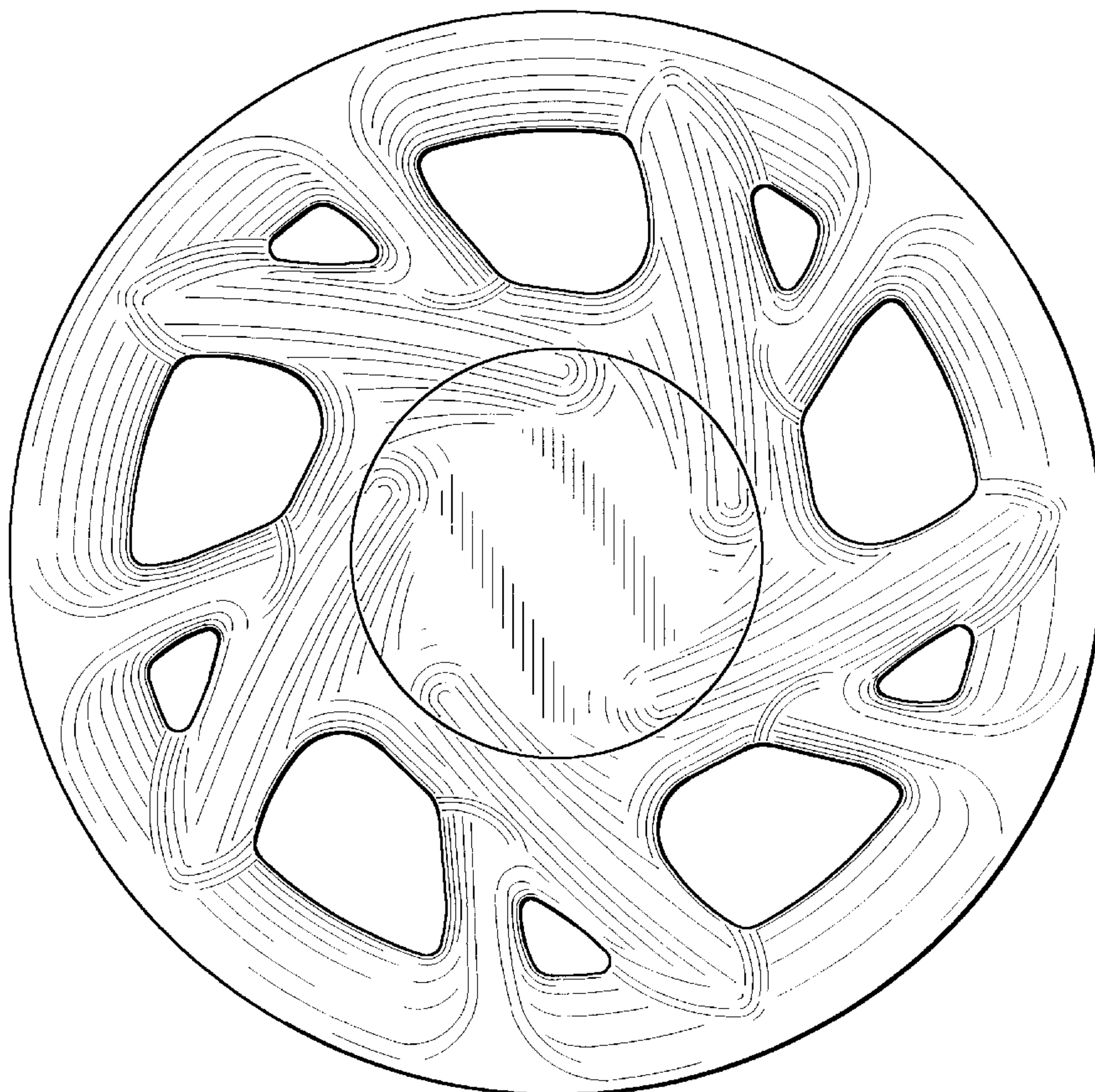
DESCRIPTION

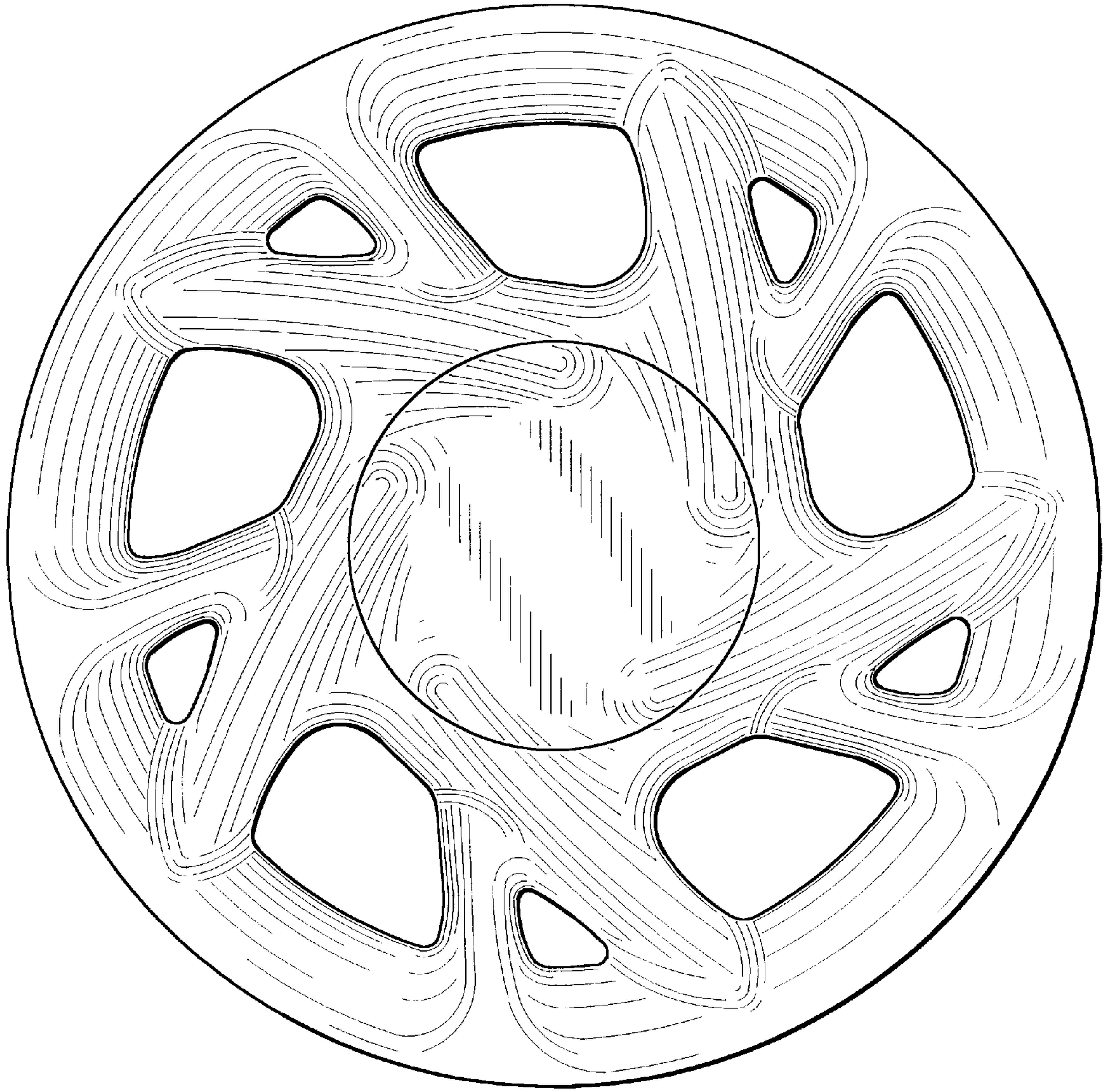

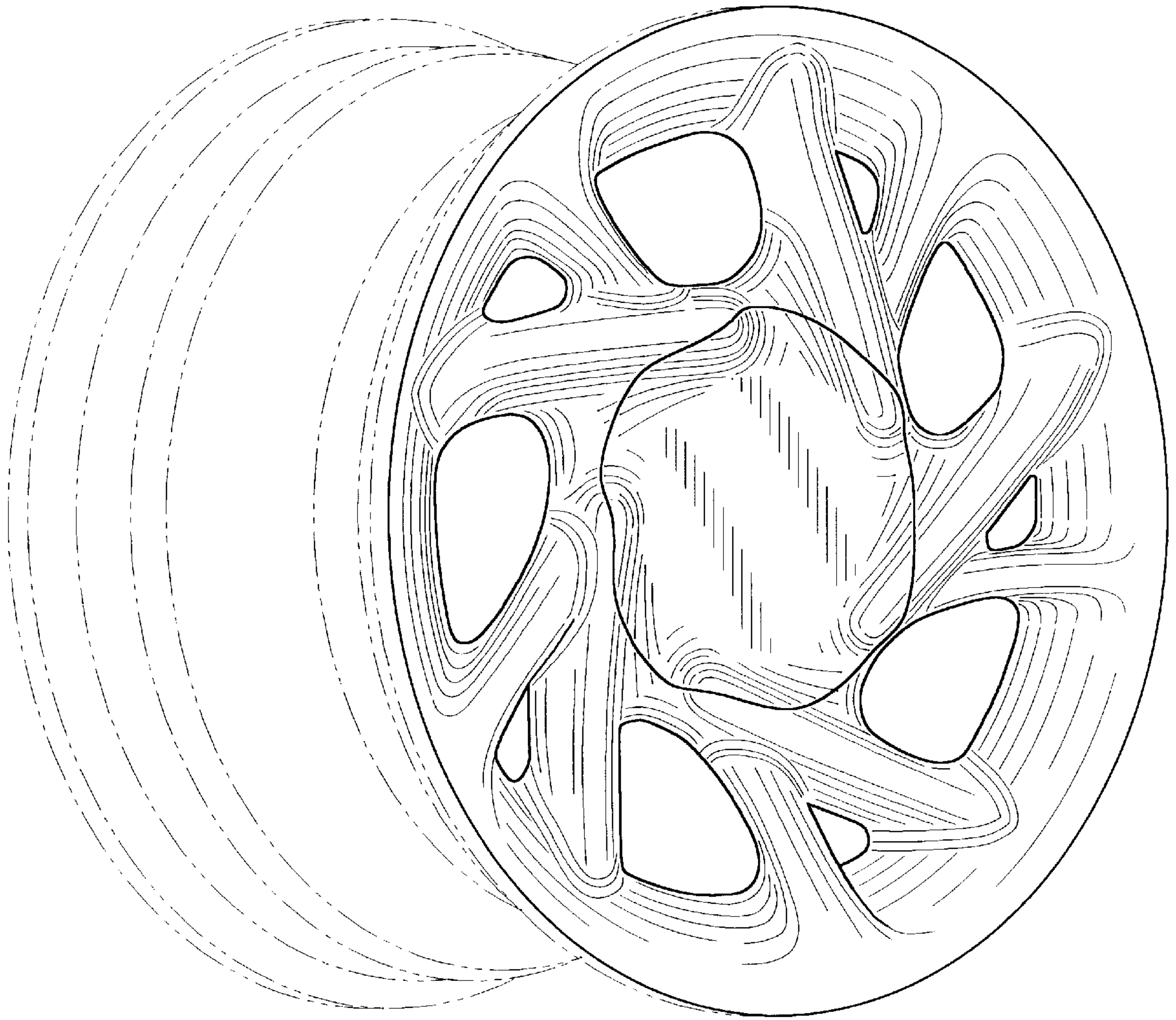
