[57] **CLAIM**

The ornamental design for a toy, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevation view of the toy.

FIG. 2 is a rear elevation view of the toy.

FIG. 3 is a left side elevation view of the toy.

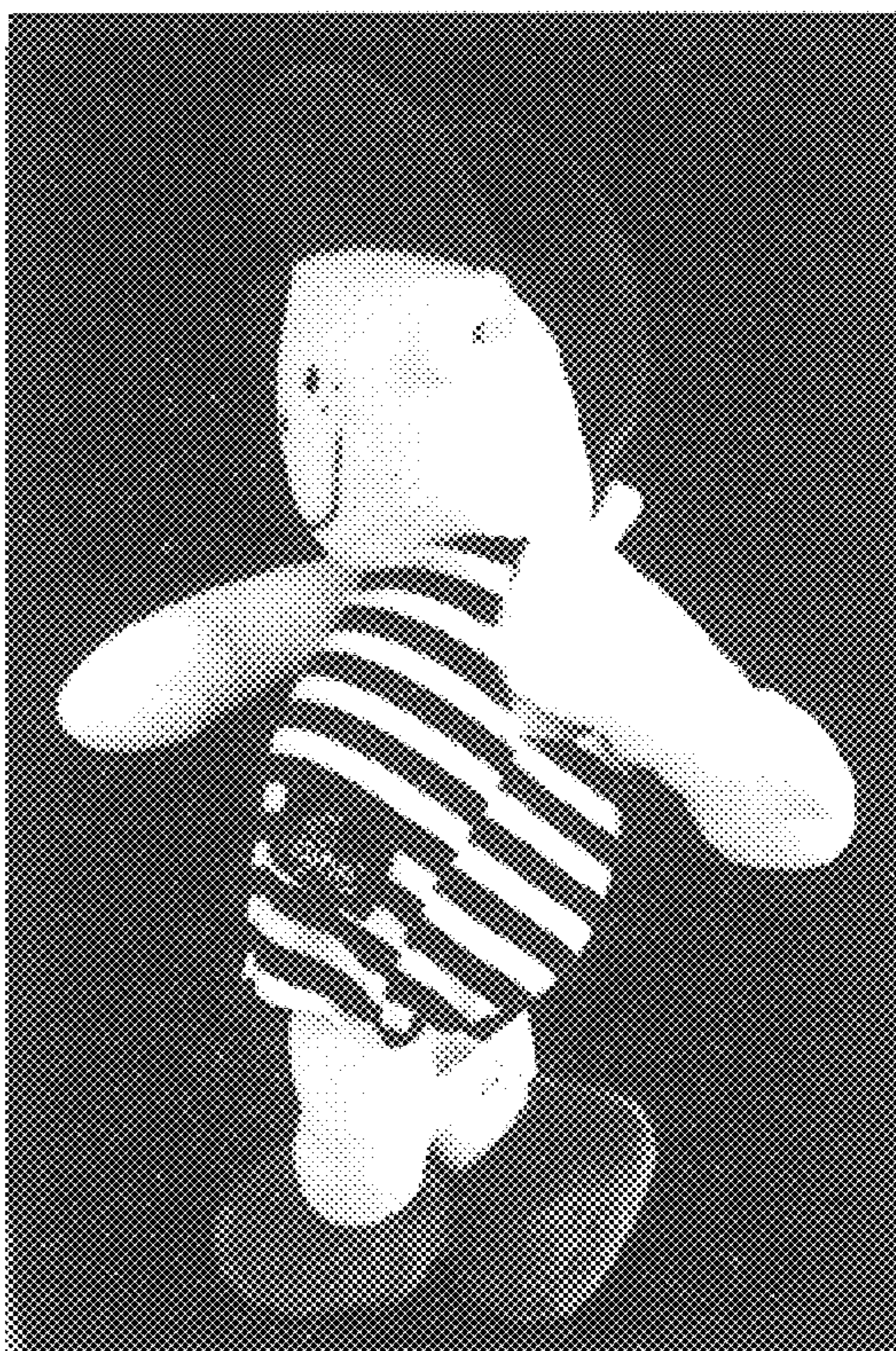

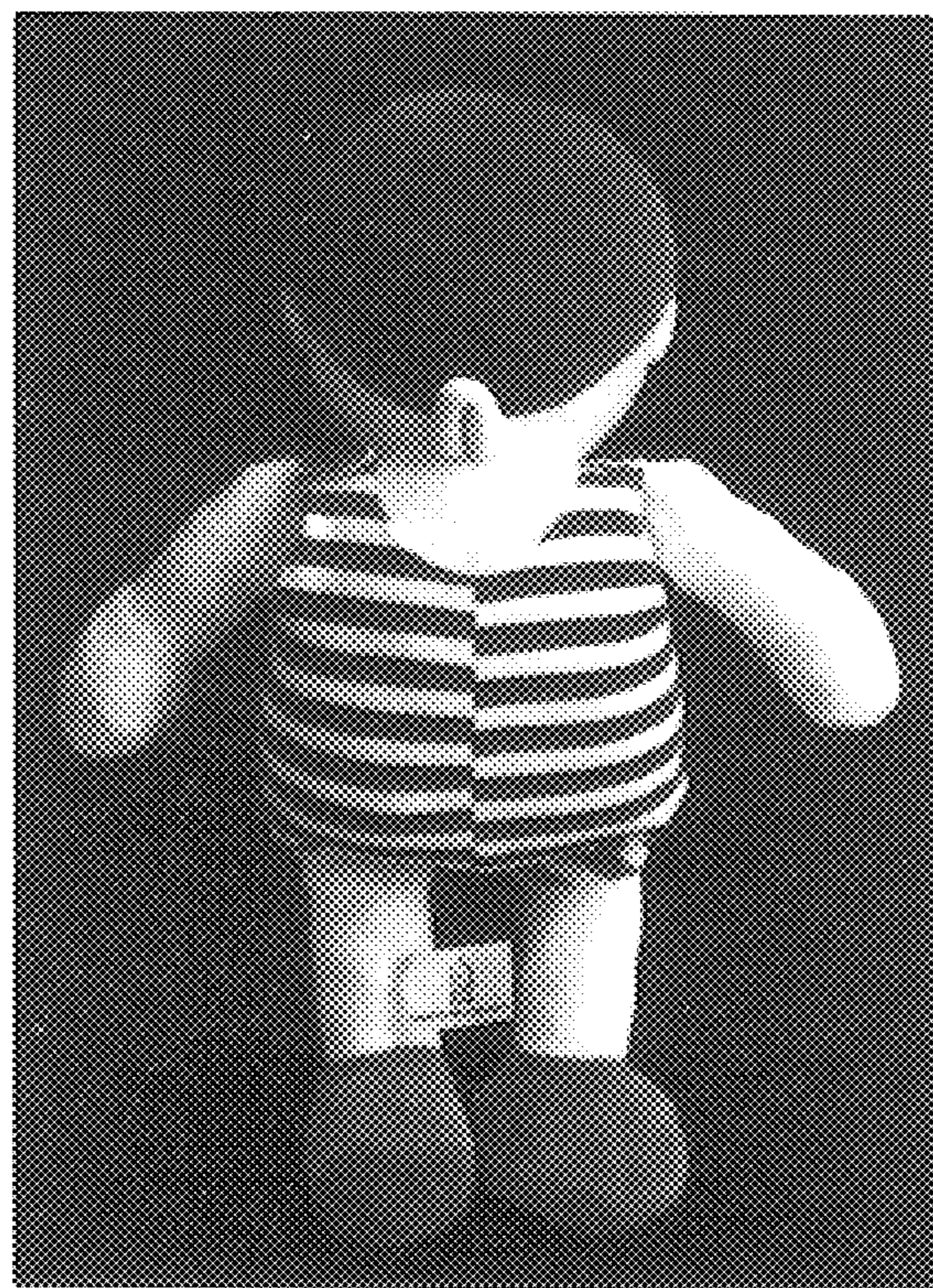

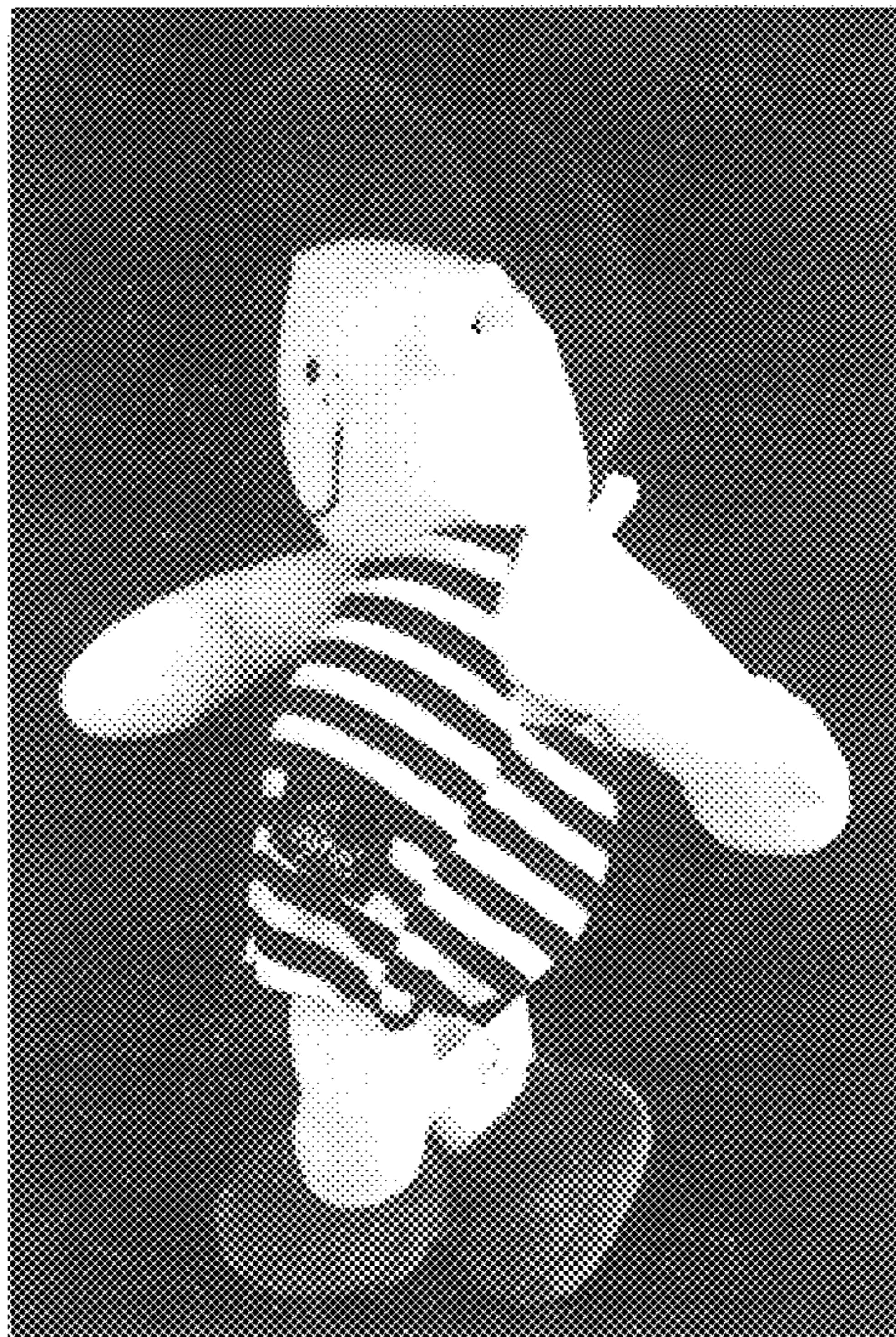

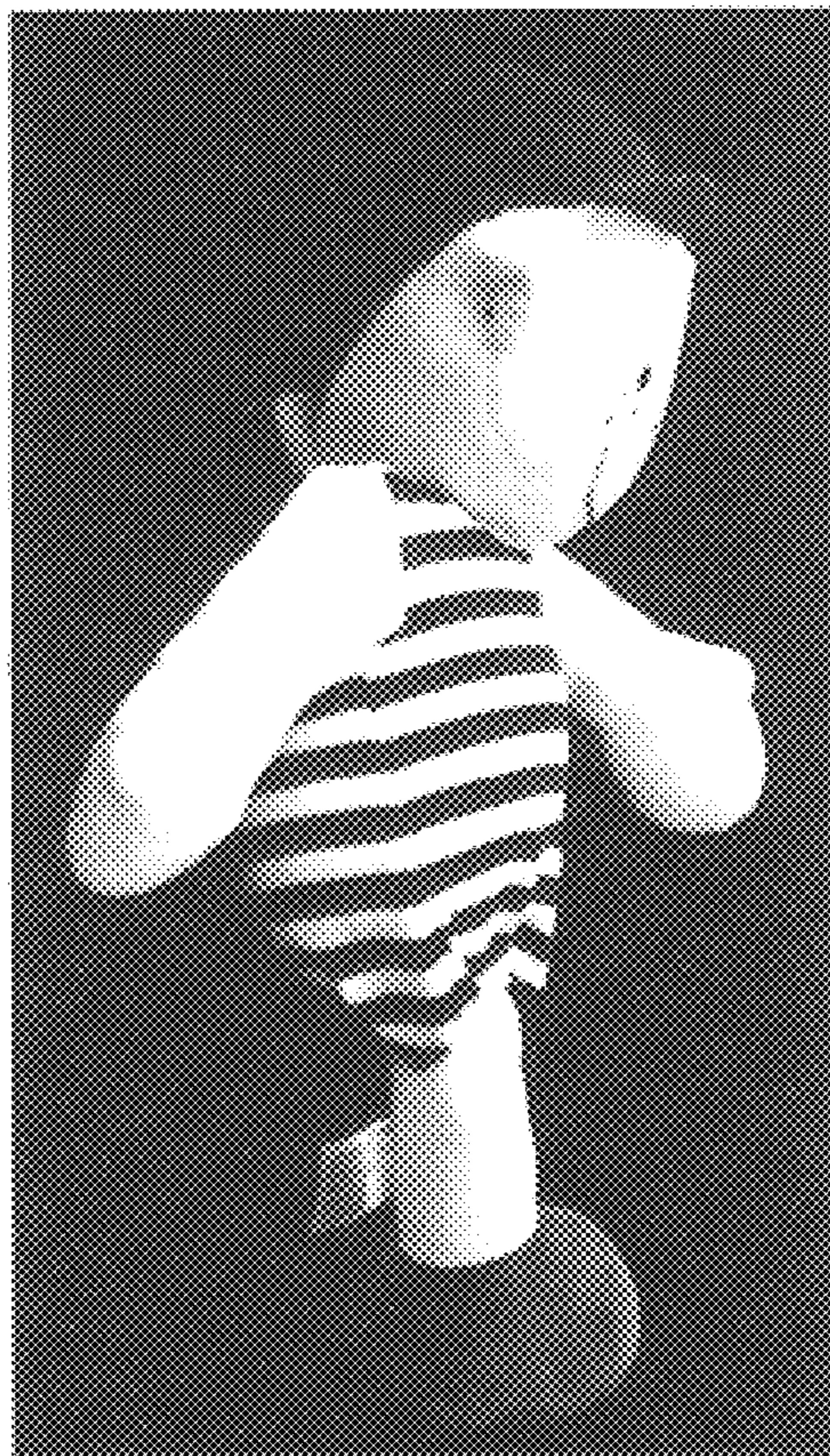

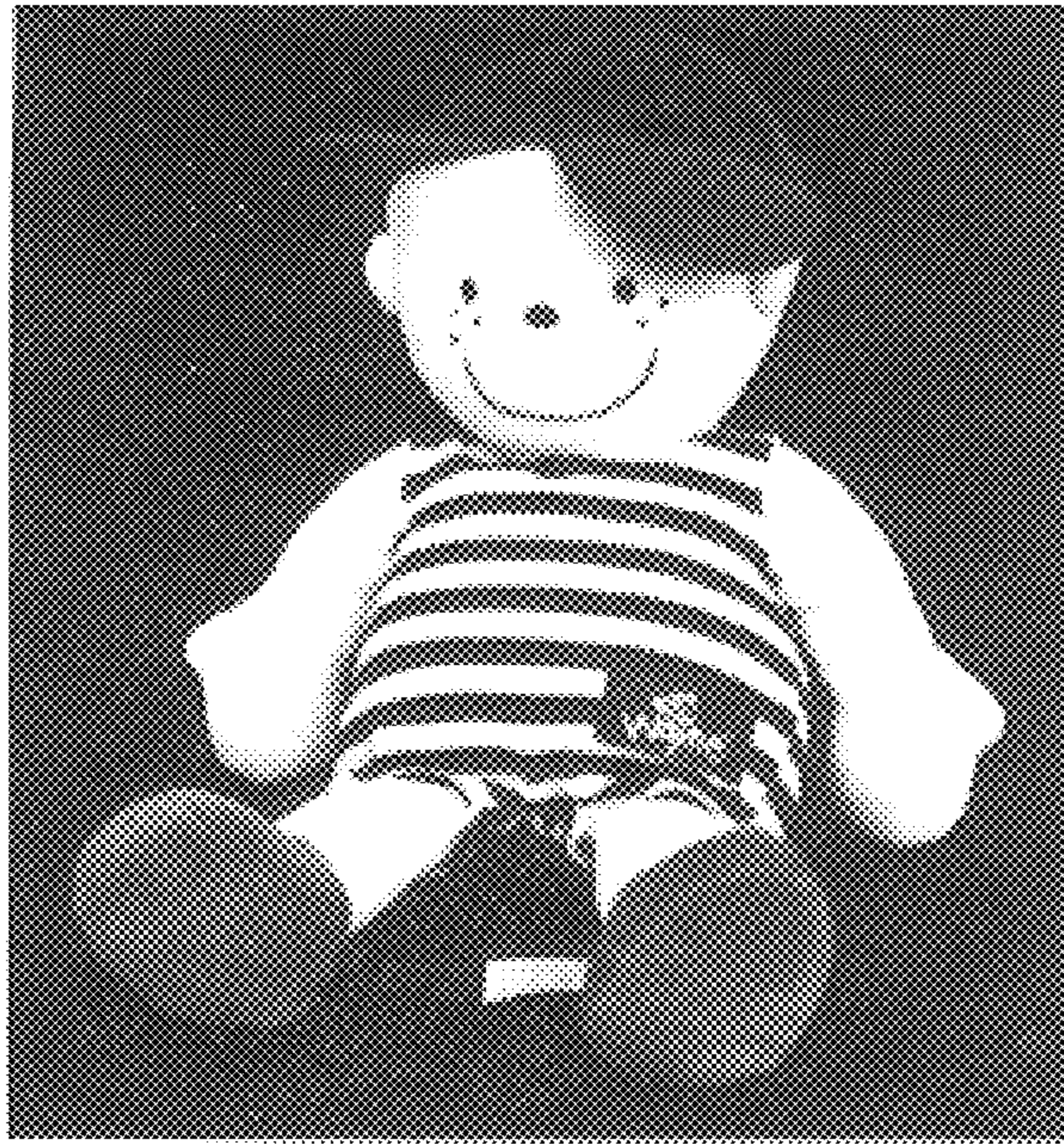
