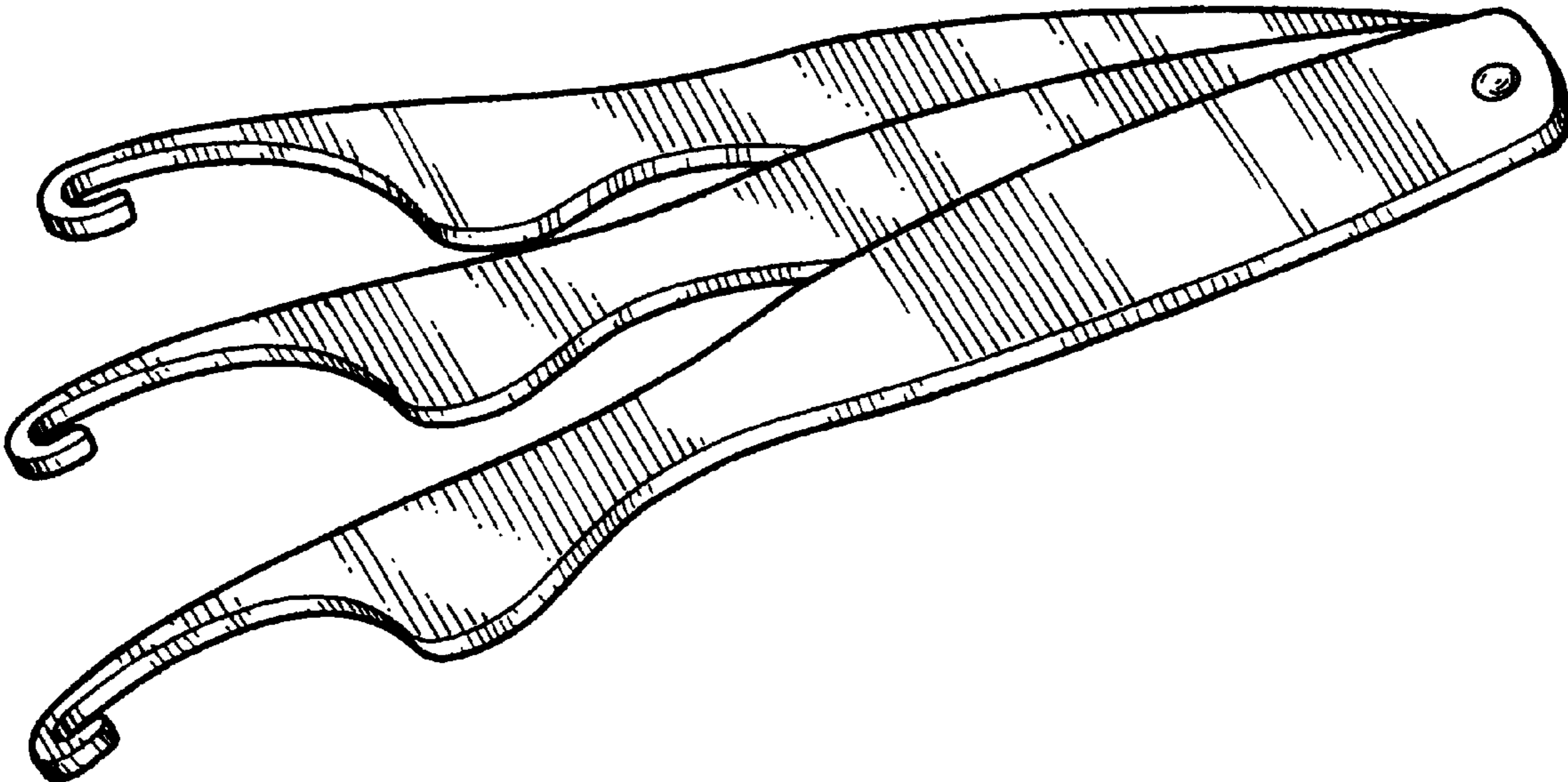
[57] **CLAIM**

I claim the ornamental design for wedding gown button looper, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a wedding gown button looper showing my new design; FIG. 2 is a front elevational view thereof, the rear elevational view is a mirror image; FIG. 3 is a left elevation view thereof; FIG. 4 is a right elevational view thereof; FIG. 5 is a top plan view thereof; and, FIG. 6 is a bottom plan view thereof.

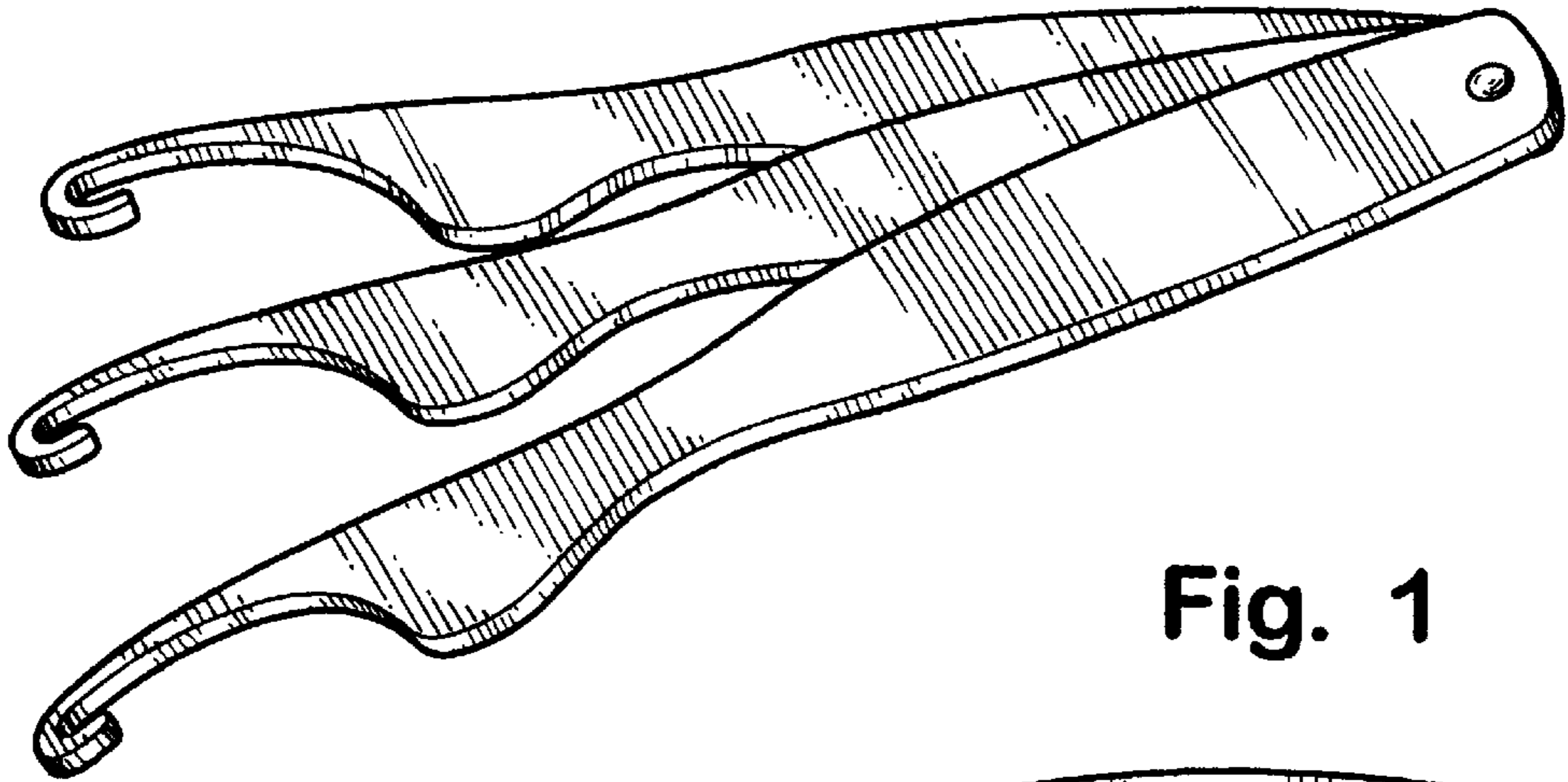

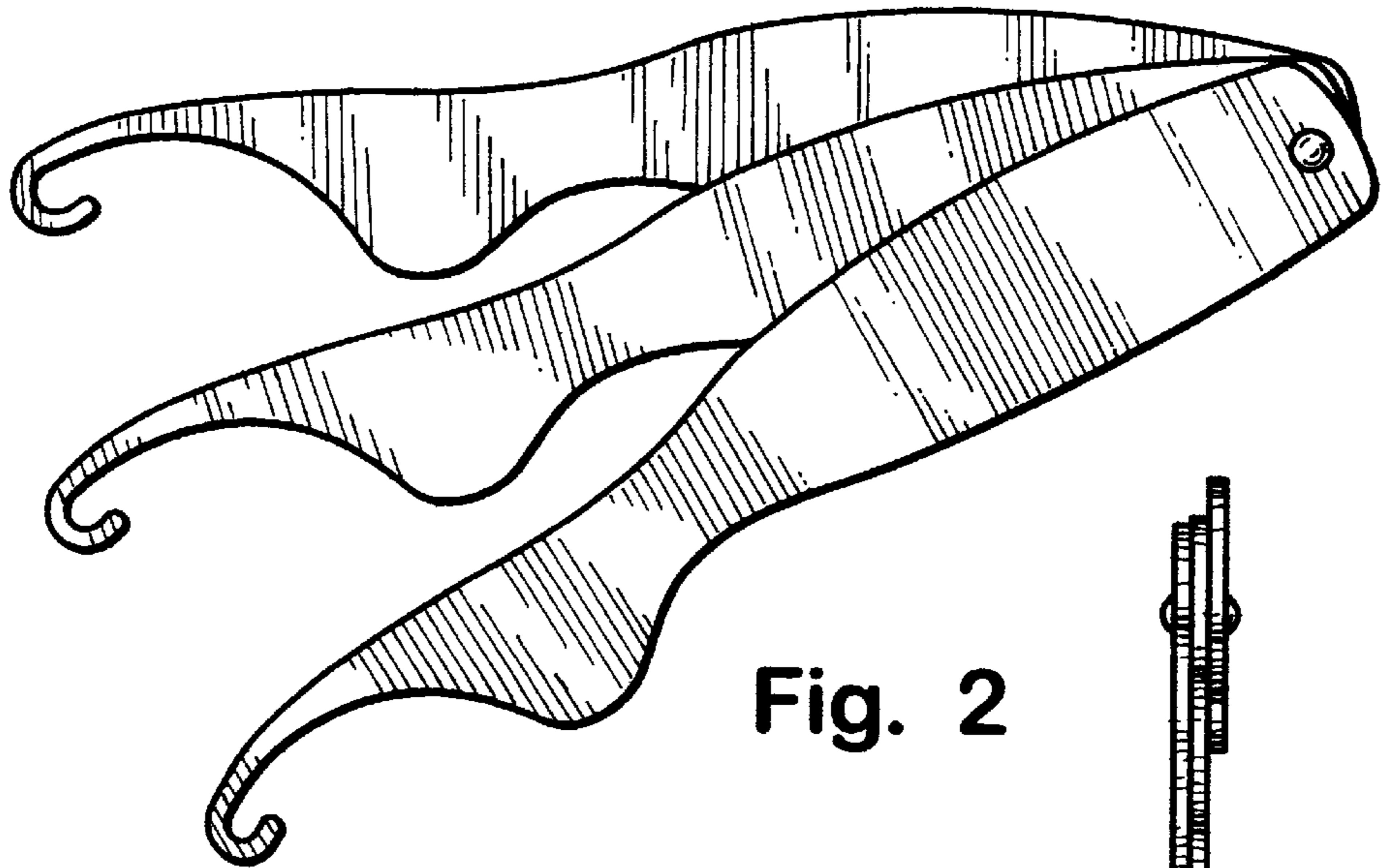

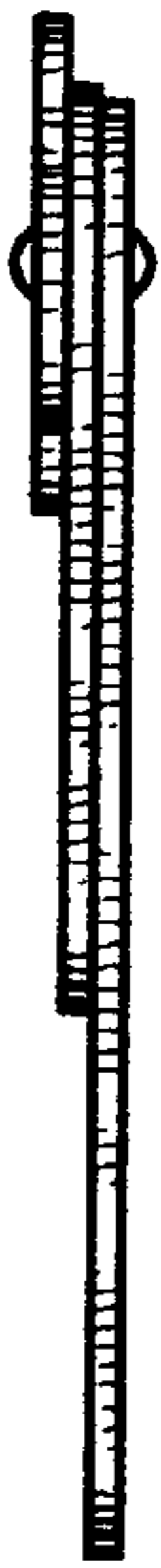

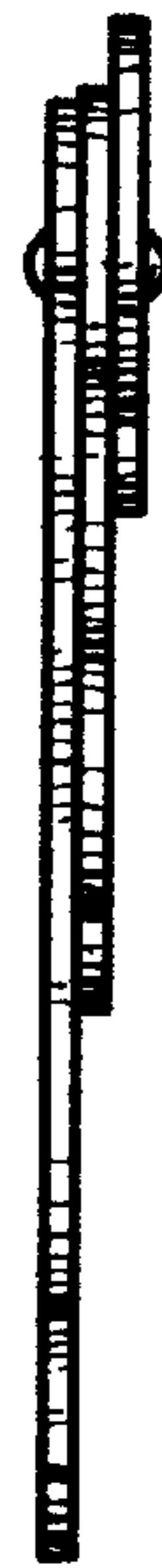

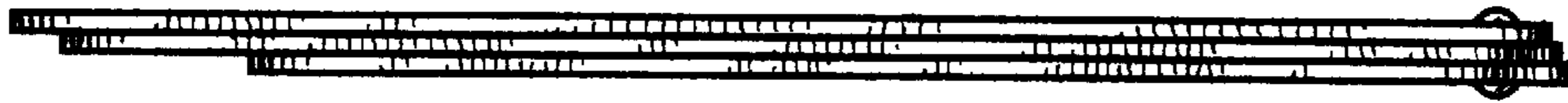
