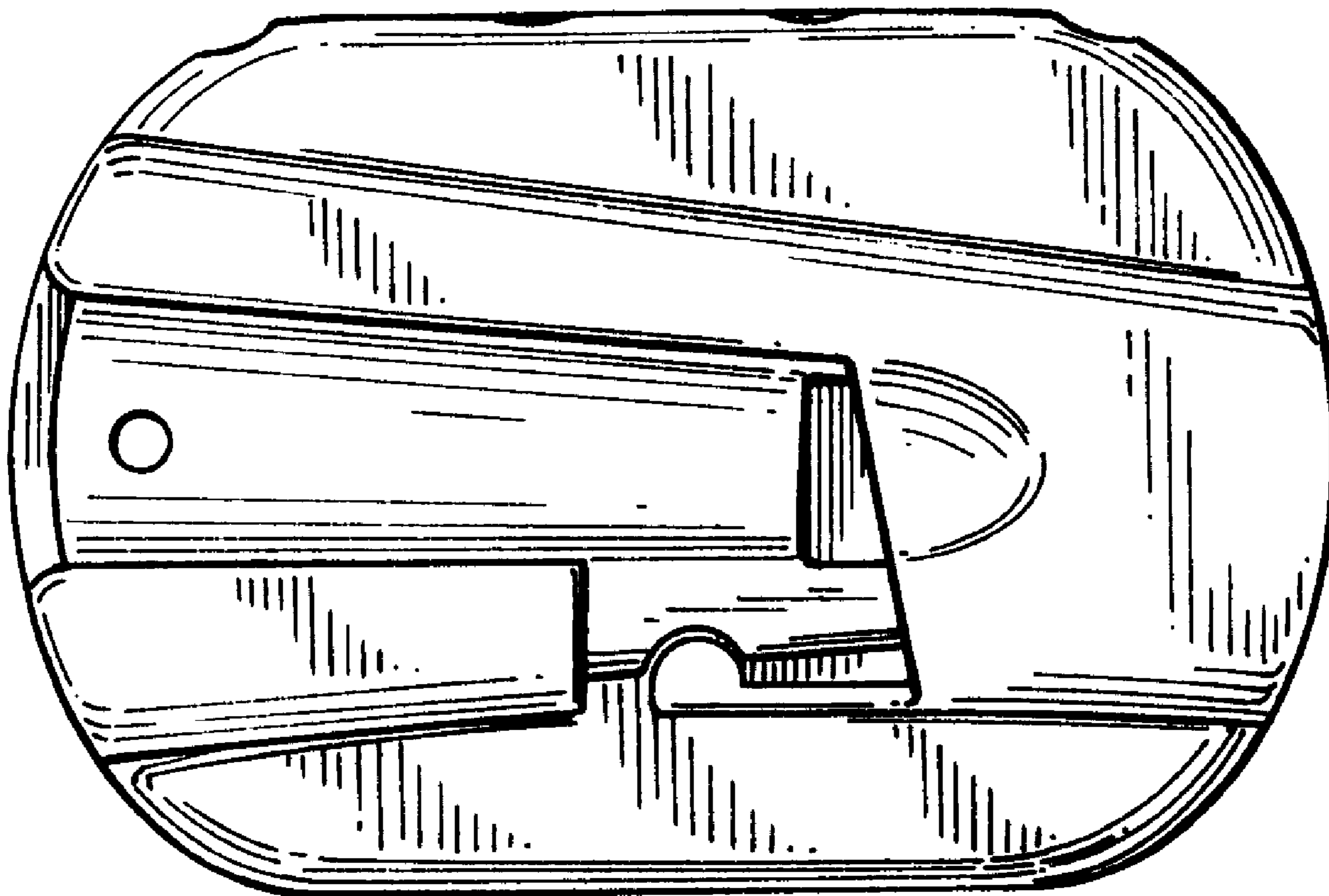
[57] **CLAIM**

**DESCRIPTION**

FIG. 1 is a front elevational view of a divot repair tool holder showing my new design;

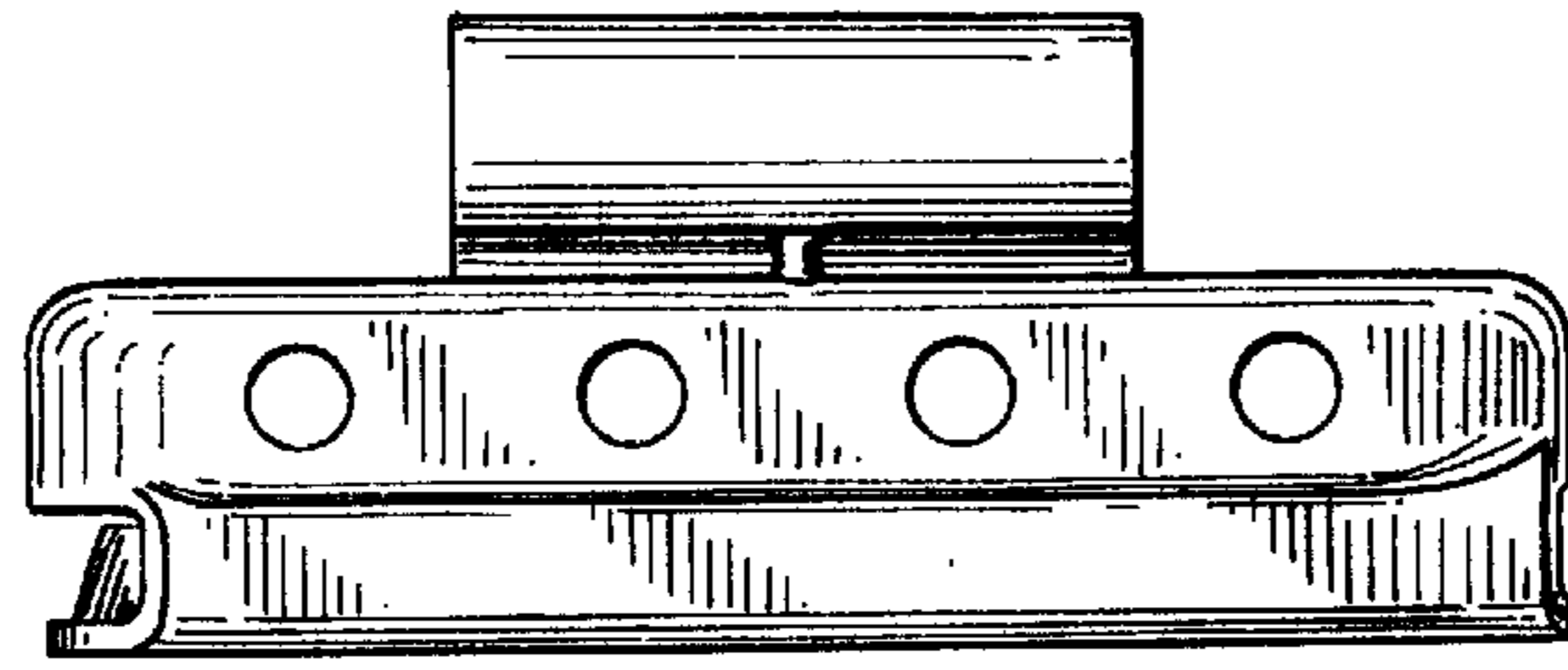

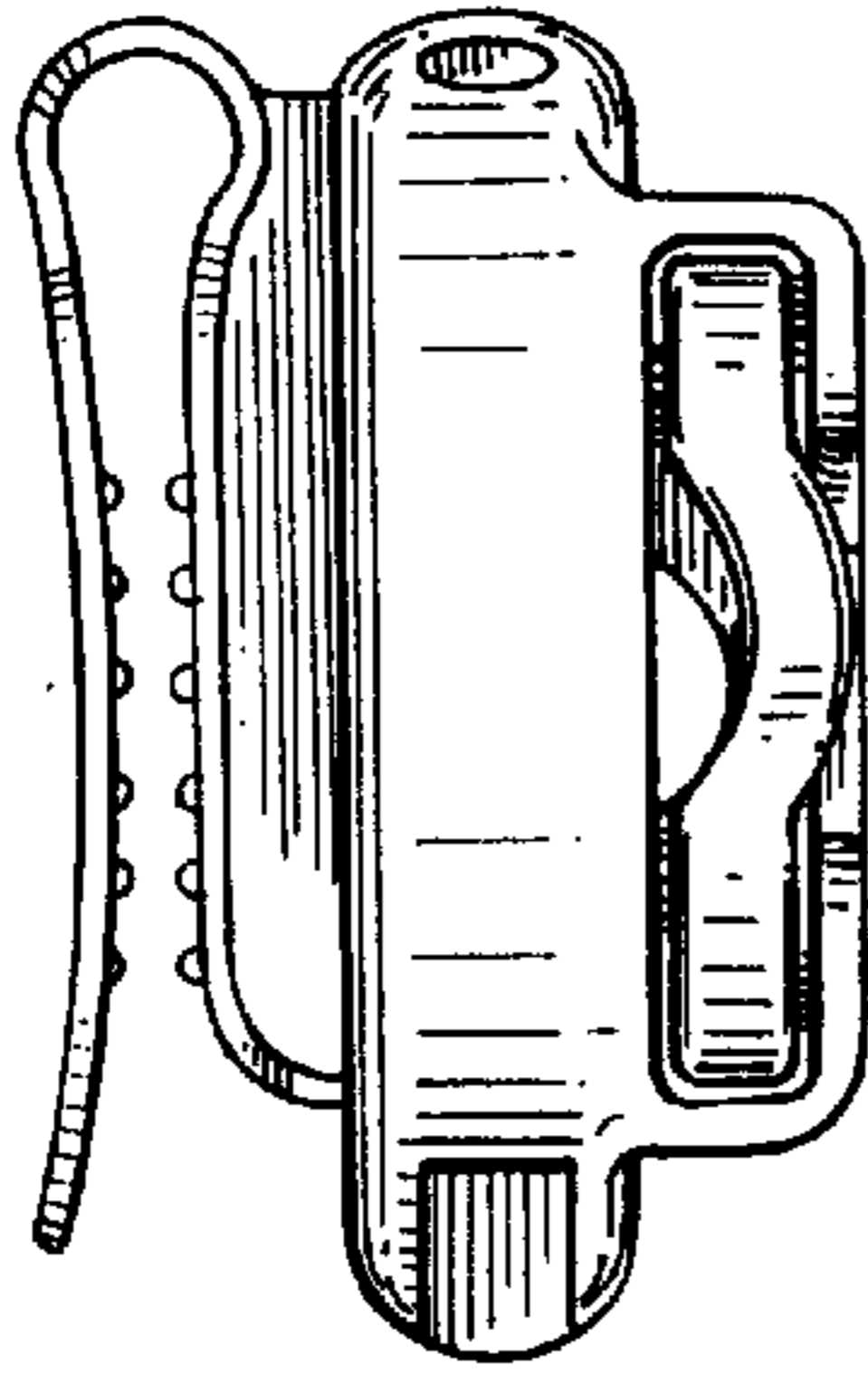

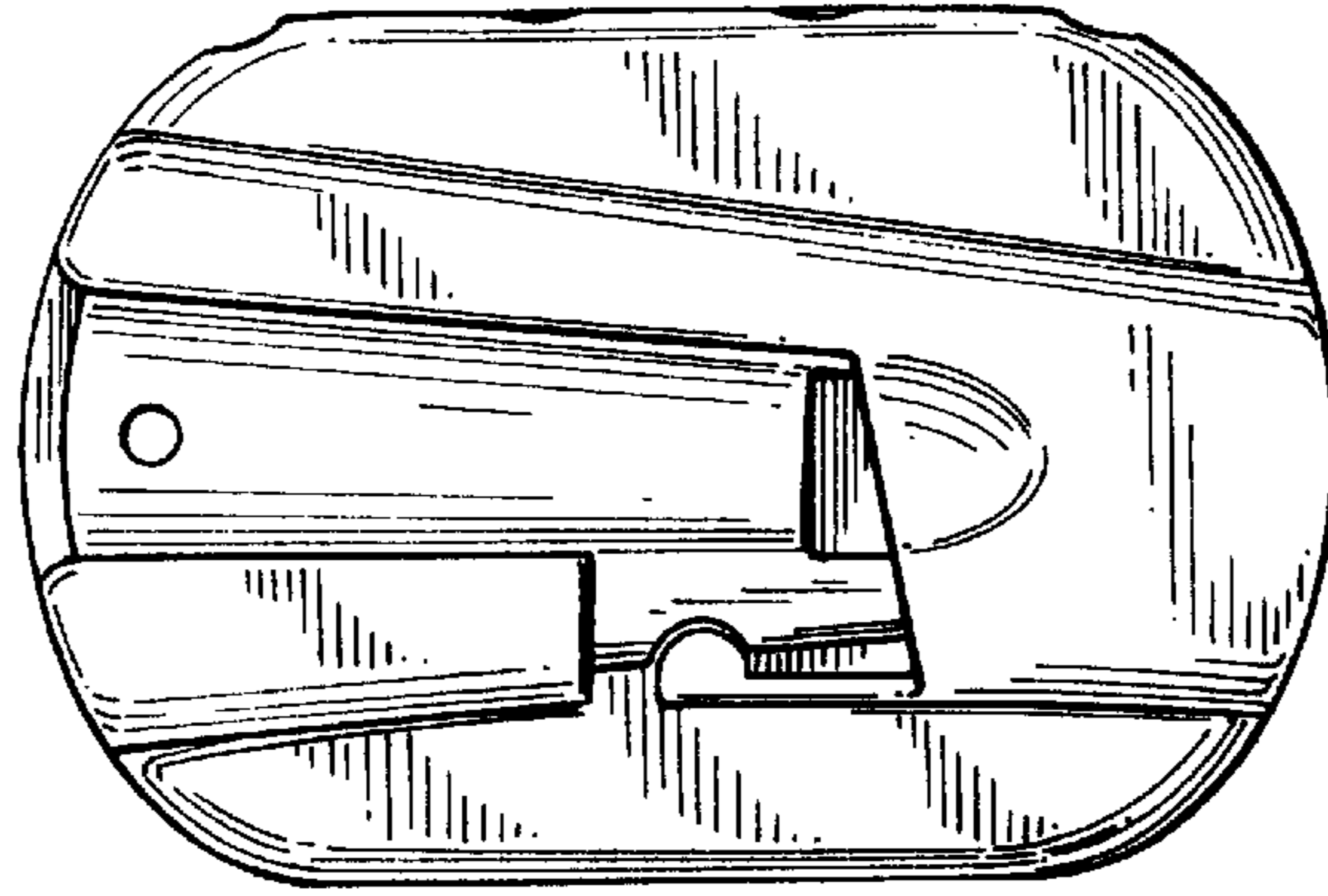

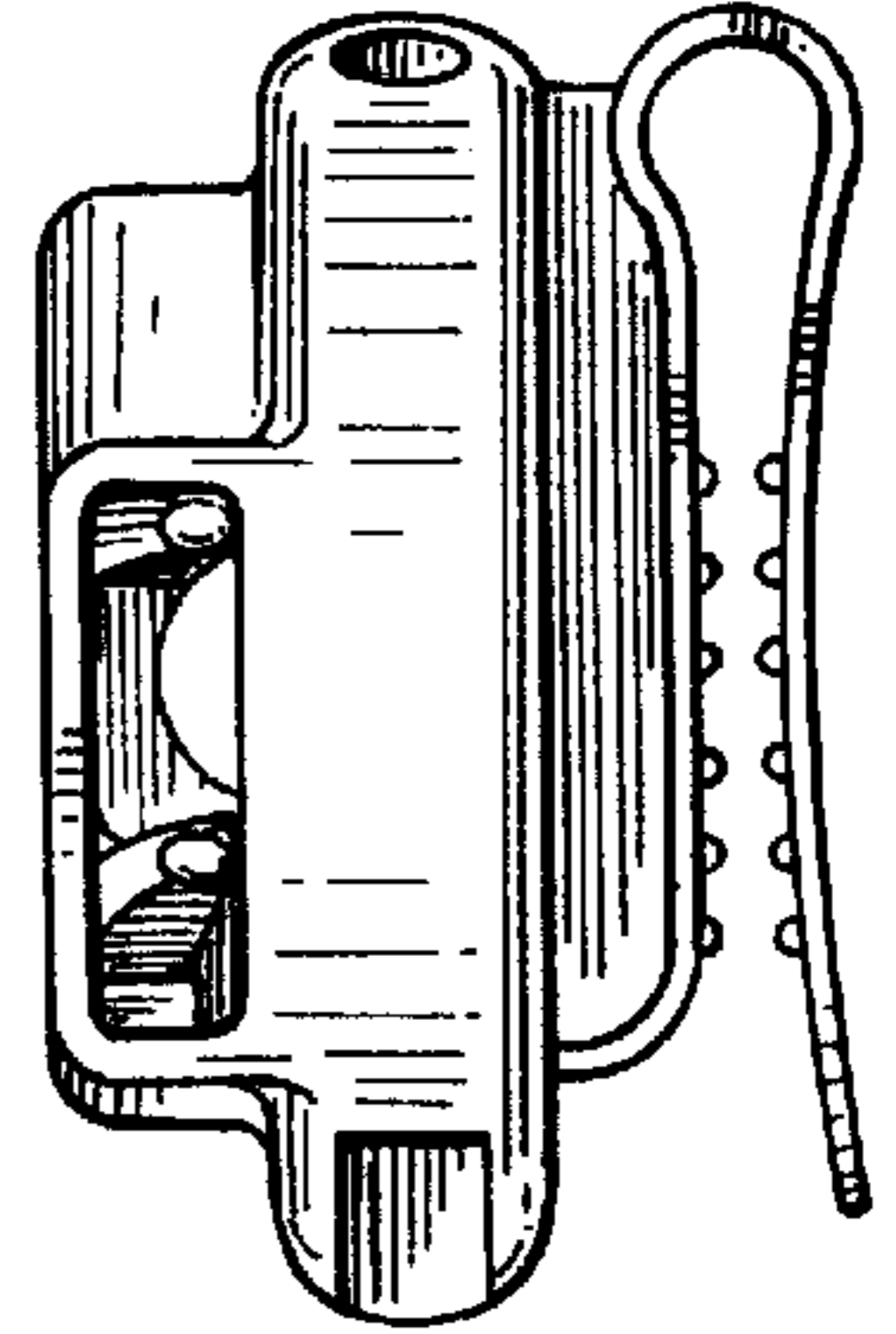

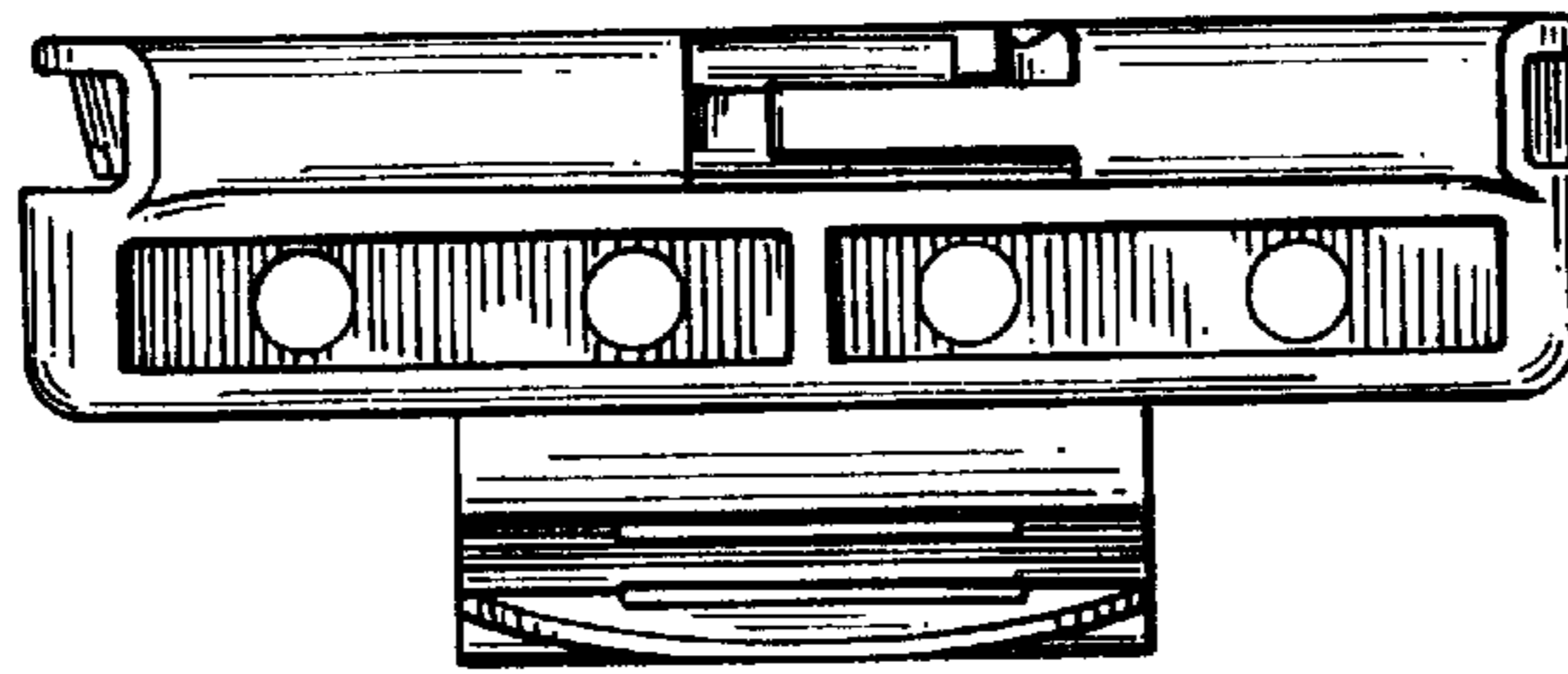

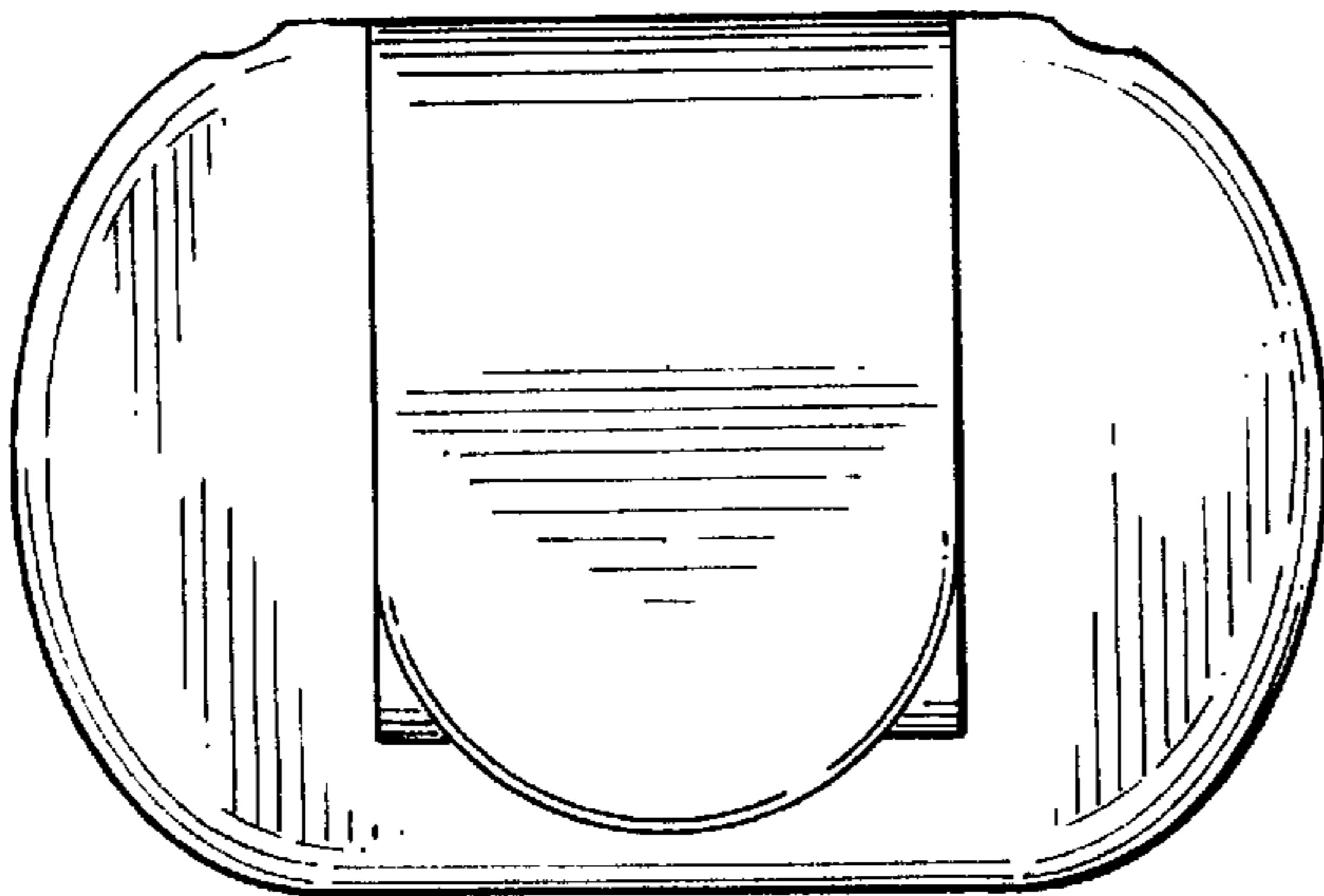

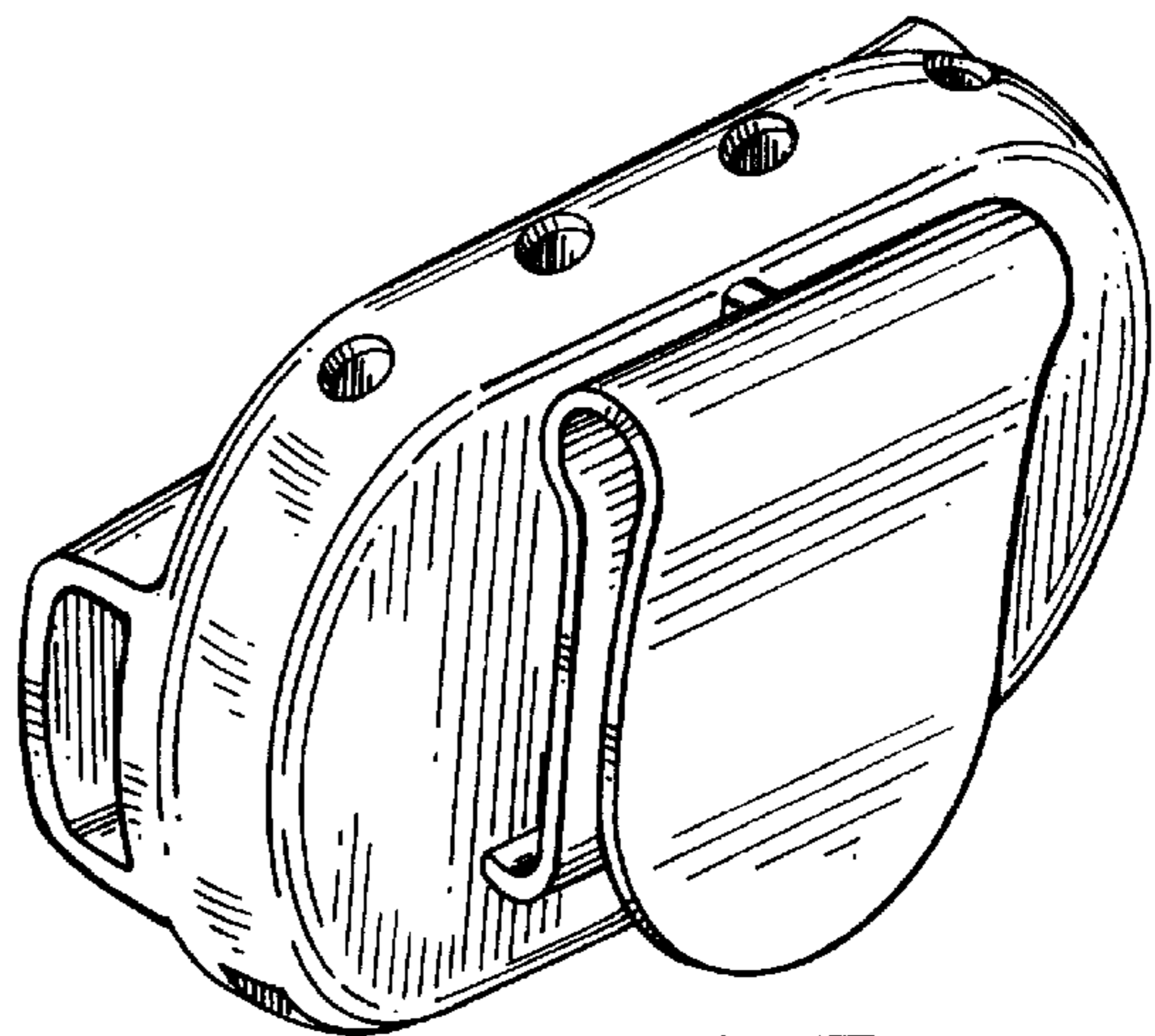
