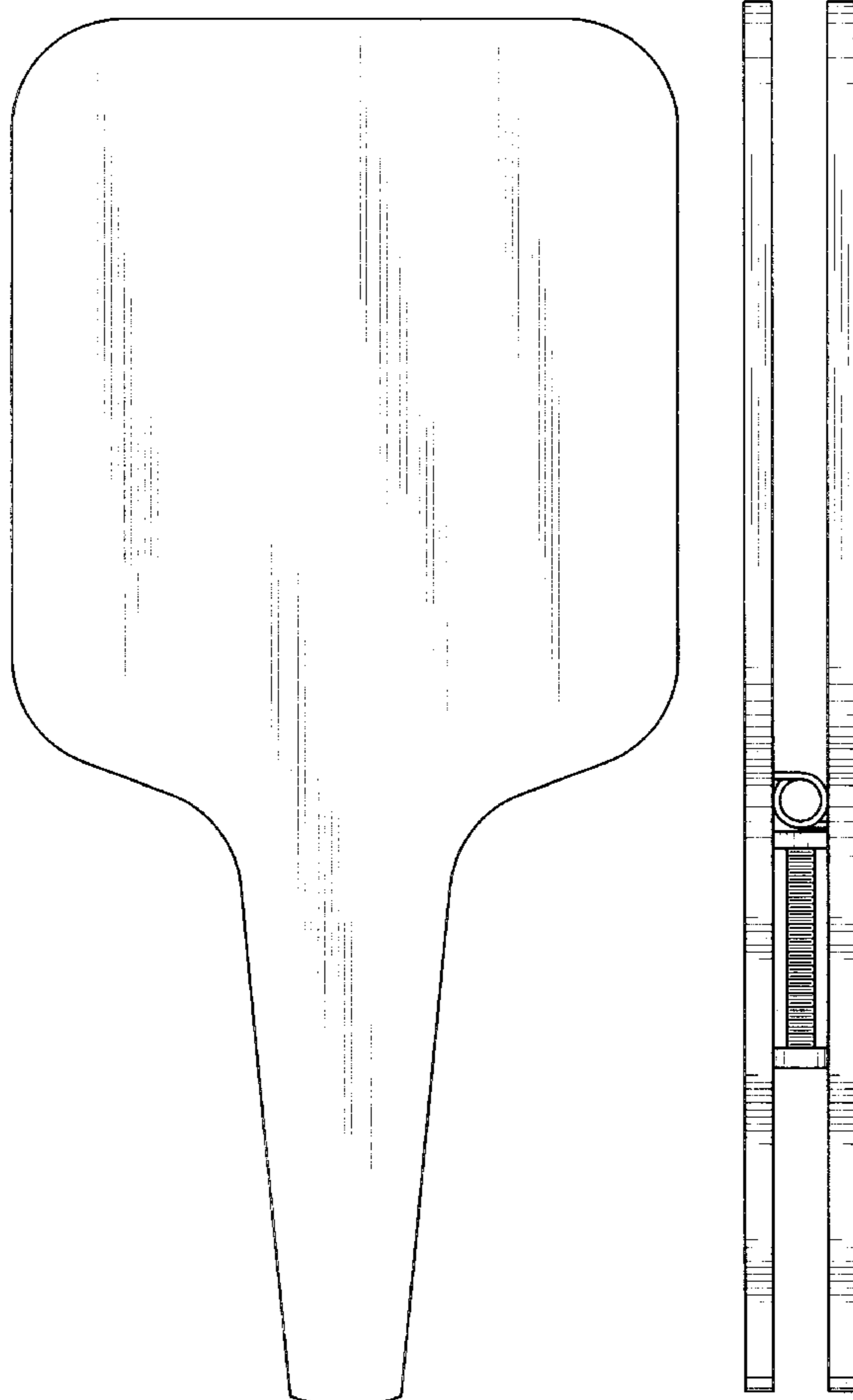
[57] **CLAIM**

The ornamental design for a pocket pressing clip, as shown.

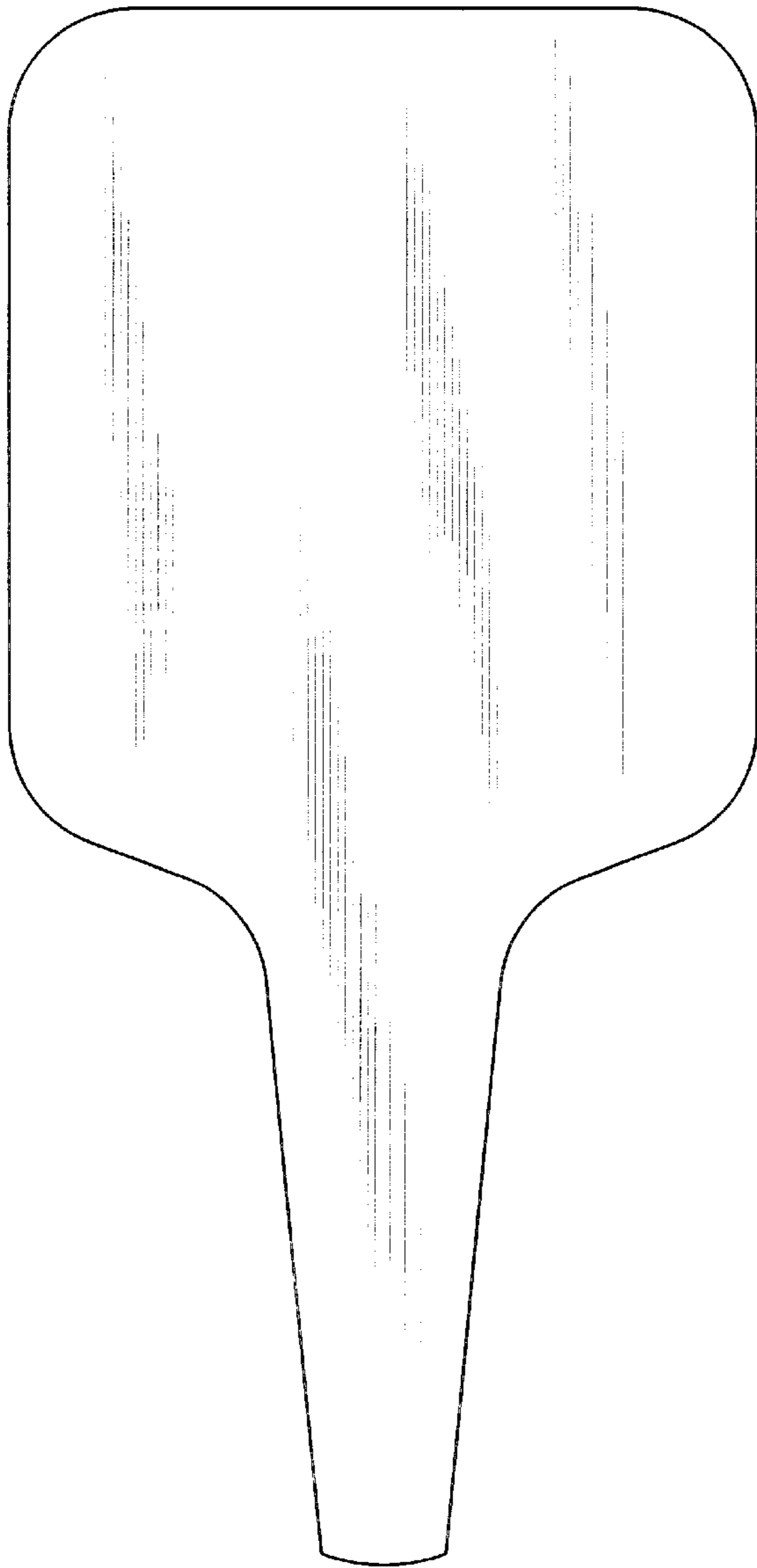
**DESCRIPTION**

FIG. 1 is a front elevational view of the pocket pressing clip of the present invention;  
FIG. 2 is a back elevational view of the pocket pressing clip of FIG. 1;

FIG. 6 is a bottom plan view of the pocket pressing clip of FIG. 1.

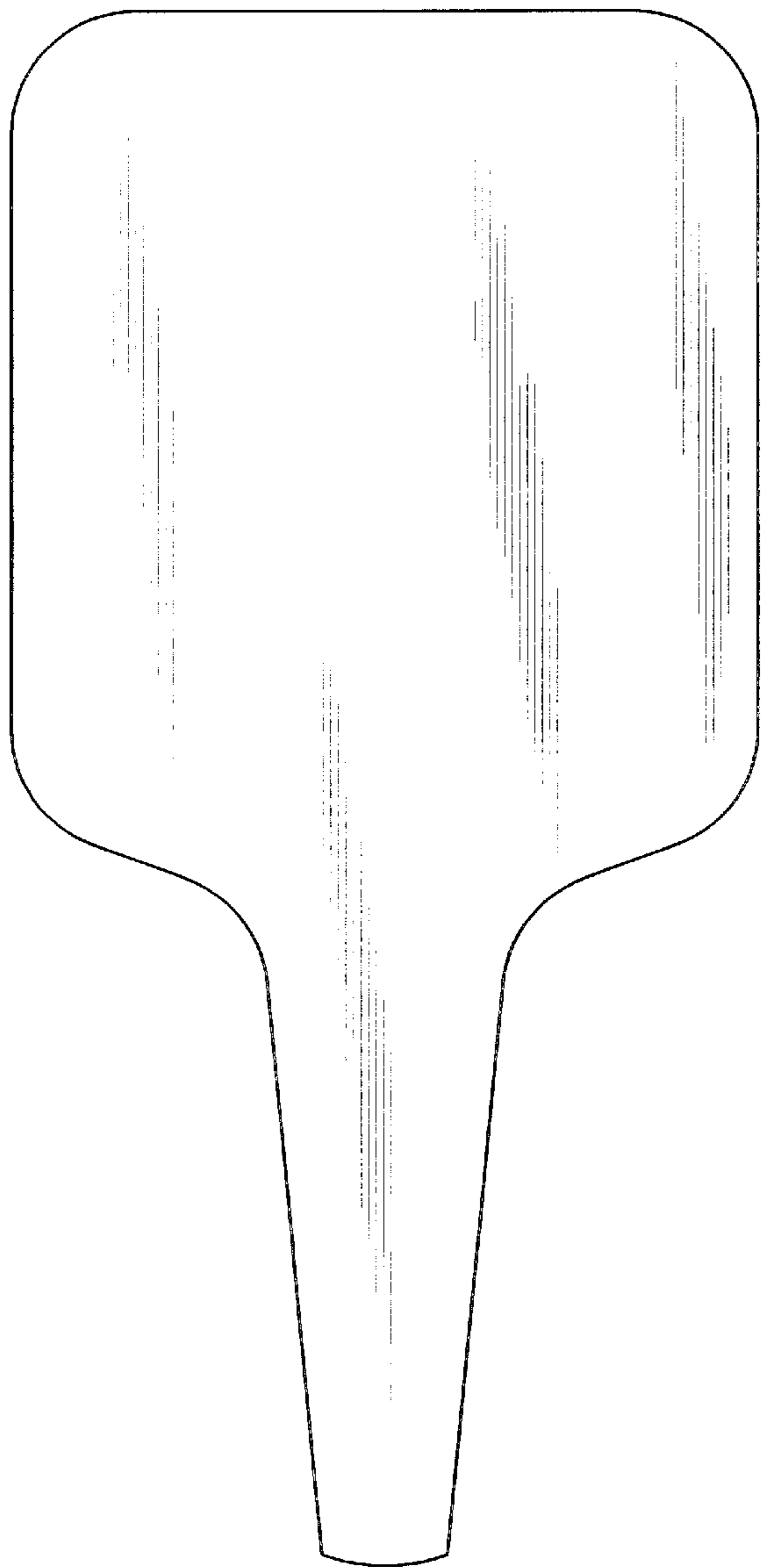

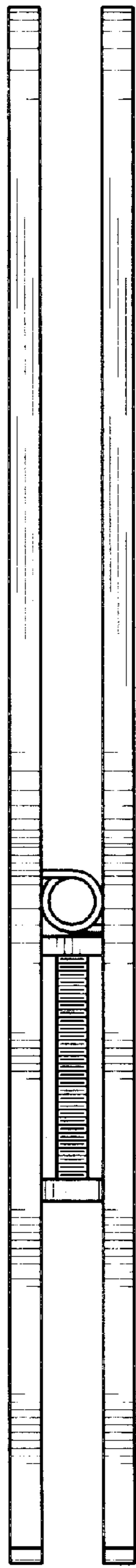

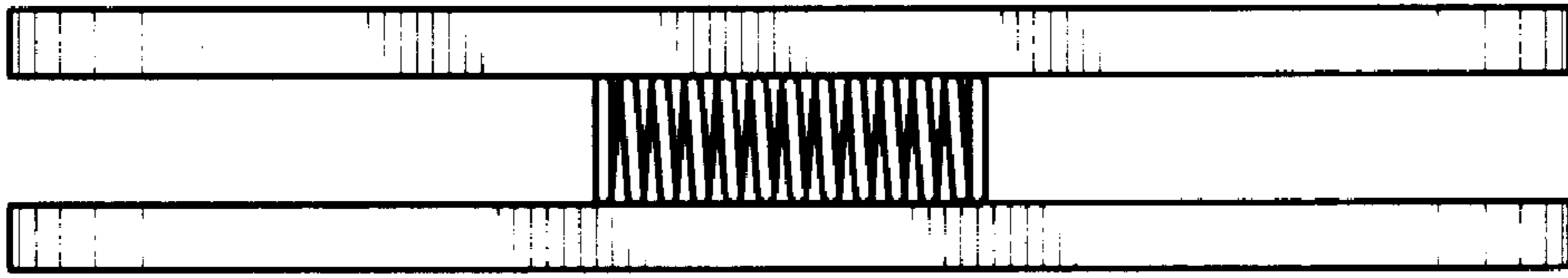
