[57] **CLAIM**

The ornamental design for a sun visor, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of the sun visor showing my new design;
 FIG. 2 is a bottom plan view thereof;
 FIG. 3 is a front elevational view thereof;
 FIG. 4 is a rear elevational view thereof;
 FIG. 5 is a left side elevational view thereof;
 FIG. 6 is a right side elevational view thereof;
 FIG. 7 is a perspective view taken from the top, rear and right side of the sun visor;
 FIG. 8 is a top, rear, and right side view of a sun visor without the removable hair band for purposes of illustration; and,
 FIG. 9 is a top, rear, and right perspective view of removable hair band shown separately for purposes of illustration.

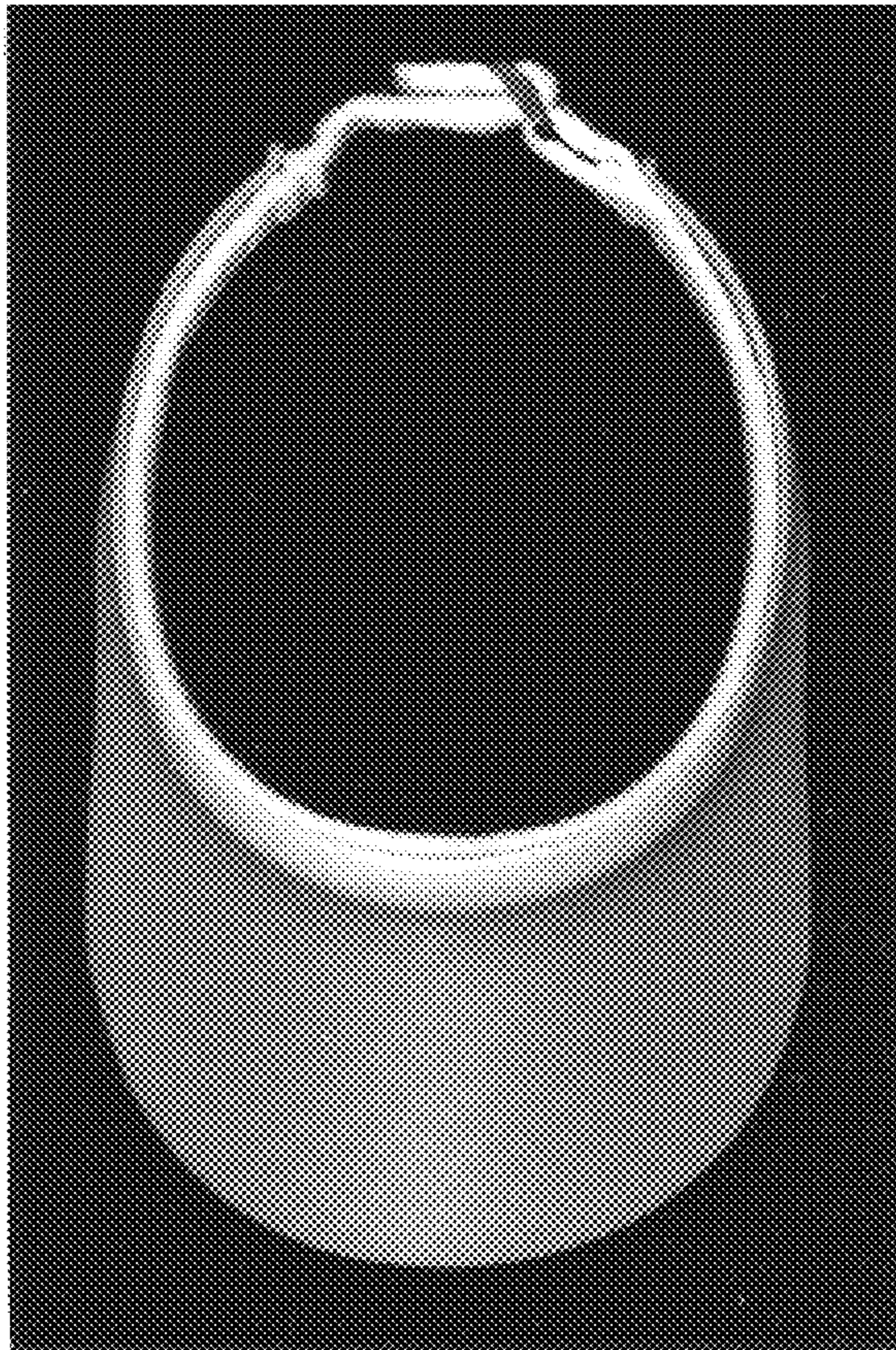

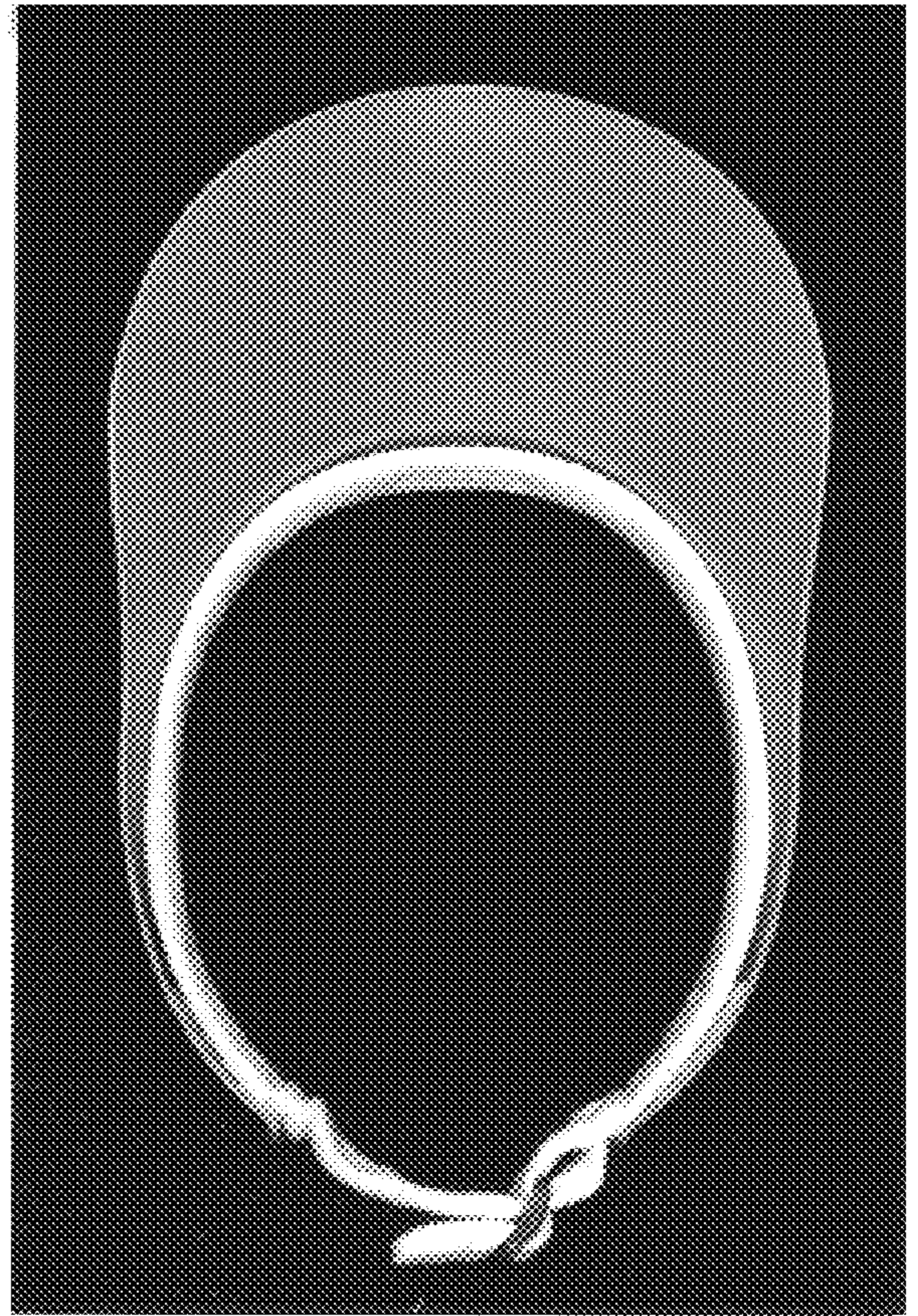

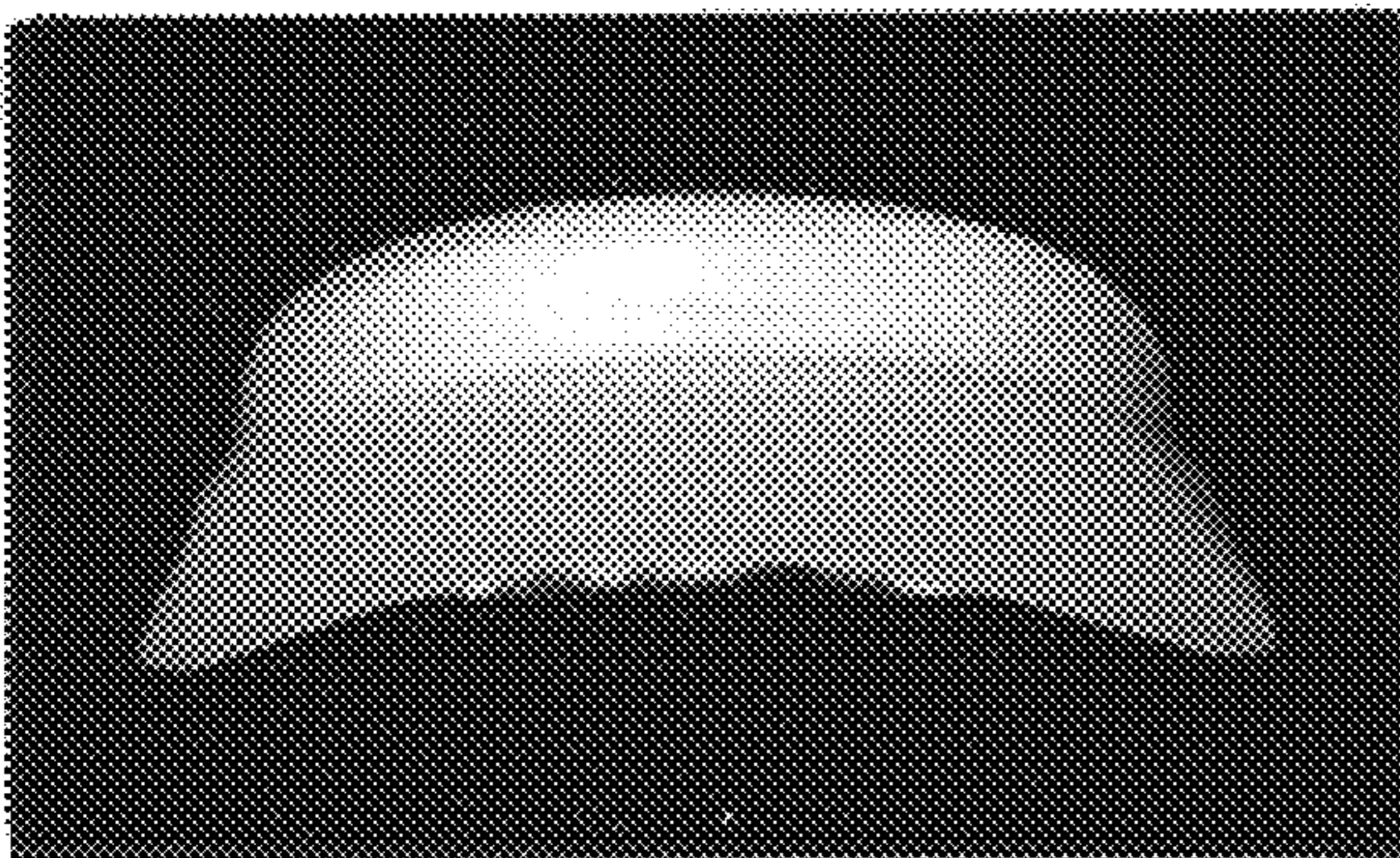

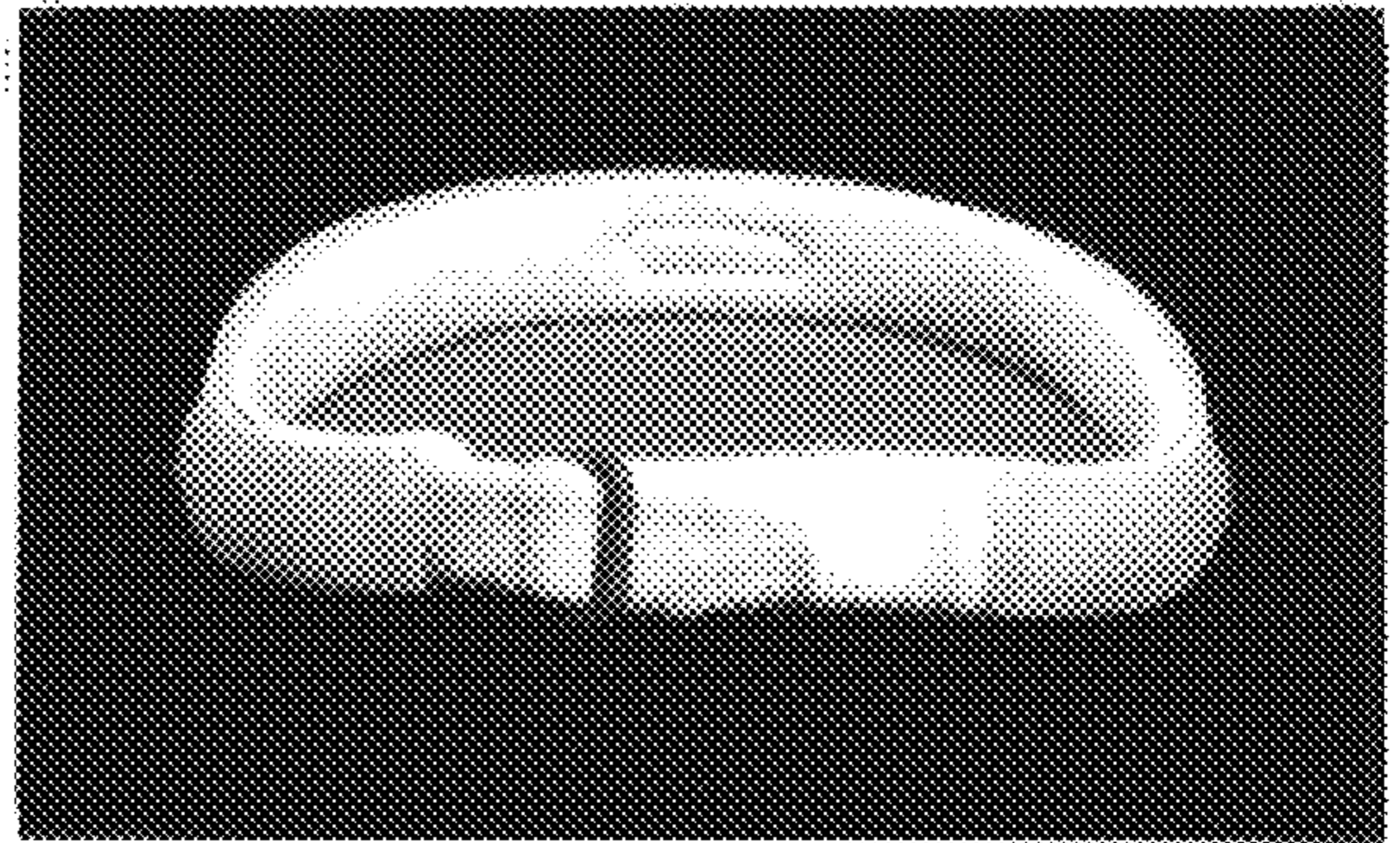

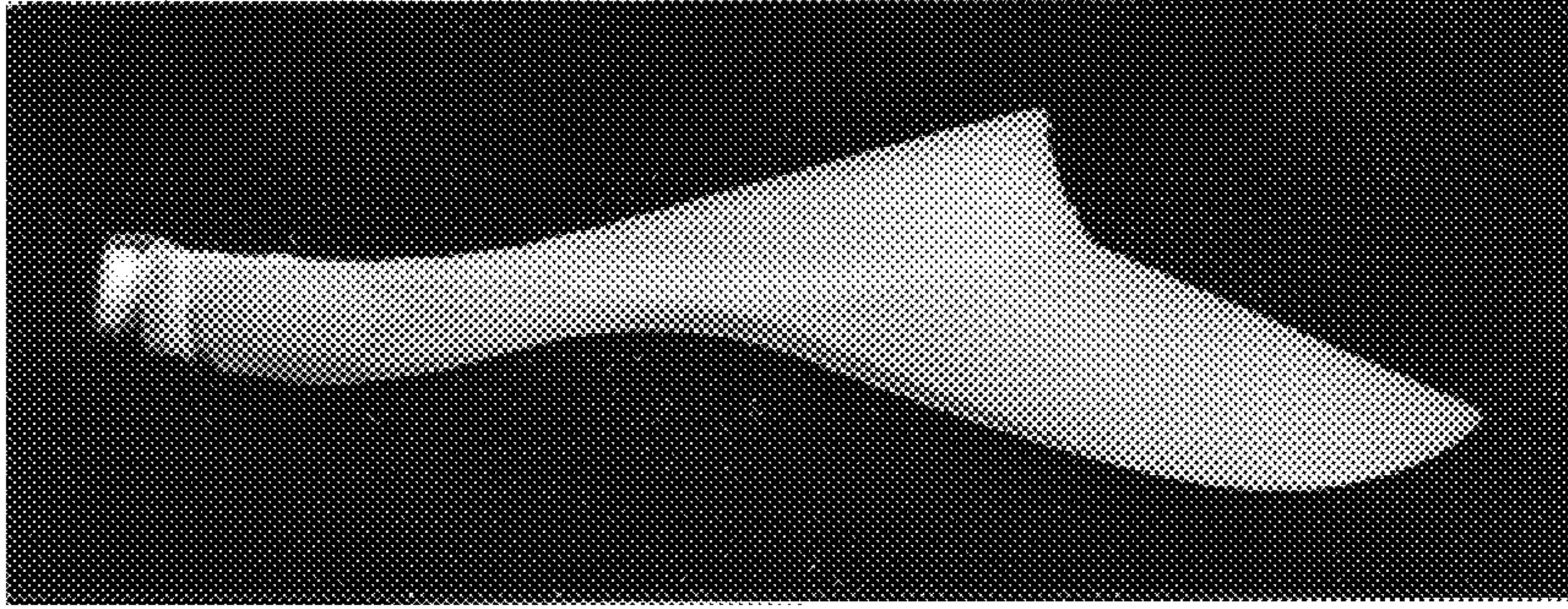

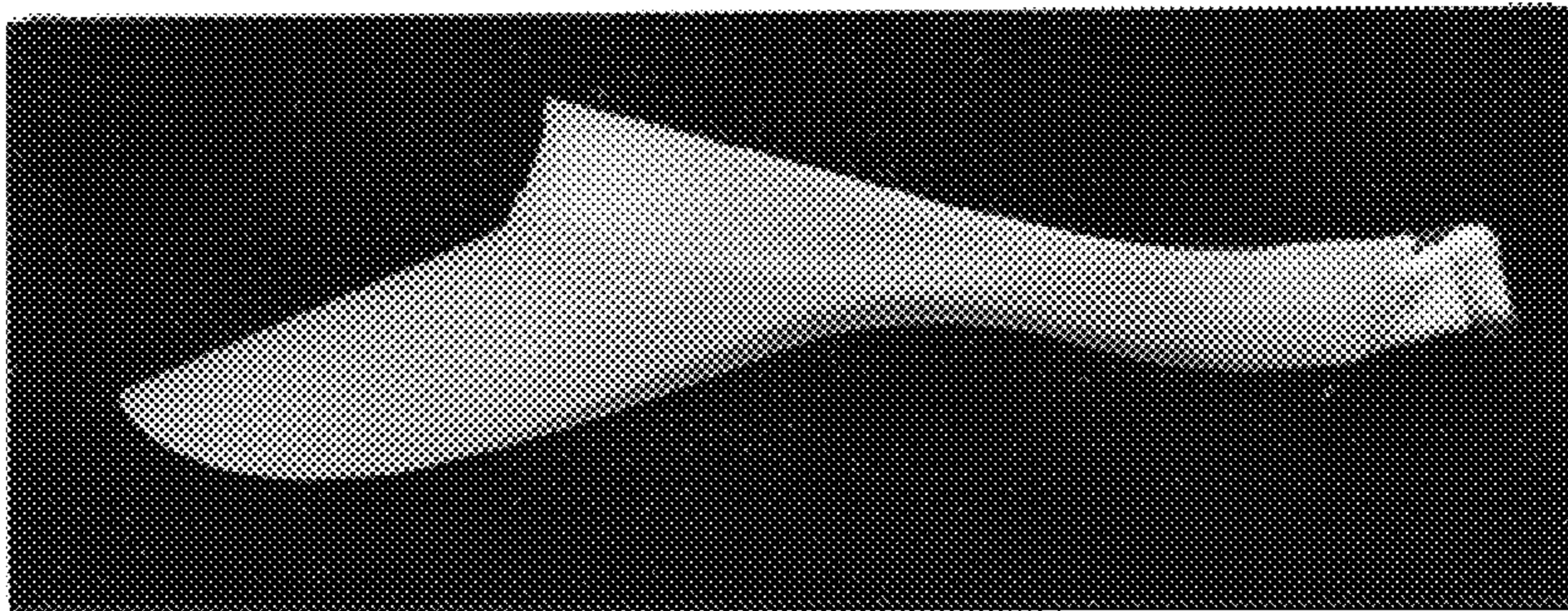

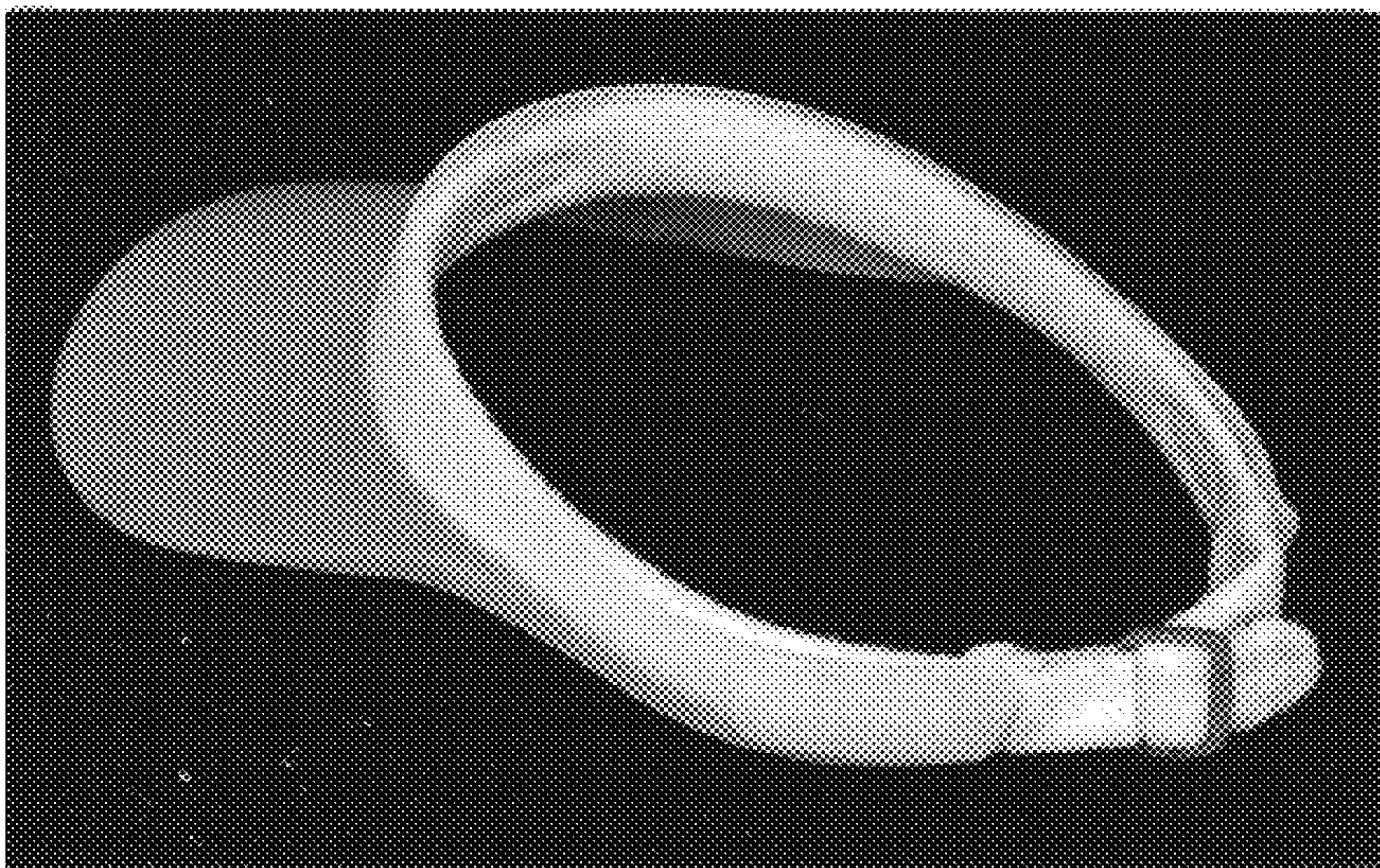

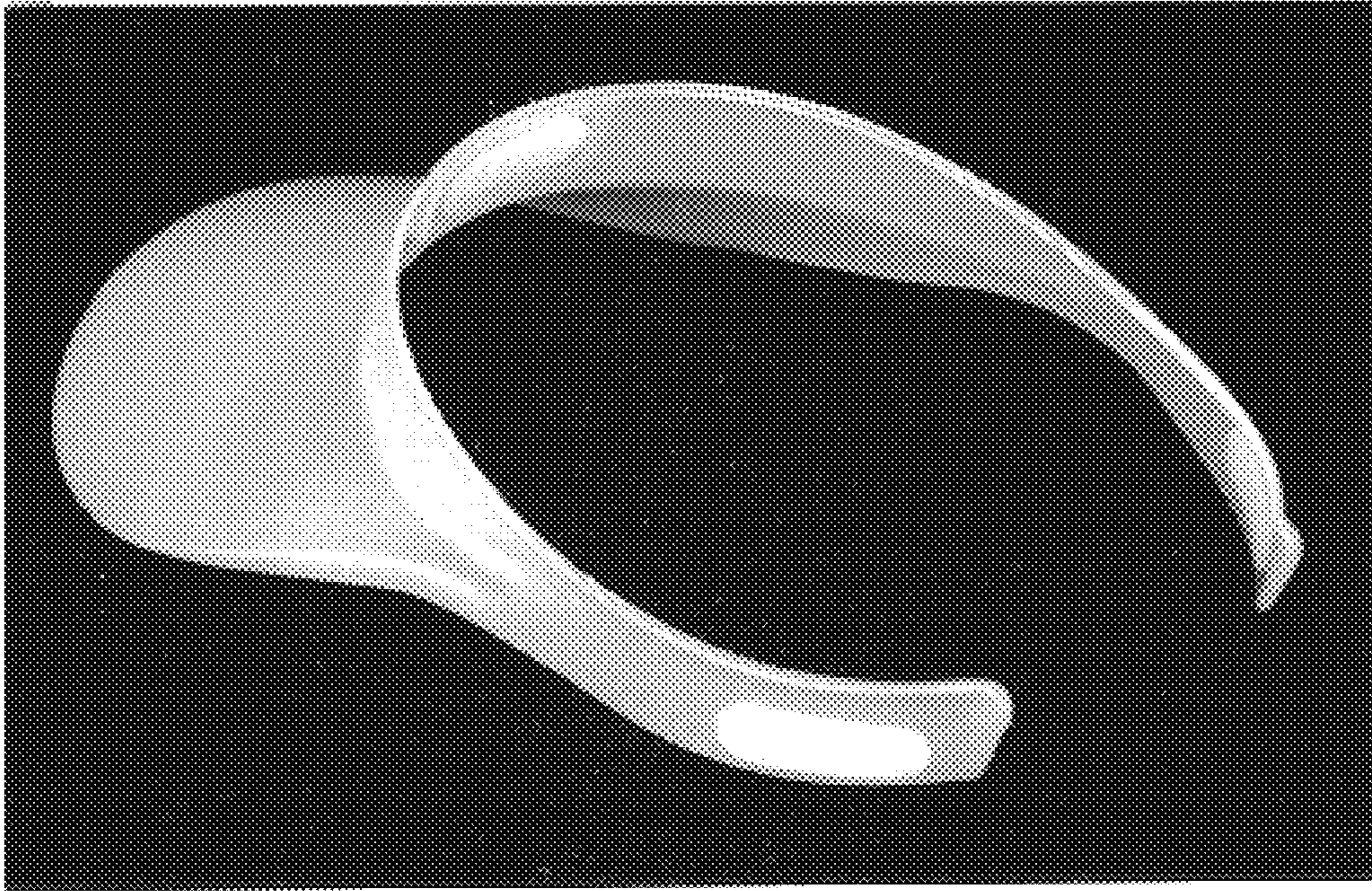

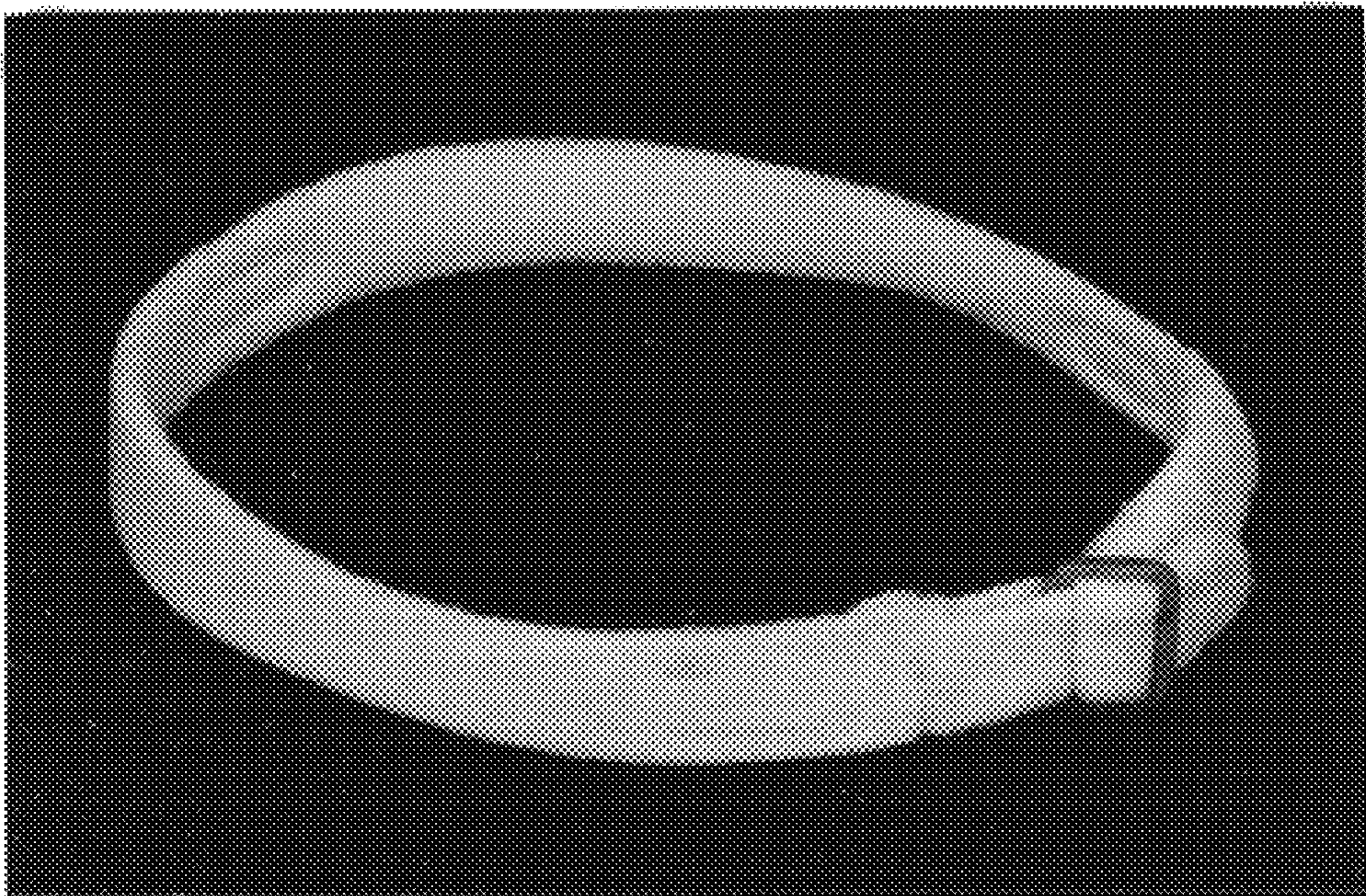
