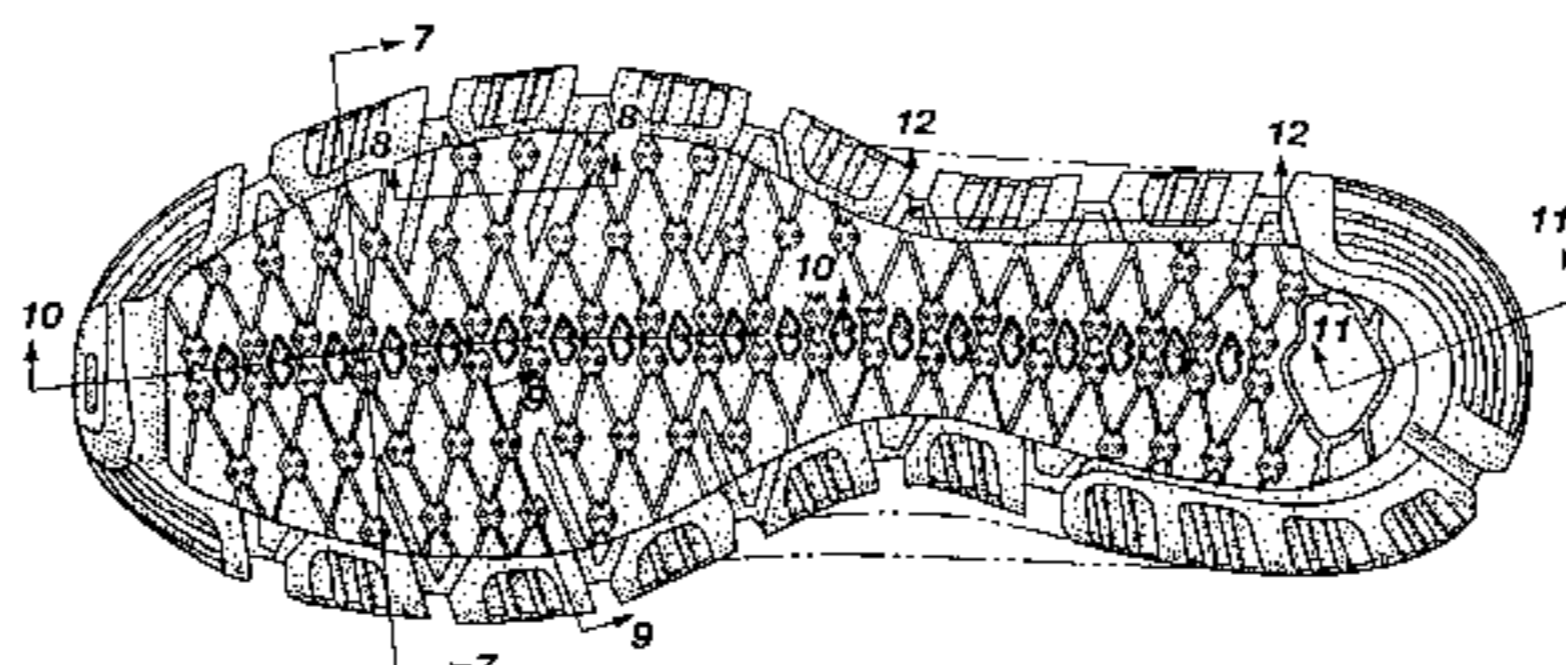
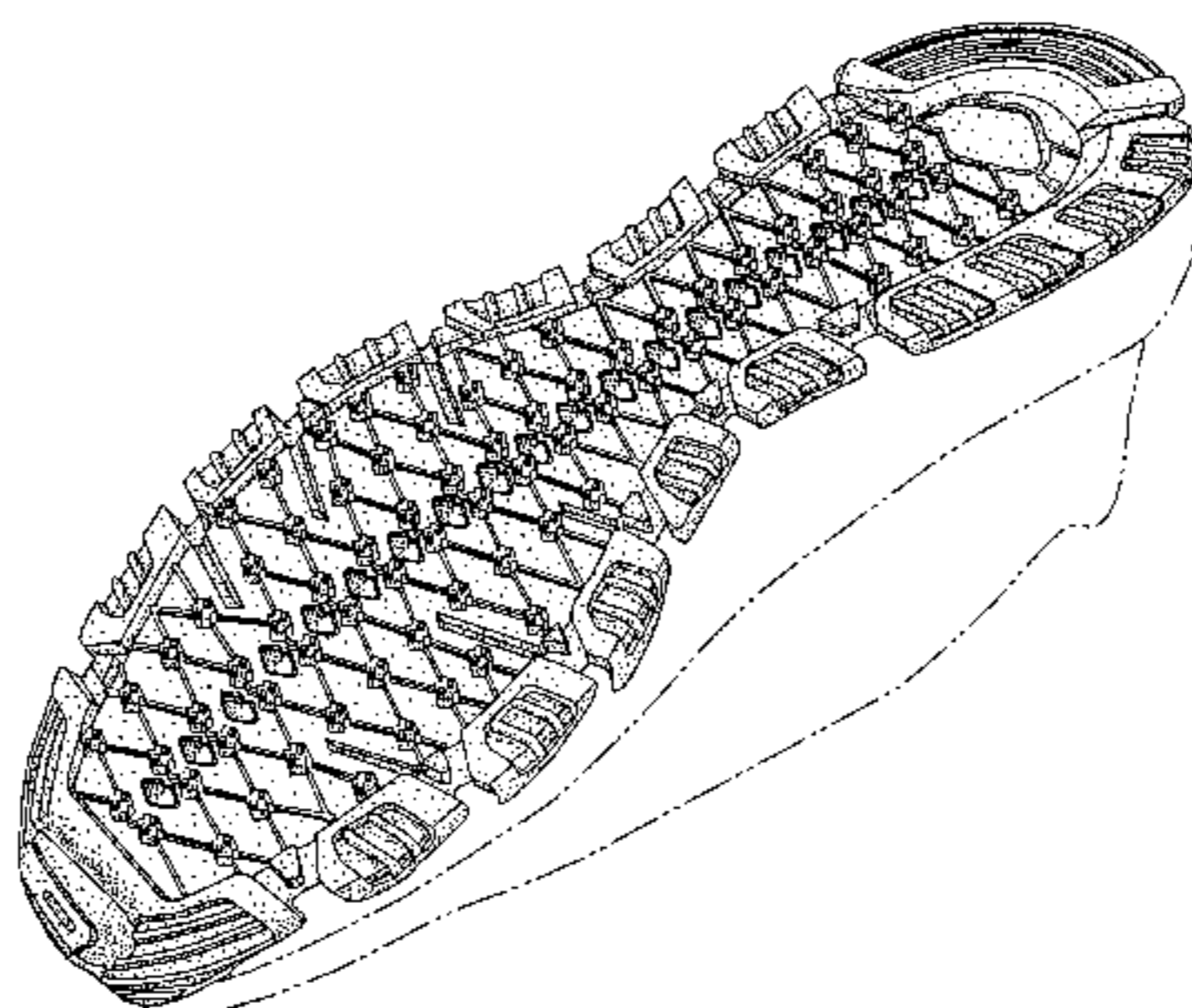
[57] CLAIM

The ornamental design for an element of an outsole of a shoe, as shown and described.

DESCRIPTION

FIG. 1 is a bottom perspective view of an element of an outsole of a shoe showing my new design;
 FIG. 2 is a first side view thereof;
 FIG. 3 is a second side view thereof;
 FIG. 4 is a front elevational view thereof;
 FIG. 5 is a rear view thereof;
 FIG. 6 is a bottom plan view thereof;
 FIG. 7 is a cross-sectional view taken along the line 7—7 of FIG. 6;
 FIG. 8 is a cross sectional view taken along the line 8—8 of FIG. 6;
 FIG. 9 is a cross-sectional view taken along the line 9—9 of FIG. 6; and
 FIG. 10 is a cross-sectional view taken along the line 10—10 of FIG. 6;
 FIG. 11 is a cross sectional view taken along the line 11—11 of FIG. 6; and,
 FIG. 12 is a cross sectional view taken along the line 12—12 of FIG. 6.
 The phantom line showing of a shoe midsole, shoe upper and portions of a shoe outsole shown in FIG. 1-12 is for illustrative purposes only and forms no part of the claimed design.

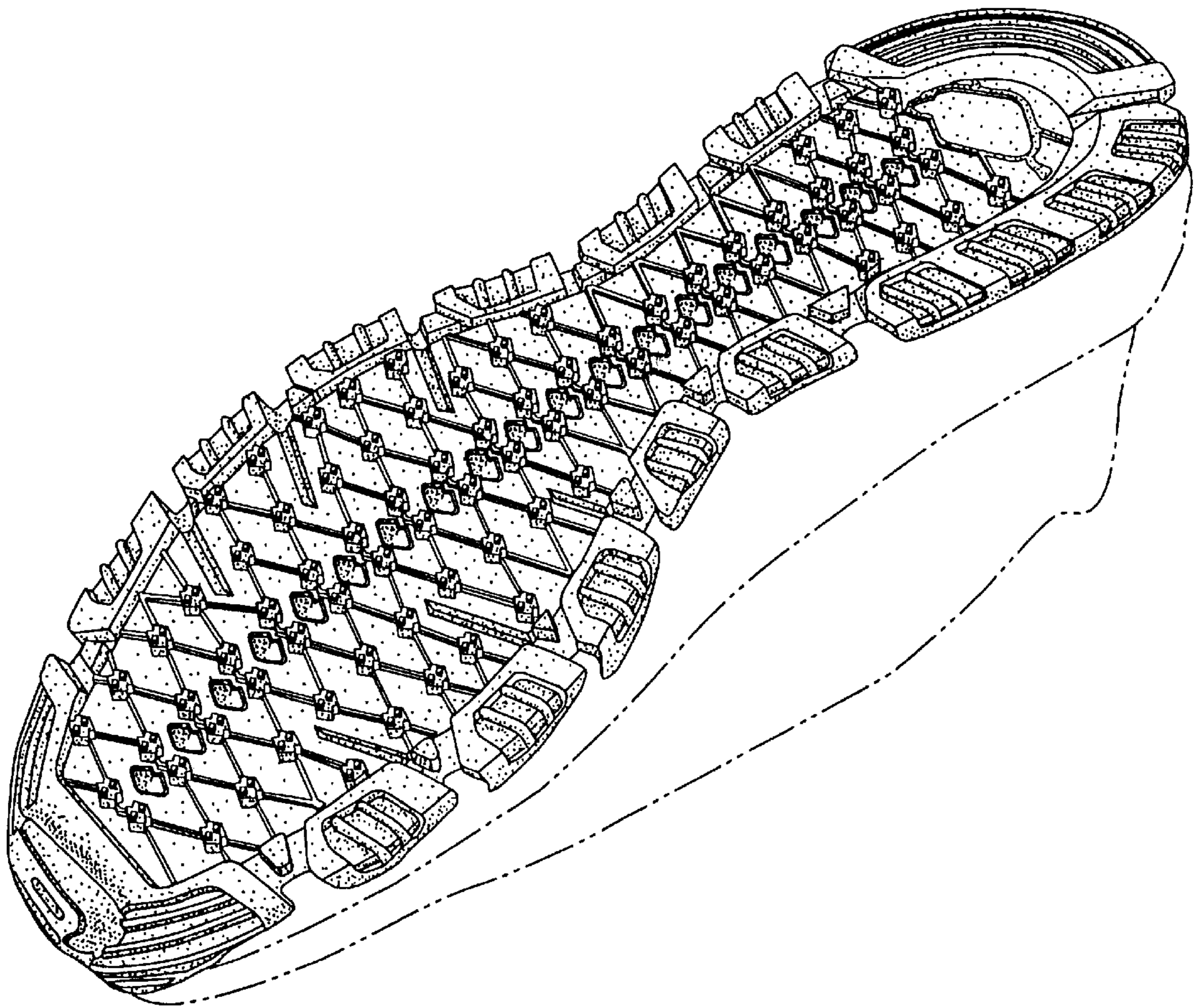

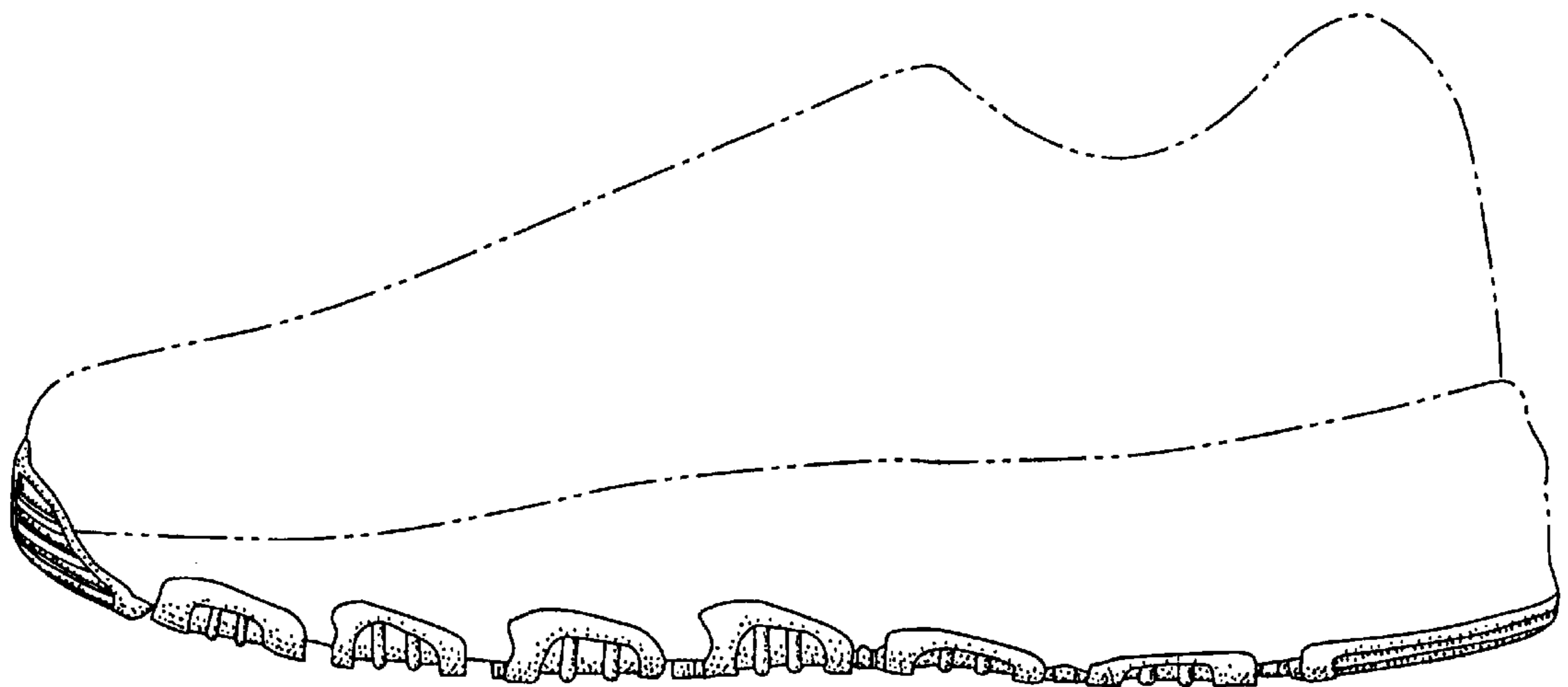

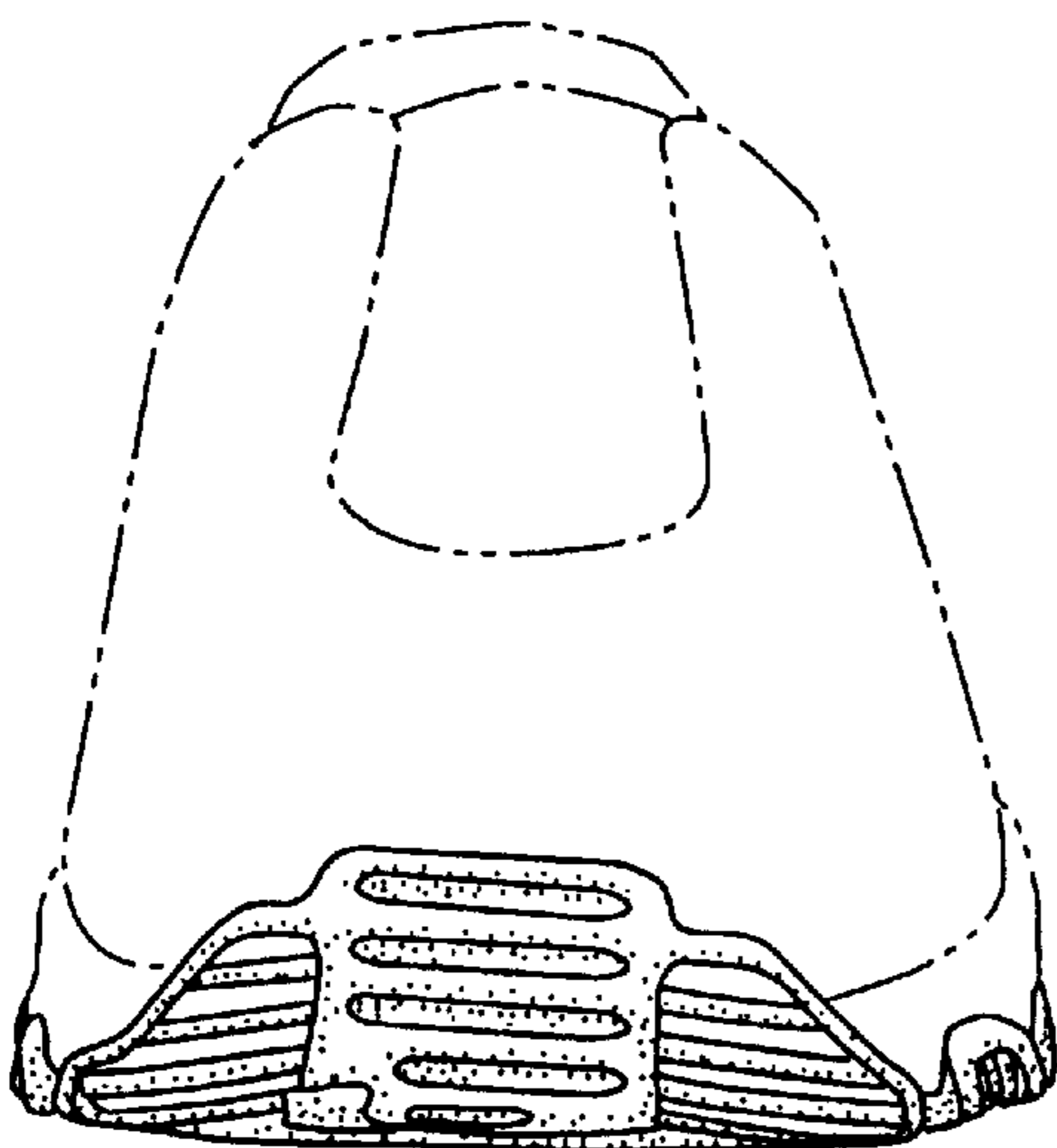

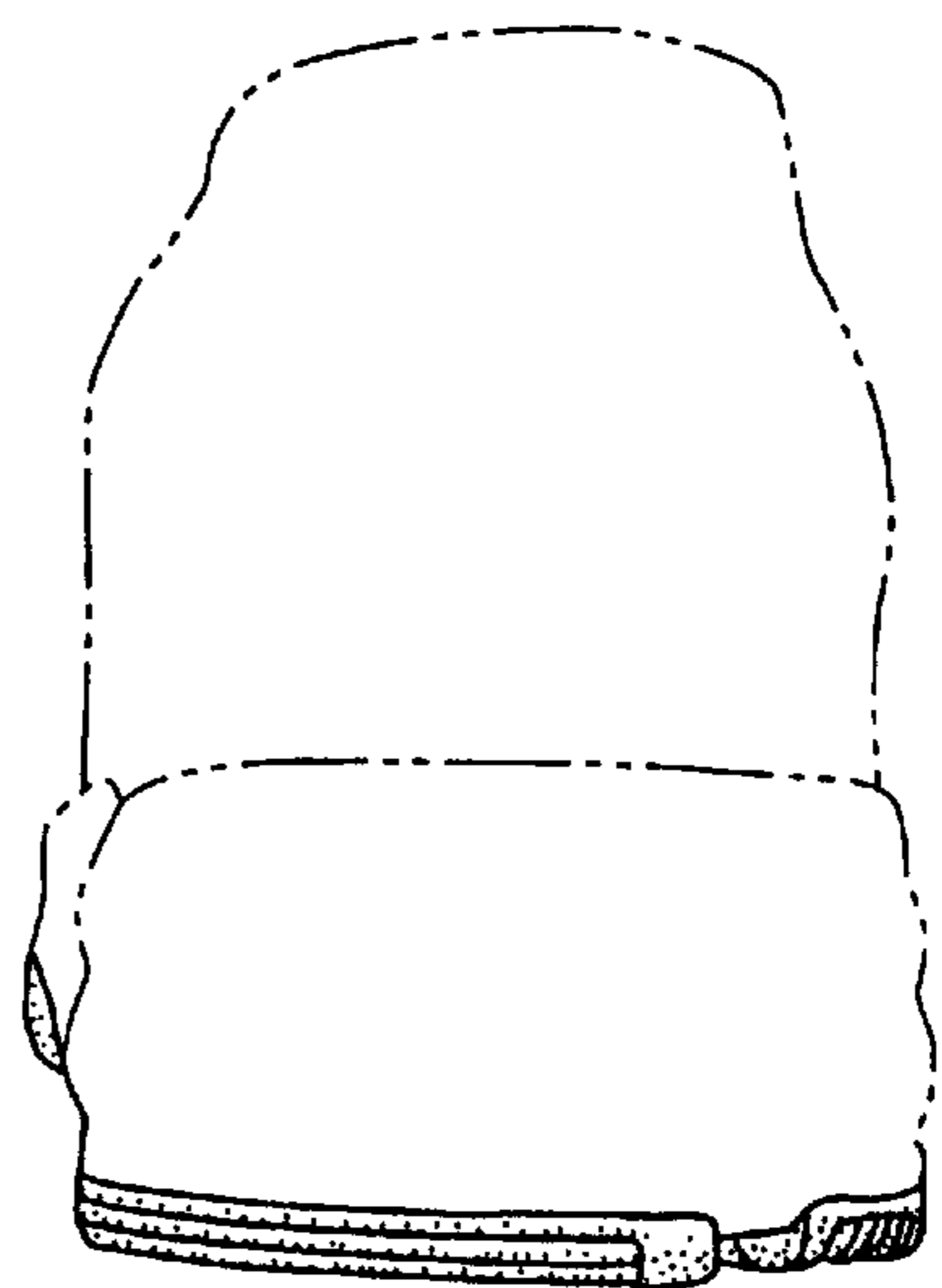

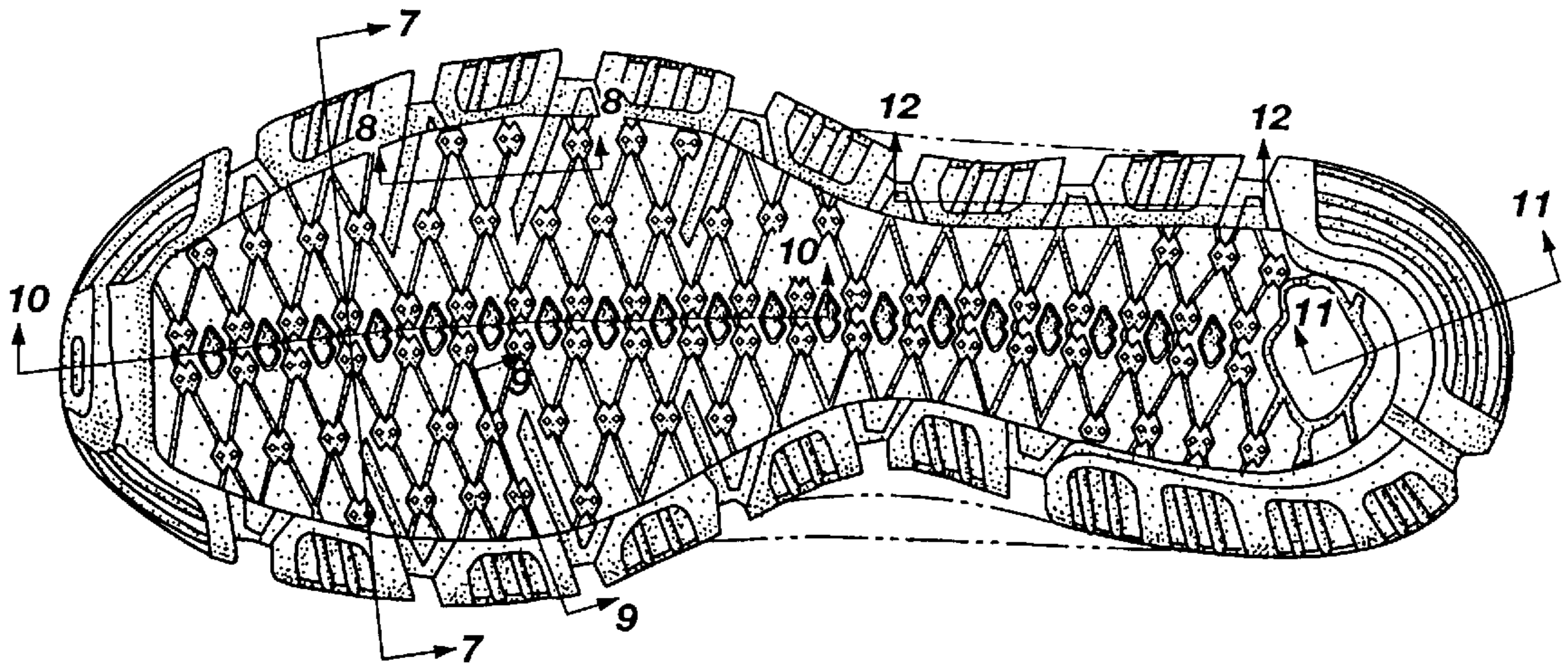

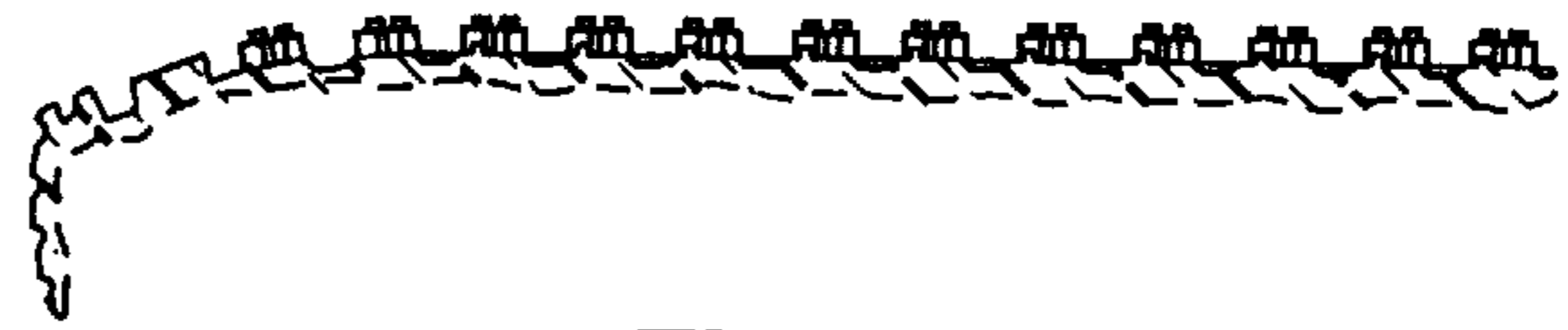
