[57] **CLAIM**

The ornamental design for a tea pot with infusor and plunger, as shown and described.

**DESCRIPTION**

FIG. 1 is an oblique perspective view of the tea pot with infusor and plunger;  
FIG. 2 is a right side elevational view thereof;  
FIG. 3 is a left side elevational view thereof;  
FIG. 4 is a front elevational view thereof;

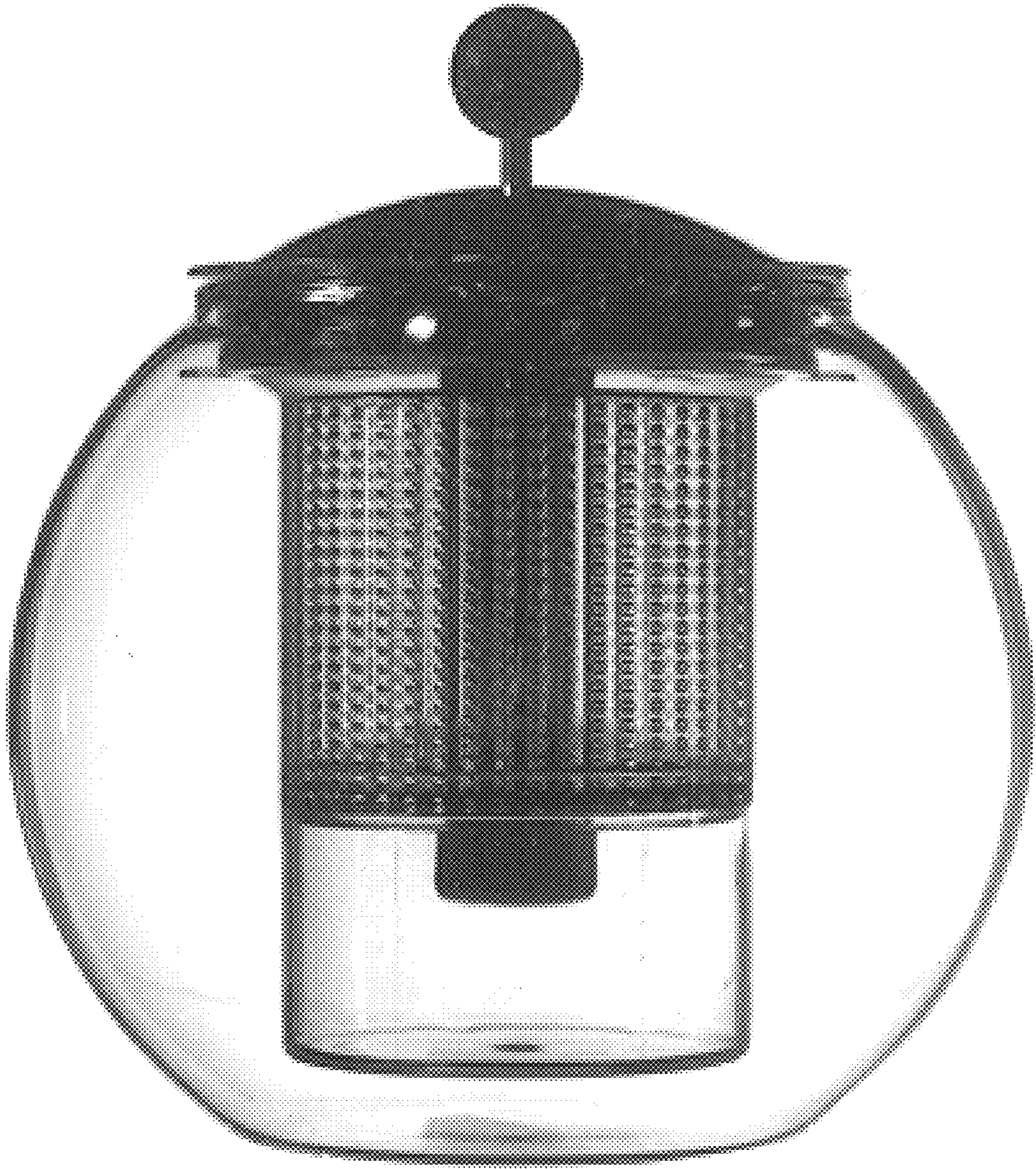

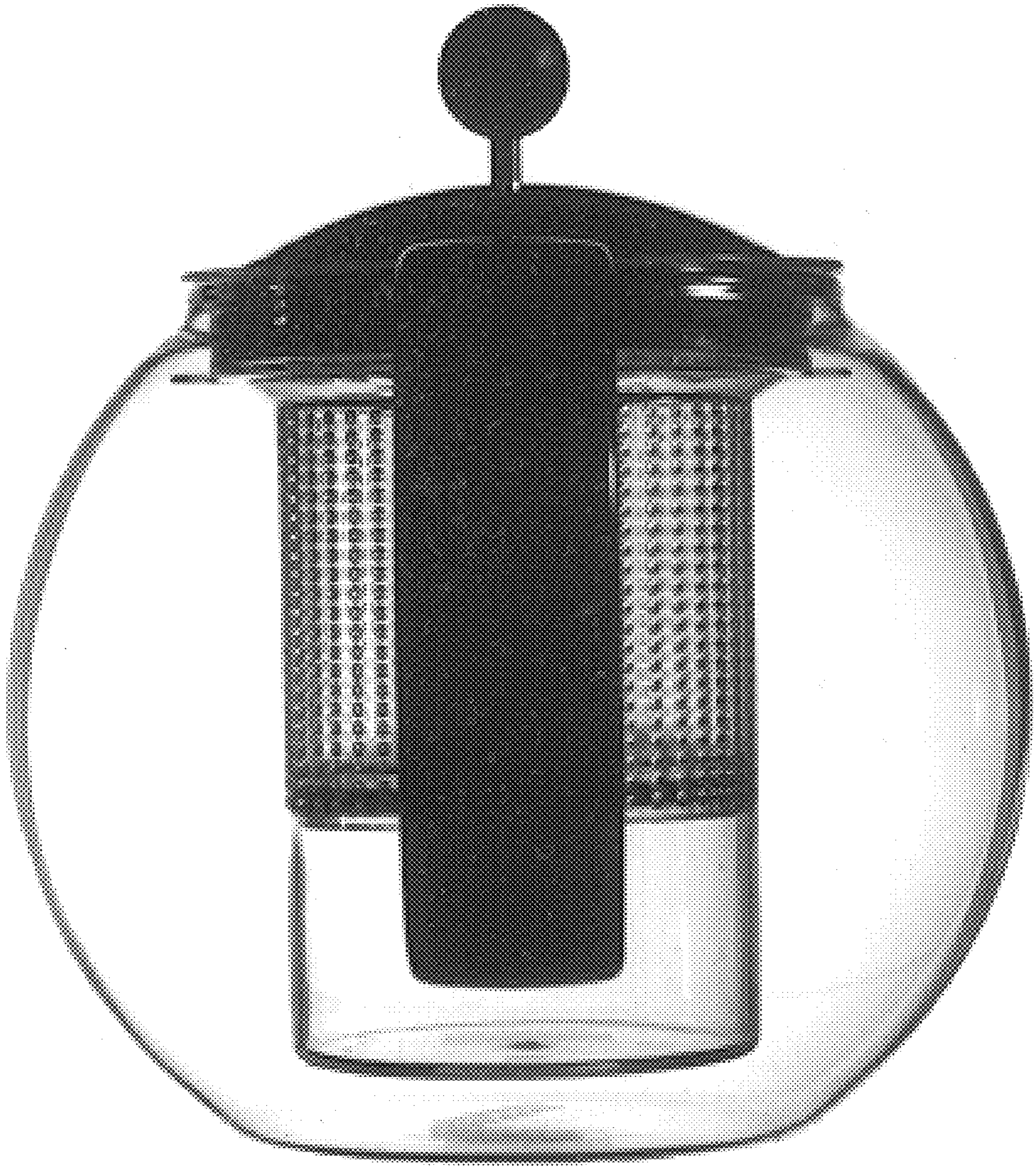

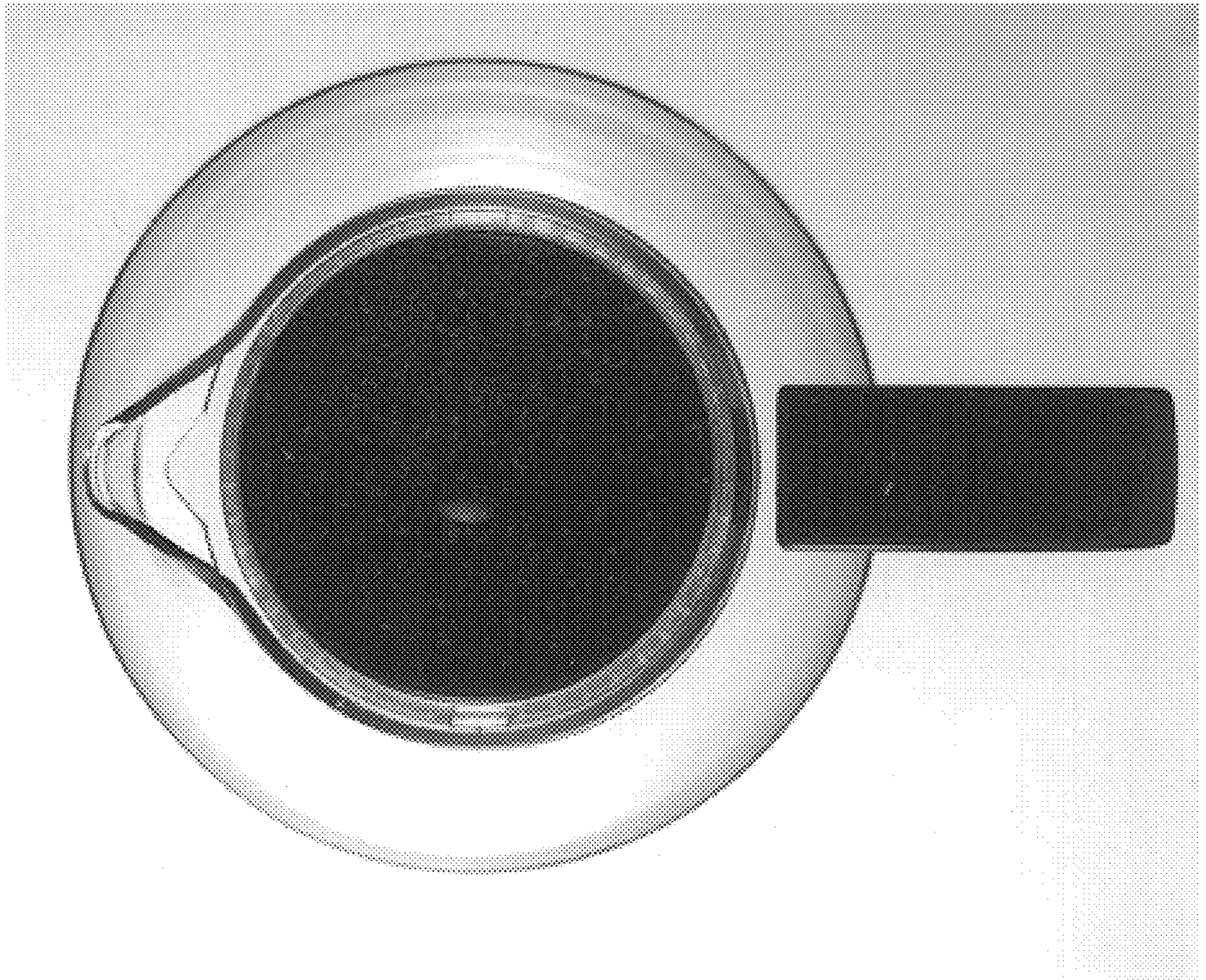

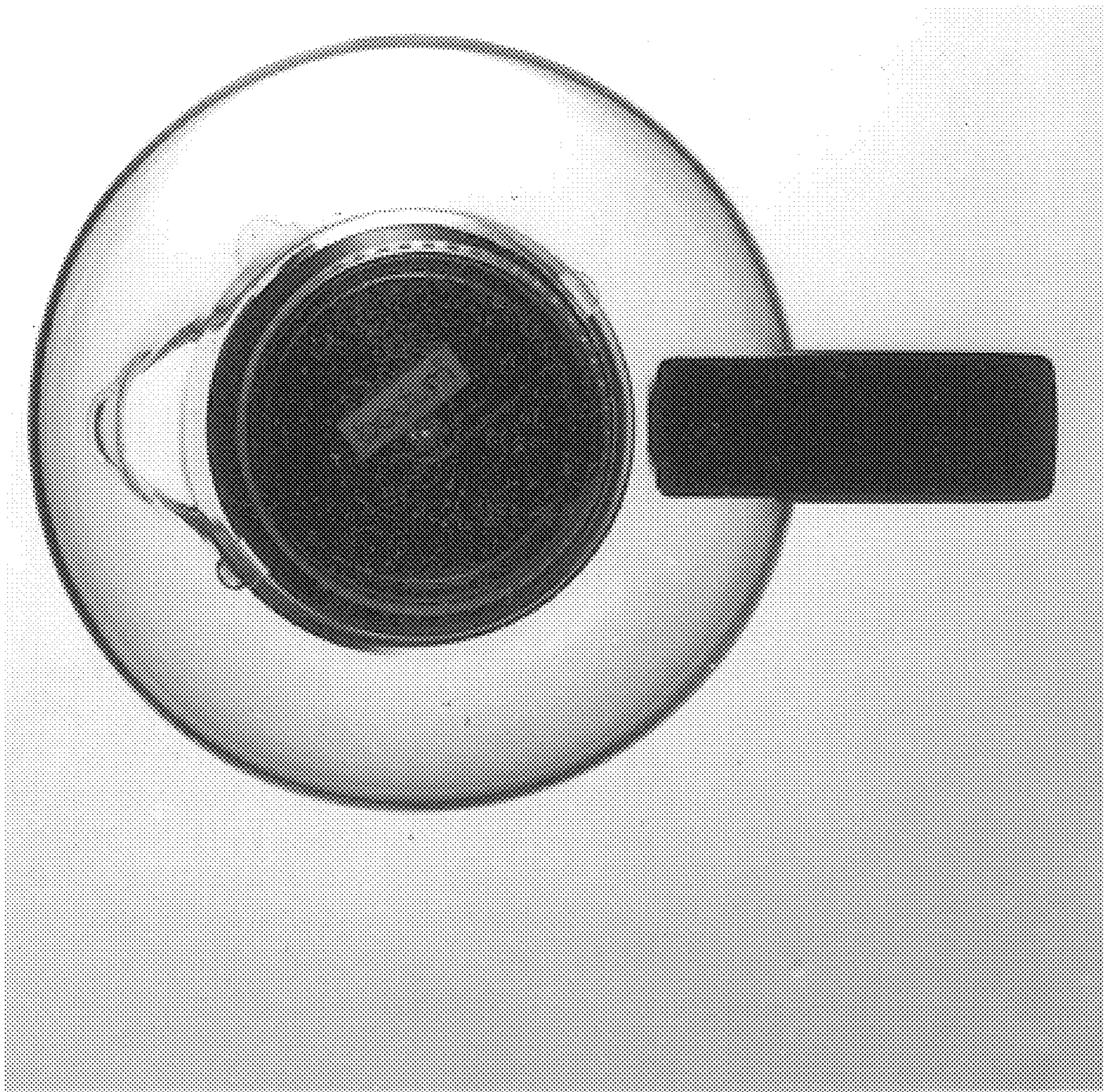
