[57] **CLAIM**

The ornamental design for a snap button for clothes assembly, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of a snap button for clothes assembly showing my new design.

FIG. 2 is a left side elevational view.

FIG. 3 is a right side elevational view.

FIG. 4 is a plan view.

FIG. 5 is an enlarged cross-sectional view taken along the line 5—5 of FIG. 1.

FIG. 6 is an enlarged cross-sectional view taken along the line 6—6 of FIG. 3.

FIG. 7 is a front elevational view of the male member tape, the female portion removed for ease of illustration.

FIG. 8 is a left side elevational view of FIG. 7.

FIG. 9 is a right side elevational view of FIG. 7.

FIG. 10 is a plan view of FIG. 7.

FIG. 11 is an enlarged cross-sectional view taken along the line 11—11 of FIG. 7.

FIG. 12 is a front elevational view of the female member tape, the male portion removed for ease of illustration.

FIG. 13 is a right side elevational view of FIG. 12.

FIG. 14 is a plan view of FIG. 12; and,

FIG. 15 is an enlarged cross-sectional view taken on the line 15—15 of FIG. 12.

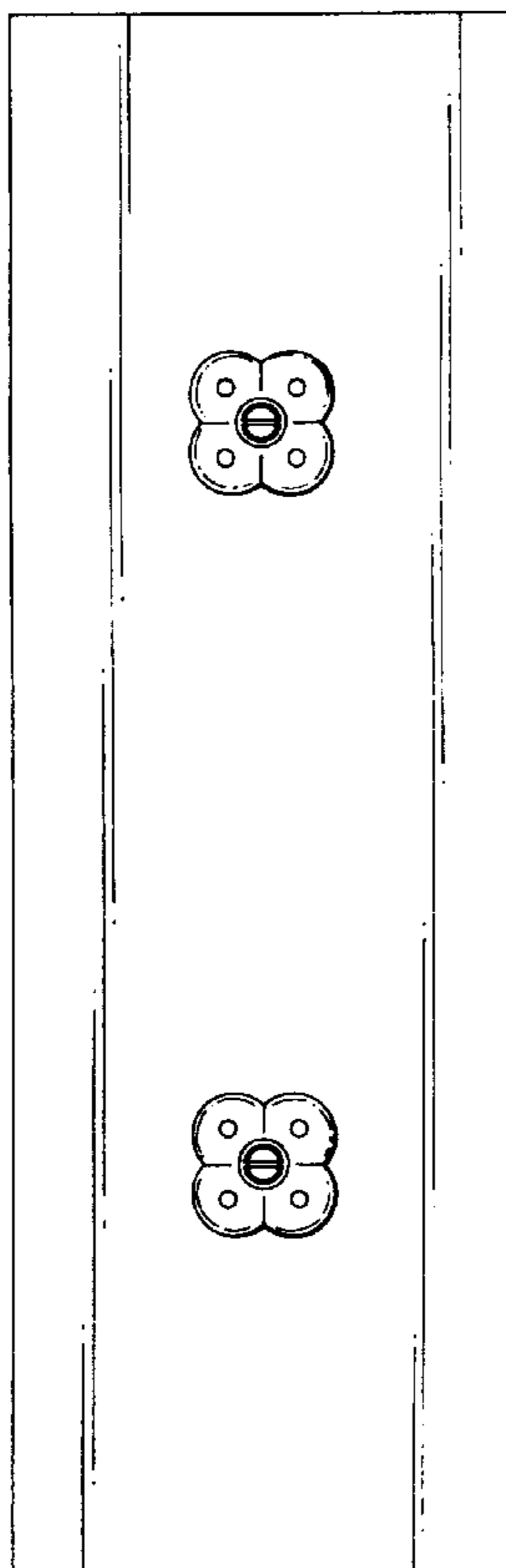

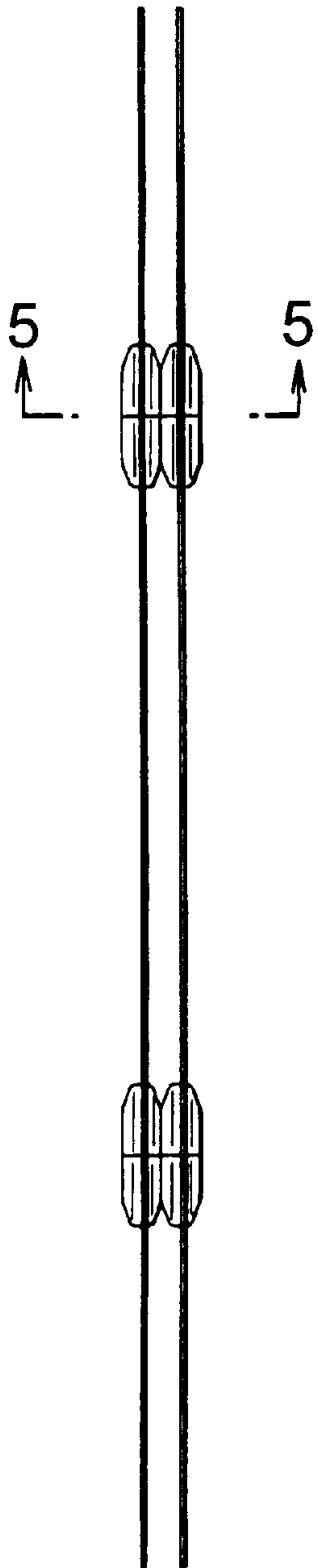

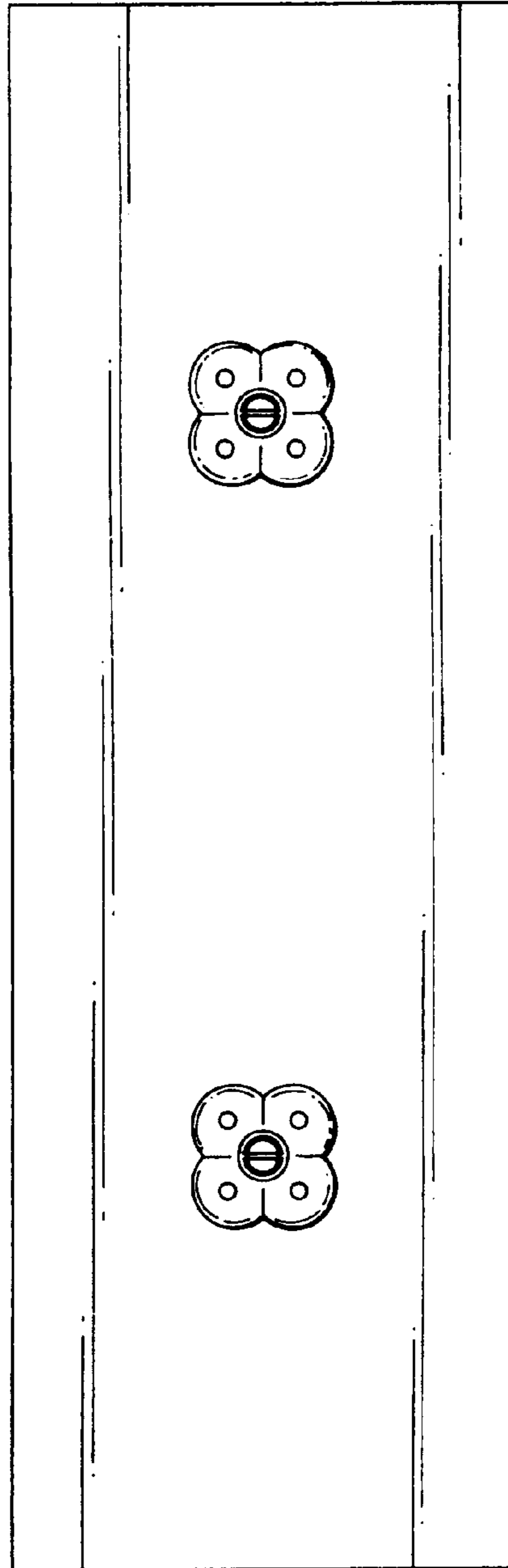

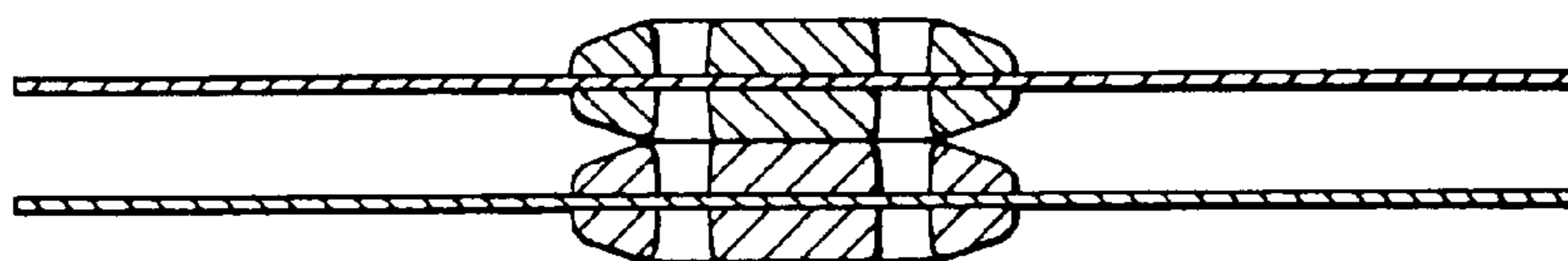

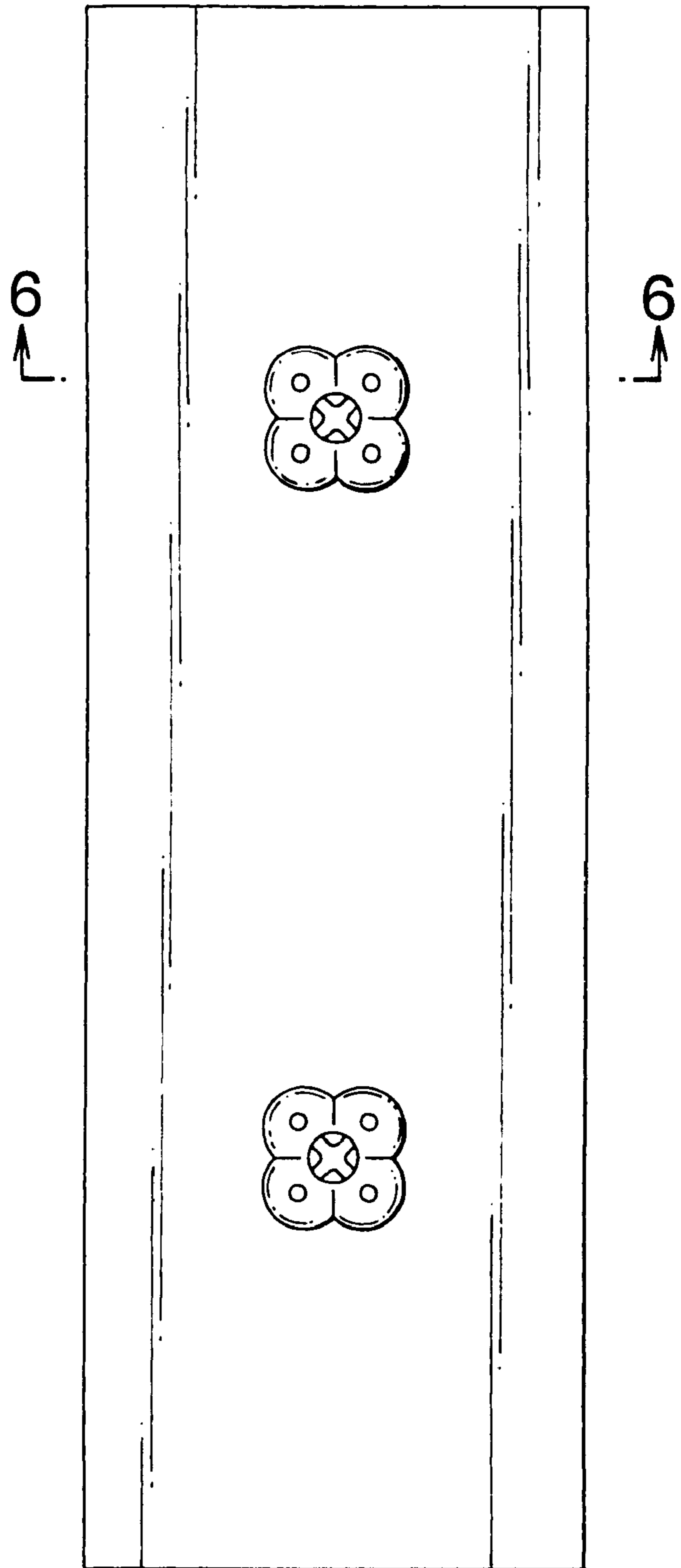

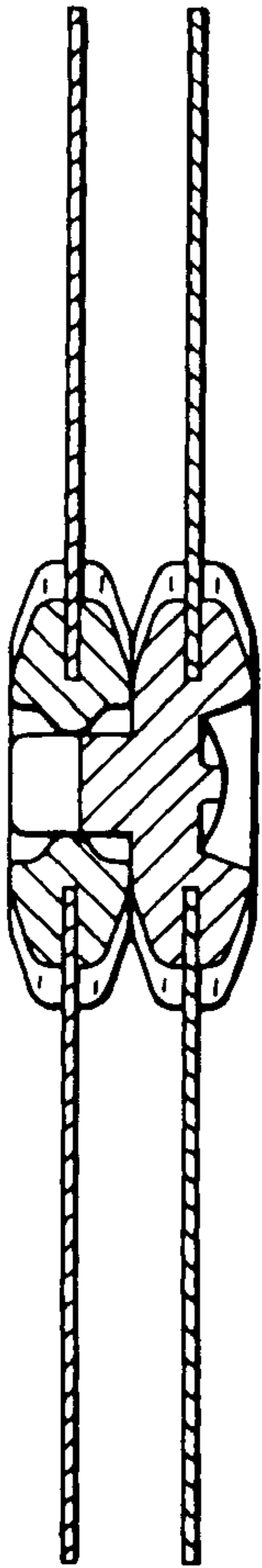

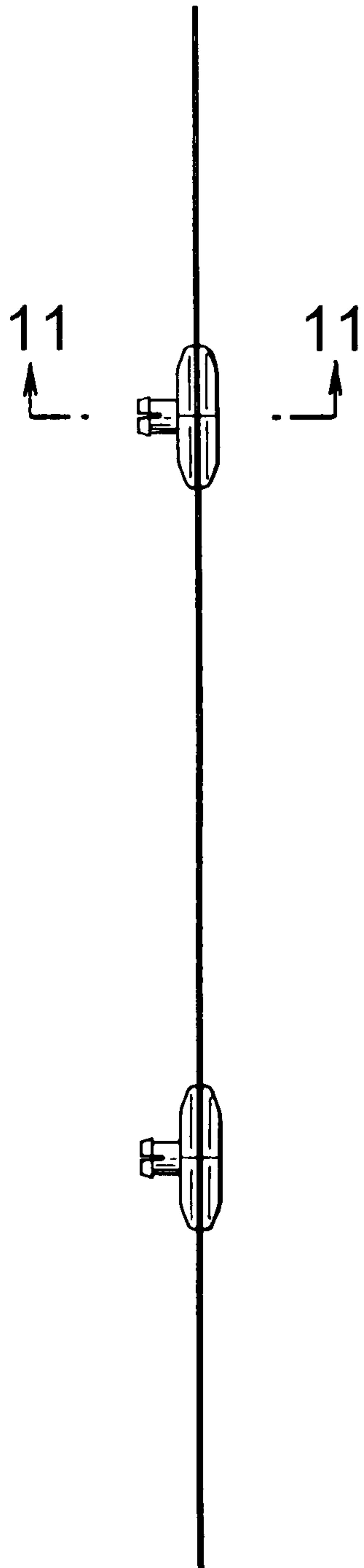

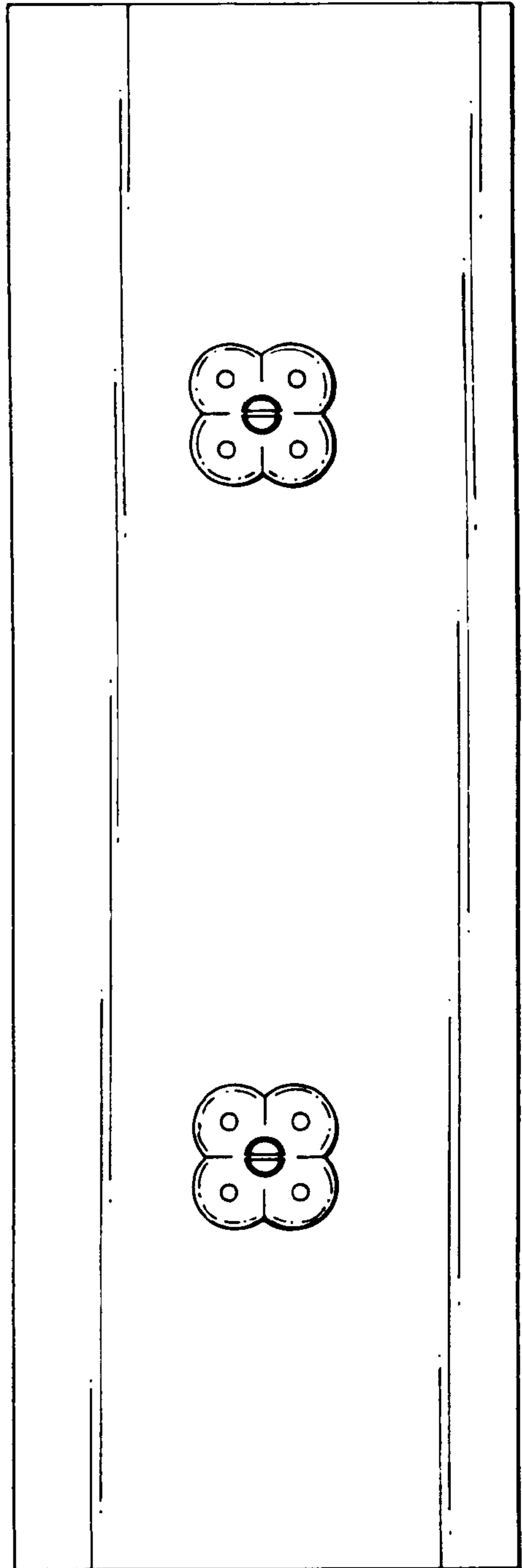

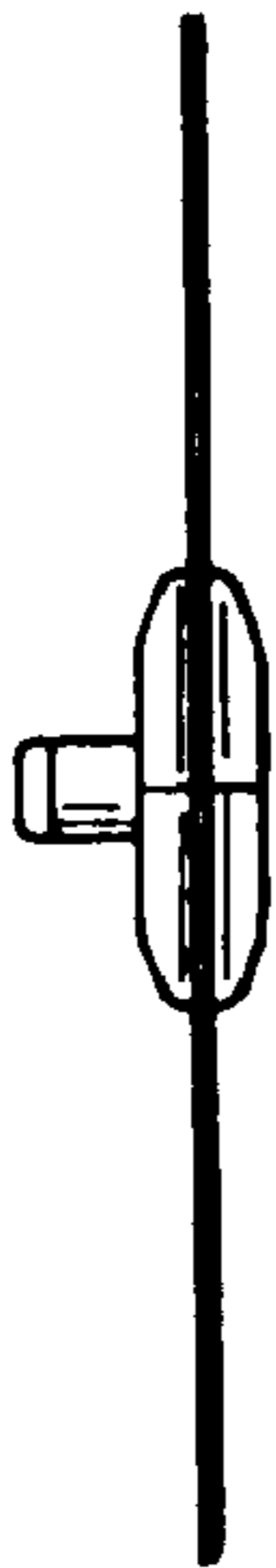

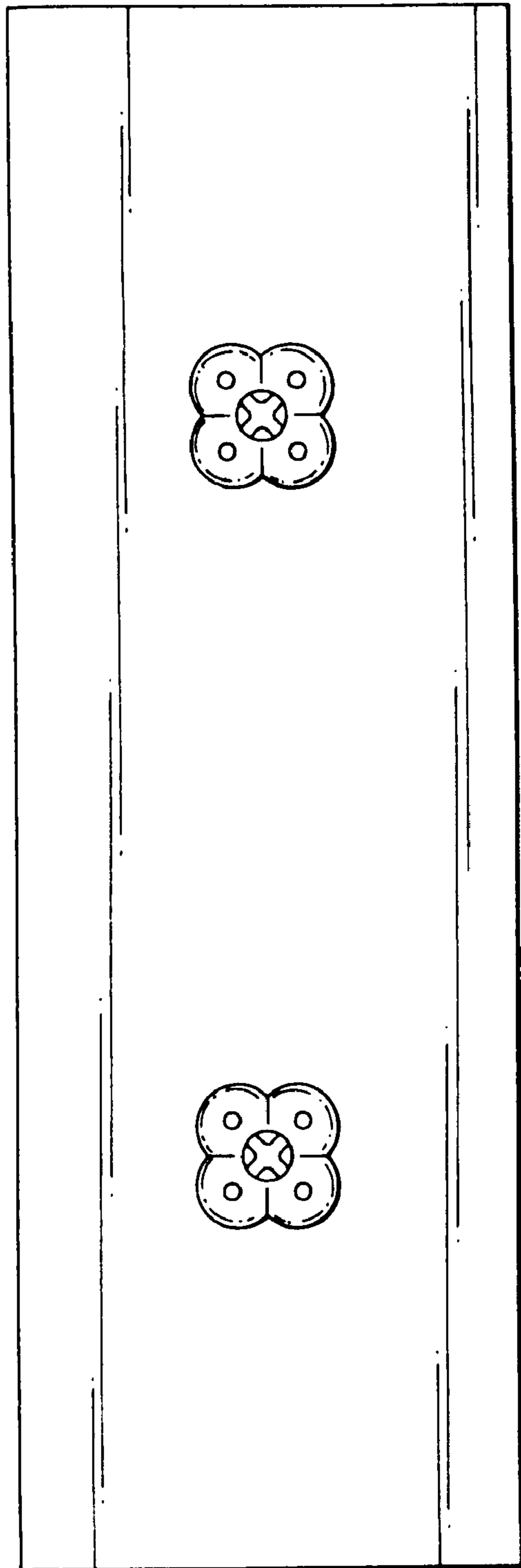

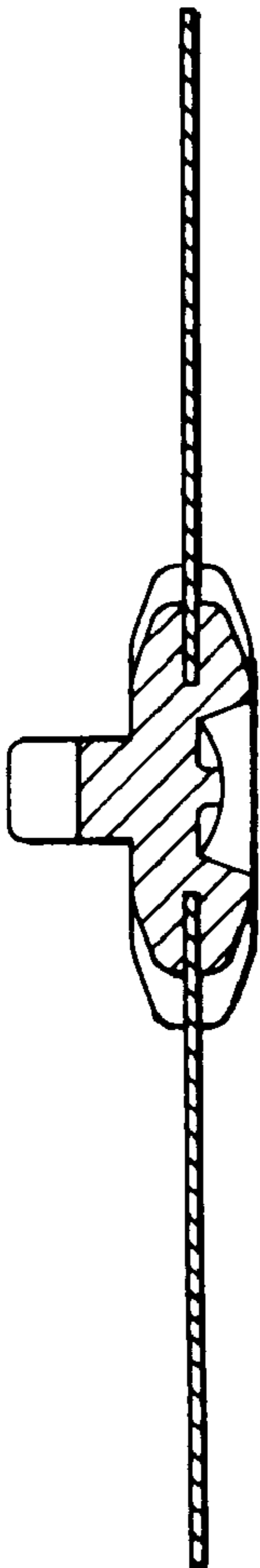

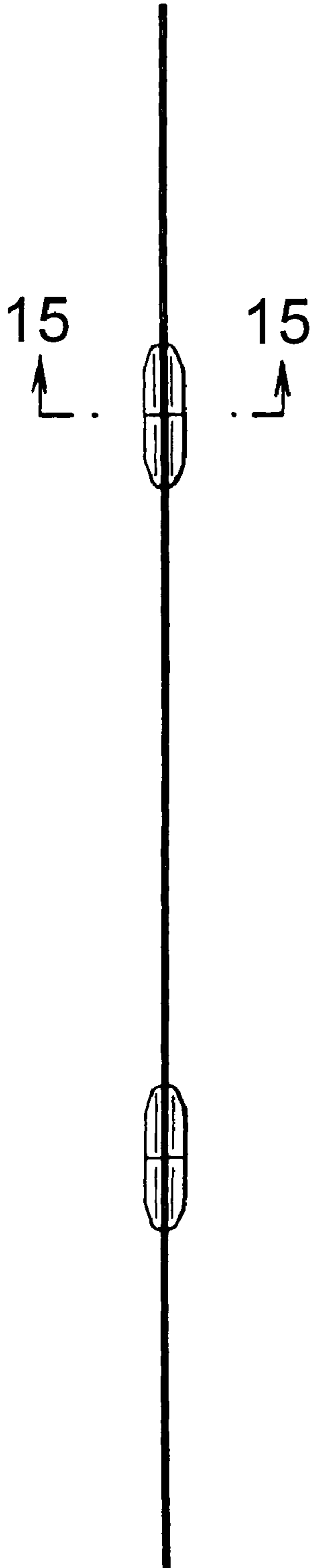

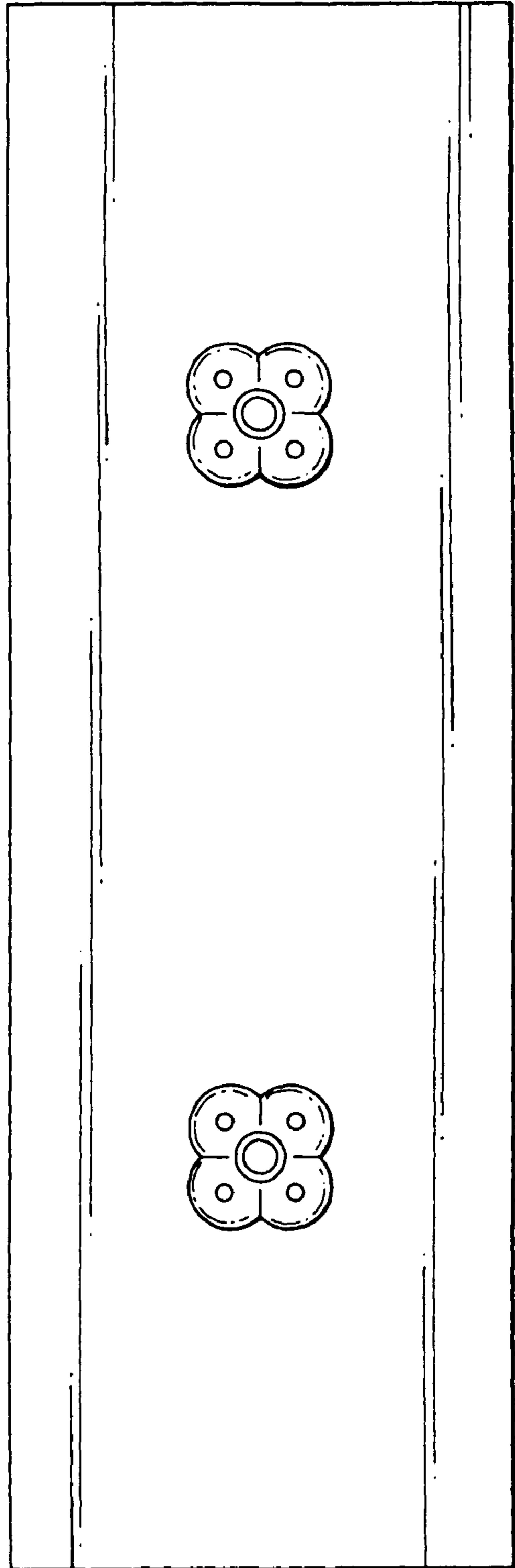
