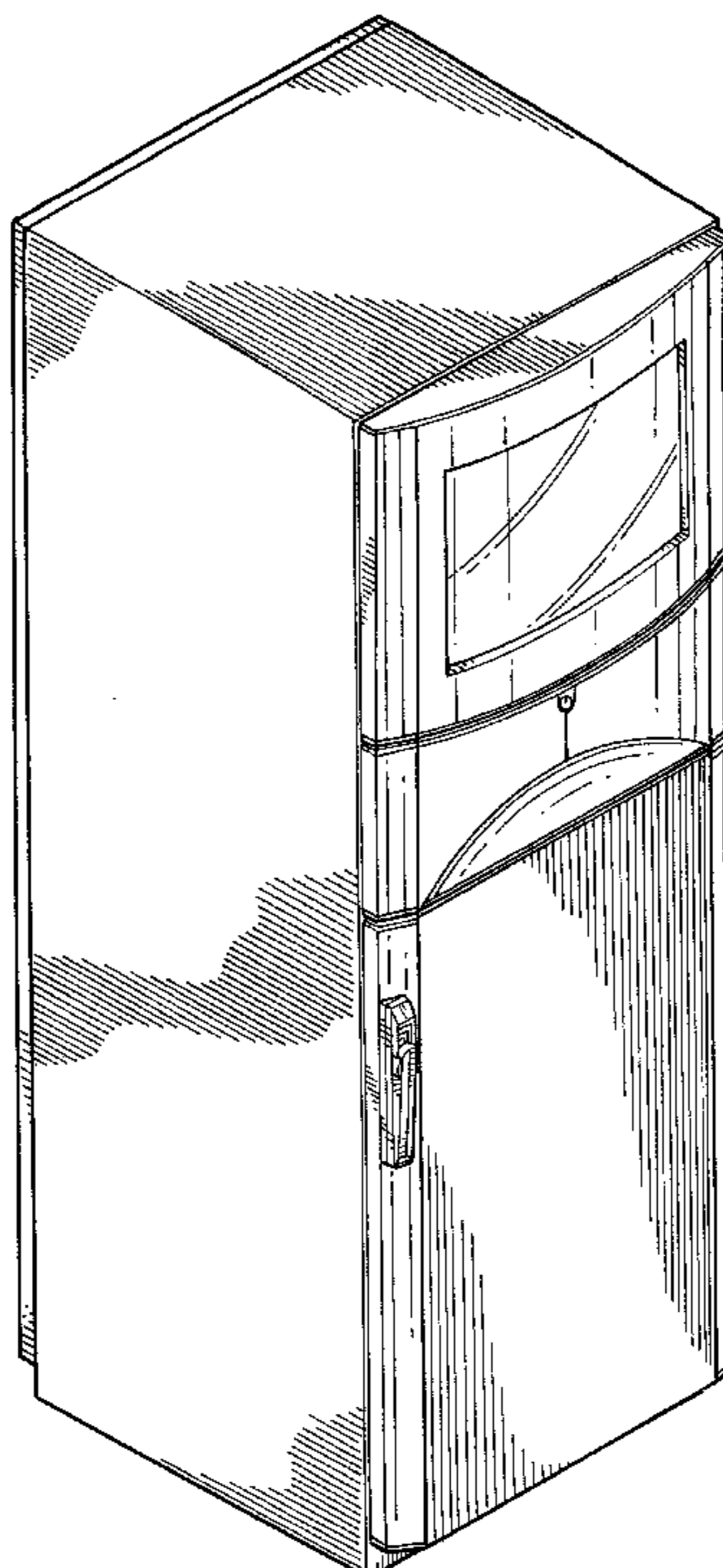
[57] **CLAIM**

The ornamental design for a personal computer shelf, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a personal computer shelf, according to one preferred embodiment of this invention; FIG. 2 is a front view of the personal computer shelf, as shown in FIG. 1; FIG. 3 is a side view of the personal computer shelf, as shown in FIG. 1; FIG. 4 is a side view, opposite the side view shown in FIG. 3, of the personal computer shelf, as shown in FIG. 1; FIG. 5 is a top view of the personal computer shelf, as shown in FIG. 1; FIG. 6 is a bottom view of the personal computer shelf, as shown in FIG. 1; FIG. 7 is a rear view of the personal computer shelf, as shown in FIG. 1; FIG. 8 is a perspective view of a personal computer shelf, according to another preferred embodiment of this invention; FIG. 9 is a front view of the personal computer shelf, as shown in FIG. 8; FIG. 10 is a side view of the personal computer shelf, as shown in FIG. 8; FIG. 11 is a side view, opposite the side view shown in FIG. 10, of the personal computer shelf, as shown in FIG. 8; FIG. 12 is a top view of the personal computer shelf, as shown in FIG. 8; FIG. 13 is a bottom view of the personal computer shelf, as shown in FIG. 8; and, FIG. 14 is a rear view of the personal computer shelf, as shown in FIG. 8.

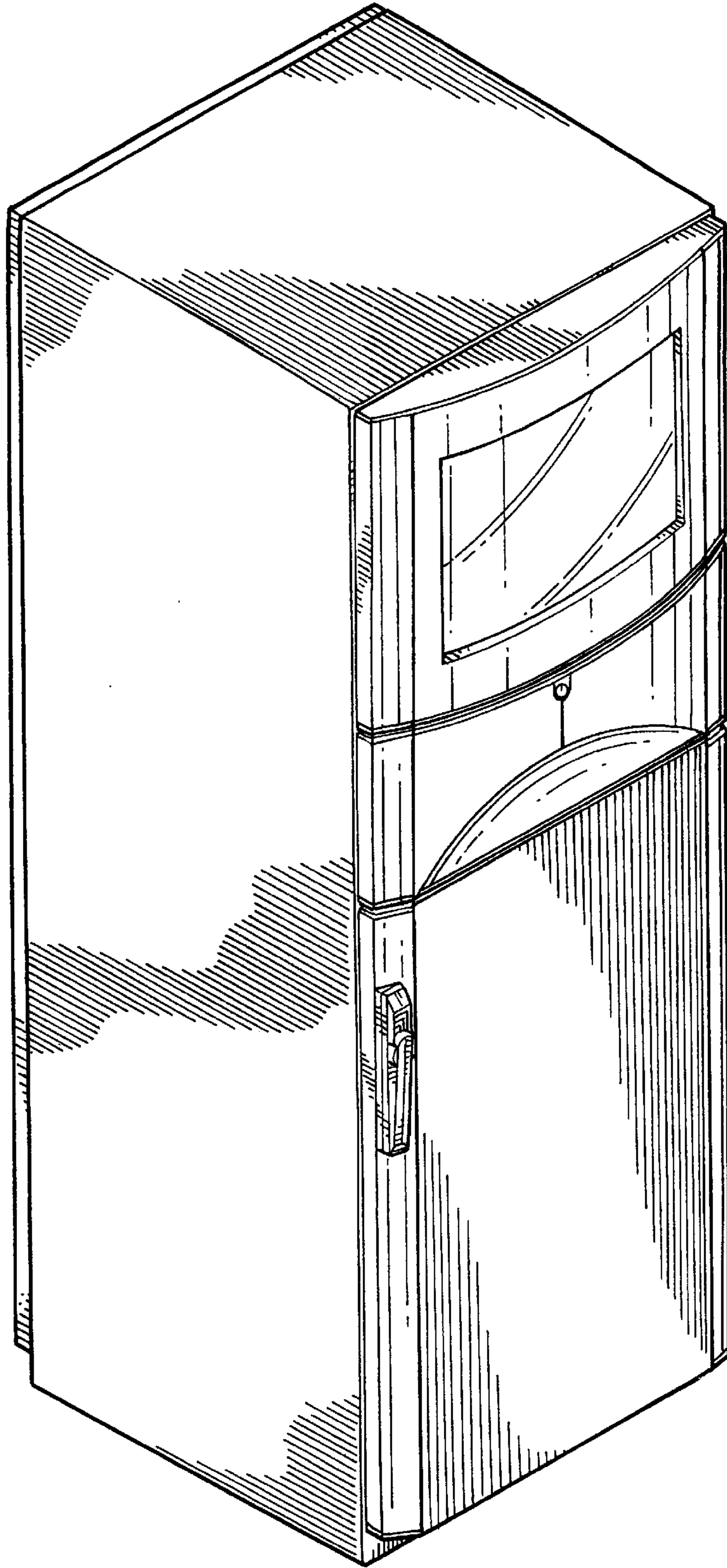

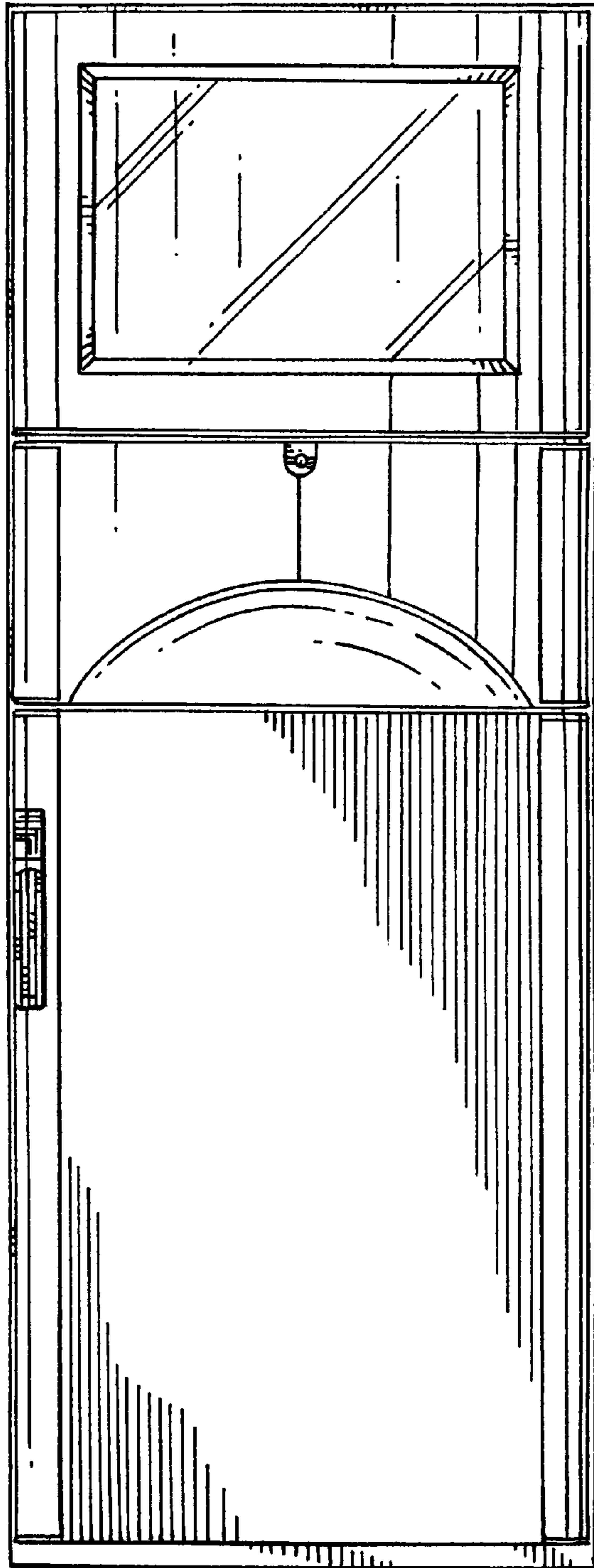

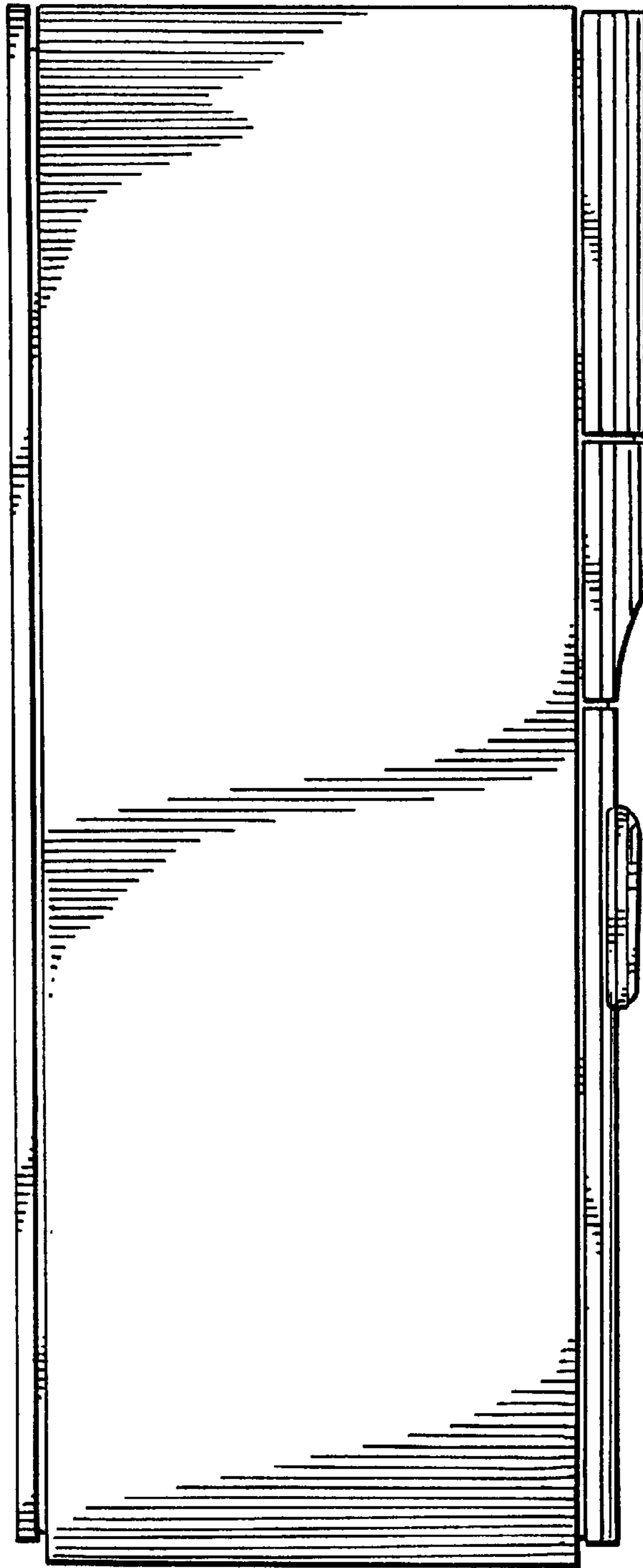

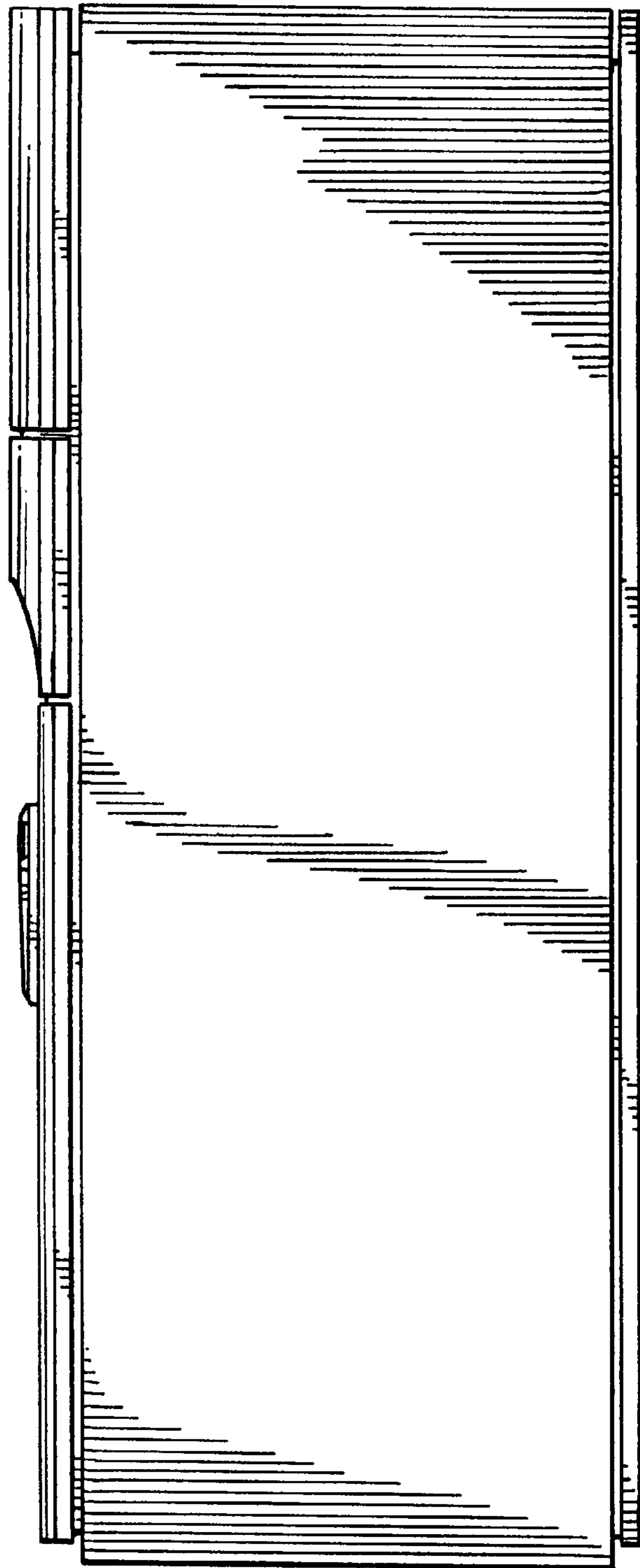

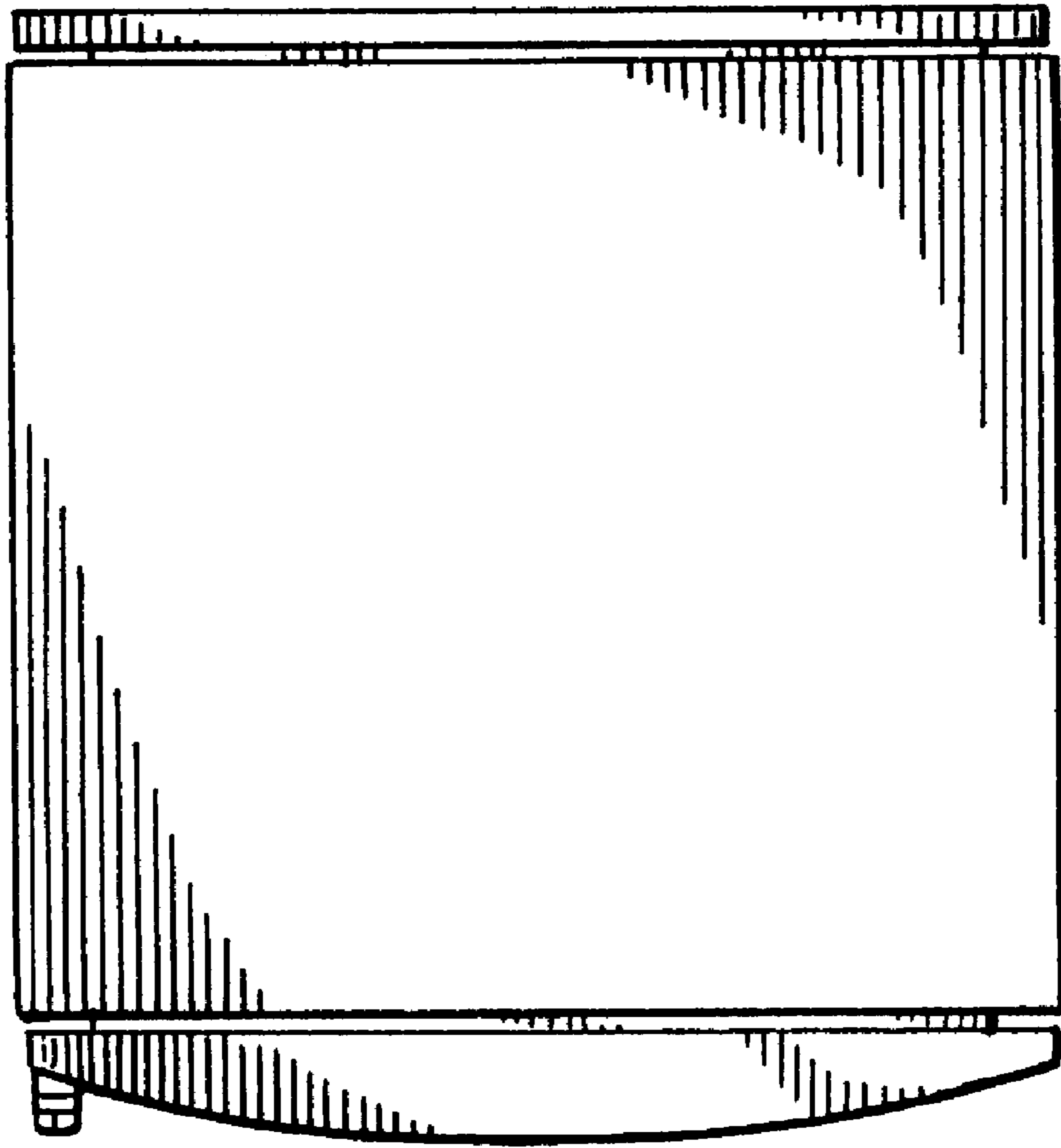

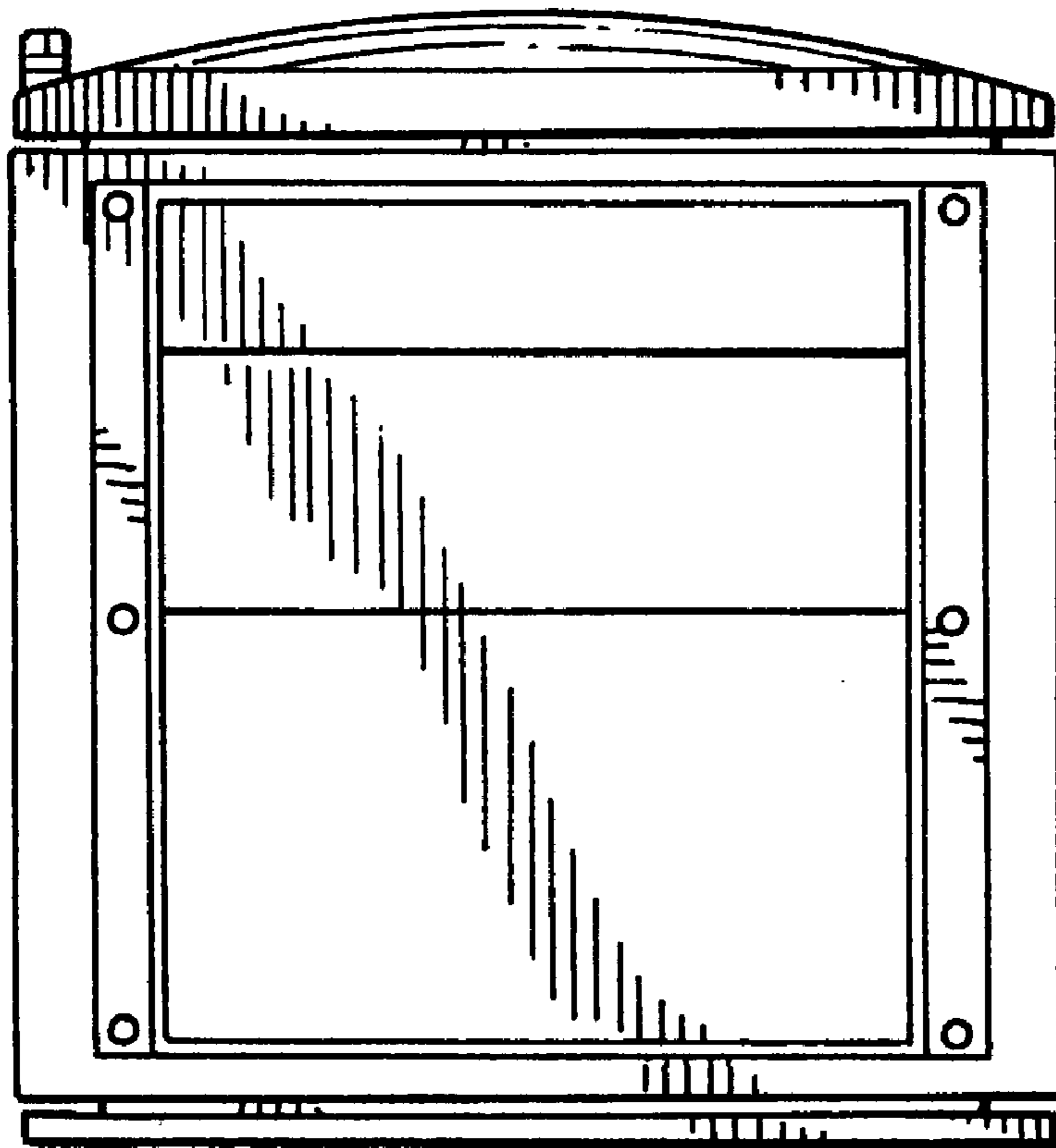

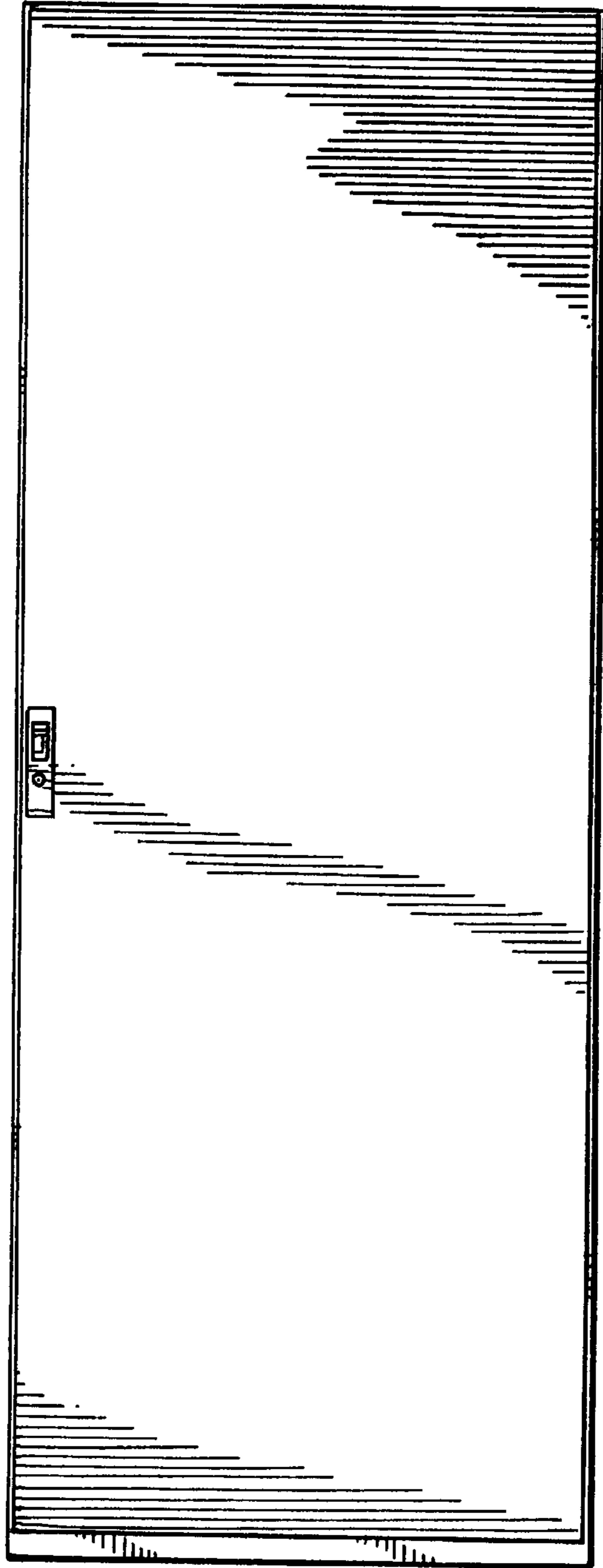

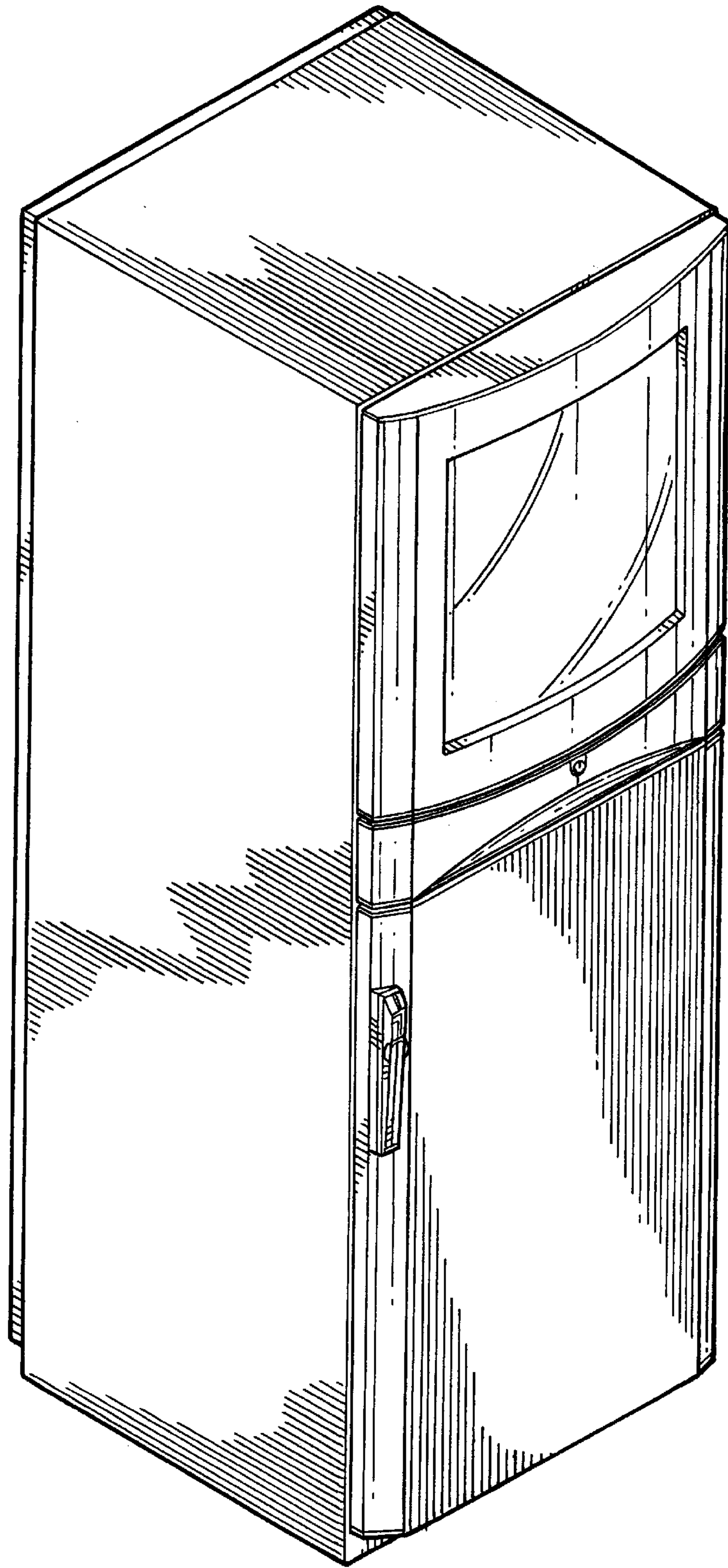

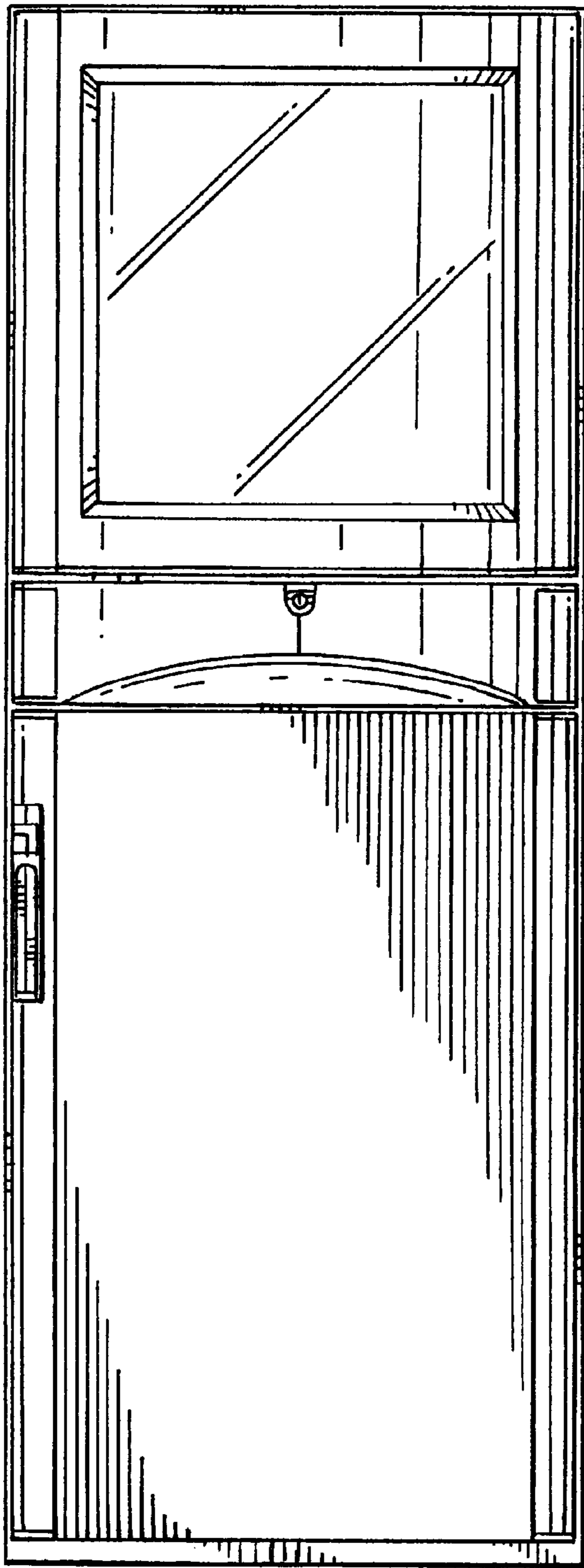

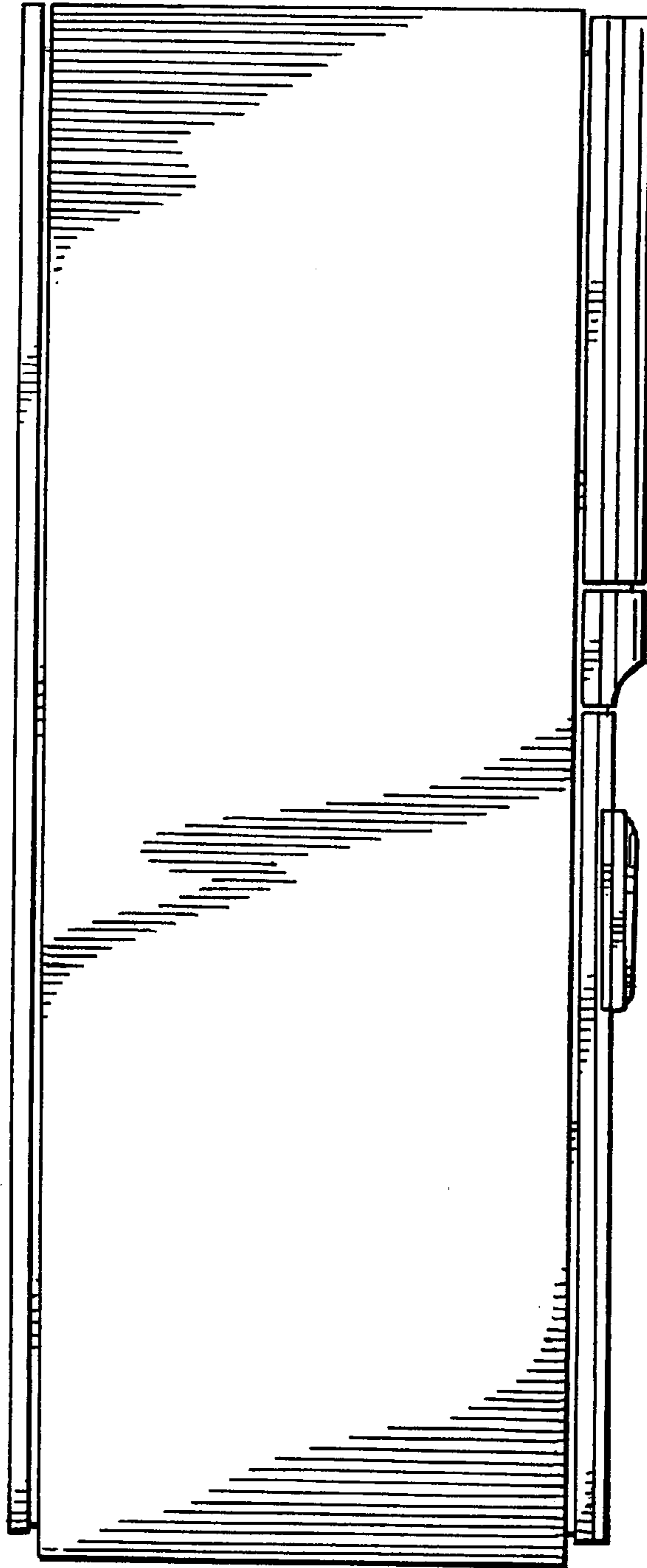

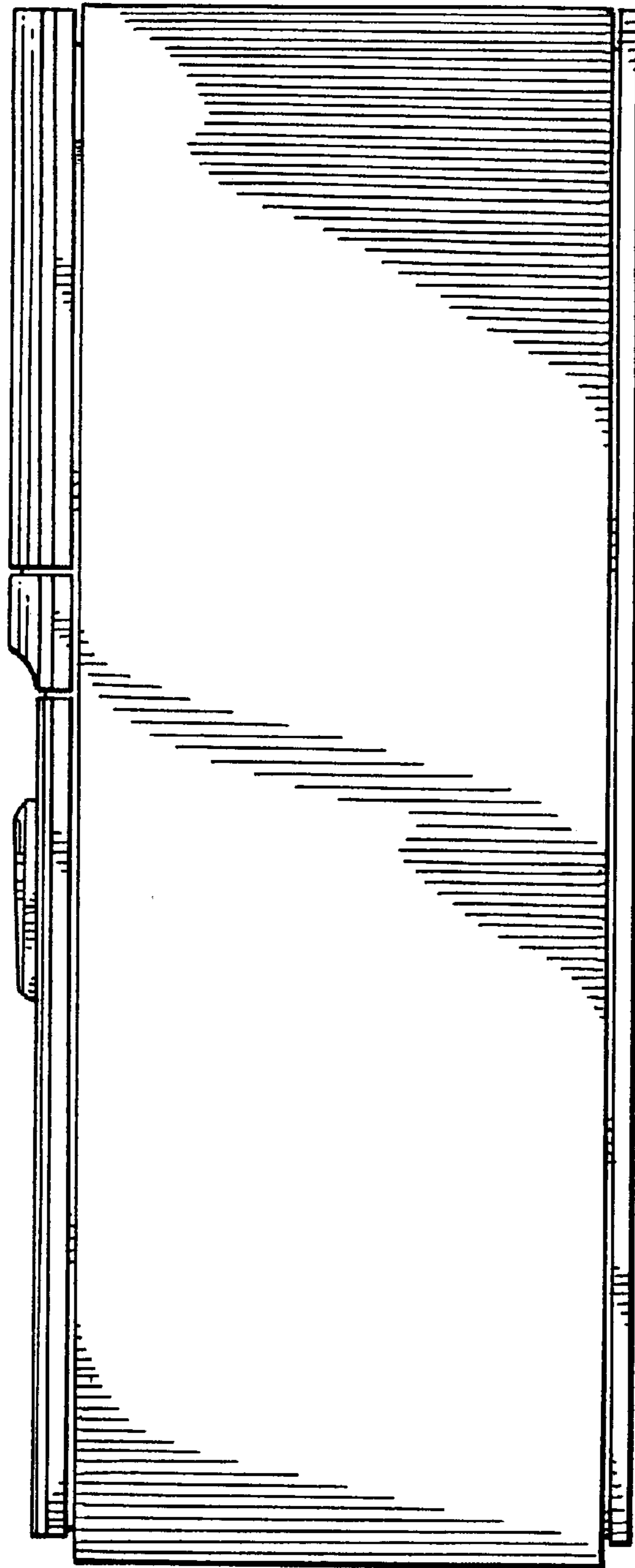

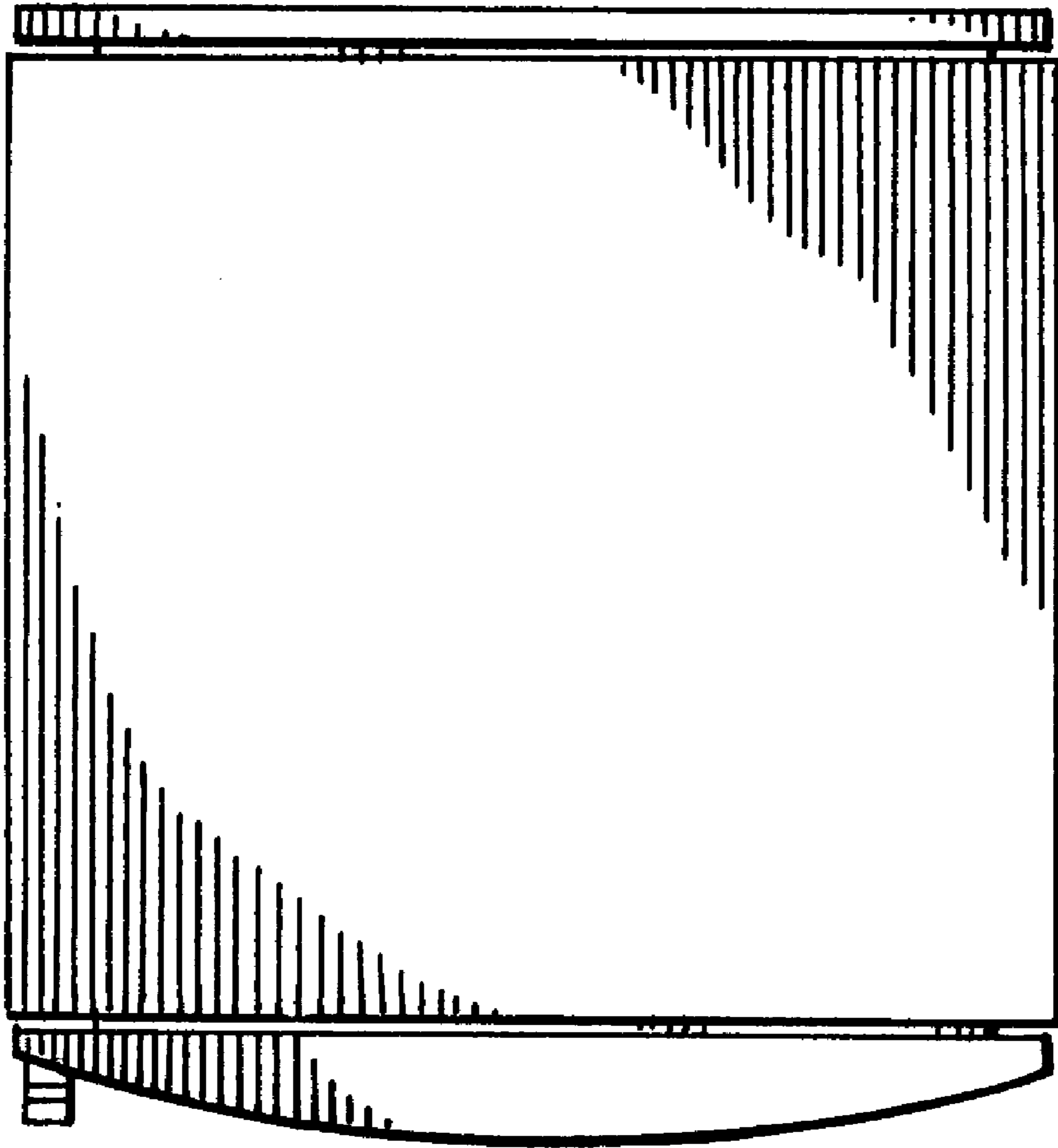

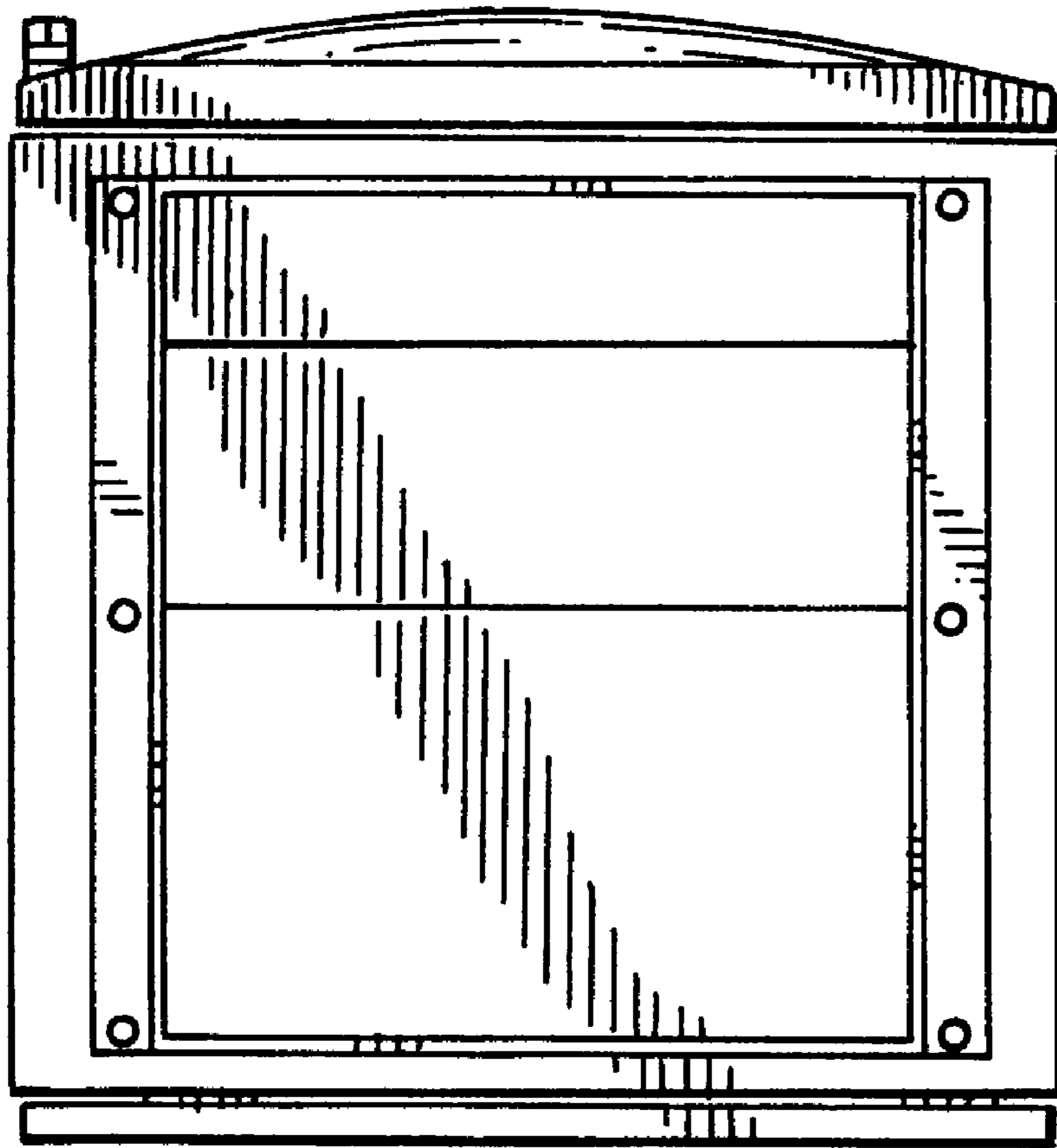

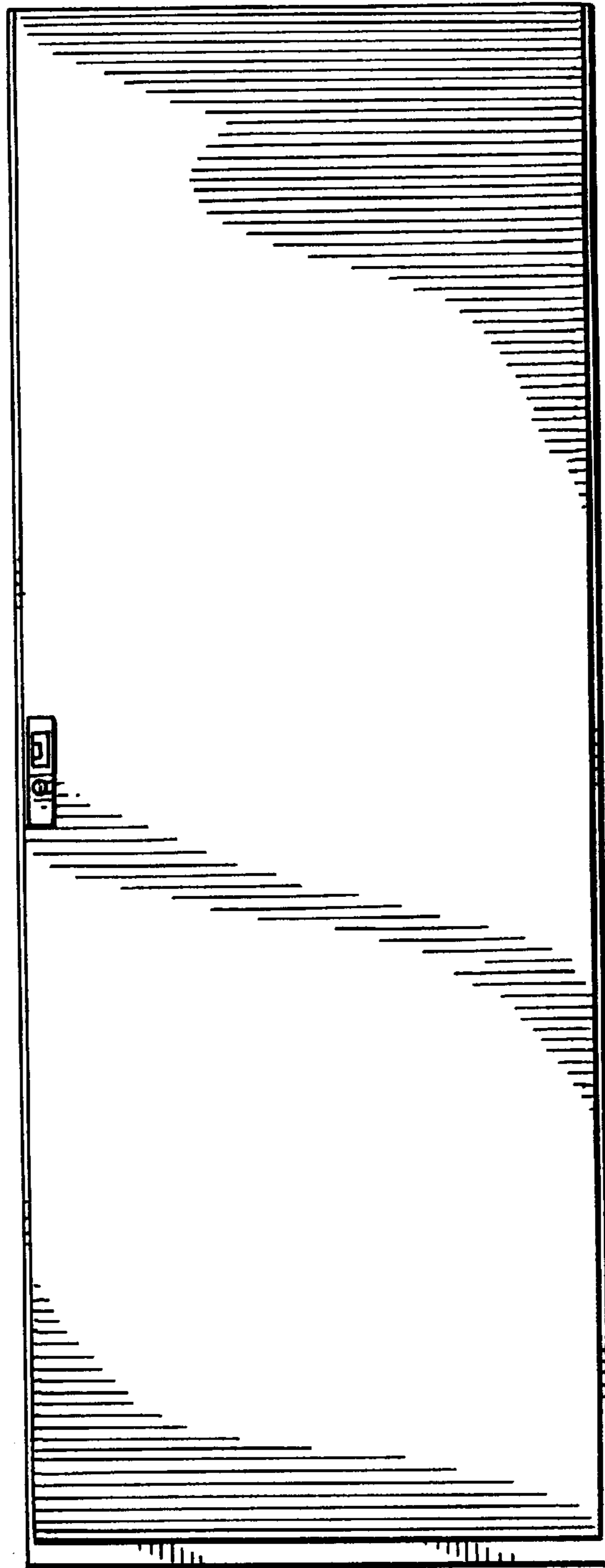
