The ornamental design for an entertainment device, as shown.

DESCRIPTION

FIG. 1 is a front perspective view of an entertainment device showing my new design;

FIG. 2 is a rear perspective view thereof;

FIG. 3 is a closed side elevation view of one side thereof;

FIG. 4 is a closed side elevation view of the other side thereof;

FIG. 5 is a front open elevation view thereof;

FIG. 6 is a back open elevation view of the other side thereof;

FIG. 8 is a bottom plan view thereof;

FIG. 9 is a closed front perspective view thereof;

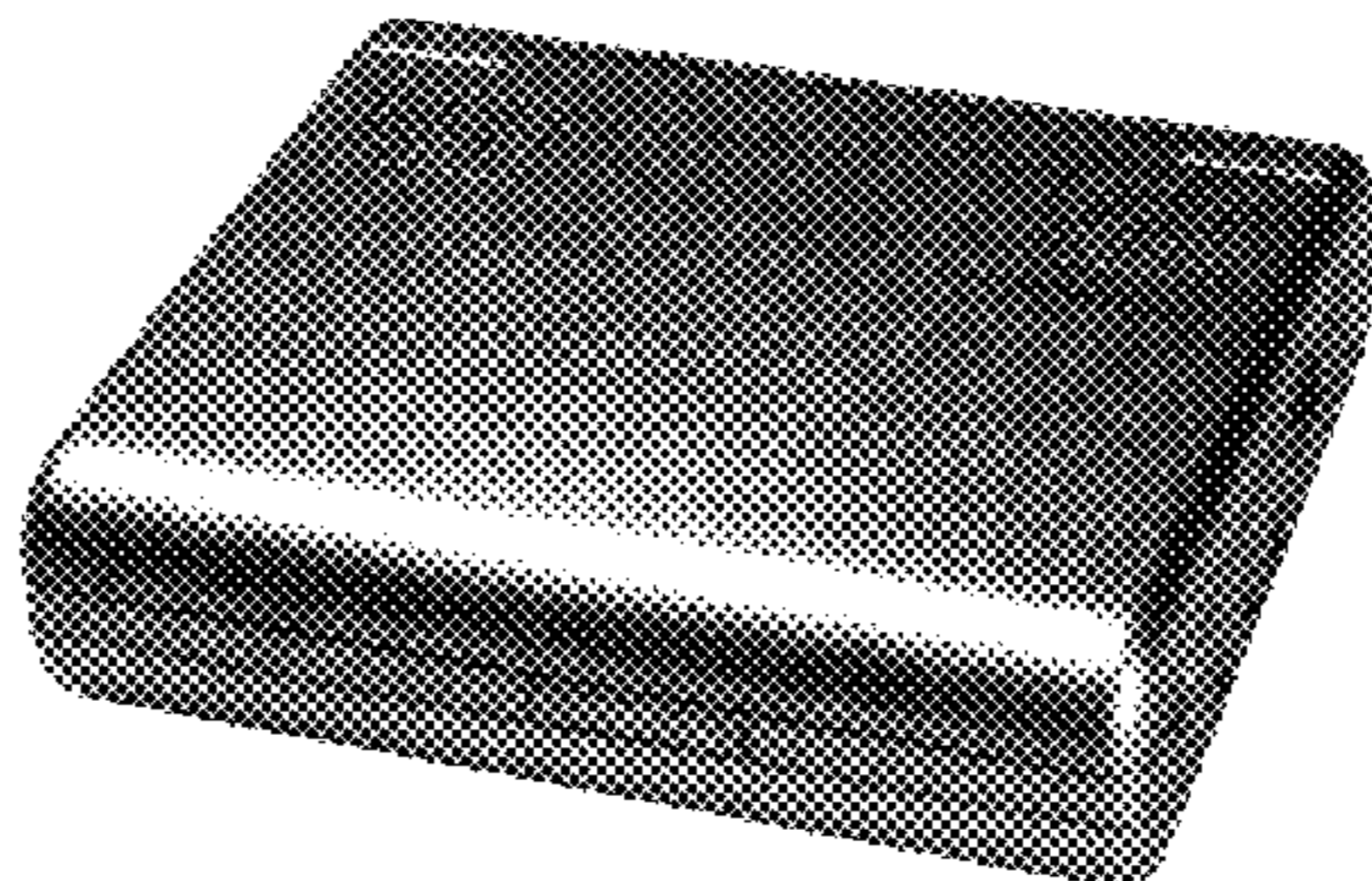
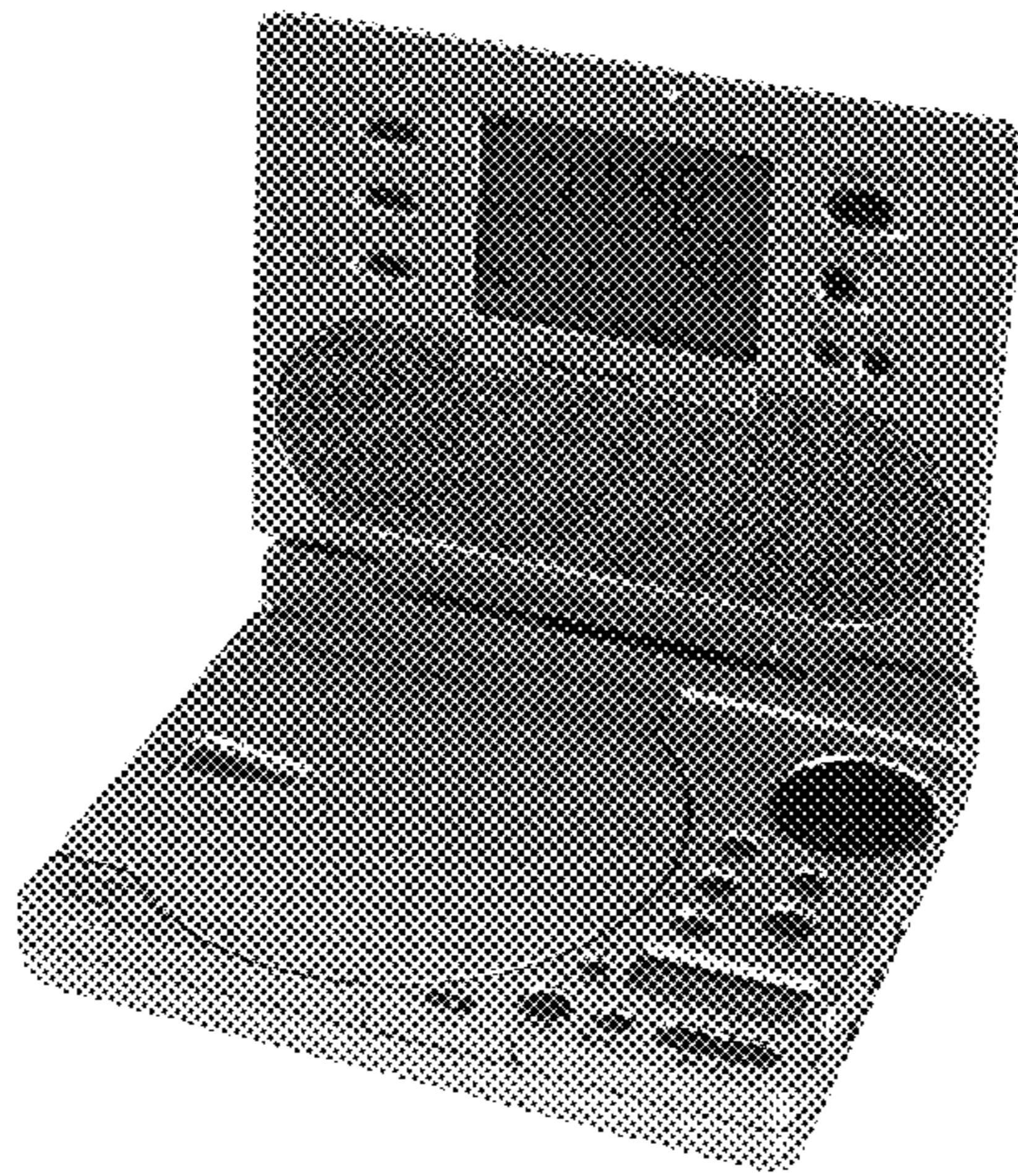

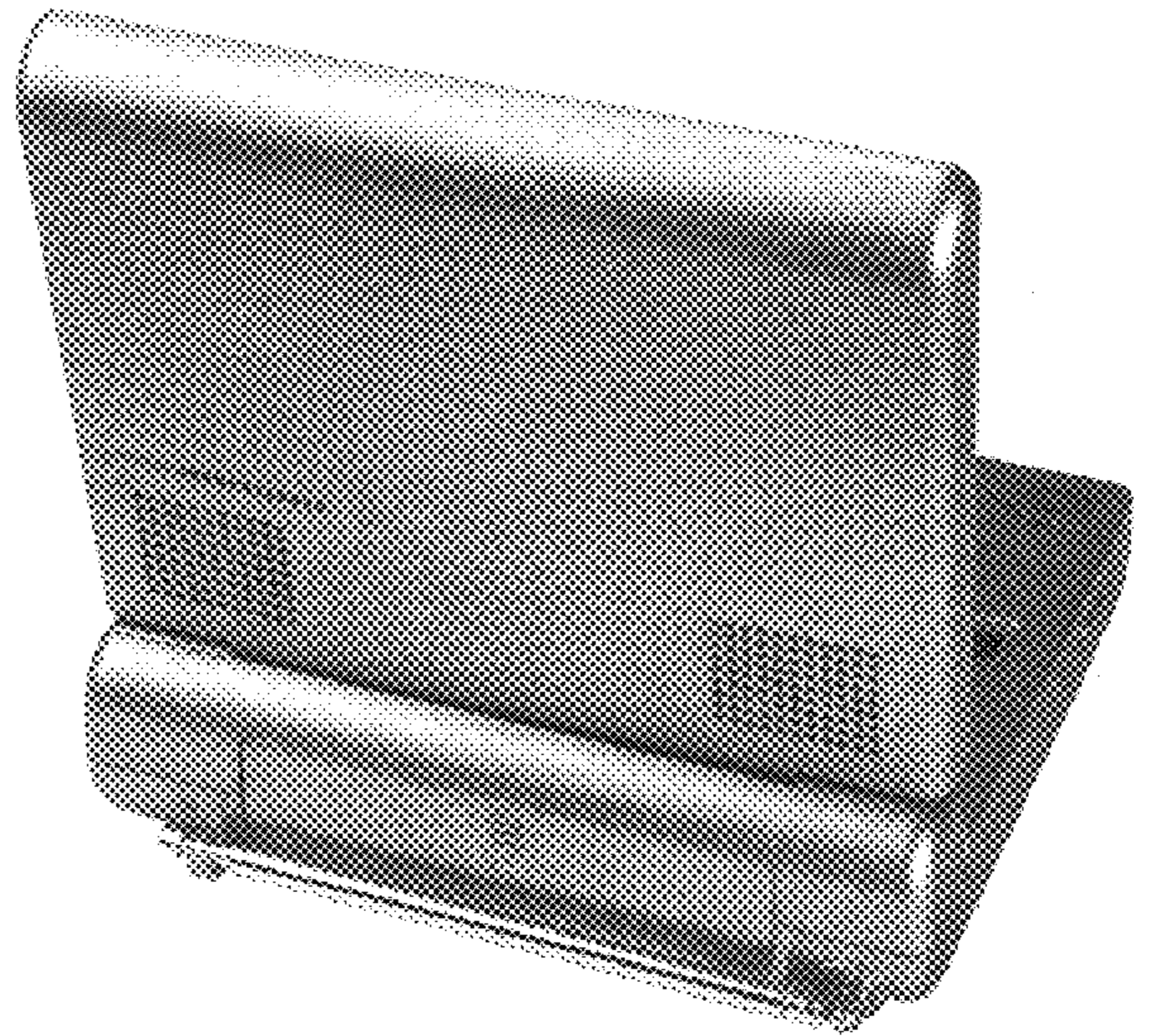

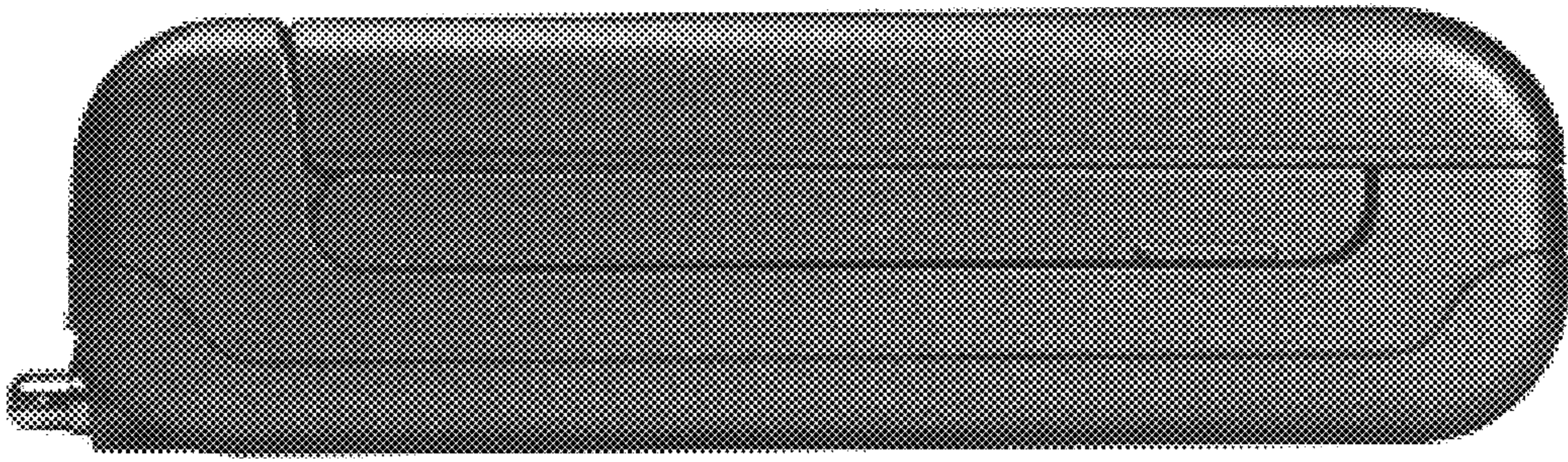

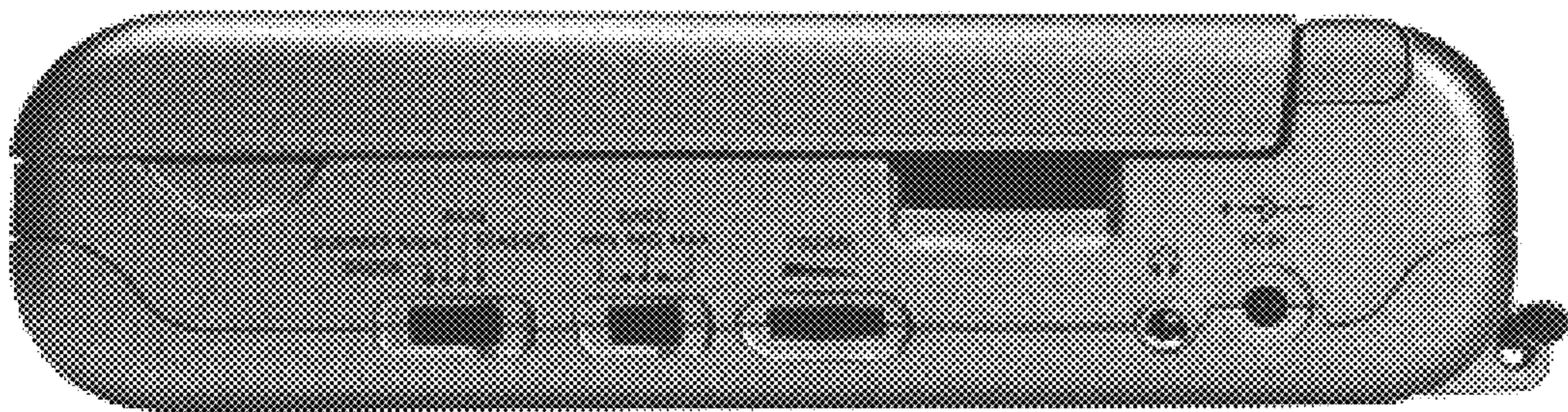

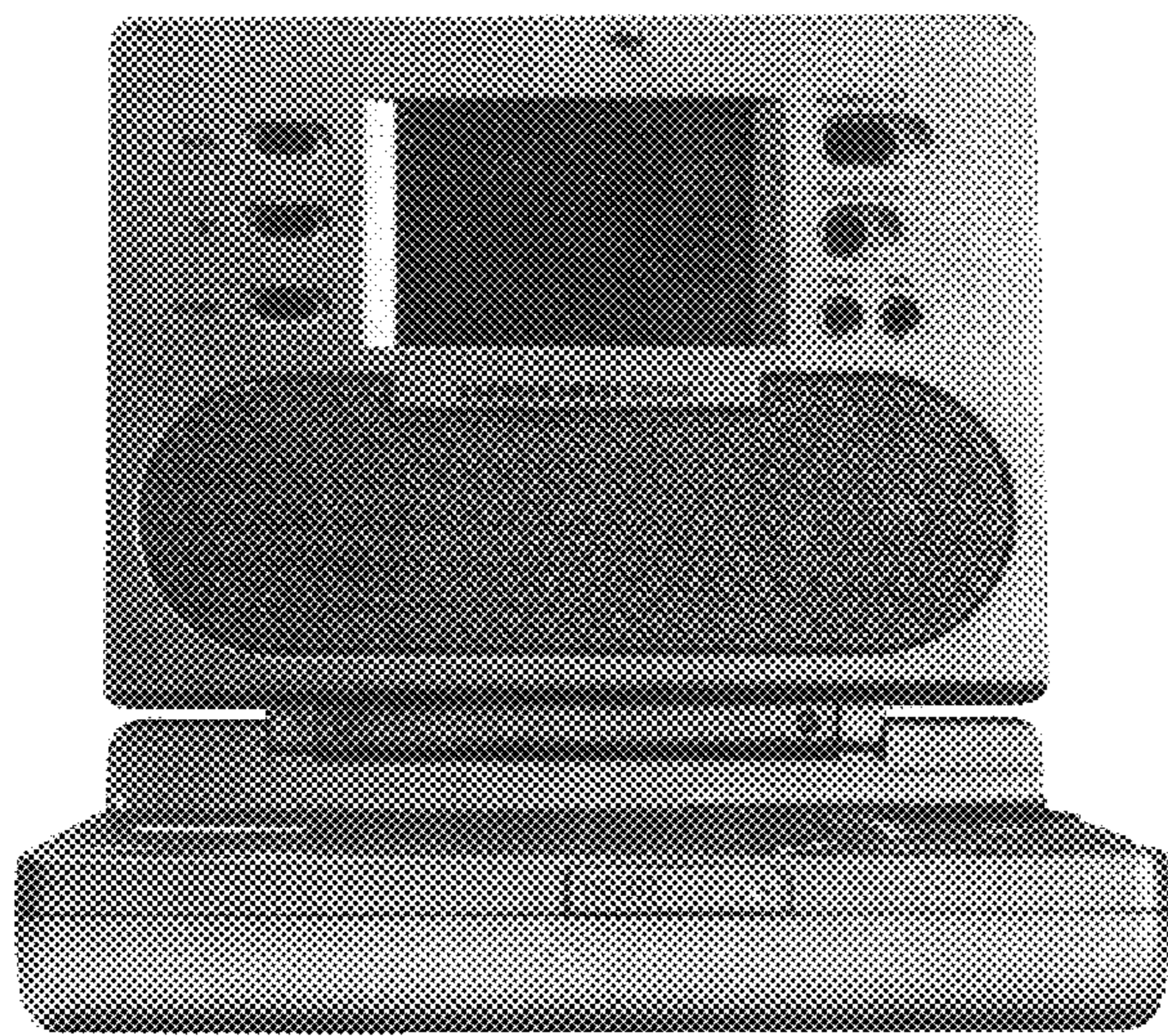

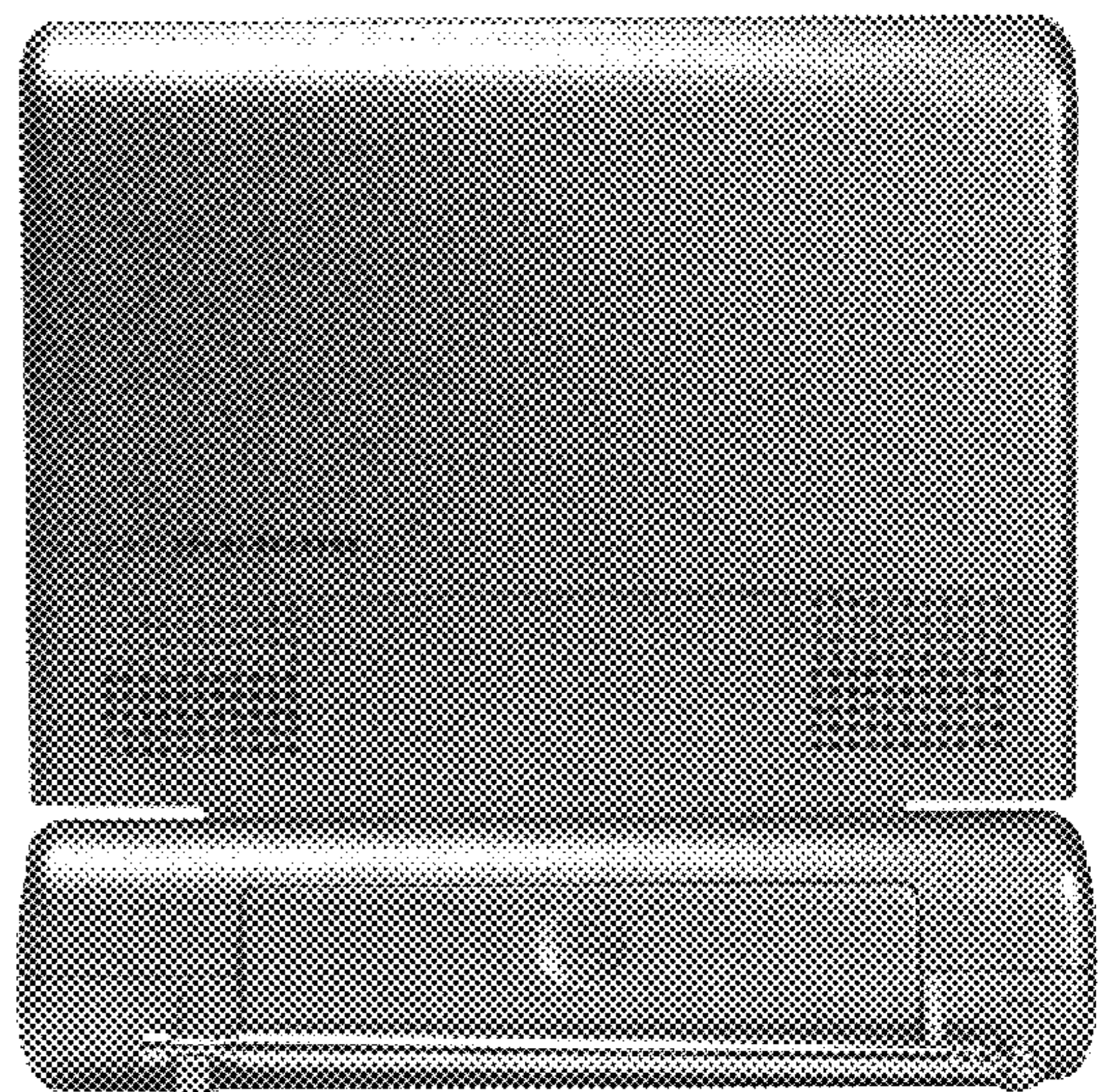

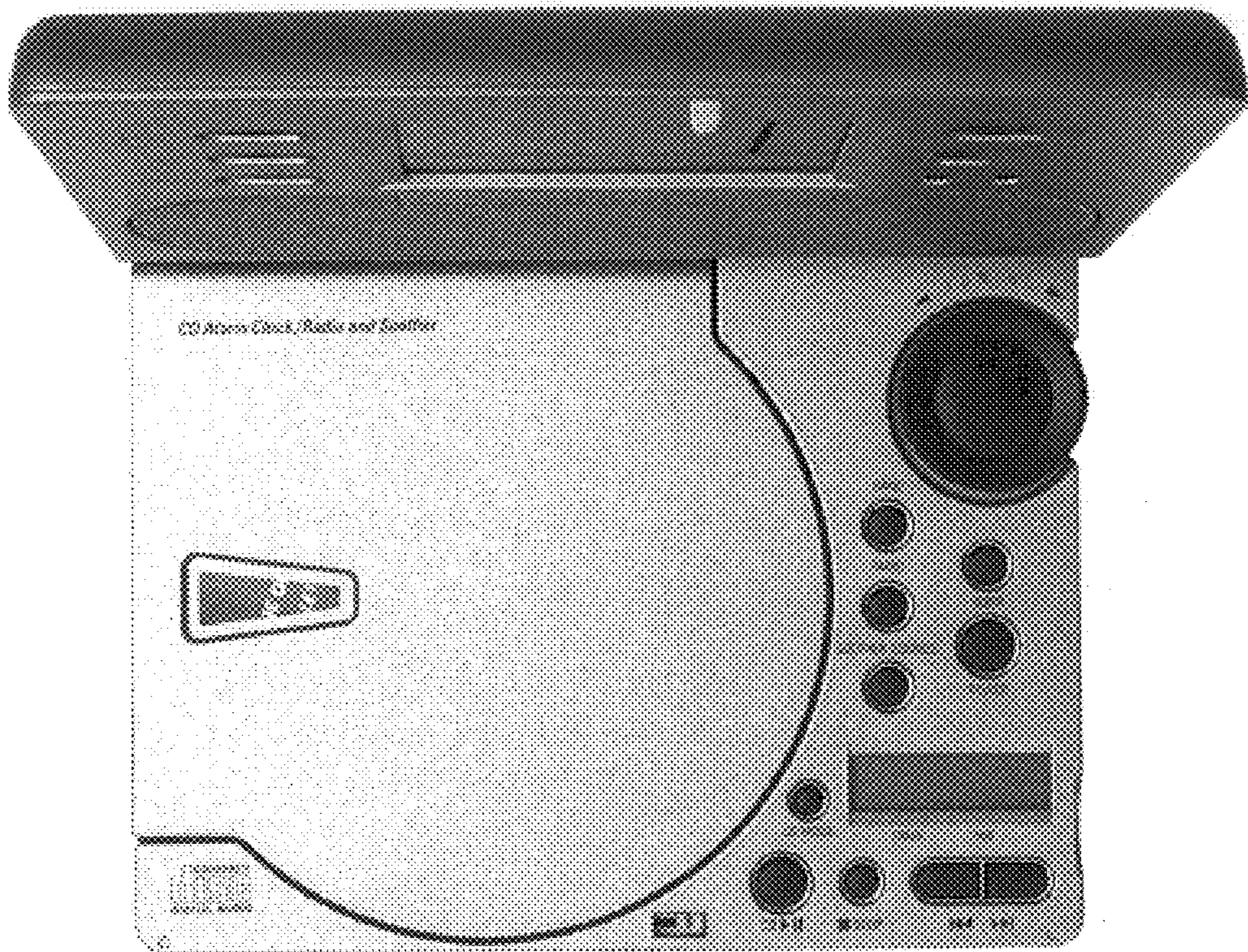

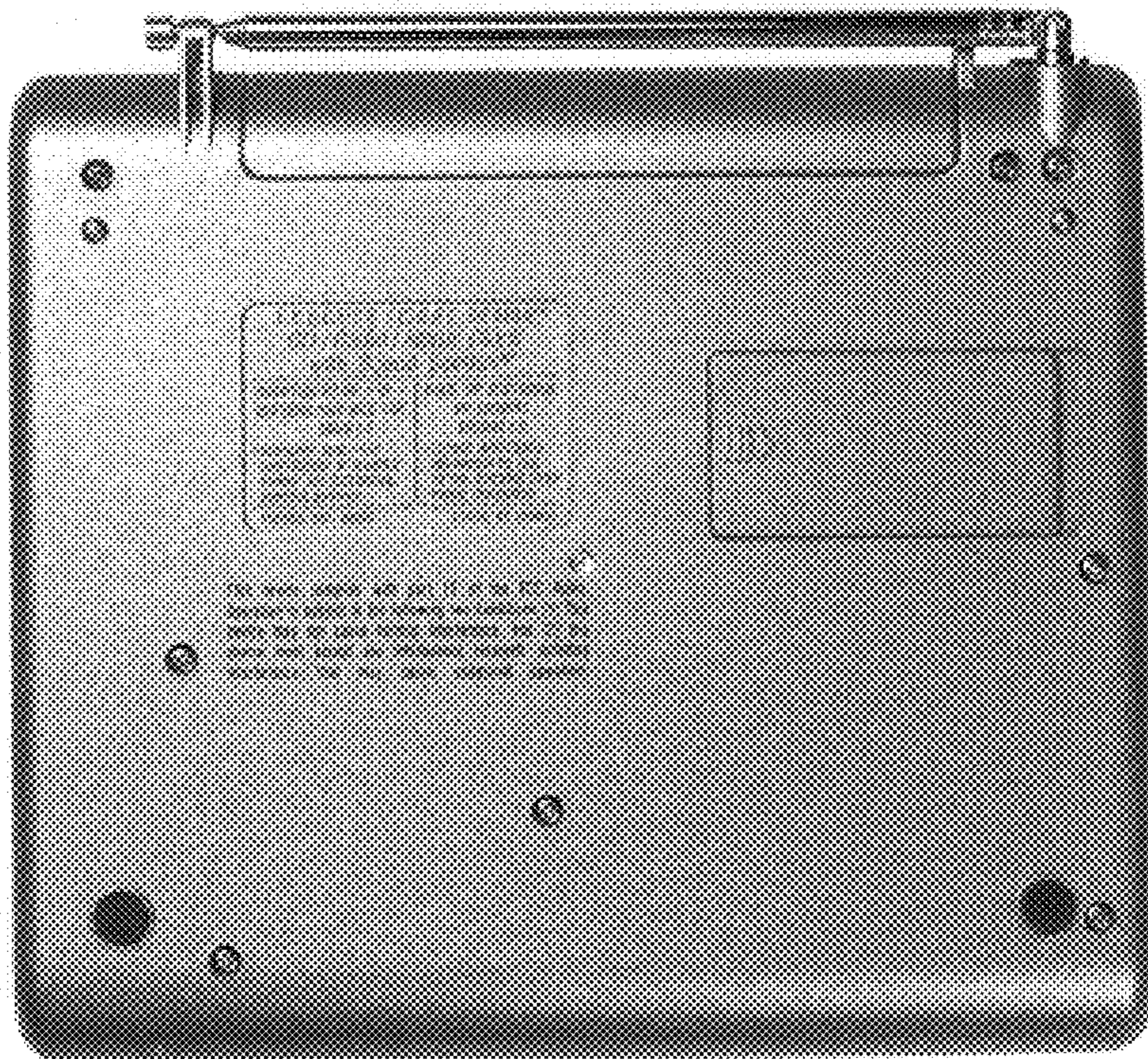

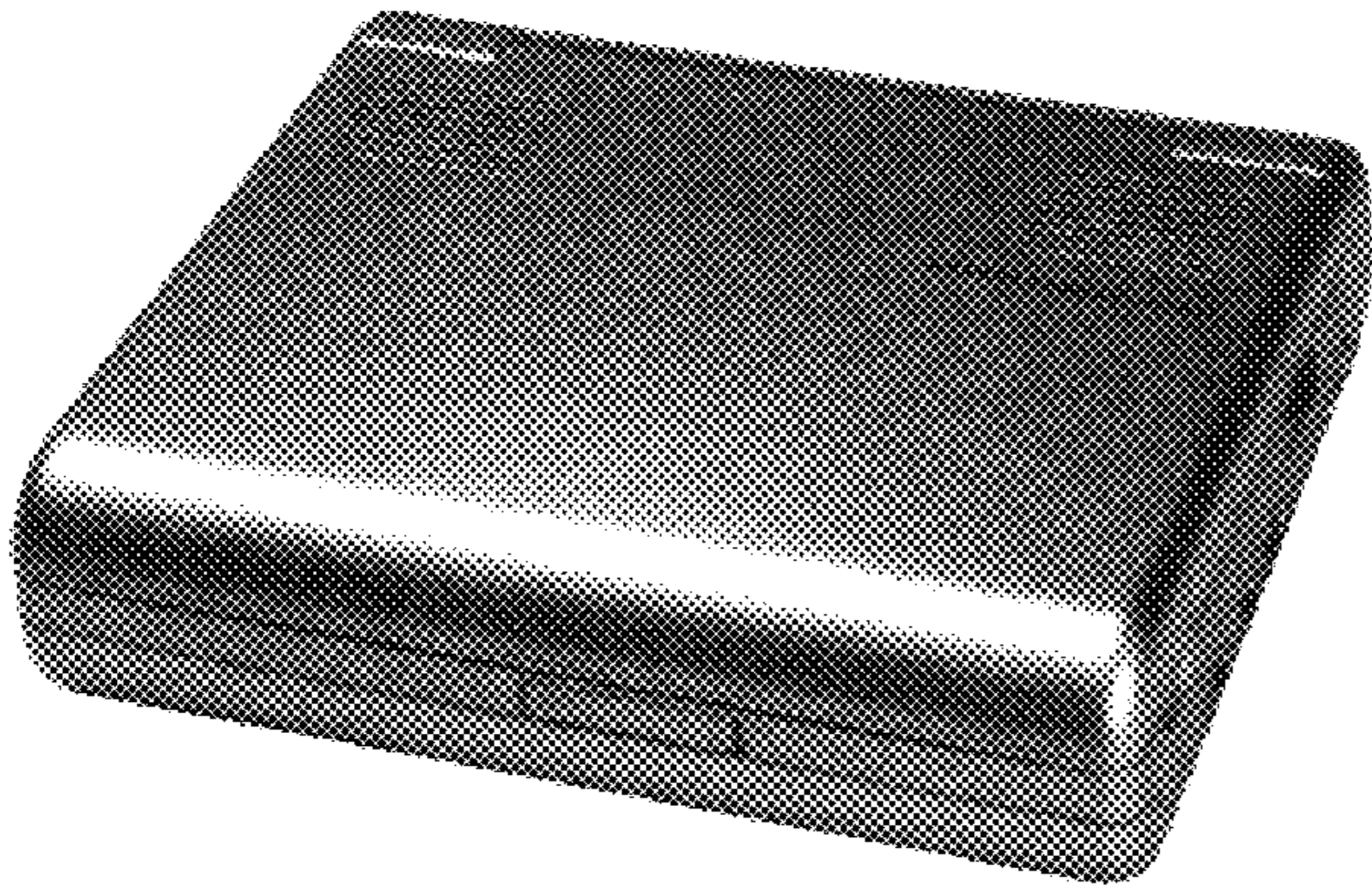

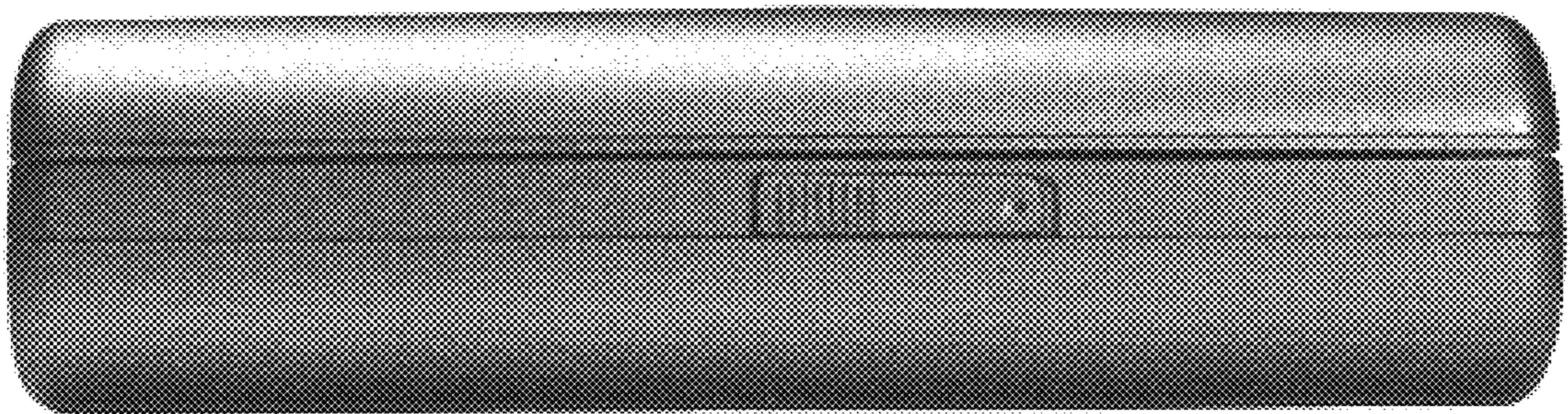

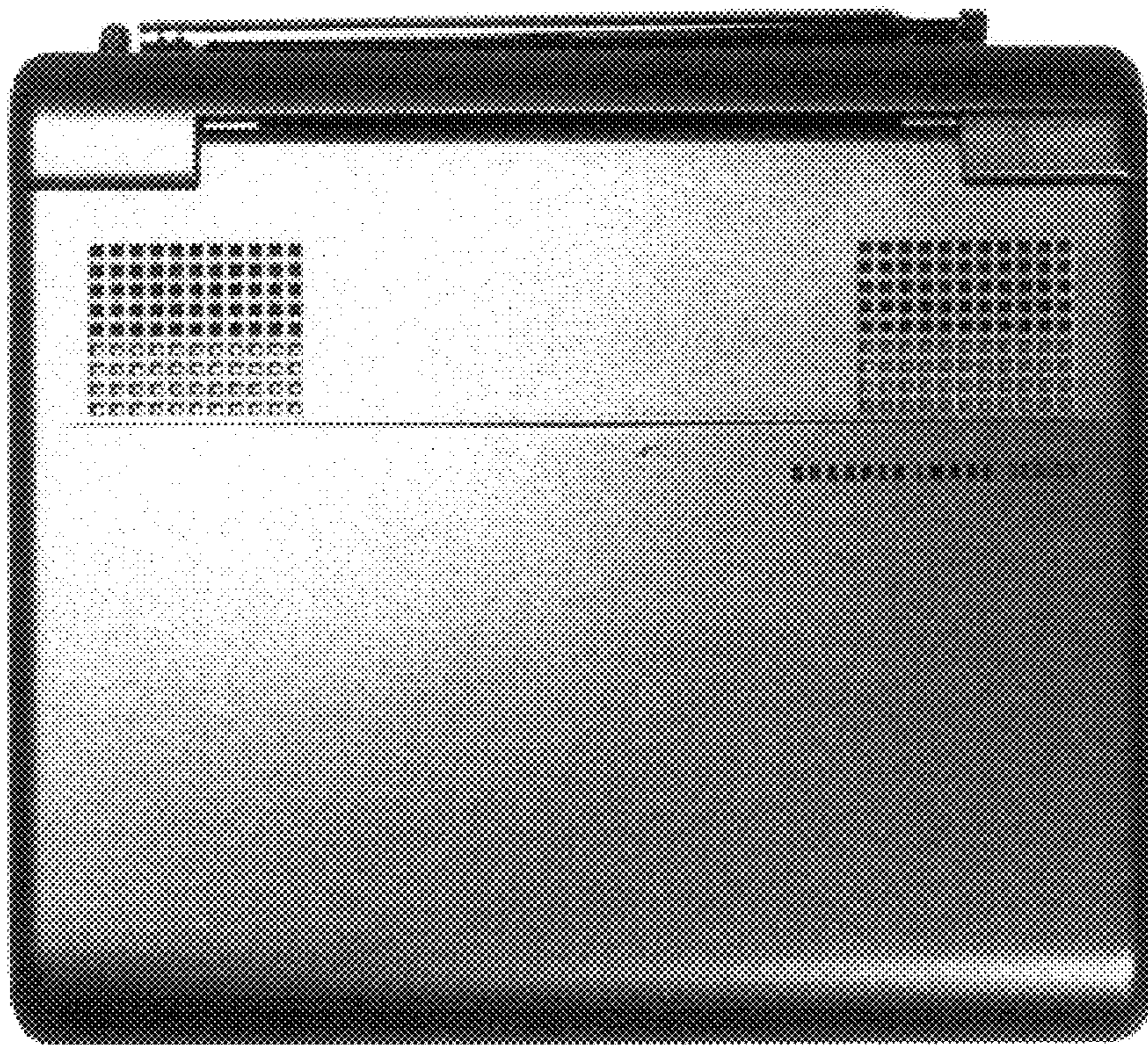

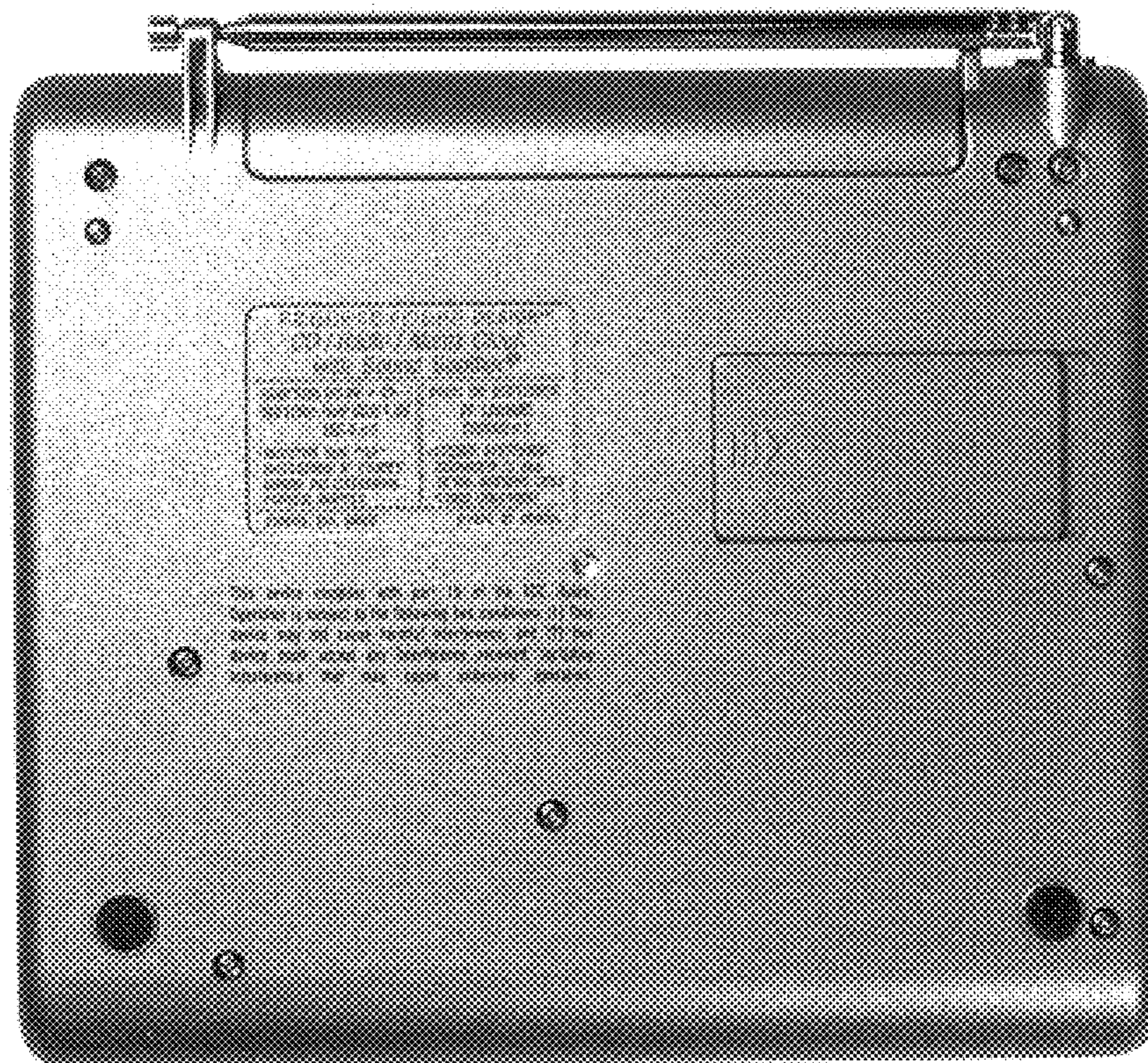
