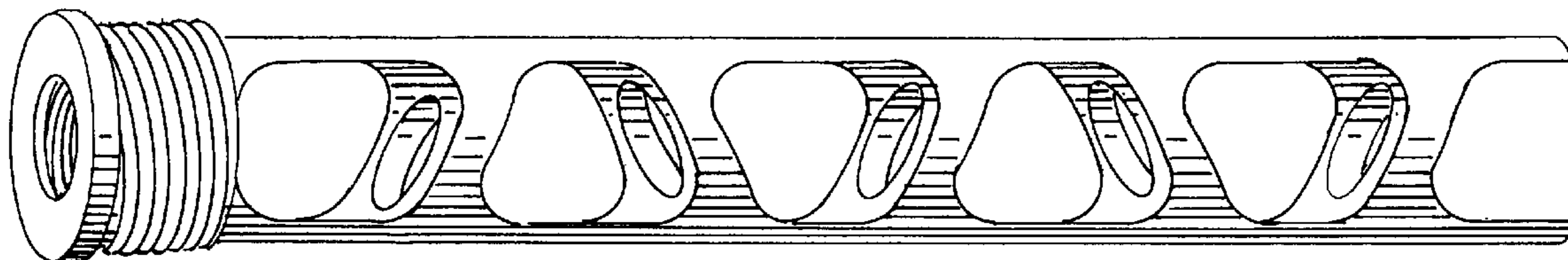
[57] CLAIM

The ornamental design for a firearms noise suppressor, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the firearms noise suppressor showing our new design;
FIG. 2 is a rear perspective view of the firearms noise suppressor;
FIG. 3 is a side elevation view of the firearms noise suppressor;
FIG. 4 is a top plan view of the firearms noise suppressor;
FIG. 5 is bottom plan view of the firearms noise suppressor;
FIG. 6 is a front end view of the firearms noise suppressor; and,
FIG. 7 is a rear view of the firearms noise suppressor.

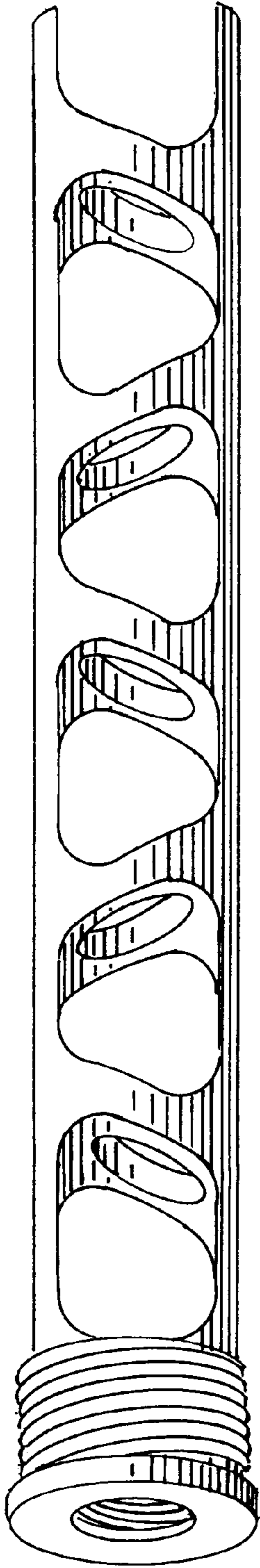

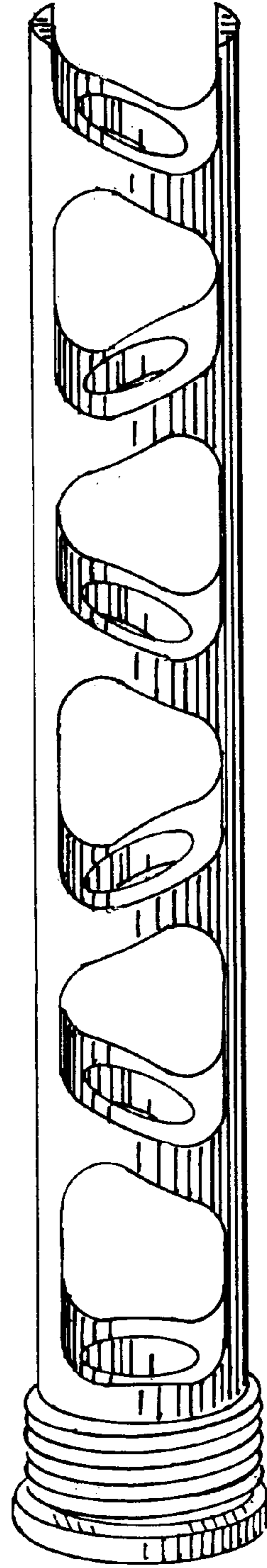

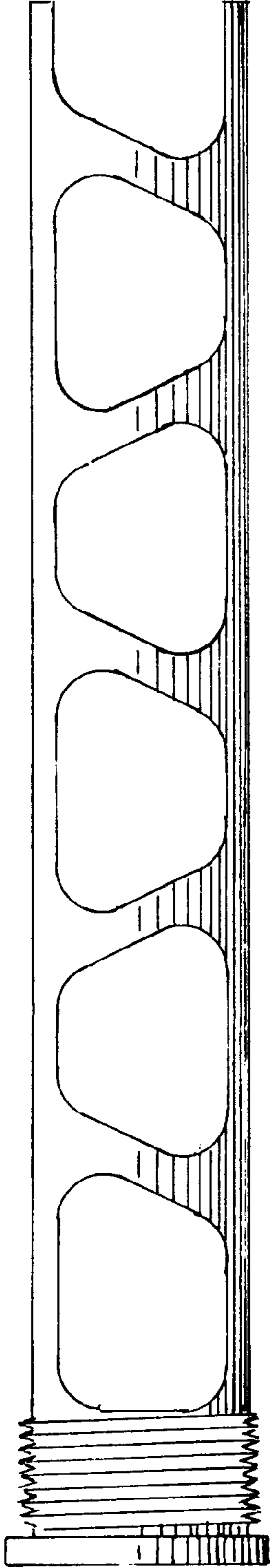

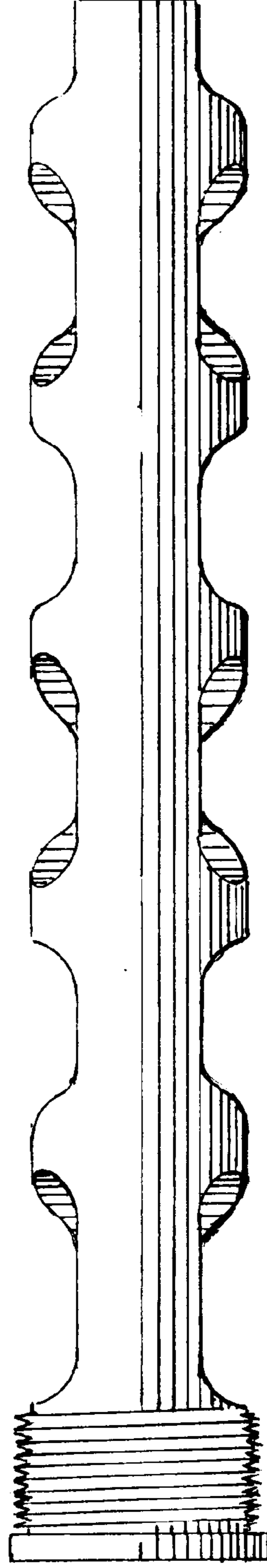

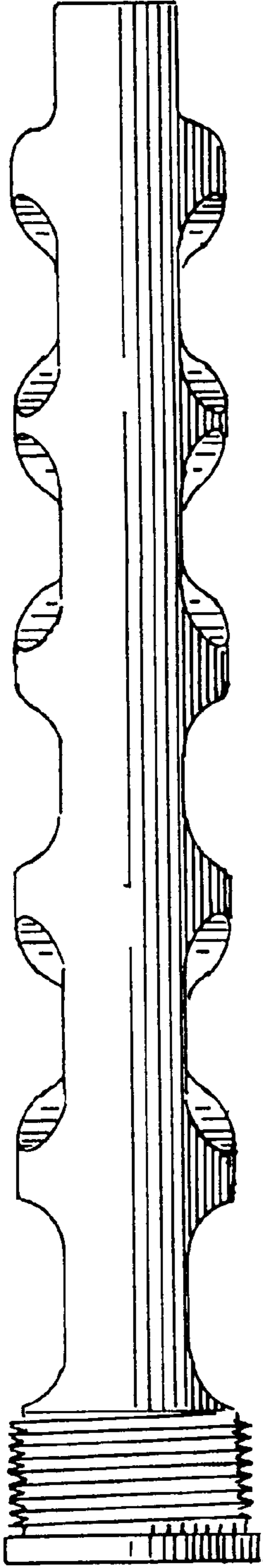

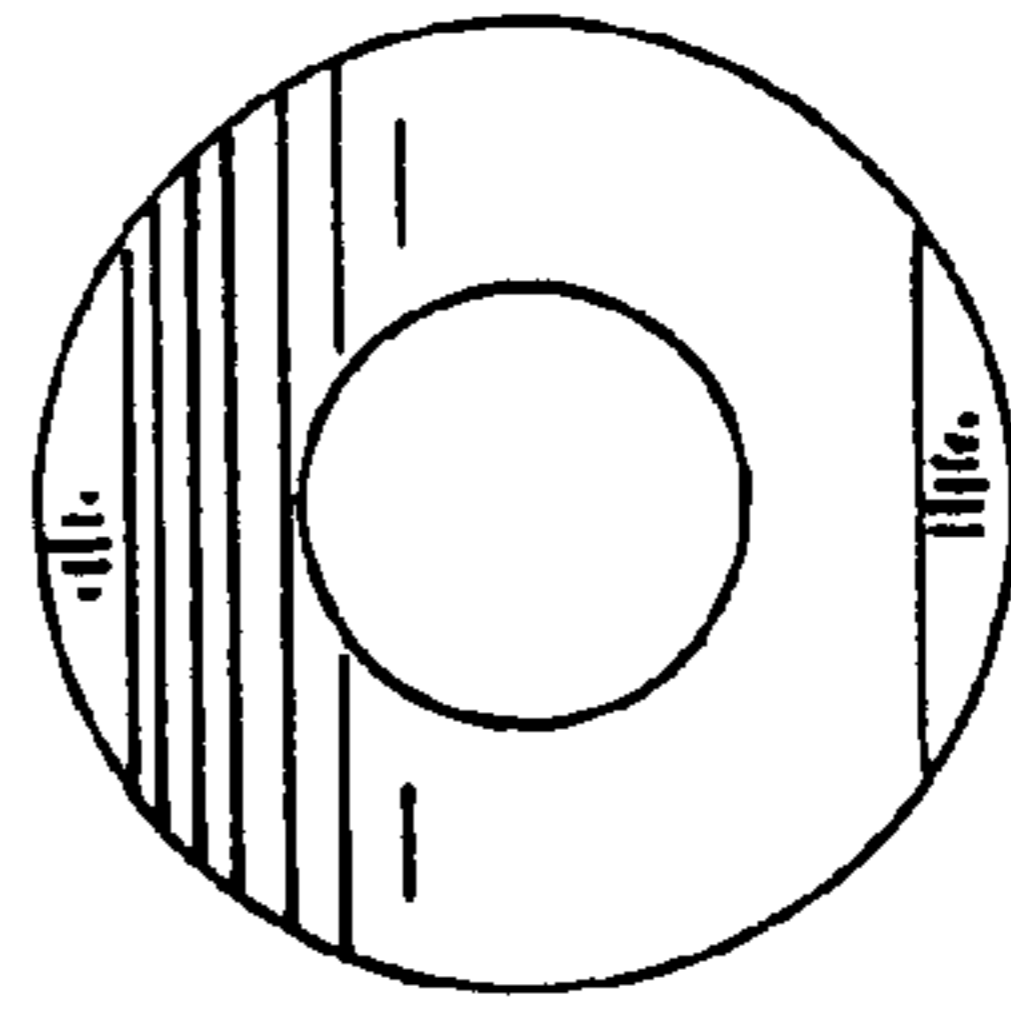

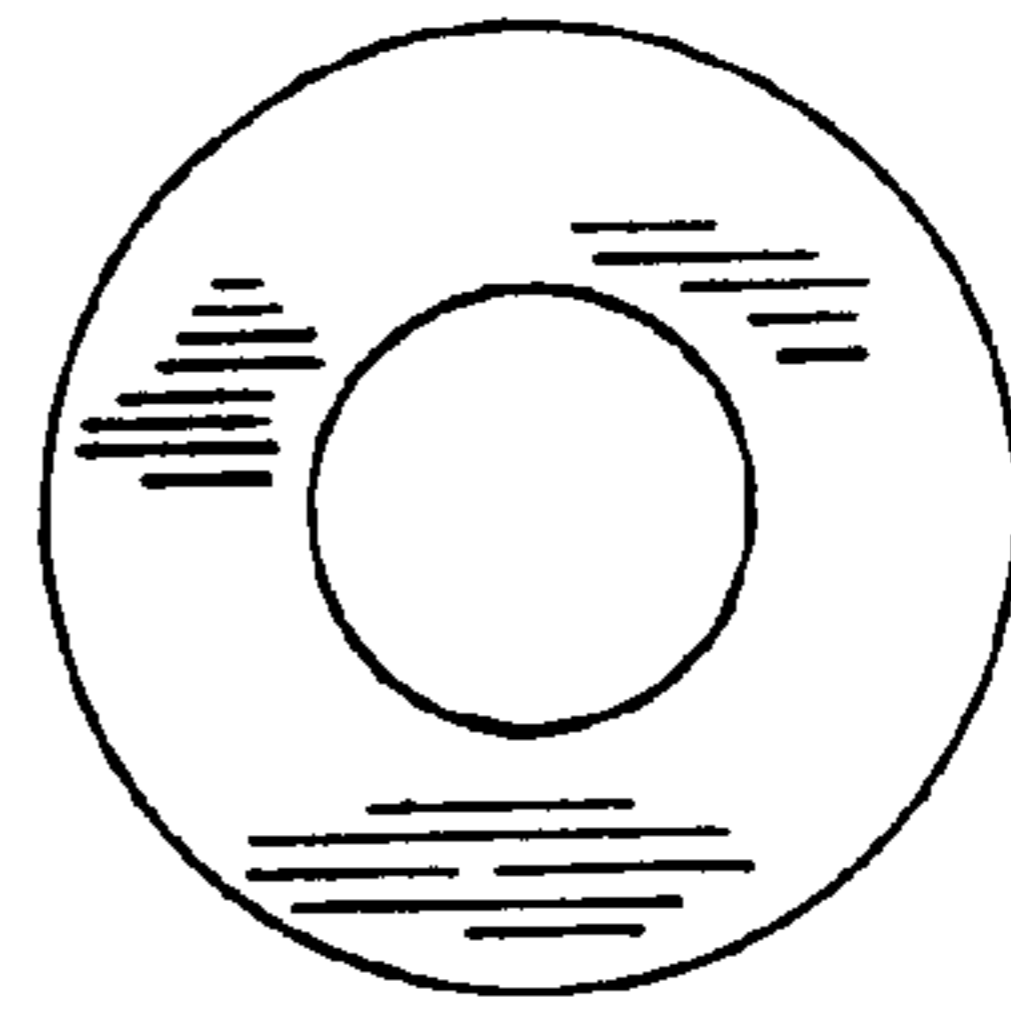
