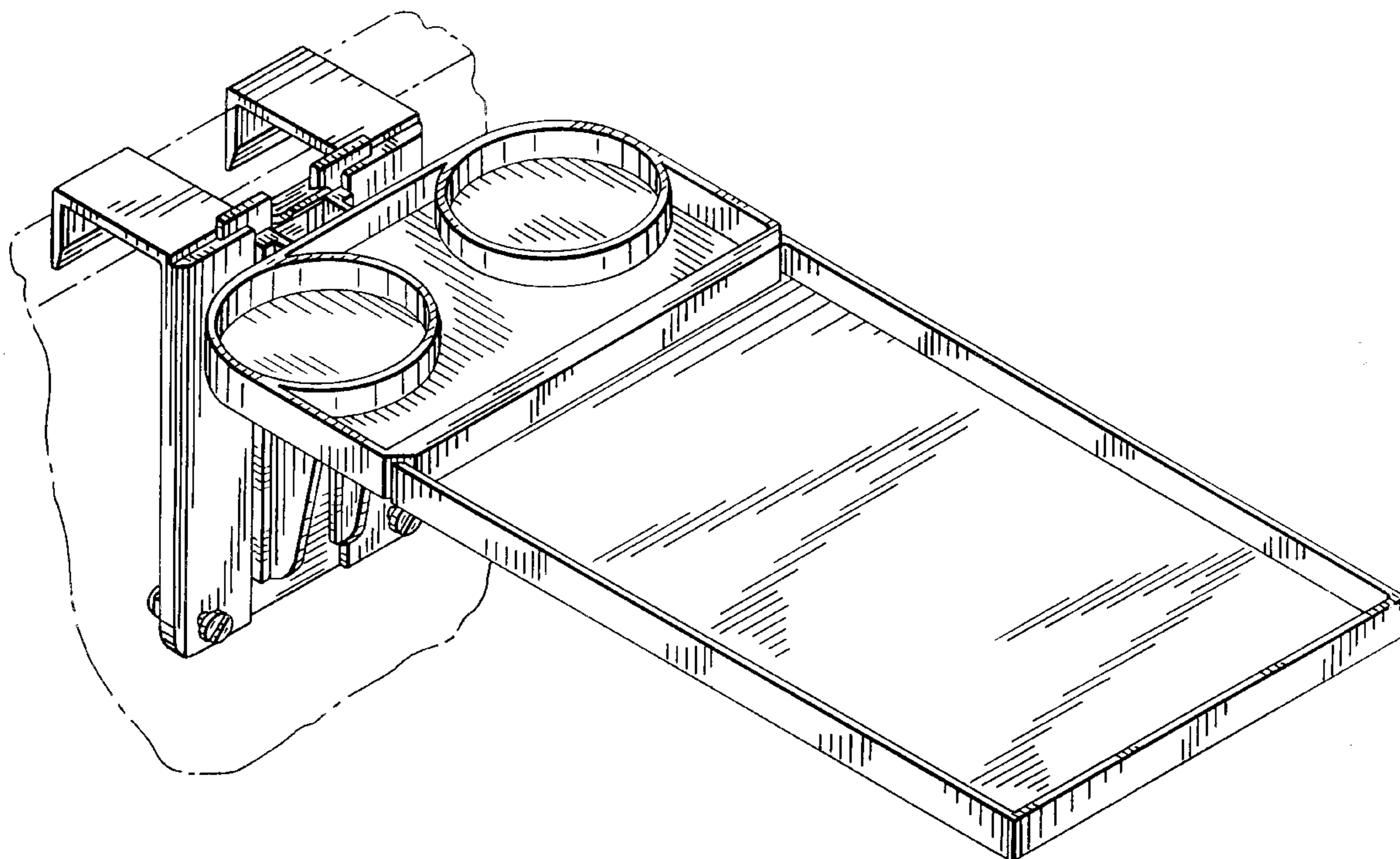

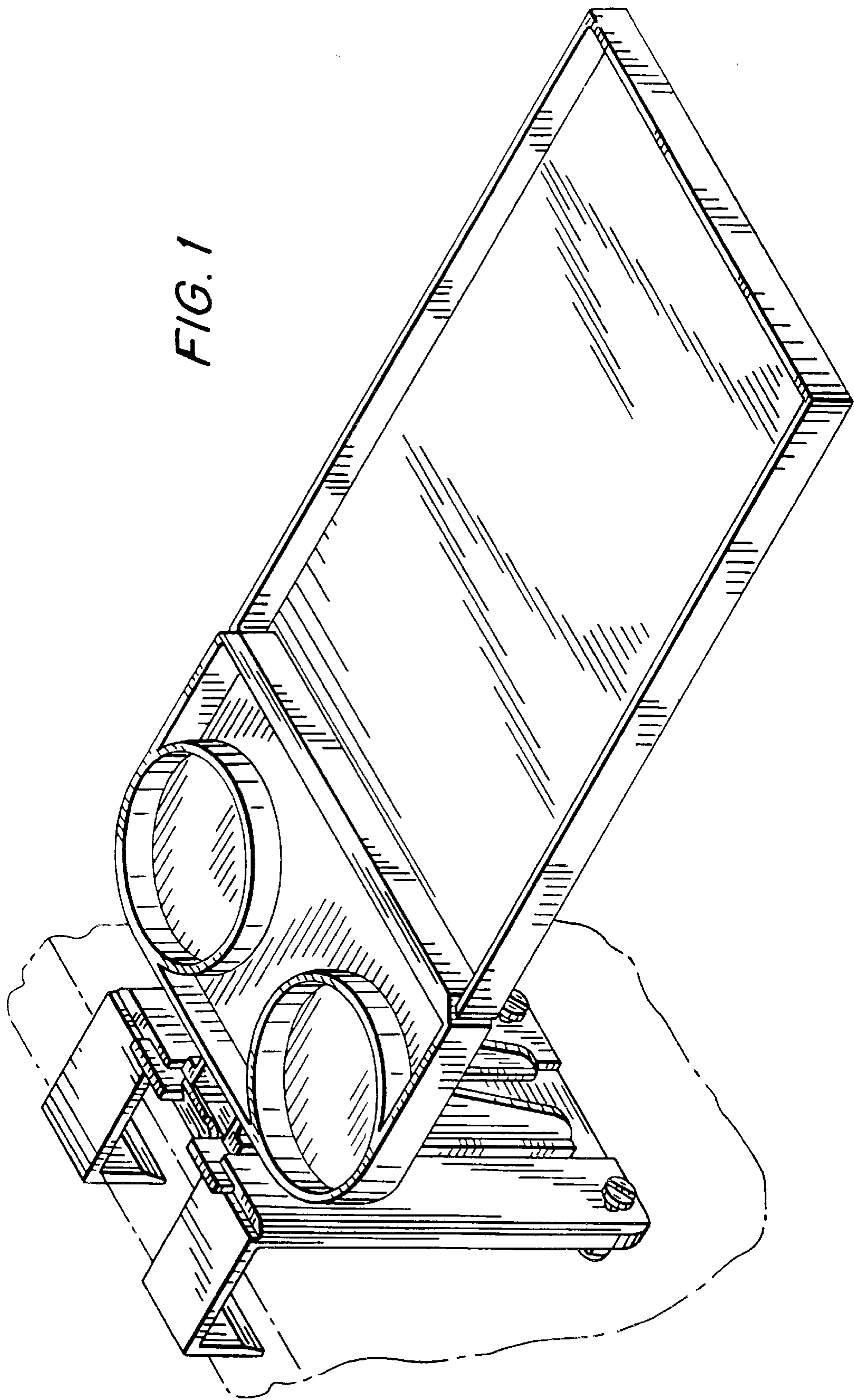
The ornamental design for an adjustable food and beverage car tray, as shown and described.

DESCRIPTION

FIG. 1 is a top, side and front perspective view of an adjustable food and beverage car tray, showing my new design;
FIG. 2 is a top view thereof.

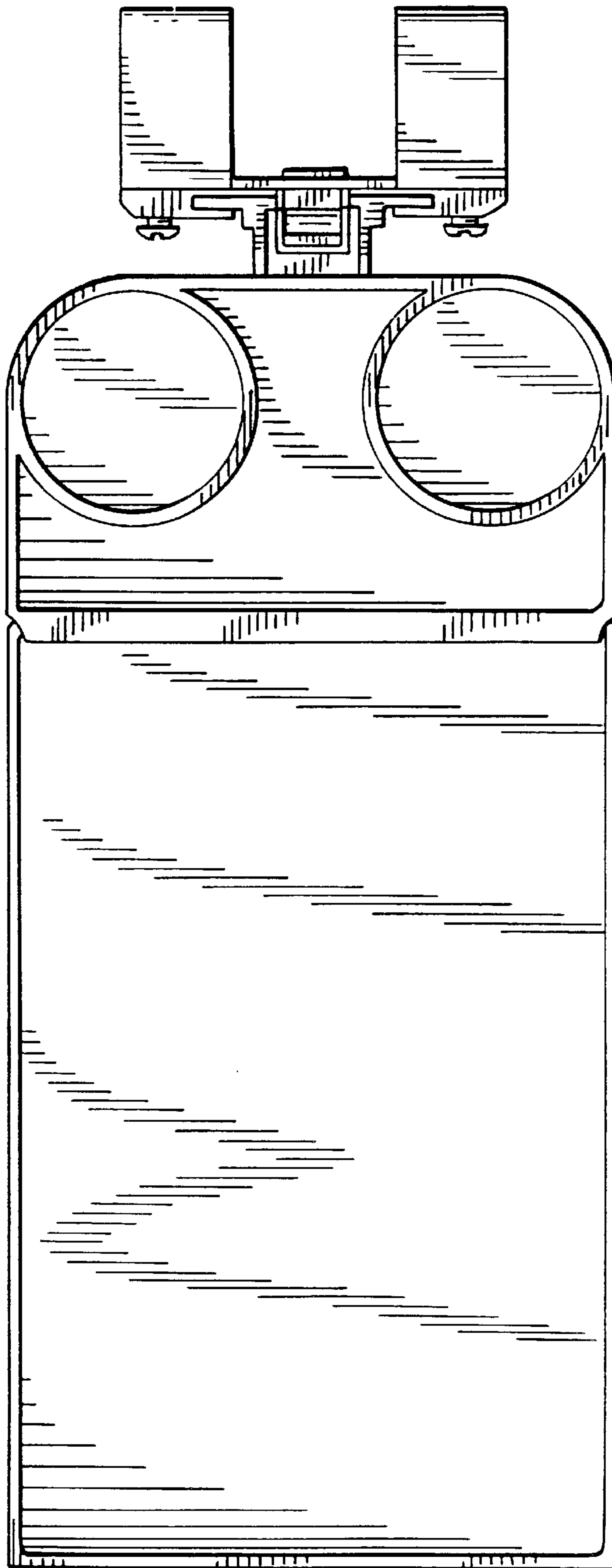

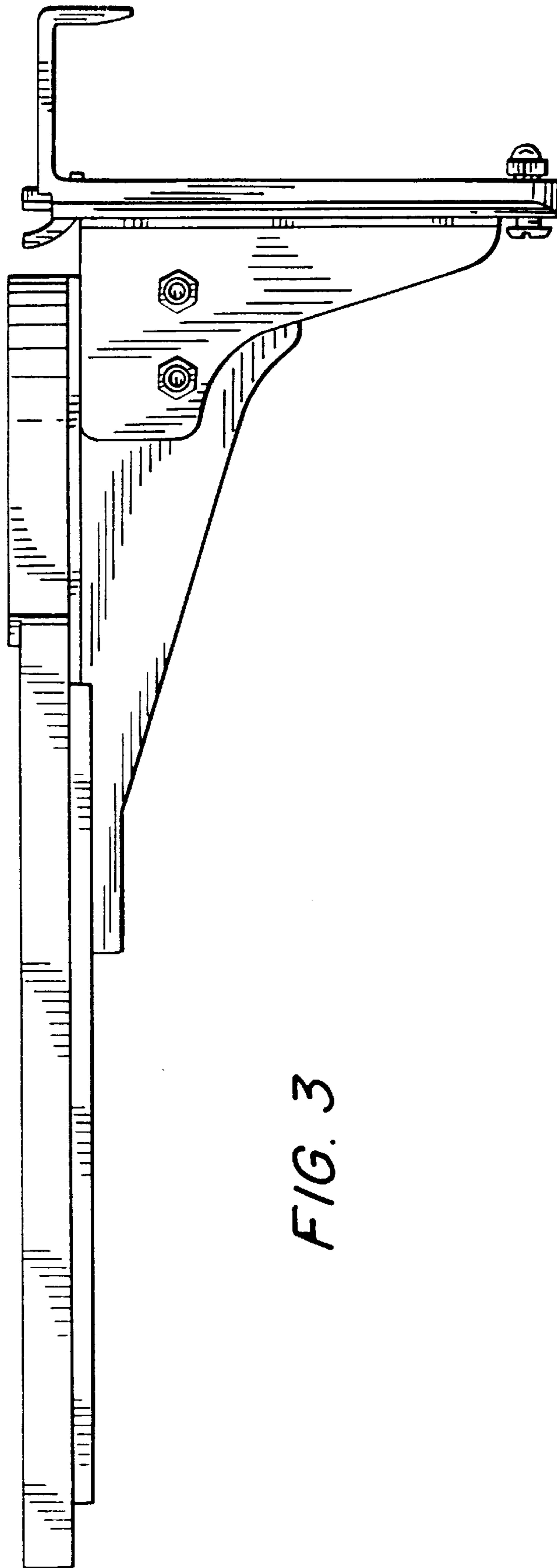

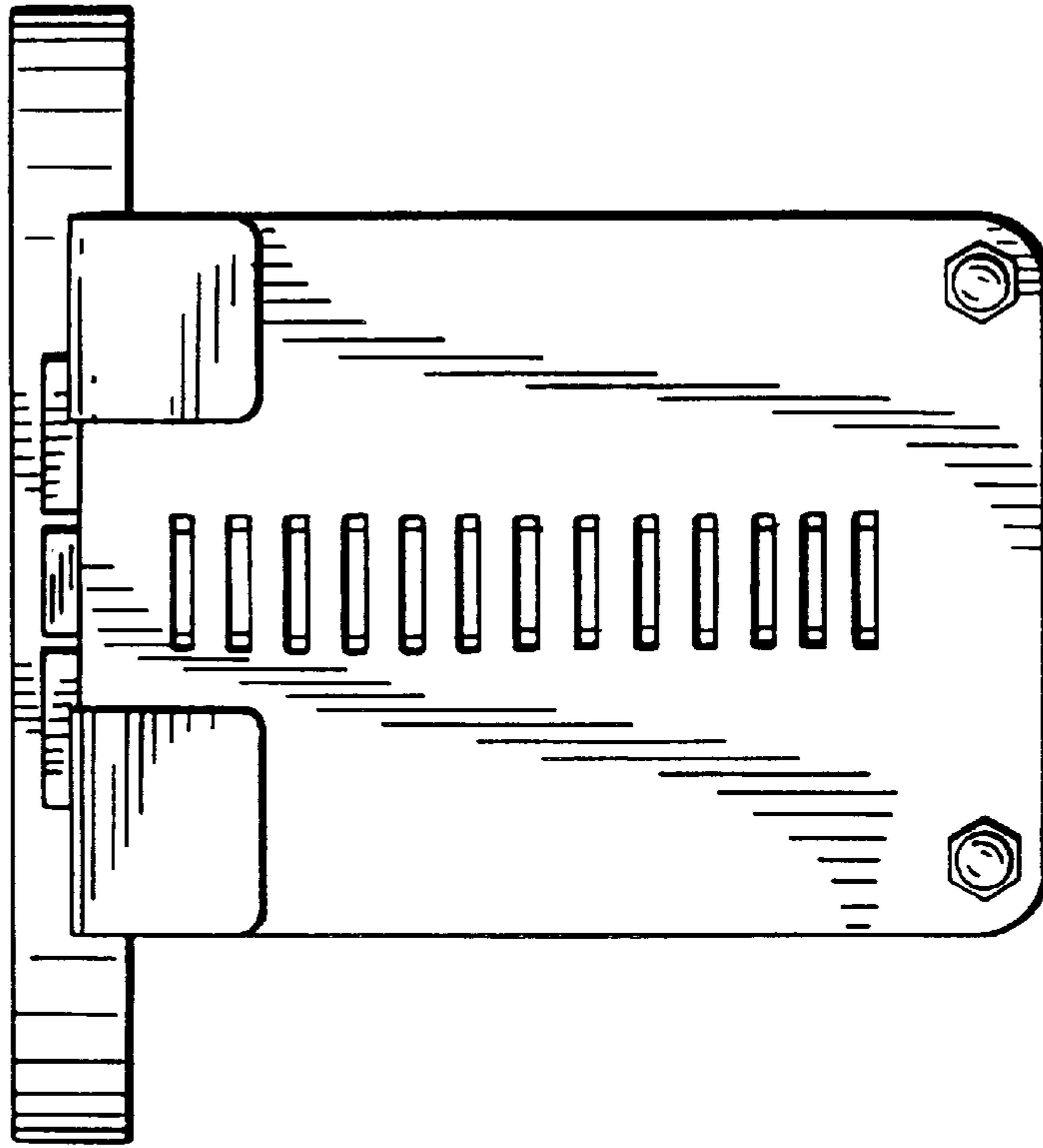
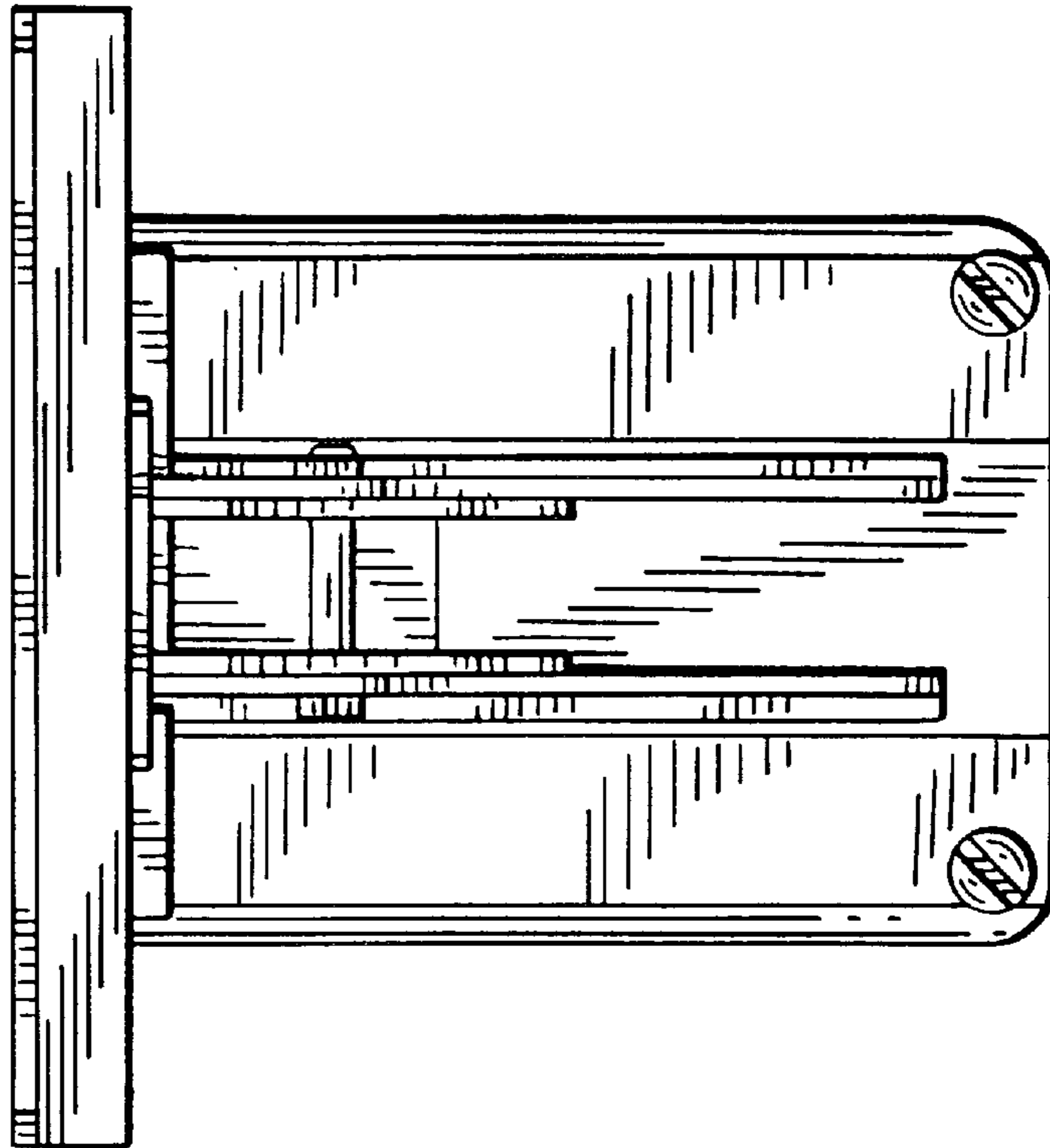

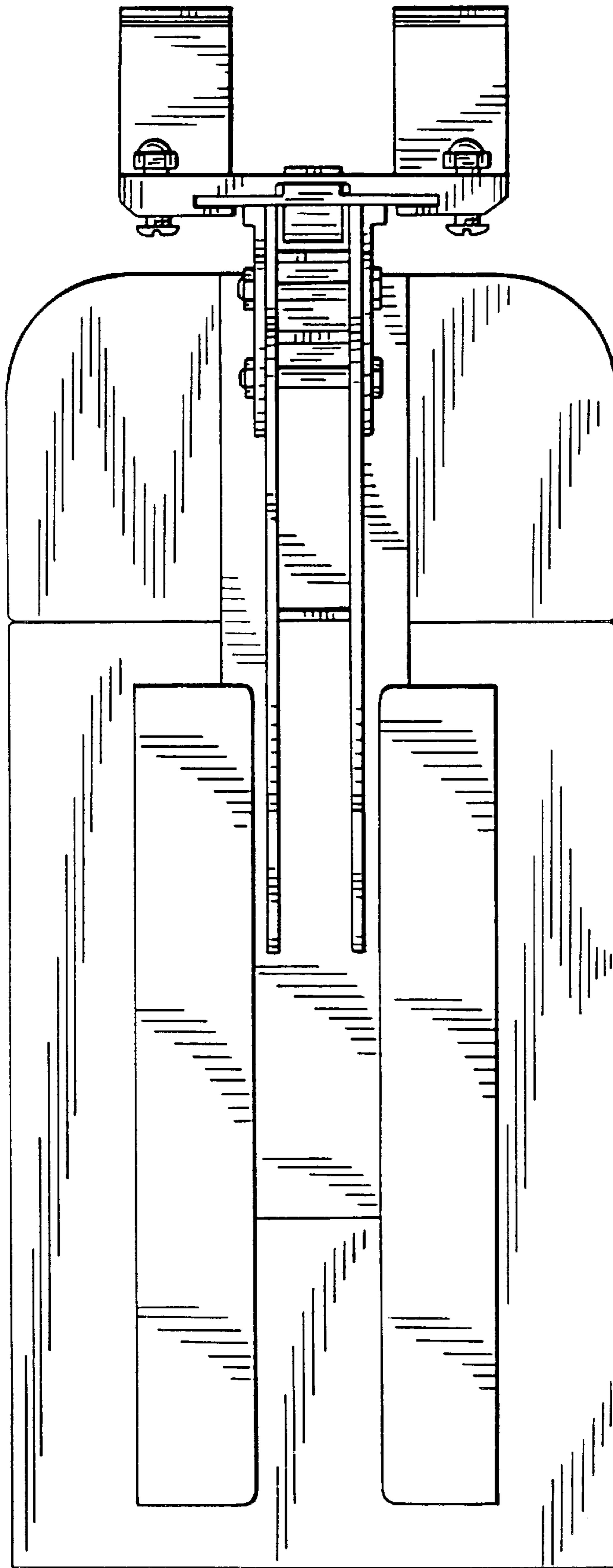
