FIG. 10 is a front view thereof;

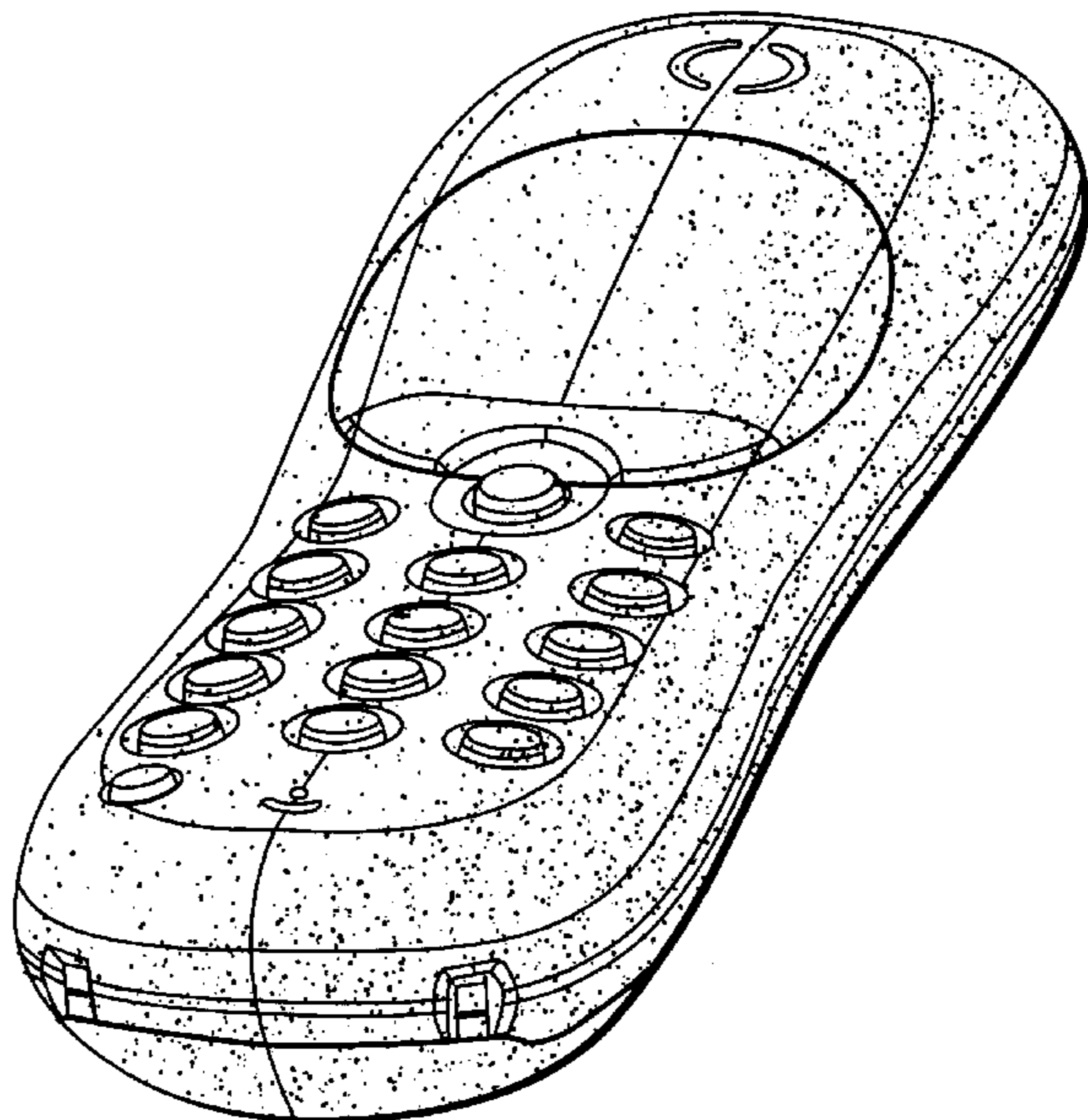
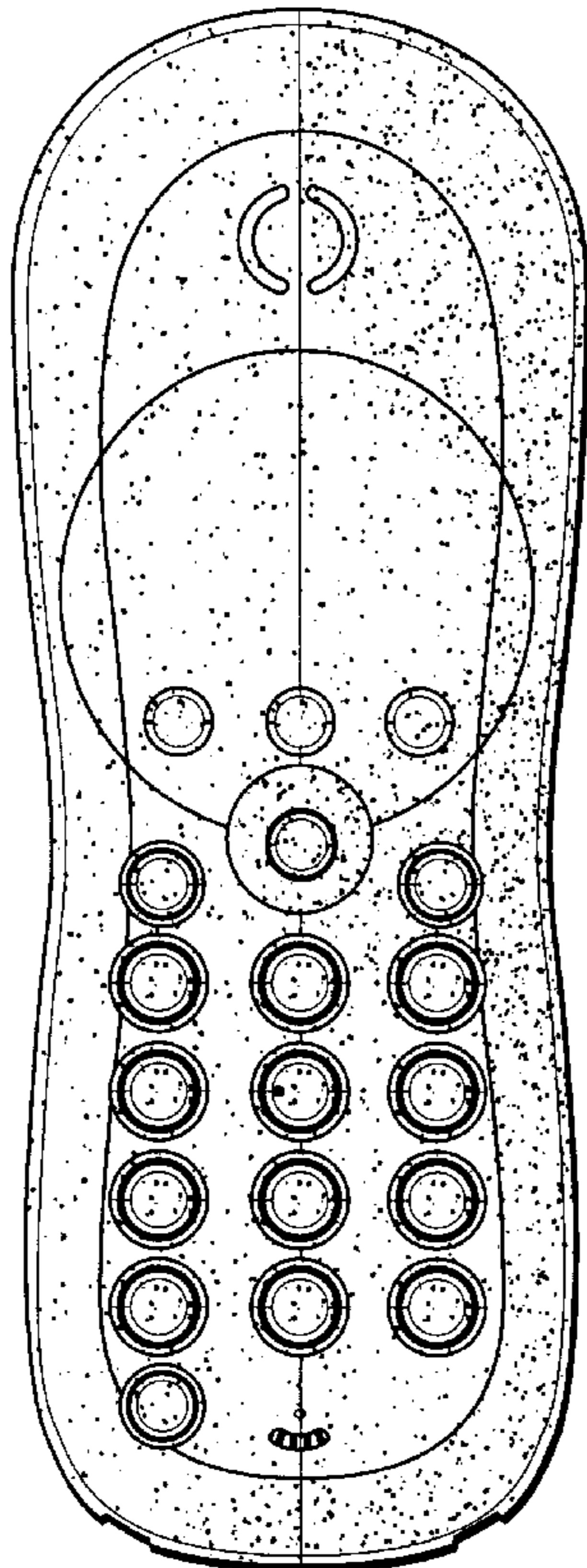
FIG. 11 is a rear view thereof;

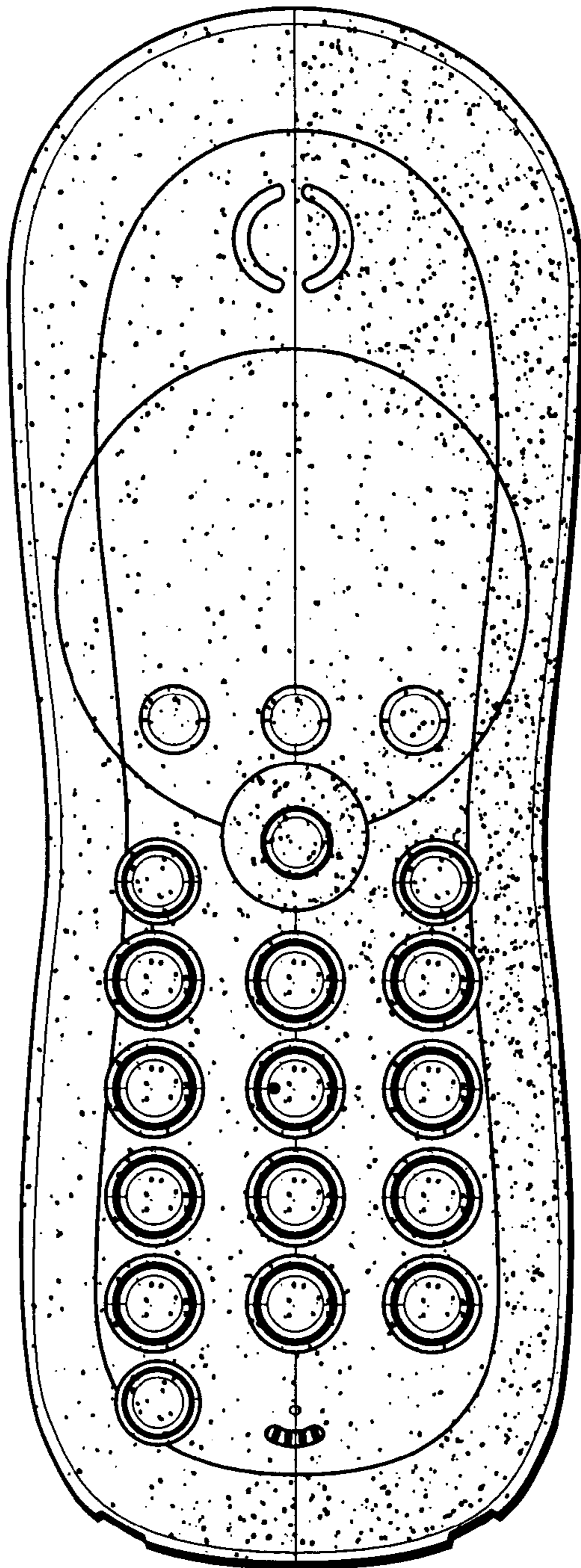
FIG. 12 is a left side view thereof;

FIG. 13 is a right side view thereof; and,

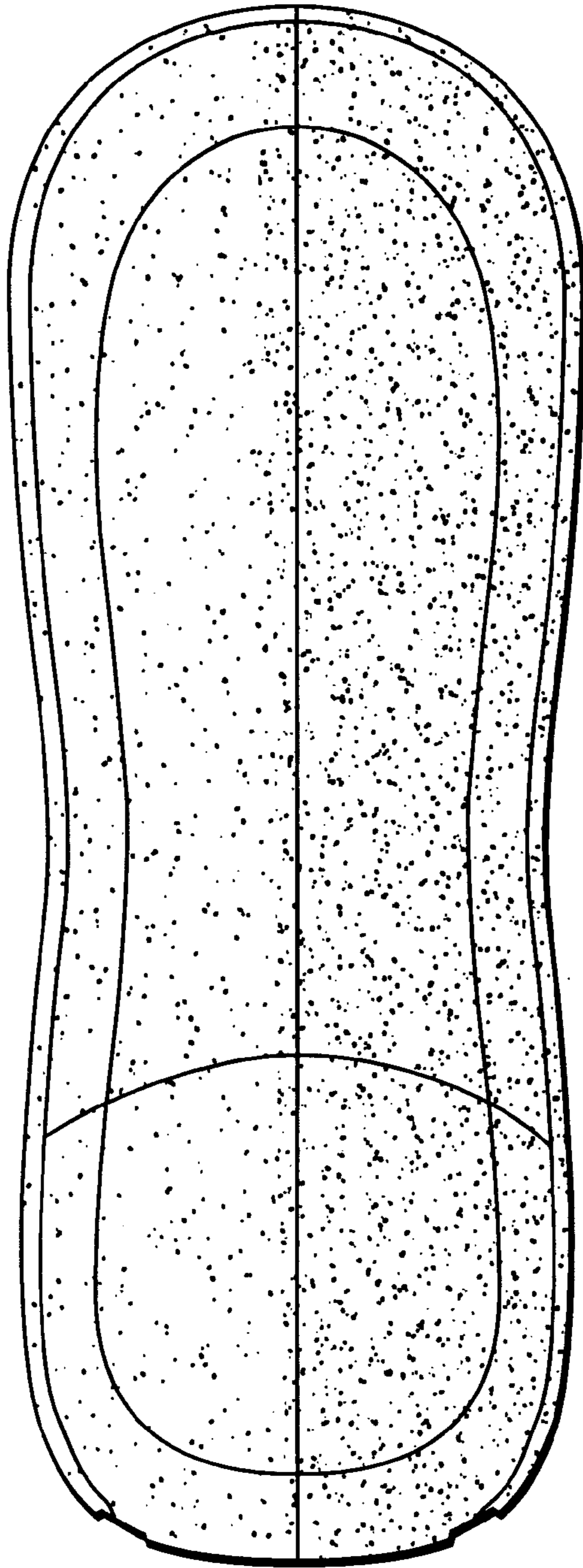
FIG. 14 is a top, right, front perspective view thereof.

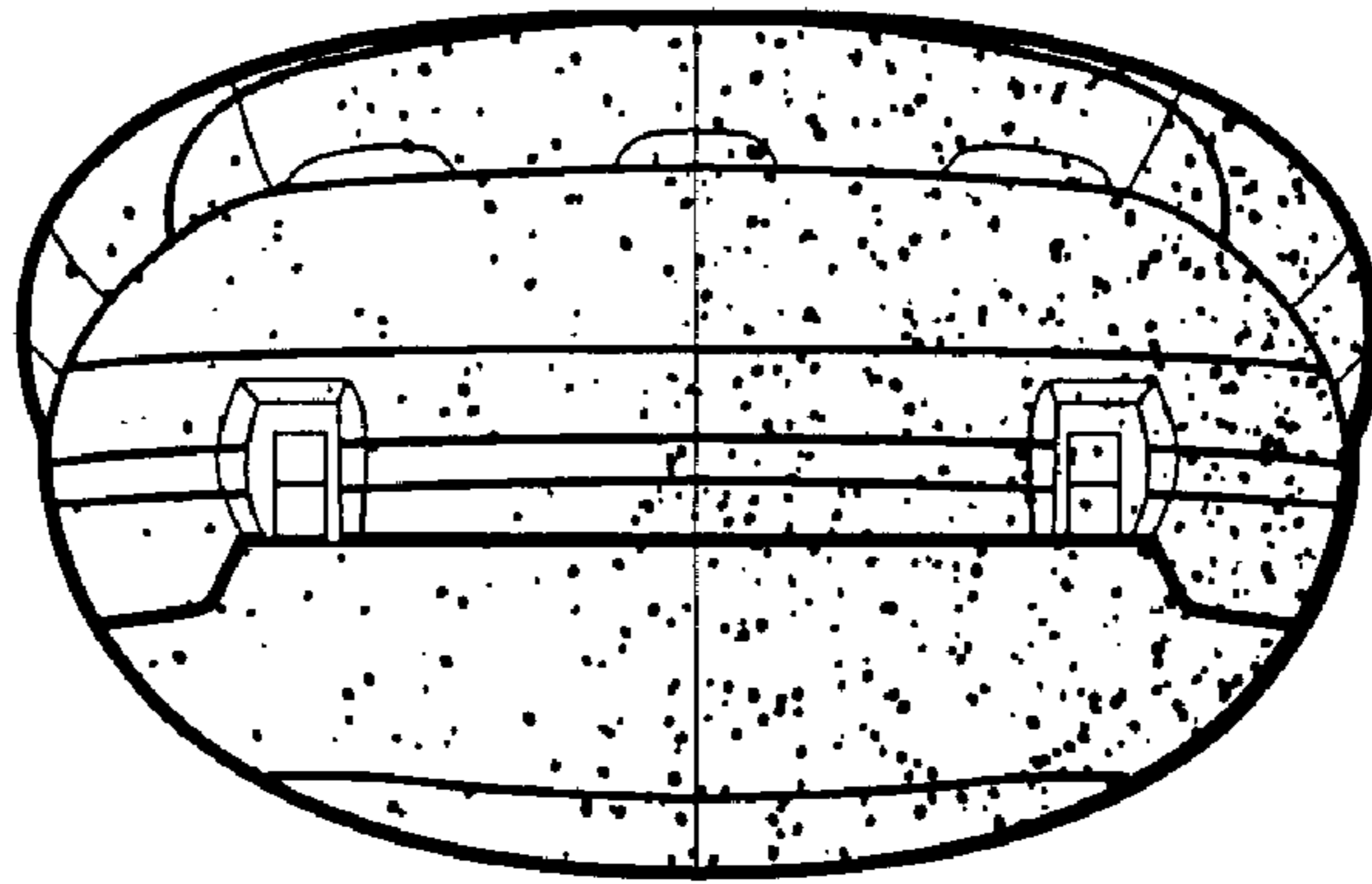




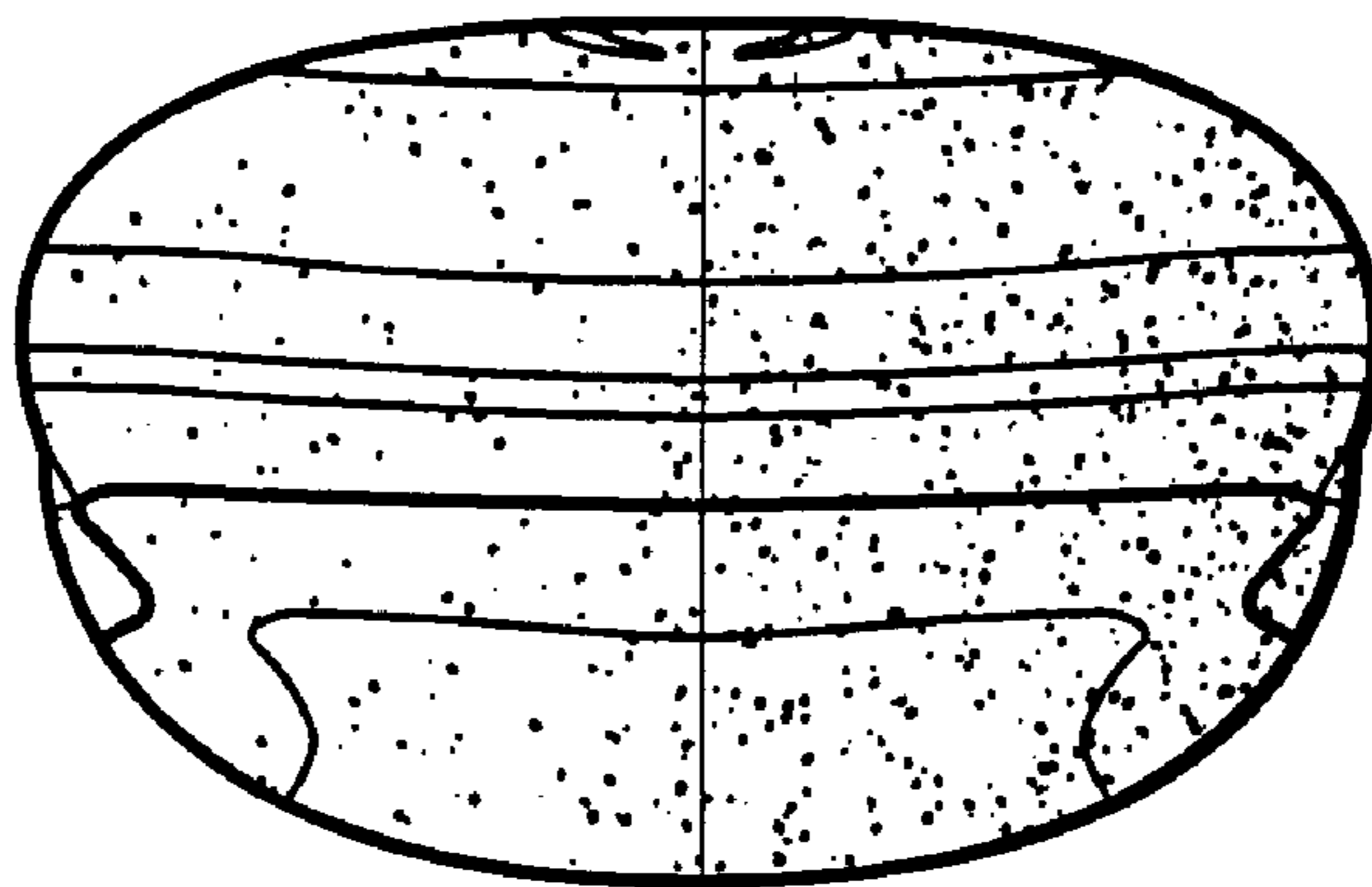

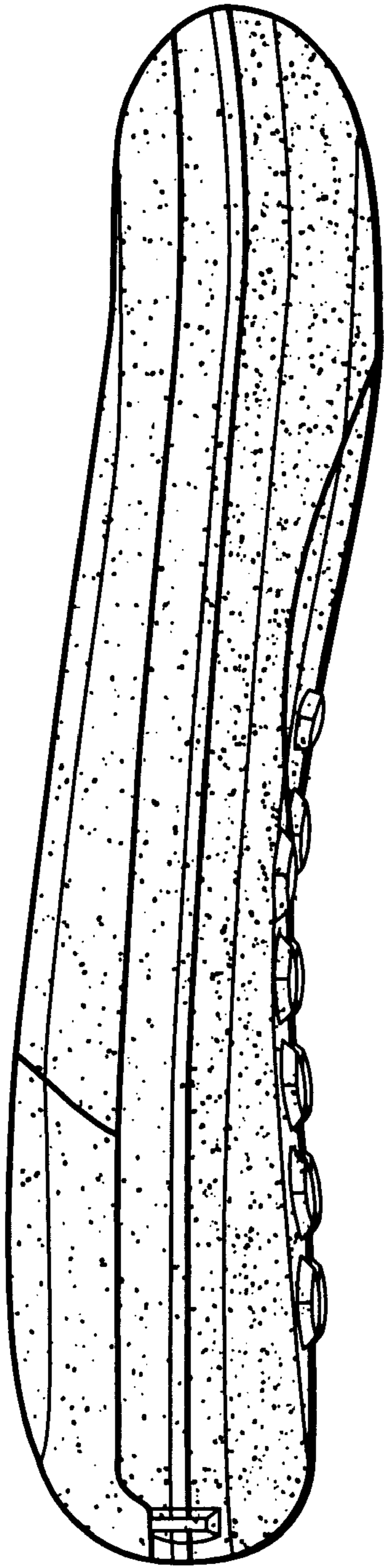

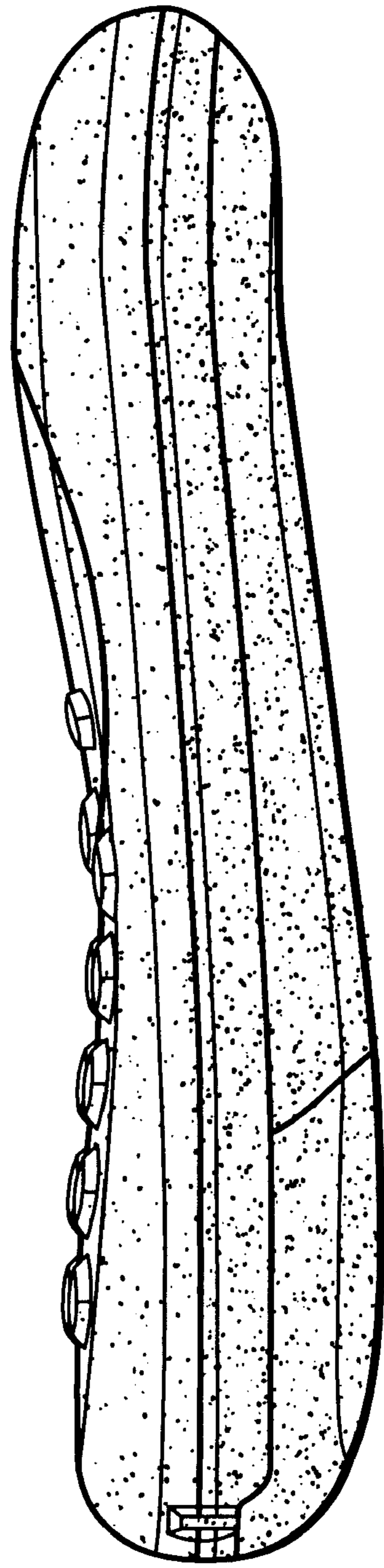

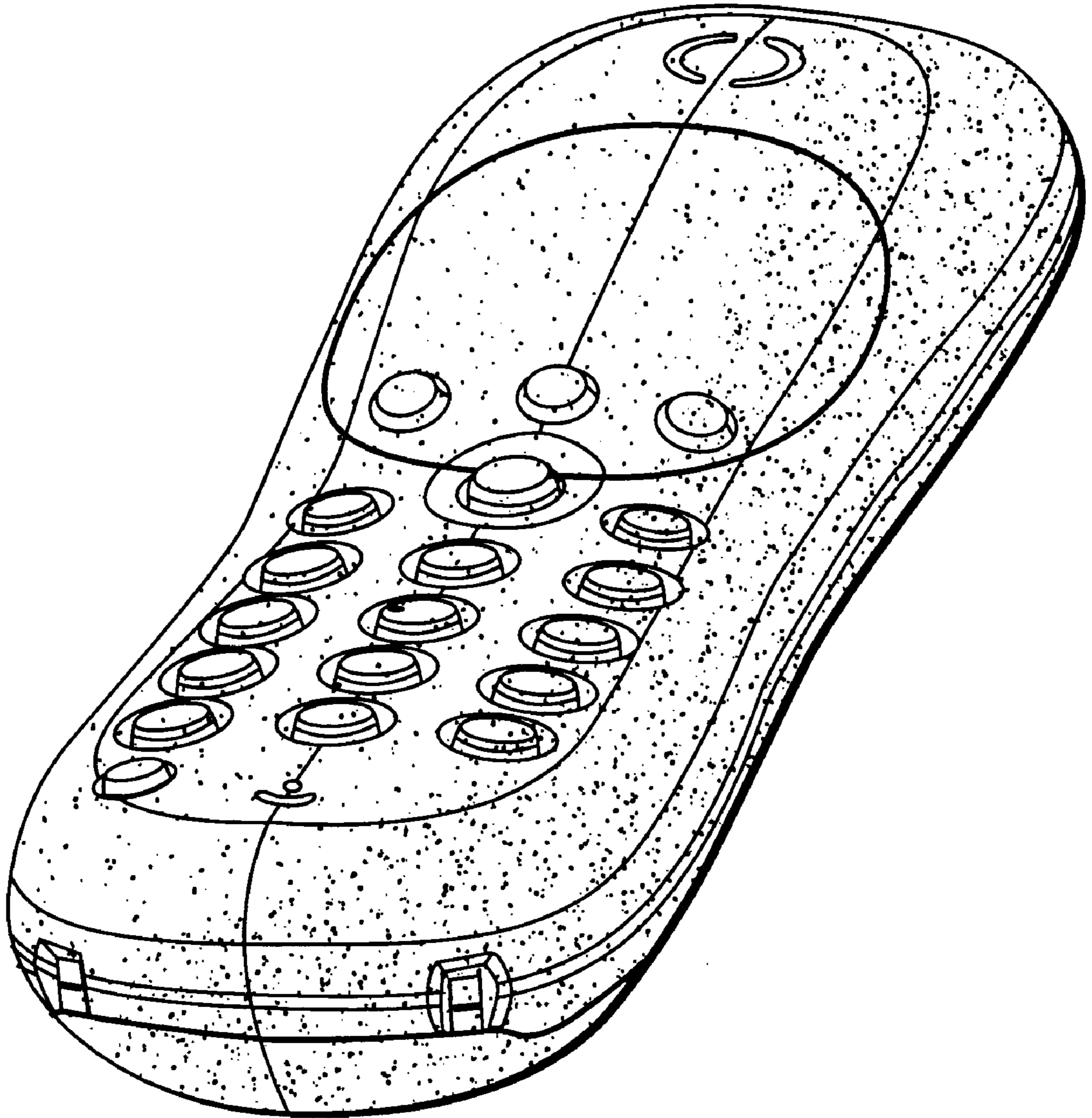

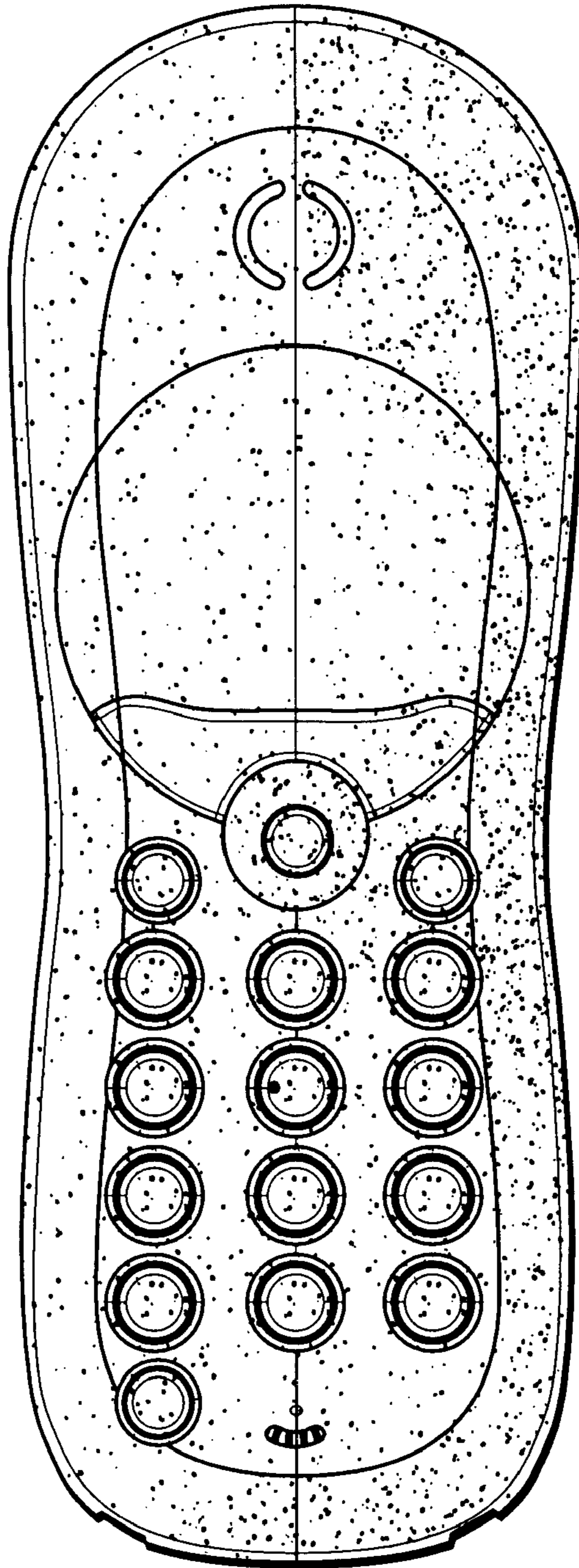

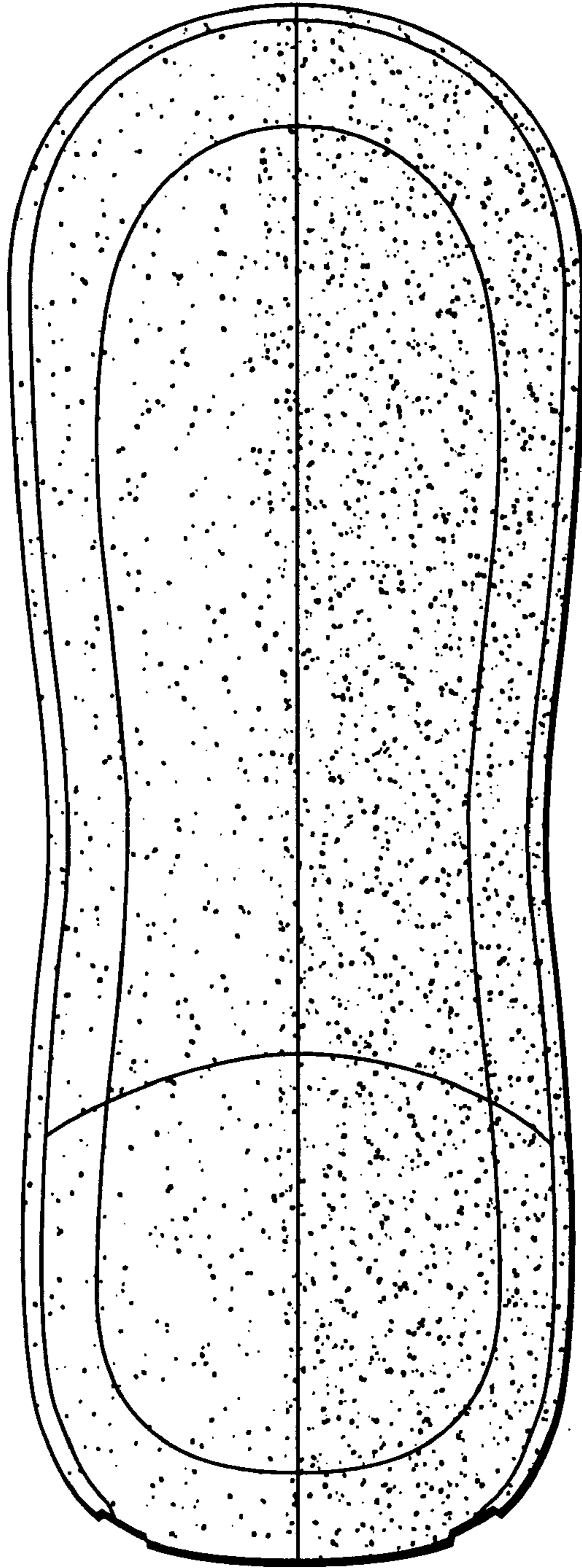

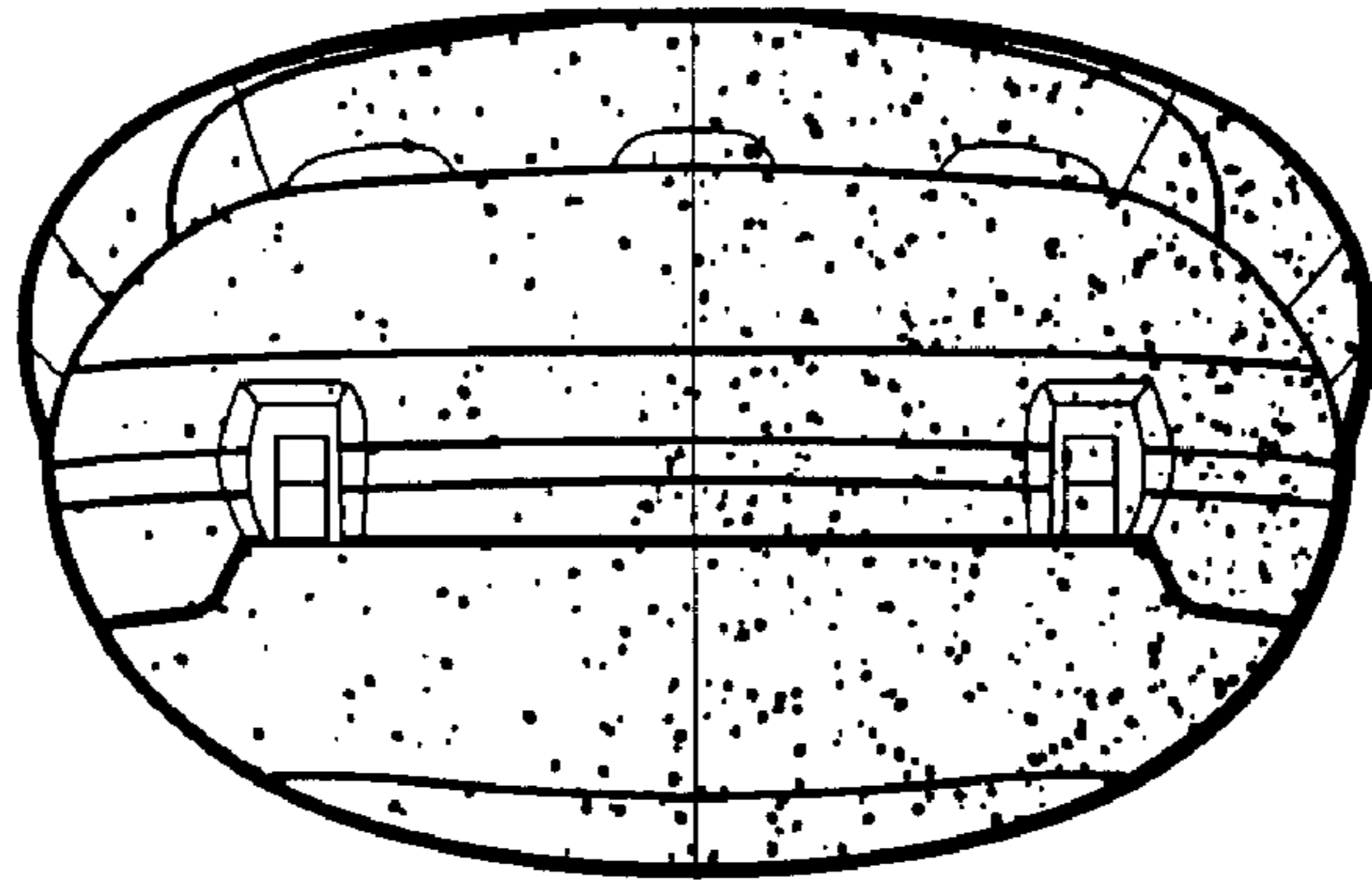

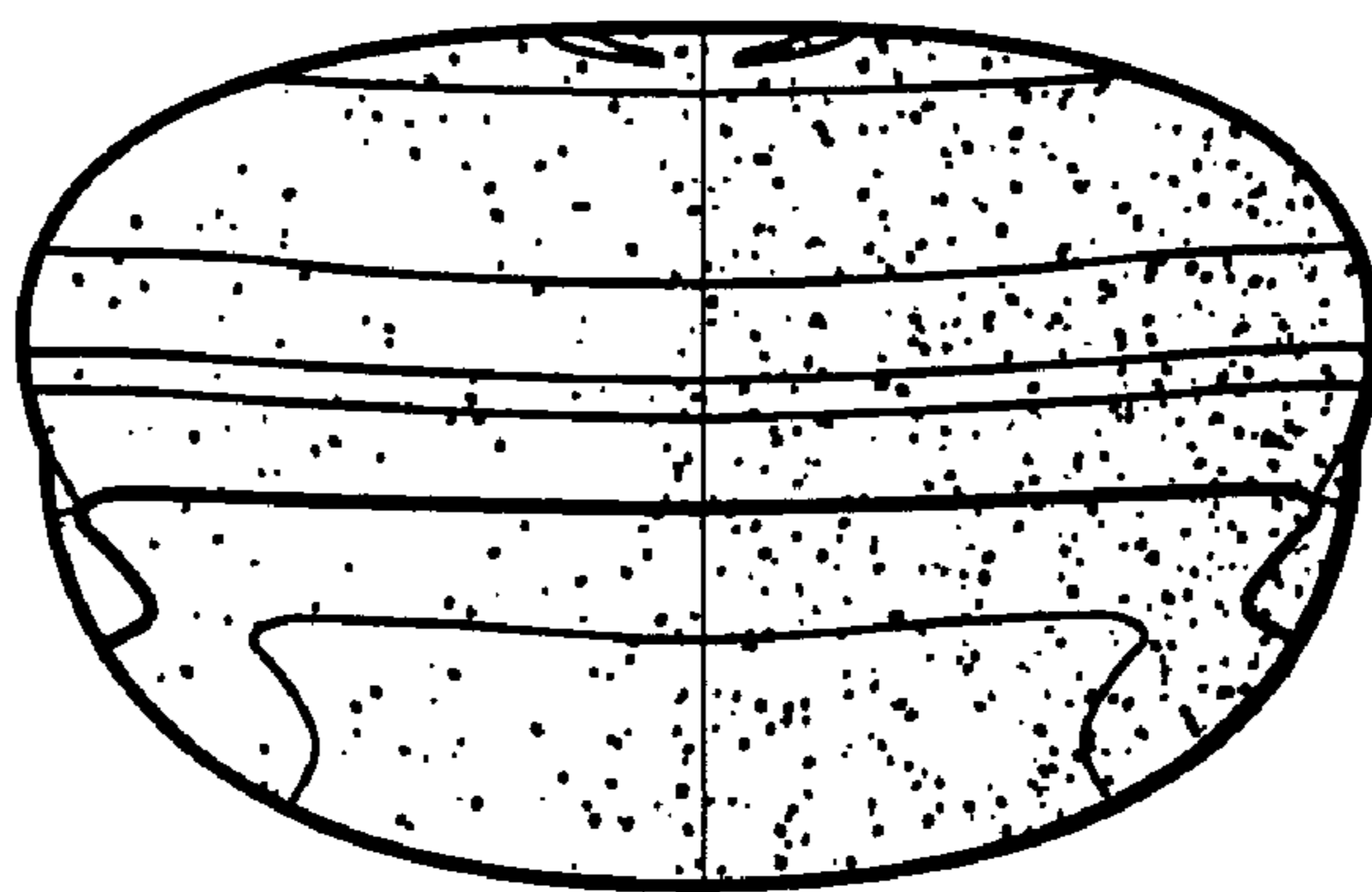

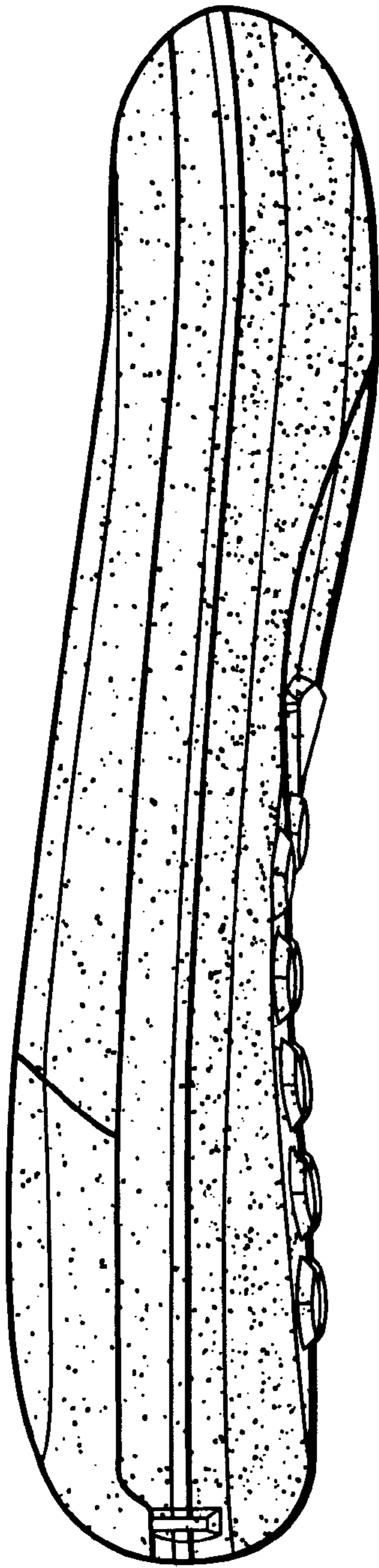




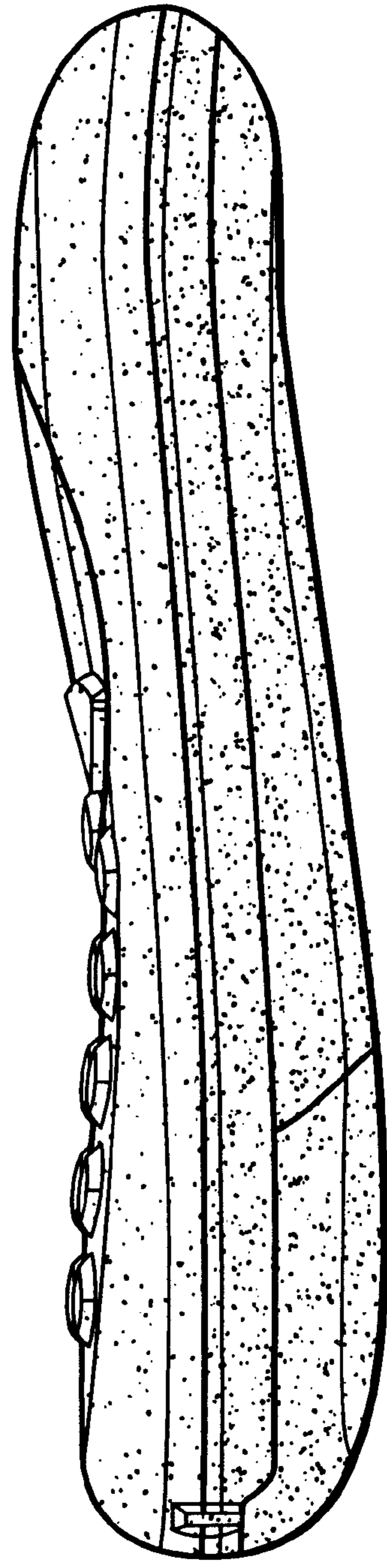

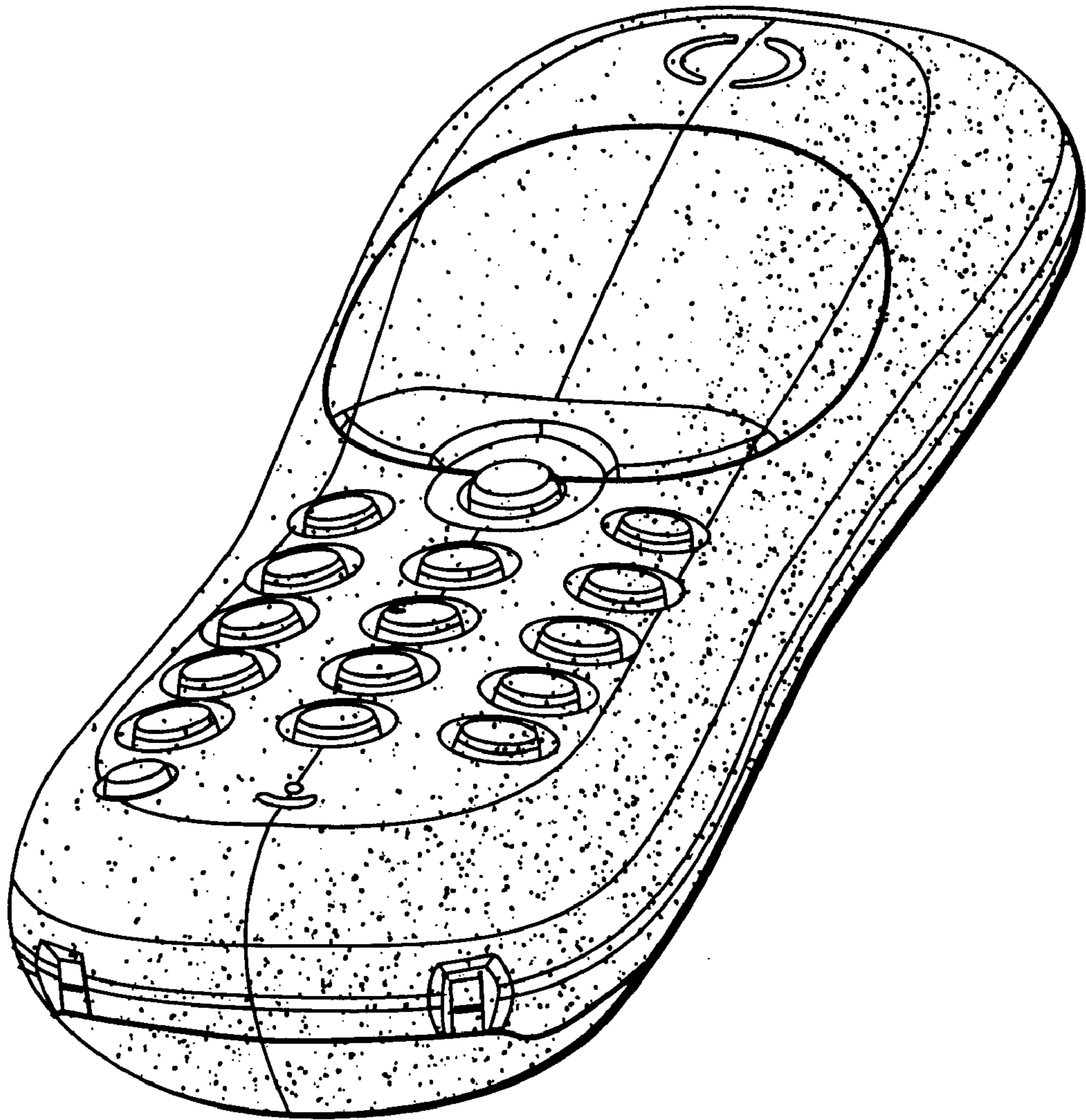
