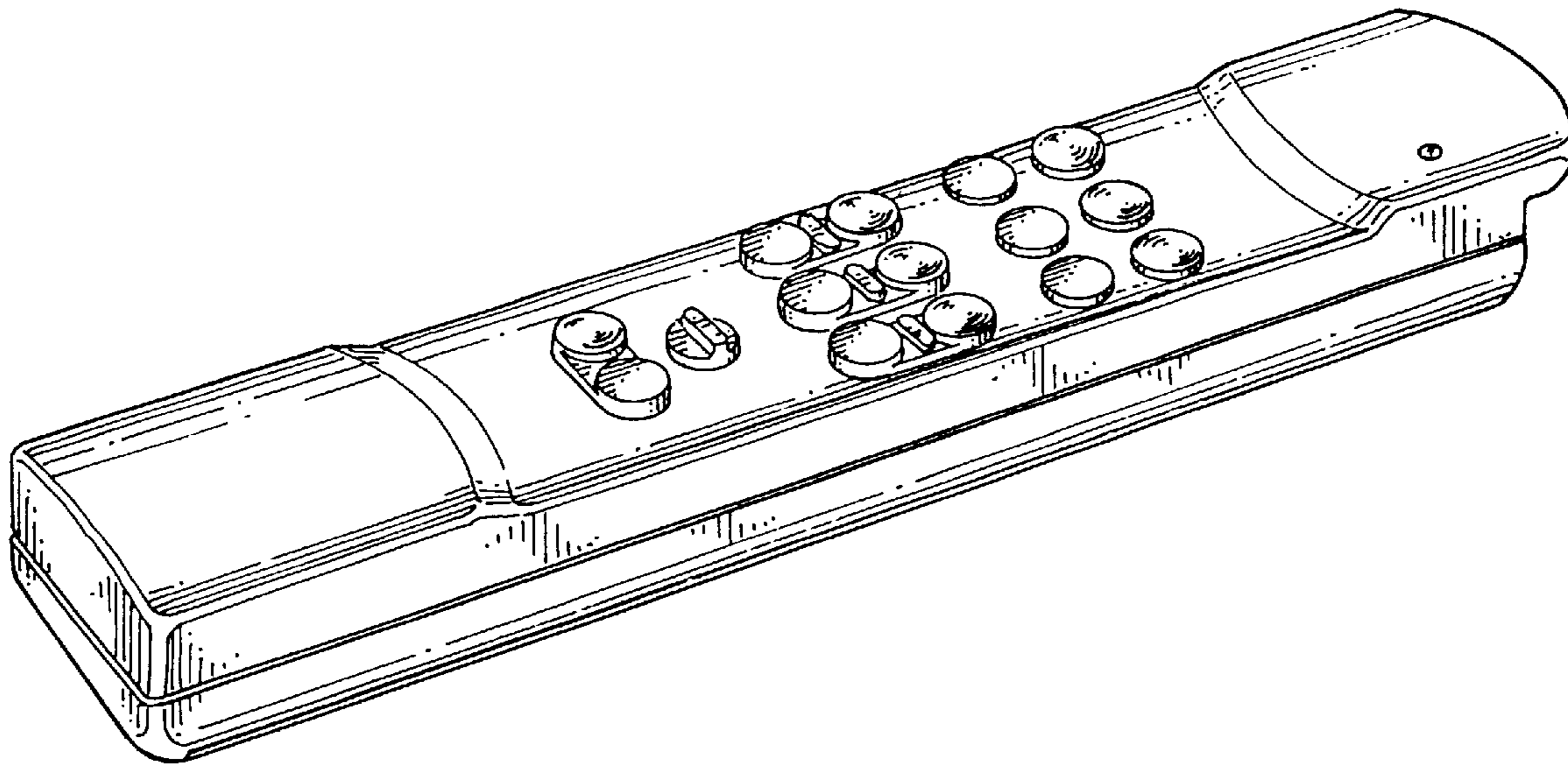
[57] **CLAIM**

The ornamental design for a remote controller, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a remote controller showing the rear, top and right side of our design; FIG. 2 is a top plan view thereof; FIG. 3 is a front elevation view thereof; FIG. 4 is a rear elevation view thereof; FIG. 5 is a bottom plan view thereof; and, FIG. 6 is a left side elevation view thereof, the right side being a mirror image.

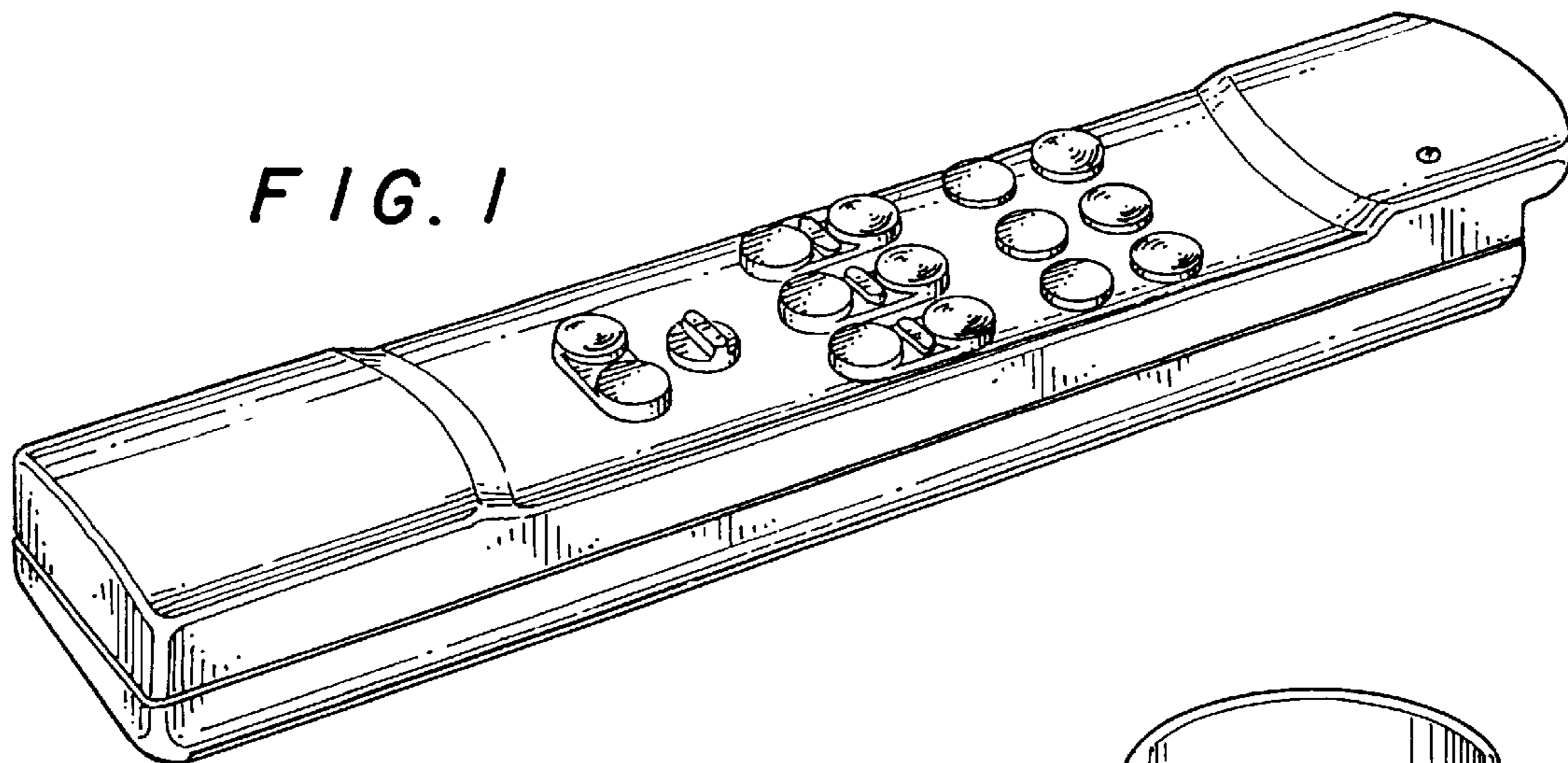

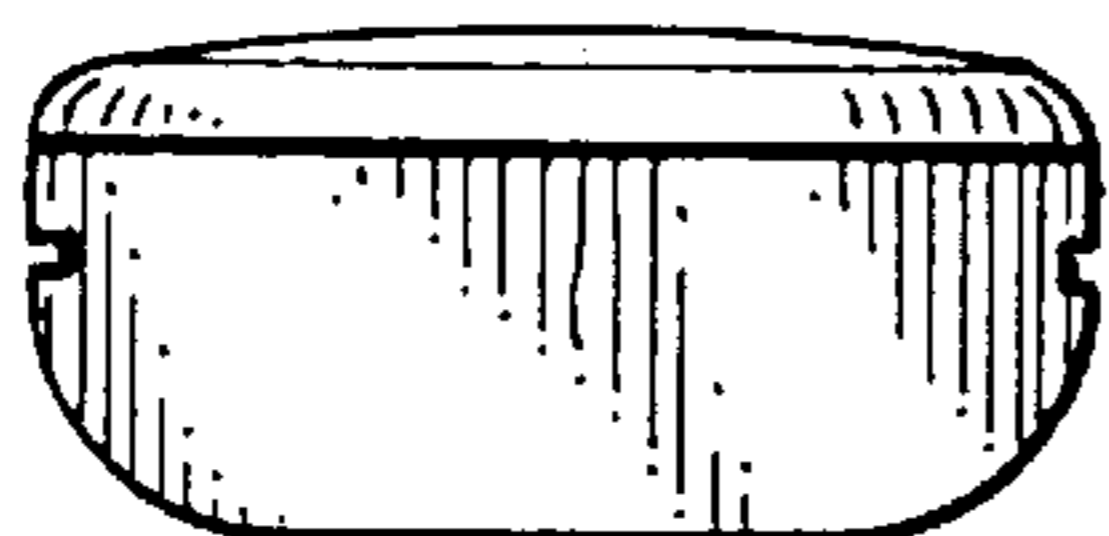

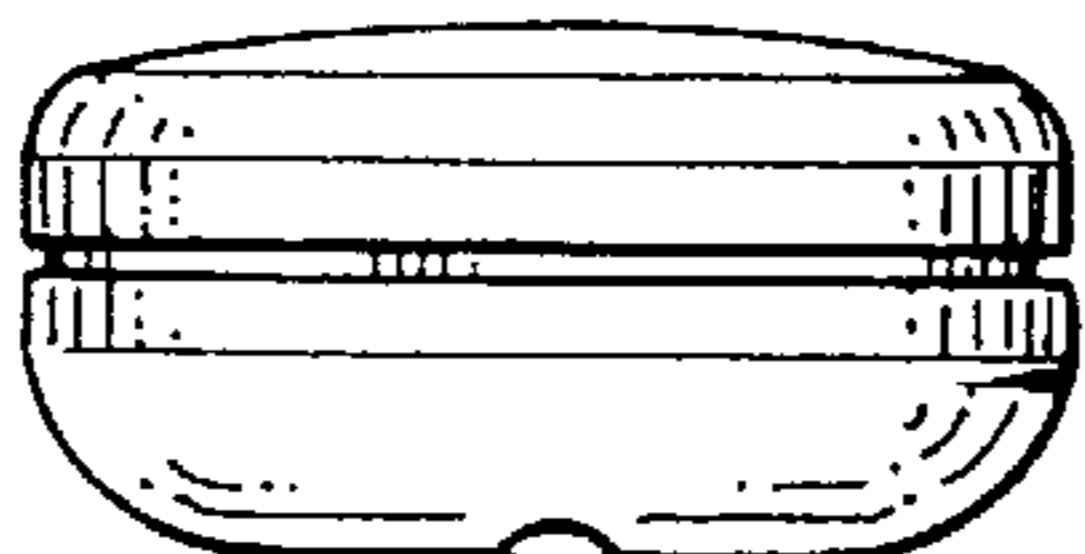

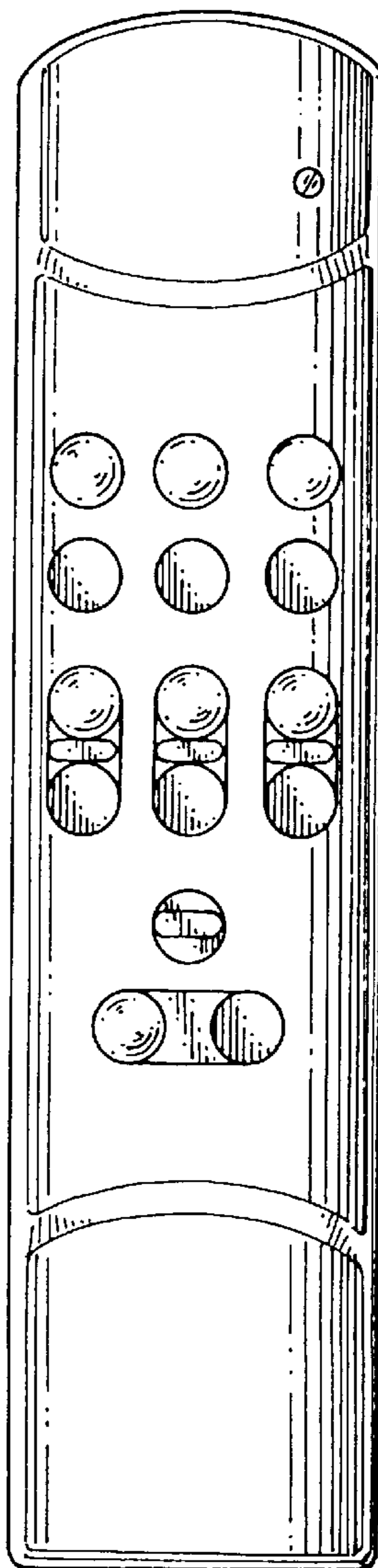

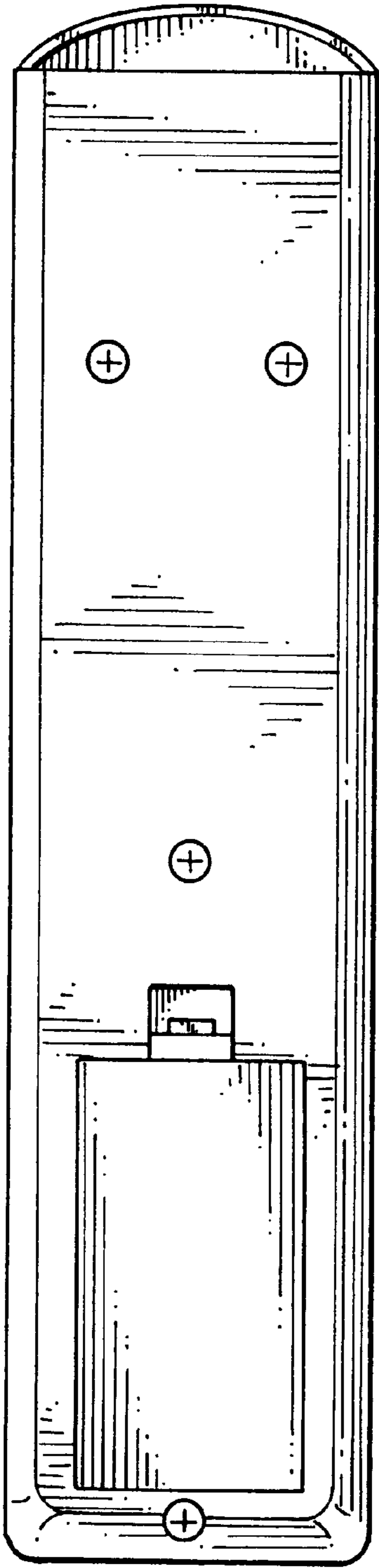

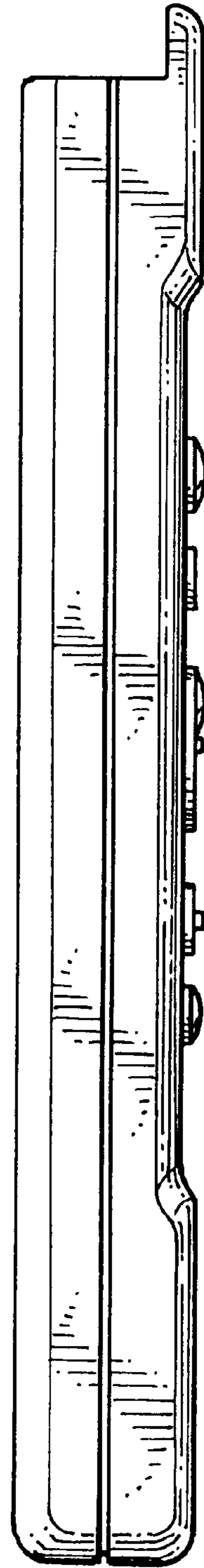
